## Spring is here... Get ready to

Local experts offer advice on buying a gas grill

tjagielo@tctimes.com; 810-433-6795 Spring is here, and so is grilling season. If buying a new gas grill is an unfamiliar experience, some local experts are here to provide some guidance.

The first thing to consider in buying a gas grill is how much you will actually use it, said Jeff Stone, of Sears Hometown Store in Fenton. Many people look at how many burners a grill has, or how many square inches the cooking surface is, or even how many burgers it can cook at once, he said.

An older couple who only cooks for themselves might be happy with a smaller, three-burner grill. A family that regularly entertains should plan to buy a larger one.

"You really need to buy based on the number of people you'll be cooking for," said Kevin McKay, of McKay's Hardware in Holly. McKay recommends stainlesssteel burners because they rust less. See GRILL on 9A

#### Gas grills

Gas grills are very popular, and work by heating the meat from below via propane or natural gas. When the hood is closed, the grill acts like an oven, heating the food from all sides. The grilled flavor comes from the juices dripping off the meat onto lava rocks or flavor bars below, and are carried back up through the smoke.



atroppens@tctimes.com; 810-433-6792 Fenton — The Fenton Community & Cultural Center (FCCC) is in need of restoration and the Downtown Development Authority (DDA) may pay for it. "If we do nothing

A March 30 preliminary report from John Dziurman Architects Ltd. shows areas where improvements could be made. With many of the suggested improvements cut, the cost will probably be \$1.3 million to \$1.5 million, according Michael

Burns, assistant city manager/DDA director. "There are lots of things we don't feel are necessary," he said.

The DDA is the most likely source of funding. There is \$300,000 in its budget in the current and next fiscal year, Burns said. Options include a construction loan, which would allow all of the work to take place at once. Fenton would pay off the loan over time.

#### Summary

The Fenton Community & Cultural Center, built in 1938, needs restoration. The Fenton Downtown Development Authority (DDA) is the most likely source of funding.

A committee, including two DDA members, two city councilors and two members of the community center's board of governors, has been meeting. The FCCC is a unique building, because the city

owns the property, the board of governors operates it and the DDA will probably pay for the project, Burns said.

The committee would like to extend

the building, with an elevator and entrance corridor. A big issue is handicapaccessibility. In addition, the FCCC needs fire suppression, electrical and mechanical upgrades.

Structurally, the building — designed by famed Finnish-American architect Eliel Saarinen and his son Eero Saarinen — is sound.

Burns said. The roof was fixed after the 2007 tornado, but there are still drainage issues because of storm damage.

Other portions of the project will include restoring the steps, improving acoustics inside the building and restoring some things inside, he said. There are many

items to address. Fenton City Council will discuss it

during its all-day budget worksession, beginning at 9 a.m. at the Fenton Fire Department on Saturday, April 30.

'We'd love to start doing some work this year," Burns said. "We'd like to be moving along on this soon."



Fenton's 10-year-old system is obsolete, said DDA Director/Assistant City Manager Michael Burns. The city's general fund didn't have enough for the expense.

A lease-to-purchase agreement is less expensive than selling bonds, City Manager Lynn Markland said. At the end of the last payment, Fenton will own the equipment.


As alternatives to getting new dispatch equipment, city administrators investigated obtaining 911-dispatch service from Genesee County Central or the village of Holly. There was no cost savings for Fenton if it went with Genesee County, Burns said. The approximately \$150,000 the city receives for 911 funding, from people's phone bill fees, would go to the county.

Fire Chief Robert Cairnduff said, if Fenton switches to Genesee County for dispatch service, the city would also change to a new rule the county has for ambulances. The new protocol states ambulance services must be housed in a building. Fenton (and Linden) contract with STAT EMS, which stations ambulances in a couple of spots around Fenton.

Automatic Vehicle Locators on the ambulances register on a computer system in Fenton's dispatch center, so the dispatcher can send the closest ambulance.

Response times are five minutes for priority calls, like someone having chest pain or trouble breathing. he said. Officials want to keep STAT EMS as an ambulance provider, but other

#### How is the DDA funding the dispatch equipment?

It is an eight-year, lease-to-purchase agreement, not to exceed \$40,000 per year. The DDA is reducing the percentage it pays for DDA Director/Assistant City Manager Michael Burns' salary and benefits. The DDA will decrease from paying 75 percent of his salary and benefits, to 50 percent. The Fenton Local Development Finance Authority (LDFA) will increase from paying 25 percent of Burns' compensation, to paying 50 percent. This will provide the DDA with \$20,000 for the dispatch equipment. In addition, there is a Fenton Gazebo improvement project, previously budgeted at \$100,000, Burns said. This was based on estimates from the previous engineering firm. The new engineering firm's estimates are much less expensive, and this will provide the DDA with the other \$20,000. With these budget amendments, the DDA can cover the dispatch equipment expense with money it already has, he said.



The goal of the presentation was to educate the community, she said. Cooper made a no-frills presentation on

the medical marijuana law in Michigan, and she fielded questions from the 25 or so in attendance.

"I was very pleased with the presentation that she gave," said Vergith. "She was very straightforward."

Vergith is concerned that the youth of the community think that marijuana is no longerillegal for them to use. "They don't think it's bad, they think it's medicine," she said. "It's not medication, or a regulated substance, and there are problems inherent with that."

Vergith is worried that medical marijuana dispensaries could be a front for illegal growing and selling activities. "Unfortunately, there are people out there abusing the system," she said. "It's not fair to people who really need it."

Cooper also discussed medical marijuana dispensaries, and how they are not provided for in the law.

**Continued from Front Page** which include pay increases, according to years of employment and levels of education. The lowest teacher salary is \$36,621 (for new teachers with a bachelor's degree), while the highest salary is \$74,325 (11 years' experience with a

master's degree plus 40 credit hours). Fenton Education Association President Lynn Thompson said, for the level of education teachers have, their salaries are not comparable to other professions. Most Fenton teachers have a master's degree. Compared with other professionals with master's degrees, teachers' pay doesn't stack up. "We're below that level," she said.



In Fenton schools, there are 183.5 teacher workdays. Teachers select, in the fall, 21 or 26 paychecks. If they choose 21, they receive their first check in August and last one in June. If they select 26 paychecks, they receive part of their salary during the summer months. They don't get more money. It's just spread out differently, said Fenton Superintendent Dr. Timothy Jalkanen.

In addition, the state requires that teachers take continuing education after receiving their teaching certificates. Within five years, they need to have obtained a certain number of credit hours from an approved program, Busch said. Teachers pay for their own continuing education.

And Thompson said it isn't cheap. For Fenton teachers, they can only take graduate-level classes. "That really adds to the expense." In addition, most Fenton teachers take their graduate classes during the summer, since it's too difficult to do so during the busy school year.

The school district can't employ a teacher if he or she doesn't meet the requirement and has an expired teaching certificate as a result, said Jalkanen. For length of service, 104 teachers

received longevity payments. The total longevity payment cost last year was \$92,250, Busch said. Benefits

The district's total projected teacher health care cost is \$3,124,040, Busch said. Fenton teachers have MESSA Choices II PAK for health insurance. The PAK program means that the district purchases health, life, vision, longterm disability and dental "packed" together from the same carrier, which is MESSA, he said. The cost per year for these insurances is \$18,684 for family, \$16,968 for a couple and \$8,424 for a

single. The teachers do not contribute for insurance premiums.

Regarding benefit levels and co-pays, Fenton schools' teachers pay \$5 per office visit, \$25 for an emergency room visit (waived if admitted or for accidental injury), and \$10 per urgent care visit (waived if a medical emergency or accidental injury).

There is no deductible for them if they use a doctor who is part of their network. Prescription co-pays are \$10 for generic and \$20 for name brand. Life insurance provides a \$40,000 benefit. Long-term disability benefits are available for all teachers under 65 who work at least 30 hours weekly. Vision and dental benefits are available for teachers and their dependents.

#### Chiropractic/massage

Chiropractic services are covered, for up to 38 office visits including modalities. On the issue of teachers having massages as a health benefit, Thompson said they must be under the care of a physician. Their doctor can refer them to a chiropractor, who determines whether massage would help an orthopedic problem. If it would, teachers can get a massage, but it is by prescription.

"It's not that we go to spa treatments and have that covered," she said. "It is all through a prescription by a doctor and/or a chiropractor."

#### What are they paid?

payroll of \$1,337,904, creating an average salary of \$83,619. Depending on their building assignment, there are 230-260 administrative workdays, Busch said. **Tenure** 

Teachers working in the state of Michigan are granted tenure after teaching for four years if they have satisfactory annual evaluations, Busch said, per the Tenure Law.

If a teacher establishes tenure at one school district, leaves and then hires with another school district, they can establish tenure at the new district after two years. If a school district decides it does not want tenure granted to a teacher, a process must be followed. Once a teacher establishes tenure, school districts must follow another process to dissolve that tenure.

Teachers who have not reached tenure do not have access to the appeals process offered through the Michigan Tenure Commission, Busch said.

#### Maintain teaching certificate

Teachers in Michigan must maintain their teaching certificate by taking two classes every five years. Classes are generally worth three credits costing the teacher approximately \$1,200, according to Wayne Wright, superintendent of Lake Fenton schools.

"Approximately 86 percent of our entire school district budget goes to personnel," said Jalkanen.

## Library millage on May ballot

#### Increase, if approved, is \$25 per year, based on \$100,000 home

Genesee County voters will decide a large chunk of the district library system's future budget, with a May 3 millage proposal. The .25-mill would be for six years, beginning in 2012, and raise an estimated \$2.2 million per year, for a Genesee District Library (GDL) budget of \$8 million annually, Executive Director Carolyn Nash has said.

Fenton City Council approved a resolution in support of the millage, at its April 11 meeting. Mayor Sue Osborn said she supports it 100 percent, and libraries are very important in communities.

Bev McKenna, speaking in support of the millage, said some Fenton residents are confusing the millage with Fenton's discussion on getting a new library. The millage proposal, if approved, would not go to that. Instead, it is for the GDL, which has 19 libraries in Genesee County, including the Jack R. Winegarden Library in Fenton.

The GDL provides staff, books, computers and other materials, all but the buildings and utilities. All of its employees have a four-year salary and benefits freeze, even if the millage passes, McKenna said. The GDL's budget has been cut to "bare bones," she added.

The GDL, like many entities in Michigan, is receiving less tax funding due to economic conditions. It was receiving more than \$7 million in tax revenue, Nash said. This year, it's \$6 million.

The GDL has lost more than 15 percent of its taxable value, and officials expect more declines. And, 57 percent

If voters do not approve the May 3 millage proposal, the Genesee District Library (GDL) will have to decrease service hours, and possibly services, even more than it has, said Executive Director Carolyn Nash.

of state aid has dried up as well. Interest income on money the GDL has in the bank has decreased by 90 percent. This income was more than \$400,000 annually, and now it will be less than \$15,000, she said.

The library has cut all areas of its budget, and renegotiated its contracts to save money. "We would like to maintain services in each community," Nash said. "We do need an increase in mills."

With the current level of revenues, the GDL won't be able to maintain even its current, reduced level of services. It is one of the few times in the GDL's history that it's asking for an increase. Costs have increased over the last few years. More and more patrons are using the GDL's e-book service, which they can download at no fee onto a mobile device or computer. E-book circulation increased by more than 900 percent in January, Nash said.

All library services are provided with tax revenue, at no additional fee for patrons.

An off-duty sheriff's deputy reportedly saw Tripp's car swerving through traffic, so the cop tipped off



## Historic year for tornadoes Tornado warning

#### ▶Three days, 241 tornadoes, 14 states

It's that time of year for residents of the tri-county area to prepare for tornado season.

AccuWeather.com reports one of the worst tornado outbreaks in recorded history last week, with 241 tornadoes reported in three days, in 14 states. Tornados can blow in at any time, and will peak from May through June and continue into August. These storms can occur as late as September and October.

The tornado that struck the Fenton and Holly area on Aug. 24, 2007 made national news and changed the landscape forever. It made area residents aware of how major devastation can occur in mere seconds.

The F-2 tornado blasted in during the late afternoon, at 150 mph, downing hundreds of trees and damaging roofs and houses. Fortunately, no one was killed or seriously injured. The tornado also did considerable damage in an area east of Fenton off Grange Hall Road, toward Holly.

On May 21, 2001, a tornado whirled up U.S. 23 at 2:30 p.m., touching down in Hartland and Tyrone townships, and spun itself out in Fenton Township at Owen and Whitaker roads. Extensive damage occurred at Tyrone Hills Golf Course. Woody's Towing and the adjoining party shop at U.S. 23 and Center Road.

Along its route, this storm took down buildings, billboards and vehicles, piling up thousands of dollars worth of damage. Travelers on the highway were forced to pull over and crouch in ditches. There were no fatalities or serious injuries. That same year, on Oct. 24, a tornado hit Davisburg Elementary School in the Holly school district at 8 p.m., with winds registering at 112 mph. It caused \$600,000 in damage.

On July 2, 1997, a tornado touched down in Springfield Township near Holly, racking up \$2 million in dam-



ages. It killed a woman, whose manufactured home in Chateau Estates Oak Hill was destroyed.

This tornado touched down at in the area of Spring Grove manufactured homes, where an estimated 10 homes were destroyed and 30 sustained damage. This same storm touched down in Livingston County near Fowlerville, destroying trees and a home under construction, before blowing itself out in Wayne County, causing \$90 million in damages.



## procedures

#### **FENTON**

Fenton has four strategically placed tornado sirens throughout the city. These sirens are placed to provide audible alerts to the entire city. The tornado sirens are tested the first Saturday of each month at 1 p.m. and will sound for a total of three minutes. The tests are done during the months of April through October. Sirens are not activated when severe weather is active, to prevent false warnings. Sirens sound for three minutes at a time, every 10 minutes while tornadoes are in the immediate area. Please do not call 911 when you hear the siren unless you have an emergency. Take cover immediately and then obtain information about the weather via a radio or television. The Fenton Fire Department recommends that all residents have a battery-powered radio available with spare batteries for use during an emergency.

#### LINDEN

The siren will be tested on the first Saturday of each month at 1 p.m. The sound will be a constant blast. When you hear the siren, other than for testing, don't ignore it. The siren means a tornado has been sighted in Genesee County. If a tornado is sighted anywhere in Genesee County, the siren in Linden is activated. Residents should check the weather, via radio, and proceed with caution. A driver should never try to outrun a tornado. Instead, one should pull to the side of the road and lay in a low area or ditch.

#### HOLLY

The village of Holly receives all tornado warnings from Oakland County's Skywarn. The siren sounds at 1 p.m. on the first Saturday of the month, from March through November. There's a one-minute blast, followed by a second one-minute blast. Residents are asked not to jam the phone lines at the police department or village hall when they hear sirens. Residents living in mobile and modular home parks, should not stay in these buildings. Residents need to make arrangements for shelter in case of severe weather.



## **Benefits of assisted living**

sstone@tctimes.com; 810-433-6786 Your widowed mother no longer has the desire to prepare her own nutritious meals, she's lonely and she sometimes forgets to take her medications. What should be done to ensure she is safe, well fed and living a lifestyle she deserves?

Families facing a similar situation might want to start checking into assisted living facilities in their hometown.

An assisted living level of care describes options between independent living and skilled long-term care. Some facilities offer private apartments or rooms, while offering tailored medical care to suit each resident's needs.

While some facilities are large by design, for efficiency, they might not feel like home. At Caretel Inns of Linden, the designers have created a home-like atmosphere by building separate inns. While their home." the living spaces are separate **Sarah Brasseur** and private, they are connected to allow for common services.

Sarah Brasseur, a caregiver at Linda's Place, said it could reach the point when placing a loved one in an assisted living facility is in the best interest of that person. She said some elderly individuals become forgetful, even about daily hygiene routines.

With dementia common, she said having a routine becomes so important. "Believe it or not, they'll kind of remember it," she said.

Having an exact daily routine helps ensure the resident is completing all of the necessary tasks, such as teeth

brushing, bathing and taking medications. Brasseur said sometimes a person suffering with dementia, or one who has bouts of forgetfulness, may think they've bathed in the past day or so, but sometimes it could have been, in reality, two weeks. She said staying on a routine cuts down on viruses and infections.

Holidays remain important for many families and Brasseur said if a resident is capable of leaving the home and visiting with family, the family is encouraged to take the resident out for a few hours.

Depending on the level of their needs, residents do socialize with one another. Some remain very social, while some act as protectors or coddlers. "Individual personalities affect each other in different ways," she said.

Adjusting to this type of move can intensify confusion for a resident; however, she said staff members strive to reassure families that their loved one will be taken care of better

than if they were on their own. Some families seek the assistance of support groups. "In most cases it's harder on the family than the resident.

"This is their home," Brasseur said.

John Hawkins, owner of Almost Home Assisted Living in Fenton, said families should make sure they are placing their loved one in a home that is licensed by the state. Employees must undergo a background check and be fingerprinted.

He suggests families ask around or ask for recommendations from local senior centers. "Word of mouth is the best way to find a home," he said.

The organizers have addressed this issue by planning the swim start so that not everyone will start at the same time. "We'll also have a 'regatta' of kayaks

and pontoons out on Bryam Lake, so that swimmers who need a rest or refreshment can do so," said Skinner. There will be coaches on hand to help participants make a smooth transition to the next sport.

For those who are hesitant about biking the 9-mile course, Skinner said the course is mostly flat with just a few small hills and only four turns. The final leg of the triathlon will be a 2-mile run, 1 mile out and back at Linden County Park.

Participants also won't have to be worried about "coming in last." "We already have someone officially assigned to be last," said Skinner. "That won't be an issue in this event."



Q: Our cat is herding our Border Collie. We've had Border Collies for years, and Geneva is particularly calm. Morgan, our cat, adopted us. One day, Morgan just showed up. He's maybe 7 months old. Geneva is very patient with Morgan, and actually allows the cat to move him around the house. I'm worried that this isn't normal. Any thoughts?

#### — A.N.N., St. Paul, MN

A: Normal, well, no. However, I don't believe you have cause to worry unless Geneva has suggested with growling, or in some other way, that he's becoming increasingly impatient with Mor-



gan. First, find a place where Geneva can find refuge from your pushy kitty, perhaps a crate. Be sure you offer Morgan lots of opportunities to chase toys rather than your dog. At least once daily, use an interactive cat toy (fishing pole-type toy with feathers or fabric) for play. I also suggest a laser light. Periodically, drop a treat or piece of kibble on the little red "bug" so Morgan

really has a chance to catch something (otherwise laser light may be frustrating). Adult supervision is important if a child is using the light, since he/ she may shine it in the cat's eves, or in the eves of another child. Also, feed Morgan at least some of his food in random places around the house (beyond the reach of your dog) so he has to "hunt" to find it. If he's searching for his next meal, he won't be focused on Geneva. And we know that after a good meal, cats (and many people) usually enjoy a good nap.

#### Time to assess why son is friendless

DEAR AMY: My 10-yearold son does well in groups such as Scouts and team sports, but he doesn't have any friends. He's reluctant to invite people over and has started to pull away from the few boys who want to hang out with him. If this is bothering him, he's not showing it, and he won't discuss it with me. He's a bit of an odd duck, and I'm afraid he'll be picked on in middle school if he doesn't



have friends. Should I leave him to figure this out on his own, or is this something to be concerned about? — Concerned Mom DEAR MOM: This issue is something to be con-

cerned about, but it is not your job to provide friends for your son. Instead, make sure he has the tools necessary to form relationships and make friends. Some children seem to thrive being part of a group, while others can feel overwhelmed by the challenges and stimulation of maintaining multiple relationships.

Your son may have a quirky and quieter temperament. He may not be adept at reading the sometimes confusing social cues thrown out by pre-adolescent boys, who are experts at creating scenarios of shifting power and alliances.

You shouldn't telegraph your anxiety to your son by querying him about this or pressuring him, but you should speak to his teacher, his Scout leader and his coach. They may report that he does just fine in a more structured peer group overseen by an adult but that he is out of his element on the playground. Or they may suggest he be evaluated for a more serious problem that may be emerging in adolescence.

admire the work of child psychologist Michael Thompson in describing the inner (and outer) lives of children. I once heard Thompson speak about childhood group dynamics. He said that parents often want their children to have lots of friends, but really, it only takes one friend to make a child feel he belongs. Your son may be a "one friend" kind of kid, and there is absolutely nothing wrong with that.

Read Thompson's book, "Best Friends, Worst Enemies: Understanding the Social Lives of Children" (2002, Ballantine Books).

DEAR AMY: My husband and I do not drink for personal reasons but do not have anything against it. However, when we host a party for our colleagues and friends, I often feel bad that we don't serve wine or beer. I'm wondering if there is a polite way to tell our guests to feel free to bring their own beverages without sounding as if we want them to provide them. We wouldn't mind buying wine or beer ourselves, but since we don't drink, we have no idea what would be considered fine wine or good beer. Any suggestions? — Eager Host **DEAR HOSTS:** You are not socially obligated to provide alcohol for your friends when you entertain. But because you are open to serving it in your home even though you don't drink (good for you), you should seek direction from your local wine shop. Any wine seller would be more than happy to give you ideas for what to serve with whatever meal you are preparing. Guests often offer to bring something to a meal. If you are inviting someone and he or she asks, "Is there anything I can bring?" You can say, "A bottle of wine or your favorite beer would be great. Thank you.

DEAR DR. DONOHUE: Can I reverse sarcopenia, or just slow it down? What I would like to know is what can I do for my thighs? How often should I do it? And I'd like something for my stomach. — J.H.

**ANSWER:** For readers: Sarcopenia is muscle shrinkage that comes with age.Weightlifting stops the wasting away of muscles and builds them up. Older people are not going to develop the same muscle size that a 20-year-old can, but they can see a marked improvement in their strength and an increase in muscle size through weightlifting.

For your specific thigh problem, the squat is a good exercise. From the standing position, you bend your knees until your thighs are parallel to the ground. You don't have to touch your heels with your buttocks. Lower yourself only to the position I mentioned. Farther than that can hurt the knees.

Start out doing the exercise with no additional weight. Your body weight is enough at first. As you gain experience and strength, you can use additional weight, either a barbell supported behind your neck and on your shoulders, or you can hold on to weights. When you start using weights, exercise three times a week with a full day's rest between exercise sessions.

For your abdomen, the bicycle maneuver is one of the best exercises. Lie on the floor and raise your legs straight up. Then bend the knees to a right angle so your lower legs are parallel to the floor. Now start pedaling as though you were riding a bike.






