## City retirees to pay 20 percent of premiums

►New health care plan will save \$100K this year

**Fenton** — The Fenton City Council adopted a resolution Monday, which deals with health care coverage for retired city employees.

City Manager Lynn Markland said the city has been working on this issue for a couple of years, with the intention of lowering the city's expenses. To cut expenditures, he said a few city administrators began paying a percentage of their health care premiums more than a year ago and on July 1, other city employees began doing the same.

Beginning July 1, current employees are required to pay 20 percent of their health care premiums. Their deductibles were also raised, which resulted in large savings for Fenton, said Markland.

### Summary

►Fenton City expects to save about \$100,000 per year by switching health care plans for its retirees. The new plan, through Health Plus of Michigan goes into effect Sept. 1.

Keeping in line with current employees, the city began looking at ways to cut costs for retirees' health care coverage.

There are 12 retirees under the age of 65 and 16 retirees over 65. With the proposed changes for both groups, the city expects to save about \$100,000 for this year.

Effective Sept. 1, retirees who are not eligible for Medicare coverage will have the same plan as current employees. Health Plus of Michigan will be the provider.

Retirees electing the HMO option for coverage will be required to pay the first \$750 of the annual deductible under the plan. Retirees electing the PPO option for coverage will be required to the first \$1,000 of the annual deductible under the plan.

The city will provide payment of the remainder of the deductible through a Health Reimbursement Arrangement administered by a third party administrator retained by the city.

Effective Sept. 1, retirees who are eligible for Medicare coverage will be required to enroll in Medicare Part B. Retirees enrolled in Medicare Part B will receive individual coverage through a choice of plans currently provided by Health Plus of Michigan for in-state retirees and by Blue Cross Blue Shield for out of state employees.

Retirees affected by the prescription coverage gap will receive a supplemental of up to \$1,000 per benefit year, provided by the city, through a Health Reimbursement Arrangement for use solely for the prescription coverage gap.

Councilwoman Cheryl King said she was pleased with this plan. "Health Plus is a very good health plan," she said. "I'm happy these people worked with the city. They'll get more benefits and have less out of pocket."

Mayor Sue Osborn said she too was pleased to have this finalized. She was especially appreciative of the fact that it saves the city money.

Aro asked that Municipal Services Consulting, which has provided services to various committees involved with the Homeland Security Grant Program be hired. The company has also provided consulting services for projects that he and the fire chief have been involved.

According to Aro, the consulting firm has done an excellent job and saved this region a significant amount of money on several projects.

With the council's approval, the police chief is hiring Municipal Services Consulting at a cost not to exceed \$18,000. This money has already been appropriated and is available for this project. He will have the consulting firm begin as soon as possible.

The city expects to spend more than \$300,000 to upgrade its 911 dispatch center equipment.

Recalls and petitions have spiked recently as organizers are moving to recall Rep. Paul Scott, (R-Grand Blanc). Scott's district includes the city of Fenton, Fenton Township, Linden and Argentine Township. Scott is the chair of the House of Education Committee and is an

influence in teacher tenure reform and changes in funding for public schools, spurring the recall effort.

Linden Police Chief Scott Sutter said that the petitioners had blocked a right of way near downtown. They were compliant after they were asked to move.

McKone reminded the council that they are not choosing sides, but simply ensuring that the public is kept safe. "Any ordinance we adopt would have to be neutral," McKone said. "We want to protect citizens and right of ways."

# New Times staffer is former Beijing daily newspaper reporter

Not every journalist has the Great Wall of China as a scenic backdrop to a professional career.

Will Axford, 24, the newest staff reporter at the Tri-County Times, completed an internship last summer for the China Daily — China's main English-speaking newspaper in the country's capital city. His "beat" in the tri-county area is a little smaller than it was in Beijing, where he covered mostly feature stories about foreigners living and working in China.

Here, most of his time is spent covering the city of Linden, Fenton schools, and writing features about interesting people in the Fenton, Linden and Holly area.

Axford graduated from Holly High School in 2005. He is the son of Holly residents Will and Theresa Axford. After graduating from Central Michigan University's School of Journalism in May 2010, he packed his bags for a three-month, paid internship in China — following his selection for this honor by a journalism professor.

Not able to speak a word of Chinese, Axford landed at Beijing Capital Interna-

tional Airport in June 2010, and found his way to the newspaper office by showing a cab driver the written address. That would be Axford's typical way of getting around for his assignments. "Sometimes I spent half of my time just trying to find the person I was supposed to interview," he said.

His most interesting assignment was with an all-female Japanese punk band, Shonen Knife that was performing for the first time in Beijing. "They had been the opening band for Nirvana, and the lead singer got to know Kurt Cobain very well," said Axford. "That was pretty interesting."

While in Beijing, Axford made his home in an apartment behind the newspaper building and spent the first six weeks getting accustomed to a new culture, new foods and a new way of doing things. He quickly learned that several

topics were taboo in China, including speaking against government policies or talking about the protests at Tiananmen Square in 1989 — the pro-democracy movement against the government, which resulted in the deaths of hundreds of protestors. "You quickly learned that

most Chinese weren't very happy with their government, but they just don't dare say anything," said Axford.

Axford did find time to travel while in China, visiting the Great Wall, and Forbidden City, the largest ancient palatial structure in the world. "It's all much more impressive in person than it is in pictures," he said.

He loved the food in China, and became very adept at using chopsticks. The only thing that he didn't like was the Chinese way of serving a main dish. Every time an animal was served in an entree, the head of the animal was served along with it. "I guess they figured if we were going to eat an animal, it should look like what we're eating," Axford said. He found it very disconcerting to eat frog legs, while staring at the entire frog.

Axford also noticed that he was one of very few left-handers in China, even though it's a common physical characteristic of many journalists and creative people in the United States.

"When the Communists took over the government, they made everyone use their right hand," said Axford, repeating the explanation he was told while in China. "So there are very few left-handed people in China, although that's begin-

ning to change."

He wishes that he had an opportunity to spend a more time in China, because his internship ended just about the time he was getting acclimated to his new surroundings. ### The reasonable expectation of privacy under the Fourth Amendment

We are indeed fortunate to live in a country where the rights of individuals have long been established by our U.S. Constitution.

Without detailing all of our individual rights, it is safe to say that one of the most important rights that all of us have is contained in the Fourth Amendment of the Constitution to be safe from unlawful searches and seizures.

Of course, the courts have been interpreting just what the Amendment means since it was enacted in 1791. Recently, the Michigan Court of Appeals, in the case of *People v. Antwine*, rendered an interesting opinion on the legality of the entry by the police into a condemned house without a search warrant, which ultimately resulted in the discovery of cocaine and criminal charges being filed.

The facts of the case show that the house had been condemned because it didn't have water service or a sanitary facility. Under the condemnation order, people could only be in the house from 8 a.m. to 8 p.m. to make repairs.

The homeowner was discovered in the home at 6 a.m. on Nov. 3, 2009 by Hamtramck police officers. He allowed the police inside. One thing led to another and cocaine was discovered on premises.

The Court of Appeals held that since the defendant should not have been in the house, his occupancy was illegal and he did not have a reasonable expectation of privacy under the Fourth Amendment, thus rendering the subsequent search of the house by the police legal.

This is a case unique on its facts and appears to be the first Michigan case decided as to this exact exception to the general rule of law as embodied in the Fourth Amendment.

"The Tahoe has less wear and tear than our Dodges," Linden Police Chief Scott Sutter told the council. "The Dodges are for more highway patrol."

The Tahoe will be purchased from Shaheen Chevrolet in Lansing, saving the city at least \$2,000 than if they bought it from a local dealership. The city had already budgeted for the purchase beforehand.

The Linden Police Department is also looking to sell a 2004 and a 2006 Ford. One of the vehicles may be kept for the use of city employees. Sutter said that the Linden police operate on a 24/7 basis and that the cars usually run up to 100 miles a day. "They're used constantly," he said.

City Councilor Ray Culbert sees the purchase as a wise financial move. "We need to have an ongoing updating process," Culbert said. "It's a lot easier than updating everything at once."

To read about the local ordinances in Fenton Township, visit the township's website, [www.fentontownship.org](http://www.fentontownship.org). Details about the existing ordinances covering amplified sound, blight, business licenses, dog control, garage sales, junk vehicles, solicitors, and sign regulations can be found.

Fenton Township's ordinance officer, Robert Atkinson, fields many calls from residents who are questioning actions of their neighbors. A complaint form is filed, and Atkinson looks into the matter.

Atkinson's goal is voluntary compliance. In his nine years as ordinance officer, he estimates a 99-percent compliance rate. The retired police officer said the most common complaint he sees involves blight. "It isn't pleasing to the eye," he said.

Atkinson said the number of complaints he receives could decrease if neighbors would just speak to each other about what is bothering them. "A lot of times, people don't talk to one another," he said. "Try to talk first." He has heard several residents say that if their neighbor had just told them they were doing something that irritated them, the whole situation could have been resolved, without getting the township involved. "Most are willing to make concessions to a neighbor," he said. "It's a great community."

Oftentimes, a dispute has underlying issues or something happened in the past that has caused the neighbors to quit communicating with each other. "I try to work out the past and look at the current issue," Atkinson said. "There could be hostilities."

Relying on his years as a police officer, he has learned how to diffuse what could be a hostile environment or situation. He stays calm and tries to maintain an open line of communication.

When a complaint is filed, he makes a point of visiting both sides, and other neighbors, to see what is actually going on. He and Supervisor Bonnie Mathis regularly meet with the residents in an attempt to resolve the conflict. To prevent a shouting match, Atkinson likes to meet with both sides separately and act as the go-between.

If hostility between neighbors escalates to where threats are made, the sheriff's department is brought in. "We take no chances," he said.

According to Atkinson, not all complaints are valid, but when they are, the cases could involve a lot of investigation. He must be able to show probable cause in misdemeanor cases. And there is never too much evidence, he said.

Residents are encouraged to take photographs of the violations and send them to Atkinson so he can keep them on hand. These photographs

could be submitted as evidence if the case goes to court.

Sometimes, opposing neighbors will both call Atkinson to file a complaint on each other. "That's just part of ongoing neighbor battles," he said. "I get double complaints."

Atkinson is always busy. He keeps a log of every phone call he receives and keeps a record of every time he pays a visit to check on a situation. He does not go out looking for violations unless it's a public hazard. "I don't solicit complaints," he said, as that would be considered selective enforcement. His investigations start with a complaint made by a resident.

### Summary

Residents who believe they have a valid complaint against a neighbor should first try speaking rationally to that neighbor to resolve the matter. The next step is to contact your local government and ask to speak with the ordinance officer.

To see a complaint resolved, Atkinson must follow due process of law and let the system do its job.

In Linden, if a business or resident is violating a zoning or code violation, Brian Oppmann typically handles those complaints.

If a complaint, such as noise or barking dogs is filed, the police department would look into the matter. Citations could be issued and offenders face fines and possibly jail time if the matter is not resolved.

In Fenton, Brad Hissong, the building and zoning administrator, looks into complaints between neighbors and zoning issues. Oftentimes, residents will call 911 and have Fenton police come out especially if there is a dog running loose regularly through a neighborhood or a neighbor plays loud music late at night.

Hissong said people could call or e-mail the city with a complaint or fill out a complaint form. Sometimes, residents want to remain anonymous with a complaint against a neighbor. Either he or one of his part-time employees Herman Robson or Jerry Willhelm would investigate every complaint.

Long grass at vacant homes and garbage are common complaints. "Neighbors shouldn't have to deal with the mess," said Hissong, who has been a code enforcement officer since 1972 and the last 13 years with Fenton. "Snow on sidewalks and grass keeps our code guy busy."

People skills are necessary when dealing with upset residents. "We work with the people and we take things into consideration," Hissong said. "We don't like to disrupt families on code enforcement."

Oftentimes, complaints are of a sensitive nature. Reports are kept confidential unless the matter escalates to the court system or a Freedom of Information Act request is acted on. "We document everything," Hissong said. Photographs and videos are kept with the files and are used possibly as evidence.

"Our biggest problem is garbage," said Hissong. With some residents finding it difficult to pay for garbage tags, sometimes, the garbage ends up being stored in the basement or garage."

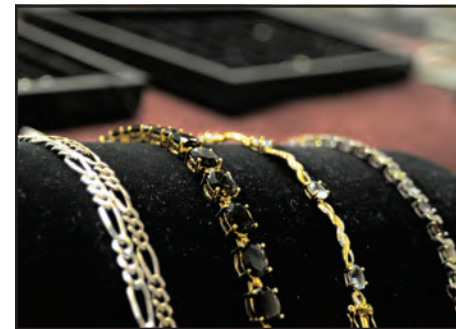
In fact, the price of gold is up more than 18 percent since the beginning of the year, according to a recent report by USA Today.

Michele Curtis, owner of Tri-City Trading Post in Fenton, believes that the gold market is going to continue to rise. "The more uncertain the economy, the more certain the market is for gold and silver," she said.

Consumers who are interested in selling their gold will find no shortage of buyers. In fact, just about every jewelry store or pawnshop buys gold, as well as a number of stores that have sprung up specifically to buy gold in this market. Many malls have gold-buying kiosks, on-line dealers are flooding the Internet, and even "gold parties" have emerged as a way to earn fast money.

So what should a consumer be looking for when it comes to selling gold?

A business that sells gold should be a reputable company that has been in business for a number of years with a proven track record of conducting business with honesty and integrity. Because the process of buying back gold is guided by local ordinance, each transaction should include

checking a customer's government-issued identification and getting a fingerprint.

The city of Fenton passed a memo to the code of ordinances two years ago, requiring a license by the city for anyone buying or selling precious metals, according to Police Chief Rick Aro. This includes scrap metal dealers, pawnshops, jewelry stores, etc. If a customer is not asked by the dealer to comply with this ordinance, they should not do business with that particular dealer.

For most local jewelers, it's all about the ethics and standards they uphold in every transaction, whether selling a piece of jewelry or buying it back.

"People need to sell their gold the same way they buy their jewelry," said Chip Beltinck, owner of Sawyer Jewelers in Fenton. "You go to someone you trust, who will be there long after this gold-selling trend."

It is also advised to ask about the gemstones that are included with the jewelry being sold back. Many jewelers won't pay anything for the diamonds or other gemstones included on the piece, so it pays

to ask upfront.

Check with the Better Business Bureau before doing business with a gold, silver or platinum dealer. Make sure there have been no complaints lodged against a particular dealer, before you do business.

If you have antique or intricate jewelry, it is wise to have it appraised before selling it to a buyer who pays by weight. "Sometimes the piece is worth more sold as a unique piece of jewelry, than for the amount of gold it contains," said Curtis.

Do not do business with a dealer who quotes another price after the customer rejects the first price offer. "If a dealer is not honest the first time around, walk away," said Medawar. "You should be given the very best price the first time you ask."

It is also advised to comparison shop. Get several bids before you sell. Medawar advises people to go to a reputable jeweler. "We try to pay the most, because we have a standard to uphold," said Medawar. "If we sell the best quality jewelry at the lowest prices, then we should also buy jewelry back from our customers at the best prices."

You can find the most recent spot prices for gold at [www.kitco.com](http://www.kitco.com). This isn't the price you'll get for selling your gold, but it will provide a basis for evaluating offers.

Be realistic about what you'll get for your gold jewelry. For example, a 14-karat ring is only 58 percent gold, the rest is base metals.

Even though interested students are required to try out for every sport, there are sports that will accept every student willing to participate. And, if there's a low number of participants, sports such as tennis and swimming are usually non-cut and will keep all students. Cross-country is a major fall sport that welcomes anyone willing to try.

Michael Bakker, athletic director for Fenton schools, said that non-cut sports give every student a chance to be part of a team. "If you're really on the fence about a sport, there's no harm in trying," Bakker said. "I encourage kids to take a leap of faith. The worse that can happen is you spend two or three months getting in shape."

Bakker said that the friendships made from being involved in sports go beyond competing and can last an entire high school career.

Unique to Fenton High School and Holly High School are equestrian teams, which allow students to ride horses and the chance to compete in regional and state competitions.

Fenton, Linden and Holly high schools all require physical examinations from a doctor before students can participate in a sport. Also required are academic standards where students must pass the majority of their classes. Once students meet the physical and academic requirements, they are presented with an eligibility card that must be presented to the coach of the sport they are interested in. The eligibility card allows students to play any sport for

the school year and even multiple sports at the same time. Students must try out for the sport that they are interested in.

Students interested in playing sports at Holly High School must pay a one-time \$120 fee for the year. At Fenton High School, students must pay \$200 to play sports for the 2011-12 school year. Linden High School requires a \$125 fee with an additional \$50 trainer fee.

Vankuiken recommends students to visit the school's website for further details on what sports are offered. The seasons are split into fall, winter and spring sessions. "If you're looking at a sport, do it that year and don't wait," Vankuiken said. "If you wait, you'll fall behind a little bit."

season with an abundance of experience. Yet, the Eagles averaged 33 points a game, defended their Metro League title and finished the season with a 7-3 mark.

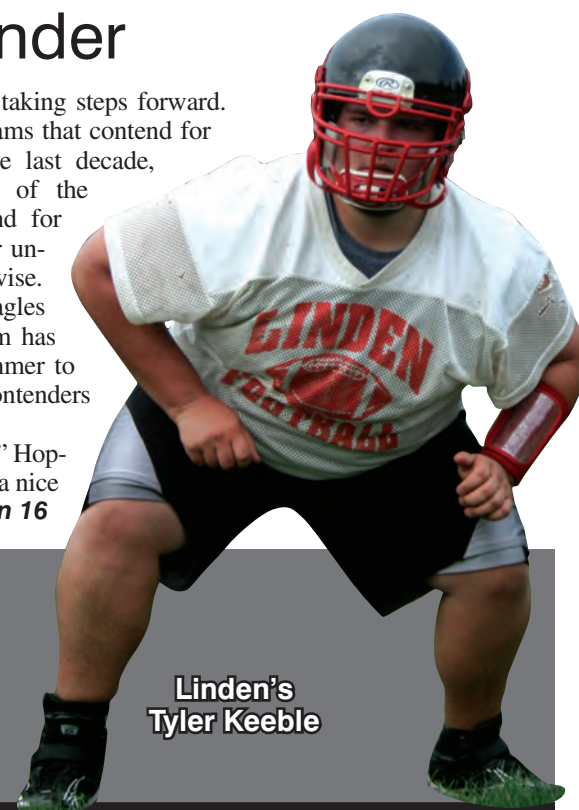
This year the QB battle is wide open, but the Eagles are excited about finding some answers.

## Football teams experience midnight madness

### ►LF enthusiastic about turning around last year's 3-6 fortunes

**Lake Fenton** — This seems to be the year of change at Lake Fenton.

That was apparent at midnight on Monday.

Never before have the Lake Fenton Blue Devils participated in a midnight madness practice during the first official day of prep football practice, at least until this year. # Bronchos expecting to earn another playoff spot

**Holly** — There was a different atmosphere at Holly's varsity football team's first official practice of the MHSAA season on Monday.

Players moved with purpose. And there just seemed to be more of a sense of confidence than in many other years.

That may have had something to do with last year.

For just the second time in school history, the Bronchos entered this year after a playoff season. The year also included wins against area foes Linden and Fenton.

Many of the players that made last year possible return for the Bronchos, creating a nice sense of enthusiasm that is well deserved. And that showed on Monday. Yet, the Bronchos are not resting on their laurels.

"Practice started off pretty good," Holly's senior captain Ryan Houldsworth said. "It's tough getting back in a rhythm, but we are all excited about getting back in our pads, and getting back in the mode. We are all really excited for the season. We all have a lot of expectations for ourselves, that we can play at that level. We are looking to do some damage this year."

"I think (last year) brings some newfound confidence that's always good," Holly coach Ryan Culloty said. "Last year we tried to establish something. This year we want to show it was not a novelty."

And that is a fair concern. In 2006, the Bronchos made the playoffs for the first time in school history, but then followed that with just seven wins over the next three years. The Bronchos don't want to see a repeat of that again this time.

"We can't focus on the past and expect to play good in the present," Houldsworth said. "You have to keep working, fighting and keep that edge. You have to have that hunger all the time or else you'll find yourself falling back. We are not a team looking to do that. We want to remain hungry and keep fighting."

The Bronchos did lose some pieces from a year ago, but return enough to make this season look like they can improve upon their 6-4 mark from a year ago. The primary piece that many will notice is that quarterback Johnny Williams returns. The sophomore had a strong first season, and, at times, was sensational last year. The defense also returns most of the pieces, looking like a unit that can make a serious stride toward improving this year.

"We have seven returning on offense and eight returning on defense," Culloty said. "We are long in the tooth coming into this year, we have a phenomenal group of seniors. This is one of the first graduation classes to go through our youth football program and it shows. They have a different football IQ."

It was a busy summer for the Bronchos. They hosted 7-on-7 events on campus and made their annual trip to the Albion College football camp. They also spent a lot of time in the weight room. And while those things have helped make the squad a better program, it has had other benefits.

"This team is really close," Houldsworth said. "We've been growing up since the third grade together. Everyone is hanging out and talking. When you have a team bonding and 11 guys playing together as a unit, you are tough to beat. That's my favorite thing about this team. We show up,

have a good time together but we are willing to work hard to accomplish our goals."

The year of varsity experience will help as well.

There will be one other change this season. The Bronchos are changing their colors back to what they were earlier in their

history — from red and white to red and silver. Culloty did some research and noted that from 1950 to 1965, with the silver and red colors, the team had 12 seasons of .500 or better football. Since then, the team has had just seven winning seasons.

"They even changed the fight song from the red and gray to the red and white," Culloty said. "We decided to bring the gray back."

The first time fans will get to see the gray will be at Saturday's team scrimmage. The first game won't be until Aug. 26 when the Bronchos host Lapeer East.

## Garcia records strong summer wrestling around the nation

Fenton resident Drew Garcia had an outstanding rookie season at Detroit Catholic Central on the varsity wrestling team.

His resume would be the envy of just about anyone in the sport.

He took second in the Division 1 152-pound class, just being edged in double-overtime by a point from a state title. His team made it to the state championship match, losing to Oxford by a single point in the final match. Finally, Garcia finished with a 49-8 record.

But while others look at those results and may feel happy with their performances, Garcia does the opposite. He sees it as coming a point away from two state titles and one win away from a season-milestone 50 victories.

And, perhaps, that's why he's worked so hard this summer. And what a summer he's had. Garcia went to Florida where he posted a perfect 7-0 Greco-Roman wrestling record and a 7-2 freestyle mark. He then went to Fargo, ND for the USA Greco-Roman and Freestyle Wrestling Championships and finished third in Greco and fifth in freestyle against some of the best wrestlers in the nation.

"I learned (last school year) that you must keep going over the summer," Garcia said. "During summer wrestling you gain a lot, and there are kids that are not doing anything, and you are still going. If you put the time and effort in, that's going to help you a lot during the season. I feel should be a lot better than last year."

There really isn't that much room for improvement. Yet, it's those three mea-

sures mentioned earlier that Garcia remembers.

"I went into (my state championship match) 1-1 into double-overtime. He took (the down position) and got up. Then when I was down, he hung on my leg and I couldn't get away. What I remember is I felt like I didn't wrestle the best match I could've wrestled. I felt I didn't open up a lot. The nerves got to me. I pinned him the last time I wrestled him."

Garcia's workload has been extensive this summer. His trip to Florida qualified him for the national competition in Fargo. At Fargo he came within one match of a national title in Greco-Roman, only losing to eventual champion Cody Law by a 1-0, 2-0 verdict.

"I wrestle a lot during the summer," Garcia said. "Just between the last two events,

I probably wrestled about 30 times. I've probably wrestled about 50 times."

Freestyle and Greco-Roman wrestling vary in a few ways, but the most noticeable is where you can attack. Greco-Roman wrestling only allows an opponent to attack above the belt. Meanwhile, in freestyle wrestling you may use your upper body and your legs. Prep wrestling uses freestyle. The summer wrestling has been beneficial to Garcia.

"You learn a lot more about yourself," Garcia said. "For instance, you find yourself in positions where you are down 3-0 or 2-0 and you have to come back. You have to dig deep to come back and win. That helps show what type of character and dedication you have to the sport. You just have to keep pushing."

He's also had to learn how to fight through adversity in terms of injury.

"I hurt my knee in my first match in freestyle, so I had to keep on pushing through," Garcia said. "It was pretty painful, but you can't stop. You have to find a way to wrestle despite it."

Garcia's knee is healthy once again.

Garcia, who went to Linden Middle School before going to DCC, has some clear goals for his sophomore season.

"I want an individual state title for sure, and also want a team state title, because that means a lot," the 3.80 GPA student said. "I want to go undefeated next season and the whole season."

26-24 verdict, will be playing in the second game of the day on Saturday. There are doubleheaders on Thursday and Friday as well.
