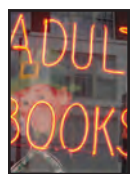

The high cost of recall elections

► Local municipalities pay 100 percent of recall, special elections

The recall effort against State Rep. Paul Scott, (R) Grand Blanc, may be costly for municipalities in the 51st District. In the city of Fenton, Fenton Township, city of Linden and Argentine Township, the typical

election costs about \$5,000, according to the clerks.

The cities of Fenton and Linden are already holding elections on Nov. 8, so if the recall were on the ballot, it would not cost extra.

A November election is not scheduled in Fenton and Argentine townships. If Scott’s

recall were approved, both municipalities would have to hold a special election.

Fenton Township Operations Manager/Deputy Clerk Thomas Broecker said that preparations are already underway for the election, in case the recall does go through. “We’re moving

forward as if it’s going to take place,” he said. “The election will cost \$5,000 to \$6,000. It is an amount we would have to make room for in the budget. Is \$5,000 or \$6,000 going to cancel a road project? Probably not, but it is still money we need to make up for.”

Results of sewer hole death investigation could take weeks

► MIOSHA will release findings when report is complete

It could take two to three more weeks before findings of an investigation are re-

vealed by the Michigan Occupational Safety and Health Administration (MIOSHA).

The state is investigating an incident,

which resulted in the death of Ronald Utica, 45, of Swartz Creek. He was an employee of Bender Pociask Construction, Inc. He died after falling head first, possibly breaking his neck, into a large sani-

tary sewer manhole in Fenton Township after succumbing to the toxic fumes of methane gas.

Utica’s colleague, Joseph Filpansick, 30, of Clio, who works for Nix Contracting, of Fenton,

SMART SOLUTIONS



1 Sliding dog dishes

To keep your dog dishes from sliding across the room, try this trick: Snip six wide rubber bands with scissors to create flat strips, then superglue a few pieces across the bottom of each dish. The no-slip rubber surface creates friction between the dishes and the floor.

2 Alleviate cramps

Next time period cramps cost you precious sleep, try this: Lie on your stomach with your legs together and your chin on the mattress. Clench your hands into fists and place them under your hip bones. Inhale as you lift your legs a few inches and hold for 30 seconds, then lift them a little higher and hold for 10 seconds; lower slowly. This yoga move, called the Locust Pose, stimulates a series of acupressure points that balances the flow of energy through the lower abdominal region, relaxing muscles and soothing cramps so you can fall back asleep in seconds.

Do the math. The cost of outfitting a family with back-to-school clothes and supplies will set their budget back this fall about \$604, according to the National Retail Federation. This figure is actually down just slightly about \$2 from last's year figures.

Some families start shopping early to avoid not only the big rush of shoppers the week before school starts Tuesday, Sept. 6, but also to pace the expense.

Village residents feeling the sting of high water rates

Holly — Residents of the village of Holly are not happy after water bills arrived recently, reflecting the increased rates to cover the sewer bond debt.

The new bill includes bond debt service, and a minimum base rate, that cover paying back the bonds used to finance the water plant, and to cover operational costs.

The Tri-County Times received a number of Hot lines and online comments on the issue, with one anonymous Hot liner stating that his or her water bill is now "as much as a car payment."

Missie Scofield saw her water bill increase by about \$50 in the most recent bill, and she said it takes a big chunk out of her budget. "We've got three kids in college," Scofield said. She admitted her family is lucky, as her husband is still employed by the auto industry. Paying more for water means cutting back — less eating out, shopping downtown, and washing their cars by hand. "It's a sore subject," she said.

Scofield is frustrated because she doesn't understand why the bond issue that caused village council to raise rates wasn't handled sooner.

Janie Slagell, of Zanie Janie's Simply Coffee in downtown Holly, said water bills are a constant source of discussion for her customers, many of which are older and on a fixed income. She is

required to pay a base rate of \$48, which is higher than the amount of water the business actually uses.

Dan Straub owns a bed and breakfast in downtown Holly and said his bill increased from around \$175 to \$240. The rate increase doesn't affect his life or his rates at the bed and breakfast. "Life goes on," he said. "You just have to pay more."

Council member Don Wingelmire said numerous residents spoke publicly at Tuesday's Village Council meeting to express frustration, and asked why other methods, such as a millage, weren't used instead of raising rates.

The council made a decision on a rate increase in May, following a contentious public forum.

Wingelmire said these debts were enterprise funds, and had to be paid out of their direct use. "(The bonds) have to pay their way," he said, meaning a millage could not be used to raise money for the bonds.

Wingelmire owns several properties, including his furniture store downtown. "I think I've got five or six meters I'm paying for," he said, adding that he voted for the rate increase. "I may not like it better than anybody else."

Unlike in the past, the council has the ability to examine and adjust the rate schedule every six months, if it is needed. Wingelmire said he believes the rates should have been raised to cover costs incrementally, instead of all at once.

Summary

►The water and sewer bills sent at the end of July reflect the rate increases voted on by village council in May.

Rescue workers located two hikers Wednesday afternoon, after they failed to return from a three-day trip along Lake Superior in the Upper Peninsula (UP), where the terrain is rocky and dense with woods.

Keweenaw County Sheriff Ron Lahti announced Wednesday afternoon that Elizabeth Hunter, 26, of Holly and James Murphy, 24, of Fenton were found

and were in good condition after a search plane spotted a fire and a man waving to bring attention to themselves.

The sheriff's department and the U.S. Coast Guard searched by helicopter and the Civil Air Patrol and searchers went out on all-terrain vehicles to look for the pair.

Hunter and Murphy were dropped off last Friday at High Rock Bay at the Eastern tip of Keweenaw in the UP. Hunter and Murphy were expected to reach Bete Grise on Monday, but did not arrive.

Linden City Clerk Martha Donnelly said that although Linden is already having an election this November, the recall may put extra strain on the city. "It is going to be an extra work load," she said. The city will save about \$1,500 in the November election by consolidating the two precincts into one.

The city of Fenton is also having an election this November. Clerk Jenifer Naismith said that the city spends roughly \$3,000 on workers and \$2,000 for supplies and for organizing an election.

Summary

►A recall of state representative Paul Scott may cost cities and townships in the tri-county area \$5,000 to \$10,000.

If Scott is voted out of office on Nov. 8, cities of Fenton and Linden, Fenton and Argentine townships, and all other municipalities in the 51st district would have to hold special elections on Feb. 28 in order to elect Scott's replacement.

"Municipalities will not be reimbursed for the election, so 100 percent of the cost will be out of pocket," Donnelly said. The Bureau of Elections office in Lansing is currently reviewing the 12,155 signatures collected to recall Scott. The bureau will announce on Sept. 9 whether or not enough valid signatures were collected and if a recall election will be held.

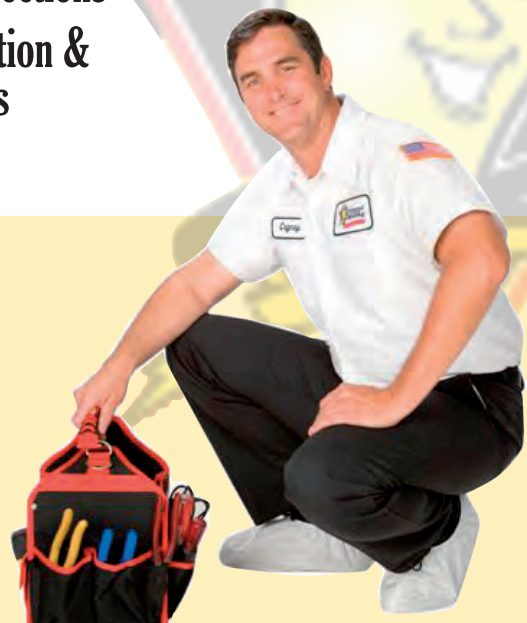

was overcome by the toxic fumes and was injured after he fell into the sewer hole, too.

From their investigation, the Genesee County Sheriff's Department believes Utica attempted to rescue Filpansick, who fell in first. Sheriff Robert Pickell said Filpansick was hospitalized and he might have suffered a skull fracture.

The men were working on an excavating project at Price's Airport at Horizon Lakes Airpark and were preparing to connect a sewer line on the state-owned property to a sewer line in Fenton Township.

It is suspected that Filpansick and Utica were not equipped with the proper safety equipment to do such work. However, the investigation is in the early stages, and findings will be issued by MIOSHA investigators.

Linden Police Officer Gary Conklin was the first responder to the scene after hearing the call on his dispatch radio at about 4 p.m. The airport property is in Fenton Township and borders Linden City.

Conklin, wearing a breathing mask he carries in his patrol car, entered the

20-foot hole in an attempt to rescue the men. He was able to turn them over and got their faces out of the sewer water, which was about two feet deep. Starting to feel the affects of the toxic fumes, he climbed out of the hole.

An employee of Schwan's, who was nearby, also climbed down the hole to help. The sheriff's department and paramedics, Fenton Township Fire Department and the Michigan State Ranger Patrol responded to the scene. The unconscious men were removed from the hole and paramedics performed lifesaving techniques. The two men were transported to Genesys Health Park in Grand Blanc Township, where Utica was pronounced deceased.

Adrian Rocskay, director of general industry safety and health division of MIOSHA, said Wednesday that the report would have to be complete before any results are issued.

Linden Police Chief Scott Sutter said his police department has been cooperating with MIOSHA investigators. Investigators met with the chief and Conklin at the police station and questioned them as to what information they had regarding the incident.

Q: I have a 1994 Pontiac Firebird w/88,000 miles. The frontend has not sounded tight or reliable since I bought it. I recently merged onto the freeway and felt a snap in frontend. It made a REALLY loud clunking noise, so I stopped it ASAP. I noticed it did not make this noise in reverse. Any ideas? It is now undrivable until I get it towed. -Trenna

A: Trenna, I would recommend that you have it towed to a repair shop and looked at. Anytime that you are dealing with a steering or suspension noise like this, it could be serious. It could cause you to lose control of the vehicle by not being able to steer it properly causing an accident or injury.

and Tomek-Eastern elementary schools. The program is also available to Young 5 students. All KinderPlus students will have transportation to and from school.

Kindergarten and Young 5 students will attend school from 8:40 a.m. to 3:35 p.m., the same hours as other elementary school students.

Parents of half-day kindergarteners will have to provide transportation for their child, depending if the child attends morning or afternoon classes. For more information on the KinderPlus program, parents can call the administration office at (810) 591-4700 or any of the elementary schools in the Fenton school district.

At Andrew G. Schmidt (AGS) Middle School, sixth-graders are entering their first year sharing a building with seventh- and eighth-graders. Principal Heidie Ciesielski said that the necessary preparations have been taken to welcome sixth-graders at AGS. "We will definitely be ready for the sixth-grade open house, orientation, and registration," Ciesielski said.

LAKE FENTON COMMUNITY SCHOOLS

There are very few changes in store for returning Lake Fenton students. Superintendent Wayne Wright said classrooms and courses are remaining the same. Supplies for the teachers remain the same and playgrounds were upgraded last summer. Wright said he would be looking to see if there are any positions, he could eliminate when he attends an administrators' retreat this week.

"I do not see many reductions as I am anticipating an increase in students this year," he said. "We are in fact adding a teacher at the high school as I am anticipating the high school growing from 540 (students) last spring to about 575 this year."

Officially, teachers begin the new school year on Tuesday, Aug. 30.

LINDEN COMMUNITY SCHOOLS

Students and their parents probably won't notice too many changes at any of the Linden school buildings when they return after Labor Day.

Superintendent Ed Koledo said, with the school board's approval to allow the fund equity to dip down to 3 percent, programs and buildings will remain the same for this school year.

School (SMS) to save the school district money will affect all students of middle school age, who will be attending grades six, seven, and eight, in Holly Area Schools (HAS).

Seventh- and eighth graders will now be housed at the Karl Richter Campus (KRC) on Baird Street. The middle school program at KRC has officially been titled "Holly Middle School."

Instead of all sixth-graders moving onto the middle school, they will be retained at their respective elementary schools for one more year. Holly Elementary School will keep around 60 students, according to new principal Franklin Cox.

"We are excited to welcome our beginning band program for fifth- and sixth-graders," said Cox. He said art, physical education, and Spanish are available to all students through sixth grade.

Rose Pioneer and Patterson elementary schools will also be accommodating an extra sixth-grade class.

SMS Principal Linda Skrzynski will move to KRC, becoming the principal of Holly Middle School (HMS), and said she is eagerly awaiting the arrival of the 558 students enrolled in grades seven and eight at KRC. "We expect to see that grow," she said.

Programs at KRC will reflect ongoing faculty education. "We will enhance instruction using Readers' Workshops, after school enrichment programs, and academic support time as well as opportunities for extra curricular programs," she said. Students

at KRC will have access to technology, with new Mac books, iPads, and Thinkpads.

Skrzynski said there would be three lunch stations set up to minimize waiting in line, and costs will be the same as last year, at \$2.75 for a full lunch, and \$.40 for a reduced fee lunch.

Buses will drop students off at the middle school at 7:25 a.m. Students will be dismissed at 2:27 p.m. Skrzynski said parents and caregivers will receive information packets with all pertinent information by mail, soon.

Skrzynski suggests that parents and caregivers review the student handbook on the Holly Area Schools fusion website to make sure they understand the dress code before purchasing new clothes.

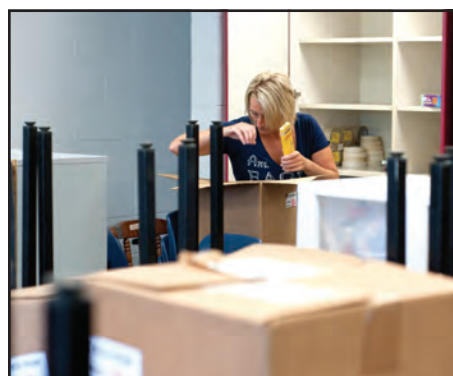

Hall of Fame. As one walks into his home, it's apparent that Toth has lived a life as colorful and diverse as the music he continues to play.

Toth picked up a violin when he was 10 years old while living in Flint. His parents gave the instrument to his sister but when she lost interest in it, he jumped at the chance and learned to play it by listening to the radio. He and some buddies formed a band when they were just 12 years old and were regularly asked to play at school functions and dances. He graduated from Central High School in Flint in 1942.

Toth joined the U.S. Marine Corps, and officers routinely asked him to join them for evenings out so that they could listen to him play. He eventually did some shows with the USO in Corpus Christi, Texas, during World War II. He didn't realize until much later that he was probably surrounded by many well-known stars.

Often heard on the radio, Toth became well known in the music industry for his talent playing the fiddle and other instruments. He dedicated one song, "Five Foot Two," to the love of his life, Dolores, and told her to listen to the radio. She was surprised that he could play the violin so well. When asked why he kept his talent hidden from Dolores, Toth said, "I didn't want to shock her." The two were married from 1948 until she passed away in 1997.

After serving his country, Toth returned to Flint and was founder and president of TV Engineers, Inc. from 1950 to 1980. He also worked for several years at Michigan Bell, in Flint.

In 1953, he became partners with Sonny Sexton and ran the Wagon Wheel Bar at Richfield and Center roads until 1975. The men have been credited for bringing in an enormous amount of musical talent to the Flint area.

The Toths moved to their Silver Lake home in 1964, where they raised four children, Leslie, Carrie, John (J.T.) and Donna. There are 11 grandchildren. Toth's musical talents have been continued on by his children and grandchildren.

Toth traveled across the United States and joined many country music legends on stage, including Roy Acuff, Hank Williams, Sr., Minnie Pearl, Barbara Mandrel, and Johnny Gimble, to name just a few. He was asked to perform at Bill Clinton's presidential inauguration; however, his wife's failing health prevented him from accepting the invitation. He did play a Stradivarius violin in front of the Vienna Boys Choir in Vienna.

His engineering company sponsored the Ken-ny Roberts show in the '60s, which was filmed at the Durant Hotel in Flint. He played the fiddle for the show. Michael Landon, Little Jimmy Dickens, Jimmy James and other stars appeared on the show. Sexton, and Sylvia Jo, two of Michigan's Country Music Hall of Fame recipients, were regulars on the show.

In between performances, Toth has

been traveling all over in his RV for another one of his passions — hunting and fishing. He has an interesting story for every prized animal hanging on the walls in his home.

Very proud of their father, Leslie Trout, of Swartz Creek and J.T., of Fenton and the rest of the family will be attending the festivities and induction ceremony in Hastings over Labor Day weekend. Leslie said, "Dad's home is always filled with music. There is never a day that you don't see him with his fiddle or some instrument in his hand."

As for how Trout feels about his latest accomplishment, she said, "You just can't imagine. He's amazing, but he's so shy about it."

Echoing his sister's sentiment, J.T. said, "I'm so proud of him. He's an awesome individual."

Toth's children said, without a doubt, their favorite song to hear their father play on the fiddle is "Orange Blossom Special." "It would bring the house down at bars," said Trout.

With his vast selection of songs to choose from, Toth said his favorite song depends on what he happens to be doing

at the time.

His fingers might not be as nimble as they were 70 years ago, but anyone listening to Toth play will surely understand why he is being recognized for his lifelong love of country music. If there's any doubt, check out this old video clip on YouTube by searching for "Johnny Toth."

enough valid signatures for a recall." The bureau is also checking to make sure the petition was filed correctly.

Gary Carnahan, a retired teacher from Linden, filed the petition. He could not be reached before press time.

Under current Michigan law, a recall is granted to a district if the signatures match at least 25 percent of the total votes cast in the last gubernatorial election, or if 9,604 signatures are collected within the 51st District. All of the signatures have to be collected within 90 days of being granted a petition and must come from registered voters in that district. City of Fenton, Fenton Township, Linden City and Argentine Township are all within the 51st District.

Scott was elected to his second term during the 2010 election. As the chairperson of the House Education Committee, he has been a major influence in teacher tenure reform in Michigan and public education funding. Under current legislation passed by Gov. Rick Snyder, tenure for teachers requires five-year probation instead of four. Teachers who have tenure may be fired if they are ineffective at his or her job. Collective bargaining has also changed, as well as the "last one hired in, first one out," method of employment.

The Michigan Education Association (MEA) does not agree with Scott's new policies, viewing tenure reform and other changes as an attack on their profession and public schooling. A statement on the MEA website said, "Every (MEA) member's job security is threatened and every member's economic security is threatened. And when the job and economic security of education employees is threatened, the education of our children is threatened... There is too much at stake

for anyone to not be engaged."

Scott said the MEA has used thousands of dollars in the 51st District in the effort to overturn politicians elected to office in 2010.

"The special interest groups have decided to pick a fight with Snyder, and unfortunately, our community has been caught in the crosshairs," Scott said.

"People not from our community are trying to protect their piece of the pie in Lansing. I feel strongly that the will of the voters is being overturned by this recall."

Scott said that the recall is a clash between the old and the new way. "The special interest groups want to keep a status quo that has led to double digit unemployment. Snyder and I are committed to bringing jobs back to this state."

Sen. John Gleason does not think Scott has done anything to deserve a recall. "I'm against the recalls. Elected officials have constitutional rights, as well," Gleason said. "You shouldn't be removed from the office if you uphold the law."

Gleason supports increasing the minimum number of required signatures to 75 percent of the total number of votes casted in the last gubernatorial election, as opposed to the current 25 percent.

Woodhams said if there are enough signatures, a recall election would be held on Nov. 8. If Scott is voted out of office in that election, a special election for his replacement would be held on Feb. 28.

Woodhams also said that if there are not enough signatures, validated by the election bureau, petitioners can try again but will have to collect new signatures.

"Even if they did collect enough, it would have to be for a future election," Woodhams said, as the deadline for a 2011 recall election was this past August 5.

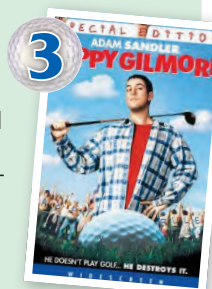
Tin Cup (1996)

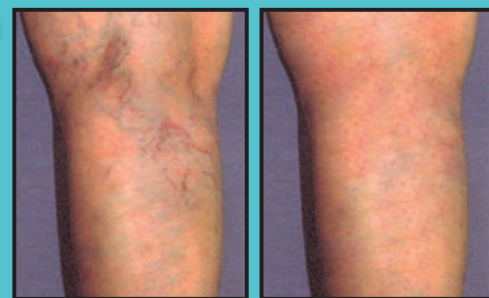

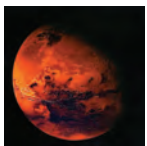

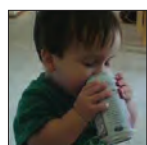

Nasa discovers water on mars



NASA scientists have discovered new evidence that briny water flows on Mars during its warmest months, raising chances that life could exist on the Red Planet. NASA scientists believe that if there is liquid water on Mars, it would be highly salty and lie beneath the surface. That would explain why it would not freeze in the planet's frigid surface temperatures, which can fall to around 200 degrees below zero Fahrenheit (minus 128 degrees Celsius), or evaporate in its low air pressure. The scientists on NASA's panel stressed that liquid water is more likely to sustain life than ice, underscoring the importance of the latest discovery.

More than 900 'Lucy' look-alikes honor Lucille Ball's 100th birthday

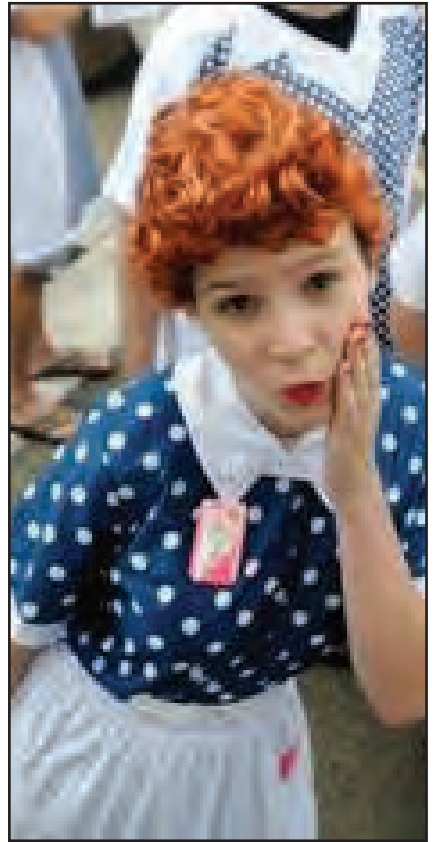

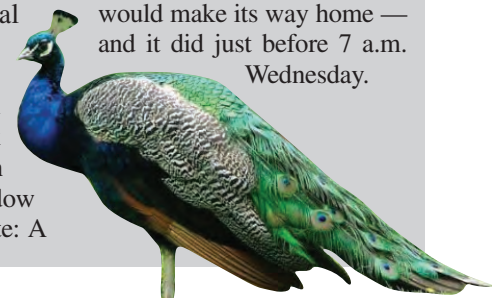
Flyaway peacock returns home to zoo

Bigger feet A growing shoe problem for women

as average female shoe size has increased to a size six over the last 10 years, and demand for size nines has triggered an 80 percent increase in stocks at the department store, Debenhams reports.

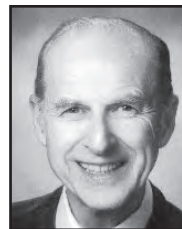

Don't let money matters get you down

A young, unemployed father was feeling down about the economy and expecting the worst. After all, he'd been searching for a job longer than he liked to remember.

'Things are going to get better,' I said, hoping to encourage him.

'How can that be?' he asked.

Speaking from many years of experience, I assured him that money matters are usually temporary and the future often turns out to be better than we expected.

The late J.C. Penney would have agreed. Penney said his most trying experience came as a result of making unwise personal commitments just prior to the financial crash of 1929. During the financial crunch, he found himself so troubled that he couldn't sleep and developed shingles, an extremely painful affliction. His condition then became so serious that he was sent to the Kellogg Sanitarium in Battle Creek, Mich.

None of the treatment there seemed to help and he grew weaker day by day, soon being filled with despair and unable to see even a tiny ray of hope. One night, he wrote farewell letters to his wife and son, saying he did not expect to see the dawn. Then, Penny's perspective underwent a complete change.

Let him tell about it.

'When I awoke the next morning, I was surprised to find that I was still alive. Going downstairs, I heard singing in a little chapel where devotional exercises were held each morning. I can still remember the hymn they were singing, 'God will take care of you.'

'Going into the chapel, I listened with a weary heart to the singing, the reading of the scripture lesson and the prayer. Suddenly — something happened. I can't explain it. I can only call it a miracle. I felt as if I had been instantly lifted out of the darkness of a dungeon into warm brilliant sunlight. I felt as if I had been transported from hell to paradise. I felt the power of God as I never had felt it before. I realized that God with His love was there to help me. From that day to this, my life has been free from worry.'

Penney's chapel encounter with God dispelled his fears and prepared him for a bright and successful future as the founder of the department store chain that bears his name. He had learned that God really cares.

I was born one year to the day after the financial crash of 1929 that affected J.C. Penney, and lived through the Great Depression, so I understand something of the panic of that perilous period.

I could then speak with understanding to the troubled and unemployed young father who feared the current financial conditions would never change.

I have learned that God is bigger than our fears, better than our faith, richer than our debts and stronger than our enemies are.

And, God will take care of you.

Oakwood Cemetery in downtown Fenton continues to have drainage problems, due to the many hills, old trees and mostly dirt roads.

Cemetery board asks city for help

► Drainage issues still causing problems

Fenton — For years, anyone who has driven through Oakwood Cemetery has most likely navigated around a few dips and bumps in the mostly dirt roads.

Winding roads through the hills lead guests to the final resting spot of their loved ones and the Oakwood Cemetery Board would like to make those travels a bit smoother and safer. They would also like to have the drainage system upgraded so that headstones in the lower lying areas are not under water.

Doug Tebo, chairperson of the Oakwood Cemetery Board approached Fenton City Council on Monday to inform them that eroding roads and flooding are ongoing problems.

With this summer's recent heavy rainfall, problems really "came to a head," said Tebo. In the Babyland area, some of the headstones were barely showing due to the amount of standing water in this low-lying area. "We found and raised Babyland headstones and we've taken care of the run off," he said.

Tebo said they have also installed a 45-foot long culvert from the maintenance shed to the woods, in an attempt to improve the drainage. He credited the city's Department of Public Works for hauling in fill to take care of the erosion.

According to Tebo, the drainage problems continue to escalate and some time soon the city would need to address the storm system. "We have to get started some place to get good drainage and not lose roads," he said.

In 2002, the city's engineering firm presented findings from a study it conducted at the cemetery, at no cost. The topography of the 40-acre parcel is a contributing fac-

tor of drainage problems.

Tebo asked that the city start looking at long range planning to address the roads.

With Munfah's 2002 plan, a new drainage system and grading would help to reduce the problems significantly. Once the area is stabilized, paving could be considered.

City Manager Lynn Markland said early estimates were \$300,000 and current costs are more likely to be \$500,000.

Councilman John Rauch suggested the city have its current engineering firm look this matter over for an estimate before the city moves forward with any plans.

The cemetery budget for fiscal year 2011-12 is \$61,950. This is up \$2,000 from what was budgeted for fiscal year 2010-2011. The increase is to cover the increase in costs for the maintenance contract.

Revenues for the cemetery break down to approximately \$19,200 from grave openings and lot sales and \$43,750 contributed from the General Fund.

When asked if the cemetery could be included in the city's DDA district, Czarnecki said DDA Director Mike Burns told him there has been no talk about adding the cemetery to the district. It would have been a huge reach to consider adding the cemetery when the district lines were drawn, as the cemetery is not adjacent to the DDA district.

The 2001 report by Ayres, Lewis, Norris & May, Inc., who Munfah worked for at the time, indicated needed storm sewer improvements were estimated to cost almost \$200,000. This estimate did not include any upgrades to the gravel roadways found in the cemetery.

Czarnecki said to his knowledge none of this work has been completed.

"At this time, with the current fiscal situation for the city of Fenton, I do not see any storm water improvements being tackled in the cemetery in the upcoming year."

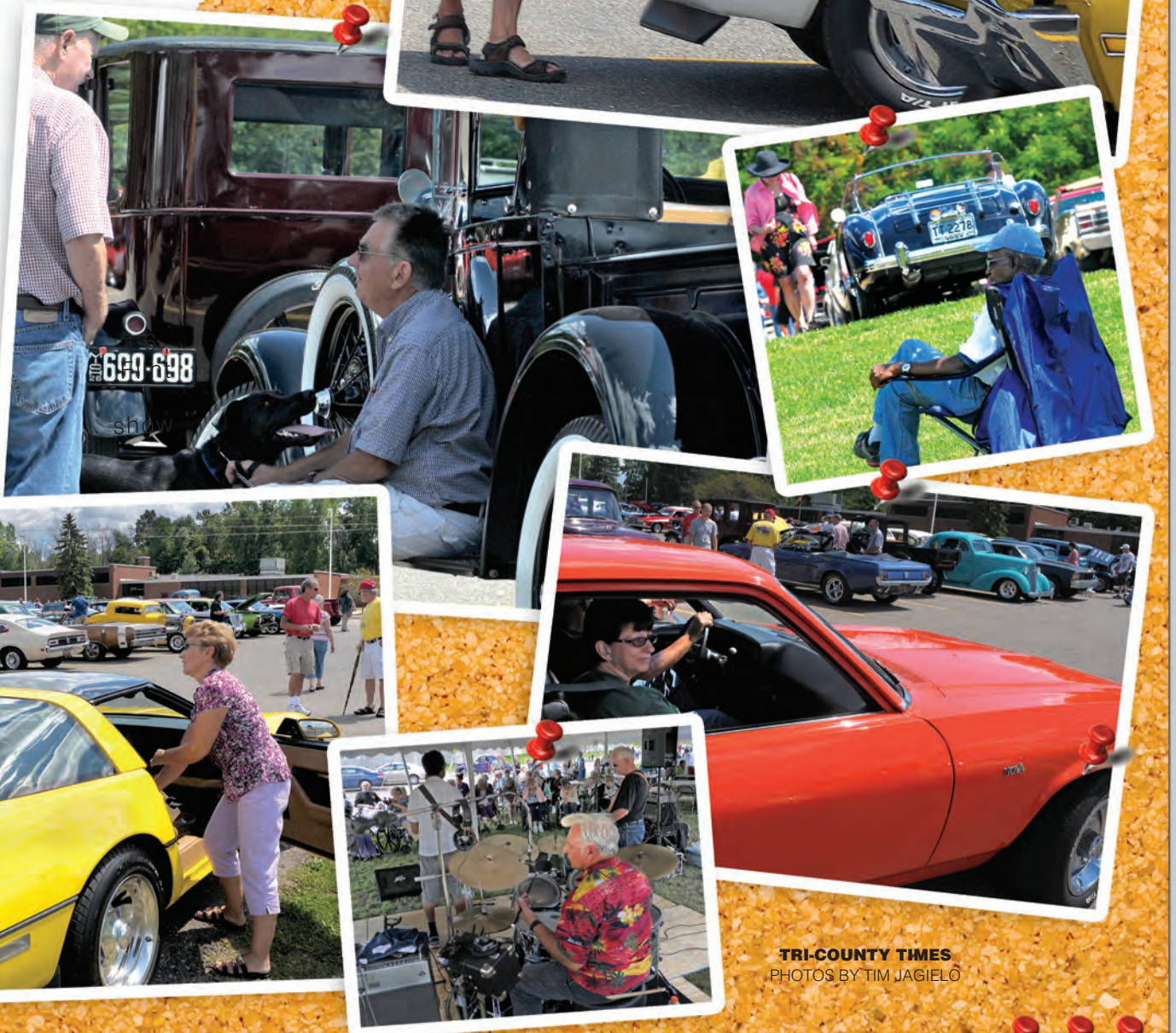

Honey mustard and red onion barbecued chicken

Ingredients

- 2 t. vegetable oil
- 1/2 red onion, chopped
- 1/4 c. apple cider vinegar
- 1/4 c. brown sugar, a couple of handfuls
- 1 c. chicken stock
- 1/2 c. prepared honey mustard
- 1/2 t. allspice, eyeball it
- 1/2 t. curry powder, eyeball it
- 4 boneless, skinless chicken breast
- 4 boneless, skinless chicken thighs
- Vegetable oil, for drizzling
- Salt and freshly ground black pepper

Directions

Preheat grill pan or griddle over medium high heat. Pour 2 T. vegetable oil into a small saucepan over moderate heat. Add red onions and saute 3 to 5 minutes. Add vinegar and reduce by half, 1 to 2 minutes. Add brown sugar and cook 1 minute to incorporate. Whisk in broth and honey mustard, allspice and curry. Bring sauce to a bubble and reduce heat to lowest setting. Coat chicken with a drizzle of oil and salt and pepper, to your taste. Place chicken on hot grill and cook 4 or 5 minutes, then turn. Baste chicken liberally with sauce and cook another 5 minutes. Turn once again and baste. Cook 2 or 3 minutes more to cook through and transfer chicken to a platter and serve.

paw's corner

To crate or not to crate?

Q: What's your view of kennel cages? My wife hates the idea of using one to train our dog Sandy, but I disagree. What do you say?

— Jerry in
Las Cruces, N.M.



A: I'm personally OK with the concept of crating (or kennel cages). It's an effective way to housetrain a puppy (who won't soil a sleeping or living area) and teaches it to stay comfortable and relaxed in a similar container, the travel crate, which is essential to traveling with your dog.

However, I do see frequent instances where the crate is misused, with negative consequences for dog and owner alike.

The crate also serves as a home or den for your dog. So it always has to be seen by Sandy as a safe place to be, perhaps the safest place in the house for her. If you use the crate to punish Sandy, such as shutting her up in it when she's being hyperactive or disobedient, she could associate it with negative feelings and avoid going into it.

I recommend you learn as much as you can about using the crate to train Sandy. The American Dog Trainers Network has a list of tips on furnishing the crate, getting her to accept it and using it as a positive training tool. Find the list here: <http://www.inch.com/~dogs/cratetraining.html>. It also includes important safety tips, such as always removing Sandy's collar before putting her into the crate, and making sure she's not left in an environment that's too hot or freezing cold.

DEAR AMY: My 25-year-old brother and I have a very strong relationship. My husband told me that my brother is smoking cigarettes. I really hate that he is doing this. Our grandfather died of cancer from smoking when I was just 12.

I talked to my brother about this but he denied smoking and told me that he only smokes one or two when he goes to a bar! Then a couple of days later my husband told me that my brother smokes a lot. I called him and he told me it's true. He said he lied to me to avoid an argument.

He sent me couple of messages saying he was sorry that he lied, but I can't take it — I feel betrayed. I don't know what he should do, so I can feel better!

DEAR SAD: Your brother has apologized repeatedly for lying to you. Accept his apology and thank him for being truthful now.

You don't mention asking your son about this, but you should — if only to clear up your confusion over who paid for the rehearsal dinner.

If he says his in-laws paid for the evening, get in touch with them. Thank them for their intention and generosity but tell them that you and your wife had budgeted for this expense and say you'd appreciate it if they would permit you to pay for the dinner.

After that, don't take this matter beyond the point of reimbursement. Otherwise it could quickly muddy your relationship with these new in-laws and affect your perception of what should be a happy event.

DEAR DR. DONOHUE: I have never seen you address acupuncture. I have had a bad back for three months, have seen two doctors and have followed their instructions. I have taken medicines that ease the pain. My back isn't as sore as it once was, but it still bothers me. Acupuncture has been suggested. What are your views on it?

—M.L.

ANSWER: I have no misgivings about trying acupuncture for pain relief. The Chinese have used it for centuries. Any treatment that lasts that long must have some value. Fine needles are inserted into the skin at specific points and are left in place for 15 to 30 minutes. From time to time, the acupuncturist stimulates the needles.

The American College of Physicians and the American Pain Society endorse acupuncture. A recent review article in the New England Journal of Medicine, a premier medical journal, also endorsed it. Who am I not to follow suit?

Back pain strikes almost everyone at some point in life. The booklet on it discusses its causes and treatments. Readers can order a copy by writing: Dr. Donohue -- No. 303W, Box 536475, Orlando, FL 32853-6475. Enclose a check or money order (no cash) for \$4.75 U.S./\$6 Canada with the recipient's printed name and address. Please allow four weeks for delivery.

DEAR DR. DONOHUE: It's that time of year again — the no-see-um season. I can feel a sharp sting when bitten. It goes away and then returns as a large swelling with incessant itching. What can I do to prevent this reaction? Others don't react this bad. I also use DEET to deter these diabolical pests. Should I wash it off as soon as I get indoors?

—C.R.

ANSWERS: No-see-ums got that name because they're barely visible, only 1/16th of an inch. Dawn and dusk are their busiest hours. Avoidance is the best protection. The red welt you describe arises about 12 or more hours after the bite and can be as large as an inch in diameter. It does itch.

DEET is the best repellent, but it's not a 100 percent barrier for all users. Have you tried a higher concentration? Are you following label directions regarding when to reapply it? When you get back home, wash treated skin with soap and water. Also, you can spray your clothes with permethrin. It will give you additional protection. Wear long slacks tucked into your socks and long-sleeved tops.

As for the itch, antihistamines are suggested. I admit they don't work for everyone.

coupons can be printed from their website, www.coyotepreserve.com. Monday through Friday, now through Aug. 31, Coyote Preserve offers 18 holes with cart for \$38 per person (with coupon), any age, and any time.

Nicolas Thompson, PGA professional at Coyote Preserve, said it's been important to set the right price to draw people out to the courses. The price has to fit within the comfort zone of the golfers to have a successful year. "The rates are cheaper than they used to be," he said.

Despite the wide range of weather, Thompson said their numbers are up this year, over the past two seasons. "The heat hasn't scared anyone off, but the rain obviously does," he said. Comparing a drought to a flood, he'd prefer the drought since the course responded by just watering the course more often.

While some courses shut down in the spring because of the heavy rains, Coyote Preserve's all-encompassing cart path, high grounds and drainage system kept the course open.

Jeff Mynatt, manager of **Bramblewood Golf Course** in Holly Township, said, "Overall, we're about even, numbers wise, which is good, considering the terrible spring we had." But nobody wanted to golf in the 90-degree days of July, he added.

Full memberships have just about doubled, said Mynatt. For a fee between \$250 to \$300, the membership covers a golfer's green fees for the entire season. If the golfer needs a cart,

they pay a \$9 cart fee. If they walk the course, they're good to go.

The full-membership deal has resulted in more league golfers. "League play is up because of the deal," Mynatt said. "Some play in two leagues now."

In spite of the dry July, the course has come back quite nicely, said Mynatt. "We went from one extreme to another, but it's playing beautiful right now."

Denis Husse, the club pro at **Tyrone Hills Golf Course**

in Tyrone Township, said it's been a tough year. The course was hit hard in April and May with so many rainy days. There were a few days they just shut the course right down. In his 34 years at Tyrone Hills, Husse said he's never seen a spring like the one we just had.

Comparing June, July and August, August so far has been doing really well. The recent downpours did affect the course, but overall, Husse said, "We've had a pretty decent year."

Season memberships run \$850 for a single member, with no cart. This covers green fees for unlimited golf. Carts can be rented, for an option. Season memberships with a cart for a single person run \$1,300. Couples memberships run \$1,100 for walkers or \$1,900 for those wanting a cart.

Husse said the season memberships are popular and couples can tack on memberships for their kids at \$100 each.

The junior leagues finished this past week. Husse said these youngsters golfed through the heat and staff members worked hard to keep water on the course and spray bottles handy to spritz water on the kids.

Fenton Farms Golf Club in Fenton Township has seen its share of "ups and downs" this season, just like the other golf courses. Christopher White, owner of Fenton Farms, said this season has

been challenging. "We've never rented more pumps. We kept flooding and we had thousands of feet of hose."

Although it is quite pleasant out now, White said once you lose days, you never get them back. If he has a good fall, overall, it will be a good season.

When the heat wave hit, he and his staff made a point of handing out complimentary cold bottles of water to all of their golfers to show their appreciation.

Due, in part, to the economy, Fenton Farms has lowered some of their prices. White said, from two years ago, a round was lowered by \$6.

In addition to the rain and heat, Fenton Farms lost 35 trees a few weeks ago to strong winds. Recently when 7½ inches of rain fell during a span of two days, White said his 18th fairway was under water. He went out there and stood in knee-high water. There was so much water that a pond overflowed into the fairway, allowing the little Sunfish to eat worms emerging from the ground.

On Mondays and Tuesdays, the course has a \$25 special, which includes 18 holes with a cart, for any age golfer. It is recommended to call ahead for a tee-time. Fenton — Jody Barnes thought it was a regular doctor's appointment.

She was taking her child, Malachy, in for a regular pediatrician appointment. But she got some less-than-regular news.

"They said they thought they heard a heart murmur and we went to U-M to have it checked out right away and had surgery two days later," Barnes said. "It was totally unexpected."

But in many ways, Malachy was one of the lucky kids, and that was proudly displayed on his red T-shirt Saturday morning behind The French Laundry, as he rode his tricycle. On his shirt was a picture of a heart with a Band-Aid on it. Above the graphic, it read, "I'm a survivor."

Malachy, 2, only needed that one heart surgery and it's hoped, "He won't need any more," said Barnes.

He's one of the success stories when it comes to children suffering from congenital heart problems. He's also one of the symbolic representatives of the good events like Saturday's ninth annual Tour des Lacs Charity Bike Ride can create in a child's and

his family's life.

The Tour des Lacs is growing beyond the infancy stages and seems to be maturing well. This year's event attracted over 300 participants who rode various types of bikes between 15 kilometers to 100 miles. Afterward, the French Laundry hosted an outdoor event for the outing. The routes take participants all around the area's surrounding communities and lakes. The event has taken on different forms, but it has pretty much established itself on being a charity fun ride with its proceeds going to the U-M Congenital Heart Center at C.S. Mott Children's Hospital. The event raised at least \$7,000 according to event organizer Kim Foerster.

"We're very happy with that considering the weather," Foerster said. "It was a great day, despite the road construction and the rain. It was one of our best yet."

One person who has been there since the beginning is Ron Stack.

"It's kind of funny because this is the ninth year and that kind of floored me. It's almost a decade old. Bastille Day (Walk and Run) is a decade old," Stack said. "Me and Mark (Hamel) met while Mark was presenting me

DENTURES

Dentures replace teeth that are lost due to dental disease. Upper and lower dentures are quite different from each other in many ways. A full upper denture covers the entire upper jaw along with the palate providing much support, seal, and retention. This means that a well-made and good fitting upper denture will be stable and have a suction-type fit. Most people with an upper denture get along reasonably well. Their upper teeth fit comfortably, look life-like and natural and stay in place. People with a well-made and good fitting upper denture can eat most anything they want. A full lower denture, on the other hand, is only able to cover the lower ridge are of the jaw and has much less surface area coverage. It must fit around a constantly moving tongue. Because of this, lower dentures have much less support and no seal or retention like an upper denture. This means that even the best made and best fitting lower denture is still unstable and lacks the suction-type fit of an upper denture. Lower dentures float. While most folks get along just fine with a full upper denture, the vast majority of people tolerate, at best, their lower denture. With a full lower denture they have many challenges one of which is eating. Those of us with natural lower teeth take for granted the fact that we can order anything we desire from a restaurant menu. Those folks with a complete lower denture are usually very limited on what they can eat. They are missing out on one of the joys of life; eating the food they enjoy. Therefore, I strongly encourage patients to at least consider maintaining their natural lower teeth and to just go with an upper denture. Many dentists truly dislike working with dentures. For us dentists denture work can be very demanding and problematic. I find dentures an enjoyable challenge. I consider dentures one of my specialties and look forward to every opportunity to help denture wearers.

Q. This year when I opened up my cabin up north, I thought I had winterized my refrigerator, but when I turned the water back on water sprayed under the refrigerator. Is there any way to prevent this from happening next spring?

A. Turning off your water to the unit is the first step, however you need to remove the water inlet valve and either store it in a warm place, or blow it out with compressed air until no water comes out the dispenser. Water will freeze in the valve and cause it to crack and leak. Hope this helps!

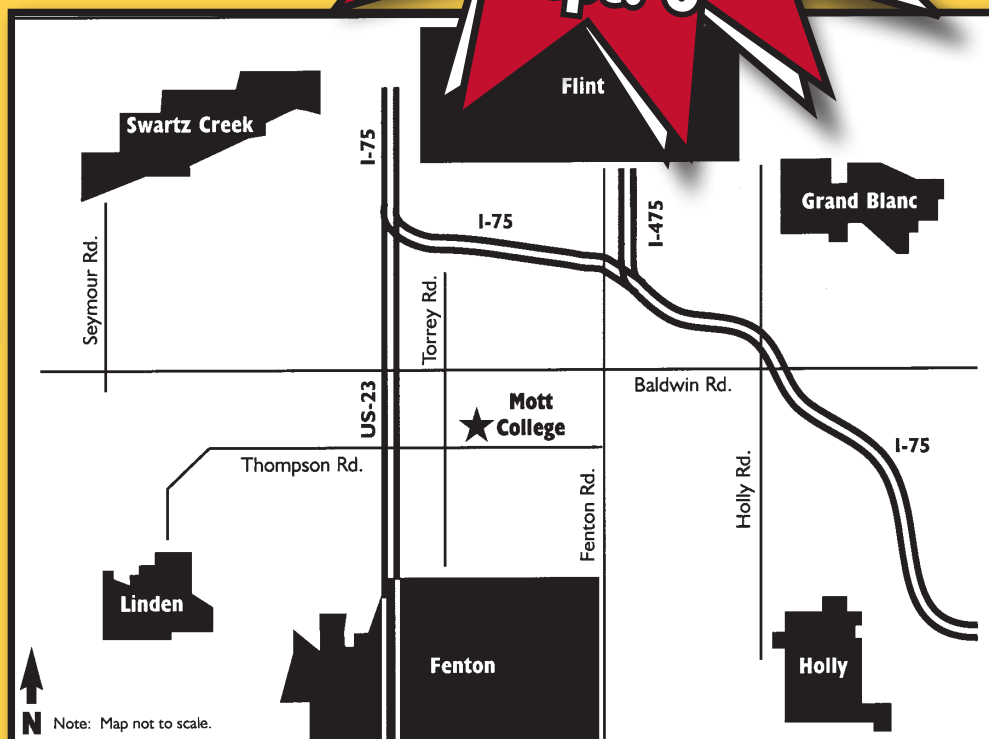
