

Don't be mean Irene

Well, Hurricane Irene wasn't as mean as expected, but it still ended up costing billions of dollars in damage and wreaking havoc all along the East Coast, including my home state, the state of Maryland.

Not many people can claim experiencing a hurricane, tornado and an earthquake — all within the same week. That is exactly what my parents experienced this past week, when an earthquake hit the area, the first in many years.

My mother was having lunch at a restaurant in Annapolis when the 5.8 magnitude earthquake was felt last Tuesday afternoon. She said it was so powerful, her initial thought was that a truck had struck the building.

According to national news reports, at least 18 aftershocks ranging in magnitude from 4.5 to as little as 2.0 followed the strongest earthquake to strike the East Coast since World War II.

A little unsettled after the earthquake my parents then started preparing for Hurricane Irene, which was expected to hit their area on Saturday evening. It hit Annapolis on Saturday afternoon, a little earlier than they anticipated. According to my mother, it was not as intense as expected, but still left them without power for three days. Irene flooded the area, left hundreds of thousands without power and delayed the first day of school.

A by-product of the hurricane was tornadoes, which are very unusual in the Baltimore/Washington D.C. area.

My mother said one of the main reasons she and my father moved to the area after they retired was because there is little threat of hurricanes, earthquakes or tornadoes. 'And we got all three in a week,' she said.

This brings back memories of the tornado that hit the Fenton and Holly area on Aug. 24, 2007. I was having dinner with my son and my granddaughter at a restaurant in downtown Fenton when the tornado struck. In a matter of seconds, nature had released its fury, destroying homes, buildings and many of the beautiful trees, but fortunately no loss of life.

Medical marijuana dispensaries

Last week, the Michigan Court of Appeals ruled that an Isabella County medical marijuana dispensary was in violation of the Michigan Public Health Code.

Currently, there are almost 100,000 medical marijuana card carriers in Michigan authorized under the Michigan Medical Marihuana Act (MMMA). Reportedly, a number of these individuals have obtained their marijuana at one of the 400-500 Michigan dispensaries.


I won't detail the entirety of the legal reasoning that the court used in its decision, but what may be of interest is a brief summary of what has been called the 'business model' Compassionate Apothecary LLC or 'CA.

CA had approximately 345 members. To be a member, an individual had to be either a qualifying patient or primary caregiver and possess a medical marijuana registry identification card. A caregiver could only be a member if he or she had a qualified patient who was also a member. Membership costs were \$5 per month.

CA rented lockers to its members to store marijuana at a cost of \$50 per month per locker. A patient could store 2.5 ounces and a caregiver could store 2.5 ounces for each of his or her patients. All of the marijuana belonged to the patients. If a member patient needed medical marijuana, it could be purchased at the dispensary at a price set by the member with a 20-percent service fee received by CA.

The court ruled that nothing in the MMMA allowed for such an arrangement and patient-to-patient sales of this kind were a violation of the Public Health Code and there was no protection to be found for such activity in the MMMA.

This is just one of a number of cases that have or will address this law. I will keep everyone posted.





MAN ASSAULTED AT CONCERT At 7:45 p.m. on Thursday, Aug. 25, Fenton police responded to the Fenton gazebo for an assault in progress, during the Concert in the Park. Upon arrival, police saw several people restraining a 36-year-old Tyrone Township man, who smelled of intoxicants. Police spoke with a 30-year-old Fenton woman who said her estranged husband showed up at the concert, which she was attending with a 25-year-old Fenton man. Her estranged husband approached her and the other man and assaulted the man. The estranged husband blew a .118 on the preliminary breath test. He was taken to the police station and was lodged overnight. He was released Friday morning with court hearings for disorderly intoxication and assault.

TEEN DRUNK AND LOST

At 4:30 a.m. on Monday, Aug. 29, a Linden police officer was sent to a home in the 200 block of Hyatt Lane to investigate a possible breaking and entering in progress. Chief Scott Sutter said the homeowner saw a young white male lurking outside his house and called 911. Upon arrival, police saw that the homeowner was detaining the unknown intruder at gunpoint. The chief said the intruder, identified as a 19-year-old Linden male, was highly intoxicated and lost. The teen was arrested for minor in possession of alcohol and taken to the police station for booking. He was driven home and released to his parents with a court appearance ticket.

TEXT LEADS TO EX-BOYFRIEND'S ARREST

On Aug. 15. Linden police received a call from the 600 block of West Broad Street for an assault and battery. Police Chief Scott Sutter said their investigation revealed that an 18-year-old male from Howell had arrived at the home of his ex-girlfriend and struck her new boyfriend in the face with his fist. The ex-boyfriend fled before police arrived. The ex-girlfriend texted the suspect and asked that he meet her. The suspect texted her back and told her where he would be. Linden police drove to the location, arrested him and issued him a court appearance ticket for assault and battery.

Impound lot generating revenue

Argentine Twp. — When Police Chief Dan Allen lobbied for the police department to move into their old office space, he told the township board that he worked out a better deal with the owner and assured board members that he could gener-

ate extra revenue by running its own impound lot.

Since the Argentine Township Police Department's impound lot opened for business on Aug. 14, it has impounded nine vehicles and stored seven of them, generating nearly \$1,100 for the police department "It seems to be w

department. "It seems to be working out well," said Allen.

People picking up a vehicle must pay an impound fee and if the vehicle is stored for multiple days, a daily fee is billed to the owner. Vehicles not picked up after three weeks could be sold at auction, said Allen.

The police department moved from its current location, across from Navistarz Bar & Grill to the basement of the township hall in September 2007 to save \$1,000 per month on the lease. The drawback was that the basement was about half the size and interviews with offenders were oftentimes difficult to conduct. It moved back to its

old location in March.

Allen negotiated a deal with Ferrellgas, which owns the building, and cut the lease payment in half, with an option to buy. The chief was convinced that space available at the site, just over an acre, could be turned into an impound lot to hold vehicles,

which are confiscated from offenders. Allen said vehicles in the lot have been impounded for various crimes, such as

drunk driving, a person driving with a suspended license or having a wrong license plate on it. "They've been impounded for crimes," he said.

Experts predict decrease in holiday travel

Travel could increase if gas prices decrease

According to AAA, nearly 1.2 million Michigan residents will travel 50 miles or more from home during this Labor Day holiday weekend, about 1 percent less than those who traveled one year ago. They join the 31.5 million Americans who will travel, a 2.4 percent decrease from last year.

Most state travelers, an estimated 98 percent, will go by vehicle to enjoy summer's last hurrah with campgrounds, resort areas and lakes among the popular destinations. They join the 87 percent of travelers nationally who will go by vehicle.

Travelers will find higher gas prices this holiday — in Michigan, gas averages \$3.71 per gallon (as of Aug. 24), \$1.02 more than last year.

"While travel will likely be down slightly because of economic uncertainty, we may see a last-minute increase in travel if recent drops in gas prices continue through Labor Day," said Steve Wagner,

American League. There is talk of righthanded pitcher Justin Verlander winning both the Cy Young Award and the Most Valuable Player (MVP) Award.

Valuable Player (MVP) Award. "Verlander has one of the best chances at being the MVP. He's better than anyone else in the league," said Terry Wright, of Flint, who has been watching the Tigers for nearly 40 years. He goes out at least

reached a national level, with newspapers such as the Boston Globe and New York Times giving him consideration. If Verlander is awarded the MVP, he will be the first starting pitcher to do so since Roger Clemens in 1986.

Winning in the postseason may be vital for the Tigers from a financial point of view. Overall, Forbes reports that the Tigers are the 21st most profitable baseball team out of Major League Baseball's 30 teams. For the 2011 season, the Tigers operating costs are negative \$29.1 million. However, the Tigers have generated \$192 million in revenue and sold \$54 million in tickets for this season.

Even if the Tigers don't have the best business model, their success can turn into a profit for other companies. Bartender Gabriel Azzopardi said that as Detroit teams make it further in the playoffs, more people come out to watch the games in public.

"There's a lot more people here during game time," Azzopardi said. "When it's closer to the end of the season play, we turn on the surround sound so people can pay attention to the game." Azzopardi said music is playing most of the time with people dancing on the floor during the middle of a sports season.

In 1984 the Tigers won the World Series, defeating the San Diego Padres four games to one. The Tigers made it to the World Series in 2006 but lost to the St. Louis Cardinals, 4 to 1.

"If the Tigers get into the playoffs, we'll see a dramatic increase in patrons," Azzopardi said. "Everyone will come out of the woodwork with their vintage Tigers gear, reminiscing about 1984." Azzopardi said that most bars and restaurants feature specials on drinks and food as teams do better through the playoffs.

The Tigers regular season ends on September 28 against the Indians. The playoffs start shortly thereafter.

• The Tigers first stadium was called Bennett Park and was built in 1896. The team acquired the rest of the block and created Navin Field in 1912. The stadium was expanded in 1938 and renamed Briggs Stadium. It was renamed Tiger Stadium in 1961. The team currently plays at Comerica Park, where they moved to in 2000.

• The Tigers have not always been so successful. In 2003, the team had the most losses in American League history with only 43 wins and 119 losses for the season.

• During the 2010 season, pitcher Armando Galarraga almost pitched a perfect game. At the top of the ninth inning, umpire Jim Joyce called a player safe, ending the perfect game. The replay revealed that batter was clearly out however, and Galarraga should have earned his perfect game. Only 20 pitchers in history have had a perfect game.

During the orchestra's first year, nearly 80 people played at some time during the year said Fleck, who now serves as president of the orchestra's board of directors. "We averaged about 40 musicians per week." What impressed Fleck the most was the number of multi-generational experiences people brought to the orchestra, with parents and grandparents playing with their children for the first time, or siblings joining each other to play.

New this year is an after-school string program, "Fenton Area Primary Strings," offered through Southern Lakes Parks & Recreation Community Education and A Joyful Noise Music Studio.

This six-week instructional program for violin, viola, cello and string bass is designed for students 8 and up, with little or no string experience, according to Fleck. Students will be grouped by age/grade, and course fees will include weekly small group classes for string instruction and weekly string orchestra rehearsals. "Beginner adults, post-high school, are welcome, too," said Fleck.

Holly Village stands alone at the moment as the only local municipality to explicitly allow for medical marijuana dispensaries. Holly Township has an ordinance in the works.

The very definition of a "dispensary" varies in each municipality, as

the meaning is not defined in the 2008 Michigan Medical Marihuana Act (MMMA) that allowed the legal existence of medical marijuana in Michigan. Federal law still defines marijuana as illegal in any form.

The issue of medical marijuana dispensaries has been complicated, with many municipalities, including the cities of Fenton and Linden, waiting to see how the law is clarified by the

courts. The language of the act was written vaguely in regards to dispensaries.

A recent Michigan Court of Appeals ruling may have provided some direction to confused local governments.

To understand the legal implications, attorney Denise Pollicella represents and advises 12 dispensaries in Southeast Michigan, including Well Greens. She

said that medical cannabis (caregivers don't like the term "pot") has traditionally been used by health professionals for pain relief up until the '30s.

According to Pollicella, the court ruling labels certain business transactions at a dispensary as being in violation of the public health code. They aren't technically illegal, she said, but the ruling does give legal grounds for a court injunction, which can be then enforced by local police.

The court opinion states that the owner of a dispensary can still sell to five patients and they can still take a consignment fee off other caregivers selling to patients at their location. But the court ruling restricts anyone making money from a patient-to-patient sale, which will likely cut many out of the business. Patients can still give cannabis to other patients for free.

Pollicella believes the decision will probably lead communities to try to shut any local dispensaries down. "It's going to be terrible," she said.

The court opinion becomes governing

law for Oakland County, and the rest of Michigan.

"We're going to advise dispensaries in Holly to close," said Oakland County Prosecutor Jessica Cooper. The Drug Enforcement Agency (DEA) raided a dispensary in Commerce Township earlier this year, but it was not connected to this court ruling.

> Cooper said that the MMMA allows only one caregiver to grow marijuana for their five registered patients. "The MMMA is for compassion, not profit, or profiteers," she said, adding that she thinks dispensaries are unnecessary.

A medical marijuana dispensary was John's answer to losing his career in the car industry. He decided to go into the medical marijuana business after he lost his main contractor job automating robots for the auto industry.

Even though his business is unusual, he said his fellow Holly business owners have treated him like any other business owner. "I haven't heard a harsh word from anybody," he said.

John wishes the public was more informed on what medical cannabis dispensaries are about. Community groups have expressed concern that children or even teenagers may be able to enter the dispensary, and possibly buy marijuana. "I just wish they could understand that not just anybody can come into the store," he said. Both a medical marijuana patient card and a Michigan driver's license are required to even enter his dispensary, once it is finished.



Michigan law currently allows schools to decide when school board elections will be held. If a school board election is held outside of November on an even year, schools must pay for 100 percent of the election.

Fenton, Lake Fenton and Linden each held a school board election this past May. The election cost Fenton \$2,851.07. Linden schools paid \$3,361.65 and Lake Fenton paid \$1,675 for their elections. May elections are more costly during even-number years. In May 2010, Fenton paid \$9,771 for their election while Linden paid \$10,849.18 and Lake Fenton paid \$5, 287.04.

Voter turnout for May elections are historically low and this year was no exception. For Fenton's 2011 school board election, 492 voters from the city of Fenton made it to the poll, or 5 percent of registered voters. There were 134 votes collected from 1,837 registered voters from Fenton Township and 118 votes were cast from 1,263 registered voters in Rose Township.

Fenton School Board President Lynn Hopper said that the law makes sense from a financial point of view. However, school districts run on a different fiscal

calendar than the government does and he foresees potential problems if the law is passed. "If schools don't adjust their fiscal year with the government's fiscal year, board members may potentially remain on the board longer than they were elected for," Hopper said. "But with the way the economy is, we have to look

> at saving money anyway possible.'

Hopper attributes May elections as a direct relation to a school district's fiscal year, which ends every May. In a Tri-County Times article published May 21, elections supervisor for

Genesee County Doreen Fulcher said that election officials have encouraged school boards to switch elections to November, eliminating the expenses that come with special elections. "It would be free," Fulcher said.

Some schools in the tri-county area have already considered switching their elections to November. The Linden school board discussed holding their elections in November at a meeting in early June.

House Bills 4005 and 4006 are currently in the Senate for consideration.

Lender turns to private financing as banks say N

There have been more doors slammed in the face of Cheryl Luttman and Joe Hood than ever in the history of the company as the two dealers fight their way back up the dealership ladder.

"Banks are just not doing any business with dealers. We think it is because they have their own problems," said Luttman. According to Hood, some local banks have stock prices at an all-time low. 

DEAR DR. DONOHUE: Can a person have bursitis and arthritis at the same time? My doctor diagnosed me with bursitis. Then I fell and crushed my kneecap. I had to have surgery for it. After a while, the knee started giving me pain. The surgeon X-rayed it, and said I had developed arthritis. My neighbor says you cannot have bursitis and arthritis at the same time. S.L.

ANSWER: Your neighbor is wrong. A bursa is a little sac outside of the joint. It lies between a tendon and a bone. It prevents irritation when the tendon rubs against the bone. Bursitis is an inflammation of a bursa. Arthritis is something that happens within the joint. Your trauma damaged the cartilages within the joint, and they have become frayed and slightly inflamed. There is no law that says you can't have both bursitis and arthritis at the same time.



"We learned that we need to push a little harder and we'll win," said Kesler, who led the Blue Devils with 115 rushing yards and two scores. "Our team never gives up and that's nice, especially against a team like that."

Lake Fenton made the first drive of the game at Rynearson Stadium memorable. The Blue Devils took the opening possession 66 yards in seven plays, scoring on Kesler's 21-yard TD run.

"I remember the offensive line opening a giant hole and leading me there," Kesler said of the score. "My full back took the guy in front of me. It was amazing."

The Lake Fenton defense stood tall on Gabriel Richard's first two possessions as well, earning fumble recoveries by Austin Frank and Tyler Mertz. However, Lake Fenton fumbled on its third possession, and Gabriel Richard responded with their first scoring drive of the game — a nine-play 76-yard drive capped by a 36-yard TD run by Nick Pauze.

Pauze finished the game with 200 yards on 26 carries. He was named Gabriel Richard's MVP. Kendzicky completed seven passes for 124 yards. Lake Fenton's MVP was Kesler with his 115 ground yards and two TDs. Defensively, Jim Lyons tied Hull with 11 tackles, while Tim Symons had six.

Philip Eugene French - age 81, of Traverse City, Michi-




Home Administration. One of Phil's passions was ensuring that farmers and rural Michiganders had the resources
