City and state officials honored Linden police officer Gary Conklin Monday evening at the Linden City Council meeting. State Sen. John Gleason (D-Flushing), State Representative Paul Scott (R-Grand Blanc) and Congressman Dale Kildee (D) presented awards

to Conklin for his rescue efforts last month.

At approximately 4:20 p.m. on Aug. 3, Conklin received a call that two male workers had fallen into a 20-foot sewer hole just outside of the city of Linden. Once he arrived to the scene, Conklin saw the two men face down floating in sewage.

After a rope was secured to his waist, he adorned an emergency mask and was able to prop one of the men against the wall and to turn over the other. His efforts saved a life that day.

84 year old struck and killed by car

►Police say man was crossing street to get mail

The Argentine Township Police Department is investigating an automobile crash that resulted in the death of an 84-year-old Argentine Township resident.

On Sunday, Sept. 11, at 8:09 p.m. police were dispatched to the 8500 block of Silver Lake Road, near Sunset Way in response to a pedestrian injury crash.

According to Police Chief Daniel Allen, Claude Jay Carr crossed Silver Lake Road on foot to check his mailbox.

Summary

►An 84-year-old Argentine Township man died Sunday night. He was struck by a car as he crossed back over Silver Lake Road after getting his mail.

After doing so, he turned back into the westbound lane to cross the street. As he entered the roadway, he was struck by a westbound 1993 Buick Roadmaster, driven by a 34-year-old Fenton man.

Carr was transported to Genesys Health Park in Grand Blanc Township where he was later pronounced deceased.

A crash reconstruction team with the Michigan State Police responded to the site to investigate. Argentine Township Fire Department also responded.

The case remains under investigation; however, the driver's account of what happened was consistent with findings of the preliminary investigation. The police chief said neither alcohol, nor speed, appear to be a factor at this time.

Argentine Township Supervisor Robert Cole was saddened to hear the news Sunday night about Carr. He said Carr was a "good ole' guy," and one of the original Argentine Township firefighters dating back to the mid-'70s. Carr was still with the fire department when Cole was elected to the board in the '80s.

The supervisor said Carr hung around the fire hall since he lived so close and often stopped by the gas station next to the township hall just to chat with the locals. Carr lived at the big old blue house on Silver Lake Road and raised his family there.

Holly Township is holding its 2011 Cleanup Day on Saturday, Sept. 24, from 9 a.m. to 4 p.m. at the North Oakland County Fire Authority station, 5051 Grange Hall Rd. in Holly. The township will be accepting garbage, refuse, recyclables, and non-Freon appliances to throw away in dumpsters. They will not accept yard waste, dirt, asphalt, shingles, wood, oil-based paint, solvents and hazardous materials. Residents can clean up yards, but also rural roads and parks. The event costs \$7,000 to rent the equipment, and is back after a hiatus. Anyone dropping off garbage will need to verify their residence to use the service.

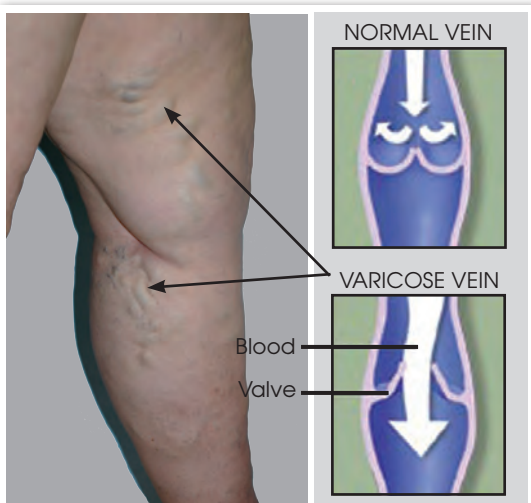

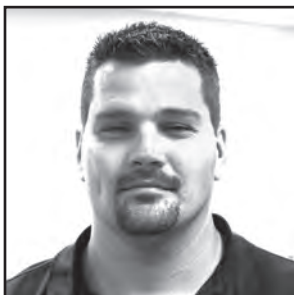

Garage sale benefits 300 families from Appalachian Mountains

►50,000 items for sale

Holly — Everyone loves garage sales. They are great for making extra cash while getting rid of clutter, or finding oddball things you need. But what about using a garage sale to raise money for families in need? This is what Carl and Shirley Roos, of Holly, have been doing for nine years.

Every September, the couple holds an unusual garage sale at their home, which benefits around 300 families in the Appalachian Mountains of Virginia. They don't provide financial assistance. They take several trips per year to the area to give things that are needed, including food, clothing and medical supplies.

The garage sale begins Thursday and runs through Sunday. The sale also benefits anyone who stops by to peruse items for sale. None of the 50,000 items are marked with a price. The couple just asks that patrons make a fair donation to their tax-exempt, 501c3, Angel Haven Foundation.

The sale is so large it takes a week to set up. "It's a very big deal, you should come see," said Shirley Roos, who also heads the Holly Township Library.

The sale itself takes up an entire barn, and around seven tents full of items including clothing, glassware, toys and small appliances. "We're really proud of the furniture we have. Some of it is really beautiful," she said. And, they do have oddball items, such as an antique juicer.

Roos hopes to raise around \$5,000, which will be used to buy items to be stored in a warehouse, and is then distributed to families in Virginia. They also use their foundation to help local people whenever they can.

Roos and her husband became aware of the plight of the people living in former mining towns 12 years ago. Cancer, polluted water, unemployment and poverty were rampant after most of the jobs left the secluded mining towns. "It's really sad, and it's our country," she said. "We're having garage sales to feed people. Very disturbing."

Roos was shocked people lived that way. One man they helped literally lives in a cave. "There's absolutely nothing," she said. "They're just forgotten people. They don't have the money to go out to the big city and get a job."

The couple will take one of their trips in the middle of November with around 15,000 pounds of goods, which includes items donated from other area churches.

At 75 and 80, the work is hard on Roos and her husband. "We're going to do this as long as we can," she said.

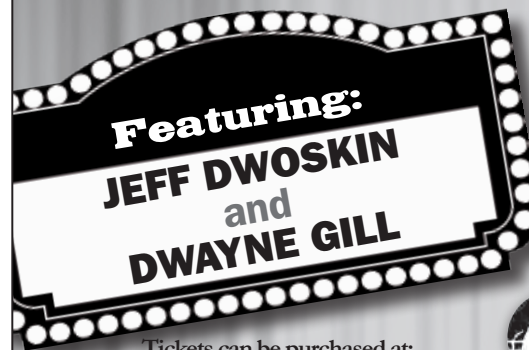
The sale officially opens on Thursday, but the couple welcomes any help from the community.

Holly trustee pleads not guilty to OWI

►Leslie heads back to court on Oct. 5 for pretrial

A Holly Township trustee arrested for operating a vehicle while intoxicated on Aug. 27 was arraigned on the misdemeanor count on Sept. 8.

During her arraignment by Judge Joseph Fabrizio in Oakland County's 52nd District Court—2nd division, Janet Leslie pleaded not guilty to the charge. Her next court date is Oct. 5 for a pretrial hearing.

According to Holly Village police, an employee at Red Devil Pizza, taking a break outside the restaurant, saw Leslie strike her parked car with her Honda CRV. Leslie stayed at the scene and the employee called police to report the collision just after 9 p.m.

The responding police officer detected a strong odor of intoxicants coming from

Leslie as she spoke. Her eyes were also bloodshot and glassy and her speech was slightly slurred. Leslie told the officer that she accidentally struck the parked vehicle.

According to the police report, Leslie told the officer that she had been drinking assorted vodka drinks at a charity golf outing that day, but was unsure as to how many she had consumed.

Summary

►Holly Township Trustee Janet Leslie was charged with operating a vehicle while intoxicated in the village of Holly. She pleaded not guilty at her arraignment on Sept. 8 and will be back in court on Oct. 5 for a pretrial hearing on the misdemeanor count.

Field sobriety tests were administered and a preliminary breath test, at the scene, revealed a blood alcohol content (BAC) of .201 on Leslie. She was arrested for OWI and transported to the police station, where a chemical test revealed a BAC of .15. She was released at 4 a.m. the next

morning with a court appearance ticket.

Following her arrest, Leslie said her actions were regrettable and unacceptable to her and her community. She said she was taking positive steps to ensure that this type of incident never happens again.

Legal words and phrases

In the law, one doesn't have to go far to run into what can seem like a veritable maze of legal words and phrases and their unique meanings. Many of these come to us from Latin, which is not a modern language, but is still used because of its historical use in the legal terminology.

When I was in high school, I took Latin and when I got to law school, it turned out to have been a very valuable class. I thought for this week's column that I would list a few of the law's most commonly used Latin words and phrases with their translations.

So here it goes — a mini-Latin legalese lesson with the Latin phrase followed by the English meaning:

- Ab Initio — from the beginning
- Actus Reus — a guilty deed or act
- Alibi — at another place, elsewhere
- Amicus Curiae — a friend of the court
- Bona Fide — sincere, in good faith
- Caveat Emptor — let the buyer beware
- Corpus Delicti — the body of the crime
- De Facto — in fact
- Ex Post Facto — by reason of a subsequent act
- Habeas Corpus — that you have the body
- Id Est — that is
- Nolo Contendere — I will not contest it
- Mens Rea — a guilty mind
- Prima Facie — at first face
- Res Ipsa Loquitur — the thing speaks for itself
- Scienter — knowingly
- Subpoena — under penalty

These are but a few examples from a very long list. There can be great beauty in the written or spoken word especially when it conveys with precision the author's or speaker's thoughts and meanings. In the law, it is very important to be as precise as possible. Historically, the Latin language has helped the law immeasurably to reach this ideal.

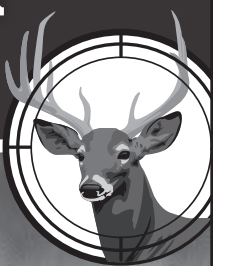

which will exist for as long as America does.

"I would like to thank him for his brazen service," said Andrew Leavitt, a representative for Kildee. "He embodies everything a public servant should have."

Gleason evoked the memories of Sept. 11, citing police and firefighters who risked their lives to save people from burning buildings. Gleason said that public servants are often taken for granted and are not given the recognition that they deserve. "I think it's important that Linden recognizes him. His own life was in the balance."

Conklin and Linden Police Chief Scott Sutter went to Lansing on Sept. 8 for a 9/11 remembrance ceremony with Scott, who said it was an honor to host them

Police Chief Scott Sutter said Tuesday the actions that Conklin took the day of the sewer accident went "above and beyond" the call of duty. "He deserved to be honored in the way that he was last night."

geared only for adults to generate a bit more revenue.

Carmine Avantini, a planning consultant for the city, told council members at their work session in August that the city was not covered by an ordinance if a store wanted to sell items that fall under the city's definition of adult materials. He recommended that council members approve the amendment for businesses having adult novelties that take up less than 10 percent of their space.

Businesses that have more than 10 percent of their space dedicated to adult novelty items are also regulated by the city.

Unless a customer is carrying an item

deemed to be of the adult nature to the cash register, these items cannot be visible to the public except for when they are located within an adult material room, specifically for such items.

These adult material rooms must have walls at least six-feet high that screen, or limit the view by customers in the other areas of the store. Individuals under the age of 18 are not permitted in.

Business owners cannot display adult novelty items in areas of the store that could be seen through exterior windows by residents walking by. Live modeling or similar activities are also prohibited.

Retail businesses with adult novelty items must be located at least 500 feet from churches, schools, day care centers, hospitals and parks.

Dopamine is the neuron chemical that produces excitement and other high-energy feelings. Eating high-fat foods provides a surge of dopamine and requires the continual eating of these foods to keep the "high."

Serotonin is a calming neuron chemical that promotes the feeling of well-being and optimism. People who consume a lot of sugar or refined carbohydrates or a combination of both note increases in their serotonin levels that make them feel good — although these effects are also temporary unless a person keeps eating these foods.

and being overweight requires some lifestyle strategies that are different from the traditional restrictiveness of a diet. "Balance, moderation and variety are the key," said Lida Athearns, executive director of EDEN (Eating Disorders Education Network), with programs available in Fenton. "There are no 'bad' foods," she said. "When you want a brownie, have a brownie, but don't eat any more than just the one to satisfy your craving for that particular food."

For some people, just a taste of one particular food will "trigger" an emotional eating binge. In that case, recovering food addicts like Athearns suggest that you go out and get the one food you're craving and enjoy that serving, rather than having it available in your home.

"Never eat out of a bag," said Athearns, who was anorexic throughout her teen years. "Portion your serving out instead, and put the bag away. Exercise helps, too. Once you get moving, you'll find you don't want all of those unhealthy foods."

Ann Batchelor, R.D., M.S., C.D.E. from Genesys Regional Medical Center, said that unhealthy foods that are "fatty, salty and sugary" all hit similar areas of the brain as addictive drugs. "The more you eat, the more it takes to satisfy that craving," she said.

People often overeat to mask emotional issues they don't want to deal with, such as a death in the family or a painful divorce, she said.

Batchelor suggests that rather than giving up addictive foods "cold turkey" people should substitute good habits that will provide similar boosts to the brain. To boost dopamine levels, be active and social. For increased serotonin levels,

cultivate relationships and step out of yourself to be kind to others. She said that people should note when these desires to emotionally overeat take place, so that they can develop other habits or patterns.

"Honor your hunger," she suggests. "Before you eat, ask yourself in a mindful manner, 'Is this what I am hungry for?'"

At around 9:30 a.m., more attendees filtered in on foot. Some were walking dogs, and many stopped to take a picture of a memorial wreath.

The entire congregation from FUMC arrived in a procession lead by Donahue. At 9:58 a.m., a siren sounded, commemorating the moment the first tower collapsed. The audience was completely silent.

Melissa Adams, of Fenton, believed the ceremony met its aim to properly remember the event of Sept. 11, 2001. "People came to remember what happened to individuals and to our nation," she said. "It's something we can never forget."

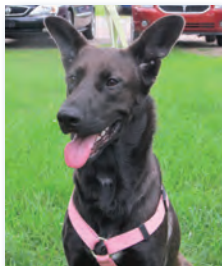

Bullycide Project will be a part of the CBS news program 48 Hours, which airs at 8 p.m. this Friday, Sept. 16. Bullycide is a collection of stories about kids who have committed suicide due to bullying.

"There's been a lot of awareness made because of the Bullycide Project," Thompson said, who has been producing the play for nearly a year with her Trust Theater Ensemble. "It would be incredible if we played any kind of hand in helping to create an anti-bullying law."

An anti-bullying law has been Kevin and Tammy Epling's goal for nearly a decade, after their son Matt committed suicide in 2002. So far, the Eplings are not very impressed with Michigan legislators and their lack of action.

"Bullying is the number one issue with schools, right below funding," Kevin Epling, of Lansing, said. "Our legislators have been really dropping the ball on this. They really need to pass something that will be helpful to schools, parents and students."

The Eplings will be a part of the 48 Hours special as well. The Eplings met Thompson after watching "Ticking," a play written and performed by Thompson's students. The Eplings introduced

the Bullycide Project to Thompson, which spurred her to produce a play from it. In the span of one year, Thompson's Bullycide has been performed in Las Vegas, Toronto and in front of state legislators. To your good health

DEAR DR. DONOHUE: I have had three attacks of gallbladder pain due to gallstones. My doctor is pushing me to have my gallbladder removed. The prospect of surgery doesn't thrill me. Can't these stones be treated in some other way? How does my body function without a gallbladder? — R.C.

ANSWER: Have the surgery. You have had three attacks of gallbladder pain; you're bound to have more. You won't find the surgery as frightening as you imagine. Often, it is done through small incisions with the guidance of a scope. The body does quite well without a gallbladder. It's a reservoir for bile, which is made in the liver. When a person eats a meal that has fat in it, as most meals do, the gallbladder contracts, sending a jet of bile into the digestive tract to promote fat digestion. Without a gallbladder for storage, bile drips into the digestive tract on a constant basis; that works out well. Medicines can dissolve gallstones. They take a long time to work, and the stones have to be small. Frequently, the stones reform after medicines are stopped.

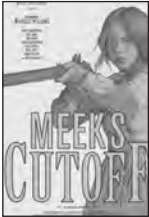

PREP FOOTBALL WEEK #4 QUICK PREVIEWS

There are some interesting developments going on in the tri-county area in terms of football. For the first time since 2001, the Linden Eagles enter Week #4 with a losing record, at 1-2. Meanwhile, for the first time since 1997, the Fenton Tigers enter this Friday at 3-0. Lake Fenton is 2-0 in the GAC Red, but still has the top three teams in the conference left on their schedule. And for the second straight year, the Bronchos find themselves playing Fenton after starting 0-2 and then defeating Linden in Week #3. Let's take a look at Week #4's games.

Fenton Tigers (3-0) at Holly Bronchos (1-2): The Tigers seemingly are getting over some of those early-season bumps. The offense had its break-out game of the season against Charlotte, scoring 38 points. A big key to the contest was quarterback Houston Shaw putting together his best performance of the season. He completed 16-of-24 passes for 221 yards and two TDs. The Bronchos are more balanced than in past years, but they still rely heavily on quarterback Johnny Williams' legs. He ran for 138 yards and two scores against Linden.

Defensively, the Bronchos struggled in their first two games, allowing an average of 32 points in those games. Against Linden, they put pressure on the Linden quarterbacks and kept the Eagles' passing game in check. However, Fenton's offense isn't Linden's right now. If the Bronchos want to make the playoffs, they need to win this game. That will be a tough mission to accomplish.

Lake Fenton Blue Devils (2-1) at Durand Railroaders (0-3): The Blue Devils are back to their identity, after running for 302 yards against Lakeville on Friday. And the defense was overwhelming as well, creating six turnovers. The Blue Devils will have a chance to get 400 yards rushing this week against Durand's defense. The Blue Devils are heavy favorites, but they better get this win. It won't be easy during the second half if they want to make the playoffs. Games with Goodrich, Montrose, Beecher and North

Holly draws East in pivotal league opener

Bronchos' Hooper scores sparking 1-1 Metro deadlock

Holly — If the Holly varsity boys soccer team wins its second straight Metro League title in October, the Bronchos can credit the scoring combination of Colin Banes and Hunter Hooper for it.

And they may be able to thank an official as well.

Trailing 1-0, the Bronchos had a set play with about 12 minutes remaining. After a long delay, one of the officials rolled the ball onto the field of play for a restart. Striding toward the ball while it was just ending its rotations near the bench sidelines, Holly's Banes kicked the ball to the far-side post of Lapeer East's net. Hunter Hooper received the pass and put it in the net for a 1-1 tie. The score remained deadlocked, giving both expected Metro League contenders a pivotal point in their first league games of the season.

"I saw their outside mid or their left outside defender. Colin saw me running behind him, he sent it and I touched it," Hooper said. "We have had shots like that, but not normally on target."

Holly coach Mike Steibel admitted the goal seemed pretty strange. Both teams scored their goals off of set plays. East scored the game's first goal with 18:05 remaining in the contest after a corner kick was crossed into the Holly box. The ball eventually got to East's Troy Willmer, who took a shot. It was saved by Holly keeper Ryan St. John, but it snuck through his legs. Bailey Boyer was there to get the rebound, putting East up 1-0, but only for about six minutes.

"I think it was fitting because they played with a lot of hustle, and defensive-wise the teams were equal," Steibel said. "It was whoever got the lucky goal."

"The corner was good for them, and that fluky little thing here (Holly's goal), I'll take it. I never saw that ever. It was a nice pass from Colin into Hunter, but I thought the restart was a little weird."

"I think this game right here will have something to do with the league title."

It was a game filled with late-season league title intensity. But quite often it seemed the teams allowed the intensity to get the best of them, creating a choppy, pinball-like game instead of a more fluent possession-type game. Still, both teams had good chances to score other goals, but frequently the two keepers — Holly's St. John and East's Colin Owen — made some strong saves. Lapeer East outshot the Bronchos 19-13, and enjoyed a 12-6 on target edge.

"I thought we didn't play 100 percent," St. John said. "I think we need to work on possession, stop forcing the ball up the field. It was too much kickball on the field. We didn't settle it and play the entire field."

That's something we will have to work on."

Just one game into the Metro season, and two other "exhibition" games at the Metro League tourney, the Holly boys are realizing defending a league title may be a bit harder than winning the first one. The Bronchos are now a clearly known quality squad.

"I think it is tougher," Hooper said. "We lost some pretty good defenders in the back, so we are trying to pick up some of the slack back there. But everyone is coming out a lot harder this year than they were before."

Appearance and protest at the hearing held to confirm the special assessment roll is required in order to appeal the amount of the special assessment to the state tax tribunal.

An owner, or party in interest, or his or her agent may appear in person at the hearing to protest the special assessment, or shall be permitted to file his or her appearance or protest by letter and his or her personal appearance shall not be required. [The owner or any person having an interest in the real property who protests in person or in writing at the hearing may file a written appeal of the special assessment with the state tax tribunal within 30 days after the confirmation of the special assessment roll.]
