School board wants better offer from tower company

►Mulls lump sum for lifelong easement or annual lease

Linden — The Linden Board of Education failed to pass a motion that would have allowed the school district to receive a one-time payment of \$200,000 from American Tower. The company leases property from the district for a telecommunication tower.

American Tower made a proposal to change the current lease to an easement by paying the district \$200,000. All the protection the district receives under the existing lease agreement (taxes,

The Linden Board of Education is evaluating which is better for the school district, a one lump payment for a lifelong easement or annual payments from American Tower for a tower the company has on district property.

maintenance, removal and insurance) would be covered within the Grant of Easement document and the use of the lease area would not change.

The lease agreement would allow American Tower the right to use the land for the tower, but the district would continue to own the land. In the event that American Tower determines that it will no longer utilize the land for a tower location, the recorded easement would be lifted.

The current agreement says that the company could pull out of the agreement after five years. The company could also opt to stay 25 years, or more.

Based on annual revenue the district receives from the company with the existing lease agreement, the \$200,000 one-time payment covers between 14 and 15 years worth of payments.

Over a 25-year span, investing \$309,178 at 5-percent interest would equal approximately \$590,000.

Superinten-

dent Ed Koledo said he believes American Tower's offer was a good deal in that it could be used for a long-lasting purchase. Board members would have to consider several issues, such as technology advancements, the need for towers, etc.

Secretary Steve Murphy said he had concerns about their offer and thought there could be a better offer out there. "I oppose this idea," he said. He believes continuation of the annual influx of income would be better for the district.

Treasurer Michael Murphy said he would like to keep things as they are and keep the annual dollars coming into the general fund.

President Laura Starrs suggested they consider taking the \$200,000 and using it to do something for the district.

Trustee Rob Rossow said it is a gamble to take the lump sum over the continued annual income, considering there is a chance the tower might not be in use in 16 years. "I'm against it,"

Vice President Pam Snyder said it would be good to have the money, but they should probably keep the arrangement as it is now.

Trustee Scott Maker said the lump payment sounds tempting, especially with the tight finances. He added that the offer is possibly in the best interest of the tower company and not the district's.

Snyder suggested that Koledo go back to American Tower and see if they would up their offer to \$309,000, which would be the same as the costout of dollars over time.

The school board will revisit this topic at an upcoming meeting.



Paying dead people

There isn't much about dysfunctional government that shocks me anymore, but this story did.

According to a report by the Office of Personnel Management and reported in Ed O'Keefe's 'The Federal Eye' column in the Washington Post, our government has been sending checks to dead people. 'In the last five years,' O'Keefe writes, 'the Office of Personnel Management has made more than \$601 million, according to the agency's inspector general. Total annual payouts range between \$100 million and \$150 million.'

This isn't something new. Inspector General Patrick McFarland had urged OPM in 2005 and again in 2008 to more closely monitor such payments. It appears his advice has gone unheeded.

'Improper payments to dead retirees are up 70 percent in the last five years, cites the OPM report. In one outrageous case, the son of a deceased annuitant kept receiving federal benefits for 37 years after his father's death. OPM didn't learn about the improper payments until after the son died. Of course, the agency never recovered any of the money.

That same month, a watchdog group reported that the Obama administration's economic stimulus program had made 89,000 payments of \$250 each to dead or incarcerated people.

I wonder how many of the dead and incarcerated got to vote — and for whom?

Then there's Solyndra, the California solar panel company that received half a billion dollars in loan guarantees and then declared bankruptcy. Solyndra officials invoked the Fifth Amendment protection against self-incrimination last month before a congressional committee. The \$535 million 'loan' was given to a major Obama fundraiser. Hmmm.

It is beyond disgraceful that so many elected officials and unelected bureaucrats continue to waste so much of our money, all the while demanding we be taxed more because they can't 'afford' to cut a dime and some of us allegedly aren't contributing our 'fair share.'



Baseball, hot dogs, apple pie and Chevrolet. The Chevrolet brand is so entwined into U.S. culture that a local dealership

is celebrating Chevy's 100th birthday with a party for the entire community. This Thursday, Nov. 3 is the date that by Chevrolet was first established General Motors, based on a car by French race driver Leouis Chevrolet in 1911.

Chevrolet was started 100 years ago as a rival to the Model T that Henry Ford had

rolled out in 1908. Today, Chevy is a full-line brand that sells everything from very small cars (Sonic, Spark) through specialty models (Corvette) to big trucks (Suburban SUV, Silverado

pickup). Its popular pricing and longtime American roots has been important milestones not just for GM, but also as a source of national pride.

"We're going to party here all day," said Matt Stevens, general sales manager at Vic Canever Chevrolet in Fenton. About a dozen classic cars from 1931, 1940 and through the '50s and '60s will be on display, along with lots of Chevrolet memorabilia. "We'll be closing down our service lane for the classic car exhibit on Thursday," he added.

Police station's phone number used in scam

The Holly Police Department is investigating an unusual complaint in which the police station's telephone

number was used.

According to police, a 28-year-old Holly woman stopped by the police station and reported she has been the victim of attempted fraud by wire.

The woman said she began receiving calls on her cell phone in mid-September from a caller who identified himself as a police officer. The unknown caller told her that she was the respondent in a civil lawsuit whereby a court had found her liable and that if she would remit \$315 by check, the suit would be

The woman received more than 100 calls from this person. Believing this to be some sort of fraudulent scam, she contacted her cell phone provider and asked that they block this number from her phone. She said the phone company was unable or unwilling to help her.

The woman then began receiving similar fraudulent calls from a different telephone number. Starting on Sept. 21, she received five or six calls from an individual who identified himself as Officer Smith from the Holly Police Department. The caller told her that she had been found to be the responsible party in a civil suit and she could settle it by sending \$315.

The woman told police that she became confused because the caller ID on

her cell phone showed the originating phone number as that of Holly police, (248) 634-8221.

Det. Jose Garcia told the woman that no one by the name of Smith was currently employed by the department. He told her that the incident

would be documented in a case report and forwarded to the criminal investigators division for review and follow up.

Police Chief Elena Danishevskaya said they are looking into this matter. Police believe the same individual who figured out how to program the phone number to reflect that of the police station is responsible for all of the calls to the woman.

The chief wants to remind everyone that police would never call someone saying that they owe money. There are occasions where organizations call people for fundraising projects but these people are working for the charity organization.

If someone receives a call similar to this scam, they are to terminate the call immediately and contact their local police agency to report it.

charge during her pretrial hearing, according to court records. She will be back in Oakland County's 52-2 District Court on Wednesday, Nov. 23 for sentencing.

Sentencing guidelines for impaired driving could include up to 93 days in jail, fines of up to \$300, community service and discretionary vehicle immobilization.

According to Holly police, an employee at Red Devil Pizza saw Leslie strike a parked car with her Honda CRV just after 9 p.m. on Aug. 27. The responding officer detected a strong odor of intoxicants coming from Leslie as she told the officer she accidentally struck the parked vehicle.

Field sobriety tests were administered and a preliminary breath test, at the scene, revealed a blood alcohol content (BAC) of .201 on Leslie. She was arrested for OWI and transported to the police station, where a chemical test revealed a BAC of .15. She was released at 4 a.m. the next morning with a court appearance ticket.

Following her arrest, Leslie said her actions were regrettable and unacceptable to her and her community. She said she was taking positive steps to ensure that this type of incident never happens again.

On Tuesday, Leslie said, "I'm grateful to the village attorney for giving me the opportunity to plead to a lesser charge.

"I'm complying with the expectations set forth by the court."

that are usually confined to smart phones. Here's a rundown of what each product features and what each are missing.

Apple TV

Apple TV is an adapter that plugs in into HDTVs, not an actual TV built by Apple. Operating on the same platform as the iPhone and the iPad, the device works similar to any Mac computer and other Apple products. iTunes serve as the primary content provider and has expanded beyond music, allowing users to rent or download movies. Netflix is also supported on the Apple TV, allow-

ing users to stream movies on demand. The Safari web browser comes standard with Apple TV, allowing viewers to simultaneously surf the Internet while watching a movie or TV show.

One unique feature of the Apple TV is its photo-sharing capabilities. Slideshows of family events can be displayed in high definition and with dif-

ferent filters and camera angels. Another feature allows parents to show or hide certain options when children are watching TV, giving parents peace of mind.

Despite the abundant features it has, Apple TV does have its limitations. The set does not have a TV tuner or a personal video recorder. Movies can only be searched through iTunes, neglecting networks and local hard drives.

The Apple TV is available for \$99 and up, depending on the features selected when purchasing the device.

Google TV

Google TV is a digital receiver that operates under Google's Android software. Netflix, YouTube and Blu-ray quality movies are some of the biggest features that come standard on the device. Amazon serves as the main movie and content provider on Google TV. By the end of the year, Google is expected to release the Android Market, which will feature countless applications and other developments directly from Google. The Chrome web browser comes standard, allowing users to search the Internet while watching movies or other programs, just like Safari on the Apple TV. Overall,

the core features of Google TV are remarkably similar to Apple TV.

Google TV has somewhat of an edge over Apple TV on the display front. While Apple TV can connect to nearly any high-definition television set, companies like Sony are creating televisions that are specifically used for Google TV. Another advantage of the device is its partnering with

news sources such as CNN and MSNBC, delivering news to viewers at all hours of the day.

Google TV may transform the television into a microcomputer, but the device still has some way to go. Critics argue that while the features are numerous and useful, operating the TV isn't simplified enough for most viewers. It has been described as designed for more serious computer users who are used to operating multiple devices simultaneously.

The Google TV varies in cost, depending on if consumers want to purchase an entire television or just use the receiver. Google TV is available from most major retailers. Check online for further details.





The right to a public trial

Three weeks ago, I wrote a column about whether the right to the confrontation of witnesses under the Sixth Amendment to the U.S. Constitution was violated in a case involving a screen being placed between an 8-year-old child victim witness and the defendant in a criminal case. The case I described is presently pending before the Michigan Supreme Court.

Interestingly, the Michigan Supreme Court has just granted leave to appeal in People v Vaughn, which is a case involving a different aspect of the Sixth Amendment concerning the right of a criminal defendant to a public trial.

In the Vaughn case, the defendant was convicted by a jury of four serious felony counts. During jury selection, the trial court closed the courtroom to the public for what is called 'voir dire.' Voir dire is French, and means 'to speak the truth' and describes the process of the court and the litigants questioning potential jurors as to their qualifications and suitability to serve on a jury.

The defendant's attorney did not object to the closing of the court-room and the defendant appealed his conviction.

In its opinion upholding the conviction, the court of appeals noted that a criminal defendant has the right to a public trial, which includes the right to have the courtroom open to the public during jury voir dire citing a 2010 U.S. Supreme Court case.

This fact notwithstanding, the appeals court held that the failure of counsel to object, even though error, did not warrant reversal of the conviction nor did it mean that counsel was ineffective because there may have been trial strategy reasons for the decision.

As with the previous Sixth Amendment case, the legal community will be very interested in the Supreme Court's decision and I will let everyone know when the final opinions are rendered.





The sluggish economy is shaping leaner and smarter financial views among the majority of Americans across the country. Belz' stay-athome and watch-every-penny view of finances is widespread and may be here to stay.

According to a recent CNN poll, 80 percent of Americans are eating at home more often. Another 67 percent of Americans are worried about their quality of life during retirement.

Denis Leyder, president of wealth management at The State Bank, agrees that people are more conscience of their finances than they have been in recent years. Homeowners are increasing their mortgage payments, paying off loans much sooner than the 15-year time period. Credit card debt is being

paid faster and is shrinking, overall. Bank accounts with nominal interest rates are becoming more frequent as families are planning for unexpected emergencies.



"We're definitely up," said Vic Canever Chevrolet Inc. General Sales Manager Matt Stevens. The dealership is up 10 percent each month over last year, which means around 20 more vehicles sold per month than last year.

Stevens said incentives are up, and it is helping drive sales. "We're selling a lot of trucks," he said.

Matt Lasco, general manager of Lasco Ford, said pent-up demand has caused an increase in larger sport util-

ity vehicles and truck sales. Medium-sized SUVs were responsible for the largest area of growth, according to news reports.

Stevens and Lasco both see stabilizing gas prices as a possible factor for better sales. "I think the stability of gas is making people more comfortable to make that purchase," said Lasco, who added that Ford would

probably continue the same incentives next year.

According to michiganradio.org, part of the increase in new car sales stems from Honda and Toyota coming back online after the tsunami in early spring severely diminished output from both manufacturers. Stevens believes GM's incentives are at least partially because of the Japanese brands ramping sales back up. He said their sales are not affected by Honda and Toyota producing more cars because local customers are mainly interested in domestic models.

The trend toward smaller vehicles has not changed. Customers are still migrating toward more fuel-efficient cars, said Stevens.

The Wall Street Journal also reported that in September, the only segment of cars with fewer sales than last year was larger ones. Stevens said larger cars such as the Chevy Impala are down slightly. "We've seen a lot of customers migrating to smaller cars," he said.

Stevens' own wife is downsizing to a Chevy Cruz. "People are making the most they can in smaller vehicles," he said. Improved technology in smaller cars, such as entertainment systems, is helping drive people to smaller cars.

Even with the bump in sales, Stevens said they are still feeling the weak economy. "It definitely feels like it's turning the corner," he said. "Our traffic is definitely up."

Lasco said Ford is up 18 percent in the surrounding region, which includes 184 dealers, and his dealership is up 25 percent in September and October,

or around 25 vehicles.

Lower lease payments are helping drive sales, according to Lasco, and he said that profits are mirroring the gross sales.

Jim Hall, owner of Hall Chrysler, Jeep & Dodge of Fenton, said his new car sales are up around 15 percent, but described business as "marginal," when overhead costs are concerned.

Richard Brinker, new car sales manager of Randy Wise Buick/GMC said their gains are similar to the other dealerships, and his staff is being kept consistent

with that modest growth. His sales reps are also trained to work with the buyers of today, who are cautious, and buying out of need, instead of want. "We're working with the trends of the market," he said.

Brinker expects the market to steadily increase, without any significant gains or drops.

Moreland said there are two opposing forces that are affecting new car sales. One is pent-up demand. The other is the stagnant economy that discourages people from buying, and encourages them to keep their cars

The auto industry is better off than it was two years ago, but still not where it was five years ago, he said. "I'm mildly optimistic. I don't think personally that we're going into a double dip recession." Moreland said that as long as a second recession doesn't strike, the industry will grow slightly, and pull other industries up with it.



DEAR DR. DONOHUE: I have puffy bags under my eyes. They look like they have water in them. I am an 85-year-old woman.

What's the best way to treat them? They aren't getting any better. I use ice on them, and it helps, but they come back. — M.C.

ANSWER: Those puffy bags under your eyes aren't filled with water; they're globs of fat. In younger years, tough strands of fiber held them in place. With age, those strands weaken, and the fat bulges out. Look around and watch for them on TV. You'll see that most people over 60 have them. They're not a sign of illness.

I have seen all sorts of ads for creams and gels that say they can shrink these bags. I can't vouch for any of them. I don't know if they work. I have reservations. One way to correct them is surgical removal. You can forget the ice treatment unless you want to keep it up. It's not a solution.



Tigers move on in district tourney

Clarkston — Sammi Cowger isn't one to willingly let a volleyball land on the ground without a good fight.

She proved that once again when the Fenton Tigers were trailing 16-14 in the first set of their match with the Swartz Creek Dragons in the opening round of districts at Clarkston High School.

A ball looked pretty much doomed beyond her reach. Yet, Cowger dove backwards with one of her arms flailing out way beyond her side. Somehow, her arm got the attempted escapee ball, and while in the middle of her awkward dive, she bumped the ball right back to the center of the Fenton side of the court for what resulted in a pretty decent offensive attack by the Tigers.

Fenton ended up winning the point, giving the Tigers the second point of a 10-point service run by Kennedy Piwowarczyk, helping spark a 25-17 first-set victory.

And from there the Tigers dominated the match, defeating what was a gritty Creek squad 25-17, 25-19, 25-10 victory in the Class A district. The victory earned the Tigers a semifinal matchup with Brandon,

slated for Wednesday at 7 p.m.

The winner of that match will face either Clarkston or Grand Blanc in the district championship match on Thursday at 6 p.m.

It's the mentality that Cowger showed on that one play that pretty much symbolizes Fenton volleyball. It seems during matches that the Tigers will make one of those incredible digs at least a couple of times a night.

"We are encouraged to never let the ball touch," said Cowger, who had 10 digs.

"Even if you know the ball is going to touch, you dive anyway because you never know what you can get to. The more you attempt it, the more times you do it.

"You don't really think (when you dive). You have to get the ball up anyway you can and you are sort of flying all over the place."

That dive, along with Piwowarczyk's service run, was all the Tigers needed in the first set to turn the tide back into Fenton's favor. From there, the Tigers got four kills from Payton Maxheimer, who has also been known the sprawl the floor to save rallies, a block by Maizie Martin and an ace by Piwowarczyk, earning the first-set win.

"Our serve receive wasn't very sharp and we had quite a few hitting errors. Not really hitting errors, but miss-hits," Fenton coach Linda Rusaw said. "We started off slow. But then Kennedy came in and served all those points — 10 in a row. She's serving second. She has a great serve so we have here there to try to get some aces."



But, a Linden run was stopped on fourth-and-goal at the Panthers' 1. The Eagles blew another chance when they fumbled in the endzone, giving West the ball back on a touchback. Finally, Linden found the end zone with 2:37 left in the third quarter when Brown hit Juhl with a reception to the West 2. Marsh followed with his two-yard score.

In the fourth quarter, Linden sealed the win. Brown found Kraus for a first down and then hit Brown for his 16-yard TD reception. Eddie Walterhouse added all

three PAT kicks.

Linden held West to only 122 yards and only 14 yards rushing. In the first shutout on Sept. 30 the Eagles' defense held West to only 37 total yards of offense. The first game was the first shutout Linden has had against West in 25 years. Now they have done it twice in the same season.

"Our defense was just ridiculous today," Brown said. "Hopefully they will do the same next game. I like teams keying on Kevin (Baker). We take advantage of it because we have so many good receivers to go to.

"I knew we would get in the playoffs. It was just a matter of who we would play. It worked out well.

"I am pretty confident we get to play (Lapeer East) again. I think we are more confident and have a chip on our shoulders."

One of Linden's defensive standouts, Gareth Elliott, had an ankle injury, and came out of the game in the second half.




