

As Mustafa Gheriani's car approached Freedom Square in Benghazi, he looked at a large crowd gathered there. "Now that's what I like to see, regular Libyans having fun," he said. A celebration on Friday included parasailing, which stopped many a car along the road as people got out to take pictures and videos using their cell phones.

Before the revolution, more than a few people assembling for fun, would be harshly questioned by the old regime,

Gheriani said. Now, up to a hundred Libyans met in the square. But, as his car turned the corner, random small-arms fire crackled nearby. "Now that's what I don't like," he said.

It was probably former rebel fighters firing for fun or practice, not at other people. There are still many assault rifles in the

city, and some trucks still have heavy artillery strapped in the back. Benghazi has actually been stable and free of violence since March. The real danger now is celebratory fire in the air that falls and hurts or kills someone.

Today, Benghazi, like the rest of

going in Libya. Libya, is rich in resources, but also suffers from neglect and abuse. The country boasts 1,200 miles of crystal-clear beachfront coastline on the Mediterranean Sea. However, the coastline is undeveloped

and strewn with garbage. Many buildings are crumbling and huge civil housing projects stand unfinished around the city.

Residents blame this on the fallen leader, Moammar Ghadaffi. Gheriani said Ghadaffi invested little or nothing

into Libya, and the people have suffered.

Gheriani is disheartened by the neglect, but is encouraged by rich natural resources such as oil, fisheries and rare fruits and vegetables in his mother country. This duality drives him to stay in Libya.

Gheriani, of Tyrone Township, and his wife Lois Van Lente, have two sons who are in college. He has roots in Michigan, but as a first-generation U.S. citizen, he feels caught between two cultures, two countries. For now, his place is in Libya. When he was



Path to citizenship



The local store would receive credit for the sale if the store's in-house portal were used to make the purchase.

When in doubt, use a search engine, such as Google, and see if your favorite local store has a website of its own for online ordering.

clothes, buying jewelry, etc.

Customers who shop on-line also miss the positive shopping experience of faceto-face assistance from a knowledgeable sales person or shop owner. There is more to shopping than just exchanging money for goods. Customers who purchase items from a retail store can also enjoy

browsing, comparisonshopping, social interaction and a positive feeling about supporting the local economy.

You also lose the power to negotiate the price and payment terms that may exist in local stores. When you buy from a local re-

tailer, you can often put your purchases on layaway, pay by check or cash instead of with a credit card, or extend payment terms because you are dealing with a business in person. Local retailers will often gift-wrap an item at no cost, a service you'll be charged for with any online transaction.

You may have to deal with the issue of an item being back-ordered, which you may not realize until only part of your purchase arrives. During the holidays, this can be a problem when you're dealing with the deadlines of company parties, family events, etc.

Sometimes, the shipping costs are higher than the true shipping rate, so that the retailer can make a higher profit

when they offer a specific item at low discounts, at special promotional rates, etc. A shopper needs to consider the full price of the transaction, not just the price of the item being purchased.

Returns and exchanges can be more difficult and

costly, because of packaging and shipping expenses incurred by the customer, not to mention the inconvenience. Sometimes, a re-stocking fee is charged, adding to the expense of a return.

You'll also want to be aware of the possibility of scams, security issues, etc., when shopping online.


DEBIT CARD FRAUD

home in Benghazi and the revolution flared up in the same city, he never felt the urge to leave. "I had this nagging feeling, 'I belong, I belong," he said.

Gheriani has coordinated many different efforts including setting up the de-facto media center, and speaking to the international press to share the image of the rebels to the world.

But they're not rebels anymore. Now, the National Transitional Council (NTC) has been recognized internationally as the current legitimate government in Libya.

Gheriani sees himself fitting into Libya's long-term recovery by finishing the infrastructure projects he already started, including water pipelines. "There are people whose wells are dry," he said.

His country looks abused, with neglect apparent in garbage along main roads. Bullet craters still pockmark many homes just outside Benghazi, from the opening battles of the revolution.

Aside from infrastructure work, Gheriani is working with other professionals to establish a new political assembly. He said it could become a party once a constitution is written that can define what a political "party" is.

On Saturday, he met with representatives from 10 other similar political assemblies to discuss merging, and the need for a general constitution.

He said his party would value the democratic process of electing leaders, in a system built from scratch. Five of the 10 groups agreed

they should merge with Gheriani's party, which is already 500-600 strong.

Gheriani would like to see a separation of powers, and of church and state. "Checks and balances are very important," he said. It will probably become

a parliamentary government, with various ministers elected to represent the people.

On Sunday, he traveled to the city of Shihad, three hours east of Benghazi, where he met with engineers to discuss the next step in his projects. He'd like to unite parts of Libya with water pipelines, but for now he waits

until money for infrastructure contracts is available.

Gheriani built homes in the Fenton area from 1996 to 2006. He pulled out of the business after building a reputation of trust in the Fenton area. In 2007, he began to work on infrastructure projects in Libya. Under Ghadaffi, projects still moved slowly, so that at the time of the revolution, the projects were only half finished. "I want to finish projects I'm in," he said.

Now his country is starting over. "It's a true revolution," said Gheriani. "The people revolted against the entire establishment."

Gheriani will focus on his projects, but it is education that Gheriani says must be the first priority. Oil can run out, but an educated country can do anything. "An educated society is limitless," he said.

visitors on Thanksgiving day as shoppers searched for the biggest bargains.

"A good portion of the people had already been out shopping all night," said Kmart store manager Rick Falck. "Customers gravitated mostly toward electronics." Aside from the Fenton police intervening over an altercation while customers were still in line, Falck said that overall, customers were courteous with one another.

With the bevy of new gadgets such as the Kindle Fire and iPhone 4s topping everyone's Christmas list this year, customers bought up everything electronic. GPS systems didn't stay on the shelves for very long. Popular video games such as Modern Warfare 3 and Batman: Arkham Asylum were also in high demand, disappearing in a flash. A GE 16 megapixel camera packaged with a free 12-megapixel camera also sold out quick.

Electronics manager Jill Ingles said that nearly every customer bought at least one electronic item during Black Friday. "The big deal was the Leader i7 Tablet for \$99.99 and a 40" LCD TV for \$299.99," Ingles said.

Electronics may top the list of everyone's wish list, but Christmas wouldn't be Christmas without the toys. Customers flooded the toy aisles, snatching up hard to find items for the little ones. Talking and dancing mechanical toys such as Fidgets and a rock 'n roll Mickey Mouse were the most in demand items, followed by "buy one, get one free" Fisher Price toys. La La Lucy was another must have toy for shoppers.

"There were a lot of singing and

dancing toys that parents wanted to buy their kids," said Mary Anne Potter, manager of the toy department at Kmart. "Most of the toys were in the ad, and at a good price."

Even customers who didn't have the cash on hand for gifts took part in the Black Friday sales by utilizing Kmart's layaway system. Under store

policy, customers still receive items at the Black Friday price, even if they don't pay the items off until weeks later.

Other area businesses, such as Eclections, also experienced long lines of eager customers waiting to cash in on the best deals of the holiday season.

"We had cars lined up at least an hour and 15 minutes before we opened up at 8 a.m.,"

said Eclections co-owner Nicole Bergeron. "There were probably 150 people waiting in line. It was pretty overwhelming."

Bergeron said Black Friday is the only time of the year that customers can expect deep discounts on the most in-demand products. Many people look forward to the sales year round and will wait in line for any amount of time. High-quality designer handbags from Vera Bradley were priced at 50 percent off and were the main attraction for most customers. Select clothing and fashion jewelry were between 50 to 60 percent off as well.

"More people came out this year than they did in previous years," Bergeron said. "More shoppers seem to be doing their Christmas shopping from local area stores as well, instead of going to stores outside of their community."

Nationally, Black Friday sales were higher this year than they were

last year. The National Retail Federation estimates that the average shopper spent nearly \$400 on Black Friday. ShopperTrak reports that Black Friday sales for 2011 were 6.6 percent higher than they were in 2010. The increase in sales may be an indication of an improving economy, as Black Friday sales in 2009 only increased by .3 percent from 2008.

A gift card provides a more personalized gift than a gift of money, because it can be tailored to the interests and tastes of the recipient. It's also easier to track than cash if the buyer has a receipt, in the unfortunate event of loss or theft. However, it's important for people to read the fine print before they purchase a gift card.

"Open" gift cards issued by credit card companies such as Visa or MasterCard are designed for use worldwide wherever

these credit cards are accepted, but there are limitations. For example, local restaurants surveyed in the tri-county area have difficulty utilizing these bank-issued gift cards in their sys-

tems at least some of the time, even at national chains such as Applebee's. They're also not advised for payment at hotels, gas stations and rental car companies because of the 15-day pre-authorization hold that some of these businesses put on the card. However, many hotels, gas stations and restaurants sell their own gift cards, which can be used nationwide.

For most purchases at stores and malls, bank-issued cards work very well for both the gift giver and the recipient. "We sell tons of our MasterCard gift cards for Christmas," said Margaret Cady, vice president of retail operations for The State Bank in Fenton. "We haven't had any complaints by customers except for one who was not able to use it to pay for a cruise bill at the end of the vacation. They've been taken and used all over the world, from Italy and Spain to England and France."

The State Bank's MasterCard gift cards are available in amounts from \$10 up to \$3,000, allowing for small purchases and large expenditures including computers, furniture, etc. The State Bank charges a \$5.95 fee for each card purchased.

Eclections co-owner Nicole Bergeron said the customer needs to know exactly how much value is left on a bank-issued card, because if they try to pay for a purchase that is larger than that amount, the card will automatically decline. Like many other local businesses, Eclections has its own gift card that customers can buy for any dollar amount, with an almost indefinite expiration date.

Thanks to gift card rules that went into



- Gift cards are good for a minimum of five years by law.
- If a gift card is inactive with no use, no fees can be charged for maintenance or storage for at least
- If a gift card lies dormant for more than 12 months, companies can charge for maintaining a balance. Most business-specific gift cards don't charge fees.
- Lost or stolen gift cards must be replaced, when proof of purchase is established, along with unredeemed value. Buyers should ask about policies before making a purchase.
- If a company goes bankrupt, there is no protection offered by holders of gift cards from that company.

of 2009 (CARD Act), gift cards must remain valid for at least five years. This act also regulated the non-usage fees that some companies were charging customers who didn't use their gift cards for a certain amount of time.


For example, the MasterCard gift card offered by The State Bank only charges a \$2.95 monthly fee on month 13 if the customer doesn't use the card. "If the customer chooses to use it slowly over time, there aren't any fees," explained Cady.

People purchasing gift cards should look for cards that allow users to check their balances online. They should also know what the policies are for a lost or stolen card. Many companies have policies in place to replace a lost or stolen card, especially if the purchaser has the receipt and can establish the unredeemed value of the card.


Many chain store gift cards can be purchased at pharmacies and supermarkets, including VG's Grocery and Walgreens. Many local restaurants and independent stores also offer gift cards or gift certificates, often with a value added, such as a free \$5 gift certificate for every \$20 spent in gift certificates.

the building, where Hometown Computers is located, have been working out details of a purchase agreement for a few months. The DDA went into closed session and discussed the purchase at its November meeting; however, no action was taken at that meeting.

Schmidt said both parties signed the purchase agreement just over a week ago. The DDA is paying Dr. James Hirt, owner of Fenton Foot Care, \$250,000 for the building. The building has three spaces that could be leased but Hometown Computers is currently the only business occupying a space.

"It's part of the cornerstone project," said Schmidt. "When we started, we looked at this building along with the Republic bank."

Michael Burns, director of the DDA and assistant city manager, said he signed the purchase agreement on Friday, Nov. 18 after Fenton City Council approved the deal in closed session at its Nov. 14 meeting.

Schmidt expects that the building will be demolished next April, about the same time as when the old Republic bank building is set to be demolished. The city bought the vacant Republic Bank site in December 2010 for \$325,000.

Schmidt said Mike Oliver, owner of Hometown Computers, has agreed to vacate his space by March 31, 2012 through a deal he worked out with his landlord. As an incentive to be out by deadline, Schmidt said their purchase agreement includes the DDA giving Oliver a \$5,000 check. "We didn't force Oliver to leave," Schmidt said.

Burns said the city and Oliver reached an agreement where he will pay \$1 monthly rent for January, February and March and if he leaves prior to March 31, he will receive the \$5,000, which is being kept in escrow.

To Schmidt's understanding, Oliver has selected another space within the city, which he is renovating. "It's a great business," he said.


The plan right now is to replace these buildings with parking, either surface or deck parking, according to Schmidt.

The building between the one just bought and the bank houses the Fenton Regional Chamber of Commerce office. Schmidt said the DDA has approached the owner, Carl Savage, about selling; however, the owner has declined. "He turned us down," Schmidt said. "Savage's building may stay there forever."

Burns added that there is currently no agreement in place between the DDA and Savage.

When asked why it was the responsibility of the DDA to purchase this property and not the Saab family, which is developing the site, Burns said the Saab family has committed millions of dollars to the project. When the partnership was formed, the city agreed to assist where it could. "This is our portion," said Burns.

The grand scheme of the \$4 million Cornerstone development has three new buildings right along North LeRoy Street with parking in the back. Schmidt said they have already received a couple of signed letters from prospective tenants for the first floor (retail/restaurants) and they're looking for two or three letters of intent for the second and third floors (office and residential).



DEAR DR. DONOHUE: I have seborrheic keratoses and have had them for many years. Doctors say nothing can be done. I had them cut off and frozen off, but they come right back. Can you help?

ANSWER: Seborrheic (SEB-uh-REEik) keratoses are brown, warty-looking spots on the back, chest, arms, legs and sometimes the face. They are not cancers and don't become cancers. There may be only a few, but there can be hundreds of them. Their cause is a mystery, but they appear at older ages, so aging is somehow involved. A doctor can scrape them off or freeze them. They might come back, but they can be retreated if they do. The tendency to develop them is inherited.



A Powers-packed state championship victory

Tri-county resident Pougnet leads Powers to 56-26 win vs. Cougars

In the most important football game of his career, Powers quarterback Garrett Pougnet had the game of his life.

But the junior signal-caller wasn't the only one to experience that sensation. The entire Powers' squad chipped in with a pretty magical performance during Saturday's Division 5 state championship game at Ford Field.

Led by Pougnet's four touchdown passes and two TD runs, Flint Powers captured its second state title in school history, upsetting top-ranked Lansing Catholic Central 56-26 in the Division 5 state championship game.

"Coming out there before the game when we got out there, taking it all in was amazing," Pougnet said. "All week I tried to stay focused on what I had to do. But I wouldn't have been able to accomplish anything without the offensive line and the receivers. They stepped up and played an outstanding game."

Powers did play a pretty outstanding game in all phases of the game. Minus a 2-0 forfeit victory recorded against Albion, Lansing Catholic Central's offense entered the title game averaging 47.6 points a contest. That included a 37-point performance against Powers during Week #2 of the regular season. But this time, the Chargers held LCC to just 26 points and a respectable 359 yards total offense. And while Pougnet ran for 155 yards and two scores, his teammates also ran for exactly the same numbers as well. Certainly it wasn't all Pougnet, but it's certain he was the star

Pougnet completed 12-of-15 passes for 258 yards and four scores, leading Powers to touchdowns on eight straight possessions. And his performance wasn't lost on his teammates.

"Garrett had the game of his life," Christopher Koenigsknecht said. "He played out of his mind. Everyone was clicking, though. The receivers were

catching everything he threw."

"Garrett played outstanding," defensive lineman Danny O'Brien said. "It was awesome. I knew Garrett could do that. In some games he'd have more running touchdowns than passing, but he really put them together in one game.

"When they couldn't keep Garrett out of the end zone, I realized we were going to win."

The Cougars opened the contest scoring on the game's first possession. Fueled by LCC's All-State quarterback Cody Rush, the Cougars took 11 plays to drive 65 yards for the game's first TD. It came on Rush's seven-yard completion to Matt Macksood with 7:09 left in the first quarter. However, from that point on, Powers, and Pougnet, dominated.

When the Flint Powers football team looks back at its 56-26 Division 5 championship victory against No. 1 ranked Lansing Catholic Central on Saturday, what most will remember was quarterback Garrett Pougnet's performance and how the offense was, simply, spectacular.

Powers' defense held the Cougars, who had scored at least 37 points in every game since a 21-19 victory against Madison Heights Madison the opening week of this season, to just 26 points. If prior to the game, the Powers' defense was told they would hold LCC to just 26 points, they would've taken it in a heartbeat.

"Our coach told us we would probably have to score 50 points to beat this team,"

The larger races start on campus and go through downtown Holly. The cost is \$28 with a shirt or \$23 a person within the same household.

"I am a family guy and love watching families run together," Basydlo said. "It makes sense."

There is free babysitting during the event for runners, and baked goods will be

provided as well. Messages will be available for runners before and after the race as well. All the proceeds go to Holly track and field programs within the school.

Basydlo is excited to see the event grow each year.

"I'm pleased with its success," Basydlo said. "Road races are popping up left and right. It's the thing to do to raise money. It's not a hard fundraiser, but you have to do it right. Two LCC penalties stalled the Cougars' next drive, setting up Powers' most impressive drive of the game. The Chargers went 98 yards on six plays, scoring on Pougnet's 69-yard TD run around the left tackle. Powers led 20-6 with 4:45 remaining in the half.

LCC cut it to 20-13 with a quick threeplay drive, scoring on Connor Bartlett's 48-yard TD pass from Rush with 3:32 left, but Powers responded with a sixplay, 75-yard drive of their own. Prescott Myers caught a 37-yard pass from Pougnet with just 47 seconds left in the half. Pougnet's two-point completion pass to Danny Meissner gave Powers a 28-13 lead at the half.

The Powers' offense wasn't stopped in the second half either. Pougnet had a oneyard TD run, while Myers caught a 34yard pass from Pougnet for Powers' two TD scores in the third period. Meanwhile, Rush had a four-yard run for LCC in between the two Chargers' scores. Powers led 42-20 entering the fourth quarter.

Powers then iced the game with two fourth-quarter TDs. Nick Sullivan scored on a 36-yard run, while Harchick scored on a 15-yard run. In between the two Powers' scores, Bartlett caught a 33-yard TD pass from Rush, but it was a case of too little, too late for the Cougars.

"Everyone played their best, from the first guy to the last. Everyone had a great game," lineman Macauley Rybar said. 
