A guiding voice through the skies

Ask anyone what they remember of 9/11, and they'll probably tell you that they were glued to the TV screen in disbelief, surrounded by family. Or, they were calling loved ones, just to make sure they were safe. But for Traffic Management

Coordinator Michael Rockman, silence dominated his day. Rockman arrived to work at Detroit Metro Airport to learn that nearly 7,000 planes had been grounded. On an average day, about 2,000 planes from all over the world fly in and out of Detroit.

Fenton — Attempting to rescue his stranded dog landed Dennis Charette, of Holt, in the frigid waters of Runyan Lake in Tyrone Township last Sunday.

Resident upset with what mobile home parks pay for fire service

►Believes township should collect \$90,000, not \$250

Tyrone Twp. — Tyrone Township resident Scott Dietrich is burned up on how the Tyrone Township board charges two mobile home communities for fire services. He shared his opinions during a recent board meeting.

Sun Communities and another mobile home park pay \$250 annually for fire runs, as opposed to Tyrone Township residents who pay \$150 annually for fire services. The \$250 covers every home within Sun Communities. Tyrone Town-

ship residents must also pay \$5 for a fire permit if they want to have bonfires and burnings on their property.

"It's very disappointing that the trust of the people was betrayed. We went to the polls and agreed to pay \$150 a year," Dietrich said during public comment.

Dietrich estimated that nearly 600 homes were covered by the \$250 annual payment for fire services.

"They pay 42 cents a unit per fire run. We should have been getting \$90,000 a year, a far cry from the \$250 we're charging. I don't think \$12.50 a month is going to kill anyone in there."

Last October, Steve and Layla Garant, of Tyrone Township, were charged \$1,337 for a fire run. The Garants had to pay the full bill because they did not have a fire permit.

The Tyrone Township board did not respond to Dietrich's comments.

1 Deodorant marks

Try this quick fix for those stubborn white deodorant marks that just won't wipe off: Dab the area with a sponge soaked in one part white vinegar and one part water (test a small area first in case it fades the fabric). The acid in the vinegar loosens buildup of the deodorant's aluminum chloride, dissolving the stain on contact.

2 Dust bunnies



To quickly capture dust bunnies, bend a wire hanger to form a loop, stretch one leg of an old pair of panty hose over it and spritz with furniture polish. Swish it around hard to reach hideouts, like under the bed or fridge. The damp nylon acts as a dust magnet to ensure sneeze-free surroundings.

Lose a pound a week!

It's easy if you just do the math

If you'd like to see a lot less of yourself in 2012, brush up your math skills and do a bit of subtraction. By the end of December 2012 — just 50 weeks away, you could be 50 pounds lighter if you follow the "numbers game" outlined by many health professionals.

One pound of fat contains 3,500 calories. To lose one pound of fat, you need to tip your personal energy balance by burning 3,500 calories more than you are eating. To lose that one pound in a week's time, you'd have to have a 500-calorie deficit every day.

Your first step is to determine how many calories you burn on an average day. Men typically expend 1,900 to 2,500 calories, depending on their level of activity, while women burn approximately 1,600 to 2,000 calories per day. For a more accurate account of your daily caloric requirements, you can turn to a basal metabolic rate (BMR) calculator, which

Tips to burn one pound of fat per week

- **Cut down on fatty foods.** Fat contains nine calories per gram, compared with four calories per gram for carbohydrates or protein.
- **Eat whole grains,** which are more satisfying and take longer to digest than simple carbohydrates like processed flour or white rice.

Summary

If you prefer the old style incandescent light bulbs and were worried about a looming phase out, don't worry, that warm yellow glow isn't going anywhere, just yet.

The Energy Independence and Security Act (EISA) was signed into law by President George W. Bush in 2007, and it in part, called for the phase out of 40-, 60-, and

Different types of light bulbs

Incandescent bulbs work by running electricity through a thin tungsten filament, in a glass bulb filled with inert gas. The tungsten heats up with electricity to 4,000 degrees Fahrenheit, and emits light. These bulbs are the cheapest in price, but waste 90 percent of the energy by creating heat.

Compact Fluorescent bulbs work by electricity entering the ballast at the bottom of the bulb, and then "exciting" a mixture of argon gas and mercury vapors, which then create ultraviolet light. The fluorescent coating inside the tube absorbs the energy and emits a white light. They are more expensive and sometimes

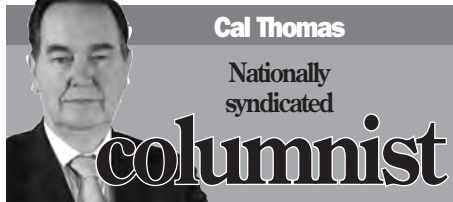

Voter ID law just makes sense

Is there, or should there ever be, a point when a state is no longer penalized for its discriminatory past?

Not according to the Department of Justice, which last Friday rejected a South Carolina law that would have required voters show a valid photo ID before casting their ballots.

Justice says the law discriminates against minorities. Why South Carolina? Because, the Justice Department contends, it's tasked with approving voting changes in states that have failed in the past to protect the rights of blacks.

Are they serious?

There are two African Americans representing South Carolina in the U.S. House of Representatives. One is Tim Scott, a freshman Republican. The other is 10-term Rep. James Clyburn, the current assistant Democratic leader. There are numerous minority members of the S.C. state legislature and Governor Nikki Haley who is Indian-American.

This is not your grandfather's South Carolina. Today's South Carolina is a modern, integrated, forward-looking, dual-party state.

If Justice thinks proving who one is by showing valid photo ID discriminates against minorities, how does it explain the election of so many minority legislators? Are only whites voting for them?

Not requiring a voter to prove his or her citizenship and residence is a recipe for voter fraud. Why? Because Democrats like to accuse Republicans of trying to keep minorities from voting because they know most will vote for Democrats.

The Brennan Center for Justice at New York University School of Law has compiled a list of new voter identification laws passed this year. In addition to the one in South Carolina, all require some form of photo identification. Will Justice go after all of them, as well?

A new Texas law, which took effect on September 1, requires a photo ID in order to vote.

Even historically liberal Wisconsin passed a new law this year requiring voters to prove who they are, in most cases with a photo ID.

Governor Haley and South Carolina Rep. Joe Wilson vow to fight the Justice Department ruling. They should. Photo IDs are required when flying on commercial aircraft or cashing a check. That discriminates against no one. Neither does requiring people to prove who they are before voting.

Lake Fenton Winter Classic rescheduled

►Pond hockey tourney postponed due to lack of ice

Who would have thought that an outdoor hockey tournament on Lake Fenton during the last week of January would have to be postponed due to a lack of ice? That's exactly what has happened though with the inaugural Lake Fenton Winter Classic, originally scheduled for Jan. 27-29.

Seasonally high temperatures and rain have forced the organizers to reschedule the tournament to Feb. 17-19.

According to organizer, Sean Lapham, the lake was nearly frozen on Sunday, except for a few spots. Tuesday's rain could have helped form a nice layer of ice, had the surface already been frozen. Areas of ice were 1-inch or less, not sufficient to hold the weight of hockey games.

Despite colder temperatures expected over the next few days, Lapham did not expect the thickness of the ice to be what's needed to support a tournament. He said they would go ahead with plans, "if we can get the lake to freeze over."

The community is invited to come out and play, watch and experience hockey at its purist form. Teams (age 18 and over) of seven will compete in a four-on-four game with no goalies or boards — only pure pond hockey. Currently, Lapham said he has enough teams for five divisions.

In addition to the pure enjoyment of pond hockey, fun is planned for the entire family, including open skating rinks, chicken bowling, kid games and prizes. Warmth, food and beverages will be available in the Fenton Moose Lodge.

Lapham said the hockey players, volunteers and sponsors have been very understanding of his predicament. "It's nothing I can control," he said.

Drive, which is on the south end of the lake. They were told that a man had fallen through the ice about 100 feet from shore while attempting to rescue his dog. His dog is now safe. The fire department sent out its heavy rescue truck and responders were equipped with their cold-water gear.

Cairnduff said the victim, in his late 50's was visiting his parents when the incident occurred. When his crew arrived, neighbors, including Farren, were already trying to bring the man in. "He tried to keep him up on the side of the canoe," said Cairnduff.

The fire department entered the lake, broke through the thin ice and pulled the man in with the use of ropes. Livingston County Ambulance transported Charette to Genesys Health Park in Grand Blanc Township. Cairnduff said, other than the hypothermia, Charette had no injuries.

Cairnduff estimates Charette was in the water for about one half hour and hypothermia was setting in. He said Charette struggled to move his arms and legs and his breathing was affected by the temperature of the water.

Farren said his little sister alerted him to the situation while he was working on

his truck with his dad. He grabbed his tow strap and started moving toward the man, who was struggling in the water. "It was hard to do anything because the ice was breaking even close to shore," he said.

Farren eventually used a canoe to safely slide out to the man's location. He threw him a rope and pulled him over to his canoe.

"As I was holding onto his jacket, I was making my way toward shore before the fire department showed up," he said. He broke ice with his boot to help the canoe make it back. "Physically, it was scary because it was a life or death thing," he said.

Farren estimates he spent 20 minutes pulling the man back to shore, and the man spent about 30 minutes in the water.

"I was pretty tired, and he was pretty much done, and said he wasn't going to make it," said Farren. "That guy has some fight in him, I'll tell you that much."

Cold hands, a dislocated finger and a little soreness are the price he paid to help save a life. "I can't imagine standing there not doing anything," he said. "His life was in our hands if we wanted to do something or not."

The proposed ordinance amends Village of Holly Ordinances, subsection 4-02-02-071 of Article 4-02-02 of Chapter 4-02 of the Village of Holly Code of Ordinances by amending the following:

4-02-02-071. Domestic violence; domestic assault.

It shall be unlawful for any person to commit an assault or assault and battery upon a spouse or former spouse, an individual with whom he or she has or has had a dating relationship, an individual with whom he or she has had a child in common, or a resident or former resident of his or her household. As used in this ordinance, "dating relationship" means frequent, intimate associations primarily characterized by the expectation of affectional involvement. This term does not include a casual relationship or an ordinary fraternization between two individuals in a business or social context. This section shall be enforced in accordance with MCL 264.15a.

The full text of the proposed Ordinance to be amended is available for review in the Office of the Village Clerk-Treasurer, 202 S. Saginaw St., Holly, Michigan 48442 during regular business hours. 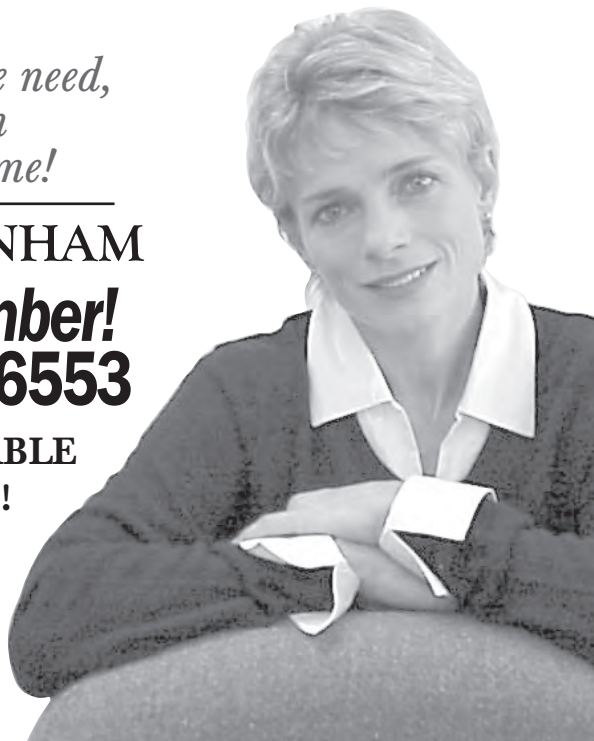

Entering Canada after and OWI or other criminal conviction *(part two)*

The Michigan Office of Highway Safety Planning publishes a newsletter called "Safety Network." In the January 2012 edition there is an excellent article titled "Collateral Consequence: Entry into Canada with a Michigan OWI Conviction," detailing the issues involved.

The basic Canadian law in this area is the Immigration and Refugee Protection Act, passed by the Canadian Parliament in 2001. The law provides inadmissibility of permanent residents and foreign nationals for "serious criminality" and provides inadmissibility for foreign nationals for "criminality." The statute covers offenses committed in Canada and outside of Canada.

Under the law, a foreign national convicted of an Operating While Intoxicated offense in the United States is deemed inadmissible into Canada provided the conviction is considered an indictable Canadian law offense. Impaired Driving is also included in this category.

If a person successfully enters Canada but is actually inadmissible because of criminality, they run the risk of being arrested and detained until Canadian authorities determine what action to take, which could include expulsion.

There are procedures in place to allow for entry into Canada notwithstanding a criminal conviction. If a foreign national has been convicted of a criminal offense in Canada they can apply for a pardon with the parole board of Canada.

Foreign nationals who are inadmissible because of a United States conviction can apply to Canadian authorities for rehabilitation status five years after the completion of their sentence and if granted, gain permission to enter. Additionally, for a single minor offense, such as Impaired Driving, a person is "deemed rehabilitated" 10 years after the sentence has been completed.

For foreign nationals not eligible for rehabilitation status there is also an application process for a "temporary resident permit." If granted, entry is allowed for a limited period and other restrictions may apply.

Dave Kurtz. "The sewer fund is healthy for now, but it won't always be. We have to pay Livingston County \$50,000 next year."

Township Clerk Keith Kremer said the increase will cost residents 25 cents more and that residents are currently paying \$6.68 per 1,000 gallons. "The only increase is to the flow rate. Residents will have to pay about \$5 more per quarter, or \$1.73 more per month," Kremer said.

Board members were also concerned about the lack of reserve funds for maintenance and capital repair. Supervisor Mike Cunningham questioned the township's ability to recover from catastrophic damages to their sewer systems.

"It's very unlikely that the pumps will go out all at once," said Steve Hasbrouck, who works for the Livingston County Drain Commission. "There are multiple pumps at the station."

In addition to the Republican Primary, Fenton Township residents and residents within the 51st District will be casting their vote on Feb. 28, for a new state representative, formerly held by Paul Scott (R-Grand Blanc), who was recalled from office in November.

Joseph Graves (R-Argentine Township), Steven Losey (D-Linden) and Cary Neuville-Justice (Green-Linden) are the candidates.

Andy Badgley, who handles voter registration for Fenton Township, said the application is a bit different this year. Residents must select one of three ballot types they would like to receive, Republican Party, Democratic Party or Ballot Without Presidential Primary, when they fill out their application.

Residents must also remember to

check the box indicating that they are a U.S. citizen.

Badgley said some people might be missing these requirements by rushing through the application or they might consider those questions an invasion of their privacy. Regardless of their opinion, all lines on the application need to be complete or the resident will not receive a ballot.

When incomplete applications are received, Badgley is required to send them back to the resident, costing the resident and township both time and the cost of postage. On Thursday, she sent back 20 incomplete applications.

Badgley said Fenton Township has a list of 600 residents that automatically receive absentee voting applications for elections.

"It was definitely an eerie feeling, you could hear a pin drop," said Rockman, who lives in Linden. "I've been in Detroit for 20 years and never heard it be that quiet."

That silence would last for the next five days following 9/11. Rockman wasn't sure when the planes would take to the skies again and he remembers trying to figure out what his schedule would be like. Eventually, traffic at the airport picked up and life proceeded forward.

Rockman became an air traffic controller when he joined the Air Force in 1979. Qualifying for any position upon taking his entrance exam, Rockman knew he wanted to be an air traffic controller as he watched planes land and take off. After eight years of active duty, Rockman attended the Federal Aviation Academy at the University of Oklahoma, where he trained for six months before working at the Toledo Airport. Eventually, he was moved to the Detroit Metro Airport, which is the seventh busiest airport in the U.S., traffic wise and 12th busiest in the world.

"To be an air traffic controller, you have to be good in math, especially geometry. You have to know when planes are coming in. It's all in the timing, miles and altitude," Rockman said. "You have to talk fast and be understood."

Air traffic controllers use phraseology to communicate with pilots. Worldwide, English is the standard language for air traffic controllers. At any given time, up to 10,000 planes are in the skies, being directed by air traffic controllers.

Day to day, Rockman said things at Detroit Metro Airport operate fairly smoothly. Rockman, however, has seen his fair share of dangerous situations in addition to 9/11.

He was working the day a Northwest Airlines DC-9 was clipped by another a 727 plane, killing nine people on contact. He was also at the airport when Umar Farouk Abdulmutallab – known as the "Underwear Bomber" – landed in Detroit on a flight from Amsterdam.

"That was hairy at first because we didn't know what the actual problem was," Rockman said about the Under-

wear Bomber. "The pilot said there was an explosion in the back. We landed the plane and Homeland Security took over after that."

Rockman has seen a vast improvement in safety protocol in the 20 years that he's worked at the Detroit airport. Radar equipment can now pick up planes on the ground and the air, no matter what the weather conditions are. Rockman said the United Air Traffic System is the safest in the world, attracting people from all over the globe for training.

"The most difficult part of the job is the volume of airplanes that come in. It's just so busy, it can be stressful," Rockman said.

"You gotta think and forget quickly. There's always something to do, and there's nonstop talking."

How to become an air traffic controller

In order to become an air traffic controller, one must attend the Federal Aviation Administration Academy, which is run by the University of Oklahoma. The program takes six months to complete and is a pass or fail program. Once training is complete, air traffic controllers are sent to whichever airport they're needed at. Full certification for the position can take anywhere from one to three years.

A majority of air traffic controllers start out in the military and attend the FAA Academy after their service. Rockman said quick, effective communication skills and high math competency, especially in geometry, is required.

The oldest someone can be when becoming an air traffic controller is 31. After the age of 56, air traffic controllers have to take a mandatory retirement. For more information on how to become an air traffic controller, visit faa.gov.

takes into account your height, weight, age, gender and level of activity (see sidebar).

Once you know your daily caloric requirements, you can create your own formula for losing one pound a week. To create a 500-calorie deficit, you can either eat 500 fewer calories a day; work off 500 more calories through exercise, or a combination of the two that equals 500 calories. At the end of each day, if you achieve that 500-calorie a day deficit through fewer calories, more exercise or a combination of both, you'll be one pound lighter in seven days.

Experts caution against losing any more than two pounds a week, which would involve a daily calorie deficit of 1,000, either through diet, exercise or a combination of both. Any more extreme weight loss than that and you'll cut into your lean muscle mass and drop water weight — neither of which provide sustainable weight loss.

Losing that one-pound per week should ideally include both diet and exercise. Although physical activity is an essential component to a healthy lifestyle, you still have to eat less to see the numbers on the scale drop. That's because it's much easier to take in extra calories by overeating than it is to expend those calories on a treadmill or other exercise program.

Many people have found that keeping a food diary is helpful in tracking, changing eating, and exercise habits. That can be as simple as keeping a notebook handy and writing in every B-L-T (also known as Bite, Lick or Taste).

• **Think before you drink.** Stick to calorie-free beverages, especially water, to decrease your calorie intake effortlessly.

• **Eat regular meals.** Skipping meals will make you so hungry you overeat later on, and can cause your metabolism to slow down. Stick to three meals and one snack per day.

• **Mix up your exercise routine.** Keep yourself from getting bored by pursuing different activities throughout the week. This will also help you override a plateau, when your body doesn't want to shed the weight even though you followed your regular eating and exercise plan. Mix it up so your body jumpstarts its weight loss again.

• **Do regular strength training.** Muscle at rest burns more calories than fat at rest. Increasing your muscle mass helps you lose weight more efficiently. The more muscle you have, the more fat you will burn.

• **Break it up.** Experts suggest a minimum of 30 minutes of exercise a day, but research shows that you don't have to do it all at once to gain weight-loss benefits. Take a brisk 10-minute walk in the morning and add a 20-minute bike ride later in the day. Even the busiest of people can fit in these short bursts of exercise.

What is your Basal metabolic rate (BMR)?

BMR refers to the minimum amount of energy, in the form of calories, that your body requires to complete its normal functions, such as breathing, breaking down food, and keeping your heart and brain working. 100-watt incandescent bulbs.

The phase out was set to begin in January 2012, in a schedule that would have gradually replaced them with alternatives like the compact florescent light (CFL) bulbs. But a provision added to the most recent fiscal year budget that congress passed and President Barack Obama signed in December 2011, gave the old-fashioned bulbs a brief stay of execution — until September 2012. This is when the next fiscal budget needs to be drafted.

Debbie Wasylyshyn of Ace Village Hardware in Linden is a little confused about the changes. "We've always had both kinds for sale, and they still are, both of them," she said. "People just come in and get what they need." Wasylyshyn said customers have not been asking questions about the phase out, or their light bulb options.

Kevin Coombs, manager for McKay's Hardware in Holly, said the change is coming to light bulbs, brief delay or not.

"They have delayed the first steps," he said.

"Everything got pushed back." The original legislation called for stopping the manufacturing of 100-watt incandescent bulbs in January 2012, 75 watts in 2013, and 40- and 60-watt bulbs in 2014. The phase out is going to take longer now, said Coombs.

He said that bulb manufacturers, such as General Electric (GE), are not changing their phase-out plan, because they know it's going to happen even with the delays from congress.

Coombs and his staff spent a great deal of time overhauling the light bulb display in the store. They still have a few packs of 100-watt bulbs, but also many more varieties of CFLs, halogen, and light emitting diode (LED) bulbs in the aisle now.

At home, Coombs said he uses CFLs because of the clean white light the bulbs emit. "They're definitely energy efficient and they last way longer," he said. To some, the 'clean' light can be seen as sterile, or cold. Coombs supports the changes. "You're going to save money," he said.

Here's a comparison: A 100-watt incandescent bulb puts out 1600 lumens, while burning at 100 watts, with a life of 750 hours. A comparable CFL puts out the same amount of lumens with only 26 watts, and it lasts 8,000 hours.

According to howstuffworks.com, 90 percent of the energy used to light an incandescent bulb is wasted creating heat, instead. Only 10 percent actually creates light.

The three main contenders to re-

place the incandescent bulbs are CFLs, LEDs and halogen. Coombs admits that the coil-of-light CFL looks weird, and said that a halogen bulb looks more natural. Some manufacturers have CFLs that are closed into a soft white bulb.

The most efficient, longest lasting light bulb is the LED, but at \$22 to \$48, many consumers won't take that plunge. Eventually though, LED's will even replace CFLs. Like any new

technology, prices and performance improve with time.

the light it produces is seen as 'sterile,' but is far more efficient.

Halogen bulbs work similarly to incandescent bulbs, in that a filament is encased in a clear container, in this case, quartz. The quartz container is smaller and closer to the filament, filled with a halogen gas. It lasts longer, and is more efficient, but burns much hotter. These bulbs are more expensive but last twice as long as incandescent bulbs.

Light Emitting Diode produces light from a solid "semi conductor" instead of gas, as in the CFL, or tungsten with the regular incandescent bulb. Light is created when electrons move about the semi conductor. They are very expensive, but last

the longest of all the bulbs and are most efficient.

To your good health

DEAR DR. DONOHUE: My boyfriend's feet sweat terribly. His socks are wringing wet when he takes his shoes off after running. I have told him to wear cotton socks, and he made the change. I don't see any improvement. Would a different kind of sock be better?

— H.M.

ANSWER: Acrylic is a better material. It wicks moisture away from the feet. Dusting powders and a change of socks will improve the situation. Have him carry an extra pair with him when he runs. Damp feet invite fungal infections.

Wins have been hard to come by for the Lake Fenton varsity boys basketball team this year.

In fact, the squad hasn't won a game all year.

At least that was true until Friday night.

The Blue Devils, who lost most of their team due to graduation from a year ago, captured their first win of the season with a 62-61 victory against the Durand Railroaders.

The Blue Devils were up 62-59 with 4.7 seconds left when Durand took the ball out of bounds in front of its own bench.

"We had our guys defend the three-point line and let them have the two if they wanted it," Lake Fenton coach Matt Furey said. "They threw the ball down low in the block for the final basket at the buzzer."

During the final minutes, Tim Hooks netted a three-point shot that gave the Blue Devils a lead. Kaleb Nealy and Darian Welch then hit some big free throws, icing the victory.

The win ended the team's six-game losing streak. Through it, Furey said, the team never gave up.

"The team has kept good focus since week one," Furey said. "We've

just tried to keep working hard, and tried to keep playing better as a team. And that was the biggest difference in the Durand game. The amount of our success as a team will come from team effort and not from individual effort. The work ethic has been great, and we are getting better each day."

The Blue Devils netted 14-of-27 shots from two-point land, and hit a sizzling 7-of-13 from three-point land. Tyler Begley and Welch

each hit two three-pointers each.

Welch led the Blue Devils with 20 points, netting 7-of-14 from the field, but two others ended up in double-digits. Nealy ended with 15 points, while Begley had 11 points.

"It was a great team win. We played unselfishly, and it didn't matter who scored," Furey said. "We had eight assists, which is a major improvement over some of our earlier games. Our goal is to pick up at least 10 assists a game, so we're getting there."

"Darian took good care of the ball, and finished well going to the basket. We moved the ball unselfishly from player to player, and it

ing that the talk about the area's top teams now involve Creek, Holly, Fenton and Kearsley, and we aren't seeing Southwestern, Northwestern and Davison. There has been a change in the dynamic the last four to five years. Right now, the schools battling for the Metro title have really good basketball players."

Fenton's goal — capture Metro League boys swim crown

Fenton — David Congdon and Chase Marcola have been around the Fenton varsity boys swimming and diving team for a long time.

As seniors, they have seen the team move to levels of respectability and dark-horse contender in the Metro League.

This season, they hope to see the team take another big step as the squad is aiming to become Metro League champions.

The Tigers are one of the contenders as they proved during a recent 120-62 victory against Lapeer.

"We got big potential for the end of this year," said Marcola, who is sidelined with a sprained meniscus. "Hopefully, everyone can step and just swim fast, swim as hard as they can."

Other individual firsts were earned by Rob Brownlee in diving (182.65), Joshua Bryant in the 100 freestyle (54.43) and Anthony Miceli in the 100 breaststroke (1:12.26).

The Tigers were particularly strong in the 200 and 100 freestyle events, taking the top two spots in both events. Chris Taylor took second in the 200 freestyle (2:08.54), while Cassidy won the 100 freestyle (54.64).

middle of a league championship chase. But for Hall, nothing has changed.

"It doesn't," Hall said. "Obviously you go into every year thinking it would be nice to be league champions, there's no doubt about that. But what we have to do is focus on what we can control and play at a consistent level. There are a lot of games left. It's hard to play 20 games and not have three or four hiccups. Our biggest opponent is ourselves. I don't get caught up if we win or lose, but more caught up where our kids' chins and shoulders are."

The Bronchos have seen gradual improvement over recent years. Not long ago, the team was winning two to three games a year. That eventually turned into an 11-9 season a couple of years ago and then a 15-5 mark last year. Nothing is written in stone that the Bronchos will remain in the title hunt until the end. Entering the season, they weren't the favorites to win the title. But from their play up to this point, no one will be shocked if the Bronchos remain in the chase the rest of the way either. They remain a resilient group, much like their leader has been during his tough years at Holly.

"I know they are going to keep on playing no matter what the score is," Hall said.

"That's something about the teams we've had the last four to five years. They aren't always the most talented, but they keep playing and fighting. And if you keep fighting, surprising things can happen."

Cory Cox has emerged as a constant scoring threat, while Eric Readman has proven to be a scoring threat as well occasionally. Defensive players Damon Thomas and Conor Muntin have played key roles, while Mitch Shegos gives the team a strong guard off the bench. Others have contributed valuable minutes as well. Olszewski is pleased with the team's defense, and how it's been able to play together as a unit.

"I think our defense has been even better than I thought it was going to be at the beginning of the year," Olszewski said. "I was looking at the scores today. We've given up 48 and 50 points, and that's the most we've given up. That's good if you keep high school teams 50 or below."

"Another positive has been the team chemistry. Having three transfers in and having returnees and new kids, that could be a little bit difficult to establish roles and finding niches. But they are doing a great job with that."

Holly was a bit more of a question mark entering this season, but still were expected to be near the top of the standings. But at 6-1 in league play, the Bronchos have to be thrilled with their position.

Holly's Nic Stoll has been emerging with some more consistent numbers recently, and Austin Hopkin remains an offensive threat. Meanwhile, freshman Isaac Casillas has also emerged as a new offensive threat, particularly with his perimeter shooting. The Bronchos also have played outstanding defense.

"This is probably the best rebounding team we've ever had. Our rebounding has been tremendous," Baylis said. "I've been really happy about that. We give up very few second-chance points."

"Second, we are a pretty good defensive team. We are giving up maybe 45 points a game. Those are the two things that stand out, things I wasn't sure about. I'm really pleased with those two things."

Both coaches expect a fun finish.

"The exciting part is eight of our first 11 games were on the road. Once we get through those 11 games, we are in decent shape," Baylis said. "We win 85 percent of our games at home."

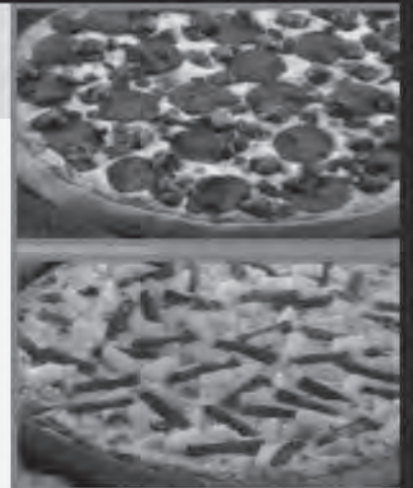
