

THE MAIN EVENT

Next week, the U.S. Supreme Court will hear three days of oral arguments in the healthcare lawsuit challenging the constitutionality of the Patient Protection and Affordable Health Care Act, otherwise known as "Obamacare."

We now know the law was based on phony predictions about its cost. After promising the price would be under \$940 billion over 10 years, the nonpartisan Congressional Budget Office has issued a correction of its initial estimate, which appears to have been based on sleight of hand accounting tactics by congressional Democrats and the White House. CBO now projects the measure will cost taxpayers at least \$1.76 trillion over a decade.

Randy E. Barnett, professor at Georgetown University Law Center, is troubled by the administration's shifting rationale in its defense of the health care law: "First they told us this was an easy 'Commerce Clause' case. Then they (said) it was an exercise of the Tax Power. Now it is the Necessary and Proper Clause. If the mandate was so obviously constitutional, the government would not be shifting its position 10 days before oral argument."

The Supreme Court has made clear that these are two separate requirements, both of which have to be met. And a law that can only be defended by a rationale that gives Congress a blank check to enact virtually any other mandate clearly is not 'proper.'"

Many wonder what will happen to needed reforms in health care should the individual mandate — the heart of Obamacare — be struck down. Many experts propose the states take the lead in reforming health care, as Massachusetts did, rather than dictate a one-size-fits-all system from dysfunctional Washington.

The authors propose what they call "Competitive Federalism" that would allow for a federal partnership, but permit states to fashion their own approach to health care based on their individual circumstances.

Much of our future depends on the Court's decision because it goes to the heart of what the government can be allowed to impose on a free people.

If the high court doesn't invalidate the individual mandate, there will be no stopping government from threatening our most valuable possession: liberty.

Estimate of value is \$625. The resident will be providing serial numbers of the pieces to police.

MEDS STOLEN IN HOME BREAK-IN

At 11:49 p.m. on Sunday, March 18, Fenton police were sent to a residence in the 1000 block of North LeRoy Street to investigate a home invasion and larceny of prescription medications. Based on their investigation, police learned that a 24-year-old Fenton man and his girlfriend argued. He left their apartment on Trealout Drive, walked to a nearby residence, entered and then passed out on the bathroom floor. The property owner entered the residence, noticed the unknown man, and forced him to leave. The suspect's girlfriend noticed later that her boyfriend had prescription medication on him belonging to the property owner and called her to report her findings. The next morning, the suspect stopped by the police station to report a theft of prescription medication, at which time police arrested him for breaking into the home and stealing the resident's prescriptions.

MOTORCYLIST INJURED

At 7:03 p.m. on Sunday, March 18, Fenton police and fire departments responded to an injury motorcycle crash at North Road and LeRoy Street. Police learned that a 47-year-old Fenton Township man, driving a 2001 Honda motorcycle, was traveling southbound on LeRoy. As he started to turn right onto North Road, with a green light, when a 2001 BMW, eastbound on North Road, started to turn into the business parking lot at the corner, into the path of the motorcycle. The motorcyclist took evasive measures to avoid hitting the car, which caused his bike to strike the curb. The injured driver was treated by STAT EMS and his bike was towed from the scene. He refused transport to the hospital. There was no contact made between the motorcycle and the car and no tickets were issued.



Arbitration

In last week's column I wrote about an Alternative Dispute Resolution (ADR) procedure called mediation. This week I will discuss another ADR procedure called arbitration.

Arbitration is a process that is similar to a trial. It differs from mediation in that rather than having a mediator facilitate a voluntary settlement between the parties, arbitration requires the parties to each present their cases before either a single arbitrator or, as is very often the case, three arbitrators with each party selecting an arbitrator with the two arbitrators then selecting a third.

After all of the evidence has been presented, the arbitrators issue a written opinion as to findings of facts and law and as to which party prevailed.

In Michigan, there is both statutory and common-law arbitration.

Statutory arbitration is typically used when the parties have entered into a written contract that provides for it. If there is statutory arbitration, neither party can unilaterally revoke the agreement and the arbitrators decision can be entered as a judgment by the Circuit Court.

Common law arbitration is similar to statutory arbitration and is employed when the statutory arbitration requirements have not been met. The primary distinction is that either party can unilaterally terminate arbitration before the arbitrator(s) renders an award. If arbitration results in an award, the prevailing party can also have the award entered as a Circuit Court judgment but there are some different rules that apply.

Michigan has long had a public policy strongly favoring arbitration as an alternative means of settling disputes.

The American Arbitration Association is a not-for-profit organization and is very commonly used to arbitrate disputes both here in Michigan and nationally.



Considered to be one of the most important legal documents ever written, the Bill of Rights is the collective name given to the first 10 amendments made to the United States Constitution. These first 10 amendments date back to Dec. 15, 1791, when they were ratified. Since then, there have been 17 additional amendments, with the latest having been enacted in 1992.

These amendments that make up the Bill of Rights is what gives U.S. citizens the freedom of speech, the right to bear arms, the right to a trial by peers, and more.

Albert Price, a political science professor at the University of Michigan-Flint, describes the Bill of rights as granting us protection from arbitrary governmental power and governmental intrusion.

How to define what is intrusion and what is not can sometimes be difficult. While the text and wording of the

document remains a constant, the way that we read it, and more importantly, how the courts interpret it, is fluid.

The second amendment is a model example of how the meaning of the Constitution

can change over time. Recently, a man openly carrying a firearm entered Lake Fenton High School to vote in the election last month. Several people debated whether he had the right to do that — by law, he had the right.

"The right to bear arms has been interpreted differently. It used to be thought of a collective right, but now is thought of an individual right by courts," Price said, addressing the longstanding debate of whether the second amendment applies only to militias or to any singular person as well.

Other rights granted by the Bill of Rights are not explicitly stated in the original document, but are instead implied. Price describes the right to privacy as an example, which was born out of the 1965 Supreme Court case of Griswald v Connecticut. The way that we understand what was written centuries ago is just as important as the actual words themselves.

The significance of the Bill of Rights cannot be understated, and remains as relevant today as when it was written, and stands as an important symbol of freedom in the nation.

CONSTRUCTION

The **fourth amendment** protects people from unreasonable search and seizure, requiring warrants with probable cause.



When a person tells you to "go fly a kite," they have actually invited you to participate in one of the most enjoyable rites of spring and summer.

With spring's windy days, kite flying is a sport just waiting for the energy levels of the young or "young at heart." Just as in a perfect sailing day, there are also justright conditions for flying a kite.

For the most enjoyable kite flying experience, a person should seek

a clear, open area, staying away from roads, power lines or airports. Open fields, parks and beaches make the best kite-flying sites. The more room a kite flyer has, the more line he or she is able to let out for maximum speed and height.

Wind that is too strong or too light is difficult to fly in, according to kite experts. About 5 to 25 mph is best for most kites and can be easily measured by watching when leaves and bushes start to move, before it really starts to blow. When the wind is just right, a kite flyer can make a kite dance across the sky by pulling in and letting out the line.

Kite flyers should never fly a kite in

rain or lightning.

HOW TO FLY A KITE

▶Find a large and windy open area free of trees and power lines — two things that are notoriously dangerous for kites and their owners.

►Hold the kite in both hands, and toss it lightly into the wind until the wind catches it. This works well when the wind is moderately strong.

► Alternatively, let out a small length of kite string and, holding the string in your hand, run with the kite behind you until the wind lifts it.

▶Begin letting out string until the kite reaches a height with which you are comfortable. Good heights generally range from 50 to 100 feet.

► Keep an eye on your kite, as it may come crashing down because of sudden changes in wind. If it dips, run or pull in the string a bit to give it some lift. Bring the kite down by slowly winding the kite string around

▶Reach out and grab the kite before it hits the ground to avoid damaging it.

A recent study by Oregon State University found that most diet pills are ineffective long-term solutions to weight loss. The study "Dietary Supplements for Improving Body Composition and Reducing Body Weight: Where is the evidence?" found little proof that diet pills can help lose more than four pounds.

"I do not recommend diet pills. You're putting a lot of chemicals into your body and that's unhealthy," said

In some cases, diet pills can have extreme side effects and may cause death. In the 1990s, the weight loss drug Fen Phen became extremely popular, starting a new diet fad.

According to PBS, more than 100 cases of heart attacks from Fen Phen were reported to the Food and Drug Administration (FDA). The FDA pulled Fen Phen from the shelves in 1997 and lawsuits against the manufacturer have followed ever since.

Weight loss drugs have not been approved by the FDA in over a decade. A new drug called Qnexa may change all that, as it was recently endorsed

by the FDA advisory committee and is scheduled for full review in April. The



Fenton Farms Golf Club. "They're out playing golf in their shorts so early in the season. Typically, our opening date is between April 7-15, depending on the weather. It's like we never really closed, because we had golfers out here on a few nice days in January and February."

Fenton Farms Golf Club is usually the last golf course to open for the season, because its close proximity to Lake Fenton typically turns early spring's melting snow into a "muddy bog," according to White. "Since we didn't have much snow this year, there's not any mud. In fact, in the last two days, everything has 'greened up' like it normally would in May."

Coyote Preserve Golf Course General Manager Nick Thompson is appreciating this early jump-start to the golf season, too. "It's not the earliest we've ever opened, but it's been the most on-going warm weather we've ever had this early," said Thompson. "Typically, our March weather is 40 degrees and windy, and if it's sunny, it's a plus. We usually have golfers on the course by March 20-25, but the weather's not nearly this consistently warm. We've already mowed and rolled our greens five times."

Golf course owners aren't the only ones seeing a rush of early spring mowers. "We don't usually have this kind of activity until April," said Jordyn Harris, a cashier at McKay's Hardware in Holly. "People are bringing in their lawn mowers, blades to be sharpened and are even buying soil and seeds this early. We've had lots of





15 PAUL G. DONOHUE, M.D. To your good health

DEAR DR. DONOHUE: My husband has just been told he has spasmodic dystonia. He has had two Botox injections. They made it worse at first but then better. Friends and family have never heard of it. Would you give us an explanation of it in layman's terms?

ANSWER: Spasmodic dysphonia messes up the voice. People often believe they have laryngitis from a virus. They don't; they have a cramping of the muscles that control their vocal cords. Their voices crack while saying a word, or become weak and breathy, or sound as though they are being choked. Sometimes it seems like the affected person has developed a stutter. The condition usually arises between the ages of 30 and 50. Its cause is unknown.

An ear, nose and throat doctor can make a diagnosis by viewing the affected person's vocal cords and seeing how they are misbehaving. Botox can put an end to the vocal muscles' spasms. Treatment lasts for about three months, and then another injection is given.

KITE Continued from Page 12 WHAT MAKES A KITE FLY?

The principle that makes a kite fly is the same as that which keeps an airplane aloft, according to kids.britannica.com. An airplane creates its own wind by its speed through the air. On a calm day running with a kite in an open space produces the same effect. The kite rises because currents of air, moving parallel to the ground, strike the face of the kite and force it backward.

Although tails are not necessary for kites to fly, the tail of a kite allows it to fly in a more stable manner. The tail creates drag, slowing down the sideways movements and showing more of the front of the kite to the wind. When the tail creates drag, it lifts the front of the

kite, allowing more air to get under it and lift it up. Tails are also used for decoration.

WHAT MAKES A KITE FALL?

In order to stay in the air, the kite needs air pressure flowing under and over the wings to be equal on both sides. If it becomes unequal, the kite will begin to wobble, and if it is not equalized quickly, the kite will fall. A kite flyer can equalize the pressure by keeping the kite level into the wind most of the time.

There are many different kinds of kites, from "toy" kites for children—to sport and stunt kites. One of the most popular "extreme sports" today is based on kites, and it's called kiteboarding a combination between surfing, windsurfing and wakeboarding.

His freshman season, Gonzales won a state title. He lost out on being our Wrestler of the Year because teammate Josh Houldsworth not only won a state title, but went undefeated.


Last season, he placed fourth at the state meet. But Todd Melick took third at the same weight class, and his brother, Esteban Gonzales, took our wild card spot by placing third.

Holly's Scott leads our wrestling team

Senior caps perfect season as Tri-County Wrestler of the Year

Holly wrestling coach Don Pluta remembers the first day he saw Shawn Scott.

"He was one of those elementary school kids I'd watch practice," Pluta said. "When I noticed him, he was in the fourth grade with some elementary school kids in the wrestling

room, and I was like 'Who's that kid?' He was in fourth grade and he was tearing up kids in his age group and other

kids that were older than him.'

Not much has changed since his fourthgrade days. About eight years later, Scott spent the entire 2011-12 Holly varsity wrestling season, tearing up opponents, eventually capping his senior season with a Division 2 215-pound state champion-

He's earning another honor. He's the Tri-County Wrestler of the Year.

Scott remembers those early years. He

started wrestling when he was 7.

"My Dad took me to a little club practice and asked if I wanted to do it and I said, 'Yeah.' I started doing it and started travelling around the nation. My first year I got to go on national tournament teams. I thought it was cool to be on team duals out of the state. It kept me motivated, and going on."

Scott's career has been a pretty bright one. He's one of Holly's few four-time state participants, is a three-time state placer and has made it to the state championship match twice in his career, including this year's victory at 215 pounds.

But while many might think it came easy for Scott, that has hardly been the case. In his freshman year it was tough just to make the starting lineup. He had wrestlers like his brother Brendan Lagios, Matt Green, and state champions Josh Houldsworth and Jake Hyde surrounding his preferred weight classes. He was forced to cut weight and wrestle at 140

"I was cutting 20 pounds, from 160 to 140," Scott said. "It was not fun. It was a really long and dragged out year."

Still, Scott flourished, posting a 48-14 record and qualifying for state.

In his sophomore year, Scott wrestled at 160 and posted a 55-10 record, taking fourth place. He ran into Greenville's Jordan Thomas in the second round, losing the match 18-5. That wouldn't be the last time he ran into Thomas.

ing the regular season and then won the divisional title. At regionals, the squad dominated regionals, earning the regional championship. At the state meet, the team struggled, keeping them from finishing higher in the final poll.

No. 3 - Fenton boys swimming and diving: The boys finished second at the county meet, won all of their duals but one against Grand Blanc, dominated Metro competition en route to a league crown and had seven participants compete at the state meet. 
eryone would pretty much expect those high expectations. It's what Fenton's girls team does routinely. But the boys did the same this year and look to be a team to watch out for in the future as well.

The Tigers followed that with a strong showing in a loss to top-ranked Saginaw in the regional semifinals. But before the tourney run, the squad also went 19-1 during the regular season and won a fourth straight Metro League crown.

No. 1 - Holly wrestling: Last season's No. 2 winter team gets to the top of this year's poll. And why not? It really wasn't even close. The Bronchos dominated regular season play, winning the Metro League and then had postseason success. The squad went to the team state tourney for the second straight year and had two wrestlers win individual state champions, a third make it to the title match. The Bronchos have a decent shot at being the school year's No. 1 team.



While talking about a similar situation in a game he witnessed in which all sides roared with approval, he opened up a newspaper a day later which described the incidents with one headline — "Game marred by fighting."

His whole point was the absurdity of the whole article. No one thought the game was marred by the fighting. In fact most roared with approval. And, Monday night, it was exactly the same.

Does hockey need fighting? Probably not. But is it bad for the game and does it cheapen the product? I don't think so.

Ask Hockeytown fans to name some of their top visions of the last 25 years, and certainly many will involve goalie fights and other battles involving people like Bob Probert.

Heck, I went to a professional game in Flint about five years ago, and it ended

with its share of fisticuffs at the end. All I remember about that game was the Generals lost (forgot the score) and that it was an uneventful game. That was the case at least until the final 20 or so seconds. That's when some fights broke loose, including a goalie vs. goalie fight. Now that was entertainment. Without a doubt, it remains one of my most memorable hockey games I have attended.

Now, should there be fights every game, or even every other game? Probably not. Like everything, sometimes little less means more. But I personally think if hockey wants to attract more fans, banning fighting won't do that. In fact, I'll bet ESPN showed more NHL highlights Monday night concerning that fight than they have of hockey games in the last week combined. It's those instances that create appeal for the NHL.

So leave fighting alone NHL. It's part of the game. In fact, it's one of the highlights of the game.

In his junior season Scott, who finished the year 57-2, said it was the first year he really looked at the state championship as an honest goal. But his weight class (171) included nationally ranked Thomas. Scott cruised to the finals, gave Thomas a better battle this time, but lost 6-3. He also lost to Thomas at the Team State Wrestling Meet a week earlier.

"I definitely didn't want to lose to him at team states and then lose to the same person in that finals," Scott said. "That was my motivation, losing that finals match."

It paid off. Scott went to 215 pounds, defeated Lowell's Josh Colegrove in the semifinals and then defeated St. Johns wrestler and good friend Payne Hayden 3-1 in the finals.

"I knew it was going to be a tough match. We go back and forth," Scott said. "(Winning a state title) was worth it. When I was done and I got that final takedown, looking up and seeing all the fans was just something I'll never forget."

The win also meant a lot to the program, considering Scott came through the Holly Roughrider pipeline, Holly's feeder wrestling program.

"(When I saw the Roughrider wrestlers) They were like I was Superman," Scott said. "They were all happy, giving me high fives. It was a pretty cool experience."

Pluta says seeing a wrestler like Scott go through the program is important to the younger levels.

"When the younger kids see Shawn Scott and know he came through the

same program, that's tradition. We are big on tradition," Pluta said. "Club coaches talk to the wrestlers saying Shawn was just your age a few years ago and is now a state champion. And he has that contact with the kids in the program. They see him and it forms a relationship."

Now Scott is preparing to start a relationship at the collegiate level. He's headed to Northern Illinois University on a full-ride scholarship. He'll probably wrestle 197 next year.

"When I was in the eighth grade going into my freshman year, that was my mindset," Scott said. "I wanted to go farther and not be satisfied with just four years. I wanted to go to college and potentially wrestle for national championships."

No one in Holly would be shocked to see him do that in the next five years.




