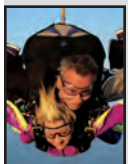

Communities mourn slain officer

► Patrick O'Rourke remembered as courageous and loving family man

Fenton — Hundreds of police officers from around the state gathered at St. John the Evangelist Catholic Church to mourn the death of Officer Patrick O'Rourke on Friday. A somber mood fell over Fenton as roads surrounding the church were shut down and out-of-town patrol cars made their way to the church.

O'Rourke, 39, of Tyrone Township served the West Bloomfield Police Department for 12 years. He was killed in the line of duty Sunday when he and other officers responded to a home disturbance call, where a gunman shot O'Rourke through a bedroom door. O'Rourke was a father of four and very involved with St. John Church, according to Fr. David Harvey, who presided over O'Rourke's funeral.

In the backdrop of the solemn ceremony were the Applefest carnival rides, which remained silent and still throughout the funeral. Church bells rang while

bagpipes and drums filled the air inside and outside the church.

Expensive cuts of meats tend to be the ones that are tender and can be cooked quickly and easily. But you can save money at the meat counter by knowing what cuts to look for and how to prepare them to bring out their best flavor.

Check out "manager specials," on meats with quickly approaching expiration dates for better prices.

Wagner says that beef today is not aged as it used to be with fat and marbling, and needs to be cooked slower with added moisture and seasonings. "Always ask your butcher for seasoning tips on the meat you've selected at the meat counter," advised Wagner.

CHUCK STEAKS

Chuck steaks are a great alternative to more expensive steaks and the chuck eye steak is the best of this primal cut. Chuck steaks are not as tender other cuts, but a good marinade and slow cooking will more than make up for this.

TOP SIRLOIN

This cut of meat is \$2 to \$3 cheaper per pound than a rib eye steak or Delmonico and it is a leaner cut. It can easily be grilled or used in a variety of recipes, from stroganoffs to stir-fries.

CHICKEN

The most affordable way to buy chicken is a whole fryer, which can be bought at VG's or other grocery stores for as little as 89 cents per pound. The secret to saving money when buying chicken is to avoid the pre-cut pieces.

The kids are back in school and you don't have much time to spend in the kitchen. You're also concerned about cooking healthy meals, but don't want to "break the bank" to feed your family. Here are a few tricks to keeping food costs down, while serving delicious, healthy foods.

Possible use for downtown Linden parcel

Reading about Linden’s purchase of the former Union Block land and the discussion about marketing the land for future business uses causes me to propose another possible use. Since this property is in the exact center of Linden, why not make it a town centerpiece as a veterans’ memorial park. I have visited such parks in other small cities and it is always an interesting stop. The park could also be used as an unmanned map and pickup center to tell about Linden’s history and area points of interest. The City has a good amount of money invested in this parcel and some may think that the City should try to recover the investment by selling it for private businesses. The problem I see with this plan is that it puts the City in the business of spending tax dollars to attract other businesses that likely would be competitors for existing businesses. This seems a questionable use of public funds, marketing to attract competing businesses. In my view, a nice veterans’ memorial with statues and monuments, to recognize those who have served and sacrificed, would be a good use and well worth the dollars spent. Swartz Creek has just completed such a veterans’ memorial. It is a wonderful tribute to all the service branches. I would encourage residents and City Council members to take a look at it and see if they agree that this would make a great centerpiece and lasting tribute for Linden.

Spartan Stores recall deli products

►VG's pulls items, Alpine Marketplace, Holly Foods not affected — make own deli products

To avoid health concerns, Spartan Stores is issuing a precautionary recall of several deli products. The recall comes after a routine surface swabbing performed by the FDA resulted in positive samples of the *Listeria Monocytogenes* organism.

The recalled deli products include various vegetable trays, fruit cups, dips, quiches, salads, and sandwiches.

Calls to Alpine Marketplace in Linden and Holly Foods in Holly revealed that those stores, which carry Spartan brand products, did not carry any of the deli items listed in the recall. VG's Grocery in Fenton, another store which carries the Spartan brand pulled all recalled items from its shelves.

"We didn't carry any of those products, we make all of our deli products in-house," said Marvin Yono, owner of Alpine Marketplace in Linden.

Likewise, Denise Addis of Holly Foods said that their deli makes their own materials, and does not utilize the products being recalled.

North Leroy VG's grocery manager Jessalyn Race said that while the store does not know if the products they received were infected, everything was pulled.

Currently no products have been identified as having come into contact with the organism, according to a Spartan Stores press release. Spartan Stores urges that anyone concerned about an illness to contact their healthcare provider immediately.

If consumed, *Listeria Monocytogenes* can result in potential fatal infections in young children and the elderly, or anyone with a weakened immune system. Still, even healthy individuals can still suffer symptoms such as

high fever, severe headaches, stiffness, nausea, abdominal pain and diarrhea. It can cause miscarriages and stillbirths among pregnant women, according to a press release.

Holly schools to hire firm for search

►Superintendent needed by July 2013

Holly — The search for a new superintendent for Holly Area Schools has not yet begun, but it is closer to finding the firm that will conduct the search.

On Monday, the Holly Board of Education decided to solicit presentations from two firms that would carry out a search to replace retiring superintendent Kent Barnes. The contract for the new superintendent should start July 1, 2013.

The board chose two out of four firms that responded to the request for proposal (RFP). Both are Michigan firms with experience in superintendent searches. MASB (Michigan Association of School Boards) of Lansing and North Star Staffing Inc., of Clio will make presentations to the board.

The firms will have 30 minutes to pitch their plan to the board, after public com-

ment at the Sept. 24 board meeting. In preparation, the board will have a special meeting next week to come up with a few points the firms should focus on.

The board has worked with MASB before, when they conducted focus groups to discuss options for closing down school buildings.

North Star is asking \$4,800 plus travel, and MASB is asking \$8,000, plus expenses. Both were considerably less expensive than the other two, and are the only firms in-state, said trustee Linda Blair. She said she'll decide which she likes better after the presentation.

Apple unveils new iPhone 5

►The lightest phone ever made will be available next week for \$200-\$400

Despite being the sixth generation of iPhone, the iPhone 5 is the name of the phone that Apple revealed this week at a press conference.

The iPhone 5, made of glass and aluminum, is purported to be the world's thinnest phone, and weighs just 112 grams. The new phone will be 18 percent thinner and 2 percent lighter than its predecessor.

Also setting the phone apart from its predecessors is the bigger, 4-inch display screen. A higher resolution will also allow the iPhone 5 to display five rows of apps at once — perhaps one of the reasons that led to the phone's name.

"It's the most beautiful device we've ever made," said Apple global marketing chief Phil Schiller

The phone's 8 megapixel camera will feature a new low light mode that will make for better pictures in dim settings, and will also have a sapphire

crystal lens cover to offer better protection for the camera lens. The front facing phone, used for video conferencing, has also seen an upgrade to 720p backside illuminated lens.

Battery life, a major sense of criticism for the iPhone 4S, has also seen an upgrade. The new iPhone 5 is expected to get eight hours of talk time or web browsing using the 3G network, and last for 225 hours on standby.

When not hanging out with celebrities on the sets for iPhone commercials, Siri, which is an interactive voice command feature, has also learned a few new tricks. Users will be able to use Siri to launch apps and receive information on movies that are playing nearby, and receive the results

of sporting events.

The iPhone 5 will be available in three different sizes, 16GB, 32GB, and 64GB for \$199, \$299, and \$399 respectively. The previous model, the iPhone 4S, will be available for \$99. The device can be preordered starting on Sept. 14.

The iPhone 5 will be finding its way into customers' hands just one week later on Sept. 21.

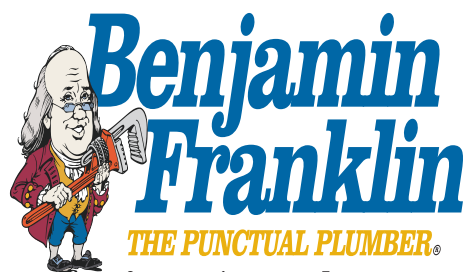

Officers gave a 21-gun salute and read O'Rourke's badge number before his burial.

"There's going to be a big void at our café in Fenton."

Muncy was with Panera Bread for about five years and was general manager at the Fenton location for the past three.

According to the Livingston County Sheriff's Department, deputies were dispatched to southbound U.S. 23, north of Crouse Road at 10 p.m. on a report of a motorcycle crash.

Preliminary investigation has revealed that Muncy was traveling southbound in the right lane when he lost control of his 2006 Honda motorcycle. It is unknown at this time as to why he lost control of the bike. He was wearing a helmet.

After losing control of the motorcycle, he was ejected into the left southbound lane, where he was struck by several vehicles. He was pronounced dead at the scene.

The sheriff's department said that the first vehicle that struck Muncy after he was thrown from the motorcycle stopped at the scene and then left prior to the arrival of emergency personnel. The sheriff's department is requesting the assistance of the public in identifying this vehicle.

Based on vehicle parts found at the scene, the vehicle appears to be a grayish or light blue Mercury that was possibly an older model Grand Marquis. The vehicle

has significant front-end damage and is now missing the silver Mercury grill. A female was seen exiting the vehicle when it initially stopped at the scene.

Anyone with information pertaining to the vehicle is asked to contact Crime Stoppers or Dep. Brad Neff with the Livingston County Sheriff's Department Traffic Safety Bureau at (517) 540-7984.

Deputies were assisted at the scene by personnel with the Michigan State Police - Brighton Post, Hartland/Deerfield Fire Authority and Livingston County EMS. Southbound U.S. 23 was closed for approximately four hours, while deputies investigated the scene.

However, boneless chicken breasts can also be a bargain, because there's no waste and they can be purchased for as little as \$1.88 per pound. Chicken thighs are another bargain at the meat market, especially when prepared with slow cooking methods.

PORK

"Pork is cheaper than beef right now," said Wagner. He advises consumers to look at more flavorful and less expensive cuts like the rib end cut or chef prime chops, pork loin roasts and pork cutlets. Pulled pork is another popular dinner choice, coming from fresh shoulder, also known as a Boston butt roast. "Most people don't realize this cut is actually from the butt end of the front shoulder," said Wagner.

GROUND BEEF

Wagner advises customers to look for certified ground beef, which is what the VG's meat counter carries and grinds fresh daily, packaged as ground chuck, ground round and ground sirloin. "I suggest people buy ground round. At 86 percent lean, it's in-between ground chuck and ground sirloin as far as fat content and price," said Wagner.

FLAT STEAKS

Flank steak, skirt steak and hanger steak used to be so cheap that butchers used them for ground beef. While their price has gone up significantly over the years, these cuts can still be a good value because of what you can do with them. They are also "all eating," so there's no waste. Since these are tougher cuts of meat, your best bet is to marinate, grill, and slice. Serve these meats on rice or pasta, as fajitas, in tacos or in other dishes.

TURKEY

Most people don't think of turkey outside of the holidays, but this poultry is an economical and versatile way to feed a lot of people. As with chicken, you get a better deal buying a whole turkey and cutting it up. Turkey breast tends to be fairly expensive, but it can go a long way with no waste. Look for fresh turkey, not those packed with chemicals.

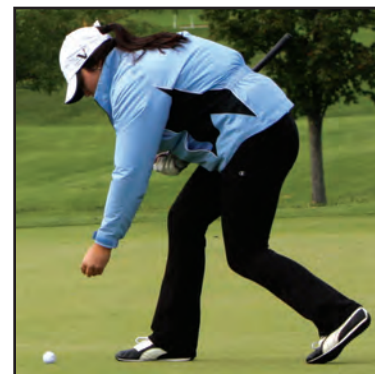

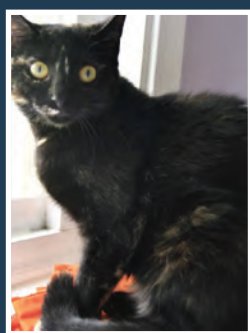

Fenton takes first step to fifth unbeaten season, beats Linden

Linden — Fenton's varsity volleyball team spent the first month of the 2012 season competing in various invitational tournaments around the state.

While tournaments are great for experience, they don't carry the same level of importance or degree of urgency as the Tigers' Metro League schedule.

Fenton found that out during the first game of its Metro opener Tuesday at neighborhood rival Linden. The Tigers got off to slow start and found themselves trailing the host Eagles 14-13.

One look at the scoreboard is all Fenton needed as it regrouped to post a 25-22, 25-9, 25-21 victory against Linden. The victory extended the Tigers' Metro-record dual-meet win streak to 38 straight matches.

"(In the first game) we didn't hit the ball the way we should have and our intensity was lower than when we started," Fenton senior Payton Maxheimer said. "We needed to regroup and get our focus back. We don't want to be the team to break (Metro dual-meet win streak), especially when we're seniors."

Fenton has won the last four consecutive Metro titles and it has not lost a Metro dual, dating back to a 20-25, 25-23, 25-22, 25-21 setback to Oxford on Oct. 25, 2007.

"This is our first league game and this is a

whole new ball game," Fenton coach Linda Rusaw said. "Tournaments, we play for experience and the league is what we have to live with every year."

Linden's program has made great strides lately, going from eighth place in the Metro as recently as the 2007 winter season to second last year. The Eagles' improvement was evident Tuesday, particularly in the first and third games.

After Fenton took a 7-2 lead to start the match, the Eagles came back and won six straight points to take an 8-7 lead. Linden continued to stay with Fenton until the Tigers used a late surge to win the first game.

Fenton got off to another fast start in the third game, taking a 13-5 advantage. Linden then came back and won 10 of the next 13 points cutting the shortage to 16-15. While the Eagles never led, they kept the match close, trailing by one point on two other occasions, 20-19 and 21-20.

For Linden (0-1, 11-3-8), Kelsey Brecht had seven kills and 16 digs, while Rachel Maxheimer had five kills and 12 digs. Rebecca McDonald had five kills and Megan Klavitter and Ashley Klavitter each had 12 digs.

"The attitude about volleyball at Linden has changed and it's really exciting," Linden coach Cori Mason said. "We stayed with Fenton and I'm impressed with what we did.

Hopefully, we can continue to grow on that."

Fenton appeared to have more size than Linden, something that came in play in all three games. Leading 8-3 in the second game, Fenton used its size up front to go on a 12-4 scoring run to take a 20-7 lead.

Leading 21-20 in the third game, the Tigers captured four of the last five points — all by front-row players, earning the game and the match.

For Fenton (1-0, 24-7-3), Payton Maxheimer had seven kills, nine digs and three aces. Bobbie Eastman had six kills, five blocks and three aces, while Ashley Bearden had six kills and nine digs. Maizie Martin had three kills and Megan Cockin had 10 digs for Fenton.

"The kids are putting in the time," Rusaw said. "They are willing to play and work hard. It's fun."

Linden — The Linden Eagles weren't looking for excuses.

ASK THE MECHANIC

Q: I recently bought a used Nissan Altima 2005. It runs great, but I hear a grinding noise coming from the passenger rear side. I have asked Pepboys to inspect and they said that the back tires are sloppy. When I asked the meaning of that, they showed me that one side of the tire has more wear than the other side and it's not even. I am not a mechanic, but I don't understand how this is making the noise. There are no bump or alignment problems while driving. The noise comes only when I drive and it increases when I increase the speed, and it stops when I stop. I am sure it's not from my engine. Mechanics are telling me to replace the tires. Before investing \$500 to replace all 4 tires, front 2 tires are not that good either, I want to double check with you to get your opinion.

A: Thyagarajan, I suspect that you may have a bad wheel bearing. The way to check this is to jack the suspected wheel up and rotate the tire. Listen for any unusual noise. Grab the tire at top and bottom then try to move it in and out. If there is any movement, then you most likely have a bad wheel bearing. If none of this shows any problems try rotating the tires to see if the noise moves with the tire. If so, then I suspect that the tires are the problem.

Q. My front load washer shakes and moves around in spin cycle.

A. There a couple of things that might cause that,

1. Washer may be unlevel
2. You may be under loading the unit with mismatched

weight clothes. When you have heavy clothes like towels, jeans or sweatshirts mixed with lighter items, it allows the heavy to collect on one side of the basket causing the washer to be out of balance and jump around.

3. You could have a weak floor causing a multiplication of the vibration, causing the unit to move around. Set a glass of water on the dryer while washer is in spin, if it develops ripples in the water, the floor is the issue.

regular meeting on Tuesday.

President Jeff Miller said there are no immediate plans to begin the search process for a full-time replacement.

Surrounding the former chief's resignation is a sexual harassment and discrimination investigation brought by Danishevskaya, a vote of no confidence from 92 percent of the Holly police officers against her, and a weak annual and six-month performance review.

The vote of no confidence came on Aug. 16 and it was signed by 12 of the 13 officers in the police union. The reasons included in this letter were obtained by Freedom of Information Act (FOIA) request.

The 19 complaints against the former chief ranged from misuse of funds, contract violations, making a traffic stop in plain clothes without a ticket book, not filling the schedule or returning calls in a timely manner, leaving shifts improperly staffed and a lack of knowledge of the police department's operating procedures.

On Aug. 30, Village Manager Jerry Walker sent a letter to Danishevskaya, ordering her to turn in all Holly police property. She was placed on paid administrative leave while the counts against her were investigated by the Oakland County Sheriff's Office. This investigation is ongoing.

Walker issued a news release Sept. 4. Danishevskaya sent her own news release Sept. 5 and offered her resignation.

"Mr. Walker has made my work conditions intolerable," said Danishevskaya in her letter dated Sept 5, 2012. "It is clear that Mr. Walker's goal is to humiliate and embarrass me." She said she will miss working with the people of the village and was forced to resign.

Danishevskaya also said the letter of no confidence in late August was a direct result of her filing complaints of sexual harassment and discrimination in March.

Those harassment complaints were investigated by attorney Gregory Gibbs of Flint, who broke her allegations into 21 separate charges. He also interviewed every person involved in every complaint, and included their response in the 34-page

document detailing what he found.

Council member Tom Clark and Walker were named in the discrimination, sexual harassment and hostile working environment charges, and clerk/treasurer Cathrene Behrens was cited as contributing to a hostile working environment.

Danishevskaya cited inappropriate e-mails sent by Clark in November 2011, including a photo of a topless woman firing a gun, among others.

Clark admitted to sending the e-mail, but said the e-mail was intended for Walker, who as a former police chief had an e-mail address similar to Danishevskaya's. He called her when he realized the mistake, urging her not to open it, and eventually sent a letter of apology. He was advised that the e-mail constituted inappropriate conduct and not to do it again.

The other e-mails he said were not intended to offend and he didn't feel they were inappropriate.

Clark was also accused of inappropriate hugging and making comments about Danishevskaya's looks. Many of the instances were witnessed by others, who were later interviewed for the investigation. Those interviewed did not believe they witnessed sexual harassment.

Walker was accused of harassment, discrimination and creating a hostile working environment. The former chief accused Walker of saying "suck me," while working on opening up a village Facebook account in June 2011, as well as on other occasions. Walker said this was his

way to express frustration at a situation and was not directed at Danishevskaya.

Village attorney Richard Figura issued his official opinion on the allegations. In every case, he said he did not believe they met the standard for sexual harassment or creating a hostile working environment. Both Clark and Walker were exonerated of charges by Figura and Miller.

Walker believes Danishevskaya's complaints came about to cover a lackluster performance review. "Walker said that chief Danishevskaya is difficult to supervise, is a weak leader, and doesn't seek help to improve," said Gibbs' report. Danishevskaya denied this, in the same report.

1 c. frozen peas
3 T. all-purpose flour
2 T. butter
1/2 t. salt
1/2 t. ground black pepper
1/8 t. garlic powder
1/8 t. onion powder
1 t. dried parsley
1/4 lb. Cheddar cheese, diced
1 pinch paprika, or to taste

PREPARATION:

Preheat oven to 350 degrees F. Layer half the potatoes, half the ham, and half the onion in an 2-quart baking dish; repeat the layers. Heat milk, peas, flour, butter, salt, black pepper, garlic powder, and onion powder in a saucepan over medium heat, stirring constantly, until thickened, 7 to 10 minutes. Stir Cheddar cheese into sauce until cheese is melted. Pour sauce over potato and ham mixture; sprinkle with paprika. Cover baking dish with aluminum foil. Bake until potatoes are tender, about 1 hour. Remove foil and continue baking until lightly browned, about 15 minutes more.

avocado, and flavorful vinaigrettes. Then you need only a small amount of protein — a few shrimp or scallops, or several slices of chicken.

Meet Father Harvey

Fr. David Harvey has been at St. John the Evangelist Catholic Church in Fenton for 35 years, and has been involved with the Applefest for all of them. While hard at work preparing for the 40th Applefest, Fr. Harvey has taken some time to share his memories and experiences.

Why did you decide to become a Priest? I had three options in my thoughts as a young guy — being a priest, becoming a doctor or a funeral director. I think they all deal with people, some more living than others. The priest that was in my parish was always someone that I looked up to. I think it was a desire to be of service is basically the reason.

What brought you to St. John the Evangelist Catholic Church? I was sent here by the Bishop. He had told me when he sent me here that you will understand after a while why I sent you there, and I did. What part of the Applefest do you enjoy the most?

I enjoy making my chili, which has become something of a longstanding tradition now. There are a lot of people who help, I couldn't do it all on my own. I also like seeing the raffling of apple pies that win the pie-judging competition. The pie makers are already happy when their pies win of course, and then seeing their eyes get big when they see some of the pies get up to a thousand (dollars).

How did your tradition of making chili start? I started it because we had no food on Thursday. We would open the festival on Thursday, but we wouldn't have a lot of food to serve. I said if we're going to advertise our festival on Thursday, we have to have something for people to eat. So I started making chili.

How has the Applefest changed over the years? All of the expanding use of apples is one way things have changed, I suppose. Before we had our activity center we had no place to bake pies like this. This was a great boon to the festival when we got the activity center. When we built the center, we put in lots of

NASCAR is the acronym for National Association of Stock Car Auto Racing. It was formed in Daytona, Fla. in December 1947 and the first race was held in 1948. NASCAR was officially incorporated on Feb. 21, 1948.

A Daytona service station owner and race track operator named Bill France Sr. saw the need for an organization that would unite, regulate and coordinate the various ad-hock tracks that sprang up after WWII.

Summary

► An organization first designed to unite the multiple stock car races going on after WWII eventually grew into a \$3 billion business, with millions of fans.

The Darlington Raceway in South Carolina was the first dedicated asphalt speedway, built in 1950. Though cars literally began as stock, meaning mostly unmodified street cars, the cars

are now built strictly for racing.

Today, NASCAR is a household name, with the Sprint Cup Series, Nationwide Series and Camping World Truck Series and it brings in \$3 billion annually. The average race attendance is nearly 100,000, according to statisticsbrain.com.

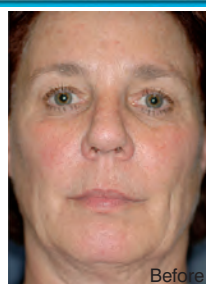

Pec implants

commonly referred to as breast implants for men, male chest implants, or pectoral implants, this procedure has seen a dramatic rise in demand the last year. Breast augmentation

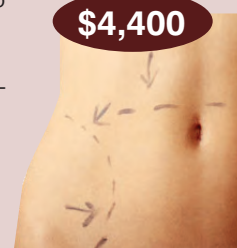
Breast augmentation, or augmentation mammoplasty, is the enlarging of a woman's breasts using saline- or silicone-filled implants. Over 300,000 breast augmentation procedures are performed yearly. The surgery requires only a few days of recovery time, although the ASPS recommends there be no physical contact with the breasts for three to four weeks.

Tummy tuck

Beer guts may be more associated with men, but women by far get more abdominoplasty procedures. The abdomen is flattened during the surgery when extra fat and skin are removed and abdominal muscles are tightened. Plastic surgeons perform over 100,000 tummy tucks yearly — 96 percent of them are women. Patients need two to six weeks of recovery time.

Dermabrasion

Although it sounds like a medieval torture tactic, 69,359 people received dermabrasion in 2005. With dermabrasion, wrinkles and facial blemishes are literally rubbed out as a surgeon uses a high-speed, rotating tool to scrape away the top layers of skin, leaving softer, newer layers. Women make up 88 percent of dermabrasion patients. Recovery time is typically two to six weeks, but the face may have a red tint for three months.

Lip augmentation

If your puckers aren't as prominent as you like, you can pump them up with lip augmentation, where a surgeon will hollow out a portion of your lip and insert an implant to give your lips more body. It usually takes two or three weeks for the swelling from this procedure to subside. Full lips are more valuable to women than they are to men.

Miller's tracking business going to the dogs

Rob Miller loves hunting.

But it's not his only outdoor love — and in many ways it's not even his primary outdoor love.

Since 2007, that honor probably goes to tracking.

Miller, a Linden resident, is a state-certified tracker and spends much of Michigan's deer hunting season with his two dachshunds Sypris and Scout searching for hunters' prize hunts. Through his dogs, Miller has helped many hunters either find their buck or doe, figured out that the possible kill shot was not mortal or, in many cases during rifle-hunting season, provided evidence the deer probably was never shot at all. One way or another, he and his dachshunds provide closure to a possible hunt. And Miller, who owns his own business called Michigan Deer Track N' Hounds, wouldn't have it any other way.

"It's a joy watching the dog work," Miller said. "Also, it's a joy when the hunter calls you all in distraught because they can't find their deer. ... When we come out with the dogs and I get to enjoy watching them work and then get to see the recoveries, you get a bunch of man hugs in the woods and high fives. It's just exhilarating. For me, it's no more fun than that. When you get to the end and find the client's deer when they couldn't find it, it's amazing."

Miller started his business venture after seeing an article about a guy who tracked for 35 years. His first year was in 2007.

"We found three deer that first year," Miller said.

But since then Miller said his demand has "probably grown about 100 percent every year." He's currently working on creating a network of trackers around the state to ensure everyone that needs a tracker's service can get one. It's not his full-time job, but sometimes it probably can feel like one considering he's basically on call by hunters during the entire deer hunting season. Since 2007, he's done about 140 tracks, has found 36 dead deer and confirmed another 32 as not being mortal. During last year's hunting season, he received 367 calls.

"It's a hobby," Miller said. "I'm not making a living doing this, but it's rewarding."

The stars - Sypris and Scout

Once trained, the real stars of the tracking are Sypris, a 3-year-old dachshund, and Scout, a 5-year-old long hair dachshund. Both stand less than a two feet off

the ground and are each about two to three feet long. They hardly look like fierce trackers.

Yet, put them within their element and it becomes obvious that they are both stars in their field of employment. Sypris, a mostly black-coated dog with some brown areas, is the more rambunctious of the two. When she's out on a hunt, a leash is entirely necessary. She's eager and works much faster than Scout, who is equally eager, just more calculated in his actions.

Miller takes the dogs to an area with some trace blood from the suspected deer, and allows them to sniff it. This way they are tracking the proper deer smell.

Miller holds them on a leash while they do their job. The leash is extra long just in case the dog goes through an area he can not venture through. This way, he can let go of the rope, and pick it up once he gets back to the other side.

He allows the dog to do its work, sniffing the scent. Sometimes the dog will retrace its track and then return to the tracking forward. Many variables such as wind, weather, time and environment can spread the scent track, but the final scent, if the deer is killed, will always lead the party to its intended deer. The animals are rewarded after their task. To keep them sharp, Miller keeps them in training, and he also delegates the tracking ventures between the two dogs so that they remain excited about the hunt.

Miller said the dogs have tracked deer that have ventured as far as five miles, but had one that was within 50 yards of the expected spot the deer was shot. The short tracking venture involved his father-in-law's deer.

"We went out and started tracking it," Miller said. "It was only about 20 yards out. It was in shoulder-high weeds, and the way the deer fell into the weeds, the weeds actually rolled on top of the deer. He walked there all day long and could not see it. ... He thought it was across the road in somebody else's yard."

His service

Miller never knows when his next tracking venture will start.

"It's a 24/7 job. My boss allows me to leave when I need to leave. He's very supportive," Miller said. "We go in rain and ev-

erything."

Most hunts take about two hours.

He has a website called www.michigandeertracknhounds.com. On it one can get his phone number for his services. One can read blogs about the tracking and other hunting information. It also has photos of some of their tracking success stories.

One thing Miller has learned is that every-

Wait and enjoy the moment

Unless the animal goes down, allow yourself time to absorb the adrenaline, collect your thoughts, and recall what had just happened. Take in the surroundings. This will help you calm down from the excitement and help you proceed with a clear head.

A plan always helps

Develop a plan based on what you recall from your shot.

Slow down, you move too fast

Walk slowly to the side where the deer was standing. When you get within five yards of the spot, stop and take a really good look for hair or blood. Do not walk directly on the blood trail.

Mark your trail

Toilet paper or tissue is easy to see and biodegradable.

thing one hears is true is never always true.

"You hear deer always go to water, take the path of least resistance, go downhill, none of these things are always the case," Miller said. "We as humans think the deer went this way or that way because of what they know. We find times when people are extensively searching one way and the blood has actually made a turn and has gone the other way."

NASCAR claimed to have 75 million fans in 2006, which is difficult to verify, but about 12 million households watch the Daytona 500 race every year.

A Sprint Cup car weighs 3,400 pounds and is 110 inches long. The cars' 358 cubic-inch V8 engine generates 750 horsepower. The replaceable outer body is designed to allow contact between cars without causing wheels to lock, unlike Formula One cars, according to about.com.

NASCAR's history is filled with names of famous racers and famous families. The Petty family has been racing since the beginning, while the names Earnhardt, Gordon, Stewart and Martin have also historically topped the leader boards.

The NASCAR Bleacher Report says that Tony Stewart and Jimmie Johnson are the most talented drivers today.

Even the most searched athlete in the U.S., racer Danica Patrick's \$12 million in earnings last year puts her eighth in earnings compared to her peers, though she just left the IndyCar circuit for NASCAR this year.

Dale Earnhardt Jr. earned \$28 million, Jeff Gordon earned \$24 million and Tony Stewart took \$22 million.

While much of their income is from sponsorships, NASCAR races include prizes that are doled out in a system that can seem complicated.

There are a series of segments, which each carry their own prize purse and are paid down to the bottom placing racer.

There are also different awards available that are independent of these segments, like the Gatorade Front Runner Award.

Manufacturer awards also depend on their logo being used prominently before and during the race.

NASCAR glossary

Aerodynamic Drag: Crewmen work to get the best "drag horsepower" rating they can, determining how much horsepower it will take to move a vehicle through the air at a certain mile-per-hour rate. At faster speeds, teams strive to get the lowest drag number possible for higher straightaway speeds.

Drafting: The practice of two or more cars, while racing, to run nose-to-tail, almost touching. The lead car, by displacing the air in front of it, creates a vacuum between its rear end and the nose of the following car, actually pulling the second car along with it.

Fuel Cell: A holding tank for a racecar's supply of gasoline. It consists of a metal box that contains a flexible, tear-resistant bladder and foam baffling. A product of aerospace technology, it's designed to eliminate or minimize fuel spillage.

Handling: Generally, a racecar's performance while racing, qualifying or practicing. How a car "handles" is determined by its tires, suspension geometry, aerodynamics and other factors.

Pit Stall: The area along pit road that is designated for a particular team's use during pit stops. Each car stops in the team's stall before being serviced.

Spoiler: Also referred to as a "blade," the spoiler is a strip of aluminum that stretches across the width of a race vehicle's rear decklid. It is designed to create downforce on the rear of the vehicle, thereby increasing traction. The tradeoff is that more downforce equals more aerodynamic drag, so teams attempt to lay the spoiler at as low an angle as possible to "free up" their vehicles for more straightaway speed.

my 'bucket list' for a long time."

She and her father each received a certificate for eight laps around MIS, as family gifts to celebrate birthdays. The laps are offered as part of the Mach I Driving School, which takes place at MIS once a month from May through September. While she and Medich could have each ridden as passengers with an experienced driver, they chose to pilot the racecars themselves to fully enjoy the experience. They each drove the same car — once owned by racecar driver Sterling Marlin — only at different times.

Bergeron was the only woman in an hour-long pre-driving class of about 30 other thrill-seekers, mostly age 40 to 50. "They try to scare you about how dangerous it is to hit the curves while going 160 mph, and it worked," said Bergeron. "There's a lot more to it than I thought. As the only woman in the class, I was not going to be the one to stall out the car before getting out of pit row."

Novice racecar drivers are required to suit up in total racing gear, including driving suits and racing gloves. Their helmets are fitted with the Hans safety device, a head restraint that stabilizes the head and neck area to reduce injury. Their first physical challenge was to squeeze into the car's tiny window to get into

the driver's seat, without hardly being able to move and only inches to spare on each side.

"You don't think you're going to be as scared as you find that you are," admitted Bergeron. She said she got more confident after about four times around the track, pushing the pedal to the floor on straight-aways and letting up on the gas around the curves, when the high speeds put you up along the banks.

"It's like a sling-shot effect," said Medich. "You come off a curve even faster than you went into it. I knew I was going fast when everything went by in such a blur that I couldn't even focus my eyes. It's quite an adrenaline rush!"

Bergeron confessed that her stomach was in her throat and her heart was pounding hard throughout the race experience, but she loved every minute of it. "It's a controlled thrill-seeking experience," she explained. "I can control what happens by what I do. I would never do something like sky diving where I wouldn't have any control."

Both Medich and Bergeron had quite different reactions after exiting their racecars. Medich's hands were literally shaking because of all the adrenaline, while Bergeron was jumping up and down and laughing. "I think it's our difference in ages," quipped Medich. "Nothing used to scare me when I was young. Now there's a fear factor involved."

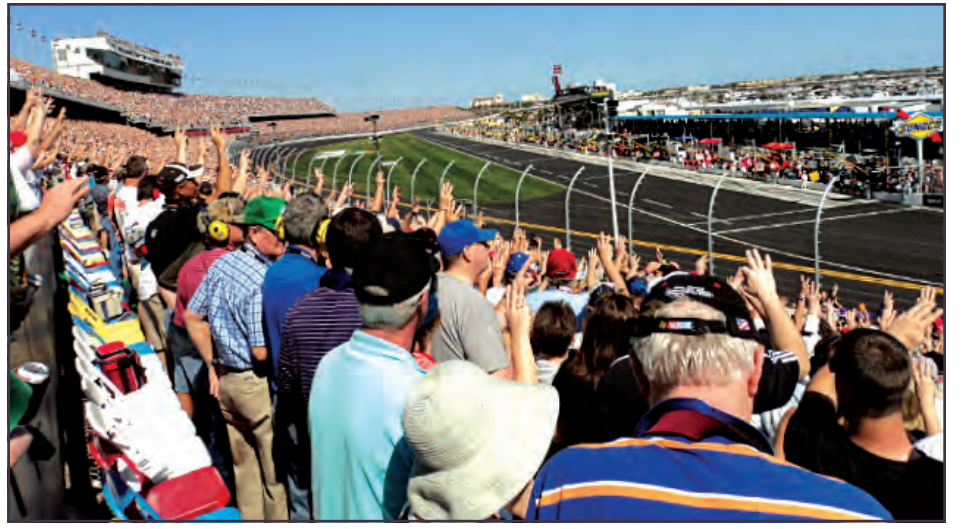
When MIS isn't sporting a NASCAR race, there are tons of other races and events. NASCAR races at MIS every June and August.

To your good health

DEAR DR. DONOHUE: My wife's doctor thinks she has intermittent claudication due to peripheral vascular disease. She also has diabetes. Would you describe it and its treatment? — S.B.

ANSWER: Peripheral vascular disease also goes by the name peripheral artery disease, PAD. "Peripheral" refers to the outer boundary, and when speaking of the body, the legs are its periphery. Leg arteries are narrowed and often blocked by the buildup of cholesterol, fat and many other components found in the circulation. The buildup is called plaque. The buildup can be so great that no blood runs through the main leg arteries.

Intermittent claudication is leg pain that develops when someone with PAD walks any distance. The person can tell, almost to the number of steps taken, when pain will arise. Taking a rest relieves the pain.

About 15 percent of those 70 and older have PAD. Its main sign is intermittent claudication.

Your wife can do many things on her own that will help her. If her cholesterol is high, she has to get it down. She has to maintain normal blood pressure. She must exercise within the limits prescribed by her doctor. Walking is one of the best exercises. If she starts out modestly and gradually increases the distance and pace, she should aim for 30 minutes of walking daily. When pain arises, she should stop, take a break and then resume once pain has gone.

One simple test for determining PAD is comparing blood pressure taken at the ankle with blood pressure taken in the arm. They should be nearly equal. If the ankle pressure is lower, that's evidence of PAD.

Your wife's doctor will discuss the use of medicines like Plavix, Pletal and aspirin. With severe blockage of an artery, opening it up with a balloon-tipped catheter and inserting a shunt is one treatment. It's the same procedure used for clogged heart arteries. Removing the obstructed artery segment and replacing it with a graft is another way to treat this illness.

Ex-boyfriend should help sexual assault victim

DEAR AMY: My ex-girlfriend and I did not communicate for five months. We spoke recently and she informed me that she was sexually assaulted by her best guy friend. She said the friendship is over, but because he is extremely well off and always pays for everything, I wouldn't be shocked if they were hanging out in a month. What advice would you give to her? I care about her and would like to pass it along. — Caring Ex

DEAR CARING: My advice is that your ex should go to the police so this guy can be charged with sexual assault. She should also be examined by a physician, get a pregnancy test and be tested for STDs. She should seek counseling. This is frightening, and I assume she reached out to you because she trusts you to help her. I hope you will.

DEAR AMY: My wife's family and I have a difference of opinion in the amount of cash to give to children on their birthdays. I think giving an 8-year-old \$40 is too much. The child loses the value of the dollar. Am I old-fashioned? — Tom

DEAR TOM: Thoughtful parents help children spend wisely by teaching that a percentage of the child's money should be saved. I agree that \$40 for an 8-year-old sounds like too much, but again, the amount isn't the issue as long as it is handled wisely.

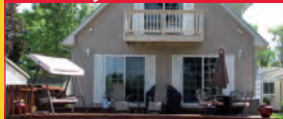
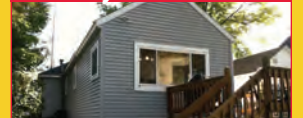
