## SMART SOLUTIONS



### 1 Wart remover

Use banana peels as a natural wart evaporator! Cut a dime-size piece from a banana peel, place it pulp side down on the wart and cover it with a bandage to hold in place overnight. Remove it in the morning. Apply a fresh peel nightly until the wart disappears (usually in about 14 days). The pulp contains mucilage, which kills the wart without harsh chemicals so skin heals flawlessly.

### 2 Cork in wine



If you open up a bottle of wine and the cork breaks, pour it through a coffee filter to catch stray pieces before serving it.

## Forget your wallet? There's an app for that

►Smartphones can act as a credit card reader, hold concert tickets

Smartphones can already perform a variety of functions, but soon they may also be a way for paying your bills.

Many current smartphone apps can take the place of a credit card. In fact, as the apps become more widely usable, a smartphone may be able to replace the contents of your wallet entirely.

Though not overly common yet, several android phones now come with a chip inside that allows them to make wireless monetary transactions.

You can use an app called Google Wallet to store your credit card, debit card, or gift card information in your phone. When you are buying something at a store with a PayPass credit card terminal, a simple tap of your phone against the terminal will pay for your purchase.

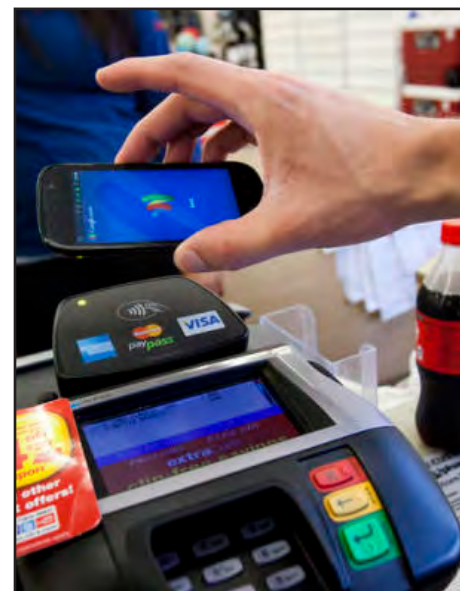
Another newly emerging payment method includes a smartphone app named Level Up. This app works similarly to Google Wallet, linking your credit or debit card to your phone. The app will then create a barcode on your phone that can be scanned by businesses to make a transaction. The number of businesses that take payment through this app is small at the moment, though constantly growing.

**Why we tolerate hate speech**

It's not easy to put up with pinheads. But that's a small price to pay for the rich benefits of freedom.

Such is the important civics lesson that Secretary of State Hillary Clinton delivered recently with language that was a bit more tactful than mine.

She was responding to those who turned to violence in protesting a particularly incendiary abuse of free speech: the 14-minute anti-Muslim online trailer for 'Innocence of Muslims' — a movie that, as of this writing, nobody appears to have seen.

Although it was not at all clear who was behind the blasphemy, protesters blamed the United States for allowing it to be posted on YouTube.

Outrage over the rude and crude video fueled violent protests at U.S. diplomatic missions in Libya, Egypt and Yemen that led to the deaths of Ambassador Chris Stevens and three others in Benghazi, Libya.

First, Secretary Clinton delivered the message that Americans draw a firm line against government action that gets in the way of free speech.

Second, she strongly condemned those who turn to violence in their outrage, especially when that violence is directed against diplomatic missions.

Finally, she acknowledged, 'It is hard for some people to understand why the United States cannot or does not just prevent these kinds of reprehensible videos from ever seeing the light of day.' That's 'impossible' in today's technologies, she said, and 'even if it were possible, our country does have a long tradition of free expression and we do not stop individual citizens from expressing their views no matter how distasteful they may be.'

That's not easy medicine for everybody to swallow, especially if they come from countries where any disagreement with the government or majority beliefs can bring immediate and severe punishment. But it's a lesson that the U.S. must teach and re-teach.

Regardless of who's responsible, the free flow of information and opinions is a fact of life.

Hate mongers and race baiters have new media power, but the rest of us don't need to take the bait.

# City considers \$12,000 storm water study

►Business owners ask Fenton leaders to address flooding issues

**Fenton** — Fenton City Council discussed what action the city should take, if any, in dealing with the storm sewer system of North LeRoy Street businesses and their parking lots.

Recent heavy rains caused the sewer system to back up and flooding to occur. In response, the city's engineering consultants, OHM, proposed a \$12,000 study of the storm system to see if any changes need to be made.

"My concern is that these kinds of rains only happen in a 50- to 100-year period. This doesn't happen every time it rains," said Councilman Les Bland at Monday night's meeting.

Bland said he wasn't opposed to assessing storm sewer issues, though he was afraid that this may be a can of worms for the city. "I can't see spending \$12,000 on a study to analyze this thing when it has worked for a lot of years in the past, and then coming back with another proposition that could be hundreds of thousands

of dollars," he said.

Councilwoman Pat Lockwood was in favor of the study. "It just seems to me any time that we have anything to do with water or water issues we just can't ignore it," she said.

During the meeting, representatives from The Quilter's Garden and the offices of Dr. James Rachor spoke up saying that the flooding has posed problems to their businesses, and wanted to see the city address the issue.

Since the storm sewer system is on private property, the council must first check with the city attorney to see if there is any action they can take, if they were to decide to take any. The matter could come back to the council as early as next Monday.

and Michigan State Police Emergency Management began to assess the safety of the structure along with structural engineers.

At this time, the cause of the fire is unknown.

Since the fire, owners Rob and Sherry Durk have been busy meeting with fire investigators, detectives and insurance agents. "We had a long day yesterday," said Rob.

The Durks rose at 3 a.m. to see their building on fire. "My heart and soul was in that place, I built it almost from the ground up," he said. "It was very upsetting watching it go down." Also lost in the fire were portraits and pictures of his deceased daughter, Janelle, the restaurant's namesake.

They will continue to operate the banquet center in Argentine Township, but it's too early to decide on rebuilding. "The public's definitely crying out for us to re-open," said Rob.

**judge****The Michigan Habitual Offender Law and violent offenders**

In Michigan if a criminal defendant is convicted of a felony, they face penalties, which can include going to jail or prison. Every felony in Michigan carries a maximum term of imprisonment, which can be up to life with the ultimate decision for nonmandatory life imprisonment offenses being left to the circuit court judge.

There are many factors to be considered in sentencing including Michigan's sentencing guidelines.

If a defendant is convicted of a second, third or fourth (or more) felony, Michigan law has long provided for the possibility of the sentence being enhanced under Michigan's Habitual Offender Statute.

Generally speaking, this law allows for the gradual enhancement of a sentence for second and subsequent felony convictions all the way up to life in prison if the fourth felony carries a maximum term of imprisonment of at least five years. If the fourth felony carries a less than five-year maximum, the sentence can be for up to 15 years.

Effective Oct. 1, this law was amended by Senate Bill 1109 to provide that if a defendant is convicted of a fourth felony, which is a 'serious crime' as defined in the statute, (including such offenses as armed robbery, carjacking or kidnapping) and has previously been convicted of a 'listed prior felony' as referenced in the statute (including such offenses as arson, felonious assault or first degree home invasion), the court must sentence the defendant to imprisonment for not less than 25 years.

Michigan is but one of a number of states that have such sentencing possibilities with the intent to make the 25-year sentence mandatory as opposed to a discretionary sentence as is the case with the other provision of this law, and to remove these defendants from society for a significant period of time.

The city council formally accepted Tallman's resignation at a special board meeting Monday night. Police Chief Scott Sutter was appointed interim city manager until the city hires a new person to fulfill the city manager position.

**Summary**

►Linden City Manager Mark Tallman has resigned from his position. Police Chief Scott Sutter will act as interim city manager until someone else is hired for the position.

"We've had some conversations that popped up and we thought it best he step aside and step down," Lossing said in a phone interview prior to the city council meeting Monday night. "We wish Tallman the best of luck."

Tallman acted as the city manager for five months. He was selected after the Linden City Council held five interviews with candidates from an initial pool of 45 applicants. Tallman will continue to receive two month's salary and benefits. He will not receive vacation time, sick pay or relocation fees for moving from Kechi, Kansas to Linden.

Tallman did not respond to calls before press time.

Lossing said the resignation was a mutual agreement amongst himself, Ross and Tallman.

Lossing said the process of hiring a new city manager will be similar to the process used in hiring Tallman. The opening of the position will be made public and the city will accept applications. From there, a search committee will be formed to sift through the applications. The search

committee will hold interviews and the city council will vote for a candidate to be the next city manager.

Sutter has previously acted as interim city manager from January to April, following the resignation of former City Manager Chris Wren.

Lossing said Sutter's compensation will be the same as his previous stint as interim city manager. The police chief will receive \$500 extra in pay per week in addition to his regular pay as police chief with two weeks paid vacation and four sick days as compensation.

"It's unfortunate that Mark didn't fit the position," said Councilor Ray Culbert.

Also of concern was the future status of the purchase of the Union Block property. Council was surprised to learn that a secondary environmental study was recommended by Atwell Environment, the company that conducted the first environmental study. The secondary study recommendation set the closing costs higher than the approximate \$12,000 originally budgeted.

"Council may have some questions on the financial status of the Union Block," said Councilor Ed Ciesielski.

Sutter said he will meet with the city personnel and council to assess the city's needs and priorities.

30 years and is currently the chief executive officer of the Flint YMCA, drilled township officials about the park at the September 17 board of trustees meeting.

"What is the total cost? How will the park be funded?" Cheek asked the board.

Township Clerk Robert Krug originally presented plans for the park at a July board meeting. On Monday, the township board of trustees unanimously voted to change the land from planned unit development (PUD) to agriculture land, with conditions.

Baseball diamonds, soccer fields and an amphitheater are some of the features Krug hopes to include on 35 acres of land owned by the township. Krug said the park will have minimal financial implications for the township and it will mostly be funded by volunteers and donations.

"Right now the township has no plans to put money into (the park)," Krug said in a telephone interview last Thursday. Krug said the overall construction of the park could cost as much as \$500,000.

According to Krug, Lawrence Engineering in Fenton has already surveyed the property, donating \$100,000 worth of work to the project. Krug mentioned companies that offer other services such as well drilling and applying asphalt have already agreed to donate material and labor.

"It is people thinking out of the box that is going to make this happen,"

Krug said.

Homeowners near the property of the proposed park continued to speak in opposition to the plans at Monday's board of trustees meeting.

"I have serious safety concerns," said Derek Snyder, who noted that Thompson Road is heavy with traffic as ambulances, fire trucks and commuters frequently drive near the property of the proposed park. "I think it's insane they're putting it out there on Thompson Road."

Fenton Oaks resident Mary Ann Brostek was concerned about the inclusion of the amphitheater.

"Being that we live out in the country, sound travels a lot," Brostek said. "I don't want to sit out on my deck in Fenton Oaks and hear music."

Krug said the amphitheater included in the plans is a 20- by 30-foot structure that will not have permanent seats. The amphitheater will support about 250 seats maximum. The park will be open from dusk until dawn. The plans for the park will be reviewed by the planning commission and then brought before the township board of trustees for further decisions.

"I would like to see this in stages. I'm not naïve enough to think everything would be ready to go at the first time," said Krug.

The park did bring support from some residents, including those involved with Little Leagues in the township. Residents who are interested in finding out more about the proposed park are encouraged to call the township offices at (810) 629-1537.

have at least one serving of both a fruit and vegetable, this isn't too bad.

In July, new federal health guidelines for school lunches went into effect and many area schools are either catching up, or are almost caught up.

Linden cook Chris Green worked the register during lunch. As students tried to leave without enough servings of fruit or vegetables, she instructed that they take an apple, apple slices or baby carrots from a small bin. "I've been warning them (of the changes)," she said. Students were receptive enough, some opting to make a salad instead of those other choices.

Most of the local districts are nearly compliant with the guidelines, which were introduced in 2010. "We've been working toward those new standards," said Fenton Area Public Schools Food Service Director Jaymi Whalen. District-wide there is no frying, and no bleached white bread. Half the wheat breads are whole grain.

When schools become compliant, they'll receive 6 cents in federal funds per plate. Most districts agree the new standards cost more for schools and producers, but no one has totaled the costs yet. It's also not cheap when schools buy fresh produce for 500 students and up to 10 percent might end up in the trash.

Lake Fenton Community Schools food service director Patti Morey said that a plate with whole-grain pizza, a salad bar, fresh fruit, juice and milk costs her \$1.20 in materials and is then sold to students for either \$3.40 or the reduced cost of \$2.25. Morey said students like the salad bar and they don't waste much at all. Her students are happy as long as there are baked fries, which counts as a vegetable on the menu.

### Summary

►As the federal guidelines for school lunches change, both the schools and the students have to make a difficult transition that requires planning and careful measurement of calories, serving sizes and amounts of whole grain and fresh fruits and vegetables.

red peppers and low fat cheese.

Whalen has seen a mixed reaction to the new guidelines and students can be given an apple, but that doesn't mean they'll eat it. At Fenton, they try to keep the vegetable bar "fresh" with tomatoes, romaine lettuce, garbanzo beans, red peppers and low fat cheese.

Whalen said one of the biggest challenges is getting the students enough calories that also conform to the guidelines. A viral YouTube video illustrates that students are well aware of the problem. A high school music video called "We Are Hungry," to the tune of "We are young" by Fun, has grabbed almost 800,000 YouTube views and it argues that the 850 calorie limit for a high school lunch is not enough.

Food service directors like Whalen have to figure out how to boost calories without going over, using the new guidelines. They also have to plan their menus one year ahead, as they order in bulk a year in advance.

"It's a work in progress, it's a big experiment nationwide," said Debbie Brindle, food service director for Linden Community Schools. "It's different at every level." She said they will continue to also

work on the same problem.

On Monday, Andrew G. Schmidt (AGS) Middle School offered subs, whole-grain pizza, chicken and baked foods like chicken nuggets. Whalen will work with the new regulations, but said that schools can't be blamed for obesity. "I think there needs to be more nutrition education for families and parents," she said.

At LHS, students chose from a hot and spicy chicken sandwich, hamburger or pizza. Everything is baked, and they're trying new meals like veggie lasagna. Students may not like new items in the line that fit the guidelines. "They'll balk at it," said Brindle. "For the most part I think that the kids are accepting it."

"I think it made the food taste worse," said Jessie Hahn, 16. "I support making lunches healthier for kids, but this does not taste good." She said she does like the fresh apples, but she misses the nachos from before the health guidelines.

Nancy Verhelle, head cook at LHS, said students still like the pizza, chicken nuggets, pasta and spicy chicken. They don't like the vegetables as much, except plain broccoli. "We'll go through 20 pounds of broccoli," said Verhelle.

Whalen said the guidelines will continue to evolve over the next 10 years, with sodium being the next target for reduction in the lunch menu.

## Public school menu guidelines

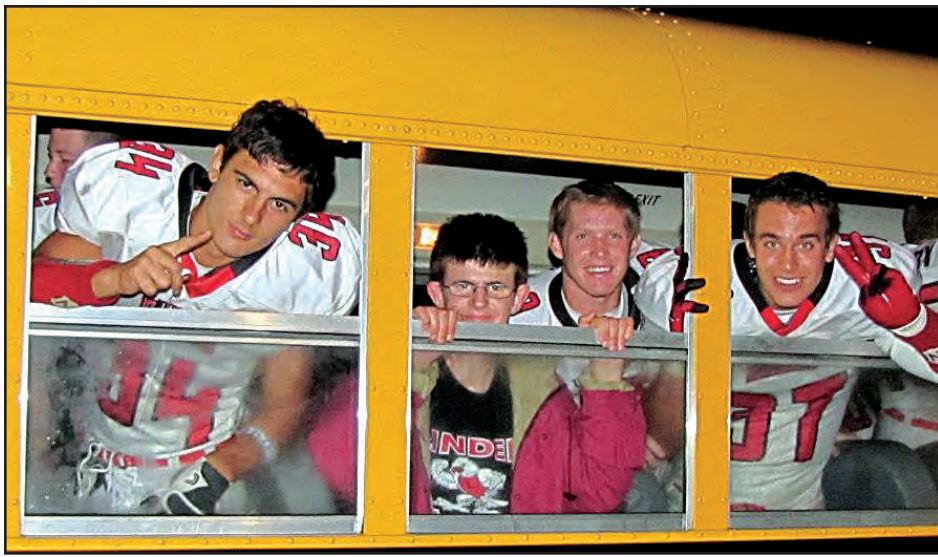

Shaye Brown also admires how Danny can talk to anybody.

"I think it's cool," Brown said.

And why wouldn't they want him around? After all they are all long time friends, since their middle school days. The fact that Danny has Asperger Syndrome, a type of autism that makes it tough for Danny to socialize and understand how people perceive him, hasn't changed what they all have in common — their friendship.

"He makes you a better person just being around him. He sees life in the best picture," Juhl said. "He's one of my best friends. Whatever we do, we invite Danny."

He's invited to all student activities. For example, when fellow senior Blake North hosted a pool party this summer, Danny was there.

"We got some pizzas and he ended up eating a whole pizza himself," Connor O'Connell said.

"When I spend time with him you don't think you are doing something great, but you are just spending time with a friend," Eddie Walterhouse said. "He's really opened my eyes. It's not just me but the whole senior class."

Walterhouse is right. When in many instances just trying to find tolerance for a special-needs child can be tough, that's not an issue for Danny. His senior class wants and needs him around. In fact, he's been given the role of team manager on the varsity football team. He spends every Friday night during the season supporting his friends and helping whenever one of them needs help during the game. That usually means helping with Gatorade during time outs.

And these aren't token gestures. While Danny's friends have taught him, most would agree they've learned more from Danny.

"People who don't talk to him are missing out," Brown said. "If you see him and make fun of him maybe you'll get some sort of satisfaction for that one moment. But if you stop, talk and get to know Danny, then you will get the satisfaction of knowing Danny for a lifetime. He's a stepping stone of happy moments."

"People say not to judge a book by its cover. ... We actually did that," Walterhouse said. I've been able to get inside his bubble and understand what he talks about. ... And he's really taught me how to be a good friend. I love him."

For some seniors, they've learned just how much in common they have with Danny.

"A lot of people look at Danny and think he's different, but he's just like everybody else," Maija Satkowiak said. "He wants to go out, have fun at the football game and cheer everyone on. He's just like every other student."

Danny's family appreciates what the kids have meant to Danny.

"These kids look beyond whatever challenges Danny's disability creates and have genuinely become true friends with him over the past five years," Leideker said. "They don't know how much of an impact they have on his life. Now he can go to strangers and say, 'Hi.' He's much more open to different social environments."

### How the friendships began

Every student has a different story of how they met Danny. For Satkowiak it began during sixth-grade art class when the teacher asked if she could help him.

"He had a different perspective than other people, but I thought he was pretty much like everyone else," Satkowiak said.

For many, the relationships blossomed when they invited Danny to sit with them during lunch during their eighth grade school year. The group of kids celebrated his birthday during lunch and invited him to sit on the bench during an eighth-grade boys basketball game.

Danny left Linden schools during his freshman year, but when he came back to Linden High School starting his junior year, the friendships strengthened again, particularly with the football team where many of his friends play. That, of course, resulted in his managerial role with the team.

Now Danny is part of the homecoming court. And who knows, he might end up being king. Walterhouse admits he voted for Danny. But guess who Danny voted for?

"(I) voted for Eddie. You're king, Eddie," Danny said during a recent dinner for football team members only.

"We love him," O'Connell said.

## Forty-nine-year-old Linden man returns, earns tech degree after layoff

At 49, Jeff Smith isn't your stereotypical college student.

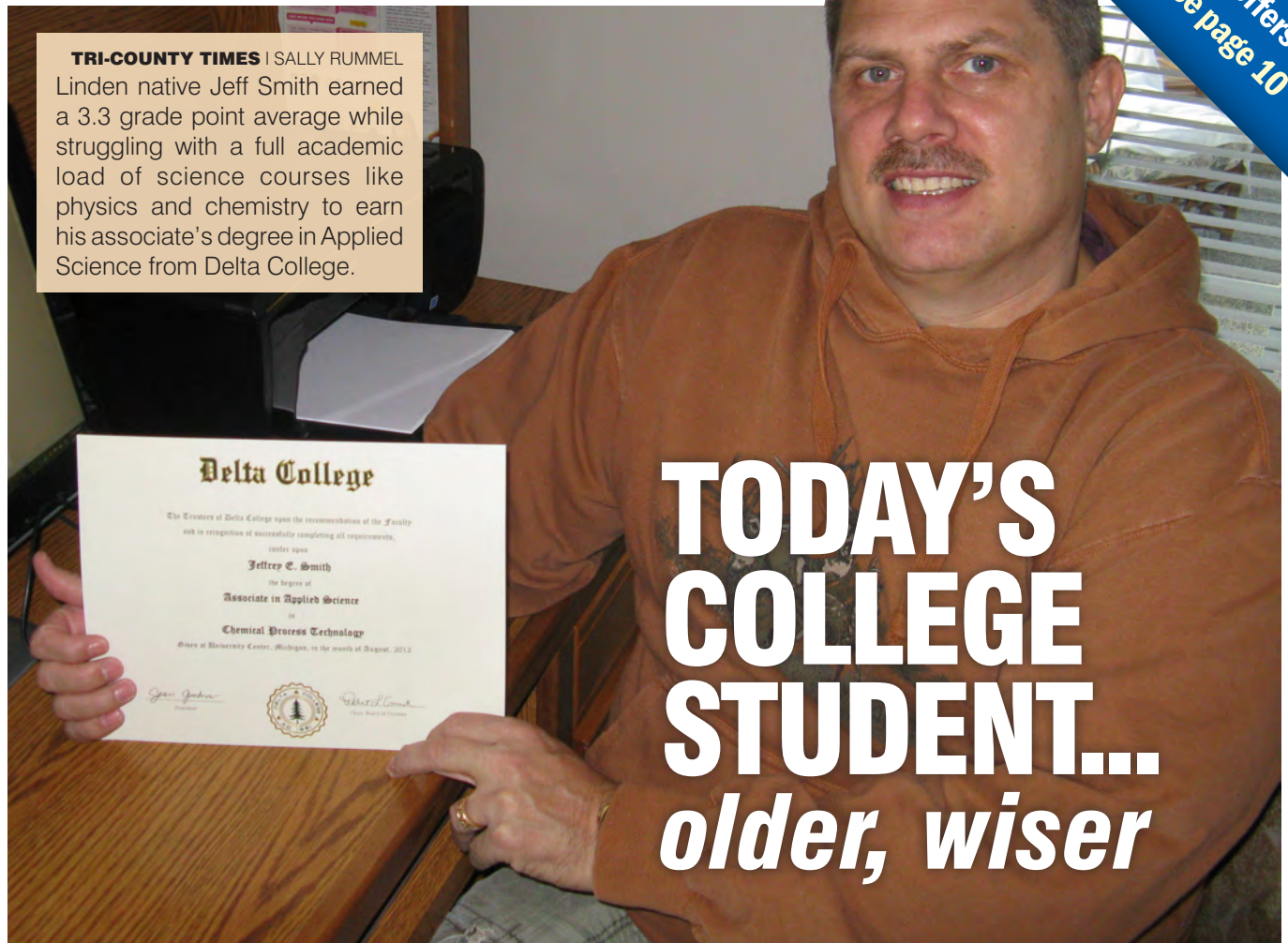
However, you're sure to see more people his age on college campuses across the U.S., as the economy forces many people out of work and back into the classroom for additional training.

Smith, of Linden, was laid off three years ago from a position he held for 20 years as quality control inspector at a manufacturing plant in Fenton, which downsized its operations. Just three weeks ago, he earned his associate's degree in Applied Science from Delta College, where he studied Chemical Processing Technology — his "ticket" to a new job and a new life for his family.

Smith begins a new position on Oct. 8, as a utility operator at Marathon Oil Refining in the Detroit area.

## Today's kindergarteners learn more, play less

Kindergarten used to be a place where children transitioned into school — from a world of play to a world of academics.

"Now kindergarten is school," said Linda Mora, director of Early Childhood Education for Fenton Area Public Schools. As a former kindergarten teacher for more than 25 years, Mora has seen many changes in the kindergarten curriculum. "There is a much more expected level of readiness for kids entering the kindergarten classroom today."

Today's kindergarten classrooms still have toys and trucks and other playthings, but there are also school computer labs, math journals and reading and writing workshops. "We have 30 to 35 minutes during our day that we call 'choice time,'" said Tresa Squires, kindergarten teacher at North Road Elementary School. "Kids can play on ride-on trucks, a wood kitchen stove or other toys, plus have a snack. The rest of the day we are working on letters and sounds, counting, reading and writing."

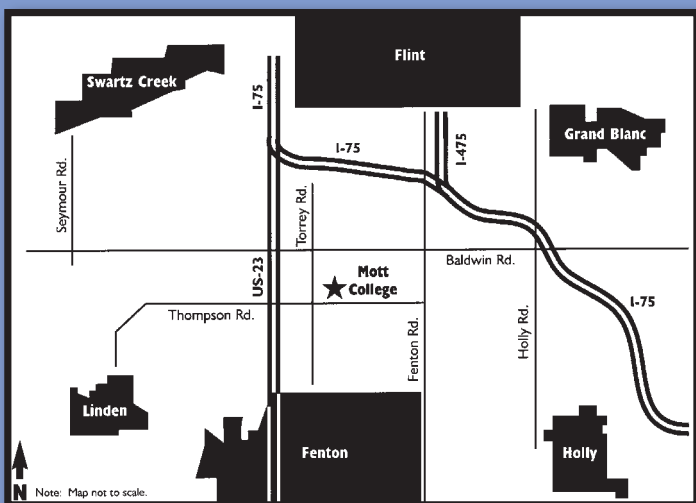

## Making mealtime a priority

►Gathering at table offers benefits to entire family

Whether you eat breakfast, lunch or dinner together, for families, sharing this time is important. If busy fall schedules make evening meal-times impossible, then think about having breakfast together or weekend traditions of gathering around the table as a family.

What's important is that you're enjoying family time together during meals at least five or six times a week, according to sparkpeople.com.

Here are some of the ways it will benefit your family:

### Benefit No. 1:

#### Communication and well-being

Conversations during the meal provide opportunities for the family to bond, plan, connect, and learn from one another. It's a chance to share information and news of the day, plus give extra attention to children and teens. Family meals foster warmth, security and love, as well as feelings of belonging. It can be a unifying experience for all.

### Benefit No. 2:

#### Learning by doing

Family mealtime is an opportunity to model table manners, meal etiquette, and social skills. However, parents should lead by example, not harsh instruction criticism. Keep the mood light, relaxed, and loving.

### Benefit No. 3:

#### Trying new foods

Introduce your children to new tastes, by encouraging them to try a new food along with some of the stand-by favorites. Experts say it can

take 8-10 exposures to a new food before it is accepted, so be patient. Trying a new food will expand your child's knowledge, experience, and skill.

Include foods from other cultures and countries and select a new vegetable from a local farmer's market. Have your child

select a new recipe to try from a newspaper, cookbook, magazine or website.

### Benefit No. 4:

#### Healthy choices

Meals prepared and eaten at home are usually nutritious and healthy,

served with more vegetables and fruits. Home cooked meals are usually not fried and are lower in sodium than restaurant fare.

### Benefit No. 5: Learning how to plan and prepare meals

Your children can learn valuable life skills by helping with meal planning, grocery shopping and food preparation. Young children can tear lettuce for a salad and set the table. Older kids can pour milk, peel vegetables and mix batter. Teenagers can dice, chop, bake and grill. Working as a team puts the meal on the table faster, as well

as makes everyone more responsible and accepting of the outcome. Improved eating habits come with "ownership" of a meal.

### Benefit No. 6: Prevent destructive behaviors

Research shows that frequent family dinners (five or more a week), are associated with lower rates of smoking, drinking, and illegal drug use in pre-teens and teenagers, when compared to families that eat together two or fewer times per week. Even as older children's schedules get more complicated, it is important to make an effort to eat meals together.

The big focus is on academics, but for Squires, it's a positive shift because she feels that today's children are so capable of doing more, especially in the setting of full-day kindergarten. "Now that we have the kids for a full day, we can slow things down a bit," said Squires.

Fenton schools holds nine full-day kindergarten classes, one half-day kindergarten and four Young 5s classrooms, according to Mora. About 25 percent of Fenton school district parents choose to have an extra year of kindergarten for their children by enrolling them first in Young 5s. "Parents can choose whether they want to send their kids to regular kindergarten or Young 5s, depending on their own view of their child's readiness," said Mora.

Michigan is currently in the process of changing the age of kindergarten start dates, she added. Children now have to be age 5 by Dec. 1, 2012 to begin kindergarten in this academic year. However, Michigan is "easing in" to a new schedule to more closely align itself with start dates in other states, especially now that the majority of states are following national education standards, called the Common Core Curriculum.

Beginning in 2013, children will have to be 5 by Nov. 1, and in 2014, they will have to be 5 by Oct. 1. By 2015, children who are 5 by Sept. 1 will have to be enrolled in kindergarten.

To get a glimpse of what today's kindergarten students are learning in school, here's a breakdown of school subjects in a typical day.

### English Language Arts

Students are ready to read, and by the time they are ready for first grade, they will be starting to print. They also learn how to hold a book properly, recognize the front cover, back cover and title page, and know the difference between a letter, word and sentence. The child will also learn the importance of listening, speaking in public and printing his or her name.

### Benefit No. 7: Improve grades

Studies have shown that children do better in school when they eat more meals with their parents and family. Teens who eat dinner four or more times per week with their families have higher academic performance

### Mathematics

They learn how to add and subtract with an object. They also learn a bit about algebra by learning how to recognize patterns in numbers. Geometry includes being able to recognize, describe and make different shapes, including 2-D and 3-D, according to Mora. "Our students also learn the numbers 0-30," she said. "They learn how to recognize these numbers in sequence, plus how to count to 100." They also learn how to measure, tell time and recognize different coins.

### Social Studies

Social studies in kindergarten teaches children how things change over time. They learn the importance of laws and regulations, people in history, as well as historical events and national symbols like the flag. They will learn what a citizen is, how to reach a compromise and how to understand the meaning of maps, globes and graphs. Learning about the environment is a big part of the social studies program. They will learn how people

depend on the environment for basic needs like food and water, and the impact people have on the environment.

### Music

A child will learn to sing, to play an instrument and some dance basics. Music also helps the child learn to read and develop reasoning skills. The teacher will use short and simple rhyming songs, and the child will learn to sing alone and in a group, how to sing on pitch and when to sing loud or soft. The child will be able to sing from memory and make up songs. Music will teach the child about different cultures and how to keep a steady rhythm.

### Computers

Kindergarteners at many school districts visit a computer lab on a weekly basis. Using the computer will let the teacher program lessons for each child based on his or her level. Computers also help a child learn to work in groups. Computer programs and games for kindergarten children teach science, reading, math and history in a fun way, and the child will learn without even realizing it.

### Benefit No. 8: Establishing traditions and memories

Sharing dinner together gives everyone a sense of identity. It can help ease day-to-day conflicts, as well as establish traditions and memories that can last a lifetime.

"It's going to be great to get back to work again after three years of unemployment," said Smith.

Even though he hasn't worked for three years, Smith has been very busy "working" at going back to school. "I treated my schooling as a full-time job," said Smith, who admitted it was tough to return to academics after 30 years in the workforce. "I had to start all over again from scratch."

He took a full-time load of 12 to 18 credits per semester, and studied for double the amount of class time he had. "I couldn't have done it without the support of my family. We all had to make a lot of sacrifices in the past three years." He and his wife, Lynn, are the parents of one daughter, Samantha, 17.

The commute to Delta College in University Center near Bay City three days a week ate up a lot of time — and gas money. But he's very appreciative that funds from former Governor Jennifer Granholm's "No Worker Left Behind" program paid for his tuition and books. "I had to take a test and then get a degree in an up and coming field

that would likely provide employment when I was done," he added.

The biggest challenge for Smith during the last three years has been financial — not having an income, although his unemployment was extended by another government program while he was going to school. "Trying to balance school and family has been a challenge, too," said Smith.

While he won't have a graduation ceremony at Delta until next spring, Smith is thrilled to have a certificate in hand from his new alma mater. "The main reason I went back to school is that it gave me more options," he added.

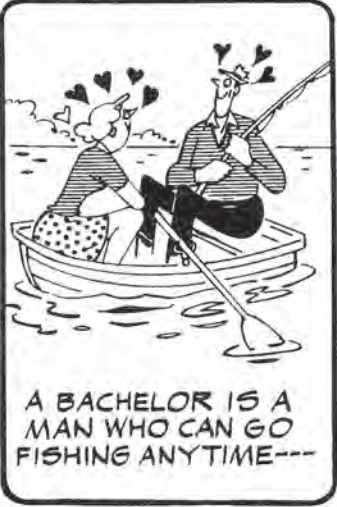
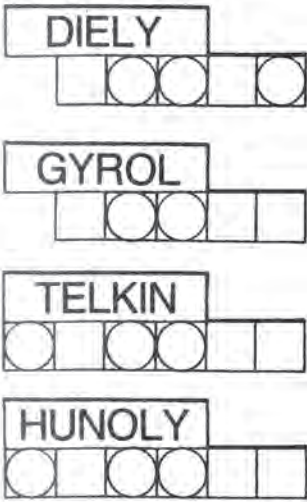

To your good health

DEAR DR. DONOHUE: I just received my grandmother's death certificate. It says: "Cause of death: uterine hemorrhage. Contributing cause: surgical shock." She died in 1931 at the young age of 33. What does all this mean?

—J.F.

ANSWER: Hemorrhage is massive bleeding. She bled from her uterus either during an operation or from a tumor, a twisted fibroid or an infection. Surgical shock isn't a term used these days. Shock means that the bleeding was so great, her blood pressure dropped. Not enough blood could circulate to her organs, including her brain and heart. In those days, such a catastrophe almost always resulted in death. I'm guessing at the meaning of surgical shock. I take it to mean that the bleeding occurred during surgery.

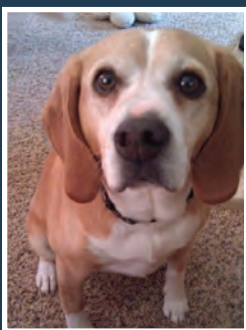

# Fenton's Bailey making an impact with Lady Vols

► Scores game-winning goal vs. 11th-ranked Missouri

When Tori Bailey played soccer for the Fenton varsity girls soccer team, she helped lead the squad to the Division 2 state semifinals in 2009.

Now with the University of Tennessee's Division 1 program, she's helping the Lady Vols accomplish some nice feats as well.

Bailey, a junior, scored the only goal of the game in the Lady Vols' 1-0 victory against 11th-ranked Missouri on Sunday.

The goal came during the 58th minute. The Vols' Caroline Brown sent a ball forward to Hannah Wilkinson to the top right corner of the box. Wilkinson pushed the ball to the right corner of the field, then changed direction toward the goal before sending a cross into the center. Bailey was there about six yards out and tapped the ball in with the

top of her foot for the only goal.

Bailey has a knack for scoring game-winning goals. In her three seasons with Tennessee she has scored four goals, and all were game-winners. She had another goal earlier this season, earning the game-winner in a 4-1 victory against Western Kentucky.

Bailey, a midfielder, has started all 13 games the Lady Vols have played and is one of only five players who have played at least 1,000 minutes (1,018). She has two goals and an assist.

"Haley knew she would be going against (Lapeer's Emily) Shallman, last year's winner and pool holder, so she knew she was going to have a fast race. She did. She posted two individual best times that were incredible."

The Tigers' other first came in the opening race of the finals — the 200 medley relay. Meagan Cassner, Shaw, Lauren Davis and Gabrielle Haaraoja earned a state qualifying time in the event with a 1:59.26.

Konopitski also had a strong showing with her two firsts. She won the 200 freestyle (2:00.89) and the 100 freestyle (55.36), both with state cuts.

Haaraoja also had a strong showing for Fenton at the meet. She earned two individual seconds. She took second in the 50 freestyle (24.96) and in the 100 freestyle (55.65). Her 50 freestyle is among the top five times posted this season.

The Tigers' other individual second was recorded by Mackenzie Deputy, who earned a diving score of 293.6.

Fenton had one more second, but it

came in a relay. The 400 freestyle relay team of Haaraoja, Davis, Cassner and Shaw earned second with a time of 3:50.21, just .22 seconds behind Grand Blanc's winning team.

Michigan State photos, you'll actually see Kelly. It makes sense since Kelly, who lives off of Byram Lake, played for the MSU football team from 1947 until 1949 under legendary coach "Biggie" Munn.

His association with Munn's era, will have him at Spartan Stadium again on Oct. 13. Kelly is expected to be one of around 10 players who will be representing the players of Munn's coaching era (1947-1953) when he's inducted to the Ring of Honor inside Spartan Stadium during the contest with the Iowa Hawkeyes. Also being inducted is another legendary coach, "Duffy" Daugherty.

Kelly is thrilled to be part of the festivities. "I'm honored," he said. "Not too many of us guys are still around, but there will probably be about 10 of us honorary captains out there for Biggie. I'm very pleased because I love Michigan State. They should've been honored before, but it takes time. But to be able to go on the field, I'm pleased."

Kelly played during the two-way player era, playing both offense and defense. On offense, he played running back, getting carries during two seasons (1948 and 1949). During his career he played behind George Guerre (6.2 yards per rush average) in 1948 and behind Lynn Chandnois (6.9 average) in 1949, meaning he didn't get a lot of carries. During those two seasons he rushed 38 times for 179 yards and two touchdowns. He also caught two passes for 31 yards.

"I played behind Lynn Chandnois who was an All-American and still probably is one of the best players of all time at Michigan State," Kelly said. "Sometimes I'd get an opportunity to play, I'd go in and he'd wave me out."

On defense he picked off five passes, including one for a touchdown. In fact, he has a photo of the TD return against Hawaii. He also returned seven punts for 79 yards.

"Scoring the touchdowns, naturally, are my biggest highlights," Kelly said. "The one that stands out in my head is one where I jumped over the goal line. That was one of them. And the other was catching the pass and running for the touchdown. But I have a lot of remembrance of those two because the pictures are here and I remember them."

Kelly was an outstanding football player in the Flint area during his prep days. He also attended Holy Redeemer High School, where he was inducted into the school's athletic Hall of Fame, graduating in 1946. His talent came honestly. His father, Jimmy Kelly, played for the Detroit Herald, the city's National Football League squad, in 1920 and 1921. He played collegiately at the University of Detroit. In fact, including current generations on the family tree, Kelly likes to say his family has played 100 years of football.

Kelly's teams were strong squads. In 1947, the squad went 7-2. In 1948, the Spartans went 6-2-2 and finished the season ranked 14th in the Associated Press poll. In 1949, the team snuck into the top 10 late in the season, but finished 19th with a 6-3 mark.

Munn's teams took off the next four sea-

sons, going a collective 35-2 during those seasons, finishing in the top 10 each year. They were the AP national champions in 1952.

Kelly, who has lived in Linden for seven years and has been a member of Spring Meadows Country Club most of his life, remained life-long friends with many of the players.

"I still talk to George Guerre. He lives in East Lansing and is a Flint kid," Kelly said. "I have lunch with him Tuesday. I talk to him once a week."

"The thing is when you are playing ball there is nobody else you associate with than your teammates. It's a job. Therefore you don't have a lot of buddy, buddies. The buddies you do have are the ones you play football, basketball or baseball with."

Kelly isn't entirely sure what his duties will entail during the contest, but he's excited to go.

"I think we're going to meet as a group before the game and then go to the middle of the field for the coin toss," Kelly said. "I'll know more about that Friday before the game. I'm excited to go."

Megan Piwowarski had a strong day, collecting 30 kills, 27 blocks and 12 aces, while Adrienne Cheff had 56 assists, 18 digs and nine aces.

"The girls keep working hard daily," Jones said. "In practice we made some small personal and team goals, so I believe if we can meet some of those goals, we may get some wins, too. Making the girls realize their potential has been my toughest challenge."

The wins represented the first ones for Holly. However, almost as important, even the losses were competitive. Of the games the Bronchos lost, they recorded at least 19 points in six of them.

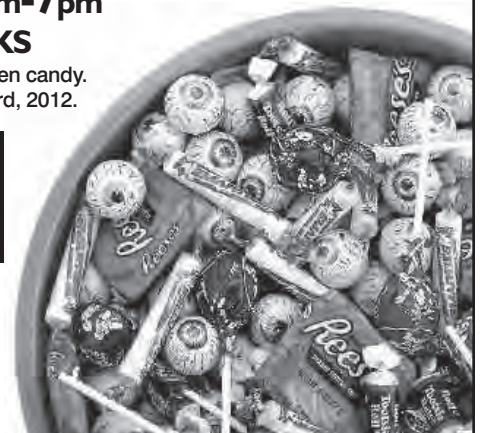
