City flushes back sewer fees on owners

►Linden building owners question legality of fees

Jack Furry, owner of the Linden Hotel, along with other building owners is questioning the legality of Linden City hitting businesses with back sewer fees.

Linden — Jim McIntyre has been renting his building out to Subway in Linden for roughly 15 years and said he has never had an issue with water usage or the county sewer system. That all changed when

the city of Linden recently asked McIntyre to pay a \$3,000 sewer tap in fee, plus back fees for the past 15 years. In total, McIntyre said the city is charging him \$14,000 for back sewer fees.

“It basically amounts to the mistake of the city 13 years ago. We get a

contract saying that if I don’t sign the contract in 30 days, I’m going to get a \$14,000 tax bill added to my summer taxes,” McIntyre told the Linden City Council at Monday’s meeting. “Which means if I don’t pay the taxes in two-and-a-half years, you take

Fungal meningitis kills three in Michigan

►119 infections, at least 11 deaths linked to injectable steroids

The Centers for Disease Control (CDC) is warning residents of an outbreak of fungal meningitis that has resulted in 119 infections and caused the deaths of 11 people. Michigan has 25 confirmed cases, and three deaths, and numbers are growing.

These cases have been linked to a contaminated epidural steroid, and are being investigated in nine states.

Fenton — Former Fenton City Councilman John Rauch passed away on Saturday, Oct. 6. He was 74. Rauch and his wife Gwen moved to Fenton in 1993, where he became very

active in the community. He served on the city council for 16 years, and was Mayor Pro Tem from three of those. Rauch was involved in several big projects, including the development of Silver Parkway, the new fire station and DPW building. He ended his time on the council last year.

Councilor: 'It's their responsibility to provide that'

► Union Block proving more costly than anticipated

Linden — Linden City Council has spent \$6,750 so far pursuing the purchase of the Union Block property. At the current rate, City Treasurer Gloria Kirshman estimates the project will cost \$243,420 by the end of year, close to eclipsing the proposed \$245,000 loan the city is considering from The State Bank.

City Attorney Charles McKone urged city council to conduct the phase two

environmental study previously recommended by Atwell, the company that conducted the first study. While Atwell reported that the property of the Union Block is not contaminated, possible contamination from surrounding properties could prove troublesome for the city.

"My concern is that there may be a real roadblock in the way and some real expense to any developer that comes in," McKone said.

McKone met with a representative of the LaFontaine family, who currently own the property. The LaFontaines offered to pay half of any other environmental studies that must be conducted and to extend the purchase agreement date by 50 days.

Councilor Ray Culbert found the counterproposal unacceptable, citing that the LaFontaines should be responsible for all costs leading up to the purchase of the property.

"In my estimation, it's their responsibility to provide that for us," Culbert said.

Kirshman said the city has not taken out a loan with any banks yet.

Chase Bank has quoted a rate of 3 percent for the same loan, .68 percent less than The State Bank. The lower rate would save the city \$13,000 during the life of the loan.

"We were told the other banks didn't call us back, that's why we went with the higher rate," Councilor Danielle Dixon said.

City council members agreed to pursue the loan option from Chase Bank and to have McKone renegotiate to have the LaFontaines pay for additional environmental and closing fees, as well as a 60-day extension on the purchase agreement deadline.

Planting fall bulbs now for spring flowers is one of life's greatest rewards. It doesn't provide instant gratification, but instead, offers the promise of a burst of color when we need it most — after a long, dreary winter.

It's hard to even imagine next spring, with the holidays approaching and a full Michigan winter ahead. But if you want to enjoy a colorful spring garden in 2013, the time to begin planning for it is now.

"You can plant right now until the ground freezes, about in mid-November," said local gardening expert Carol McAlister, of Yard 'N Garden in Fenton. "Bulbs have to go through a cooling off process, which is why we plant them in the fall in a cold weather climate like Michigan."

While McAlister is very knowledgeable about bulbs, she doesn't carry bulbs for sale at Yard 'N Garden because of the

huge volume and variety required. Other greenhouses, like Carlson's Greenhouse in Fenton, don't carry them because the humidity in their greenhouses is hard on seeds and bulbs.

Larger garden centers like The Home Depot do carry a limited variety, but the majority of bulbs are found through mail-

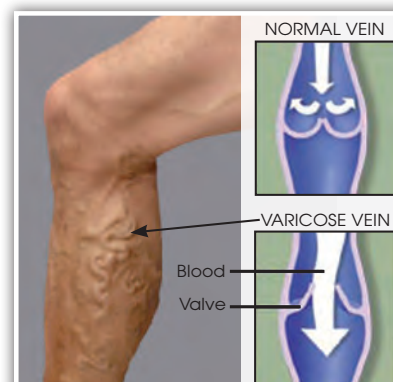

**Obama’s second-term blahs**

After scraping around for something — anything — good to say about President Barack Obama’s debate performance, I came up with this much: At least he didn’t look at his watch.

That disastrous gesture by incumbent President George H. W. Bush near the end of his 1992 debate with Bill Clinton and Ross Perot pretty much sunk whatever re-election chances he still had.

Obama suffered from the same sort of bored, disengaged, ho-hum presentation at his face-off with Republican nominee Mitt Romney in Denver. Call it the Second-Term Blahs. After four years of being surrounded by deferential yes-men and yes-women, presidents simply forget what it is like to face somebody who is pointedly accusing them of wrecking the country.

Did Obama forget that he was not standing on that stage to hold a civil conversation? Televised presidential debates are political theater. What you say is less important than how you say it, especially to the estimated 5 percent or so of voters who are still undecided.

Romney understands. With his polls sinking in the battleground states, he cheerfully threw everything that he had into the fight — plus more than a few things, that he did not have, such as facts that were on his side.

For example, Romney flatly rejected Obama’s assertion that Romney’s 20 percent across-the-board tax cut would cost \$5 trillion over the next decade and raise taxes on the middle class while giving a cut to the wealthy. “I don’t have a \$5 trillion tax cut,” Romney said.

And Romney flipped enough flip-flops to make inviting targets for zingers, had Obama cared to zing a few.

Most viewers probably thought, as I did, that Romney hogged more time in this largely free-flowing debate. Yet, it turned out that Obama grabbed almost four-and-a-half minutes more than Romney, according to a political website at the University of Minnesota. Who would have guessed?

Obama’s campaign did an excellent job of arguments like these on the day after the debate. Too bad for Obama that he didn’t make more during the debate. Time is precious.

Funeral held for former Linden hardware owner

►Pieczynski remembered as community member and family man

A prominent member of the tri-county community died last Friday. Glen Pieczynski, 71, of Linden was fondly remembered an effective businessman and one who cared for his community.

Pieczynski was born in 1941 in Posen, later attended school at Michigan State University, and obtained his masters degree from Eastern Michigan University. He is remembered for purchasing and operating Linden True Value Hardware with his wife for 32 years. Pieczynski was also the director of The State Bank in Fenton.

"He was valued as a board member to us because of his expertise in the local market," said Ron Justice, current president and CEO of The State Bank. "He had a distinct personality. He was a great

guy who did a lot for his community."

Jim McIntyre has been neighbors with Pieczynski for 20 years and said Pieczynski was an asset to the community.

"You couldn't have asked for a better guy. He will be missed," McIntyre said.

Locally, these steroids would have been dispensed from:

- Michigan Neurosurgical Institutes in Grand Blanc.
- Michigan Pain Specialists in Brighton.
- Neuromuscular and Rehabilitation in Traverse City.
- Southeast Michigan Surgical Hospital in Warren.

Patients, who received the steroids after July 1, are being urged to watch for symptoms.

As of Oct. 8, most of the patients who received an epidural injection have been notified. The CDC has expanded the notification process to include patients with injections in other sites, such as injections for joint pain. Notification of these patients is ongoing.

On Oct. 3, the New England Compounding Center (NECC) ceased all production and initiated a recall of all methylprednisolone acetate and other drug products prepared for injection into the membrane surrounding the brain or spinal cord. On Oct. 6, NECC expanded its recall to all products produced by the company even though there is no indication at this time of any contamination in other NECC products.

Summary

►Six cases of fungal meningitis have appeared in Michigan, and five have died nationwide from 49 confirmed cases. It is believed that it is being transmitted through contaminated steroid injections.

Symptoms according to the CDC include fever, headache, stiff neck, nausea and vomiting, sensitivity to light (photophobia) and altered mental status.

The CDC warns that anyone experiencing these symptoms or symptoms of a stroke should immediately contact their physician. Symptoms have surfaced one to four weeks after the injection.

Fungal meningitis is not communicable and is most likely to affect people with a weak immune system.

Treatment includes a long-course of anti fungal intravenous (IV) medication. The length of treatment depends on the state of the patient's immune system, and the type of infection.

Physicians should contact the Michigan Department of Community Health (MDCH) concerning "any patients undergoing evaluation." The MDCH Communicable Disease Division can be reached at (517) 335-8165 to report a case, or ask any questions.

Holly schools selects superintendent search firm

► Kent Barnes replacement to be hired by July 2013

Holly — After some discussion and two votes, Holly Area Schools (HAS)

Summary

► The Holly Board of Education opted to hire the MASH to conduct the search for a new superintendent. The search will cost around \$8,000 and will be completed by July 2013.

Board of Education decided to hire the Michigan Association of School Boards (MASH) to handle its search for a new superintendent.

This is the same firm who headed up the project studying the viability of closing a Holly school building last year.

The search must be finished, and a new superintendent hired by July 2013, when current superintendent Kent Barnes is set to retire.

MASH and North Star Staffing Inc., of Clio each made 30-minute pitches for their services at the previous board meeting.

Initially, trustee David Rath made a motion to hire North Star Staffing, Inc., which led to discussion on both group's plans, and how they differed. "They seem fairly consistent," said Rath. "It appears to me that North Star had more experience."

He added that North Star, the group founded by a former member of MASH, was less expensive at around \$4,300, while MASH was closer to \$8,000. He also liked the company's flexible time line.

Other members argued in favor of MASH. Board president Tony Mayhew liked the rigid time line of MASH and also that HAS would be the only superintendent search project on MASH's plate during the year. Mayhew also was not encouraged when he sought references for North Star's performance.

Secretary Robin Carne liked dealing with the MASH personally, saying their accessibility would help MASH "get the flavor of what we want."

The first vote to accept North Star Staffing, Inc. was voted down, with trustee Kevin Diviney abstaining and Rath voting in favor. Trustee Michael Newcomb made a motion to accept MASH, which passed with Rath dissenting, for the same reasons he previously offered to support North Star Staffing Inc.

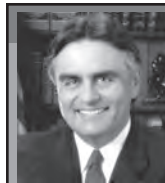

Indigent criminal defendants

The Constitutional right to an attorney in a criminal case has long been one of the hallmarks of our American justice system. A number of defendants can retain an attorney and they are represented at all critical stages of a criminal proceeding until their case is concluded.

However, there are a number of individual defendants who meet the standards of indigency, of not being able to afford to retain an attorney and for these individuals the law provides for appointment of a lawyer at public expense.

Historically in Michigan, there has been a fairly wide county-by-county variance in both spending levels for indigent defense attorneys and appointment plans. For example according to the Michigan House Fiscal Agency, estimates have placed the statewide three year average of per capita spending at \$7.38 with spending amounts for individual counties varying from a low of \$2.56 per capita to a high of \$17.01 per capita.

In an attempt to address this issue in a more uniform way, House Bill 5804 was introduced on Aug. 15, 2012 in the State House with bipartisan support. The House Judiciary Committee summarized the contents of the Bill as follows:

'The bill would create the Michigan Indigent Defense Commission Act to create the Michigan Indigent Defense Commission, provide for its duties and powers, provide for constitutionally effective assistance of counsel to represent indigent defendants in criminal cases, provide standards for the appointment of legal counsel, and provide funding for certain functions of the MIDC and to implement the standards in courts around the state. The bill specifies that nothing in the bill should be construed to overrule, expand, or extend, either directly or by analogy, the decision reached by the U.S. Supreme Court in Strickland v Washington, 466 US 688 (1984), or its progeny in the Michigan Supreme Court.'

The Bill has a number of supporters including the Michigan Supreme Court.

As is always the case we will have to wait to see what happens. The full report from the Judiciary Committee is available on the Michigan House website.

Local lawmaker glad money returned to citizens

Michigan's taxpayers will start keeping more money in their paychecks as a broad-based tax relief plan reducing the state's personal income tax takes effect, State Rep. Joseph Graves announced last week.

Public Act 223 lowered the income tax rate from 4.35 percent to 4.25 percent. PA 224 increases the personal tax exemption from \$3,700 per person to \$3,950 per person. Both plans took effect Monday.

"Michigan residents work hard to earn their money and if there is any extra state revenue, it should be given back to the taxpayers who earned it," said Graves (R-Argentine Township). "Being fiscally responsible has been key to turning our state around and I'm glad we're getting this money back to our local economy where it belongs."

Summary

Public acts 223 and 224, effective last week, lower the income tax rate and increase personal tax exemptions, respectively.

Under PA 224, the personal exemption also will increase to \$4,000 on Jan. 1, 2014.

Graves said he is extremely proud that fiscal responsibility has been a priority in Lansing and after the 2011-2012 session began with a \$1.5 billion state deficit, reforms have resulted in more than \$500 million in the state's Rainy Day Fund. Legislative initiatives to streamline government also reduced Michigan's debt by \$20 billion and focused priorities will result in more funding for K-12 education, roads and public safety while still finding ways to return surplus revenue to taxpayers.

"Michigan got to this point by being fiscally responsible and I look forward to seeing us accomplish much more for our residents by staying fiscally responsible as we move forward," Graves said.

Take a hike

►Walk on Michigan's nearby trails for close up view of fall

There's no better way to experience the stunning beauty of a Michigan autumn than by hiking your way through it.

Michigan provides hundreds of hiking trails, allowing hikers the privilege of seeing nature up close rather than from the distance and confines of a car.

The colors have been great, according to Jim Case, supervisor at Seven Lakes State Park in Holly, midway between the city of Fenton and village of Holly. Last week, he estimated that the trees were at about 40 percent peak color. "There are a lot of oranges, reds and yellows already. The way it's going with cooler weather, peak color at the park will be coming early."

These vibrant colors and cooler temperatures make fall a perfect time to hike in Michigan. There are fewer crowds at most parks, yet patrol officers are still in force, according to Case. "The park is very safe this time of year," he said. "Because we're open for hunting in the early morning and late evening, we suggest that hikers choose mid-day to hike, and wear bright colors."

For hikers who want to enjoy a full afternoon of hiking, michigantrailsmap.

com suggests that they consider taking Seven Lakes State Park's 1.8-mile Red Trail Loop from the Meadow Ridge Shelter to the Dickinson Boat Launch, and then continue to the Green Trail Loop for a short distance. Depart at Post #8 to skirt the south end of Big Seven Lake, looping back to the picnic area and beach along its west shore.

This would provide a 3.8-mile hike that would skirt the park's three largest lakes and cover some of the most scenic sections of the trail system.

To enjoy a beautiful view from the summit of Seven Lakes State Park, Case suggests that hikers take the Dickinson Trail west at the Boat Launch, cross the footbridge then take it toward a very tall hill — the highest peak at the park. "It's a beautiful view even after the leaves have fallen, because you

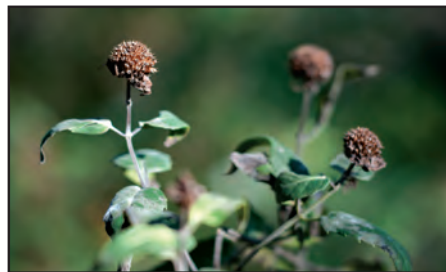
get an unobstructed view of the entire Holly area," said Case.

Nearby at Holly Recreation Area, Wilderness Trail provides hikers with a 5.75-mile loop amidst McGinnis Lake, wetlands and hardwood hills.

Hikers will find the trail delightful in October, according to Michigantrailsmaps.com. Fall and spring are the best times for hiking this trail, and hikers will enjoy the natural beauty of numerous ponds and marshes. The main trailhead is located south of McGinnis Road in the Heron Lake day-use area.

Fall hiking lets visitors get close to nature and all the colorful details that accompany autumn.

For shorter hikes and walks closer to home, check out Genesee County Park's Linden County Park/Clover Beach's 1½ miles of walking trails, with Byram Lake as a scenic backdrop. These paved trails lie just a half-mile south of Linden's city limits.

The Dauner-Martin Nature Preserve off Dauner Road in Fenton is also a hiker's perfect fall destination. With 4.5 miles of marked trails dotted with benches for relaxation, hikers will also enjoy deer sightings, bird watching and plenty of color. In addition to pine trees — some 50 years old and more — oak, elm, cherry, maple, and ash are prevalent on the property.

People who want to take their families on a hike might want to check out the For-Mar Nature Preserve & Arboretum in Burton. Featuring a well-mapped trail system with shorter segments, families can adjust their outing to their abilities. The longest trail is a 2.5-mile loop, followed by a two-mile Edge of the Wood trail, then shorter walks, a .7 mile Maple Walk and .8-mile Lilac Walk. For more information on their schedule, check out geneseecountyparks.org.

For more information about hiking in Michigan, the website hikingmichigan is dedicated to all levels and all ages. Many of their weekend events are held close to the tri-county area, including upcoming Fall Color Hikes at Seven Lakes State Park (date to be announced).

Additional Michigan scenic hikes

1) Virgin Pines Foot Trail

One-mile loop at Hartwick Pines State Park, just north of Grayling.

2) Highbanks Trail

Seven-mile linear trail, which skirts the high bluffs above the Au Sable River in the Huron National Forest.

3) Warren Woods Natural Area

This is a 200-acre tract in Berrien County. Hike begins at footbridge across Gailen River, then 3-mile loop past giant trees.

4) Lighthouse Park

Four miles of footpaths at the tip of Old Mission Peninsula 20 miles north of Traverse City.

5) Pierce Stocking Scenic Hike and Drive

In Leelanau County, this overlooks Lake Michigan and Sleeping Bear Dunes. Picturesque covered bridge leads to 200 ft. dune overlook with a panoramic view of Manitou Islands, Pyramid Pt., Sleeping Bear Bay and Dunes, Glen Lake and historic D.H. Day Farm.

McIntyre isn't the only building owner that the city is hitting up for back sewer fees. William Hamrick, who owns a building in downtown Linden, has been charged \$21,000 in back sewer fees. Linden Hotel Owner Jack Furry said the city is charging him \$70,000 in back sewer fees from 30 years ago — a 50 percent tax increase compared to his current rate.

“This \$3,000 fee, we need to justify this. What legal grounds are you doing this on?” Furry asked the council.

City Attorney Charles McKone said the \$3,000 sewer tap in fee is set by Genesee County and that the city of Linden purchased the taps from the county for \$2,000.

“I'm not certain, I don't think we pass on the exact same cost to property owners, I think we pay \$2,000 and I think we charge \$3,000 per unit for associated costs,” McKone said.

According to McKone, the city had to prepay for a number of sewer tap in fees

in order to be a part of the county sewer system. The fees collected from building owners are used to pay for the city's pre-paid sewer fees. McKone said the \$3,000 tap in fee is based off a formula created by the county, not the city.

Furry, Hamrick and McIntyre noted that the city's new fees don't match the fees that would be charged when they bought their buildings.

“We've expanded and operated all these years without tap in fees,” Furry said. “We've done nothing to change this.”

In June, the city charged the Linden Sweet Shoppe \$3,000 for a sewer tap in fee after owners Laura and Chris Mathews placed an oven into their building. Then City Manager Mark Tallman said restaurants use more water and that “Everyone should pay their fair share.”

“I believe we will be revisiting this process to make it more transparent,” said Mayor David Lossing. Council is expected to discuss the topic at a future meeting.

“This \$3,000 fee, we need to justify this. What legal ground are you doing this on?”

furnace thermostat at 68 degrees or lower in the winter, and your air conditioner at 78 degrees or higher in the summer. Roughly

3 to 5 percent more energy is used for each degree higher or lower than these, which can get expensive. When you are going to be away from

home for long periods of time, consider lowering or increasing the temperature respectively.

Save money while washing your clothes.

They can both be a source of excess energy usage. Consumers Energy suggests washing and rinsing clothes in cold water to avoid the cost of heating up the water. Wait until you have a full load of clothes to wash so that you run fewer loads overall.

When buying a washer, like with all other appliances, do your research before you spend the money. For saving money on your power bill, a high-

efficiency machine may be the way to go.

“The high efficiency washing machines will use 60 percent less water per load,” said Stone. “It can add up if you are paying for your water, plus you have to pay to heat your water.”

Drying your clothes can be cheaper too.

Avoid over drying your clothes — it will not only cost you more money, but will also wear out your favorite outfits. Consumers Energy also recommends to clean out your dryer's lint trap after every load of laundry, as it will help your clothes dry quicker.

Unplug your electronics.

Some devices will continue to use up electricity even when they are not actively being used or are turned off, such as cable boxes, surround sound systems, modems, and others. Other devices that have digital clocks, also use up electricity. Unplug these devices when not in use for small savings that can add up over time.

Regularly replace or clean furnace and air conditioner filters.

The longer you wait to do either of these things, the less efficient your heating and cooling systems will become, and the more money they will end up costing you.

a new building, or something else entirely. The study will only cover the current building, and not any other buildings to determine if they could potentially house a library.

Councilman Benjamin Smith was happy to see progress with the library. “I applaud loudly for moving forward with this,” he said. “I am pleased we got to this step.”

The council's representative to the

Library Board, Councilman Bradley Jacob, said that the feasibility study would be a good first step to figuring out what the building's problems are.

City Manager Lynn Markland said that the feasibility study will help determine if there are short-term fixes the library may need, and if there are any long term actions the city may need to look at down the road.

The feasibility study is expected to take about four weeks, after which a representative from THA Architects will present their findings to the council.

order or online garden companies.

The most important aspect of choosing bulbs is to buy the highest quality ones you can find. They are graded 1-2-3, with #1 grade being the most mature, promising big beautiful flowers next spring. Grade #2 may take another year for the flowers to blossom, and #3 are small, and may take two to three years to flower, according to McAlister.

Look for plump, firm bulbs that aren't dry or withered, spongy or moldy. "Choose a bulb that feels firm, but has a little 'give,'" said McAlister. "The bulb should be golden brown, not black, and it should smell clean." In general, the larger the bulb for its type, the more flowers.

Choose bulbs that are suited to your area, and make sure that your soil is a rich, well-draining soil with a balanced pH that will feed the underground bulb and fuel the spring growth and flowers.

Rule of thumb:

If you want a show-stopping impact, plant tulip bulbs 3 inches apart with a little bone meal or bulb booster in the bottom of the hole.

Tip: For a dramatic show, layer larger bulbs for tulips, daffodils, etc., underneath with smaller bulbs for crocuses or scilla on top.

Here are a few other bulb-planting tips:

1. Most bulbs prefer full sun, but fall shade is fine for many varieties. Jack-in-the-Pulpit, Dog's Tooth Violets, Snowdrops and Trillium all prefer a bit of cool shade.

2. Plant before mid-November so that the bulbs will have a chance to begin growing roots and establishing themselves.

3. Plant with the pointed side up. The pointed end is the stem. You may even be able to see some shriveled roots on the flatter side. If you're not really sure, don't worry, because the plant will find its way up, but you can avoid stressing that plant if you plant it "point side up."

4. When planting tulip bulbs, McAlister suggests planting them 8 to 10 inches deep. Planting them at the proper depth will result in a big flower year after year, she said. The general rule of thumb for bulbs is to plant them to a depth of about 3 times their diameter. For daffodils, that's about 6 - 8 inches.

5. Mix some bone meal or super-phosphate into the soil at the bottom of the hole at planting time, to encourage strong root growth.

6. If rodents tend to eat your bulbs, you can try sprinkling some red pepper in the planting hole. A more secure method is to plant your bulbs in a cage made of hardware cloth. The roots and stems grow through, but the rodents can't get to the bulbs. Make it easy on yourself and make a cage large enough to plant at least a dozen bulbs. Or you can make it really easy on yourself and stick to daffodils, which rodents and most other animals avoid.

7. Replace the soil on top of the bulbs. Water the bulbs after planting.

DEAR DR. DONOHUE: I have gotten my weight to a point where I am happy with it. I still have fat bulging at my sides. I think these are called love handles. I don't love them. I don't think that losing more weight will rid me of them.

What do you think of liposuction? Is it risky? — A.S.

ANSWER: Liposuction removes fat from fat deposits beneath the skin. It doesn't remove deep deposits of fat, the fat that surrounds organs in the abdomen, the fat that creates most metabolic troubles. It's the deep fat that's associated with increased risk of heart attack and stroke. Your dieting should have taken care of that fat.

Liposuction surgery is cosmetic surgery, so you'd better check with your insurance if you need it to cover the procedure. All surgical procedures, including liposuction, carry a risk. Complications from it, however, are not frequent.

Metro title hopes dashed for Fenton, Linden

►Tigers can't get offense going in 1-0 loss to Lapeer West

Fenton — The Fenton varsity boys soccer team went through the entire Flint Metro League season without a loss — at least until Monday.

And it was that Monday loss that cost the Tigers their first Flint Metro League crown since 2009. In a game which the winner would get the outright Metro title, Lapeer West scored on a failed clear attempt by Fenton (6-1-1, 10-4-2) during the first half, earning a 1-0 victory at Fenton High School. If Fenton won the game, the Tigers would've been outright champions. If they tied, they would've shared the crown with Linden. A loss means the Tigers finish the season in third place.

"We just didn't execute on offense," Fenton senior Bradley Gornick said. "The defense played solid, but it's a team effort. We are all responsible for what we did, but we played good."

"We still have a lot of season left. That was just one goal we had. We still have some other goals left. We just have to keep moving forward. We still have a lot of season to go."

It was an evenly played game with both teams enjoying control for about a half. However, while a team might have had control, that didn't necessarily result in shots on net. West had just two shots on frame in the first half, the 40-minute juncture they seemingly controlled. Meanwhile, needing a goal

to tie the game at 1-all, Fenton managed just two shots on net in the second half.

"We tried to force things and guys tried to do too much, and we didn't get the ball wide like we want to do," Fenton coach Matt Sullivan said. "When we are successful, we play the ball wide, and we didn't do that. It's been like that all year. When (how we played tonight) happens, we lose."

The only goal came with 29:27 left in the first half. As Fenton tried to clear its defensive zone, the ball deflected back into the Fenton

The Eagles did their part of the equation, defeating the Swartz Creek Dragons 3-1.

However, Lapeer West defeated Fenton 1-0, earning West the league crown. Linden needed Fenton to tie West in order to earn a share of the title.

The Eagles (6-0-2, 11-2-2) took a 2-0 lead in the first half. Zach Bakos scored on an assist from Kyle Frederick to start the scoring. Before the half was over, Kevin Wright scored on a Bakos assist.

Both teams scored a goal in the second half. Patrick Lubahn scored Linden's goal unassisted off goalie deflection.

In net, Collin Hoerberling had three saves, earning the victory. Linden dominated play for the most part, enjoying a 21-6 shot advantage against Creek.

The Eagles opened the Metro League season with two draws, meaning to have a chance at the title they probably needed to win their final six games. But in the process, they still would've needed help to win the title. The Eagles did rattle off six league victories after the draws to Fenton and Holly, but needed Fenton to earn the draw with West to share the crown with Fenton. Instead, West's win gave the Eagles second place outright, while Fenton finished third.

Linden CC makes a statewide statement

► Takes third at Portage Invitational, beating six ranked teams in the process

Ranked ninth in Division 2, the Linden varsity boys cross country team was seemingly a bit underrated in recent weeks.

The Eagles proved that to be the case on Saturday at the Portage Invitational.

In an event which included eight ranked teams, the Eagles finished third, at the Portage Invitational, finishing only behind the top two ranked teams in the state.

And it wasn't like the Eagles were dominated. Second-ranked St. Clair won with 89 points, while top-ranked St. Joseph recorded 106 points. The Eagles, who were the only team to have two of the top five runners, placed third with 128 points, while third-ranked Cedar Springs was fourth with 137 points. Sixth-ranked Ionia was a distant fifth with 215 points. Other teams Linden beat included fourth-ranked Grand Rapids Christian, seventh-ranked

Grand Rapids Forest Hills Northern and eighth-ranked Richland Gull Lake. In fact, the Metro League represented well. Unranked Clio placed ninth at the event, suggesting Linden's Metro League jambo-ree victories deserve more credit than one originally suspected.

"The kids ran really well," Linden coach Clint Lawhorne said. "While we may have caught some teams off guard with our performances, we weren't surprised. The kids ran the way both coach (Seth) Normington

and I knew they could. They were aggressive from the start and raced to the end. It was a great day for our team, but we need to get better if we want to take home a trophy at MIS in November."

Of course, Lawhorne was hinting at the state meet. The Eagles know what it takes to place high at the state meet. Linden's boys cross country team is the most current tri-county squad to win a state title, winning it in 2008. Before that season, the Eagles took third in 2007 and fifth in 2006.

The Eagles were the only team to have two runners finish in the top five or to finish under 16 minutes. Graham Elliott and Roger Phillips led Linden, finishing fourth and fifth place, respectively. Both came in with times of 15:52. Zach LeMieux was 34th (16:34), while Ryan Torok was 42nd (16:40). Dave Doyle capped the scoring five by posting a 43rd-place finish in 16:41. Kyle Susalla, 56th in 16:52; and Adrian Taylor, 77th in 17:11; capped the Eagles' top seven. Only St. Clair had its top seven finish earlier than Linden's seven runners.

Shaw, Haaraoja progressing well during swim season

Fenton — Haley Shaw and Gabrielle Haaraoja entered the varsity girls swim season with high expectations.

But in recent weeks, they've learned some pleasant news. They are finding out that maybe they are each capable of more than they thought just two months ago.

Both were expected to be among those making second-day swims at the state

meet in November. However, if all goes right, their recent swims are suggesting that as long as they qualify for the state meet's second day, they'll have a good shot at placing high in their events.

Shaw recently broke school records in the 100 freestyle (57.54) and the 200 individual medley (2:07.64) at the county meet. In the process, she's put herself in position to possibly win state titles in both events. Meanwhile, Haaraoja isn't too far behind. She's ranked seventh in the state in the 50 freestyle (24.96). Both swimmers are excited.

"No, I saw myself here at the end of the season," Shaw said. "I never expected this

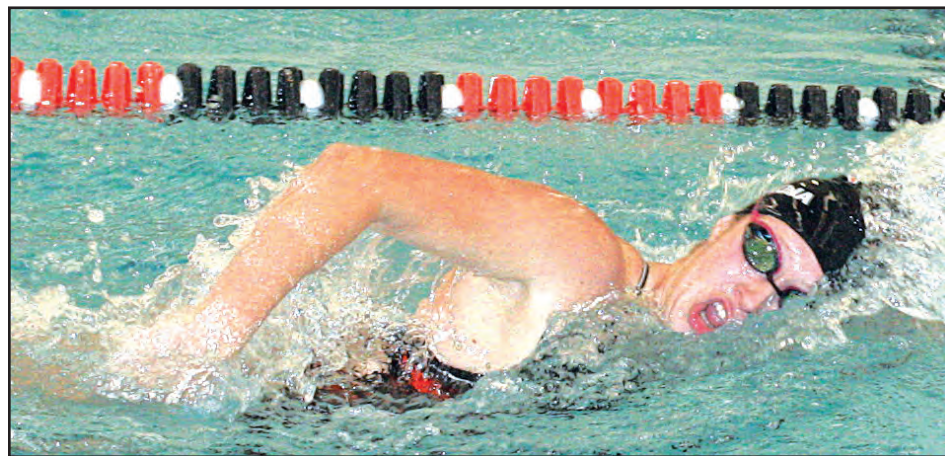
now. I'm going faster than before."

"I feel really good about it," Haaraoja said. "I've done more than I expected to do this season. I'm (seventh) in D2 in the 50, so I'm feeling pretty good about it."

The pair didn't get those type of times during the dual meet, but they weren't expected to, either, since the squad is now back in full training mode. Still, each eas-

Fenton's Lessard wins regional title, headed to equestrian state meet

►Despite being one-person team, making her second straight trip to Midland event

Being the only person on an equestrian team can make it tough to get noticed.

Just ask Fenton's Nadine Lessard.

"A lot of my friends know (I compete on the equestrian team), but it's not really a very publicized sport," Lessard said. "It doesn't even have a page in the year-book."

If Lessard continues her success from earlier in the season at the state meet, however, she could end up getting some notoriety.

Lessard, who has already won a district and regional championship, will compete in the Class D state equestrian meet starting on Thursday. She'll compete in 16 classes over those days on her two horses — Bowen, a 17-year old Arabian, and Smokes, an 11-year old Quarterhorse.

This is the second time Lessard's name has made up everyone on the team. Last season during her junior year, she also qualified for the state meet as a one-person team. During her freshman and sophomore years the team was five and four people in size, respectively.

"It's a lot to take in during your junior year," Lessard said. "Now I kind of have the hang of it."

Participants compete in many different classes. Each class has specific events within that class. First, there are the showmanship classes and then the English classes. Jumping classes follow and saddle seat classes are after that. Finally, there are western classes and gym-

khana classes. There are 16 events within the classes overall. Lessard will split the events between the horses based on their abilities.

"Even though he's 17, Bowen acts like a 2-year old," Lessard said. "He has a lot of energy. I'm borrowing Smokes from a neighbor. I've trained a lot of hours with Smokes the last two-and-a-half years."

Lessard, who has been riding horses since she was 3 and started showing horses when she was 7, will compete against teams that are like-size, either one or two competitors large. That helps her cause. Because while larger teams have more competitors to use in all the events, Lessard is by herself.

"It's crazy, but at regionals I had to compete in all the events in two days and in districts in one day," Lessard said.

Until last year, the Fenton squad has never made it beyond districts. Lessard has lofty goals for this season.

"Last year the competition at regionals was really tough and I barely made it out of regionals," Lessard said. "This year I've come a long ways and both of the horses are doing really well. I'm confident but I don't want to get cocky about it. I (won the regional championship) by quite a bit point spread, so I was pleased."

Lessard said equestrian is a unique sport.

"I love the commitment in it," Lessard said. "Not only do you as an athlete have to be fit, but you have to work with a 1,000-pound animal that will do anything for you. It's so rewarding."

ily won their individual events.

Shaw posted a time of 25.86 seconds in the 50 freestyle, while earning a 1:01.85 in the 100 butterfly. Meanwhile, Haaraaja recorded a time of 57.13 in the 100 freestyle and a time of 2:09.89 in the 200 freestyle. The pair also teamed with Lauren Davis and Addison Ransom to win the 200 freestyle relay (1:50.14).

Both discussed their lofty goals for the rest of the season.

"My ultimate dream goal is to go for All-American in the 100 backstroke," Shaw said. "I need to go a 56-low in my 100. That's what I'm going for. Other than that, I really want to place in the top eight for states and break some more records."

"I want to be top eight in both of my events at state," Haaraaja said. "I'd like to break the varsity and pool record in the 50 as well. Those are my goals."

But beyond the individual goals, both have strong team objectives as well. Due to the youth of the team, both are being asked to become strong leaders. So far, they've done a fine job.

"This year we've been more determined to get the team together as a unit, and accepting of everyone," Shaw said. "We're trying to get everyone to cheer for everyone else. We really don't have a lot of seniors on our team anymore so the leader-

ship role has fallen to me and my fellow captains."

"I've definitely had to step up and be a leader," Haaraaja said. "And it helps that I have been swimming for six years and Haley Shaw (has been swimming a long time too). We are definitely out there to help everyone."

For Haaraaja, leading means having one well-known student, her sister Taylor Haaraaja. The pair teamed with Davis and Brianna Costigan to win the 400 freestyle relay (4:10.25) in the night's final event.

"It was cool to be in a relay with her," Haaraaja said. "We are really close. It's good to have her on the team. She's a freshman on the team who can help support the other freshmen."

The Tigers had two other firsts at the meet. Diver MacKenzie Deputy won with a score of 185.40. Meanwhile, Meagan Cassner won the 100 backstroke (1:11.39).

Of course, one goal the Tigers want to maintain during the season regardless of youth is their Metro League streak. Fenton has never been seriously challenged in a league dual or a league meet. That probably won't happen this year either.

"We lost a lot of people from last year, but we are definitely making up for it," Haaraaja said. "We are doing better than what I thought we'd do. We are unexpectedly doing better. I think we are still going to have an undefeated (Metro) season, so that's good."

"We just are going to refocus and we are going to come back strong next week," Gornick said. "We are going to come back tomorrow, play Brother Rice on Thursday and prepare for Brandon on Monday. We are looking to come back strong."
