The pieces they pick out fall through the floor into more bins, 15 feet down. The front part of the conveyor is where good "recovered fiber" or cardboard is removed.

The ground below is muddy and strewn with post-consumer debris.

Voters in the Fenton, Holly and Byron school districts have proposals to decide on when they submit their absentee ballot or head to the polls on Tuesday, Nov. 6.

We are all creatures of habit, for better or worse. Sometimes we may have formed good habits, such as going to the gym on a regular basis, but more often than not, we have formed habits that are not in our best interest.

Breaking bad habits is easier said than done.

Heidi Grant Halvorson, a social psychologist and author of the book, "Suc-

ceed: How We Can Reach our Goals," said one key to breaking habits is to be very clear about what you want.

"One of the most common mistakes we make when trying to reach a goal is not being specific enough about what we want, and what we're going to do to make it happen," she wrote on the Psychology Today website.

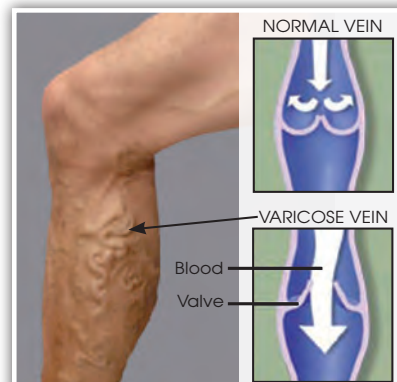

# Political ads and lemon meringue pie

Most people have experienced the phenomenon of consuming a particular food just prior to becoming ill. Whether the particular food you consumed is responsible for your gastric distress is irrelevant. It's highly likely you will never eat that food again. Moreover, just the sight or smell of that food will trigger nausea and disgust in you for the remainder of your life.

As a 6-year-old, I consumed a piece of lemon meringue pie immediately prior to the onset of a nasty case of the flu. To this day, the sight or smell of lemon meringue pie triggers the instant

onset of nausea and disgust in me. This phenomenon is called taste aversion. It's built into our DNA and is one of the strongest conditioned reactions ingrained in humans. It's our body's way of telling us that we have been poisoned. It is an automatic survival mechanism that involves the release of memory-enhancing hormones that encourage us to remember the source of contamination so that we can avoid it in the future.

It's also the fundamental basis for most of the negative political ads you see on TV.

In a nutshell, if we can associate a

politician or a proposal with something negative, then voters' 'taste aversion' mechanism will kick in.

Example: Candidate Bob Jones, the incumbent, once voted no on a bill to increase women's health care because he felt it wasn't sufficient, and wanted a more substantial bill. In the next election cycle, a grainy, unflattering photo of Candidate Bob Jones fills your TV screen along with a female voice-over stating in a disgusted tone, 'Bob Jones even voted NO on a bill to increase health care for women. Now it's our turn to tell Bob NO. Let's send Bob back home where he belongs.' It's called 'candidate aversion.' It's incredibly dishonest, totally misleading...and extremely effective.

The opposite is true also. If you can associate your candidate, or agenda, with images of policemen, firemen or

other iconic representations of public safety, no matter how remote the stretch, a predictable percentage of the voting public will unconsciously recall that image when their pen is hovering over the ballot, and will instinctively vote in a manner they perceive as in their own best interest.

Truth be told, political TV ads are like weather forecasters — they can say anything they like without worrying if it's a stretching of the truth, right, wrong or an outright lie. They are simply never held accountable.

And why would that surprise anyone? Professional politicians, especially on the national scale, are also professional liars.

Political advertising?

Same as lemon meringue pie to me.

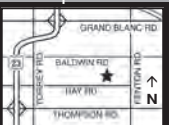

# Refinancing bond could save Holly \$160,000

► Savings of \$15,000 in interest could be realized annually

**Holly** — Many people consider refinancing their homes or debt in today's financial climate to save money, and the village of Holly is no different.

On Tuesday, municipal financial advisors Robert Bendzinski and son Ryan of Bendzinski & Co. of Detroit filled the village council in on the basics of a water and sewer bond refinancing options available to them.

The village pays around \$1.5 million each year in debt service for bonds from around a decade ago, to expand the sewer and water service in the village. Few topics raise the hackles of village residents as much as the price of municipal water and sewer service.

In 2011, residents began paying a debt service charge of \$48.50 per month, after lengthy public discussion. Adding apartment complex users reduced the fee a nominal amount this spring.

It's an expensive issue and the village is exploring the option of refinancing one "bond issue," to lower the amount of interest the village will pay. By refinancing, the village is projected to save

\$15,000 per year or around \$160,000 over the life of the bonds, which is 12 years. It would not extend the length of the payment term.

Currently the village is paying 4-percent interest, eventually expanding to 4.85 percent. Should it refinance a certain bond issue, it would pay 1.2 to 3.5 percent interest.

It's not a cheap option. Bendzinski and Co. would take \$75,000 in fees to broker the deal in March of 2013, which are already included in the savings the village would experience. Robert Bendzinski said the village would pay no fees, if the market does not allow savings through refinancing bonds. "Your risk is about zero, at this point," he said.

Former council member William Kuyk pointed out that residents would save little to nothing from the deal and it wouldn't affect their payment. It would save the village money, however. "This is a good savings," said Jeff Miller, president. "To me, the time is now."

The village has the option to draft perimeters for the deal, setting a minimum savings and/or maximum percentage amount they will pay, in order to make the refinancing worth it. The council voted to ask the finance committee to come up with these parameters for the bond issue, and the council would then decide whether to proceed.

## Summary

► The Village of Holly is considering refinancing one set of bonds, which would save the village \$15,000 in interest every year for 12 years. Residents probably won't feel the savings though, and the deal includes a \$75,000 fee for services.

Random shootings have been reported between Tuesday, Oct. 16 and Thursday, Oct. 19. Most of the reported incidents involve cars near I-96 in Oakland, Livingston, Ingham and Shiawassee counties. Ten

of the shootings were in the city of Wixom. No injuries have been reported.

Based on a witness' description, the gunman appears to be a man in his 30s, with close-cropped hair and stubble on his cheeks and chin.

A task force of several law enforcement agencies has formed to follow up on all leads.

The Oakland County Sheriff's Office Forensic Laboratory has reported that preliminary tests have been completed on the ballistic evidence submitted by the Wixom Police Department and the Livingston County Sheriff's Department. The preliminary results indicate that the evidence was fired from the same gun. Additional testing will be completed to determine the gun's caliber.

As of the evening of Oct. 23, the task force has received more than 250 tips. Investigators continue to work on the open tips and suspect leads. The task force would like to stress that there have been no new incidents since the evening of Thursday, Oct. 18.

ATF Special Agent in Charge Dave McCain said, "Our citizens deserve a safe community; unfortunately, there are predators whose violent activities threaten our safety, security and quality of life. We are committed to working with our local, county, and state law enforcement partners in bringing this individual(s) to justice."

The task force encourages citizens to remain vigilant in reporting information leading to potential suspects by calling the tip line at 1-800-SPEAK UP.

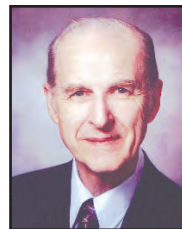

### Weak people who changed the world

Investigators of the work of the well-known missionary, Mary Slessor, were amazed at her ability to influence tribal chieftains to cooperate in her efforts to evangelize their people. 'You have forgotten to take into account the woman's God,' said one of them.

Most of the disciples of Jesus were not noted for their strengths. Peter had trouble with his temper and was unstable at the crucifixion, denying his Lord three times. Philip tried to figure a faithless way out of problems. Thomas, at first, doubted the resurrection. Yet this group of weak ones planted churches throughout their world.

Christianity exists today because of the accomplishments of imperfect people who counted on God's strength to com-

pensate for their weaknesses. His power made the difference.

What makes that power available to us? Prayer and faith. God imparts His power to those who trust Him.

When we reach the end of human endurance, it is good to know that God has promised divine strength to His fainting children. Believers who have exhausted their own resources can exchange weakness for God's limitless strength.

'I can do all things through Christ who strengthens me,' said Paul (Philippians 4:13).

What encouraging words for those who feel at the end of themselves! And those times come for us all. Our burdens become too heavy to bear; our responsibilities require more than we have to give.

Sickness may drain our normal vitality. Lack of sleep may rob us of alertness.

Financial needs may become so distressing that our work hours are lengthened to meet the money crunch. Even then, God offers to compensate for our weakness with His strength. He understands our limitations.

'He knows our frame. He remembers that we are dust' (Psalms 103:14).

God has tipped the scales in favor of many weak ones.

George Frederick Handel lost his health; his right side was paralyzed, his money was gone and his creditors threatened to imprison him. Handel almost despaired, but his faith prevailed and in his affliction composed his greatest work: 'The Hallelujah Chorus,' the crowning section of his renowned 'Messiah.'

Fanny Crosby was blind but composed thousands of published hymns, many of which are still used in worship services around the world.

Shortly before her 60th birthday, Helen Keller expressed pity for the real unseeing, writing: 'If the blind put their hand in God's they find their way more surely than those who see but have not faith or purpose.'

Every week has weak days. 'But they that wait upon the Lord shall renew their strength; they shall mount up with wings as eagles; they shall run, and not be weary; and they shall walk, and not faint' (Isaiah 40:31).

So if you're feeling weak, in view of your problems, burdens and responsibilities, you're just the person God wants to empower to rise above your circumstances and change the world.

The city is still pursuing the purchase of the Union Block property, the site of the city's most historic district.

Depending on whom you ask, Linden's future either burns brightly or is one gust away from being extinguished.

"I'm very optimistic about the future of Linden," said City Councilor Ray Culbert. "I know we've lost a lot of businesses but we've replaced them. You have few vacancies downtown but the traffic is there."

Culbert cited the opening of Linden Mercantile and the ongoing operation of SweetDee's as signs of success downtown. Caretel Inns recently expanded. On the north end of the city, Culbert said businesses such as Companion Animal Hospital, Sloan's and the Alpine Marketplace plaza usually have full parking lots, another sign that businesses are surviving in Linden.

But the downtown business district in Linden is becoming an eyesore. The Linden Sweet Shoppe, Beirut Restaurant and Linden Pharmacy are all going out of business. The Linden Hotel, Subway and Coney Café have been hit up for back sewer fees, which may cost business owners thousands if enforced. Longtime business owners in the historic district of Linden feel city leaders do little to help them.

"The historic district is too restrictive on businesses," said Jack Furry, owner of the Linden Hotel. Along with the expensive sewer fees the city is attempting to impose, Furry cited the sign ordinance, which prohibits neon and backlit signs, as an additional hindrance for businesses downtown. "When you look at the surrounding businesses they do pretty good

but when you come downtown it seems like businesses can't thrive. They come and go."

In the 19 years Furry has operated within the city, numerous businesses have closed their doors after only a few years of operation. Furry has seen four city managers come and go during his years of operation.

In June, Linden Sweet Shoppe owners Chris and Laura Mathews were hit with a \$3,000 sewer fee. Laura said the sign ordinance hampered the Mathews' other business, The Linden Toy Factory, and was a factor in closing the business.

"You go three blocks down the road and you have businesses that have longevity," Furry said. "You have to wonder if there's something going on down here."

### Summary

►The City of Linden is in a situation much they were in six months ago when a new city manager must be hired and development downtown needs to move forward.

Culbert believes the Union Block property is the key to Linden's future and could possibly turn the city around.

"We need a signature business, one that would be a draw to the downtown area," Culbert said. "That's the most important initiative."

Despite the tough economic climate, Culbert views the present as the perfect time to entice a developer. Culbert said some businesses outside of the city have expressed interest in operating downtown, having approached him during the Farmers' Market in the summer.

"We're always seeking to draw business in," Culbert said. "A lot of times they just come in and knock on your door."

Will the inquiries from outside businesses transform Linden? Will a developer draw in a key business if the city purchases the Union Block? And when will the city have a new full-time city manager? These are all questions that will have to be answered in time. For existing businesses however, something has to change downtown.

mill (\$1 on each \$1,000 of taxable valuation). Superintendent Timothy Jalkanen said a resident with a home worth \$50,000 would pay roughly \$25 a year.

Per state law, proceeds from this bond cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.

### Holly Area Schools

Residents within the Holly school district will vote on a proposed renewal of the school district's 18-mill non-homestead millage. These 18 mills on non-homestead properties allow the district to receive the full state funding under the 1993-94 Proposal A constitutional change.

This proposal will allow the school district to levy the statutory rate of 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance and renews millage that will expire with the 2013 tax levy.

Superintendent Kent Barnes has said that the failure of this proposal would result in a loss of \$3.3 million to the district, and the state does not replace this funding. Failure to approve this proposal will not result in a decrease to the homeowners' taxes paid on the primary residence.

### Byron Area Schools

Residents within the Byron school district will be asked to vote on a renewal of the 18-mill non-resident property tax

levy. This levy applies only to industrial, commercial, business, rental, and second homes and does not affect the millage rate on owner-occupied primary residences.

This operating millage has been levied since 1994 on non-homestead property only and it is used for classroom instruction and programs and to operate the school district. It is not used for construction projects and it is not levied on residences, qualified agricultural property, industrial personal property or qualified forest property.

The millage would provide funds for operating purposes. The estimate of the revenue the school district will collect if the millage is approved and levied in 2012 is approximately \$740,000.

## Four candidates vie for Linden school board

► Voters will select two board members in upcoming election

Linden Community Schools may have a shakeup in leadership following the November General Election. Currently, a pair of six-year terms are up for grabs on the school board. Four candidates are in the running.

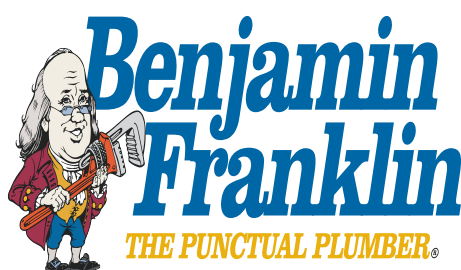

Life's Little Mysteries.com. What you are doing when an earworm strikes is also significant. Psychological studies show that usually a person is doing something somewhat routine or mindless when an earworm strikes.

While studies are currently underway as to the benefits of earworms on human emotions, no one seems to know yet how to get a song "unstuck" once it has mapped out a place in your brain.

This common phenomenon is just one example of the power that music has over our lives.

"Simple things can remind me of a song," said Brandon Maniez, 27, a Fenton area musician. "If I hear a certain tempo, it will pop a song right into my head. There are times when I create a song on my guitar, and it will take me back to prior times in my life."

Music and moods are closely related, according to ScienceDaily.com. Even if the music is an instrumental

## BAD HABITS

"Studies show that it is much easier to stay motivated when we have a very specific end point in mind, and can know at any moment exactly how far we still have to go.

Any habit can be broken down into three main parts — referred to as the habit loop. These parts are the cue, the routine, and the reward.

The cue is the situation you find yourself in that triggers your habit. The routine is the action you take that is caused by the cue, and the behavior that you will want to change. The reward then is the desire that is satisfied by completing your habit.

The problem with habits, and why they are so hard to break, is because as the cycle continues, it becomes more automatic and ingrained within you, and then harder and harder to change.

The first part to breaking a bad habit requires you to be introspective and to identify the cue-routine-reward loop that you are stuck in. Determine first what specifically the habit that you want to break is. With that in mind, determine what the cue for that habit is — do you

do it at a certain time, at a certain place, or around certain people?

Once you have identified your cue and routine, figure out what your reward is. Are you eating that candy bar because you are hungry, or to satisfy a craving for sweets?

The second part is to look at your habit loop and make a plan to change it.

Try out different rewards for your habit. Try replacing an unhealthy treat that you enjoy with something healthier that you also enjoy. Alternatively, you can try to alter your cues. If you cannot help but order a milk shake with your hamburger, try eating somewhere else entirely.

Once you understand how habits may be formed unintentionally, you can use the system to try and form new good habits for yourself. Determine what you want to make in a habit, create a cue for the habit and determine a way in which it can reward you.

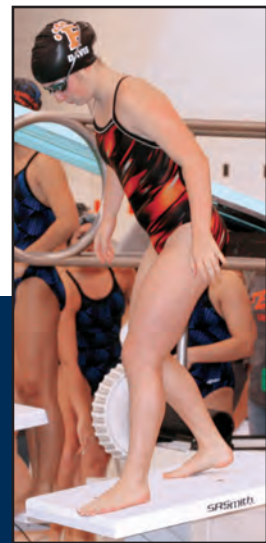

## Holly forfeits boys tennis Metro title

The Holly varsity boys tennis team aren't 2012 Metro League champions anymore.

In a statement released Wednesday afternoon by Holly's Director of Athletics, Deb VanKuiken, the team has issued "official notice of our forfeiture of the 2012 boys' tennis championship held on Oct. 2 at Kearsley High School."

Ironically, the self-induced forfeit involves a player who never competed on the court at the Flint Metro League tourney. Based on the MHSAA's Protocol for Implementation of National Federation Sports Playing Rules for Concussions, the Bronchos' top-seeded No. 2 singles player needed to be cleared for a possible concussion before competing. In the team's attempt to give the player as long as needed to provide the documentation, the player remained in the lineup. When that documentation didn't arrive, Holly co-coach Brennan Brown forfeited his No. 2 singles match, eliminating the player from the tournament without ever stepping on the court. However, based on his top-seed position and the fact there wasn't an eighth seed, without competing, the player recorded a point to his team score. It created the question when one is actually competing in a meet.

## Tigers taking nothing for granted, defeat Lapeer in final Metro dual

**Fenton** — Ever since girls swimming became a championship competitive sport in the Flint Metro League, the Fenton varsity girls swim team has been the unquestioned dominant power.

Some of that tradition took a minor hit recently when the Tigers appeared to have lost the team's first Metro League dual meet ever, when Brandon appeared to have outscored the Tigers. ## GAME #1 Giants 8, Tigers 3

Here are some quick thoughts and facts about the Detroit Tigers' 8-3 loss in Game #1 of the World Series against the San Francisco Giants.

### Verlander not so special in the World Series

If Detroit Tigers' ace hurler Justin Verlander has any questions he must answer to critics, it would involve his performances in the World Series. After an outstanding start to the postseason, Verlander put together one of his worst starts of the entire season, allowing five runs in just four innings of work. He faced just 19 batters, allowing six hits including two home runs. He wasn't very special in the 2006 World Series either. In his three WS starts, Verlander holds an 0-3 record with an earned run average of 7.20.

### Pablo Sandoval's home runs

The Giants' third baseman's three home runs in game one tied him for a World Series record for most home runs in a game with

Babe Ruth (1926 and 1928), Reggie Jackson (1977) and Albert Pujols (2011). He's not too far from at least tying the record for most four-baggers in an entire World Series. The record is five home runs. Jackson (1977) and the Philadelphia Phillies' Chase Utley (2009) each had five home runs in what were both six-game series.

### Zito does better the second time against the Tigers

Oakland's starting pitcher Barry Zito allowed just one run in 5 2/3 innings of work against the Tigers' lineup. It was a strong performance. It may help Zito forget his first postseason start against the Tigers. Zito was the starting pitcher for the Oakland Athletics in game one of the 2006 American League Championship Series and he was shelled for five runs in just 3 2/3 innings of work.

### Tigers' defense not so bad

While one can argue the Tigers' defense struggles with range, one thing Detroit's defense has done is handle the balls they do get to this postseason. Monday's game was the fourth out of five postseason games in which the Tigers didn't commit an error.

### Young's bat remains hot

Detroit's Delmon Young was named the Most Valuable Player during the American League Championship Series, batting .353 with two home runs. He remained hot, going 2-for-4. That said, he did hit into a double play as well.

Here is a look at the Tigers' 2-0 loss to the San Francisco Giants in Game #2 of the World Series on Thursday night.

### Fielder out at the plate

With no out in the second inning and Prince Fielder on first base, Delmon Young hit a double down the left-field line. Young was waved in and was thrown out at the plate on a perfect relay throw. The question is, should he been sent home or held at third? Baseball wisdom says not to have the first out of an inning occur at the plate. However, statistically there may have been some merit in the decision. Fielder had eight times this season when he was held at third after a double and never scored.

### Blown opportunities

It wasn't like the Tigers had many great chances to score runs in the second game, but when they did, they failed to score. Bumgarner has tossed 15 innings of shutout ball in his only World Series performances. What is the longest streak of shutout innings a pitcher has had to start their World Series career? Christy Mathewson didn't allow a run in the first 28 innings he pitched in the World Series.

### Starting 0-2 in a World Series

The last team to win a World Series after losing the first two games was the 1996 New York Yankees against the Atlanta Braves. The last team to lose the first two games on the road and come back to win the World Series was the 1981 Los Angeles Dodgers against the Yankees.

Sports Playing Rules for Concussions, "Any athlete who exhibits signs, symptoms, or behaviors consistent with a concussion shall be immediately removed from the contest and shall not return to play until cleared by an appropriate health professional." Based on her contact with the MHSAA, VanKuiken said the Bronchos violated MHSAA regulations, and the self-imposed forfeit became reality.

"It was brought to our attention we may have violated the return to play protocol. And when I followed up with the MHSAA, initially I thought we might have to forfeit that flight," VanKuiken said. "However, the entire MHSAA staff reviewed it during their staff meeting the following week and came to the conclusion that we had violated the rule. Therefore, in our quest to uphold the MHSAA regulations we agreed to abide by, we self-report and forfeit the tournament."

Brown said he wanted to give a senior player every opportunity to compete in his last Metro League meet.

"We believe we complied with both the letter of the policy and the spirit of the policy," Brown said.

"He is our only senior captain on the team and we wanted to give him and his parents every opportunity to get that doctor's note to clear him to play or default that flight. Because we didn't have a doctor's note clearing him to play, we did the right and honorable thing and did not play him. We defaulted him. We put the health and well being of our student-athlete first."

Ironically, the player, who is on the varsity soccer team, competed in more than half of a Holly's soccer contest a couple of days after the decision not to play him at the Metro meet.

"At the time of the tournament we believed he had a concussion and that's why we removed him," VanKuiken said.

The forfeiture means Holly's 20 straight seasons of Metro League titles are reduced to "just" 19. The forfeit also means Holly has fallen to fourth in the final Metro League standings and means Fenton is now recognized as the Metro champion because of its 5-1 regular season mark and second-place showing at the league meet. Brown and VanKuiken say they plan on appealing the forfeit through the MHSAA. A decision could come in early November.

If the Bronchos forfeited the flight, Holly would've still easily won the meet. Entering the meet, most thought it was a foregone conclusion the Bronchos would win their 20th straight league title because they had convincingly crushed every Metro foe during the dual season. The Bronchos served no real competitive edge by fielding a No. 2 singles competitor, winning the meet by an overwhelming 12 points. Brown said he doesn't regret his decision.

"We are proud we gave him every opportunity to participate in our Flint Metro League tournament because he's family to us," Brown said. "We'd do it again."

"The spirit of the rule has to be the protection of the student-athlete, and we most assuredly followed that because he never played."

"It was a perfect storm," VanKuiken said. "We had a seeded player who drew a bye because Lapeer West did not have a team this year. I don't know if because he advanced and we earned a point mattered. I don't know. But it happened. We were protecting our player and didn't play him. ... I believe the policy is to keep athletes safe, and at no point in time did we jeopardize the student-athlete's safety."

it and we did it."

The Tigers may have saved their best Metro match of the season for the last one as well, as the Tigers were efficient with their digs, service reception, sets and kills all night long. The fluent and efficient work was most evident with the attacking numbers. Fenton experienced a sizzling 37.6 hitting percentage, collecting 50 kills in the three games. Meanwhile, Lapeer West had just 16 kills and collected seven hitting errors in the process. But it all started with the defense and the service reception. The Tigers had no service reception errors during the contest, and were led by Megan Cockin, Maxheimer and Jaime Hansen in that venture.

The only game that really was competitive was the first one, but the Tigers made very few errors in it, eventually pulling away from the Panthers. With Fenton leading just 15-12, the Tigers scored seven of the next eight points. And most of the Fenton points were recorded with strong offense. Maxheimer had three kills during the juncture, while Cassidy Rourke, Bobbie Eastman and Martin also had kills during the run, leading the Tigers to a 22-13 lead.

The final two games were never seriously competitive. West wilted against the Tigers' pressure, collecting just three kills and five hitting errors in the second game. 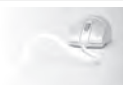

and flanked by tall piles of loose plastic and paper. Tall 30-yard dumpsters form a maze around the facility. Small Bobcat fork trucks push bales into piles to be shipped later.

"We're cleaning up the city," said Dion Telorick, of Grand Blanc, while on morning break. Workers start every day at 5 a.m.

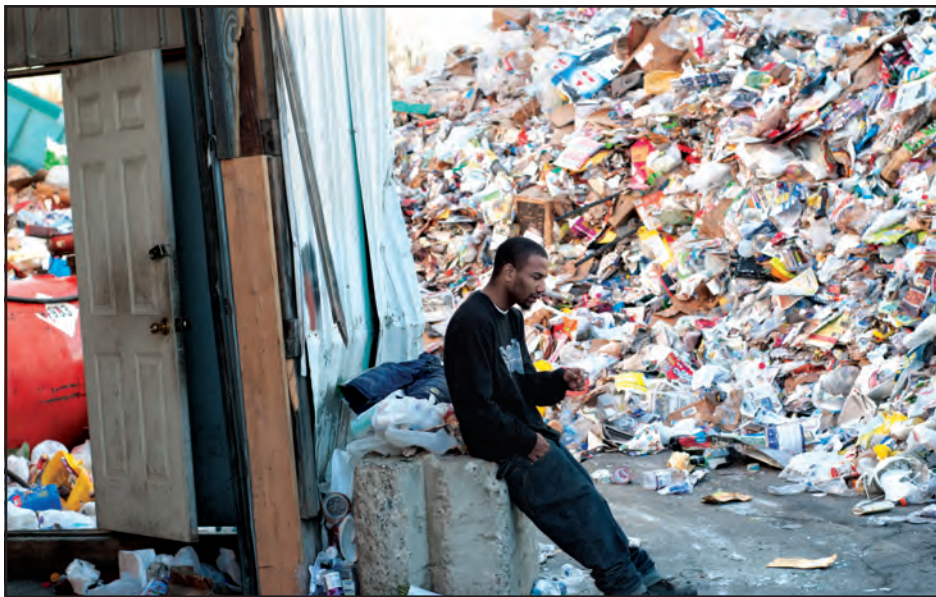
The balmy climate is better this time of year for yard and line workers. The winter is "cold and slippery," said yard worker Michelle Smetana.

This is where curbside consumer recyclables end up. Once a bin is picked up by the recycling truck, the materials are eventually moved onto a conveyor belt, and hand sorted by the 15 or so people. Averill Recycling also sorts 15 to 18 trucks per day, processing around 100,000 pounds, said Boyt Johnson, president.

Different paper types are sorted into their specific bins and are eventually crammed into 1,200-pound bales.

The material ends up being sent to the corresponding mill for the specific material. According to the Institute of Scrap Recycling Industries (ISRI), the recovery rate for paper was nearly 65 percent in 2010, valued at \$8.9 billion. These recovered fibers end up being new newspaper and packaging and 77 percent of materials come from recycled sources. The going rate for newspaper and cardboard is \$1 per 100 pounds.

No matter the material, it is sorted into its

type, and baled together.

Johnson ships the materials once they reach 40,000 pounds. He sends them to wherever he can get the most money. This could be the Midwest or around the world. "If it's \$10 more a ton, I'm going to sell it for \$10 more, it doesn't matter the location," he said. Some prices, like paper, are better in China than the U.S.

According to the ISRI, plastics recycling

grew 9 percent steadily from 1950 to 2009.

Plastics made from recycled material are far more energy efficient than producing "virgin" plastic. Recycled plastics end up being used for imitation wood, the sprocket of a wheel, or in various appliances around the home.

Johnson recycles many things, but not glass. "It's a hazardous thing," he said. "We have people sorting on a conveyor. With glass

you get cut very often." Not only can people get cut, they also may not know what they can be infected with. After all the sorting, packaging and shipping, he would only get around \$8 a ton.

His favorite part of business is 4:30 p.m. With a laugh he said quickly, "No, I enjoy this business, it's a daily challenge. It's much harder to make a dollar than it ever has been."

His costs are higher, while the profits are slimming, a common problem today. His business is easy to explain, but tough to stay in.

Recyclers are licensed through the U.S. Department of Environmental Quality annually.

Johnson said the business changes with the economy and with the ups and downs of production. "I think we lost 80,000 families from this county in the last 10 years," he said. This means fewer people recycling and less volume.

The business must sort and package to the specifications of the "end user," the person buying the materials in bulk, said Boyt Johnson Jr, vice president and son of Boyt Johnson. Some buyers might allow 5 percent contaminants or other materials amongst their cardboard, while others may be more flexible.

"It's not a perfect science," he said. As the industry fluctuates, the end user may tighten their standards or lower prices to the point where there is no profit in sending the materials. "It's poker game," he said. "It's very interesting, you don't go to college and get a degree in recycling." It's an expensive business to be in, with labor and equipment. Environmentally, it may be a wash with heavy equipment running to move materials.

"It's very questionable where the industry is going to go," he said, adding that a mandatory recycling law could be in the future. "Our landfills can only handle so much material."

a reserve and has lived in the Linden school district for the past 11 years.

**Q:** My wife hit curb with right tire in our 2005 Ford Taurus. The tire is rubbing on fender well, the steering is pulling hard left, and it makes a grinding sound. I put my spare on because I thought the rim was bent, but the steering is pulling still. The grinding tire doesn't rub, but squeals when turning opposite from the pull.

**A:** Robert, This sounds like you have a bent steering and or suspension part that will need to be looked at on a hoist and replaced or straightened if possible. After that you will need to get a wheel alignment to confirm that everything is running true again and not causing any tire wear or steering issues that could make your vehicle unsafe to drive.

necessary one. Whether you acknowledge it, you will die. You will leave behind family members, friends and communities you were a part of. And oddly enough, your body will be there but you won't.

"The funeral is for the living," Sharp said, adding that all people, no matter their religious beliefs, need emotional support from time to time. "People don't understand the importance of community support or family support until they have a funeral."

So how does one broach the subject of their funeral with family members? Sharp recommends sitting down with your loved ones and discussing what your wishes are. Express whether you want to be buried in a casket or cremated. Do you want a religious ceremony or a contemporary one? Write down the details — flowers you want, videos to be played, items next to your casket and the exact spot where you want to be buried. From there, take your plans to a funeral home, discuss your budget and review your options.

The sooner funeral arrangements are made, the easier it is for families to talk openly about death.

"I didn't know you could laugh while you were planning your own funeral," said Cheryl Marshall, an employee of Sharp Funeral Homes. Marshall said early planning removes the emotional duress of death, allowing people to even have fun discussing death.

Just like most things in life, dying isn't cheap. A traditional funeral costs roughly \$6,000 to \$7,000 or more, depending on what you want included in your funeral. Payment can be one time or set up monthly or quarterly. Some funeral homes will freeze the price of a funeral once it is paid in full so families

do not have to pay extra in the future. For example, someone who pays \$10,000 for a funeral this year but dies 15 years from now won't have to pay extra, even if costs have increased.

"This generation now, the generation of young people coming up, don't really have that promise of having things better than their parents did," Marshall said. "For someone not to plan in advance, it may leave their family with expenses they're likely not going to be able to absorb."

Gordy Dryer of Dryer's Funeral Home in Holly finds that people are more comfortable planning their funeral after speaking with their family members.

Becca Temrowski of Temrowski Funeral Homes in Fenton said funeral arrangements should be reviewed yearly in case your life has changed and you need to make adjustments. Planning ahead of time with loved ones will give them peace of mind, Temrowski said, even if they feel uncomfortable about death.

"It's something you can do and check off your list and continue living your life," Temrowski said.

by probate courts and redistributed by the state. It's a process that Fenton lawyer Sharon Miner said isn't as bad as most people believe but it does limit your total options. Wills and trusts are other options that can spell out who your beneficiaries are and where your assets will go.

"Settling an estate is a process that doesn't happen in one day," Miner said. "There are things beneficiaries may want to do. The thing they don't want to do is give out money and find out there are payments they may need to make."

Before going to the beneficiary, taxes or payments to creditors must be paid out from a person's assets. In Miner's experience, most beneficiaries are children or grandchildren of the deceased.

Miner said a will or trust should be set up once someone is married or

acquires a large asset such as a house. Wills and trusts should be revisited if there are any major life changes such as a divorce, heart attack, death or birth of family members.

Beneficiaries can be added to accounts such as IRAs and savings accounts Miner said, as long as account owners speak with their banks or lending institutions.

Even with a will or trust however, your assets will pass through the probate court.

"Think of it as two parallel lines. A will tells probate what to do with your assets," Miner said. "A trust is another parallel line that controls your assets during your lifetime and also says how to distribute them after you pass."

According to CNN Money, trusts do not replace wills. Most trusts deal with specific assets such as real estate or saved income. A will takes care of other assets not covered by a trust.

# LEGENDS OF A FULL MOON

**Watch for the next full moon on Monday, Oct. 29, 2012.**

The full moon occurs when the Moon lies on the opposite side of Earth from the Sun. The moon as seen from the surface of the earth is fully illuminated by the sun at this time.

There are many legends and myths associated with the full moon. The full moon is said to give off an energy that makes it the best time for predicting the future or fortune telling. It is also rumored that the full moon can have a positive effect on a woman's ability to conceive. Some even say that there are more births during a full moon. Pet injuries increase significantly during the full moon. The moon is said to influence the behavior of humans making them more violent and aggressive (aka the "Lunar Effect," hence the term lunatic).



## Who owns the moon?

Although Luna landers scattered pennants of the Soviet Union on the Moon, and U.S. flags were symbolically planted at their landing sites by the Apollo astronauts, no nation currently claims ownership of any part of the Moon's surface. Russia and the U.S. are party to the 1967 Outer Space Treaty, which defines the Moon and all outer space as the "province of all mankind." This treaty also restricts the use of the Moon to peaceful purposes, explicitly banning military installations and weapons of mass destruction.

## Facts about THE MOON

### Eclipse every full moon?

A full moon is the only time when a lunar eclipse is possible. However, because of the tilt of the moon's orbit around the earth relative to the earth's orbit around the sun, the moon may pass above or below the shadow, so a lunar eclipse does not occur at every full moon.

### Leave only footprints

The Moon's surface is about the same now as it was 3 billion years ago. The astronauts' footprints remain unchanged on the Moon's surface.

### Flags still there

The flags placed during the Apollo 12, Apollo 16, and Apollo 17 missions were still standing as of 2012. The flag for the Apollo 11 mission was blown over during lift-off. It is believed that the colors on the flags have turned white due to sunlight and space radiation.

### Calculating Easter date

Easter is the first Sunday after the first Saturday after the first full moon after the equinox.

### Not the brightest

The Moon lights up the sky nightly, but only about 7 percent of sunlight that hits the Moon is reflected. The brightest parts of the Moon are still only about 30 percent reflective.

## Oddest facts about the first moon landing

► After placing his left foot on the lunar surface, Neil Armstrong meant to say: "That's one small step for a man, one giant leap for mankind." He later apologized for fluffing the line by leaving out the "a." But some experts think he did say the "a" and was let down by the relatively primitive recording technology of the time.

► **Buzz Aldrin's first action on the moon was to have a pee. The astronauts' spacesuits were each fitted with a pipe for urinating into, which they could later empty into a waste disposal unit on the lunar module.**

► Armstrong and Aldrin made late adjustments to their landing spot on the moon, coming within 20 seconds of running out of fuel. Ground control in Houston told them: "You got a bunch of guys about to turn blue here."

► The schedule called for a five-hour break before Armstrong stepped on to the moon — but he couldn't wait and successfully asked Houston to bring forward the schedule.

► One reason for Armstrong being first on the moon was that the Eagle's hatch opened inward and to the right, blocking Aldrin until Armstrong got out.

► There is no atmosphere on the moon, so how come the U.S. flag was shown "flying" there after the Apollo 11 crew installed it? Simple — it was stiffened with wire to give the appearance it was flying.

► Assassinated U.S. President John F. Kennedy had in 1961 set a target for landing an American safely on the moon before the decade was out. As Armstrong and Aldrin walked on the moon, a note was placed on his grave. It read: "Mr President, the Eagle has landed."

► **The U.S. flag on the moon was blown over by the Eagle's take-off, prompting later missions to plant their flags farther from the landing module.**

► The Apollo 11 astronauts were travelling at 25,000 mph when they re-entered Earth's atmosphere — eight times faster than a rifle bullet.

► **When back on Earth, they had to fill out U.S. Customs forms. They listed their departure point as Moon, their arrival point as Honolulu and their cargo as samples of moon rock and moon dust.**

► They spent their first three weeks back home in quarantine just in case they had picked up unknown germs.

More Nobel Peace Prize winners claim Switzerland as their home country and Switzerland boasts the highest consumption of chocolate of anywhere in the world.

Local chocolatier Carol Schuler doesn't think that's just a coincidence.

Owner of Sweet Variations in downtown Fenton for 31 years, Schuler's convinced that chocolate is really good for one's health, and she works hard every day to put chocolate in the reach of all tri-county area residents.

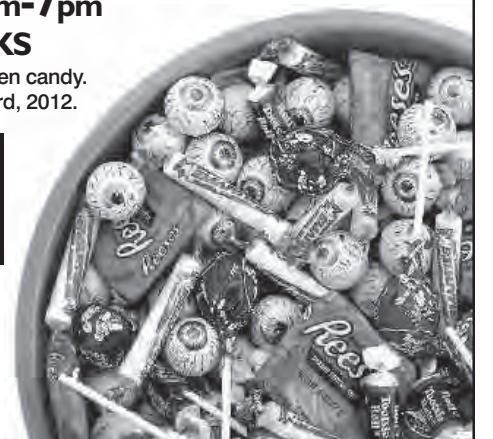

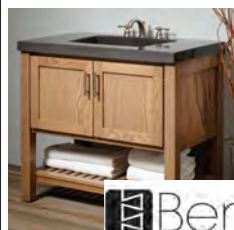

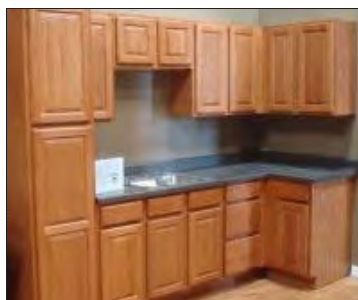

**DEAR DR. DONOHUE:** My entire family has lice. I am starting a support group for families who have had to experience this awful invasion of their scalps. I have reached the breaking point. Give me a plan for treatment and a timetable for their eradication from our home. — Name Withheld Lest Neighbors Find Out

**ANSWER:** One of nature's smallest creatures, the head louse upsets domestic tranquility with more revulsion than most health-endangering illnesses. Head lice bring no disease with them. They are tiny, only 3 millimeters (1/10 inch) in length. They feed on blood and die within a day or two off the scalp. After feeding, lice have a reddish-brown hue. The mother louse glues louse eggs to hair, and those structures are called nits. They are only 1 millimeter (4/100 inch) long. The eggs hatch in six to 10 days. If nits are more than a quarter of an inch from the scalp, the baby louse has already hatched, and the nit is no longer a problem. In an average life span of three months, the mother louse can lay up to 300 eggs.

Lice are not an indication of poor hygiene. Most of the time, they're introduced into a family by a child who caught them at school. They can infest other family members quickly. Transmission comes from direct contact with an infested individual and, less often, from contact with inanimate objects used by that individual, like hats, combs, brushes and bedding. You're not alone. Six to 12 million Americans come down with head lice yearly.

Almost all people with head lice have intense scalp itching. A number of methods effectively rid you of the problem. The first medicines used are permethrin (Nix) or pyrethrins (Rid), which are cheap and usually effective, although lice are becoming resistant to them in some locations. A second treatment is given seven to 10 days after the first. Ovide (malathion) is used if lice linger after Nix or Rid. And should Ovide not work, the oral medicine Stromectol (ivermectin) is available. A new medicine is Natroba (spinosad) suspension. It is held in reserve as a last resort. This nightmare should be over in two to three weeks.

## HOW TO: mess-free painting

**Pimple pads soften latex paint**  
Facial cleansing wipes aren't just for pimple prevention. The alcohol in them softens latex paint, but won't harm most surfaces (test first to make sure). They work best on paint that's been dry just a few hours.

**Long reach paint pad keeps tight spots neat.**  
If you have a tight spot to paint, remove the pad from a paint edging tool (about \$2 at home centers). Hot-glue the pad to a stir stick, and you've got a painting tool that will fit behind toilet tanks and radiators.

**Coat hanger catches excess paint**  
Cut the bottom section from a stiff wire coat hanger and bend it so each end straddles the rim to fit inside a paint can. Let the wire overlap the sides and tape it to the can to keep it steady when you rub off the excess paint. When the job's finished, remove the wire and wipe it clean to be ready for next time.

**A little heat for old tape**  
Sometimes, masking tape that's been sitting on a shelf for years won't pull off the roll without tearing. Freshen it by microwaving it for 10 seconds. Heat softens the adhesive for easy release.

# Southwestern Salmon Caesar Salad

**Dressing**

- 1/4 cup light mayo
- 1/4 cup grated Parmesan cheese
- 2 T. fat-free buttermilk
- 1 T. lemon juice
- 2 T. water
- 1/2 t. freshly ground pepper
- 1/2 t. Dijon mustard
- 1 clove garlic, minced
- 2 anchovy fillets, chopped

**Salad**

- 4 salmon fillets (6-ounce)
- 1/4 t. smoked paprika
- 1/2 t. chipotle chile powder
- salt and pepper
- olive oil
- 8 cups chopped Romaine lettuce
- 1 cup frozen corn kernels, cooked
- 1/2 cup canned black beans, rinsed and drained
- 1 Roma tomato, diced
- 2 T. chopped cilantro
- 1 t. minced chipotle chili in adobo sauce
- salt
- chipotle cheddar tortilla strips

**Directions:**

1. To make dressing, combine all dressing ingredients in a mini food processor or blender. Pulse until well blended. Cover and chill at least 1 hour.
2. For fish, sprinkle fish with paprika, chipotle chili powder, salt and pepper, and drizzle with olive oil.
3. Heat a grill pan or nonstick skillet over medium-high heat. Add fish spiced side down and cook 4 minutes. Turn fish over and continue to cook another 4 minutes, or until done.
4. In a medium bowl, combine corn kernels, black beans, diced tomato, cilantro, and chipotle pepper in adobo sauce. Season to taste with salt.
5. Mix together lettuce and corn mixture in a large bowl. Drizzle with dressing, place salmon on top, and sprinkle with tortilla strips.
6. Yield: 4 servings

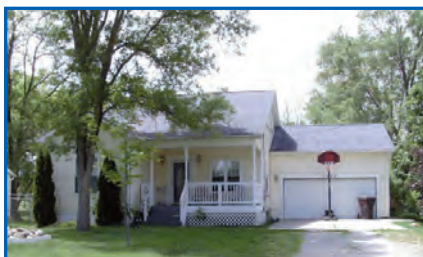
