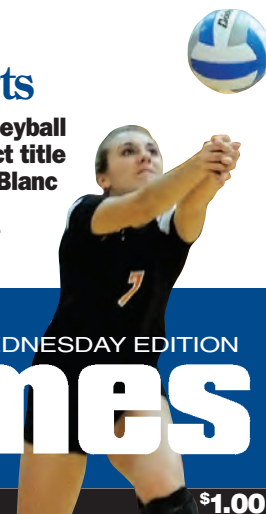

Voters say ‘NO’ to all six proposals

Proposal 1 would have allowed for the Emergency Manager Law, while Proposals 2 through 6, which, had they been approved by voters, would have amended the state constitution. As of 11:20 p.m., the Secretary of State’s office reported that all six of the statewide proposals were defeated by voters. Here’s a rundown of how each proposal worked out. Volunteers have already spent time collecting money at The State Bank and VG's, and they have managed to raise more than \$3,300. Volunteers will also be collecting money at the corners of Adelaide Street and

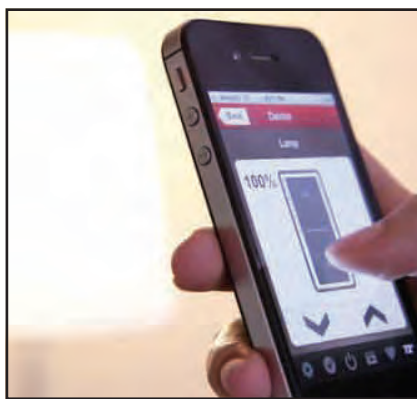

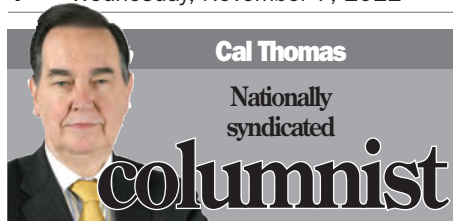

**Hidden side of Obama's race gap**

In his 2008 'More Perfect Union' speech, presidential candidate Barack Obama declared, 'Race is an issue that I believe this nation cannot afford to ignore right now.' Then he tried his best to ignore it.

At least in public, that is. It says a lot about the trickiness of being the nation's first black or, if you prefer, biracial president that Obama noticeably avoided saying much about race or racism before that speech, which he delivered to calm the furor over his former pastor the Rev. Jeremiah Wright's taped 'God Damn America' remarks.

And he has measurably avoided addressing the issue ever since. Obama talked less about race in his first two years in office than any other Democratic president since 1961.

That's politics. When your biggest asset is your lack of scariness, your opponents will focus on making you more scary.

That may at least partially explain why after four years in office, President Obama remains popular with every historically underserved minority but the largest one: white men without college degrees.

He's not alone. Most white male voters, particularly without degrees, have been turning away from the Democratic Party since the mid-1960s civil rights era. But polls since midsummer found Obama's white support has sunk from surprisingly high four years ago to historic lows.

A later National Journal study found Obama's level of support among white men to be lower than any Democratic nominee since Ronald Reagan beat President Jimmy Carter in 1980.

Yet I believe that those who attribute that race-gender gap to white racism are as dangerously unfair and overly simplistic as those who attribute the 95 percent support that black voters gave to Obama to black racism.

Why, my fellow liberals often ask, do working class voters so often vote for the class that pushes tax cuts for the wealthy? The short answer: Money isn't everything. Nothing connects quite like shared culture to persuade voters that, despite other appearances, you're really on their side.

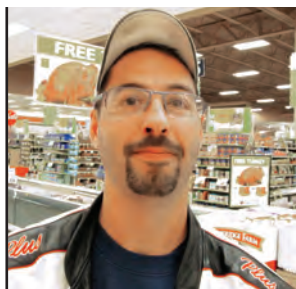

Veterans Day events set for Sunday

►Monday will be the official holiday with government offices, post offices closed

Veterans Day, observed this Sunday, Nov. 11, was originally set as a U.S. legal holiday to honor the end of World War I, which officially took place on Nov. 11, 1918.

Summary

►Local Veterans Day observances will be held throughout the tri-county area on Sunday, Nov. 11. Federal government offices are closed on Monday, Nov. 12 to observe Veterans Day.

After several legislative, date and name changes throughout the years, Veterans Day became the official name of the holiday to honor American veterans of all wars, beginning in 1978.

If the Nov. 11 holiday falls on a Saturday or Sunday, as it does this year, the holiday is observed by the federal government on Monday (if the holiday falls on Sunday) or on the preceding Friday (if the holiday falls on Saturday), according to military.com.

• Great Lakes National Cemetery will conduct its ceremony on Nov. 11 at 11 a.m. Keynote speaker, patriotic music, presentation of colors, rifle salute, taps, wreath presentation and flyover are the planned events. The cemetery is located at 4200 Belford Rd.

Voters pack polls at 7 a.m.

Holly — A steady stream of people had already gathered by 7 a.m. at Holly High School. Instead of tired-eyed students however, people from all over Holly gathered to exercise one of our country's most cherished freedoms: the right to vote.

Roughly 200 people from four different precincts waited in line to cast their ballot. Amongst showing identification, filling out a ballot application and casting a ballot, voting took about an

hour. By 8 a.m. the lines had died down to where voters had virtually no wait time to get their ballot.

Kevin Alexander, 23, recalled when then presidential candidate Bill Clinton visited his Michigan high school. For Alexander, the experience reinforced the importance of voting during the election.

"I was a little overwhelmed, there were an awful lot of people, that's for sure," Alexander said, who voted when the polls opened.

In addition to the presidential election, voters in Michigan had the opportunity to decide upon six ballot proposals that ranged from emergency managers to collective bargaining rights. For many voters, the ballot language was somewhat unclear and required outside research before reaching the polls.

"There's a lot of confusion. There was a lot of information thrown at me about the proposals," Alexander said, who studied up on what a 'yes' or 'no' vote meant for every proposal. "This is definitely an important election."

Mindy Creger, 34, arrived to vote at 7:45 a.m. and felt the process was very efficient and went smoothly. Creger also researched to ballot proposals before heading to the polls.

"I felt pretty informed," Creger said. "I think the presidential election will be close."

The Electoral College

As we all know yesterday was Election Day. I trust that all of the votes have been counted and that preliminary results have been announced in all candidate races and as to the various state and local proposals.

Of course, this includes the presidential and vice-presidential election and even though a winner may now have been declared, it must be remembered that the process of holding the final election and official declaration of the winners for the offices of president and vice-president will actually not be completed until Jan. 6, 2013.

Under our United States Constitution, the president and vice president are selected not by the direct vote of the people, but instead by the Electoral College, which was first established under Article II Section I of the Constitution, which was then amended by the 12th Amendment.

To say it is a rather complicated process would be accurate but some basic highlights are as follows.

On Nov. 6, the electors are chosen from each state to serve in the Electoral College. Each state is allowed the total number of its senators and representatives in Congress. So for example, Michigan having two senators (as do all other states) and 14 representatives has 16 electors.

On Dec. 17, 2012, the electors meet in each state to vote for the presidential and vice presidential candidates who they were chosen to vote for on Nov. 6.

The votes are then sent by state officials to the president of the Senate, the archivist of the United States and other designated federal and state officials who must have the electoral votes in hand by the Dec. 26, 2012 deadline.

On Jan. 6, 2013, the United States Congress meets in joint session to count the electoral votes and the winners are officially declared.

For now, this is the method we have, and the Electoral College has been existence for more than 200 years.

Although there have been criticisms of the process it appears that on balance our founding fathers devised a workable election system.

active ingredients in the products you're comparing,” said Joe Starrs, registered pharmacist at VG's Grocery on SilverParkway in Fenton. “All the ingredients have been approved by the FDA (U.S.

Food and Drug Administration), but each brand may have different combinations.”

When comparing a bottle of NyQuil and a bottle of Top Care Nite Time Cold and Flu, the active ingredients are exactly the same — acetaminophen for pain relief and fever reduction, dextromethorphan for cough suppressant and doxylamine succinate as an antihistamine.

However, the inactive ingredients — the flavoring and coloring agents, water, citric acid, etc. — vary slightly in order of ingredients. “In most cases, these differences are insignificant when it comes to how they will treat your symptoms,” said Starrs.

He also said that taking a liquid medicine will be quicker to respond to symptoms than tablets, because they

• **An antihistamine** such as brand names Claritin, Allegra or Zyrtec. Generics with the same active ingredients are typically a less expensive alternative.

• **An antihistamine** plus decongestant (any of the above with a “D” added). Make sure they are non-sedating so you can use them during the day.

• **Throat lozenges** like Hall's to ease symptoms of post nasal drip.

don't have to dissolve.

When it comes to using products like Airborne and Emergen-C to prevent colds from happening in the first place, Starrs said, “Anytime you can boost your immune system, you have a better chance or warding off a cold.” Airborne is a vitamin supplement that advertises it boosts a person's immune system, while not making any other health claims that it reduces cold symptoms or actually prevents colds. Emergen-C's major claim is its 1000 mg. of Vitamin C, which has been proven to fight off colds.

Still, the old-fashioned remedies for preventing or suppressing cold symptoms still hold true, according to Starrs. “Learn-

ing how to cough correctly is very important,” he said. “Cough into your shoulder, not into your hand. Wash your hands anytime you've used someone's phone or computer.”

If you're unlucky enough to have gotten a cold, he suggests that you keep yourself well hydrated, using products that contain electrolytes if you're really sick.

How do you know if you've got just a simple cold or a more serious flu? “If it's the flu, you might be running a fever, have body aches, a dry cough and generally a run-down feeling,” said Starrs. “Your best prevention against the flu is getting a flu shot.”

Monday's Fenton City Council work session, the small, 80-word amendment to the city's ordinances was presented to the city council with positive feedback.

The ordinance amendment would prohibit personal ice rinks in a front yard. A 4-foot setback would be required from adjacent property lines and ice rink boards would be restricted to 2-feet in height or lower. The amendment would also not allow rinks to be set up before Nov. 15 and removed no later than March 15.

Councilman Patricia Lockwood was in favor of the ordinance amendment. "I think it's a very good amendment. I like the fact that it's not so extensive that you have pages and pages of an ordinance," she said.

Councilman Benjamin Smith described the ordinance as short and sweet, and working well with the city's other ordinances. "It's right to the point, and that's the way it should be. We don't want to take away the kid's entertainment, but

on the same note I would have a fit if someone in my neighborhood had an ice rink in their front yard."

Smith went on to say that he doesn't expect there to be a lot of issues with the ordinance. "I think if we have two ice rinks in the city, we are going to be the ice rink capital of Michigan. I don't think it is as big of an issue as people think it will be," he said.

Fenton resident Bob Campbell, who had spoken out earlier this year about his neighbor's ice rink, attended the work session meeting, and spoke in favor of the ordinance.

"As a board member of a local homeowners association and one that might be asked to consider a similar such request, I think the ordinance provides a reasonable and sufficient guidelines for the location, maintenance and operation of personal ice rinks for neighborhoods like the one I live in," Campbell said.

A public hearing for the ordinance will be set during the planning commission meeting on Nov. 29.

The app is available for both android phones and iPhones. The first year of the app is free, but then has an annual fee of \$20.

Your home

Have you ever been reading a book in bed and found yourself not wanting to get up to turn off the lights when you are drifting to sleep? Or maybe you have left your house and can't recall if you turned off the lights. Both near and far away, the Lightswitch app can let you control different functions of your house. Lightswitch works in conjunction with home automation software to remotely control your household lights as well as your thermostat.

The Lightswitch app costs \$10 and runs on both android and iPhones. House automation kits can vary greatly in price depending on how much you wish to hook up — from \$30 for light switches on up to the hundreds.

A new device called the Lockitron can be preordered online for \$150. This device can be installed on your current home locks, allowing your home to be unlocked by your smartphone. Instead of giving keys to family members, you can allow their smartphones to unlock the door as well.

Your security cameras

If you have security cameras set up at your home, there may come a time when you want to check them at a moment's notice. With the iCam app, as long as you have your smartphone with you, are never more than a few taps away.

The app can be picked up on both android and iPhones for \$5. To get the app to work you will also need to install some simple software on the computer that you have your security cameras hooked up to.

Your computer

You don't have to control your computer with just a keyboard and mouse. Now you can do so with your smartphone. If you have your computer set up as a media center to play music or to watch television on, your phone can use the HippoRemote app to control your computer from anywhere you are — though it helps if you can actually see your monitor. The app has two versions available, a basic version for free, as well as a full-featured version for \$5.

If you are far away from your computer and want to access it, you can check out the Remote HD app, which is also available on iPhones for \$8. The app will allow you to view your computer's desktop and take control of your computer from anywhere you have a phone signal.

Deputy Clerk Kirsty Beelby expected about 4,700 voters in Holly to cast a ballot for the 2012 election, up from 4,500 voters in the 2008 election. Election workers also received about 1,400 of the 1,649 absentee ballots sent out. Beelby believes more voters are turning out for this election because “people want change.”

“It’s great that people are coming out to vote,” Beelby said, noting that a lot of younger people are showing up at the polls as well. “More people will show up after lunch and before and after dinner time.”

Beelby said 7 a.m., noon and around 5 p.m. are the peak times for voters, where up to 200 people will show up, packing the lines. The biggest problem Beelby

encounters with voters is the requirement to show identification.

“Some people don’t want to show identification,” Beelby said, admitting she doesn’t know why people refuse to show I.D. If a voter doesn’t have or refuses to show identification, they can sign an affidavit. Beelby said voters who refuse to show identification or sign an affidavit are not allowed to vote, per state guidelines.

No matter who wins or what ballot proposals are put in place, voters will be glad when the election is over. Creger said she received nine flyers in the mail on Monday and received a barrage of phone calls for endorsements leading up to Election Day.

“There’s way too much campaigning, way too many phone calls,” Creger said. “It’s a little excessive.”

Jason Hughes has unseated Holly Village President Jeff Miller, 924 votes to 591. Former Village President Pete Clemens grabbed 340 votes and 13 went to write-ins. In 2010, Miller unseated Clemens in the mid-term elections. Hughes ran for president during his first term as a village council member. His term was set to end in 2014.

The village council will also pick up three new council members, with Debra Musgrave winning 1,077 votes, Robert Allsop with 901 and Ryan Bladzick with 878. John Lauve received 805 votes, and former council member William Kuyk took 522 votes.

Council members Pauline Kenner and Don Wingelmire’s terms expire on Dec. 31, and they did not seek reelection.

Holly Township

Former Township Supervisor Dale Smith will become the new supervisor,

narrowly defeating George Kullis by 64 votes.

Kullis spearheaded the effort to ask voters whether they wanted to add two new trustees to the township board. Voters turned this measure down with 55 percent against.

Clerk Karin Winchester and Treasurer Mark Freeman will keep their seats, running unopposed.

The race for the two seats on the Holly Township board was narrow. With three running, incumbent Janet Leslie and newcomer Mark Cornwell took 47 more votes than incumbent Steve Ruth.

Holly Area Schools

The operating millage renewal passed with 57 percent of the vote. The board will also see two new members with Leon Sharpe and Pete Deahl. Votes were evenly divided between the newcomers and Sue Julian and Linda Blair. All four ran unopposed, as four seats were up for election.

Treasurer Kevin Diviney and trustee Dave Rath both have terms ending Dec. 31, and they did not seek reelection.

Shapiro leads Fenton school board race

► Bond proposal too close to call at press time

As of press time, newcomer Drew Shapiro led in the race for the one available seat on the Fenton Board of Education with 1,704 votes or 50 percent of the 3,387 votes cast. Incumbent Sandra Mathews-Barnes was in a close second with 1,353 votes or 40 percent. Dior Rushton had 274 votes or 8 percent and nearly 2 percent of the votes were write-ins. At press time, 70 percent of the precincts were counted.

The proposed Fenton school bond, which would be used for technology and new buses, was too close to call at press time, where 70 percent of the precincts were counted. Of the 4,404 total votes, 2,282 or 52 percent were in favor of the bond while 2,122 or 48 percent were opposed.

and public safety and have a lot of work left to do as state representative on these issues.

"While today's victory feels great, there is no time to rest and I will continue working tirelessly on behalf of the residents of the 51st district."

Graves has held the position since a special election in February. He ran against Steven Losey (D-Linden), who serves on the Linden Board of Education.

The 51st District includes Atlas, Argentine, Gaines, Flushing and Fenton townships and cities of Fenton and Linden, all of Genesee County. The district also includes Holly, Rose and Groveland townships, of Oakland County.

As of 12:50 a.m. on Wednesday, the Genesee County Clerk's office was reporting that Graves received 12,663 (53 percent) votes, while Losey received 11,068 (46.3 percent). These numbers will change since only 28 of the 35 precincts had been tabulated.

Brown projected winner of Genesee County Commissioner — 6th District race

Tony Brown (R-Fenton Township) was projected to be the next commissioner for the Genesee County Board of Commissioners. Reporting precincts in the sixth district put Brown over his challenger, Jonathan Ettinger (L-Linden).

As of 12:45 a.m. Wednesday, the Genesee County Clerk's office was reporting that Brown had 7,028 votes (70.7 percent), compared to Ettinger's 2,752 votes (27.7 percent).

The sixth district includes Argentine and Fenton townships and the cities of Fenton and Linden.

"Last time it wasn't like this, I walked in and walked through," said Candi Chodacki. She waited a little longer at the front of the line with voters from the third precinct. She was also out early to vote in 2008, but that was just because of her job. "This year seems to be heightened," she said.

As she exited the polling location, Tammy Mackenzie said she voted Republican. "I think it's going to be a very close race, very close," said, adding that she's not surprised by the turnout.

Tonya Coffin, said she had thoroughly researched all the issues on the ballot. "I'm a teacher so I've really been looking over the issues, especially Prop 2." She said the proposals that could amend the Michigan constitution make this election a little different than a regular general election.

Election worker Ray Leppert guessed that the proposals added equal weight to the election, increasing the turnout. By 7:30 a.m., 88 voters had already cast their ballot. Fenton Township Operations Manager Thomas Broecker said the count was 181 at 7:30 a.m., just half an hour after polling opened.

Tyrone Township residents voting at

the Fenton Church of the Nazarene said the wait was only around 20 minutes.

At many polling stations in the tri-county area, lines slowed at peak times, but generally ran smoothly.

After 5 p.m., activity picked back up at the St. John Activity Center, with steady groups until around 6:30, when there was once again a line out to the door to the parking lot. "It's uncommon to have this many (voters)," said election inspector Jeremy Barancik. "This is definitely pretty crazy."

The last voters in Fenton trickled out before 8:30 p.m., and the election workers began tearing down. Fenton voters cast just over 4,115 votes.

The buildup to the 2012 General Election led to a strong voter turnout.

In Tyrone Township, 47 percent of registered voters turned out, with 3,646 out of 7,749 registered voters casting ballots.

In Holly Village, 2,617 ballots were cast, of 4,459 registered voters, or 58 percent turnout. Holly Township cast 2,871 ballots, of 4,156 registered voters, or 69 percent.

In Rose Township, 3,555 ballots were cast out of 4,957 or 71 percent.

the term is most accurately described as simply being the concept of watching television programs through the Internet. In fact, there are multiple ways to do this and all have their own pros and cons.

The easiest way to make use of Internet TV is to simply watch them on your computer with a connection to the Internet.

"The first, most popular ways are probably Hulu or Netflix," said Mike Oliver, owner of Hometown Computers. "With Hulu you have limited viewing capabilities unless you pay for a subscription. Netflix, you have to have a subscription to use it at all. Both are very inexpensive though

at about \$9 a month."

Hulu is a great way to watch new episodes of your favorite television shows as they are released, while Netflix offers only what is typically available on DVD, offering a better back catalogue of episodes.

Other websites to visit include those of various broadcasting networks, such as www.abc.com. These websites will also have the new episodes of current television shows the day after they have aired on television.

Of course, not everyone wants to sit around their computer to enjoy their

favorite program. Some people want to watch television on their television. In this case, there are several different options to choose from.

Your phone is not the only piece of technology to become smart in recent years. When looking to buy your next television, you could look for a smart TV, which has built-in ways to access and utilize the Internet.

If you simply want to access Netflix or Hulu on your television, there are many devices that can do this for you that you might already own. Video game consoles such as a Wii and some Blu-ray players, if hooked up to the Internet, can provide you access to those services.

Instead of buying a brand new television set, a cheaper alternative is to look at digital video player devices such as the Roku box. This device easily plugs into your television, and offers more than 100 free channels of Internet content, as well as access to premium content for those who wish to subscribe, such as Netflix and Hulu, and others such as HBO Go. If you are looking to find a particular television show or actor, the Roku search feature will search across all of the services and Internet channels it offers to help you find what you are looking for.

Another alternative is an AppleTV, which Oliver said can be a confusing name as it is not a television, but a device similar to the Roku box. "The biggest benefit to that is you can use it to stream your own personal media library," Oliver said. Anything you have purchased on iTunes can be watched on the AppleTV, and those with a little tech knowledge can transfer their physical DVDs or Blu-ray movies onto the device.

It may not always be possible to find all the programs you want to watch through one Internet TV source but you might be able to mix and match different services — or wait as Internet TV continues to evolve.

Linden boys take runner-up spot at state CC meet

Roger Phillips and the Linden varsity boys cross country team weren't necessarily thinking "state championship" when they completed their Division 2 Lower Peninsula Cross Country Championship race at Michigan International Speedway. At least they weren't thinking about it until a visit from an opposing coach.

"When we finished we had the St. Clair coach come over and mention to our coach it would end up between him and us," Phillips said. "We knew we were going to beat (third-place) St. Joseph. I was really excited to find out if we were going to finish on top."

The Eagles didn't get their first state championship since 2008, but did make it to the podium with a somewhat surprising second-place finish, earning them the runner-up trophy. Linden had three individuals earn All-State honors, helping the team to 128 team points, while St. Clair edged the Eagles with 114 points. St. Joseph recorded 153 points. The Linden girls also competed and placed 17th over-

all. The boys' finish shocked even their coach, Clint Lawhorne.

"No, not really at all," Lawhorne said when asked if he thought the team was contending for the title. "We were running well, but, honestly, I wasn't looking at any other teams. I wasn't counting or trying to see where our fourth or fifth kids were with respect to anyone else."

"That's pretty awesome when you come within a few points of a state championship. It shows you what you can do when you work hard to achieve your goals."

"When the race started I wanted top five and we went out there running our hearts out," said senior Adrian Taylor, Linden's only runner to compete at the state meet each of the last four years. "I was not expecting a podium finish like we did. People started crying and smiling. It was a great feeling. Our freshman year, our goal was to get a podium spot before we graduated. We knew it could possibly happen, and it did."

Linden was paced by Phillips, who earned All-State honors with a sixth-place and school record time of 15:35.3, about 31 seconds out of first place and just over three sec-

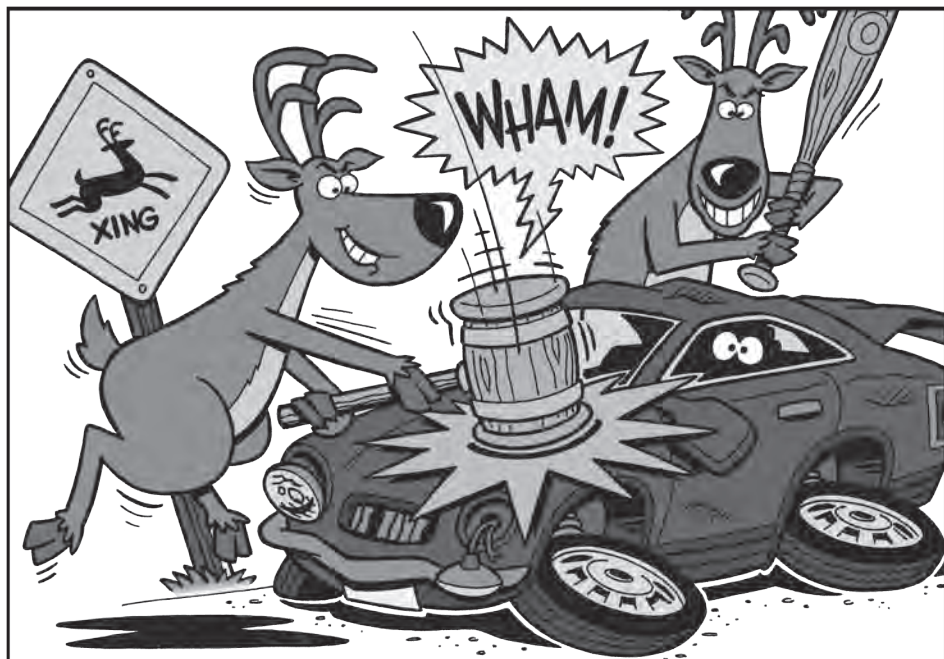

Fenton swimmers take second at Metro meet, earn co-league title with Brandon

A streak continued, but probably not the way the Fenton varsity girls swimming and diving team would have liked to see it happen on Saturday.

The Tigers earned a share of their ninth co-Metro League title by taking second at the Metro League Meet Friday and Saturday.

Brandon, who almost beat Fenton in a dual meet earlier this season, won the meet with a total of 460 points, just 16 more than the Tigers' total of 444. Coupled with Fenton's undefeated dual meet season, the two teams share the title. Holly finished in sixth with 214 points.

"We are co-champs. It's not a loss, but..." Fenton coach Brad Jones said hinting it was a bit disappointing. "Brandon has made tremendous strides under coach (Todd) Duncan. They were last in the Metro League when he took over two years ago, were second

last year and co-champs this year. It is great for the league and good for us to have another team that will challenge for the title every year. That being said, our goal will always be to win the Metro League. And we will start addressing next season very soon."

The Tigers had firsts in six events compared to Brandon's three events, but the Blackhawks' depth was the difference.

Leading the Tigers was Gabrielle Haaraaja, taking first in four events. She teamed with Meagan Cassner, Haley Shaw and Lauren Davis to win the 200 medley relay (1:58.54) and the 400 freestyle relay (3:46.02). Individually, she won the 100 freestyle (54.43) and the 50 freestyle (24.98). Haley Shaw also won the 100 backstroke (58.77), while Mackenzie Deputy won diving (300.3).

"We swam well, but the bottom line was depth," Jones said. "We graduated more than we brought in and it was very difficult to cover all the areas we needed to.

"I am very pleased with our performance and what we have returning. We are set up for some very good state meet swims. Gabrielle dominated the 50 free and 100 free, swimming times that already place her in the top eight at state. Haley already had times that would place her very high at state, so getting the drops from Gabrielle this early was very exciting. Both Lauren Davis and Meagan Cassner will be swimming in both relays at state, and had great swims as well."

Fenton had two individual second-place finishers as well. Shaw placed second in the 100 butterfly (58.79), while Cassner was second in the 100 backstroke (1:06.82).

Holly had three individual second-place finishers. Courtney Konopitski placed second in the 100 freestyle (54.66) and second in the 200 freestyle (2:00.62), while Sabrina Bruni took second in diving (264.60).

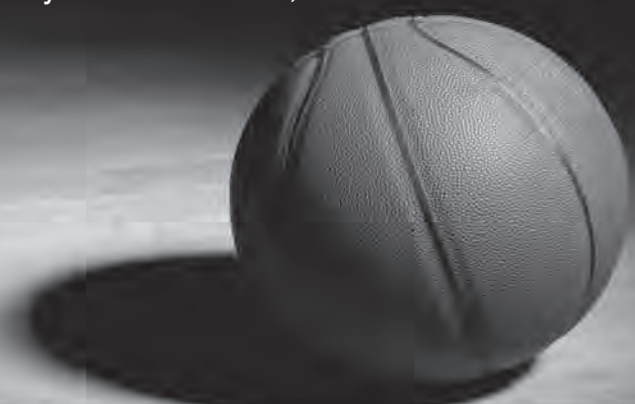

To your good health

DEAR DR. DONOHUE: My 12-year-old son has large breasts, like a woman's. In other respects he looks like a 16-year-old. He's tall and wears a size 11 shoe. What has caused his breasts to be like they are? — M.C.

ANSWER: Your son is going through puberty. Two-thirds of boys experience breast enlargement during puberty. It's normal. The enlargement for some boys might not be as great as your son's, however. It comes from a temporary imbalance of male and female hormones. It's not a lasting thing, for most. Some see a regression in a matter of months, while others might have to wait for two years. The condition is gynecomastia. If this causes your son great embarrassment and makes life miserable for him, speak to the family doctor. Removing the breast tissue ends the problem. Surgery isn't extensive and doesn't require a long healing period.

What is a bunion?

A bunion is an abnormal shifting of the bones in the foot which causes a bone bump on the inside of the foot and the big toe tends to deviate toward the 2nd toe. The big toe is critical to walking and when it is misaligned it can cause pain in the foot and other joints due to walking abnormally. With the change in size and position of the foot from a bunion it can be hard to find shoes that fit. The good news is it can be fixed. You don't have to hobble the rest of your life.

What causes a bunion?

Usually it is a combination of things. Genetics plays a part. Foot structure like a flat foot or a falling arch can cause overload of the joint and cause the bones to move. Improper shoes can also cause abnormal pressures which can move the joints and bones.

Can bunions be prevented?

Once the foot is evaluated we can make a plan to prevent the bunion. Typically if we see a bunion starting it can be prevented with proper shoes and a custom made orthotic. It is particularly important to have a mold taken of your foot while it is held in the correct position to make a Custom Functional Orthotic. The scanners that people stand on do not provide an "orthotic", they provide a soft insole without the needed functional support, which does not help to prevent or correct anything.

Can bunions be fixed?

Yes, bunions can always be fixed. The worse they get the more work they take to correct, but I have not found a bunion I could not correct yet. Bunions usually take a procedure to release contracture or a surgery to move the bone back into the correct position. The earlier the diagnosis the easier it is to fix or prevent.

My mom and grandma told me bunion surgery was painful?

Not so much anymore. Surgical procedures have changed significantly over the years. Every surgery has some discomfort, but there is much less pain than there used to be. I would say the majority of patients state they have less pain than they expected and some have no pain at all.

Do the gimmicks in the magazines like toe splints work?

For the most part they will not. Gimmicks don't address the root of the problem, abnormal position of the joint or bone. A toe splint cannot correct that.

What happens after surgery, if I need surgery?

Most of the time patients can walk on the foot after surgery in a walking boot. There is usually no need for crutches or casting. You will be slowed down but not prevented from daily activities that need to be done. Time in the boot will depend on the type of procedure performed.

What should I do if I suspect a bunion?

We evaluate people with bunions every day. We can give recommendations as to how severe it is and different treatment options available. We will work out a treatment or prevention plan that works for you.
