Stretched out sleeves

Use this quick save for stretched out sleeves on natural fabrics (like wool, cotton and linen). Spritz the cuffs with hot water then blow dry. The combination of heated water and air causes the fabric to shrink to its original shape.

are unique and special because of their people, businesses and natural resources, the names Fenton, Linden and Holly are not altogether unique names in the U.S.

Fenton

Fenton, Mo. is located in St. Louis County, about 20 minutes from the Illinois border. The city is home to 4,022 residents according to the 2010 census. The median household income in the city is \$84,000, compared to \$57,000 in the county.

Fenton, Mo. is home to five universities, including Sanford Brown, and St. Clare Hospital. St. Louis County, like Genesee County, suffers from more than 8 percent unemployment. Fenton, Mo. is home to 15 African Americans, and 3,841 Caucasians.

The town of Fenton, N.Y. in Broome County has nearly 7,000 residents and is home to the Chenango Valley State Park. The median income for that town is \$39,622

►DDA extends consultant's \$3,000 per month contract

Fenton — The Downtown Development Authority (DDA) extended its consulting agreement for three months with Jerry Mansour at its meeting on Tuesday. Mansour is paid \$3,000 per month for his services.

Mike Burns, the DDA director and

assistant city manager described Mansour as being an instrumental part of the project, and said that the DDA is very near to beginning the construction phase.

Mansour said that the Cornerstone Project has been compli-

cated. "We thought it was going to get started earlier than this, but it has taken longer," he said. According to Mansour, however, every obstacle they have faced has ended positively.

"There is still a chance that this won't happen, but the likelihood of that is very slim at this point," Mansour said of the Cornerstone Project. "We seem to have so many pieces of the puzzle that are going together.'

The Cornerstone Project itself will be a building with four stories that makes up approximately 47,000 square feet. The first floor of the building will be made up of restaurants and retail stores, while the three floors above it will contain between 21 and 30 loft-style apartments.

The exterior will be mainly made of brick, limestone/architectural cast stone, and glass.

Restaurants will be encouraged to utilize outdoor seating. Additional features for the building being considered include non-protruding decks for each loft, courtyards and a

parking deck.

Mansour said that they still have nonbinding letters of intent with a deposit for nearly all of the business space on the first floor. Mansour said he believes they may

have a little bit of space still available — around 1,500 square feet.

"Our next step is to try and convert those letters of intent into actual contracts," he said.

The lofts on the other hand are more difficult. "It's tough to really premarket lofts a year or 9 months in advance, but that will take place when construction starts," said Mansour.

Craig Schmidt, DDA chairman, said that Mansour has done an excellent job in getting the project moving.

Genesee County cancels school

Mayan calendar, alleged threats prompt officials to cancel classes, activities

at Fenton Area Public Schools discovered a bomb threat and at Grand Blanc schools, there were reports from students of gunshots being fired. Those reports turned out to be hoax.

With the recent school

shooting in Connecticut, Linden Community Schools Superintendent Ed Koledo said tensions have been high to any alleged threat to any local school.

"The decision was not based on school safety alone as Linden had no specific threat, but more on mental health," Koledo said via email. "With the likelihood of increased threat (as reported by the Michigan Intelligence Operations Center)... with the difficulty investigating the number of threats already existing... with the number of concerned parents, students and staff... the level of anxiety was extremely high."

Continued from Front Page site Facebook was filled with confused students, parents and even teachers looking to find any verification of the rumor that had been spread — that school was cancelled due to a 'safety risk.'

As the details surrounding the threat were mixed and confused, so were the opinions and comments of the students who attend these schools.

"I think that someone may have said something they shouldn't have and other people overheard and then the rumor spread," Fenton High School senior Craig Horning said. "I think it is good that the school is taking action because we can't be sure if it was real or not."

Dozens of schools across

Michigan were sequentially shut down, whether due to a legitimate threat or worry that there would be one. Many students believed that there was no real threat — just kids spreading rumors hoping to get a few extra days off school.

"I don't think it's worth calling off school. There should honestly be a better contingency than just calling off school. But I think the reason things like this, the Colorado and Newtown incidents, happen is because of the media's fascination with it and focus on the killers," FHS senior Adam Tokarsky said. "It glorifies and promotes the killers, and makes them famous almost."

As with any highly publicized act of violence, school districts are concerned with copycat incidents and taking no risks in keeping schools open. Lisa Hagel, the superintendent of the Genesee Intermediate School District, told ABC12 that Fenton Area Public Schools Superintendent Timothy Jalkanen did not respond on the alleged bomb threat before press time.

Authorities became suspicious of possible planned attacks after investigating rumors through social media, according to officials with the Genesee Intermediate School District (GISD).

"Our communities are anxious, parents are concerned about the safety of their children... and there are threats within

local districts that bring pause as to whether conducting classes would be appropriate," GISD said in a press release.

Genesee County wasn't the only school district to close down in Michigan. Lapeer Community Schools also closed for

schools Thursday and Friday due to alleged threats.

Fenton police are investigating the threats. Police Chief Rick Aro said, "Anyone that threatens to harm individuals or disrupt the functions of our schools or other government agencies will be prosecuted to the full extent of the law," said Aro. "These crimes are a felony, punishable by up to 20 years in prison."

Aro said his department has a zerotolerance policy in these cases, and will use all resources available to investigate, identify and charge anyone committing these acts.

"If someone is really wanting to shoot up a school, they still are going to do it whenever school resumes. I think everyone just needs to calm down and stop being

crazy. Because in a month or two, no one is going to care anymore about it. That is how it is with everything."

RxPATROL has offered a reward of up to \$2,500 for information leading to the arrest of the bold and potentially dangerous suspect believed to be responsible for an armed robbery in Fenton earlier this month.

The armed robbery occurred at 8 p.m. on Dec. 7 at Walgreens, 3270 West Silver Lake Rd., in Fenton.

The reward is being donated by pharmaceutical company Purdue Pharma L.P., which operates RxPATROL, a collaborative effort between industry, pharmacists and law enforcement to collect, collate, analyze and disseminate information in an effort to solve crimes and prevent additional incidents.



same tactics that work for the food bank are unlikely to work for you at home. "Our leveraging ratio is really based upon our ability to get donated food products into our area and we pay for transportation on that food," said Kara Ross, vice president of the Food Bank of Eastern Michigan.

Donations make up a large amount of what the food bank holds in stock. Most often, the money will not go to food, but instead toward getting that food to those who need it. "If Nabisco or Campbell Soup wants to donate products to us, we just have to arrange for transportation to get it here," Ross said.

Summary A major task and expense for food banks is transporting donated goods.

Food from businesses is only one way in which the food bank obtains their food. "We get food from a variety of sources. Some food comes from the USDA, some is donated, some comes from FEMA," said Ross. "We do purchase some products, but it is very minimal,

and it is mostly to keep things that our agencies are accustomed to having in stock during those lulls when we don't get those products coming through."

Items the food bank tries to keep in stock are meal

type items according to Ross. Beef stew, soups, canned meats, fruits and vegetables. "Staple items so that if those things aren't donated they are still available here for people to get," she said.

Donated items from businesses can take many different forms. "We do see a lot of seasonal type products that they can't sell in the store. The Cap'n Crunch with his Santa hat on will come to us in January for example," Ross said. After the Atkins diet craze came to a close, the food banks received a lot of Atkins products, such as dressings. While it may be out of vogue, Ross said it is still a very viable product. "It's still food," she said.

While a lot of money goes to arranging

transportation and maintenance on their fleet of vehicles, Ross said that the food bank has very low administrative overhead. "Basically each year we typically have only a 2-percent administrative cost for our administration. So 98 percent of every dollar is going right back to that mission of feeding people." The key to getting so much bang for

their buck is in the food bank's efficiency. The Food Bank of Eastern Michigan serves 22 counties, though they only have the one location in Flint, and ship to each county twice a month. "We will have

one drop zone in each county where agencies can come and meet our truck," Ross said. "We don't have two or three satellite hubs or buildings to maintain and take care for — we basically just have a truck and a truck driver."

Ross said that in the 15 years with the food bank, she has seen it grow and evolve internally to make them more efficient at their job. The organization runs on fewer than 60 employees who manage to deliver 21 million pounds of food to eastern Michigan every year.

"Our warehouse typically holds a million and a half pounds of food at any given time and it is usually out of here within one month," Ross said.



Lake Fenton — It was a tale of two halves for the Lake Fenton varsity girls basketball team on Tuesday night.

Fortunately, it was the one that the Blue Devils dominated that ended up being a bit more important in Lake Fenton's 47-42 victory against Beecher.

The Blue Devils played one of their best halves of basketball of the season in the opening 16 minutes, taking a 31-12 lead into the break.



Linden girls remain perfect, defeat Kearsley, 57-14

Ben Varner preaches defense to his Linden varsity girls basketball team frequently. It seems the Eagles are getting the mes-

sage Already playing strong defense through four games this season, the Eagles posted their best defensive effort yet against Flint Kearsley, earning a 57-14 home win against the Hornets.

the basket and was fouled, putting him at the line. He made both shots and Lake Fenton led 2-0. The Blue Devils even stopped Beecher from scoring on its first and second offensive possession. However, a missed shot by the Blue Devils resulted in a Monte Morris fastbreak layup, 53 seconds into the contest. The next 67 seconds would result in eight more points for Beecher. About 37 seconds later, a Morris steal was turned into his second transition layup. That was followed by two more steals and hoops by Beecher, the second hoop being a slam by Markell Lucas, raising the gap to 10-2 with 6:00 left in the first quarter.

The lead grew to double-digits for the first time at 13-2 on a fastbreak layup by Emmanuel Phifer less than a minute later. The Blue Devils ended the 13-point run with a layup by Welch, cutting the gap to 13-4 with 4:46 left in the first quarter. However, that would be the last time Lake Fenton was within single-digits. "We got a chance to see how tough we are, and we've found out we have some work to do in that department, that's for sure," Erway said. "Our composure was not good, not good tonight.

"We talked before the game, we knew the biggest thing with Beecher is transition and steals. One thing we talked about is if you get tied up, don't make weak passes ... it led to easy buckets."

While how quickly the game became lopsided may have been bothersome, it's not like anyone else has enjoyed much success against the squad expected to contend for another Class C state title this year. "Ninety-one cents of every dollar donated goes to whatever cause the donor has designated," Bono said. "If they want it to stay in their local chapter, it would stay in their local chapter. If they want it to go to hurricane Sandy, it goes to hurricane Sandy.'

The President of the Red Cross is compensated with a salary of \$501,122, which amounts to .01 percent of the charity's expenses.

Feeding America is a large organization that acts as a network between all of the food banks in the country.

"Instead of 200 food banks going to Kellogg and asking for cereal, there is just us," said Ross Fraser, spokesperson for Feeding America. "It's all about moving donated food and getting food donated to us."

Once they obtain the food, Fraser said that they then find the food bank that can make the most use of it, and easily get access to it. This year, Feeding America will distribute more than 3.5 billion pounds of food and grocery products.

While you can donate to help support Feeding America, which uses 97 percent of every dollar to assist hunger programs, Fraser said that it is important to remind people to donate locally as well.

Donating to the Food Bank of Eastern Michigan will see 98 percent of every dollar go directly to the mission of feeding the hungry. The food banks' president makes \$174,291, which is .45 percent of total operating expenses.

I noticed that when I drive through mud puddles in my car that my engine sounds louder. Should I be concerned about this?

A. First thing, I hope you aren't going through the mud puddles very fast. This can cause water to go into the intake and hydro lock the engine causing severe damage. It could be that water is getting into the fan or on the belt area and causing the extra noise. One more possibility is an exhaust leak that may sound louder over water than other road surfaces.

Larger containers coming for curbside recycling

The Holly Village recycling program will change to a bi-weekly schedule, but with larger carts, instead of small bins. "They really weren't big enough to promote a viable recycling program," said Village President Jason Hughes. The new carts will be distributed in late January and early February. At that time, pick up of refuse and recycling will occur only on Wednesdays, with recycling every other week. The change occurred as the Holly Village Council was offered a five-year contract extension for Republic Waste Services for both refuse, and curbside recycling pick up. The contract extension has a oneyear freeze on the 4 percent scheduled annual increases, bringing the increase overall to 3 percent. Hughes said the service costs about \$11 per home, per month and is rolled into the 13.5 mills residents pay.

Salary increases, promotions approved

The Holly Village Finance Committee's recommendations to increase the salaries of both interim Chief Michael Story and clerk/treasurer Cathrene Behrens was passed by the council on Tuesday. The council passed all of the committee's recommendations, including promoting two patrol officers in the village police department to sergeant, to help Story supervise the department. The changes, once all implemented, will cost the village about \$17,000 annually



Music director of St. John the Evangelist Parish

Tim Garback has spent the last three months preparing the St. John the Evangelist Choir for Christmas mass. One of the biggest performances for the choir, preparing for the Christmas mass can be daunting. But with decades of experience, Garback has whipped his choir into shape, who will undoubtedly perform beautifully. Here'a closer look at the man orchestrating the performance:

How long have you been playing music? When did you come to Fenton? I've been at St. John Church since 2000, the past 12-and-a-half years, been playing full time for 30 years. I play anything that's keyboard and a little bit of

accordion, believe it or not. What made you decide to pursue a career in music? When I was younger I danced in a Polish Dance Troupe, and at that time there used to be piano accompaniment while you were dancing, so I was very interested. My mother introduced me to the accompanist and gave me piano lessons and then it kind of went from there.

I met my music teacher in eighth grade. He realized that I was playing music for so long that he introduced me to the organist at the place I was going to school, St. Christopher's in Detroit. She gave me lessons and I played my first mass at 16 years old.

How did you come to be employed by churches? I went to Oakland University after high school. Before 1980, there were only part time (organists). Priests found that they couldn't find organists for weekdays, and funerals are usually during the week. My first position was at St. Anne's of Warren. It just dovetailed into a full-time position. My first fulltime position was in my early 20s.

What's it like playing music on Christmas Day? It's absolutely exhilarating. It's such a rush of endorphins, you hear the organ playing, you hear the choir singing, you hear the people downstairs singing and you hear the brass band playing. It's a complete rush, it's hard to describe, when you're in that zone, it's like musical magic and it's

awesome. **Do you think anyone can play music, or is it genetic?** My mother, before the war, she was in the Warsaw Philharmonic. My father was in the seminary before the war broke out. He played the organ. So, I think some of that is passed down gene-wise. But I think you can get an appreciation of music from the home. Both of my daughters are perusing fine arts degrees and we've always had music in the home. I think somewhat people are born with it. But certainly, if you work hard with it, you can overcome the difficulty of playing an instrument. I have friends who didn't graduate but they have great careers because they just practiced. Lessons help because they give you the foundation of how to play. Once you learn basics and how your hands should go, the rest should come. You can overcome it, lots of hard work, dedication.

The organ can be pretty intimidating, especially one as big as the one at St. John's. What would you recommend for those who want to play it? If you really want to study the organ, you need quite a few years of piano. A lot of churches have liturgical degrees in organ and voice. I would say to those people, study as hard as you can on piano, take some organ lessons and see if you like it. The difference between organ and piano is there's pedals involved. You have to play lines on your feet and hands, a lot of people find that very difficult to do. You have to learn it, it's difficult, but once you learn it, you have it for the rest of your life.

Music and your faith seem intertwined. What's it like being a music director at a church? It's like being a priest. Faith and music for me intermeshes real well for me. I try to pick things that are reflective of the faith of the scriptures we have on Sunday. I pick music that reflects the reading. I think that's part of the whole thing with faith. It is expressed more in music. You're doing things musically that you can't do in a homily. It's more of a vocation and not really a job.

Why Bethlehem?

More than a century ago, Philips Brooks wrote his enduring poem, 'O Little Town of Bethlehem.'Hearing it during the Christmas season often takes me back to a one-room country school when it was still legal to sing carols at the annual Christmas program. Revealing this memory dates me but the poem Phillips Brooks penned is timeless and its message will be as meaningful to future generations as to his and mine.



Brooks said it so well:

'O little town of Bethlehem, how still we see thee lie!

Above thy deep and dreamless sleep, the silent stars go by. Yet in thy dark streets shineth the everlast-

ing light -The hopes and fears of all the years are

met in thee tonight.' What makes Bethlehem special?

Long before Brooks wrote his first poem, even before the first Christmas was celebrated, the prophets had revealed a very special birth would take place in Bethlehem.

Before Caesar and his senate plotted to enrich Rome with yet another tax while saving money on a census, Bethlehem had been pointed out by the prophets as a place that would enrich the world. Centuries before Joseph and Mary traveled to the birthplace of their ancestor, David, to be counted and pay their taxes, that tiny town had been pin-

pointed in Holy Scripture as a place of holy expectation (Micah 5:2).

Why? The first Biblical mention of Bethlehem names it as the place where Jacob and his wife Rachel stopped so she could give birth to her child. The journey had been hard for Rachel, much as it would later be for Mary, and she died shortly after her child was born. Before she died, Rachel named her son 'Benoni,'meaning 'son of my sorrow.' Centuries later, Mary gave birth to a son who was called the 'man of sorrows,' as had been prophesied by Isaiah. And while the birth we celebrate at Christmas brought joy to Mary, and finally to the world, imagine her sorrow when she stood at the cross witnessing the crucifixion.

Bethlehem was also the place to which Ruth and her mother-in-law, Naomi, came feeling empty and brokenhearted after their husbands had died. But, there Ruth met kind Boaz and married him, finding love and fulfillment. Over two thousand years have

come and gone since Mary gave birth in the town of Ruth and Naomi and unnumbered thousands, feeling empty and brokenhearted, have found love and fulfillment in the One born that holy night in Bethlehem's stable.

Perhaps the most revealing clue to the reason for Bethlehem being chosen as the place for the birth of the promised One is found in the meaning of the town's name. Bethlehem means 'house of bread.' And the babe laid in Bethlehem's manger would later declare Himself to be 'the bread of life' (John 6:35).

There is no greater gift to the hungry than bread, so Brooks wrote his final stanza to the hungry of heart. No wonder this carol has endured.

'How silently, how silently, the wondrous gift is given; So God imparts to human hearts the blessings of His heaven. No ear may hear His coming, but in this world of sin. Where meek souls will receive Him still, the dear Christ enters in.'



Pet services is the fastest growing portion of the pet sales market, in part due to the growing popularity and more widespread availability of clothing,

shoes, and upscale cosmetology procedures for pets.

Plastic surgery can now be done for pets, such as un-wrinkling pug noses, and ear clamping that makes a dog's ears perkier. More extreme measures like Botox, nose dye and implants grew from competition in show dog circuits. With the expansion of pet oriented services and products, much room has been made for pet spending in years to come. Spending increased 4.8 percent from 2009 to 2010 and according to APPA, is expected to grow even more in the upcoming years.

Barking Babes alone has seen a sales increase of about 40 percent in the past few months, partially due to the holiday season and cold weather.

"We are doing very well as a business. I think a lot of people love their pets like I do. When I go to Florida I take my girls with me," Williams said. "I make sure to stay specifically in pet-friendly hotels. I take my girls everywhere with me. A lot of people, myself included, treat their dogs as their own children and love them like family."
