The highest court in the state ruled that the 2008 Medical Marihuana Act does not allow patients and caregivers to make a profit from medical marijuana, a ruling first made by the Michigan Court of Appeals in 2011.

Job hunting tips for men, women over 50

► Stay busy, current and network while volunteering

Though the job market has improved in recent years, many men and women are still out of work. Perhaps most troubling, many of those people are age 55 and older who are fearful of an uncertain future and a job market where they are seemingly overlooked.

According to a 2012 study from the Government Accountability Office, the number of long-term unemployed people age 55 and older has more than doubled since the onset of the recession.

For many unemployed men and women

has passed older workers by. Workers in their 50s might be unfairly categorized as dinosaurs with no grasp of mobile technology or the latest software programs. But those applicants who can demonstrate their proficiency in the latest technologies, including mobile technologies like smartphones, tablets and social media, can put themselves above fellow applicants.

• Start working. If you are mired in long-term unemployment and spend every day at home, get out and start working. Volunteering is a great way to lift your spirits, network with other professionals and maybe even learn of employment opportunities you won't hear about on the couch at home. And volunteering, be it with a charity or a professional organization is a great way to revive your resume and continue to add accomplishments despite your unemployment.



Hagel and defense

President Obama's choice for secretary of defense, Chuck Hagel, former Nebraska Republican senator, has a resume most politicians can envy: a clean senatorial record, no ethical lapses and two purple hearts from a war many opposed and many more tried to avoid.

Hagel will likely be confirmed, but that should not mean Republican senators must roll over and relinquish their constitutional power of 'advice and consent.'

Of even greater concern is what he thinks about American defense in an increasingly tumultuous world. Yes, the defense budget is 'bloated,' as Hagel has said, but does that mean the best solution is to dismember it?

In an interview with the Financial Times last fall, Hagel said, 'I think the Pentagon needs to be pared down. I don't think that our military has really looked at themselves strategically, critically, in a long, long time.'

Maybe not, but outgoing Defense Secretary Leon Panetta, when it appeared that the just averted 'fiscal cliff' might bring \$600 billion in cuts to defense, indicated that defense budget cuts that large would bring 'dire consequences' to national security.

In remarks to the American Iranian Council, June 2001, Hagel said, 'The national security of the United States is not served by isolating Iran.'

In 2007, Hagel voted against an amendment to the Defense Authorization Bill that labeled the Iranian Revolutionary Guard Corps a terrorist organization.

Also in 2007, Hagel said, 'The Palestinian people have been chained down for many, many years.' Whose fault is that? If he suggests Israel is to blame for their situation, he either misunderstands history or accepts the propaganda of the 'Islamist lobby.'

Hagel and a number of former senior U.S. officials sent a letter to Barack Obama days before he took office asking him to 'talk with leaders of Hamas to determine whether the militant group can be persuaded to disarm and join a peaceful Palestinian government...' Hamas leaders have pledged to eradicate Israel.

Republican and even some Democratic senators should question Hagel about all this and more during confirmation hearings. It's their job and responsibility.

Family breakdown goes biracial

I know from past experience that I'm going to upset some folks by saying this, so brace yourselves: Marriage is very important and beneficial to the raising of children, but there's little evidence that it fights crime.

I bring this up in response to the sincere, well-meaning readers who say that we won't be able to do anything anything — about urban violence until we reverse the decline of marriage in African-American households.

I'm as troubled as any other concerned black parent about the rise in out-of-wedlock births in black America since the 1950s. But I am even more troubled when I hear people who should know better try to lay every social problem, including the nation's current gun violence debate, at the feet of single-parenting — as if nothing else mattered.

Heather Mac Donald, a writer at the conservative Manhattan Institute, helped set this tone in a 2010 essay on black-on-black violence in the Chicago neighborhood where Obama famously worked for four years as a community organizer.

Her conclusion: Obama and 'decades of failed social policy' in crimeplagued low-income neighborhoods on the city's far South Side 'ignored the primary cause of their escalating dysfunction: the disappearance of the black two-parent family.³

'If we are honest with ourselves, we'll admit that ... too many fathers (are) missing from too many lives and too many homes,' he said then. 'We know the statistics — that children who grow up without a father are five times more likely to live in poverty and commit crime; nine times more likely to drop out of school and 20 times more likely to end up in prison.⁷

I believe that we can't expect to see much of a turnaround in out-of-wedlock births as long as we have rising and not just in black America.

A development this huge calls for more than simple one-size-fits-all analysis. I'm not saying that government programs provide all the answers, but we're only beginning to ask the right questions.

Last month, the Holly Police Department raided Well Greens, the last medical marijuana dispensary in Oakland County.

Kelly Klocek of Linden has Atypical Trigeminal Neuralgia, a disorder that includes frequent and intense migraines, chronic aching and burning sensations. Before obtaining her medical marijuana card, Kelly said she was taking 35 different prescription pills a day.

"I haven't taken a pre-

scription medication since I received my medical marijuana card almost three years ago," Klocek said. "I now have my life back.'

James (last name withheld) of Fenton was recommended medical marijuana by his doctor after he tore his anterior cruciate ligament (ACL) and had chronic pain. Like Klocek, James said medical marijuana is the only treatment that has eased his chronic pain.


"Medical marijuana isn't an excuse to smoke pot. I know a lot of good people who would be truly devastated physically, mentally and emotionally without their license," James said.

Klocek and James support dispensaries but did see how selling medical marijuana was controversial.

"I can understand both sides of the argument. A lot of the places that caused the dispensaries to be illegalized were selling medical marijuana to non-patients, which is a huge violation," James said. "The law-abiding dispensaries, however, were great places to get help. If you don't know what you need to help you, they were there to help figure out the best care-plan for your specific needs. Without them around, a lot of people are without anyone to help them with their treatments."

Under section 6(i) of the Medical Marihuana Act (MMA), an annual statistical report of marijuana cardholders must be presented to legislators in Lansing. The state collected nearly \$9.8 million in revenue from medical marijuana applications in 2012. With expenditures costing \$3.6 million, the state made a profit of \$6.2 million from the MMA last year.

Of the 122,463 original applications and renewals applied for, 6,687 of them were denied, meaning that roughly 80



percent of applicants are approved for medical marijuana. Severe and chronic pain is the most frequent condition patients list as a need for medical marijuana. Oakland County ranks second in coun-

ties within Michigan when it comes to the number of medical marijuana cardholders, with 11,117 patients and 4,425 caregivers.

Genesee County ranks fourth highest in the state with 8,231 patients and 3,336 caregivers.

Livingston County has significantly fewer medical marijuana cardholders with 1,867 patients and 804 caregivers.

The report also states 1,928 physicians provided written certifications for patients to smoke medical marijuana.

Under the law, a cardholder is allowed to posses 2.5 ounces of usable marijuana. If a cardholder does not have a specified primary caregiver, he or she is allowed to have 12 marijuana plants in an enclosed, lock facility.

Holly and Fenton police have said that they do not arrest law abiding medical marijuana patients. Linden City Attorney Charles McKone said that he has received several phone calls about Linden's policy of arresting anyone with marijuana, regardless if he or she has a medical marijuana card. McKone told the city council to forward all calls to him or Interim City Manager Scott Sutter. Officials in Linden may change their medical marijuana policy at a future date.

Detroit to lay off 600 to avoid state takeover

On Monday, the financial advisement board for the City of Detroit voted to furlough 600 unionized workers. The Detroit News reported that the vote happened the same day that Gov. Snyder confirmed he was interviewing applicants for the position of emergency manager for the beleaguered city. According to Michigan Public Radio, Detroit will barely have \$6.5 million in surplus if it implements several painful cuts, along with the lay offs.

Union sues to block **Right to Work**

A lawsuit was filed Monday, to challenge the right-to-work legislation passed in November. An earlier suit challenged how the law was rushed through the Republican-controlled Legislature. The suit is one of several, and unions claim the law can't apply to private-sector employees because it overreaches into an area controlled by the National Labor Relations Act. AFL-CIO lawyer Andrew Nickelhoff said the law is an unconstitutional attempt to control workplace activities in federal areas such as dockyards. Supporters of right-to-work laws say they give employees greater freedom of choice. Opponents say they undermine the ability to unionize. Source:AP

The legality of marijuana dispensaries in Michigan

On Feb. 8, the Michigan Supreme Court announced its decision in the case of the State of Michigan v Mc-Queen which involved a civil public nuisance action against two individuals, Brandon McQueen and Matthew Taylor, who were operating a membersonly medical marijuana dispensary called Compassionate Apothecary LLC in Isabella County.

Specifically the question before the Court was whether the defendants' business which facilitated patient-topatient sales of marijuana was operating in accordance with the provisions of the Michigan Medical Marijuana Act (MMMA).

The Apothecary's business operation allowed members of the dispensary (who had to be current registered primary caregivers or registered qualifying patients) to pay a monthly membership fee to access services. A member could then rent a locker to store up to 2.5 ounces of marijuana and make marijuana available to any other member for sale. The Apothecary retained a percentage of the sale price (about 20 percent) as a service fee. There were other terms and conditions as well.

The prosecuting attorney for Isabella County had filed a Circuit Court action seeking injunctive relief claiming that the business constituted a public nuisance.

The Circuit Court denied the request and the Court of Appeals reversed that decision holding that the activities were not allowed under the MMMA.

In a four to one decision, the Michigan Supreme Court found that the law was indeed being violated.

The Court held that although the sale of marijuana constitutes 'medical use' as the term is defined in the Act, the law does not permit a registered patient to transfer marijuana for another registered qualifying patient's medical use.

Additionally a registered caregiver cannot transfer marijuana for any purpose other than to alleviate the condition or symptoms of a specific patient with whom the caregiver is connected through the Michigan Department of Community Health registration process.

Thus, the Court held injunctive relief to abate a violation of the Public Health Code was appropriate. Michigan Attorney General Bill Schuette has indicated dispensaries will now have to close their doors.





The Blue Devils had seven wrestlers place in the top four at the Mt. Morris district, earning a spot in regional action at Williamston High School on Saturday.




