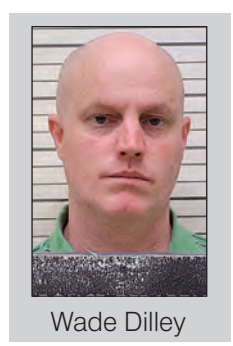

Former Linden cop pleads no contest to criminal sexual conduct

►Defendant Wade Dilley could seek dismissal of charges after one year

A former Linden police officer pleaded no contest last week to five counts of second-degree criminal sexual conduct (CSC) involving a

female family member under the age of 13. Instead of prison time, Genesee County Circuit Court will seek plea under advisement. After successful completion, Wade Dilley, 38,

of Fenton can seek dismissal of the charges in one year. A plea of no contest does not imply guilt, it means that the defendant no longer wishes to fight the charges. John Potbury, special assistant prosecuting attorney with the Genesee County Prosecutor’s Office said, “Significant evidentiary is-

sues developed in this case as it went through the criminal court system. The victim and victim’s mother believe this is an appropriate disposition.” Dilley was charged with the offenses in January 2012. Fenton and Mundy Township police departments worked together on the complaints

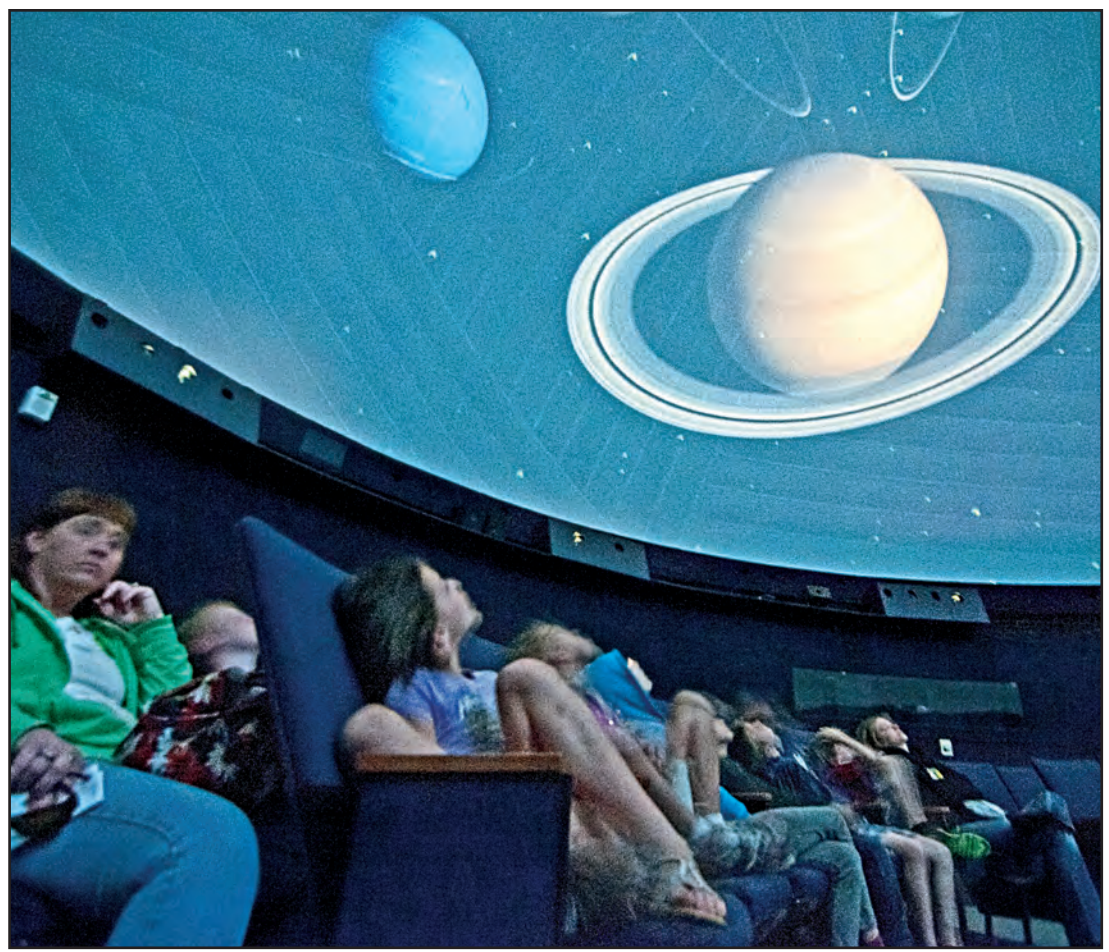
Custard anyone?

More than 40 area officials attend simulated disaster

►Training session builds relationships, improves emergency response times

Fenton — At 2:08 p.m. on Friday, May 3 a tornado touched down in Linden, leaving a path of destruction in its wake. A power substation was struck, resulting in a massive power loss, and the surround-

ing areas worked together to deal with subsequent problems such as gas leaks and road gridlock. Fortunately, this time the tornado and the repercussions of such an event weren’t real. The natural disaster existed only in a series of images projected onto a screen at the Fenton fire station and in the minds of more than 40 city, township, and school officials from throughout the tri-county area.

Marine Patrol prepares for torrent of lake activity

► Deputies of the Marine Patrol are undergoing training involving first aid, CPR, boating safety, and much more over a three week period.

and bringing their boats out of storage, the Genesee County Sheriff's Department is undergoing its own set of preparations.

To cover all of the lakes in Genesee County, 11 deputies, some old and some new, are undergoing

training to patrol the waters come Memorial Day.

Training lasts three weeks and covers a wide range of skills, including first aid, CPR, boat maintenance, marine laws, boater safety, inspections, how to deal with the public and the marine patrol operations systems, preparing the deputies for all that they might face while out on the water.

"Training goes on for a week," said Undersheriff Chris Swanson. "Then

the next week is when they go hands-on with the boats. We do all of our seasonal maintenance, make sure everything is working from over the winter, dock the boats. Then the last week we start the on the job training on the lakes before the big crowds come on for Memo-

rial Day."

Swanson said that they look for people who best understand the position, and that can best adapt to the public. Personality is important, as while the Marine Patrol deputies are there to enforce laws and address reckless behavior, people

go to the lake because they want to have a good time.

"This isn't a police position, they are all non-certified deputies. We look for individuals who are mainly college age, that are coming into the world, are teachable, and want the

Was President Obama really joking at Saturday's White House Correspondents' Association dinner? Or was he showing, as I suspect, early signs of the second-term blues?

It's fashionable for critics to harrumph with outrage over the chummy elbow-massaging of politicians, media moguls, Hollywood stars and, here and there, some actual White House journalists — especially if they didn't get invited.

But sometimes actual news breaks out, especially if you listen for hidden messages in the president's traditionally humorous roast of himself and others.

Right off the bat, Obama drew contrasts between his first and second terms. 'How do you like my new entrance music?' he asked the crowd after half-dancing his way to the podium to the pounding beat of a rap tune.

'Rush Limbaugh warned you about this,' he quipped. 'Second term, baby. We're changing things around here.'

He also turned the paranoid right's Obama myths on their head: 'I'm not the strapping young Muslim socialist I used to be.'

But some of his humor made one wonder whether he was actually joking.

'Everybody has got plenty of advice,' he sighed. '(New York Times columnist) Maureen Dowd said I could solve all my problems if I were just more like Michael Douglas in 'The American President.'

Obama was responding to a column by Dowd, in full mean-girl mode, praising his ability to connect emotionally with people but opining that 'he still has not learned how to govern.'

'No one on Capitol Hill is scared of him,' she wrote. He won public opinion for a popular bill to expand background checks for gun purchases, yet the bill fell short of passage in the Senate.

Obama has one of the most hostile Congresses in history. Besides new issues, he still has to defend his past successes such as the health care law and the Dodd-Frank financial regulation bill.

His headaches may well get worse after the 2014 midterms, which traditionally draw voters who are older, more conservative and more anti-incumbent toward whomever is sitting in the White House.

'Mainstream media' are alarmed by reports that billionaires Charles and David Koch are considering the purchase of Tribune Company's eight daily newspapers, including the *Los Angeles Times*.

When Warren Buffett spent \$344 million to purchase 28 newspapers, there were mostly sighs of relief from journalists glad to keep their jobs. However, reaction to reports of the Koch brothers' interest in buying the Tribune papers was quite different. Charles and David Koch, you see, are conservative libertarians, not liberals. Will the Kochs, *gasp*, force their conservatism on readers? Will they sully journalism's good name? Truth is, no one knows what the Kochs plan to do.

The Newspaper Guild and Communications Workers of America issued a joint statement, which said of the Koch brothers: 'They are active political proponents of harsh right-wing positions.' And many current owners, editors and reporters are what? Such arrogance is what has helped accelerate the newspaper industry's decline.

When news of the Koch brothers' interest in their paper reached the *Los Angeles Times*, columnist Steve Lopez asked for a show of hands from people who would quit if the Kochs bought the paper. According to a report in *The Huffington Post*, 'About half the staff raised their hands.'

That should make things easier for the Kochs. They can start by replacing liberal quitters and others whose ideology has turned off conservative readers. They could hire reporters and editors who will try to win back readers and advertisers by providing the type of ideologically balanced coverage they seek.

There are many good unemployed and underpaid journalists who could report the news fairly and without bias. They might leap at the chance to work for a paper whose owners would make a strong financial commitment.

Newspapers, like all media, are businesses first. If they can't make a profit because too many readers don't like or trust their product, they will go out of business, or reduce their size and coverage to something smaller and less substantial. The First Amendment is of little use if one can't afford a printing press.

The weekend of April 19 was an adventurous one for Fenton High School's Video Production students that took a trip up to a snowy Paradise, to hike and film at the Tahquamenon Falls State Park and Whitefish Point Bird Observatory.

This is the second year in a row teacher Rich Ashley has taken the group of student cinematographers to film biologists that band certain species of owls.

"The highlight of the trip is always the owls, which we were able to get some great footage of," Ashley said. "We

then turn around and use this footage to produce an episode of a public access educational television program called 'MI Wildlife Adventures.' This trip, as well as the production of the episode, provides these students with a great hands-on experience for filming in a real world setting,

as well as allows them an opportunity to explore areas and film wildlife in a region of the state that many students have not been to before."

Ashley had been helping to create the public access program 'MI Wildlife Adventures' before he became a teacher and used his past connections to utilize the students' work in creating new episodes. Ashley and his students traveled mostly by snowshoe to Whitefish Point, which is not only a hotspot for migratory birds, but the closest Michigan gets to Canada.

The Doctrine of Retroactivity in Michigan

As each year progresses it is a fact of legislative and legal life that laws and judicial opinions are changed or modified.

As to legislative changes, these are found in amended or new statutes. For judicial opinions, these are found in appellate courts overruling or changing prior decisions to announce new rules of law.

At times, the appellate courts are called upon to decide if these changes are to be retroactive or prospective only.

As to statutes, the general rule is that an amended or new statute is given prospective application only unless the legislature expressly or impliedly identifies its intention to give the statute retrospective effect. However, constitutional due process principles act to prevent retrospective laws from divesting property rights or vested rights.

As to judicial decisions, they are generally given full retroactive effect.

However, in determining whether a judicial decision should be applied retroactively a court considers (1) the purpose to be served by the new rule (2) the extent of reliance on the old rule and (3) the effect of retroactivity on the administration of justice.

An interesting example of such a judicial decision is found in the Michigan case of *Metrish v Lancaster* presently pending before the United States Supreme Court.

The facts of *Metrish* involve a defendant who was charged and convicted in 1994 of First Degree Murder. At his trial, he used what is known as a 'diminished-capacity defense.' This allows a legally sane defendant to offer evidence of a mental abnormality to negate the specific intent required to commit a particular crime (such as first-degree murder). In 2001, the Michigan Supreme Court abolished this defense.

The defendant's conviction was subsequently overturned on other grounds and in 2005, he was retried and convicted again. At the second trial, he was prevented from raising the diminished capacity defense due to the Michigan Supreme Court's 2001 ruling.

The question now before the United States Supreme Court is, should this defense which was allowed in 1995 now be allowed since the crime occurred before the change?

When the final decision comes out, I will make a full report.

"We felt that this pump house could be a vital little asset to the community as long as it's anchored to a larger one. It needs to benefit a bigger structure to make sense business wise," Catallo said in a presentation to Fenton City Council on Monday.

"This is a really great blank canvas," he said. "We think this makes sense. We're in this for a long-haul."

The city plans to offer Catallo an agreement identical to the one with

the fire hall — a five-year lease at \$1 a year, then the option to purchase the building at the end of the five years for an additional \$1. According to Michael

Burns, assistant city manager, no other financial incentives are being discussed.

Catallo presented a budget estimate for renovating the pump house, which came out to \$116,780. The budget only considers things that are necessary for renovation such as electrical issues, plumbing, and drywall. It does not include the costs of items needed to turn the building into a custard shop such as refrigerators and cash registers.

The council responded positively to Catallo's presentation and the idea of the custard shop.

Councilwoman Pat Lockwood said that the custard shop would be a great complement to the Fire Hall restaurant. "I think it's a lot of money you are putting in to the fire hall and I think it's a great project," she said.

"I really, really like the project," said Councilman Les Bland. "For one thing we as a city have been trying for years to see what we can do with the building. I am all for this 100 percent."

Councilman Ben Smith voiced his gratitude to Catallo. "I am thankful that the DDA and Union Joints got together and Curt and his wife Ann have the

vision that they have and are bringing that vision to the city of Fenton. I am just tickled."

After the positive response to the idea, the next step in bringing the Pumphouse from idea to reality is for the city attorney to draft up an agreement between both parties.

Lake Fenton schools closer to getting liaison officer

►Township, school officials looking to hire full-time officer

Fenton Twp. — Lake Fenton Community Schools may get some extra safety next school year.

At Monday night's Fenton Township Board of Trustees meeting, township officials voted to apply for a grant that would help cover the cost of an extra officer. The grant would allocate \$46,174 to Lake Fenton schools and the township for one full-time officer, whose main duty would be patrolling each school.

The total cost for the proposed officer is \$91,560. The remaining \$45,386 cost would be split evenly between Lake Fenton schools and the township, costing each entity \$22,693.

"This has been in discussion for a while. We talked about getting a school liaison (officer) that would go around to all the schools, which is important. It's a safety thing," said Supervisor Bonnie Mathis.

In March, township officials and Genesee County Commissioner Tony Brown (R-Fenton Township) were working to create a small hub station at

Lake Fenton Middle School where an officer could occupy a room, an idea that has been scrapped in favor of an officer who patrols each of the schools. Mathis said she has met with the Lake Fenton Board of Education and it has agreed to pay its share for an extra officer.

"In the summer months when school is down, we're going to be able to use this officer for summer, which is our busiest times," Mathis said. "When you really think of it, it's going to help the schools and the township."

The deadline for the grant is May 22. Although the board voted to apply for the grant, it will have to vote once again to approve the use of an extra officer, should the township be chosen for the grant.

Clerk Robert Krug said that he has spoken with students and administrators at Mt. Morris Consolidated Schools, who have a liaison officer. Krug said the liaison officer has served as a person students can confide in, speaking about drug abuse and bullying.

"The officer is not looked at by a majority of kids as a police officer," Krug said. "It's a relationship, this is somebody they can talk to. They feel it's very beneficial and he goes to all the schools."

The school board may vote on having a school liaison police officer within the next few meetings.

Department heads, police chiefs, fire chiefs, principals, and other area leaders from the city of Fenton, Fenton Township, Linden, and Argentine Township, as well as EMS personnel and state police met for a disaster emergency class.

"Our goal for today is to get to know each other better, get to know who the first responders are, and who will be making administrative decisions at the local and school levels," said Linden Fire Chief Brian Will at the beginning of the emergency class. "Every day we seem to hear a news report about these natural or manmade events, and if it happens here it would involve all of us."

Separated into groups, the local city and school districts were given a series of problems they might have to deal with should a similar scenario occur in real life. The different groups were able to communicate with each other by sending notes to one another and share resources.

"For the first time we had a really good turnout, I think it went really well," Fen-

ton Fire Chief Robert Cairnduff said. "If anything happens in this area it's going to affect everybody. You're not on your own, we are surrounded by a lot of communities."

A variety of tools were used, from the very high tech devices such as tablet computers using Google maps to examine the areas involved in the scenario. A program was used to include visual effects such as fire and smoke on images of Linden to simulate what the area might look like if such a disaster were to strike.

"I thought it went really well," said Linden Superintendent Ed Koledo. "It was a high energy way to bring our staffs through detailed emergency planning as it happens. It helped us see what assets are available out there, and helps us to be better prepared for the future."

"It's only beneficial to all of the communities and residents involved," said Linden City Manager Paul Zelenak. "I think it

shows the forethought of everyone and shows people that we are actively looking at things like this. I think everyone worked very well together. We want to be prepared."

Gifts given to the President from world leaders take some surprising forms

►Bamboo bikes, swords, chew toys — gifts no president can deny

Have you ever been surprised by a really great gift? Well, the President probably has you beat.

No matter which political party you associate with, all it takes is one look at photos of a President before and after his elected term to see how stressful the job can be. Though they may appear to age quickly — there are a few perks to the job, such as being showered by gifts from other world leaders and ambassadors.

According to a listing released by the Department of State, gifts given to President Obama in 2011 take many forms. Common gifts include chess sets, books, vases, statues, and paintings.

Yet, there were plenty of exciting and even a few unusual gifts.

A sword was given to the President from the Attorney General of Qatar.

From the President of the Republic of El Salvador, the President was given a wooden mask carved into the shape of a jaguar head.

The Philippine Ambassador gifted a bike with an estimated value of \$1,060 — because it was made almost entirely out of bamboo.

Some gifts were items that a President could only receive in today's world — iPads, DVDs, and even a video game.

The President does not receive all the gifts — others were given to White House staffers, and some to the First Family. Former French President Nicolas Sarkozy and his wife Carla Bruni gave more than \$30,000 worth of gifts, including to First Lady Michelle Obama, who was given two crystal table lamps valued at \$5,500.

First Daughters Natasha and Malia Obama were given sporting equipment from the German Chancellor, and jewelry boxes from the president of Brazil.

It also pays to be the President's dog — as United Kingdom Prime Minister David Cameron gifted the first dog with a bone shaped chew toy stamped with the U.K. flag.

Unfortunately, if you are planning a presidential campaign just for the unusual and sometimes pricey gifts, there is one downside — the President does not get to keep most of them. The Constitution prohibits anyone in the United States government from receiving personal gifts from a foreign head of state without the consent of Congress.

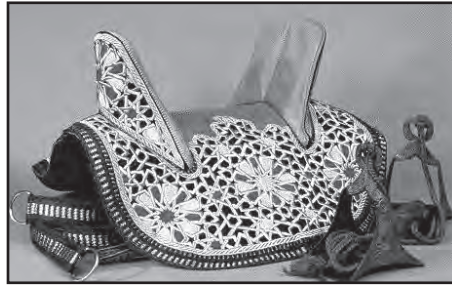
However, gift giving has been a longstanding political tradition. While gifts that are valued more than \$350 cannot be accepted, they are not rejected either. The official reason, according to the State Department, "non-acceptance would cause embarrassment to donor and U.S. Government."

As such, those gifts more than \$350 are handed over to the National Archives and Records Administration to be preserved. From there, the gifts may become part of a presidential library museum collection, or even possibly

given to charitable organizations. Over the years, a wealth of unique treasures from around the world have been collected.

Some of the items sitting with the records administration are ancient pieces of history. A gift given to President Gerald Ford from the Israeli Defense Minister is one of them — a Roman wine cup that is dated to be more than 1,000 years old.

Some gifts have been closely tailored to the interests of the President. According to the National Archives and Records Administration, President Reagan received dozens of saddles from the public as well as foreign leaders. One in particular stands out however, an ornately embroidered saddle made of leather, velveteen and gold thread

in 1985 from the President of Algeria.

Other gift givers include Pope John Paul II himself. In 1994, His Holiness had a private meeting with Clinton, and after the two discussed religion at great length, the Pope gifted the President with the painting of a glass mosaic titled 'The Roman Coliseum.'

Summary

Exploring outer space

► Visit the stars at Flint's Longway Planetarium

Flint — As the stars swirled above, the children watched, leaned back in their seats. The constellations came alive, illustrated with the disembodied voice of their guide through the stars.

The night sky is never clearer than under the dome of the Longway Planetarium in the College Cultural Center, at least in the cities and suburbs of Genesee County.

Summary

► The Robert T. Longway Planetarium is part of Sloan* Longway, and a staple of the cultural center in Flint, providing inexpensive, educational entertainment for children and adults.

Out of more than 30 facilities in the state, the Robert T. Longway Planetarium has the most seats. It is a 20-minute drive from Fenton, and a little

further for Linden residents.

On Monday morning, students from Grand Blanc Community Schools' Brendel Elementary experienced a slide show which personified each of the planets

(and Pluto), giving them characteristics to match their own unique traits. Jupiter was portrayed as a king, with a royal voice, crown and scepter. Uranus had crutches and a bandage, because it is tilted

sideways in its orbit.

The images brought laughs from the students, who learned about the planets of the solar system in a clever way. The presentation was a virtual "solar system safari," narrated by an Aussie-sounding man.

The planetarium experience is nothing without the stars, which erupted over the heads of the kids after the slide show, and a laser pointer was used to explain the different constellations.

Astronomy Educator Richard Walker is usually the one under the dome at Longway Planetarium, but on Monday he took his program on the road with their portable dome.

Field trips like this one are booked up until the middle of June, where Walker will run the program that takes students on a tour of night sky, from any place on earth, at any point in history. He can

program the device to show students the night sky at the times the pyramids were being built.

His favorite part is showing them the sky that will be above their heads that night. "You don't need a telescope. If you want to enjoy outer space, you can walk out to your backyard," he said. "Little kids

like two things — dinosaurs and outer space, and I got half of that."

Though most will view the building itself as the planetarium, technically the high-powered projector that displays the stars in the center of the dome is the "planetarium."

The dome surrounding it is the "theater." The machine is an "ultra high luminescent video tube" that projects the image through a specially designed fish-eye lens onto the dome.

The Planetarium is cooled by three fans and run by as many UNIX computers.

Walker said the show that the students watch takes between three months and a year to program, depending on whether they bought the program, or designed it themselves.

Cathy Gentry is the Sloan* Longway marketing manager. "It's an icon, it's a landmark in Flint," said Gentry, of the planetarium. "It's a place most people have been."

The greenish dome is instantly recognizable, and is part of the cultural center. Gentry said the planetarium is important because it sparks those 'a-ha' moments in visitors. "There's that spark of curiosity, that is a big part of what people experience under the dome," she said, whether it's on this solar system or the universe as a whole. "We are able to touch so many children with that 'a-ha' moment," she said, adding that students from 16 counties visit the facility. Field trips from as far away as Wixom and scout troops from as far north as Traverse City come to learn at the planetarium.

Walker doesn't expect his visitors to remember every star and constellation — maybe the North star and the "Big Dipper," and a few others.

"It's the oldest science," he said. As soon as people could, they started looking up, and exploring the stars, at least visually. "What are those lights, where did they come from and what are they doing up there," said Walker.

For the most part, he just wants his students to want to go outside on a clear night, and look up.

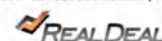

experience working for a government agency," he said. "And they have to swim."

The marine patrol operates entirely on a federal grant from the Department of Natural Resources. It is not supported by any county tax dollars. The federal money funds the marine division throughout the whole year, and covers all of the lakes in Genesee County. The grant provides \$37,000 which is used to cover everything, including personnel, equipment, and fuel.

"It's not a lot of money, but we make it work," Swanson said.

In 2011, the location was used as a photo shoot for New York woman's clothing company Mauric's, which may have made a certain other Christmas-themed Michigan location jealous.

Rogers isn't sure how the place got the name, though a website said that a Munising man had a factory to build holiday gift items around 1938. The factory is gone, but the holiday decorations are still there. "If you blinked you probably would miss it," said Rogers.

In Fenton though, residents are closer to Hell, than Christmas.

Hell is located near Pinckney, and shares a zip code with it. Hell is also not technically its own municipality — residents pay Township taxes. Hell does have its own post office, from which a postcard reading 'I've been through Hell,' is signed and sent to friends and family.

Local business owner John Colone said the name came about because the first mill owner also ran a distillery making moonshine. Men would ride out to the general store, and ride back completely drunk — or the horse would ride back by themselves.

When their family asked what happened, others would report that they "went to hell." The owner of the mill was asked what the town should be called and he said, "Call it 'Hell,' everyone else does."

Today, Colone has built the location into a destination. He owns four of the five businesses including "Screams Ice Cream and Diner." He has built a Halloween theme into everything there. "Halloween was easier to sell than the devil," said Colone.

Only in the summer does the Halloween theme recede into outdoor tourism via kayak rentals.

Puns are plentiful with such an easy topic as Hell — Colone sells 37 different T-shirts with graphics like "Hell: It's safer than Detroit," and "Hell-O."

Colone said 60-70,000 bikers will ride through Hell this summer, and he hopes you do, too. When getting off the phone he says, "Have a helluva day."

Slapneck is a residential area near Chatham, in the Upper Peninsula near Au Train. The community no longer appears on maps and is not technically a municipality like Fenton or Holly. The name still appears on streets schools and a river still bears the name.

Slapneck, according to a hobbyist's website, was named for a surveyor named John Slapnick. Eventually the name became "Slapneck," though the town dwindled to just a residential area by the 1930s. The nearby Village of Chatham, only has 219 residents.

Michigan of course, has dozens of strange city and place names — but writers are always limited by space and time — have a helluva day.


