It's a good thing that Doug (Smitty) Smith of Smitty's Exit-80 Sunoco gas station in Fenton sells more than just gas. "Thank

goodness for minnows and propane," said Smitty. "Everything else is just a break even thing."

Just ask gas station owners about the future of gas prices and

they'll tell you the same thing: it's totally out of their control and they don't know prices from one

day to the next.

"We all get a rack price at about 6 p.m. every night telling owners what our cost will be for the next shipment of gas," said Smitty. "It's up to us individu-

ally how much margin we put on a gallon of gas, based on how much I paid for my last shipment and how much our competitors are charging. I won't raise the price

at the pump until I've sold the lower price load first."

# 'There is a life after prison'

Two-time felon makes another go at life, after 20-year delay

Flint — In the yard of a vacant home on Flint's notorious east side, Ricky Glutz, 42, picks up garbage from a bare spot in an otherwise green lawn. He'll work for an hour, picking up trash, cutting the grass twice — all for around \$15.

He can't lift much, because many of his stomach muscles are detached following a

obstacles to

liver failure, and subsequent complication. But he's been clean from alcohol for 30 months, and he's never felt better.

On Thursday he cleaned up to go to class at Mott Community College (MCC) in Flint.

"I've been a good guy, I just have a problem with the bottle, man," he said. "When I got into the bottle, everything went, you know."

Glutz spent more than

20 years delaying his life, instead choosing to party, drink, and get into fights which landed him in jail several times. He has two felony convictions, one for felonious assault, and another for OWI.

A quick search of his 67th district court records shows about 20 criminal, or traffic infractions on his record.

He feels this may have led to the death of

his mother, at age 52. "She was my best friend," he said. He attributes his lifestyle to causing stress that led to her massive heart attack. "I look back now, I don't even know who that person was."

In 2007, he started his new life, out of prison.

According to the U.S. Bureau of Justice Statistics (BJS), more

than 650,000 men and women are released each year from state and federal prisons, back to their home communities. Ex-prisoners suffer

between 25 and 40 percent unemployment, which can contribute to recidivism — former inmates returning to prison within a year.

This isn't Glutz's plan. Though at age 38 he was released from prison, it took a near death experience to wake him up. The same year, he suffered from kidney failure, as a result of his alcoholism. Basically,

his liver gave up — after his doctor told him continued drinking would kill him.

#### **▶**Reasons for cut remain unclear

**Linden** — For the first time in six years, Barbara Kincaid will not be in the Linden Memorial Day Parade. On Friday, May 20 Kincaid received a call from VFW Post Commander Charlie Blain informing her, "...the decision was made that we will terminate your presence at the Memorial Day Parade."

The decision baffles Kincaid, a Gold Star Mother who had a son pass away while serving for the U.S. Navy.

"If you had not completed your military duty and did not come home, would you like your mother treated in such a way, and your memory?" said Kincaid. "It's disrespectful."

Blain said that parade organizer Doug Morgan took issue with how Kincaid con-

ducted her ceremony for the parade and that Kincaid's involvement does not fall in line with the post's guidelines.

"To be honest, it's an issue that's been going on for a while," Blain said. "It's been settled. My coordinator said no and I'm taking his advice."

Gold Star Mothers is a nationally recognized group of mothers who have lost a son or daughter during their military service. Kincaid has been involved with the organization for more than 20 years and has appeared in many Memorial Day Parades, VFWs and other military events.

State Adjutant Stuart Billey of the Michigan VFW post said he is looking into the matter but is unsure if there is anything he can do about it, since strict guidelines for parades do not exist.

VFW Director of Public Affairs Joe

Davis said in an email to Billey, "My understanding of the disconnect, as it was relayed to me, is Doug Morgan didn't want Mrs. Kincaid to represent GSM (Gold Star Mothers). Instead, he wanted her to only represent and mention Gold Star Parents, which she is not a member of (though eligible)."

In previous parades, Kincaid has laid the wreath

in remembrance of fallen veterans at Fairview Cemetery and flowers in the Shiawassee River for Navy veterans. Kincaid said she has never had a problem with any VFW posts and is unsure why she is being excluded at the last minute.

"I've never been treated like this. This is the first time that there was any disrespect," Kincaid said.

#### **Threat on bathroom stall prompts 'secure** mode' lockdown at Fenton High School

Fenton — On Thursday, classrooms were locked, bomb sniffing dogs patrolled the halls and hall passes were limited as the crackle of police radios were heard.

By 11:30 a.m., Fenton High School seemed completely calm, but the school was in "secure mode" after a written threat was found on a bathroom stall. This means classroom doors are locked, and teachers and students are made aware that they are in secure mode. Outside activities are cancelled and moved inside, and a notice was sent out to parents.

Fenton Area Public Schools Superintendent Timothy Jalkanen described the threat as "a non specific, not credible threat" according to Fenton police.


It's already policy to have the building doors locked, with access via remote camera and buzzer.

Jalkanen said this is the first time in 2013 the school has been secured, and there is no extra administrative cost to switch the school to secure mode.

Fenton police will continue the investigation.

#### Questions 'dispatched' at council meeting

►Issue of changing to Oakland County dispatch services dominates council meeting

**Holly** — One topic took up an entire meeting on Tuesday's Village Council meeting — the Holly dispatch center.

The council is considering contracting with the Oakland County Communications Center for dispatch services for 12, or 24 hours, which they think could save the village \$100,000 annually.

In an unusual format, audience members were able to submit questions directly to the Oakland County Sheriff's Office representatives, specifically Undersheriff Michael McCabe and Chief of Communications Mel Maier. The dispatch center is run by the Oakland County Sheriff's Office.

Lengthy public comment also led to barbs being traded between current council members Ryan Bladzik and President Jason Hughes, and former council member Bill Kuyk over the dispatch assessment ending in 2010.

McCabe and Maier answered all the questions that fell under their umbrella of responsibility, from audience and council members. Topics like special events requiring more dispatch coverage, or catastrophes adsorbing more dispatch time were all addressed. Some of the systems the Holly dispatch uses, such as special patient needs, are addressed in a similar way at the Oakland County dispatch center.

Council member Jackie Campbell has had grave concerns along the way for switching to at least 12 hours of Oakland County dispatch.

Though McCabe and Maier answered all of her questions, a large amount fielded by the audience they had to deflect as an internal matter for Holly police to address. For example, as the dispatchers are at the police station 24 hours a day, there is always someone to watch the jail, and to administer breathalyzer tests. Switching to Oakland County would leave the building vacant.

The PBT (Preliminary Breathalyzer Test) is a strong source of revenue, along with various permits the HPD can issue any time of the night.

Holly dispatch also handles extra administrative tasks. Campbell said that losing this revenue, and/or hiring someone to take on this work could financially defeat the purpose of the Oakland County dispatch. "I just don't want another Silverman/Pulte fiasco," she said, referring to the deal with land developers to extend village water service to a township subdivision that was never completed, losing the village large sums of money.

These concerns are at least in part shared by Hughes, who said the council is way off from even voting on the subject. They are waiting on numbers from Oakland County, in the "buyback" of Village dispatch equipment. "We have to make sure we have all the dollars and figures together," he said. "There's a lot of in-house details we have to work out." In referring to extra administrative work, Hughes said, "We have to make sure to accommodate for all those

As the proposed 2013-14 budget is already balanced, Hughes said the dispatch question is not tied to any specific deadline. "Our concern is looking at this before we're under the gun next year."

Hughes said two resolutions will be needed from the village to change to Oakland County dispatch, which includes Groveland Township.

Campbell at this point said she is weighing the options carefully, and needs more input from the community, whether they like the idea of changing dispatch.

At the time of his retirement and after he learned he had been selected as the grand marshal of Fenton's Fourth of July parade, Cattaneo told the Times that he hoped Fenton residents would remember him as a fair and honest indi-

vidual, a man of integrity and a guy who cares about the community and its people.

Cattaneo was a native Detroiter and began his second career when he moved to Fenton after he retired from the Detroit Police Department following 25 years of service. He will be remembered for implementing the DARE (Drug Abuse Resistance Education) program in Fenton schools and for starting Operation Congregation, which kept kids off the street and out of trouble.

Fenton Mayor Sue Osborn met Cattaneo in 1987 when he came to Fenton to be the new police chief. She remembers him bringing his wife Jeannette and three kids,

David, Jeffrey and Stacy to the city council meeting to meet everyone. Jeannette became very involved with St. John Church and the community, serving on several boards and commissions until she passed away in 2008.

"He was so eager to come to this community and work here," Osborn said, adding that Cattaneo was with Detroit police in the '60s during the well-known riots.

"He loved the community. He loved the city and the people in it. He loved being the chief and the people loved him. He was a good administrator."

Osborn and Cattaneo remained friends through all these years and the two would go out to lunch occasionally, despite his failing health. "He was very ill toward the end, but he was still so very thoughtful and very determined," she said. "He always thought he could be it (Parkinson's Disease)."

Fenton City Councilwoman Pat Lockwood considered Cattaneo as a dear friend. She and her entire family was close to Cattaneo and his family. "He was such a community-oriented guy," she said. "He was so proud to be in Fenton.

"He came from Detroit and he was a real trendsetter for the police department. He worked really close with the public and he set the stage for the great police department that we have."

Lockwood said as police chief, Cattaneo jumped right in and immediately became engaged with the community. "Everyone respected him. He was a great tribute to our community." She added that his death is a huge loss for all who knew him.

"I swelled up like a balloon, ended up in the hospital, it was mess," he said. "That was the rock bottom for me." Glutz felt that he was on his death bed, and said he promised to God that if he was allowed to live, he would clean up his life and help others.

Glutz was in and out of jail for the last 20 years, and spent two "flat" years in prison in the Upper Peninsula. He was released in 2007, and is now dealing with a misdemeanor through the 67th district court.

Coincidentally, probation officer Ryan

Gerhardt went to high school with Glutz, in Swartz Creek. "Once he did that time, he's a totally different person," said Gerhardt. "Sometimes they don't change ever." He said he is amazed each time he talks with Glutz.

Though inmates have done their time and are paroled, many will find employment difficult.

After he was released, he found it difficult to find a job. He was job hunting with a friend, and saw him get a job at the same location at which he applied, and did not get a callback, despite a large number of positions being open. He feels like he's still paying for his past crimes.

More recently, he was denied entry to Baker College in Flint because of his record. Baker College of Flint President Julianne Princinsky said felons are decided on a case-by-case basis.

The most recent, violent crimes may exclude applicants, and anyone who does not disclose their status as a felon may face expulsion. "It's sad, but some circumstances were especially violent," she said. "We have to be cautious, we try to serve each and every student, but we have to consider the entire population."

Princinsky said that the policy on felons is company-wide and openly disclosed. As Baker is a vocational school, some specific programs also exclude certain felons. For example, a sex offender will be denied from entering an education program, because the school is aware the felon will not be hired because of their record.

She did not speak about Glutz specifically, but in many cases, the letter of denial usually includes an invitation to try again and how to reapply, but was preceded by a uniformed background check with many criteria.

But Glutz is in school, and he successfully finished his first semester at MCC. On Thursday evening, he goes to class at the Mott Memorial Building at MCC, surrounded by younger students who have no idea what he's been through — or how the real world can be.

Glutz would like to be a therapist, or a social worker and use his experience to help others.

When his work was completed on the yard of the vacant house he said, "There is a life after prison." To him, it's a matter of persistence, and hard work.



Holly Area Schools (HAS) put another foot in the 21st century, as an Apple com-

puter tech plan was approved by the Holly Board of Education on Monday.

The Applelease cost \$159,000 in 2012, with two rolling leases on approximately 200 Apple computers. The council approved the investment of \$335,000, for about 400 computers. The rolling lease payments haven't been established, but were \$174,247 for the 2011-12 school year.

Superintendent Kent Barnes stated that there is no bond, no extra money coming from HAS stakeholders to secure the technology. "We're working with the dollars we have in prudent fashion," said Barnes in his weekly podcast. "I'm so excited about this."

He said the computers are teaching tools to help the students to be better

prepared for the future, and that he appreciates the board's decision.

The tech plan will in total buy around 400 machines, which will include new iMac laptops for faculty, and MacBook Air rolling computer labs for students.

> Technology Officer Matt Mello said Kindergarten through sixth-grade elementary labs, with one lab per school, (four total) will receive a mobile MacAir laptop lab.

> All kindergarten through grade 12 faculty will receive a new MacBook Pro, totaling

Google Chromebooks will also be researched as an option as needed, and some elementa-

ry schools will keep PC netbooks, as they are an effective tool to teach keyboarding, said Mello.

He expects the machines to arrive in the middle of the summer, and then begins the work of migrating the user preferences and information from the current iMacs, which Mello said is a large-scale undertaking.

Resale 360, owned by Donna Hitz of Fenton Township, moved into the Stevens Furniture Plaza at the corner of Poplar Street and Silver Lake Road in March 2009. The shop was a popular destination for residents wanting to sell items through consignment.

By March 2012, people who had signed agreements with Resale 360 to sell their items in exchange for a percentage of the selling price found a locked door and a sign that said the business was closed.

Customers were stunned when they showed up to pick up checks on their sold items. A notice was soon posted on the front door providing customers with an email address to contact so that they could arrange to pick up their unsold items.

For about two weeks after the shop's closing, Hitz arranged to return the majority of items in the shop to their owners. Any items that were not picked up by customers were eventually donated to charity.

Frustrated about not receiving their money, more than 100 people filed complaints with the Fenton Police Department and an investigation was conducted.

Det. Scott Townsend of the Fenton Police Department said Hitz filed for bankruptcy. His investigation revealed that she owed taxes and was attempting to sell the business prior to the final door closing in 2012. She also owned a Resale 360 consignment shop in Brighton.

The detective said Hitz was trying to pay back taxes by selling the business, but when the sale fell through, everything

Based on the sheer number of complaints, Townsend presented the case to the Genesee County Prosecutor's Office. He was informed that no charges would be authorized. He said he was told that the situation was a result of bad business practices rather than anything criminal. Four individuals filed civil cases against Hitz in district court.

Through the bankruptcy process, those who were owed money were listed as a debtor and they would receive money if any became available.

John Potbury, special assistant prosecuting attorney for the Genesee County Prosecutor's Office said, "Based on the results of the police investigation, this appears to be a case of poor business practices where the owner failed to pay her debts until it was too late and there was no money left to pay anyone.

"There was no evidence that the shop owner intended to defraud anyone and no evidence that she used any of the money or assets for her own personal gain."

Hitz could not be reached for comment.

condemned sign issued by the city hangs from a ground level door, as well as a no trespassing sign on one of the windows.

Playing off the building's haunting atmosphere, Crane opened up the former seminary to the public as a haunted house shortly after she bought it in 1995.

"I didn't believe in any ghosts or spirits but I sure do now," said Crane. "I was scared to death of the place."

But shortly after discovering the 145-year-old building was opened up to the public, Crane said city officials closed its doors, condemning it until the proper permits were approved for renovation. Crane has been fighting with the city ever since to lift the condemned status and transform the monastery into a usable facility.

"The mayor and the council in the last 20 years have done nothing but stand in the way and stall," said Crane, who gives piano lessons in a house behind the monastery. "I've fought unbelievable circumstances. Anyone who has tried to buy this... they don't work with anyone.'

Fenton City Zoning and Building Administrator Brad Hissong said Crane needs to get reports from an architect and engineer in order to get the condemned status lifted.

"You can't fix the dry wall, paint it and move on in," said Hissong. "There are lots of unanswered questions before we can get it fixed."

Hissong also added that the city cannot allocate funds to restoring the building since it is privately owned.

Crane said she's turned in several structural engineering and architectural reports to city officials and even went as far as obtaining a degree in architecture in order to work on the building. Over the years, Crane

has attended numerous city council meetings and met with various city officials. The status of the monastery hasn't changed however and the building remains closed to everyone, even Crane.

The monastery was built in 1868 and was originally a Baptist seminary. By 1886 it became a retired home for Baptist priests and their wives. The stone goliath saw more transformations in the next century, retrofitted into apartments between 1935 and 1945. The monastery served a short stint as a learning center for kids in the late '40s. The elderly filled the halls by the 1950s when the building became a nursing home.

Since its heyday as a nursing home, Crane said various people bought up the monastery in hopes of making a profit off it, only to go broke less than six months later. Crane has done everything from hosting fundraisers to applying for grants and reaching out to historical societies.

After many years of being unable to

from ghost hunters and historians, Crane

sees unlimited potential for the building.


Hissong said he would love to work with Crane or anyone else who wanted to

> Fenton City Manager Lynn Markland said he's unsure of how city officials would proceed if they ever came to own the former seminary.

"We don't really have a position on it at this

time," Markland said. "It's kind of hard to make a comment. We'd have to look at what's available to work with and if there are some grants to help restore it."



The price you pay at the pump at Speedway gas stations may actually have more of an effect on local gas prices than the price of crude oil. As a corporateowned and controlled store, Speedway is a wholly owned subsidiary of Marathon Petroleum Corp. and is the fourth largest

chain of company-owned and operated stations in the U.S. There are 1,350 Speedway locations, including about 300 in Michigan.

"Speedway controls everything," said Joe Yusif, who owns the Marathon gas station on Silver Lake Road in Fenton with his brothers, Joe and Mike. He chooses to make a very low margin on

each gallon of gas he sells, so that he can keep a steady stream of customers coming into his convenience store and repair businesses. "I can't make a living from gas," he said. "All I see is the price of the barrel going up and I know that gas

prices will be up."





# Things to consider when choosing a vehicle

Buying a new automobile, be it a brand new car or a preowned vehicle, is a considerable investment. Some buyers agonize over which automobile to buy, while others tend to stick with the same make or model for years on end.

Regardless of which group buyers fall into, there are some things all consumers should consider before buying their next vehicle.

**DRIVER NEEDS:** A large sport utility vehicle might be your dream vehicle, but it might not be the most practical car to start parking in your garage. When examining your vehicle needs, ask yourself what you use the car for. Is it just a vessel to get you from point A to point B? Do you routinely use your vehicle to take your children and their teammates to and from soccer practice? Is your commute long or short? Each of these things should factor into your decision. For example, if your commute to work is especially long, then perhaps a smaller. more fuel-efficient vehicle is the most practical

choice. However, if you routinely carpool or use your car to get the kids to and fro, then a larger vehicle with a more roomy interior might be the best bet regardless of its fuel efficiency.

**BUDGET:** Your budget is perhaps the biggest thing to consider when shopping for a new vehicle. Many buyers intend to finance or lease a vehicle, and sites such as Edmunds.com can help prospective buyers estimate what their monthly car payment will be. The larger the down payment you're able to make, the less your monthly payment will be. In addition, those who intend to finance their vehicle purchases should consider the length of their finance agreement. You might be able to finance a vehicle purchase in as little as 12 months or as long as 72 months. The longer your agreement, the less you will be paying each month. However, you will pay more interest the longer your agreement is and your payment is likely to be the same in the 72nd month, when the vehicle has significantly

depreciated in value, as it was in the first month when the vehicle's value was at its peak.

LEASE OR BUY: The decision to lease or buy is something to consider. Leasing allows drivers to drive a brand new car for far less money than if they were to purchase the vehicle outright, and the terms of a lease are typically far shorter than those when buyers are financing, which allows drivers to get a new vehicle more often. Buying or financing a vehicle has its advantages as well, most notably that you will be making payments for something

you're eventually going to own. In addition, buying or financing gives consumers more flexibility, as they're allowed to sell the car whenever they choose without penalty, something that is not allowed under many lease agreements. In ad-

dition, there are no

mileage restrictions

when buying or financing, while such restrictions are typical when leasing a vehicle.

**INSURANCE:** Some vehicles are more expensive to insure than others. Insurance companies base insurance rates on a host of factors, but those vehicles that have the strongest safety records and are less likely to be stolen tend to cost less to insure. How much you will pay to insure a vehicle also depends on how you will be paying for it. Lenders typically require borrowers who are financing or leasing a vehicle to fully insure the car, which costs considerably more than basic insurance coverage that drivers who buy their vehicles outright tend to choose. Weigh the costs of insuring different makes or models before making your purchase.

Buying a new vehicle requires a considerable financial investment, so buyers should weigh a host of factors before driving their next vehicle off the lot.

#### Routine auto service never more important

A "check-engine" light may signal something as minor as the need to replace an inexpensive oxygen sensor. But if ignored, costly damage to the catalytic converter can ensue.

Nor should service intervals be ignored. Failure to change out the engine's timing belt according to the owners manual's schedule can result in major engine damage if the belt fails. Must less dramatic are routine things such as scheduled oil changes, replacing dirty filters, or simply paying attention to tire pressure. These seemingly minor services help you get better gas mileage.

"The main reason people should get routine auto service is the technology is so advanced and there's so many features that interact with each other," said Jim Hall, owner of Hall Chrysler and Jeep. "It's important for customers to bring in their cars for routine maintenance so we can do preventative maintenance by a trained technician."

Maienbrook enjoys this style of fitness training because of the group support. Through her experiences, she has met many new friends and made what she describes as a 'family.'

"I and everyone who knew me didn't think I could run 10 miles," Turner said. "But I did it in under two hours. If you run by yourself, you have a tendency to talk yourself out of it. But here, there's none of that."

Maienbrook and Turner are both enrolled in the CrimFit Adult training program, which aims to train all skill levels to perform in one of the many Crim races to take place on Aug. 24.

The training is 16 weeks long, from May up until the race date. To participate in the Crim, \$160 must be paid to register in the race and to be provided once-aweek training with a professional.

The Crim races were founded and organized by Bobby Crim, who was a teacher in Davison, around 1960. The Crim races are non-profit and donate proceeds to increase literacy and decrease homelessness in Flint and to various charities, the main of which being the Michigan Special Olympics.

"The Crim has something for all skill levels, from running to walking," Turner said. "The main goal is to get people from the couch to the curb and to build them up to run their best. As a sponsor I get to give back but as a participant I get to be in on the fitness, health and fun."

The Fenton varsity girls soccer team has performed perfectly for seven Metro League games.


Now, if the Tigers want to be outright Metro League champions, they'll have to be perfect one more time on Monday.

cord. So when Balmer was told he was elected to the Michigan Golf Hall of Fame, he understood it had to do with his service to the game.

"It's humbling," Balmer said. "I never expected to be inducted. When I was nominated, it was a great honor just to be nominated. There's a lot of great golfers who are in, but I'm not in because of my golfing ability. I'm in for my service to the golf community. Normally we don't get recognized as much, and I feel great to think they thought I was worthy of it. I never expected it and am humbled by it."

Balmer will be inducted with Tom Doak and Steve Brady on Sunday at the Henry Center at Michigan State University's Forest Akers West Golf Course.

Balmer began his service to golf in 1975 when he became a member of Spring Meadows Country Club, quickly becoming the club representative to the Golf Association of Michigan (GAM), holding the position for nine years. He also began service as a GAM Volunteer Rules Official, something he still does

Balmer said his service to sports began even earlier than that in some ways. He also has a history of running organized bowling, billiards and other sport activities. Originally from Wisconsin, he came to Michigan in 1966 after getting married and getting a job for the City of Detroit's Park and Recreation program. He moved to Fenton in 1968 and worked at General Motor's Institute at Kettering University.

'It's just been part of my background. It's been a part of my make-up most of my life," Balmer said.

Balmer was appointed a Governor of GAM in 1986, and chaired the Junior Committee from 1987 until 1991. He was the chairman of the GAM Long Range Planning Committee as well.

In 2000, he was appointed Interim Executive Director and served as GAM president until 2002. In 2007, he was given the GAM's Distinguished Service Award.

Balmer is a solid golfer in his own right. He didn't start up the game until he was 20, but was a reasonably quick

"I grew up in a small town in Wisconsin and was the youngest of six kids," Balmer said. "I knew what golf was, but it wasn't the sport for us. But I had a friend who asked me to play when I was 20, and I immediately got the bug. That first year I didn't take lessons and I was terrible. My second year I took lessons and got better."

He was good enough to play on the University of Wisconsin-LaCrosse golf team in 1966. His handicap usually is five or better. He's been a one before, and is a six currently because of a few bad spring scores.

The sport has been good to his family as well. Balmer enjoyed watching his daughter, Susan, play at Powers. She helped lead the team to a Class C state championship in 1989. She went on to play collegiate golf at Bowling Green State University.

"It was a joy watching my daughter compete, and going to her first college tournament in Notre Dame," Balmer said. "The first hole she played she birdied. It was so much harder to watch than to play. You go through so many emotional things. I got to caddy for her as well and that was extra special."

I have a 2004 Dodge Neon manual transmission. I was going down the road and all of a sudden I heard a pop. Now it acts like the car is in neutral, you can shift it into gear but it won't go when you let out on the clutch.

Shoney, It sounds like you have had an internal transmission failure or an axle shaft come apart. These cars are known for the differential pin coming out and damaging the case of the transmission. You will need to have it up in the air enough to get to the back side of the transmission. Look at the small curved cover for any kind of damage or leaking fluid. When you have the car jacked up you should also look at the front C/V axles and make sure the boots are intact and not twisted or torn. You can also try rotating the tires while in gear and jacked up to see if the axle shafts spin on both ends like they should. The tires should be difficult or unable to rotate.

What is the difference between coast guard approved vests and other life vests? A non-coast guard approved vest is thinner,

and allows for greater mobility without chafing. "The arm is cut lower and it's very thin. If you have a coastguard approved life jacket, the arm hole is up higher and it's a lot thicker, and there is more of a tendency to chafe," said

For those who live on a lake or do a lot of activities in the water, Rising said she recommends getting both a coast guard approved vest for on the boat, and

# Drinking and boating What's the LAW?

▶Being intoxicated while operating a boat can carry seven-year jail sentence

If you plan to take the boat out this summer with your friends, you should be aware of Michigan laws when it comes to relaxing with alcoholic beverages.

The safest course of action is of course, to not drink while operating a vehicle. Unlike driving, it is not illegal to be consuming alcohol while you are behind the wheel of your boat, as long as you are clearly not impaired while doing so. If you do decide to indulge in a cocktail or beer, it is important to limit yourself, as you do not want to face the consequences of being found intoxicated while boating.

According to the Drunk Boating Act, someone operating a boat is considered intoxicated if they have a blood alcohol level of .10. If you have a blood alcohol level higher than .08, you are considered to be visually impaired. However, even with a lower blood alcohol level you could be stopped depending upon

# **Boat launches**

► Local residents can enjoy all the beauty of area's inland lakes with use of public launch sites

You don't have to live on the water to enjoy the local waterways with such recreational activities as fishing, skiing, swimming, sailing, etc.

In the state of Michigan, there are more than 1,200 public launching sites for boaters, most of which are administered and operated by the Parks and Recreational Division of the Department of Natural Resources. These sites are primarily funded by marine fuel taxes and a share of boat registration fees, according to the DNR.

Use is free to the public, except for those sites that require an attendant for site maintenance and traffic control. A

State Park Permit is required for launches located within a State Park or State Recreation Area.

As with any property, everyday use at boat launches takes a toll on the facilities and users are advised to heed guidelines from the DNR.

Boaters are strongly urged by the DNR to winch their craft onto boat trailers, instead of powering their boat onto the trailer. Boat ramps throughout the state are being badly damaged by boaters who power their boats onto the boat trailer. The strong current created by the boat's propeller causes severe erosion and wash out at the end of the ramp. This condition, in turn, can also cause damage to boat trailers.

The DNR is attempting to repair as many of the damaged ramps as possible, but says that the best solution lies within the boaters to refrain from this practice.

# Boat launches in the tri-county area include:

#### **Fenton Township:**

- Lake Fenton: Boaters may launch their watercrafts at the DNR site off Grove Park Road, east of Torrey Road.
- Lake Ponemah: The public access site is located along the southeastern side of the lake, which is accessed from North Road, just north of Ponemah Drive

#### **Argentine Township:**

 Lobdell Lake: The public access site is on the west side of the lake, which is located south of Silver Lake Road.

#### **Holly Township:**

- Crotched Lake: A boat ramp is at the northern tip of the lake, which is located north of Grange Hall Road and east of Fagan Road.
- Big Seven Lake: Situated in the Seven Lakes State Park north of Grange Hall Road, the public access is available on the west side of the lake.
- **Dickinson Lake:** Inside Seven Lakes State Park, the boat launch site is at the north end of the lake.

#### **Rose Township:**

• Tipsico Lake: A boat ramp is available on the west side of the lake near Rosmar (off Tipsico Lake Road). The lake is located south of Rose Center Road, east of Tipsico Lake Road and west of Hickory Ridge.

if you seem to be clearly acting as if you had a few too many beers.

Should you get stopped while out on the water, you may be asked to submit to a Preliminary Breath Test. Refusing this test can result in a civil infraction and a fine of up to \$100.

If bad judgment results in someone being arrested, this person will be asked to submit to a chemical test.

Violating the Boating Act can result in being charged with a misdemeanor, which carries a sentence of up to 93 days of jail time and is accompanied by a fine of up to \$500, and 45 days of community service for a first offense. If convicted a second time, the penalties become much steeper — up to seven years in jail, a \$1,000 fine and 90 days of community service.

If you are intoxicated while operating a vessel and an accident occurs that results in a death or serious injury, a felony may be charged. Likewise, if a third incident of operating a boat while intoxicated occurs within 10 years of the second, the result is a felony with between one to five years of jail time, and a \$5,000 fine.

A zero-tolerance rule for minors means that any minor found to be drinking and boating are judged as adults on the blood alcohol scale under the Boating Act.

Where you may be embarking on your day of fun on the water does play a role, however. While you may be able to drink out on the lake, the boating access sites on state land may prohibit you from opening or consuming alcoholic beverages.





other non-approved vests for other general water activities. "The non-approved have circular flotation that is even all around, which lets them lean forward and learn to swim," she said. The floatation devices on a coast guard approved jacket meanwhile try to force the wearer's head up out of the water, making it difficult for smaller children to swim in the water with it on.

The non-coast guard approved jackets come in a many different forms, some zip up and buckle, others pull over the head with no buckles, others go over the head with a partial zip to make them easier to put on. Picking one of these life jackets is all about which is most comfortable to put on and wear, as Rising says they are all equally safe.

If you're taking Fido out on the lake, there are even life jackets available for him too. With different colored vests, your pet can be the talk of the lake while enjoying the summer weather and looking good at the same time. Rising says the jackets come in all different sizes so you can find the right life jacket to fit your dog — or other animals.

"We actually have one customer who comes in who puts the dog life jacket on her cat," Rising said.

Water trampolines are also popular, sometimes serving as a platform for jumping or diving into the water. Some manufacturers also offer attachments like logs, slides, bags or mats.





# Here are a few safety guidelines to follow:

- Read the owner's manual and set up the floating toy following their instructions.
- Check your product before set-up to make sure there are no tears and other imperfections.
- It's a good idea for kids of all swimming abilities to wear a life jacket when bouncing on a floating trampoline.
- Teach everyone how to use the trampoline, including yourself. Know how to stop jumping by flexing your knees when coming down.
- Supervise your children at all times.
- **Don't overload your** trampoline. Pay attention to weight and size limits.
- Go inside if a storm is approaching.
- **Don't swim too** close to your trampoline and never swim below it.
- **Don't use any** inflatable toys while under the influence of alcohol or other substances that might cause impairment.
- If the toy contains a slide, use it facing the water, legs first.





DEAR DR. DONOHUE: I have vitiligo, and it keeps spreading over my body. My father had it on his legs. I'm an older lady of brown complexion. This vitiligo is so embarrassing. I wear slacks every day, except to church. Do you know of any cover-ups for it? —C.

**ANSWER:** Vitiligo is the loss of special skin cells called melanocytes, cells that produce the pigment melanin, which gives skin its color. The loss comes about because of an immune attack on those pigment cells. Genes are one of the ingredients that lead to vitiligo. Your father is an example of the genetic influence. The skin patches devoid of melanocytes and melanin become chalky white and are most noticeable on people with dark skin. The patches appear on the face, in circles around the mouth and eyes, on the neck, trunk, arms and legs. Stronger varieties of cortisone in creams, lotions and gels often can coax melanocytes back into the depigmented skin. Many users have enjoyed success with skin applications of pimecrolimus (Elidel cream) or tacrolimus (Protopic ointment). Ultraviolet light, along with the oral psoralen drugs, is another way of repigmenting vitiliginous skin. Quite a few people with vitiligo find it more convenient to apply cosmetic agents to cover the white patches and make them blend with adjacent skin. Covermark (800-524-1120), Dermablend (800-662-8011) and Cover Fx (416-665-7444) are three popular products. I've included the phone numbers of the manufacturers in case you cannot find the products in your area. The National Vitiligo Foundation, Inc., will provide you with information on the many ways that vitiligo is treated. The website is www.nvfi.org, and the phone number (not toll-free) is 513-541-3903. You'll find the foundation to be a friend that can help you cope with vitiligo.

## Fried Cheese-Stuffed Zucchini Blossoms



### Ingredients

- 1 cup all-purpose flour
- 1 cup sparkling water
- 3/4 t. kosher salt, plus extra for seasoning
- 1/3 cup goat cheese, at room temperature
- 2 T. cream cheese, at room temperature
- 2 t. heavy cream
- 1 T. chopped fresh basil leaves
- 1 green onion, finely chopped
- Freshly ground black pepper
- 8 zucchini blossoms
- Vegetable oil, for frying

#### Directions

- 1. In a medium bowl, whisk together the flour, water and salt until smooth. Set aside.
- 2. In a small bowl combine the goat cheese, cream cheese, heavy cream, basil, and green onion. Mix until smooth. Season with salt and pepper, to taste. Spoon 1 1/2 to 2 teaspoons filling into each blossom. Close the blossoms and gently twist the petals to seal.
- 3. In a large heavy-bottomed saucepan, pour enough oil to fill the pan about a third of the way. Heat over medium heat until a deepfrying thermometer inserted in the oil reaches 350 degrees F. (If you don't have a thermometer a cube of bread will brown in about 1 minute.) Dip the stuffed zucchini blossoms in the batter and allow any excess batter to drip off. Fry for 1 to 2 minutes, turning occasionally, until golden brown. Allow the cooked blossoms to drain on paper towels.
- 4. Season with salt and serve with your favorite marinara sauce or vinaigrette.



THE FOLLOWING CONSTITUTES A SUMMARY OF HOLLY TOWNSHIP'S AMENDMENTS TO THE CODE OF ORDINANCES:

SECTION 1 – AMENDMENTS:

Sec. 32-134. Accessory Structures and Uses.

Amend definition: Accessory building means a supplementary <u>detached</u> building or structure <u>incidental and subordinate to the principal building</u> or buildings on the same lot or parcel of land as the main building or buildings.

Add: (2) Accessory buildings may only be constructed at the same time as or after the construction of the principal building or structure on the same lot or parcel of land. Accessory buildings may only be maintained in conjunction with a principal building or structure on the same lot or parcel. If the principal building or structure is destroyed, demolished or removed, the accessory building shall also be demolished or removed.

- (3) An accessory building may be located in a front yard provided it is not in the required front yard setback.
- (5) The accessory building and/or accessory structure shall not create a nuisance or hazard.

SECTION 2 - INVALIDITY

SECTION 3 - EFFECTIVE DATE

This ordinance shall become effective seven (15) days after publication as prescribed by law.


