Purified water now outselling pop

►Wine, spirits sales on the rise as well

Americans are quenching their thirst these days with a healthier liquid. For the first time in decades, water is now outselling pop. From 2001 to 2011, bottled water sales have surged 56 percent according to Market Watch, while carbonated beverages like pop have shrunk 16 percent.

A desire to be healthier and the downed economy are some of the reasons professionals in the food industry believe water has become the liquid of choice.

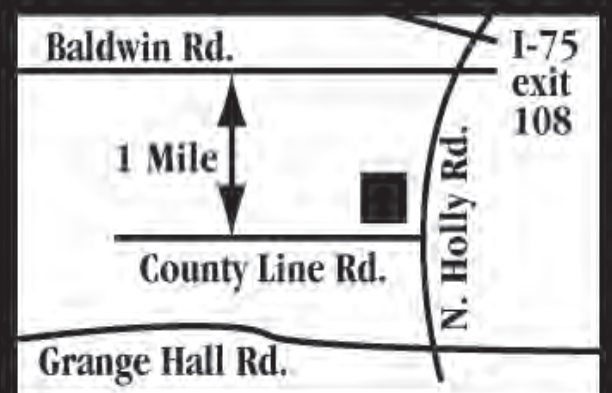

GARAGE FIRE IN HOLLY TOWNSHIP

The North Oakland County Fire Authority (NOFCA) and the village of Holly Fire Department were aided by an Oakland County fire investigator this past weekend. According to NOFCA Chief Jeremy Lintz, the county fire investigator is called whenever local firefighter authorities question how a fire was started. Lintz said the inspector came to Holly Township this past weekend to investigate a garage fire, which was started by electrical wires. So far, NOFCA has had three major structure fires this year and has had to call on county fire inspectors twice. "Bigger fire departments like Detroit have their own investigators," Lintz said. "Smaller municipalities like us don't have them. Having a fire investigator is a perk of using the county resources."

Whether you are spending the lazy days of summer barbecuing in your backyard, or just enjoying a meal in the indoor shade, warm summer days can prompt an increase in food poisoning incidents.

The higher temperatures cause meats to spoil more quickly. Bacteria that can grow on meat can result in nausea and diarrhea, and symptoms can last for up to 10 hours. To avoid an unpleasant bout with sickness — there are a few things you can do.

Check the temperature on your

As the father of a young man who is close to the same age, size and build as Trayvon Martin, I sympathize with his parents.

All they asked in the early days of what quickly became Zimmermanania, was for George Zimmerman to be arrested so the killing of their son wouldn't be shoved aside without a proper investigation.

Now that Zimmerman has been found not guilty, many are asking, did the justice system work? The answer is yes, it worked very well — for the defendant, George Zimmerman.

That's partly because Florida laws in close-call cases like this one give an edge to the shooters.

The big question in Zimmermanania is whether the prosecution proved its case 'beyond a reasonable doubt.'

It turns out that under Florida law I can provoke you into a fight and, if things turn sour on me, I can legally kill you, as long as I 'believe' I am in danger of 'great bodily harm.'

After Zimmerman pleaded not guilty, it was up to the state to prove 'beyond a reasonable doubt' that he either was lying about being afraid for his life or that his fear was not warranted.

To justify the use of deadly force, the jury's instructions said, 'The appearance of danger must have been so real that a reasonably cautious and prudent person under the same circumstances would have believed that the danger could be avoided only through the use of that force.'

In other words, it is not enough for the state to prove that Zimmerman behaved stupidly. Under Florida law, acting stupid in that way isn't a crime. Zimmerman had no obligation to stop or retreat. After he got into his scuffle with Trayvon, it was up to the state to prove Zimmerman had no reasonable fear for his life.

As in the Simpson case, those of us who were not in court will argue forever about whether race or racism was involved. But I have a much harder time living with the injustice suffered by other gun crime defendants who are serving long prison terms without killing anyone.

I HAVE PASSED a driving school truck many early mornings since school has been out and they have had a headlight out this whole time. Why wouldn't they do a daily safety check like school bus drivers do?

WHY DO STORES have a dozen checkout counters and never have nearly half of them staffed? If more customers were to just walk out of the stores and leave shopping carts full of groceries behind perhaps management would provide more manned checkout aisles. Let's try it and see what happens.

THE ONCE GREAT city of Detroit, the crown jewel of liberal policies, has filed for bankruptcy. It is a warning to all local municipalities and their citizens that when you elect and re-elect rogue politicians, overtax the citizens, and let unions run the government, Chapter 9 is inevitable.

columnist**Zimmerman verdict and double standards**

We are so programmed by our history with race in America that reaction to the acquittal of George Zimmerman on charges of murdering Trayvon Martin depends largely upon one's individual experience. If you are African-American, you might react like former Washington, D.C., homicide detective Rod Wheeler. Appearing on Fox News, Wheeler said many blacks look at quarterback Michael Vick, jailed for taking part in an illegal interstate dog-fighting ring, and wonder why Zimmerman gets away with killing a young black man.

If you are white, you might conclude that if the victim had been white and the perpetrator black the media would have shown little or no interest. Or you could point to O.J. Simpson, who was acquitted of killing two white people by a majority African-American jury. Putting all extraneous considerations aside, the jury of six women was asked if there was sufficient evidence presented by the prosecution to convict George Zimmerman of murder or manslaughter.

The jury found there was not. What helps keep us divided is our propensity for labeling and categorizing people. Certain behaviors and language are tolerated, while others are not. Some people can get away with language that others cannot. Some faiths can be disparaged while others are insulated from criticism.

What is needed is one standard. One national identity. One America. We're not there yet. Benjamin Crump, an attorney for Trayvon Martin's family, compared Trayvon's death to those of Emmett Till and Medgar Evers. Any attempt to turn Trayvon into a civil rights martyr similar to Till and Evers goes well beyond the apples and oranges analogy.

More to the point was a comment by Zimmerman's attorney Don West: 'The prosecution of George Zimmerman was disgraceful.' The defense believes he should never have been brought to trial. Co-defense counsel Mark O'Mara speculated about 'how many lawsuits will be spawned by this fiasco.'

Probably quite a few, given our never-ending racial double standard. As both sides noted during and after the trial, there are no winners in this case.

Detroit Lions photographer finds 'ultimate mancave' in Linden

►Gavin Smith purchases old fire hall, plans to incorporate firefighter equipment into decor

Linden — A photographer from Grand Blanc is giving new life to one of Linden's oldest buildings. Photographer Gavin Smith is putting the finishing touches on retrofitting the old Linden fire station into a fully operational studio. Giant photographs of professional athletes cover the red brick walls, as well as original fire fighter equipment from the early 1900s when the fire station was originally built.

"I told the Realtor to find me the ultimate mancave, something I can turn into

a studio," said Smith, who made an offer on the building the same day he toured it. "The city's been great. I'm really trying to play on the history of the building. I'm trying to take it back to as original as possible, with a little flair in it."

Part of that flair will include a full theater and glass wall garage for cars on the first level of the building. Smith said clients will be able to cycle and pick out their photos while viewing them on the theater screen. Plans for a full kitchen are in the works as well.

"So far, the building has an awesome feel to it. As I'm falling more and more in love with Linden, I'm living upstairs more also," said

Smith, who hopes to turn the top level of

"It's a slow build and has been happening over the years. We've been selling less and less pop," said Brian Haaraoja, vice president of merchandising with Spartan Foods. "It's no secret that if you ask Coke or Pepsi that they continue to struggle with sales."

Although pop and other sugary, carbonated drinks dominated diets in the 1980s and 1990s, many of them were attributed to the increase in nationwide obesity. According to the American Medical Association, roughly 10 percent of the population struggled with obesity in America. Today, nearly one in four Americans have trouble with their weight, fueling a public push to steer away from sugary, carbonated drinks.

Earlier this year, New York City Mayor Michael Bloomberg attempted to ban sales of large sodas in his city but the ban was overturned before it went into effect. Still, the attempt to curb drinking larger amounts of pop shows a continuing decline on the drink's popularity.

Just as pop has a wide range of flavors and styles, water continues to diversify and come in a variety of flavors. Enter any random grocery store and you may encounter spring, purified, flavored and artesian water, just to name a few. Throw in packets that can add flavor, protein and other nutritional items, water is now much more flavor-wise than it has been in the past.

"It appeals to health — water is good for you, pop is bad for you," Haaraoja said. "It's also a case of economics. You can buy a case of pop for \$5 to \$6. You can buy a whole case of water for as low as \$2.99."

Pop isn't the only beverage in decline. Milk consumption has decreased by 6 percent and juice has fallen 18 percent between 2001 and 2011. Drinks that have increased in popularity in the same decade include tea (5 percent increase), wine (21 percent increase) and distilled spirits (20 percent increase). Market Watch reports that while drinks in higher alcohol content continue to rise, macro-brewed beers are declining in popularity.

refrigerator and freezer to make certain they are keeping your food at the appropriate temperature. You will want your refrigerator to stay below 41 degrees Fahrenheit and your freezer between 0-5 degrees Fahrenheit.

Transportation is also important in keeping your meals healthy. "After you purchase any fresh meat for sure you don't want to leave it in your car all day. It's important to make sure it gets refrigerated," said Chris Hawk of Alpine Marketplace in Linden.

Once you have the food stored at home, don't forget to eat it before it expires. "Everything has a shelf life (marked) on it, you want to make sure you use it on time. You can always call someone in your local meat department and they should tell you what to do," said Hawk.

Hawk advises against refreezing any kind of meat if it has already been frozen before. Most foods if spoiled will have a particular odor to it, but if you aren't certain if the food is good,

unless you want to spend some of your summer incapacitated, opt for safety. "When in doubt just get rid of it," Hawk said. "It's just not worth it."

A clean kitchen will help you maintain a healthy body. Being lazy may save you a few minutes as you cook, but cost you days as you recover from an unpleasant case of food poisoning.

"You want to keep the utensils you handle it with clean, you want them clean before you handle the meat," Hawk said. "Anything that can grow bacteria, keep clean

when you prepare anything." Bleach water can be used to clean utensils, it is recommended to use one capsule of bleach per gallon of water used.

Perhaps most important of all is to make certain you cook your meat properly. Hawk says with ground meat, bacteria that grows on the outside will get mixed in so you will want to be sure to cook thoroughly. Make certain food is heated to at least 165 degrees to ensure it is safe to eat. A meat thermometer can erase all doubt and make certain the food you serve is not only delicious, but won't make anyone sick.

judge**Competency to stand trial and criminal responsibility, Part II**

Under the law, if a person is not criminally responsible for their actions they are considered legally insane.

Historically Michigan had been what is referred to as a common law jurisdiction in its definition of insanity. This means the courts defined the term as opposed to the legislature in a statute.

The most famous case in this area and which arguably all present insanity definitions at least partly rely on, is an English murder case from 1843 called M'Naghten's Case. Without going into the facts, the M'Naghten Rule came into being and states as follows:

'At the time of committing the act, the party accused was laboring under such a defect of reason, from disease of the mind, as not to know the nature and quality of the act he was doing; or, if he did know it, that he did not know he was doing what was wrong.'

This was Michigan's rule until 1886 when the Michigan Supreme Court announced a new test in People v Durfee. The salient elements of this test were 1) whether the defendant knew what he was doing was right or wrong; and 2) if he did, did he have the will power to resist the wrongful act?

This test was based in part on the M'Naghten Rule and added a component commonly referred to as the 'irresistible impulse' test.

In 1975, the state legislature passed a statute defining insanity. This statute was subsequently amended and the present definition of legal insanity is as follows:

'An individual is legally insane if, as a result of mental illness (as defined by statute) or as a result of being mentally retarded (as defined by statute) that person lacks substantial capacity either to appreciate the nature and quality of the wrongfulness of his or her conduct or to conform his or her conduct to the requirements of the law.'

It is the defendant's burden of proving the defense of insanity by a preponderance of the evidence.

This defense is not frequently used and when it is there is always the possibility of a defendant being found guilty but mentally ill. This verdict results in the same criminal penalty but also requires treatment while the defendant is mentally ill.

Does your lipstick contain lead?

►Study reveals many expose wearers to damaging metal

Ladies, take a moment to sift through your purse. You might find a cell phone, a car key or two, maybe a gum wrapper, but most likely, you will find some sort of lipstick, lip gloss, or colored chap stick.

These products are designed to make women feel beautiful, but a recent U.S. Food and Drug Administration (FDA) study finds that this common beauty product could be exposing you to lead — a metal that, if ingested in high enough amounts, could pose a serious health threat.

Currently, the FDA does not regulate the amounts of lead in cosmetics, but does limit the amount of lead that can be found in color additives to 20 parts per million (ppm). Despite suspicions, the FDA claims that lipstick is intended for topical use only and is consumed in very small amounts.

Lead, however, is a metal that humans should avoid contact with altogether. This can cause damage to organs like the heart

and kidneys. In children 6 and under, lead poisoning can impair mental development.

In the study, the FDA tested 400 lipsticks, lip glosses and tinted chap sticks for lead and found trace amounts in all 400 brands including many Procter & Gamble products such as L’Oreal and Maybelline, and even pricy brands like Dior. Even so-called ‘natural’ brands like Burt’s Bees tinted chap stick ended up landing on the list at number 17.

Fortunately, the Campaign for Safe Cosmetics did its own test to find lipsticks that did not contain any amount of lead and found 11 that were safe to use, including Avon Ultra Color Rich Cherry Jubilee, Body Shop Lip Colour Garnet, Clinique Long Last Lipstick Merlot, Dior Replenishing Lipcolor Red Premiere, Estee Lauder Maraschino, MAC Matte Lipstick Viva Glam 1, Revlon Superlustrous Love That Red, Revlon Superlustrous Bed of Roses, Revlon Colorstay Lipcolor Red Velvet, Tarte Inside Out Vitamin Lipstick and Wet N Wild Mega Colors Cherry Blossom.

slow down a bit, working just six days each week instead of their normal seven, tallying about 70 hours each. They stagger their hours so that one of them is always there.

Dave's the "front guy" for the business, greeting customers, leading staff, etc., while Todd is the "process guy," making daily decisions about ice cream quantities, flavors, etc. Dave admits that his main business product isn't ice cream, it's the "fun" of the ice cream experience. "Anyone can sell ice cream," he said. "What we sell is an experience."

The "fun" comes with a huge price tag of overhead expenses of more than \$10,000 a month, even in the slow months of winter. That means the Durant brothers have to have a strict handle on their

top expenses of labor and ice cream products. "We sell quality, so we don't skimp on our ice cream," said Dave. "We make our ice cream with 15 percent

butterfat, it's the Cadillac of ice cream. Our soft-serve is 6 percent butterfat, also a premium product."

On an average day, Todd will churn three or four batches of ice cream, each making about 40 quarts, in the dairy's micro-creamery located at the back of the store. Every day, he checks the inventory to see what flavors need to be made. "Every flavor

starts with vanilla," said Todd. "That's the staple for everything we do. Then we move on to butter pecan and progressively make darker flavors, ending with chocolate."

On Monday, Todd made an extra batch to help refill the dipping cabinet, because the weekend had been so busy. "We finally got a break in the weather," said Dave. "We're a lot busier when the weather is in the 70s

Summer evenings are the busiest, with 75 percent of their business scooped between 7 and 10 p.m. "That's when we're going full steam," said Dave. The single busiest day of the year is Monday of Memorial Day weekend, "because families haven't left on vacation yet since the kids are still in school." Sundays are the busiest day of the week and Mondays are the slowest.

One of the pivotal business moments in Dairyland history was in 1988, when the Durants started in the frozen yogurt business, right on the heels of the TCBY yogurt craze. "They had all the artificial flavors, while we were and still are, adding fresh fruit to our homemade frozen yogurt," said Dave. "Now frozen yogurt accounts for about a third of our business. With no fat, no cholesterol and zero trans fat, it's a 'healthful' choice for people to enjoy at Uncle Ray's."

Another "sweet treats" local business also touts its healthy offerings as part of its business plan to appeal to the many people who can't eat ice cream.

Panda Water Ice & Sorbetto Co., headquartered in Fenton, promotes its sorbetto, sorbet and Italian water ices as fat-free, soy-free, gluten-free, whey-free, dairy-free and egg-free, made with ice, flavor extracts and natural fruits. These products are old concepts from the days of Emperor Nero in 62 AD, brought up to today's tastes with recipes like Pure Michigan Cherry Vanilla Chocolate Chip and Mango Strawberry.

Owner Steve "Panda" Herman and his business partner Amy Burnett opened the Fenton store in June 2012 to be in the geographical center of mid-Michigan — the hub of natural resources that comprise their product, including fresh water and a full supply of fresh Michigan fruits. Their plans to grow their business throughout the state have already taken hold with two new locations, one in downtown Frankenmuth and one in Genesee Valley Center in Flint Township. They're also looking to grow their brand through franchises, equity funds and wholesaling to restaurants, sports arenas and entertainment venues.

"I've invested heavily in this, well into the seven figures for an infrastructure that can grow," said Herman. "We never intended to be a single store on LeRoy Street in Fenton. This is our headquarters and our 'factory store' for our other two locations."

Study suggests e-cigarettes effective for quitting

According to the Centers for Disease Control and Prevention (CDC), roughly 70 percent of smokers wish they could immediately quit smoking. With an average of 443,000 people dying each year from smoking and the increasing price of packs of cigarettes, it's easy to see why someone would want to quit smoking.

But ask any random smoker and nine times out of 10, they'll tell you that quitting is not so easy.

E-cigarettes (electronic cigarettes) were introduced in 2007 and are a popular alternative to smoking cigarettes. Using vapor and nicotine, e-cigarettes contain no tobacco and can be smoked anywhere, including indoors.

But do e-cigarettes actually help smokers keep away from cigarettes or is it trading one habit for another? E-cigarettes are not regulated by the Food and Drug Administration (FDA) so the long-term effects of the devices are largely unknown. Critics also say that nicotine is addictive, keeping smokers from truly breaking away from their habit.

Despite these criticisms, there is evidence that suggest e-cigarettes do

help smokers keep away from cigarettes. According to a 2011 study done by Webmd.com, 31 percent of e-cigarette smokers said they quit buying cigarettes altogether. Another 33 percent of smokers in the survey said they quit smoking cigarettes and e-cigarettes all together within half a year.

So while far from flawless, e-cigarettes may be the perfect tool for a smoker to get away from the leashes of cigarettes.

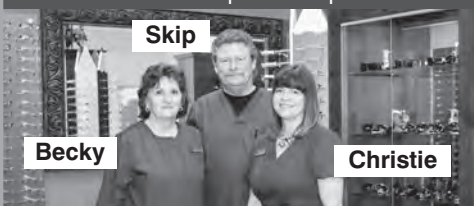

\$64,563. The calculator budgets \$754 in monthly expenses for food, \$607 for transportation, \$711 for housing, \$1,397 for health care and \$1,172 for childcare.

The most expensive Michigan location listed by the calculator is Ann Arbor, at an estimated budget of \$68,140 for a two-parent, two-child home. Meanwhile, the cheapest catchall "rural" category which totaled to \$62,058 for a family of the same size. Flint fell exactly in the middle of the list.

In a report published by the EPI, based on information obtained using the budget calculator, it was determined that for a two-parent, two-child household, housing expenses range from 10.8 percent to 25.6 percent of the family's

budget. Child care, as may be expected influences that amount.

Perhaps the most noteworthy finding from the calculator is just how little many families across the country make. "Even in the best of economic times, many parents in low-wage jobs will not earn enough through work to meet basic family needs," the report states. "Annual wages for one full-time, full-year minimum-wage worker total \$15,080, far below what is necessary for a one-parent, one-child family to live in even the least expensive family budget area," the report reads.

According to its findings listed on the EPI website, it was determined that no matter size or location, "In all cases, they show families need more than twice the amount of the federal poverty line to get by."

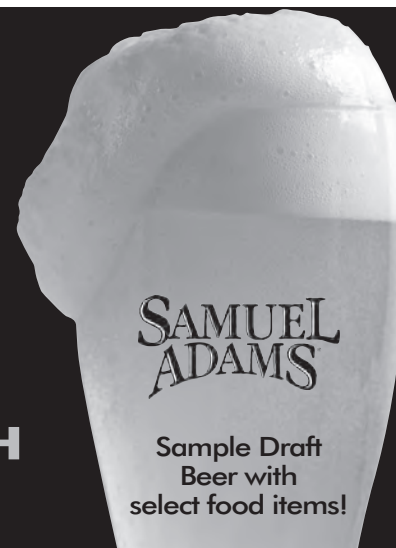

even if they only attended a few services.

"I don't do anything halfway. God made us to be creative and to use our senses," said McKay, who has been with The Freedom Center since 2000. "God is creative—look at all the things he created. We should be more creative than Hollywood when it comes to kids and faith."

After the music, the congregation was broken up by age group, where McKay spoke to high school teenagers about identity and the dangers of changing personalities depending on who they were surrounded by. McKay read his

sermon from an iPad rather than a Bible, using relatable, everyday metaphors to communicate his message. The sermon is delivered in a relaxed setting where the teenagers could talk freely about their concerns.

"Worshipping and service is not about a specific religious format. It's about building a relationship with God," McKay said of his delivery method. "If you do it out of a relationship, you do it out of love."

Ingrim became involved in The Freedom Center in middle school when he attended a service with a friend. Since then, he's learned how to play guitar and sing, as

Youth Leader Bret Carlton, 26, has attended The Freedom Center since he was 8 years old. Like McKay, Carlton delivers his message by recalling personal experiences and reflecting on lessons he wishes someone told him when he was younger. Carlton said kids are drawn to this style of sermon because youth leaders strive to understand them.

"One of the things we like to do is meet them at their level and challenge them to go to the next," Carlton said. "No one else pushes them like that."

the building into an apartment.

To your good health

DEAR DR. DONOHUE: I am a 59-year-old man. About five years ago, I had my spleen removed due to a traumatic injury. I was vaccinated with the pneumococcus vaccine. I was told that it would last a lifetime. Does that apply to a person without a spleen? — J.K.

ANSWER: The spleen is an integral part of the immune system. People who don't have one are more susceptible to infections and, in particular, to pneumococcal infections. The pneumococcus (NEW-moe-KOK-us) causes pneumonia and potentially lethal blood infections. People without a spleen need a second dose of the vaccine five years after the first dose. The pneumococcal vaccine is popularly called the pneumonia vaccine.

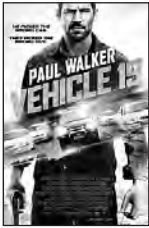

Holly — It was a little warm for it being just 9 a.m., but that didn't stop the tennis players at Bill McDaniel Tennis Complex, located at Holly High School on Thursday.

compressed balls the younger players use during their games.

"They are having fun," Sophia said. "When I was growing up, tennis wasn't all that appealing because everyone was hitting those hard green balls. Now with the new balls, the kids enjoy it more. They can actually play. They can keep score and keep the ball in the court.

They learn not just how to make a swing, but how we move the ball around the court. They learn how we compete and all those things. I think that's really added to our program. You see a lot more of the younger kids. On Monday morning we have more than 50 5-, 6- and 7-year-olds, out with us."

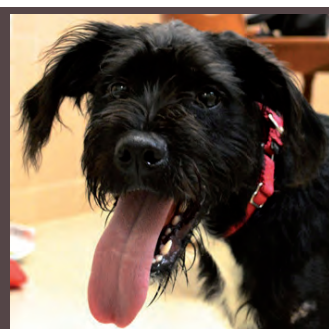

For Pastor Rolf, he was hoping to find the added benefit of helping membership at his church.

everyone knows everyone Rochester is a big city and we had to adjust."

"My dad got me into golf," Baslock said. "We play together all the time in the summer. Also I would have to say my high school coach (as an influence). Coach Wilson, he stepped up and taught me. He really prepared me to play golf at a higher level."

Alexander contributes her success to her family as well as her sister's husband, Eric Dovre. Dovre recently won the Frank Syron Memorial tournament, perhaps Oakland County's most prestigious amateur tournament.

"My whole family played golf so that's what got me started," Alexander said. "After my sister started dating her boyfriend (now husband)... he started helping me too. Golf was something we shared in common and he is the big brother I never had. I have to thank him and my dad for helping me succeed."

And now the two will continue to try to help Rochester College's team to succeed this fall.

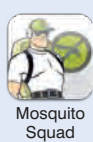

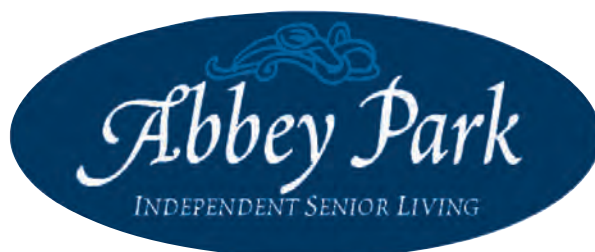
