of the season, against Linden on Thursday, some local athletes will likely be experiencing concussions and other sports related injuries.


Last Thursday, emergency medical staff responded to two injuries, one to a player's neck at a local high school football practice.

According to the Centers for Disease Control and Prevention (CDC), U.S. emergency medical facilities will handle around 173,000 sports and recreation-related traumatic brain injuries, which includes

Knox is facing nine felonies, including one count of possession of heroin in Fenton City; one count of unlawfully driving away of an automobile (UDAA) in Argentine Township; one count of seconddegree home invasion in Fenton City; two counts of UDAA in Fenton City; one count of UDAA in Grand Blanc Township; one count of larceny in a building in Grand Blanc Township and two counts of UDAA in Fenton Township.

Apretrial for Knox has been scheduled for Wednesday, Sept. 4.

Linden — At Caretel Inns of Linden, William Koch, 88, does shoulder exercises with Certified Occupational Therapy Assistant Kayle Corkins, and is then wheeled down to the Turner Hall for lunch.

Most of the guests at Caretel are not long term — many are there recovering from an injury or surgery. In the memory care unit, guests may be there longer.

Choosing a nursing home can be a difficult decision for families or individuals. There is also a big difference between a nursing home, assisted living, and an independent living facility.

Rodney Roberson manages the facility, and he has been working in the industry since graduating high school in 1977.

There are varying levels of care available, with different price point and facilities for residents.

INDEPENDENT VERSUS ASSISTED LIVING

Independent living facilities are for residents who, in general, can take care of

needs," said Roberson, though assisted living has elements of independent living. There will also

be better medical, or memory support. The cost will likely be close to double that of independent living.

The next step up is long-term care, or a nursing home. These facilities have more ability to handle higher medical acuity, around the clock nursing care. The licensing rules are tighter and the facility is more regulated. LPNs, certified CNAs instead of "guest assistants" work with residents. The situation is likely longer term, and will also double in cost.

Memory care is a more individualized living situation, where the needs of each resident is met by different activities.



GOP looks for love by Hillary-hating

Why are Republican Party leaders getting so worked up over a couple of television movies that haven't been produced yet? Oh, yeah, the proposed movies are about Hillary Rodham Clinton.

In their summer meeting last week, the Republican National Committee voted to back up Chairman Reince Priebus' threat to refuse any partnership with CNN or NBC in the 2016 presidential primary debates if the networks proceed with their plans to broadcast programs about the former secretary of state and first lady.

It would have been amusing to watch Priebus justify boycotting a wing of NBC over a movie produced by a wing of Rupert Murdoch's Fox empire.

The Speech, the Dream and Me

It was an atypical August summer day in Washington, D.C., 50 years ago next week. Temperatures were in the low 80s, about 10 degrees cooler than normal. Skies were partly cloudy. Most government officials were vacationing.

I was a young copyboy at the NBC News Washington bureau. Correspondent Jack Perkins asked me to accompany him to hear a speech by Dr. Martin Luther King Jr. at the Lincoln Memorial.

What I knew about African-Americans was limited to my experience with two maids employed by my parents during my childhood. I knew our maids only by their first names. Basketball exposed me to people I might not otherwise have met growing up in an all-white suburban neighborhood. Basketball and socializing with my African-American teammates began to teach me about race, class and discrimination. Then came that August day. Never before and not since have I heard or seen a person with such rhetorical power, conviction and authority. This month, Turner Classic Movies has been running the documentary 'King: A Filmed Record ... from Montgomery to Memphis.' While it has long been available and excerpts have been televised over the years, the broadcast of the entire documentary is magnetic. Mostly without narration, the film is allowed to speak for itself and speak it does.

One sees contorted faces and hears unbleeped profanities hurled at black marchers. 'Go back to Africa!' is one of the few slurs that can be printed in a family newspaper. The scenes are gut-wrenching, embarrassing. Mine was not the only life touched by Dr. King's 'I Have a Dream' speech. It is rightly called one of the greatest orations of all time. For those who were there, this is not an overstatement.

One wonders what Dr. King might think of racial progress today. Yes, there have been great advances in civil rights, but fewer advances in strong black families and economic empowerment.


Dr. King often salted his speeches with spiritual truths such as this one: 'I have a dream that one day every valley shall be exalted, every hill and mountain shall be made low, the rough places will be made plain, and the crooked places will be made straight, and the glory of the Lord shall be revealed, and all flesh shall see it together.'

RECIPES

Fun, yummy treats for tailgating

• GRAHAM NUT CLUSTERS:

6 cups honey graham cereal, 1 cup honey-roasted peanuts, 1 cup coarsely chopped pecans, 1/2 cup butter, 1 cup firmly packed light brown sugar, 1/4 cup light corn syrup, wax paper, 2 cups pretzel sticks, 1 cup candy-coated chocolate pieces.

Preheat oven to 350 degrees. Combine cereal with peanuts and pecans in a very large bowl. Melt butter in a 3-qt. saucepan over medium-low heat; stir in sugar and corn syrup. Bring to a boil over medium heat; boil 2 minutes. Pour butter mixture over cereal mixture, and stir quickly to coat. Spread in a single layer on a lightly greased aluminum foil-lined jellyroll pan. Bake at 350 degrees for 10 minutes. Transfer to wax paper, and cool completely (about 10 minutes). Break into pieces, and toss with pretzel sticks and chocolate pieces.

Texas allows for speeds of up to 85 miles per hour in certain areas. Michigan could potentially see itself joining one of those groups in the not too distant future.

While there is no bill drafted up yet, when finished the legislation could result in increased speed limits all across the state, along many different types of roads, not just the expressway.

"For about four decades, it's been proven that if you post the proper speed limit, it's safer, you have fewer accidents and have better traffic flow," said Jones. "If you get a ticket, auto insurance

rates skyrocket, and if somebody gets a couple of tickets, they have to pay an even higher fee. It's an abuse of the citizens of Michigan."

Changing the speed limit could help fix areas with an artificially low speed limit

— where traffic consistently moves at a much faster pace then the posted speed.

Jones merely wants to lift the cap, however, he believes the speed limits in areas should not be set by politicians, but should instead be done scientifically by the Michigan State Police, or the police in areas where studies are done. Many areas could stay the same.

Fenton Police Chief Rick Aro said that

he would be open to a change in the speed limit around Fenton.

"If studies show that the current limits are too low, I say give it a try," Aro said. "If there is an increase in accidents, then we would have to look at it again."

For now, the possibility is left up in the air, as there is a lot of discussing to be done. Democrats in Lansing have said they will consider the bill, but want to look it over thoroughly before any decisions are made.

Fenton — A new exterior paint job is next on the docket of work to be done to the Fenton Jack

R. Winegarden Library.

Earlier this month, bids were opened seeking a contractor experienced in lead paint removal to scrape the building's external windows, and to prime, chalk, clean, and glaze. The job also includes repainting of the library's stairwells and trim.

Only one bid was submitted — one from Bruce Hatch Painting, a Fenton businesses. Assistant City Manager Michael Burns said that after speaking with their references, he had only been given positive feedback about the company.

In total, the city will be paying \$12,150 for the painting services, and the money will come from the Downtown Development Authority (DDA) fund. While the bid was \$1,350 higher

than the estimate provided from the library feasibility report conducted earlier this year, this was likely due to a lack of businesses submitting bids for the job.

It was speculated at an earlier DDA meeting that most companies with experience in dealing with lead paint removal are working on larger projects.

The city council voted unanimously to accept the bid. "I am glad to see this process on the library get started," said Councilman Bradley Jacob, who also serves as the council representative to the library board.

An update on technology in the courts

In this column I have periodically written about advances in technology, which are or will be used in our court system. Today will be an update on a recent Administrative Order and a proposed Court Rule regarding the use of video communications in the

By way of background, an existing Court Rule allows the courts in Michigan to use two-way interactive video technology to conduct certain types of proceedings and hearings. These include initial arraignments, pretrial conferences, guilty pleas and sentencings. Additionally with the consent of the defendant in a criminal case, certain other hearings may use video conferencing including for a preliminary examination and even a trial.

The common denominator in all of these videoconferences is that the judge is physically present in the courtroom where the hearing is held.

On Jan. 1, 2013 through Administrative Order 2012-7, the Michigan Supreme Court approved the use of remote videoconferencing in certain limited circumstances allowing the judge to be in one courthouse and the other participants in another. For example a judge in Genesee County and specifically assigned to hear the case sitting in a courtroom located in his or her own circuit or district area is allowed to preside over a case in which all of the parties are appearing in Oakland County. A separate local administrative order must also be approved by the State Court Administrative Office.

Additionally on May 1, 2013, the Supreme Court proposed a new Court Rule and amendments of others, which would further expand the use of videoconferencing to allow it at the requests of the participants or on the court's own motion or initiative.

The full text of the latest proposal can be found on the Supreme Court website under ADM 2013-18. The comment period expires Sept. 1. We will wait and see what action the Supreme Court takes on this after that.

As far as picking a level of care, Roberson said "everybody's different. It's up to the individual, only the person can decide what's right." He said it's also not always clear when it's time for family to go to a nursing home.

WHAT TO LOOK FOR

Roberson suggests checking to see if the facility is licensed. "We want that quality, we want those guidelines," he said. Caretel is licensed by the Department of Human Services, Bureau of Health Services, Michigan. He said it's important to know who the facility answers to, to know if they are in compliance, and answer to a standard. Tara Pizzola is a spokesperson for A Place for Mom, who links family members to elder care facilities. "Each

state will license and monitor assisted living communities to ensure the safety and health of the residents, so it's an important factor when reviewing and choosing a community for a loved one," she said, via email. "Each state has its own specific licens-

ing requirements, so it's important to understand what services can and cannot be provided."

Some facilities choose not to be licensed, but then they cannot receive federal funds. Pizzola said that indepen-

dent living facilities are not required to be licensed.

Roberson suggests using your senses when it comes to checking out a facility. Notice first, cleanliness, and appearance. "Are the guests neat, clean, happy?" he said. If

they can smell something sweet — like deodorizers, that could be a red flag. They shouldn't be covering up something with a spray sent. "If it's clean, there's nothing to cover up, there's nothing to mask," said Roberson.

Go in and look around. "Don't go nine to five, drive through at night, or on a weekend, and see what it's like, go in off hours, at 7 a.m.," he said. Roberson said the facility should always be open to tours at any hour.

Roberson had to decide in which facility to place his mother. A deal breaker for him is a reluctance to tour or answer questions, or come in after hours.

Pizzola suggests prospective family or residents to look at senioradvisor. com, as well.

Food is big. "Look at the menu," said Roberson. Also ask how often the same menu repeats. If you wouldn't like, or eat the food, or if it doesn't smell good, these are things to consider. "Mealtime shouldn't be institutional either," he

for their senior's needs and trust their instincts," said Pizzola. "When touring communities, families should take time to check for cleanliness, meet the management, try the dining options, seek out activities that are offered, ask security and safety questions, and discuss personal care options and move-out criteria."

She said it is not unusual for a family to make more than one visit. "By evaluating components like these during the tour process, families can be better equipped to determine whether a community is a good fit."

The upcoming school year brings not only football games and fun, but also more paperwork and added clutter for already busy households.

That's why the fall months are second

only to January in setting goals to get more organized, according to Betty Huotari, of Logical Placement, LLC in Fenton. "It's also a time when many organizational products are on sale."

Huotari says that families tend to be more disorganized now than ever before, because

your life," said Huotari.

Back to school organizational tips:



Concussions are a sudden blow, or jolt to the head, according to webmd. com. It can lead to coordination, sleeping and thinking problems.

Symptoms are persistent headaches, extreme drowsiness, and blurred speech — these could also be symptoms of a serious side effect of the concussion, like a blood clot in the brain, which can be life threatening.

Mitch Smelis is the athletic trainer for Fenton High School. He sees about 25 concussions a year, and most are in contact or collision sports like football, and one in 10 are likely to have a concussion in a year's participation.

Concussions are caused by a direct blow, a body shot, or even whiplash or rotational force. Ten percent will experience a loss in conscience, most of them for a brief moment.

Sometimes a concussion reveals itself through behavior — Smelis has had athletes take a hit, and report to the wrong team huddle, or forget being removed from the game by the trainer. These behaviors are easier to spot; many are not.

The concussion itself is triggered by the brain shaking violently in the skull, and the disruption of brain chemicals. "A concussion is more of a certain disruption for how the brain functions, as opposed to a physical injury to the brain." he said.

"The body has to sort itself out over a period of time, that's why there's not a quick recovery."

Preventing injury doesn't necessarily have to do with equipment. "There is no perfect thing, no perfect helmet, no perfect mouth guard, they're there to prevent injuries," he said. Smelis said

prevention has to do more with proper conditioning and proper technique. It also has to do with culture.

For one thing, he said the helmet is not to be used as a weapon against other players — it's just to protect the player from injury. Even more critical is the culture of not just playing through injuries. Student athletes are encouraged to report any problems they're having. It's up to Smelis to look at the whole picture, and try to decide if the athlete is experiencing a drop in blood sugar, or a concussion.

"The big thing is awareness and education," said Smelis. State law requires that adults, which includes coaches and teachers, to complete a free online training course on concussions. He said they are turning a corner when it comes to concussion reporting and prevention.

The evolution of the football helmet

many orchards to order apples from other parts of the country and in some cases, skip the entire season.

Mueller's Orchard was forced to remain closed during 2012 due to the extreme weather, which completely wiped out their crops.

This summer's cooler temperatures and abundant rainfall have brought crop production back to full speed. The crop is doing so well that the U.S. Apple Association expects 2013 to be the most productive year in the past decade for apples.

The apple trees took a year off and came back in full force," said Wendy Mueller. The apple trees have come back so strong that Mueller expects to have an overproduction of apples. "The reason we didn't open last year is we lost

97 percent of our crop. This year, the trees have been producing like wildfire. There's a silver lining to every cloud and I think this makes everyone understand we live according to the weather."

The Michigan Apple Committee expects 30 million bushels of apples to be produced this year, significantly more than 2012's three million bushels. In 2011, Michigan produced nearly 26 million bushels of apples. While the year break hit orchards hard, the committee said it gave farmers, shippers and packers the opportunity to invest in new equipment and facilities. Michigan is the third highest

apple-producing state, right behind Washington and New York. Overall, apples are estimated to add anywhere from \$700 to \$900 million into the state's economy.

Will Cartwright, manager of Spicer Orchards, said this year's grow season has been a complete turnaround.

"It has been so promising, I've enjoyed farming," Cartwright said. "Last year we knew we were going to have apples from Grand Rapids but it wasn't the same. This year we have a full crop."

Rainfall for this summer has been up overall according to Bob Tritten of Michigan State University Extension,

with some areas seeing an increase of 150 to 300 percent. Adding the cooler evening temperatures and fertile soil, Tritten expects fruit to continue to swell in size well in to the fall.

Back at Mueller's Orchard, production for apple cider and dough-

nuts are expected to start within the next few weeks. Charles Mueller expects his orchard to run all the way to the end of November. While the abundant rain has brought more fruit, Mueller said he has seen a slight increase in fungal diseases amongst his crops. Still, Mueller said this year has been 100 times better than 2012 and estimates his orchard has produced at least 8,000 bushels of apples so far.

"You never completely recover every season. If you can't go a year or so without income, you shouldn't have an orchard," Mueller said. "It's nice to be back in business.'







control of the contest once Bakos scored a first-half goal with 26:45 left in the first half. The goal was set up by a pass from Blake Bloomfield. Bakos received it, had plenty of space in the midfield and took a 40-yard low kick toward the Fenton net for the first goal. Linden led 1-0 and held that lead at the half.

In the second half, the Eagles remained in control. A shot from Ted Parcher hit a crossbar, and a Fenton clear attempt hit the crossbar as well just four minutes into the second half. Finally, the Eagles' pressure paid off with a second goal. A cross by Linden's Tyler Ziccardi was headed by Ben Thornton to McDonald. McDonald also headed it, right into the goal. Linden led 2-0 with 25:29 left in the game.

"I went up for it and got a pretty good head on it and it went in," McDonald said.

Then with 23:45 left Linden's Parcher hit the post with a shot, and the ball deflected to McDonald for an easy second goal.

Last year, the Linden girls cross country team captured the crown. 


