



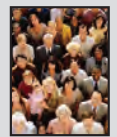

Halloween candy sales reach \$2.4 billion in 2013

►Two-thirds of American candy bar brands have been around for more than 60 years

If you’re like most kids, you’ll sift through your stash of Halloween trick-or-treat candy on Thursday, Oct. 31 and pick out your favorites, while maybe trading your not-so-favorite candy with a sibling or a friend.

The box of raisins and the bag of pretzels may sit there forever, but Reese’s Peanut Butter Cups, M&Ms, Kit-Kats, Skittles and Snickers will likely be gone before anyone else can get to them.

Most of your favorite candies were probably your parents’ favorites, too, as many of today’s most popular candy bars have been around for generations.

In fact, 65 percent of American candy bar brands are more than 60 years old, according to favoritecandies.com, including the Hershey Bar, which was introduced in 1900.

Poker room tied to Fenton schools faces illegal poker game charges

►Superintendent denies any illegal activity

A Flint Township business that hosted charitable gambling events for Fenton Area Public Schools (FAPS) has been shut down by the state due to alleged illegal gambling. Pocket Aces Poker Room, located at Foutch’s Pub and Grill, was issued an emergency suspension from

the Michigan Gaming Control Board (MGCB) last week, a location where FAPS has held charitable poker events.

Fenton Superintendent Timothy Jalkanen said school officials were not involved with any illegal activities associated with the poker room.

“We followed all the guidelines and rules of the laws,” Jalkanen said. “We have no idea what’s going on in their business.”

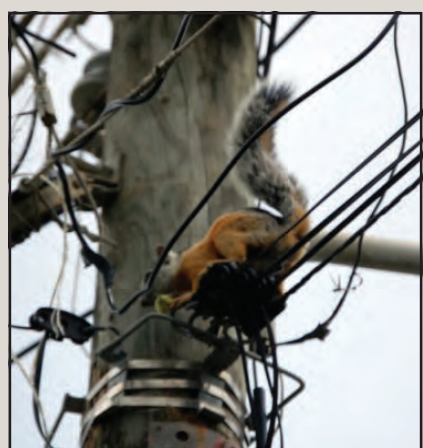

No TV? Blame the squirrels

►Animals account for 30 percent of power substation outages

Squirrels and raccoons are cute and fuzzy — and really good at cutting off power to thousands of people.

Consumers Energy reported that 30 percent of power outages at substations are caused by animals — 63 percent from squirrels and 21 percent from raccoons.

A substation is an important link in the electricity chain. It takes power from the distribution line, and reduces the voltage to be transmitted to utility poles, and then your meter. Substations can service around 6,000 people at once, in a broad estimate by Consumers Energy

MEN STEAL \$1,071 OF STORE MERCHANDISE

Police are seeking arrest warrants on both men for retail fraud and they hope to identify the female driver of the getaway car.

English may still reign supreme as the language of choice in America, but other languages like Spanish, French and Mandarin continue to grow in popularity, especially inside of homes. The Pew Research Center reports that a record 37.6 million people 5 years and older speak Spanish, with 2.8 million speaking Mandarin and another 2.1 million speaking French.

In a world dominated by globalization and the Internet, knowing a second language is becoming a factor for success rather than a novelty.

"Learning a language can be accomplished at any age," said Amy Pardee, a Spanish teacher at Lake Fenton High School. "We live in a global community where communication can be accomplished instantly between countries. Therefore, it is especially vital to know other languages for the sake of communication. If you are bilingual, it opens many opportunities in various occupations."

But other than increasing success career-wise and widening opportunities for college acceptance, knowing another language can improve your health. Trends in Cognitive Sciences

magazine has published reports that indicate being bilingual can delay Alzheimer's and dementia in life by nearly five years. Knowing more than one language also improves memory and critical thinking skills.

In Pardee's class, Spanish is taught by comparing word structure to English words. Students who can hardly speak a word of Spanish at the beginning of the year are writing essays and carrying on full conversations in Spanish by the end of the year.

COLOR BLINDNESS

►Setting the record straight on misunderstood malady

Where one may see the color purple or green, Fenton resident Dan Ingram may see blue or brown. Ingram may be 'colorblind' but that doesn't mean his world is devoid of color.

"Most people think that color blindness means that you see in black and white. I tell people that I see all the colors, I just have a hard time telling the difference between colors," said Ingram, who works as a manager at Bordine's.

"People ask me 'does this color go with this color?' I smile and answer, 'God made all the colors and they all go together.' But seriously, I have learned to deal with color."

Ingram is one of an estimated 32 million people who have some sort of color deficiency in their eyesight. According to the Wall Street Journal, about 8 percent of men and .05 percent of women have a color deficiency.

Color deficiency is better known as color blindness, which Dr. Juan Alvarado of Fenton Vision Center said is not an accurate term for most people who may have difficulty differentiating between certain colors.

"Colorblind" is a very misleading word," Alvarado said, adding that people who are truly colorblind, only see in black and white and are considered legally blind. "The number one cause of color deficiency is a genetic marker you get from your mom. Moms typically give it to their sons and sons typically give them to their daughters."

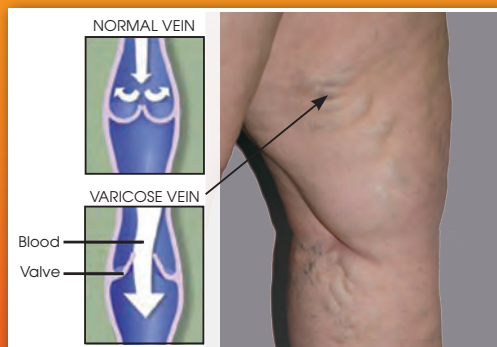

Who would have guessed that President Obama's signature program would roll out with more glitches than the computer program in Mitt Romney's campaign that crashed on Election Day?

You may recall how the Romney campaign's much-touted ORCA program caught a lot of blame after the Republican presidential nominee's defeat.

That sounds familiar now after the botched rollout of the Patient Protection and Affordable Care Act (ACA), also known as Obamacare. Now it is Obama who looks as luckless as Romney did on Election Day.

Like ORCA, the Obamacare website was not adequately tested before it was put online. Before the Oct. 1 launch of Health-Care.gov, the online marketplace website crashed during a simulation in which just a few hundred people tried to log on at the same time, the Post said. Yet federal officials plowed ahead, despite the failures.

Obama has vowed to fix the glitches while also pointing out repeatedly that frustrated site visitors can also shop for insurance and enroll by telephone. True, but the program also needs a functioning website, especially to attract the younger and healthier folks. Their participation is needed to fund health care for the less healthy. Unfortunately, now that we can see actual price menus, we can see in many cases that insurance premiums, deductibles and co-pays are rising. But, it's hard to tell how much of the increase would have happened anyway. Yet the program's relative success in those states that operate their own websites indicates that it mostly is at the federal level that officials bit off a bigger techno task than they could chew.

As numerous Internet startups have demonstrated, starting out smaller is better. The website was produced by 55 contractors working on a system that passes information back and forth between other systems and agencies, plus the private insurance industry, which brings to mind the old saying about too many chefs spoiling the gumbo.

As the Jan. 1 deadline approaches for Obamacare coverage to go into effect, the law, like the federal website, needs more work. But it's worth the effort.

As a child, Alissa McClimans always had a gift of helping others. She visited her classmate, Tamara Johnson who was battling Leukemia and would bring her homework to help her pass her classes.

"I have known her since third grade," McClimans said. "I met her in class and we grew up together. She was in and out of remission and I would visit her."

Johnson graduated from Fenton High School in 2011 and was able to walk with her class after McClimans wrote a speech and went in front of the school board to help her friend. "She was a few credits short, but I tutored her in math and brought her homework," said McClimans.

Now several years later, Johnson is still battling Leukemia and McClimans and her friend Lana Sache joined Team In Training, to prepare and run the marathon on Oct. 13 in honor of Johnson.

McClimans and Sache raised more than \$3,000 for the Leukemia Foundation for research to help find a cure.

In order to run with TNT participants have to raise \$1,350. McClimans raised \$1,500 by contacting family and friends on Facebook and sending cards explaining what

Fenton Fire Hall opening delayed again

►DDA and restaurant owner agree to January 2013, but hoping for December

Fenton — Clarkston Union owner Curt Catallo asked the Fenton Downtown Development Authority (DDA) last week for more time to complete the extensive renovations to the old fire hall on LeRoy Street in Fenton.

The DDA unanimously agreed to give him more time, pushing the date to finish the restaurant at the end of January 2014, though the unofficial goal is to finish in December.

The previously agreed upon dates were Oct. 31 and June 30.

So far, hiring and training for what may be called Fenton Fire Hall — Kitchen and Taphouse, has begun, HVAC systems are installed and wallpaper is going up.

Installing the vintage lighting and new audio/video equipment is being saved until last.

DDA Director Mike Burns said issues with construction have slowed development.

Curt Catallo said, "Nothing so far has surprised us." He added that the building has been cooperative, but they aren't used to a deadline. "You don't know what you're getting into until you get your head under water."

Catallo said they now have a clear view of what needs to be done, and the extra time will give the community the restaurant they're looking for.

Graves attempting to limit back-sewer fees

►State rep. calls legislation common sense, pro business

State Rep. Joe Graves (R-Argentine Township) is continuing his effort to limit the amount of fees municipalities can charge businesses and residents associated with sewers.

Linden business owners Jim MacIntyre and Jack Furry recently traveled to Lansing and testified before the House Local Government Committee in support of House Bill 4492, which would prevent municipal governments from charging more than two years of retroactive sewer tap-in fees. Graves said the bill is a response city officials in Linden attempting to charge nearly 30 years worth of sewer fees last year. Had the

fees been collected, city officials in Linden would have collected more than \$240,000 from 21 different business owners.

"My point was businesses need certainty. They need to know what the fees are going to be ahead of time," Graves said.

Graves hopes to have a bill on the House floor by the end of this year and into the hands of the state Senate by the beginning of next year. He said the bill is currently being vetted by different members of the House and organizations like the Michigan Municipal League for potential flaws.

"This is a common-sense matter of fairness," Graves said. "Local governments should be working hard to keep the businesses they have, not drive them out of Michigan with burdensome retroactive fees."

Spokesperson Terry DeDoes.

A squirrel attracted by the humming sound and the heat of 46,000 volts, climbs into the substation. If he touches energized equipment and the ground, or grounded equipment at the same time, the voltage is transferred through the animal, into the ground, killing the animal and the power to likely all 6,000 of these residents.

Substations don't just service homes and businesses nearby. If the substation on Fenway Drive in Fenton is knocked out for example, it could reach out into different counties.

Of course when the power is out, Consumers Energy is not making revenue, and on top of replacing fried equipment, crews must be brought in. Rodent deaths are being reduced by new, stringent and standardized guidelines for keeping the marauders out.

"If we can prevent these outages it's even better than a quick response," said DeDoes. These outages can take six hours, to a day to repair.

This is enough of a problem that the company that services 68 counties in Michigan is making it a \$150 million priority as it does its annual upgrades. Current substations will be built or upgraded to better protect the substations from animals.

These include tighter mesh fences around the substation, and plastic sheets attached to the upper few feet of the fence. The new standards are stringent; for example, the wires that attach the polycarbonate sheets must run vertical, as to not give the animals something to grip.

In addition, discs can be added to wires leading to, or from the substation to stop climbers, and the fence can be buried deeper if burrowing critters are the problem.

A company news release said the changes are too new to determine if it's helping, but if weather can't be blamed for an outage at your home, the squirrels have figured out how to breach Consumers Energy defenses.

judge****Armed robbery in Michigan, Part I**

In law school, I learned about a number of different criminal law topics including the definitions of various crimes.

One of the definitions was for 'armed robbery.' We were taught that for an armed robbery there had to be a showing of 'larceny,' which means a trespassory taking and carrying away of the property of another with intent to steal it. Additionally for a robbery, it had to be shown that it was property taken from the person or presence of the person. For it to be 'armed robbery,' the robber had to be armed with a weapon or an article fashioned to resemble a weapon.

When I became a lawyer, Michigan had robbery and armed robbery statutes consistent with what I had learned.

In 2004, the Michigan Legislature amended the robbery statutes in several ways. First in the armed robbery statute, language was added that if a person represents orally or otherwise that they have a dangerous weapon this would be sufficient for the being 'armed' element. Additionally the definition of 'robbery' was changed to read as follows:

Robbery

Sec. 530. (1) A person who, in the course of committing a larceny of any money or other property that may be the subject of larceny, uses force or violence against any person who is present, or who assaults or puts the person in fear, is guilty of a felony punishable by imprisonment for not more than 15 years.

(2) As used in this section, 'in the course of committing a larceny' includes acts that occur in an attempt to commit the larceny, or during commission of the larceny, or in flight or attempted flight after the commission of the larceny, or in an attempt to retain possession of the property.

To summarize all of this, if it is shown that a person has a weapon or somehow represents they have one and commits a 'robbery' it is elevated to the life offense of armed robbery.

In Part II, I will discuss a fairly recent Michigan Supreme Court case interpreting the precise meaning of the amended statutes.

Special events require permit, 90-day notification

►Unauthorized events can't be promoted until approved by city

Linden — Special events in Linden will now require a permit, as well as notification to city officials 90 days prior to the event.

City Manager Paul Zelenak said the ordinance came as a response from the past summer, where plans for events were turned in 30 to 40 days prior to the event date. He said city departments and the council need more time to review event plans to properly assess safety concerns and that activities follow city ordinances.

"Obviously, we're willing to work with individuals," Zelenak said. "For lack of a better term, it's more of a training for the individuals to make sure we get it in advance, because we need as much time as possible."

City attorney Charles McKone added that the 90-day period will be used by city officials to determine whether a permit is needed for the event and that the full application process will start afterward. The ordinance does include a waiver for certain events on the 90-day

time period, if approved by city officials.

The ordinance defines special events as a parade conducted upon public streets or sidewalks; a block party, cul-de-sac party or other neighborhood festivity requiring the closing of any street or sidewalk, or any other event that the promoters or organizers should reasonably expect to require an increase in police protection, or a significant increase in motor vehicle traffic.

The ordinance also prohibits any person or organization from advertising or promoting an event unless it is approved by city officials. Organizers utilizing city services are also required to reimburse the city. Zelenak said fees may change over time as wages and expenses fluctuate.

Councilor Ray Culbert said Southern Lakes Parks and Recreation and Linden's Downtown Development Authority (DDA) are already in the stages of planning events for next summer such as the Linden Tune-Up and Music by the Mill.

"These events don't happen overnight," Culbert said. "The 90-day lead time is good, it gives everyone a chance to go back and forth."

According to MGCB Executive Director Rick Kalm, Pocket Aces has violated the Bingo Act multiple times, including:

- Operating and managing licensed millionaire party events without a qualified organization being present
- Falsifying gaming records of qualified organizations
- Retaining more than 50 percent more than the qualified organization's gross profits
- Employees unlawfully participated as players in gaming events at the location he or she represents

Roger Foutch, owner of Pocket Aces Poker Room, said every event held at his business was cleared by the state of Michigan and that he has never accepted more than 50 percent of proceeds from any charity that used his facility. Foutch said FAPS has always had the proper licensing to hold charitable gambling events and have never been involved with illegal activity.

"We've had parents, coaches and teachers here from Fenton. For the state to say

they were running an illegal gambling operation is a slap in the face," Foutch said.

Foutch has not been able to make contact with the MGCB despite numerous calls. He attributed the charges to the MGCB's increased pressure on poker rooms in the past few years. Foutch anticipates that he may have to close down the poker room pending the investigation and future pressure from the MGCB.

Kalm said Pocket Aces was investigated in 2010 and 2011 as well for similar allegations. Since 2010, the MGCB estimates that charities have reported chips sales of over \$530,000,000 since 2010. State law currently allows charities to self-report chip sales to the state.

"The result has been routine underreporting of sales and illegal involvement at numerous locations, many of which call themselves 'Poker Rooms' and are driven by profits and volume, not in helping local charities as evidenced by our investigations," Kalm said in a press release.

Michigan citizens who suspect any illegal gambling operations are encouraged to call the MGCB at (888)314-2682.

Alvarado said vision, color, brightness and movement is identified by four different cones in the retina. Three of the cones are responsible for seeing red, green or blue, while the fourth cone is responsible for registering movement and

other functions of the retina. Alvarado said color deficiencies stem from a cone that doesn't develop fully, causing some people difficulty distinguishing red or green from other colors.

Alvarado said identifying color deficiencies in people is not an easy task, since color can be open to interpretation, especially for someone who sees mostly brown but hears it being called red their whole lives. One indication could be mismatching clothes, others may be not being able to recognize patterns made of different colors.

"Kids should be tested in case they have a disease in the eye of deficiency in color," Alvarado said. "Especially high school students thinking about careers. Law enforcement officials must have full color vision and kids could study criminal justice. If that kid has a color deficiency, they may not be able to use their degree."

For Ingram, he taught himself to recognize that certain colors go with certain words, even if he doesn't see those colors properly.

"There are times when it is a challenge. I am thankful that the DOT makes all traffic lights the same," Ingram said via email.

House Bill 4234: Vehicle trade-in 'sales tax on the difference'

To exempt from sales tax, the value of a trade-in when buying a new motor vehicle, titled watercraft or recreational vehicle, but phase this tax break in over 24 years, and halt the phase-in if the federal health care law's Medicaid expansion (authorized by House Bill 4714) is rescinded. Under this bill and Senate Bill 89, when fully phased-in, the buyer would only pay sales tax on the difference between the value of the trade-in and the purchase price of the new car. Initially, the tax break would only apply to \$2,000 of the price difference, which would increase \$500 per year. When fully implemented the tax break's annual value would reach \$226 million (in 2013 dollars).

Senate Bill 318: Repeal mandatory life sentences for minors

To repeal Michigan's mandatory life sentence with no chance of parole for certain very serious crimes committed by minors, and replace it with a system in which prosecutors could request a genuine lifetime sentence. Under Senate Bill 319, if this request was not made or was denied, a judge would have to impose a minimum sentence of between 25 and 40 years, with a maximum of at least 60 years. These provisions would only apply prospectively, to cases still open as of the U.S. Supreme Court's Miller v Alabama decision in June 2012.

House Bill 4353: Mandate schools have 'epi-pens'

This bill and House Bill 4352 extend legal immunity to school districts, boards, officials, staff and pharmacists for harm arising from use of the devices, except for gross negligence.

Last week, Corlin Builders, the developer for the Cornerstone building made their official pitch to the DDA for a stop gap loan. In August they discovered that the \$3.2 million budget was short by \$800,000. Ghassan K. Saab and father Khalil Saab of Corlin said that the original bids and investment were based on conceptual drawings, which did not give credence to the complexity of the project, mostly due to combining residential spaces and mixed commercial spaces.

Prices have also increased, and stabilizing the ground also cost a chunk of that deficit.

Councilman Brad Jacob, a carpenter, said that he could understand how sudden cost increases can happen, and that this is the phase of the project where this can happen.

Though Councilman Les Bland supports the loan, he made it clear he wouldn't support any more loans. Sorensen Gross CEO Ghassan M. Saab (uncle of Ghassan K., of Corlin) assured council that there will be no more requests for funds. Sorensen Gross is general contractor for the project.

DDA Chairman Craig Schmidt said he had become aware of the situation right away, having met with Corlin

Builders and Sorensen Gross.

Both parties had already agreed to concessions to the tune of \$544,000, which included conceding profits and construction management costs. "I think what you've done to reduce your costs is excellent," said Bland.

Corlin also shaved \$197,000 through "value engineering." This means some details have been taken from plans to save money, like using less expensive brick and eliminating the balconies — a decision which disappointed some council members.

In the end, to close the \$200,000 gap, Schmidt said the best option was a direct DDA loan. He said that without the sacrifices of the builders and developers, the project would have stalled, and it's a good time financially for the DDA to make the loan,

which makes \$4,000 per year for five years, with a final balloon payment of the \$200,000 principle.

"I have never seen so much goodwill," said Saab, of Sorensen Gross, in cooperating to complete the project.

DDA Director Mike Burns said the DDA budget will have to be amended to reflect the \$200,000 loan to Corlin.

The council approved the drafting of a loan agreement from the city attorney, and for the DDA to loan funds to Corlin Builders.

Summary

► To cross out the \$805,000 funding deficit for the Cornerstone building, developer Corlin Builders and general contractor Sorensen Gross conceded profits and fees, and sought savings of \$544,000. They needed an additional \$200,000 loan to continue the project.

DEAR DR. DONOHUE: I have been active all my life. In high school, I played three varsity sports. I am now 60. My doctor told me I have a dropped uterus. Do you think all that physical activity caused it? — B.A.

Area football teams start playoff march on Friday

►Fenton, Lake Fenton host postseason games while Linden travels to Lapeer West

The Linden Eagles looked like a doomed team.

Needing a win to qualify for the playoffs during their last game of the season against Swartz Creek, the Linden varsity football team trailed 22-3 about midway through the second quarter.

But before the contest was over, the Eagles qualified for the playoffs in thrilling fashion, by winning a 40-37 verdict on a Cameron Cook 37-yard field goal with just six seconds left.

The Eagles (6-3) will be the only tri-county area team entering the state playoffs on a high, but also will be the only one of the three starting the venture on the road. Linden plays at co-Metro League champions Lapeer West. Meanwhile, fellow co-Metro champions Fenton (8-1) host Midland Dow and Lake Fenton (7-2) host Williamston. All three games are Friday at 7 p.m.

Linden co-head coach football Denny Hopkins is pleased with the fight his team showed to earn that playoff spot.

"I was really proud that the kids didn't quit," Hopkins said. "They hung in there when we weren't playing our best ball. How often does a team win with six turn-

overs? That hurt us, but we did a good job rebounding in the second half."

Now the Eagles get a chance to avenge a previous loss. Linden lost to Lapeer West 33-11 earlier this season. West's ground game and quarterback Hunter Sharrard hurt Linden by collecting 186 rushing yards as a team in the first game.

"It's our last chance to play them and last time we played them we didn't do very well," Hopkins said. "We know each other, and we're excited about it. We finished strong and got in the playoffs. Now we'll see what happens."

Lake Fenton lost a chance to win a Genesee Area Conference Red title with a 37-0 loss to Montrose. The Blue Devils face a Williamston team (5-3) that is probably much better than their record would indicate. Two of their losses came against defending state champions — Ithica and Portland. Their other loss came against another playoff squad, Lansing Catholic Central. Lake Fenton is happy to be at home during the first round.

"It is a reward for the kids. We've got some tough draws over the years when we had to travel when we

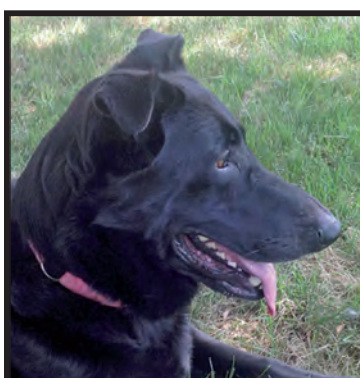
Both programs were thrilled by the collective success of each

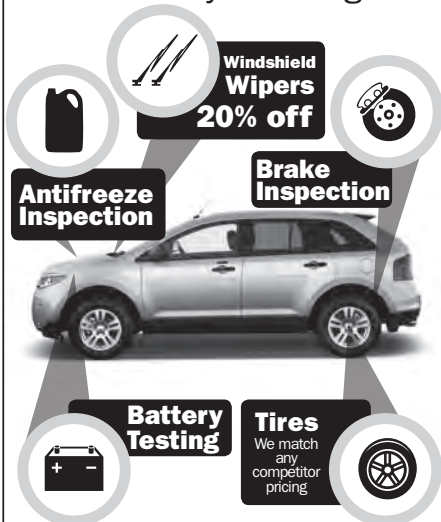

►Two Fenton runners qualify for D1 meet as well

The last time the Holly boys cross country team qualified for the state, the squad placed fifth at the meet, just 51 points behind the eventual state champion Brighton Bulldogs.

But that last time was in 1995, so excuse anyone in the program if they couldn't quite remember those memories of the Broncos being there.

But remembering the last time won't be so tough after Saturday. That's because the Broncos placed third at the Delta College Division 1 regional, qualifying for the state meet to be held at Michigan International Speedway on Saturday.

The top three teams and top 15 individuals qualify for the state meet. The Broncos had four runners in the top 25, helping them post just 105 points, 23 less than second-place Grand Blanc but 23 more than fourth-place Clarkston, qualifying the squad for state. It was a mission that started last year.

"Last year leaving regionals I talked with the team about finishing fifth, having everyone back and having the possibility of finishing in the top three and advancing to MIS," Holly coach Rich Brinker said. "Even with the regional change, we still felt like we had the individuals and the team to advance to do well at states."

The Broncos had two runners within the top 10. Vincent Cantu placed fourth with a time of 16:18.37, about 24 seconds ahead of the race winner Grant Fisher (15:54.29), of Grand Blanc.

Dilon Lemond placed 10th (16:22.39).

The rest of Holly's scoring runners were Nate Frasier in 17th (16:41.30), Kurtis Cooley in 24th (16:59.05) and Zac Felix in 51st (17:33.83). Health was an issue entering the race.

"I sort of had my fingers crossed and have made a lot of wishes in the last couple of weeks for health and wellness for all of my guys," Brinker said. "We entered the meet with Nate and Zac having not put their feet on the ground in two-plus weeks, unless it was a meet. It's not ideal, but my guys have never asked not to run and have given 100 percent each time we have toed the line."

"Vinny and Dilon led the way today, and did what had to be done with Nate not 100 percent. Kurtis had a very solid run to step up and fill in for Zac."

The team hopes to finish near the top 10.

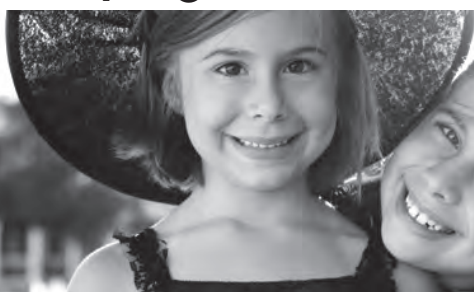
"If we can mend/fix Nate and Zac this week, I like our chances," Brinker said. "If the guys are at 80 percent, I still think we can be in the top 15 to 20 teams."

The Fenton Tigers had two state qualifiers and placed ninth as a team. Jacob Lee was the first sophomore to finish the race, doing so in sixth in 16:19.72. Finishing right behind Lee was his Fenton freshman teammate Dominic Dimambro, who placed seventh in 16:21.51. Dimambro was the first freshman to complete the event, and the only one to earn an individual state invitation.

Three area athletes came close to qualifying. Holly's Alex Matvchuk placed 18th (20:07.48), while Fenton's Torrey Christopher placed 19th (20:19.16). Holly's Abby Brown was 20th (20:20.51).

Eagles' tourney trip ends in state regional finals

Fenton — It was a great season.

It included a Metro League championship, an undefeated title at that.

It included three wins against their biggest rivals, Fenton. The third of those wins earned the squad a district title.

And the season also included an eye-popping 25-2 record.

But the Linden varsity boys soccer season ended three victories short of their ultimate goal — winning a state championship.

Nevertheless, the Eagles capped what was an outstanding season by losing to fourth-ranked (and a past No. 1 team in the state) East Lansing 3-0 at Fenton High School in a Division 2 regional championship contest on Saturday.

East Lansing seized control early, scoring on a penalty kick in the first 10 minutes of the game and never trailed as Linden was shut out for the first time all season.

The players were, obviously, upset to see the season end.

"This means a lot. It was my last season playing with all the guys," senior A.J. Brasseur said. "I love all of the guys dearly. Most of the guys are seniors, so I've been playing with them since freshman year."

"It was the best season I ever had," senior Michael Ziccardi said. "I'll remember the whole 25-2 record and setting a new school record for the boys soccer team. Definitely going undefeated in the league."

"There's not much to say. I'm re-

ally proud of them," Linden coach Kevin Fiebernitz said. "We have a lot of seniors and it was a fantastic year. The parents should be proud of them. The students should be proud of them and the community should be proud of them. They were a classy bunch. ... We were going to play you hard, but we were going to play you pretty fair. Just as a group they did a great job."

East Lansing took control of the game from the start. The Trojans had two shots on net before the third one would put the Eagles down 1-0. Ben Swanson-Ralph was taken down in the Linden box, setting up a penalty kick. Tommy Lammers scored the PK, putting the Trojans up 1-0.

Linden had a couple of chances to tie it up. The Eagles had back-to-back corners with about 14 minutes left in the first half, but the first was cleared easily and the other was punched by East Lansing keeper Blair Moore. Linden had just one shot on frame in the first half. It came on a 45-degree angle shot by Kevin Wright, which was saved. Linden trailed 1-0 at the half.

"The first 20 minutes was key," Fiebernitz said. "We talked about it at halftime. My speech was I thought we gave them too much respect. They were ranked number one throughout most of the year. ... It's a good team. But I think we almost gave them too much respect and almost played too afraid."

The lead grew to 2-0 just 3:48 into the second half when Jared Howenstien scored from about eight yards out.

thought we've done enough to earn the home game," Lake Fenton coach Eric Doyle said. "It's nice to get a home game. The kids are excited about it."

Williamston will pose problems, starting with quarterback Ryan Watters.

"Their quarterback is a really nice player," Doyle said. "They have talented kids, good size up front and get after it. They are a good, solid football team."

girls cross country coach Teresa Wright said. "It is not a competition between two teams. We just hope that everyone can run their best at the state meet and represent Linden with pride on and off the course. Cross country at Linden is one program."

The Eagles showed great pride on Saturday.

The girls dominated their race, scoring 29 points and beating second-place Essexville Garber by 46 points. Lake Fenton also ran in the race and placed fifth with 148 points. Linden's entire starting seven finished in the top 20. After Guy, the rest of the team included Sydney Elmer in third (19:44.07), Jordan Holscher in sixth (19:59.13), Savannah Ferrara in seventh (19:59.88), Courtney Davis in 12th (20:33.29), Taylor Ganger in 19th (21:07.94) and Maya Gossett in 20th (21:13.64).

"We were very pleased," Wright said. "We were the top-ranked team in our region and performed the way we should have. It was a team effort as the top five finished in the top 15, and all seven were in the top 20."

Wright was pleased with Guy's regional title performance.

"McKayla was a pleasant surprise," Wright said. "She is peaking at the right time. It was her season PR. She was behind

the leader at the two mile. Going into the trail she was shoulder-to-shoulder. She managed to pull away coming down the final stretch. It was her first ever high school win. I am proud of her."

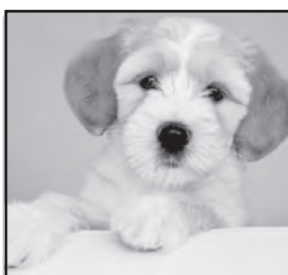
