# **Runner attacked, knocked out**

Police try to identify male suspect, possibly driving an older white SUV

A 56-year-old Fenton Township man was transported to Genesys Health Park in Grand Blanc Township after being struck in the head on Sunday, Dec. 1.

Lt. Jason Slater of the Fenton Police Department said the man is a runner and was out doing his nine-mile run at about 7 p.m. on Sunday. As he ran along Alloy Drive, near the old cinema, he heard someone call out to him to get his attention.

Suddenly, he was struck in the

head by an unknown object. He fell to the ground unconscious. When he awoke, he was lying flat on his back and bleeding from his forehead. He attempted to make his way home, however, he made it as far as the Joe & Lewie's Penalty Box where police were contacted.

Slater said the injured man believed the person yelling to him while he was out running came from an older white SUV, possibly a Tahoe. He was treated for his lacerations.

The case has been turned over to detectives for further investigation. If anyone has information regarding this incident, they are to call Fenton police at (810) 629-5311.

#### K.O. the 'knockout game'

# Fenton monthly sewer rates to increase by \$5.67 per month

no choice but to pay more for county sewer services, which started Sept. 1, it does have a choice on how much cost to pass on to its customers.

This cost is for the District 3 sanitary sewer plant, which is shared by Fenton, Fenton Township and Linden.

At the Fenton City Council work session on Monday, council members discussed the rate increase handed down from the Genesee County Drain Commission in August the first since 2006. This

change is expected to stay until 2018, according to the drain commission.

To ease shock of the increase, the city is lowering its capital charge from \$40 to \$30, which will offset the fee for many users. "This is the system, it's not like we can refuse to participate," said Councilwoman Pat Lockwood. "I'm happy we can reduce (the capital fee) by \$10."

The city is able to reduce this fee because tap-in fees are increasing again, allowing the city to manage its bond debt.

The city runs its own water plant — sewer and water rates are separate and water rates will not be affected by this increase.

According to the drain commission, the average customer will experience an increase of \$5.67 each month, though the amount for many will be less because of the lowered capital charge.

The fee breakdown for each resident is as follows: "readiness to serve" is increasing from \$8.85 to

\$18.35. Metered users will see an increase from \$2.46 to \$2.73, or \$.30 per 1,000 gallons. Un-metered users will experience an increase from \$77.85, to \$98.85.

**Continued from Front Page** there are generally more listings that come onto the market, bringing with them, more competition.

"We approach the month of December the exact same way we do every month," said Shane Adams, of The Shane Adams Group of RE/MAX Select in Flint. "I've been in the real estate business for over 20 years, and we've always sold houses in every single month. December can be a really good month. If you're looking for a home in December, it's likely for re-location reasons for a new job at the first of the year."

For sellers, you're getting serious buyers and much less competition in a smaller pool of for-sale properties. For buyers, you may get a better price and terms because you're likely negotiating with a motivated seller.

"When you've got people calling to look at homes during the month of December, they're not 'tire-kickers," said Tom Jones, of RE/MAX Platinum in Fenton. "These are serious buyers who need a house."

He advises people interested in listing their home to seek out the advice of a pro-

fessional to help them price their property. "We're in a '60 days and under' market," said Jones. "If your house hasn't moved in this environment during this time period, it would suggest that the market is not

willing to respond to your property at that price point. We have a very brisk market, and the numbers are holding up nationally."

Staging is also an important aspect of holiday home sales. "Your house is all decorated and looking its best," said Adams.

Jones emphasized the importance of curb appeal on the outside. "When a person drives up to your home, they're already forming an

opinion about the property. If they feel positive about it from the outside, they're looking for confirmation when they walk through the door."

There is still a shortage of inventory, added Jones. "For every house sold, there are only about four on the shelf," he said. "That means we have only about a quarter of the inventory of homes we usually have." While that makes it a challenge for buyers looking for "the perfect house," it does set the stage for fairly stable or increasing pricing going into 2014. "Our housing prices have gone up 12 percent

in 2012 and 2013, year-to-date," said Jones. "I wish I had a crystal ball for 2014."

"In Fenton, houses have appreciated in value, and demand is higher," said Adams.

While interest rates are going up, which may seem discouraging for first-time buyers in their 20s and 30s, Jones points back in history to give a clearer perspective.

"Interest rates are going up for what you know," said Jones, referring to young buyers. "But

we remember back in 1992 when interest rates were between 14-18 percent. When they finally dropped to under double-digits, we thought it was unbelievable."

While typically fewer homes sell during the winter season than any other time of the year, the season still represents a hefty chunk of sales. "In the course of 12 months, we do about 8 percent of our business in December," said Jones.





# Life without parole for juvenile offenders — an update

Several months ago, I wrote a two-part column regarding the 2012 United States Supreme Court case of Miller v Alabama, which held that the imposition of a mandatory life sentence without the possibility of parole in certain homicide cases was unconstitutional as being contrary to the Eighth Amendment, which prohibits cruel and unusual punishment.

I won't detail everything I said here but suffice it to say the basis of the Opinion was that juveniles should not be treated the same as adults in such cases.

The Supreme Court did not rule as to whether its decision should be given retroactive effect as to juveniles who had already been convicted and sentenced.

Today by way of an update, I can report that on the state level neither the Michigan Legislature (by way of enacted legislation) or the Michigan Supreme Court (by a judicial decision) have given their final answers on the retroactivity issue. However there is pending legislation and the Supreme Court is currently considering three cases that will presumably furnish these answers.

On the federal level in the case of Henry Hill et al v Rick Snyder et al, federal Judge John Corbett O'Meara issued an Order on Nov. 26, 2013 which in essence requires the State of Michigan, the Michigan Department of Corrections and the Michigan Parole Board to provide an opportunity for parole to individuals who had previously been convicted as juveniles of first degree murder and given life sentences.

Judge O'Meara ruled in his Order that the defendants have until Dec. 31, 2013 to comply with eight specific requirements to implement the opportunity for parole process and they have until Jan. 31, 2014 to submit the program and process to the court to comply with the specifics set forth in his Order. If the deadline isn't met, a Special Master may be appointed to make available to prisoners sentenced to life without parole for juvenile crimes the process that the Order envisions.

On Dec. 2, Michigan Attorney General Bill Schuette announced he would appeal this Order to the United States Court of Appeals for the Sixth Circuit.

According to the U.S. Department of Labor's Wage and Hour Division (WHD), minimum wage was enacted in 1938 under President Franklin D. Roosevelt's administration at the height of the Great Depression. The first minimum wage was set at 25 cents an hour and was aimed at stopping sweatshops, where women and children were typically employed to work many hours for next to nothing pay.

Minimum wage rose from 40 cents to 75 cents an hour in 1949 and reached \$1 by 1955. Minimum wage continued to increase through the decades but never reached the point of a livable wage. Minimum wage reached \$1.45 in the 1960s; \$2.90 in the 1970s and \$5.15 in 1997. The current minimum wage rate was established in 2009.

States are allowed to set their own minimum wage rates, yet the Fair Labor Standards Act states "where an employee is subject to both the state and federal minimum wage laws, the employee is entitled to the higher of the two minimum wages." South Carolina, Mississippi, Georgia, Louisiana and Tennessee do not have a minimum wage. Georgia, Arkansas, Minnesota and Wyoming have minimum wage rates lower than the federal \$7.25 rate. Western states like California, Montana, Arizona and other states like Michigan have minimum wage rates higher than \$7.25.

Michigan's current minimum wage of \$7.40 is not enough to live off, according to a living wage calculator created by the Massachusetts Institute of Technology. On average, MIT estimates one adult in Michigan would have to make \$8.73 an hour in order to be above the poverty

rate. Add one child and the minimum hourly rate needed to stay out of poverty is \$18.33.

Historically, minimum wage has not been equal to a living wage nor has it kept up with inflation. According to usinflation calculator. com, an item costing a quarter in 1938 would cost \$4.14 in 2013, after adjusting for inflation. A \$1 item from 1955 would cost \$8.71 today. An item costing \$1.45 from 1960 would run \$10.75 in 2013. Inflation dipped slightly by 1997, where a product costing \$5.50 would now cost \$9.83.

So should minimum wage be comparable to a living wage? Bloomberg News reports raising minimum wage could actually hurt lower income families, since more money would disgualify them from the Earned Income Tax Credit (EITC). Bloomberg News also points out that lower income workers are more likely to spend money on goods rather than invest in stock markets and businesses, stating that raising minimum wage "has ambiguous effects on economic growth."

Princeton economist Paul Krugman argued in the New York Times that having a low minimum wage hurts everyone, since low-wage workers will have to depend on food stamps and Medicaid for survival. Krugman calls the current minimum wage "very low by historical standards." Since most minimum wage workers are in the retail or food industry, Krugman theorizes that these jobs can't be exported and that they're here to stay.

"Despite the lingering effects of the financial crisis. America is a much richer country than it was 40 years ago," Krugman said. "But the inflation-adjusted wages of nonsupervisory workers in retail trade who weren't paid well to begin with — have fallen almost 30 percent since 1973."

get grades in because the systems at our workstations are so slow," Powers said. "Continuous breakdowns... we have that on a weekly basis and we don't have a back stock. It's frustrating working with workstations in our network right now."

Powers suggested the district could raise funds for new technology through a bond, which would need approval from voters within the Fenton school district. Two other alternatives included leasing computers from manufacturers like Apple or Dell and possibly purchasing refurbished computers. Powers said for

\$150,000, the district could get 300 refurbished workstations from a company in Canada.

\$150,000 is a far cry from a \$9 million bond," said trustee Drew Shapiro. "Personally, I think it's more important to look at essentials."

Shapiro told the board that the two previous failed bond proposals could hurt the district's financial rating. Director of Finance Doug Busch said the district uses the state's credit rating when pursuing bonds and that school officials will know by February what the district's official credit rating will be.

Powers added Fenton schools could attempt a leasing option through Apple, similar to what Holly Area Schools (HAS) currently has. According to a May 2012 Times article, the Holly school board approved a \$335,000 investment Powers said the Apple computers were sold to Holly teachers at a bargain price by the end of the leasing cycle, raising \$6,500 toward the next lease. downgraded Fenton Area Public Schools (FAPS) credit rating from Aa3 to Aa2 in

June 2012, stating on their website "\$46.2 million in outstanding parity debt is affected by the rating action." Limited financial flexibility and declining trend of financial reserves are two challenges Moody's predicts FAPS will face in the future.

Fenton superintendent Timothy Jalkanen said the board might have a meeting

next Monday, Dec. 9 for further discussion. By law, a governing board has to post time and place of a meeting 48 hours before it is held.

"We're not sure what's going on. Talking about district finances would be a part of the discussion," Jalkanen said.

The board of education attempted to pass bonds twice last year, once in May and the other in November. Technology upgrades were a major part of both bonds, where the board sought a \$9.6 million bond in May and an \$8.4 million bond in November. New buses and upgrades to infrastructures and parking lots were included in the May bond proposal. The board reduced the second bond proposal by focusing on technology and buses. The May bond failed by a margin of 189 votes and cost the district \$13,466. The November bond failed by a margin of 1,333 votes.

DEAR DR. DONOHUE: My son is 43. When he was 20, he started getting lumps, which the doctors called lipomas. He has them on his whole body in varying sizes, except for on his face. No one else in the family has them. What can be done besides cutting them out? — M.F.

ANSWER: Lipomas are mounds of fat encased in a tough covering material. They range in size from a golf ball to two or three times that size. They're soft, and they are not painful. Surgical removal, at present, provides the best results. If your son has too many for total removal, a select few, the most bothersome ones, can be excised. Research is ongoing to find a substance that will dissolve these fatty tumors. Injection with cortisone medicines can shrink them a bit, but it doesn't totally get rid of them. The results are somewhat mixed, and it isn't a popular treatment.

# ▶ Eagles striving to improve boys basketball product from grade school to prep level

dtroppens@tctimes.com; 810-433-6789 When Anthony Wright looks at Linden High School's banner for championship basketball teams, he gets a bit bothered by the experience.

The Eagles haven't won a Metro League crown since the 1995-96 season and haven't captured any postseason glory since winning a regional title in 1998.

Since then, only Fenton and Lapeer West have captured district crowns, but when it comes to Metro League titles, six other schools have won conference championships. The two others that haven't - Clio and Kearsley — are the league's most recent additions and have actually played Metro contests for a handful of seasons. That fact bothers the second-year coach. And he realizes there's only one way to change it.

"We need to change the culture," Wright said.

"We have the oldest most recent banner up on the wall in our gym (compared to the other Metro schools). We haven't hung a banner since 1998 and everyone else has hung some since then. That is the goal moving forward the next three to four years. We need to change the culture of the entire program. That is the big step we need to take right now."

Wright sees some of that change tak-

ing place from the fourth grade right up to the current squad. JV coach Jason Lund took a group of several elementary players to six 3-on-3 Gus Macker tournaments last summer. While competing, the players — a mixture of Blake Lund, Eli Beil, Mikey Cemezar, Gavin Shepherd and Reichen Lund captured four titles.

"That was a blast," Wright said. "They went to all these towns and beat other teams from other cities in these towns.

"For them though, basketball is their thing they do and that's what we need. A lot more kids are starting to take it seriously."

That same mindset is starting to sneak into the high school program as well. More kids that are considered basketball players first before most other athletic events are sneaking up the ranks. And it should eventually make Wright's job easier. However, it might take at least a couple of years before Wright's dream of another league or district crown is earned since the varsity team remains young.

The only two senior players returning from last year's 2-19 squad are Collin Hoeberling and Travis Rinks. Hoeberling plays at the point and should help set up the offense. Rinks should play at guard as well.

"He's gotten better by a leadership perspective," Wright said about Hoe-See WRIGHT on 15

# Linden's Benford named GAM's Women's Senior Player of the Year

If one is looking for Michigan's top amateur senior golfer, Donna Benford would have to be in the argument.

In fact, over the last couple of years, the Linden resident has proven to be just that according to the Game Association of Michgan's (GAM) Senior Women Player of the Year award.

Benford won the honor by earning the most points during the 2013 season, collecting 405 season points, 25 more than second-place Julie Massa of Holt. It marked the second straight year Benford has won the honor, earning it with 403 points in 2012 and beating out runner-up Susan Nathan by 213 points. In 2011 and 2010, Benford finished third in the standings.

Benford said fellow Linden resident, recent Michigan Hall of Fame inductee and good friend Fritz Balmer told her she won.

"I was very pleased," Benford said. "I knew I was close, but I didn't want to count on it until it was for sure. This year no one won more than one tournament, so it was a race for the rest of the points."

Benford's biggest event of the season was repeating as winner of GAM's Sernior Women's Championship for a second consecutive season. Her 73-69-138 at The Pines in Gaylord earned her the title by a whopping eight strokes. The score was a career low for Benford.

Benford also took third at the GAM Tournament of Senior Championship and made it to the semifinals of the Michigan Women's Senior Amateur (a match-play event).

Benford, a long-time member of Spring Meadows Country Club and the women's champion there many times over, has always been a strong golfer, but her GAM success has been notably stronger since the start of the 2012 season.

"I am not sure why now and not before," Benford said. "Maybe all the lessons are finally paying off. I keep going back to the swing thoughts and practice drills from Paul Haas at Miles and Golf, which has helped me tremendously keeping the drives in the fairways. When I can do that, the rest comes easy."
