A few suspects didn't believe Debbie Wasylyshyn (formerly Debbie Williams) of Linden when she pointed a gun at them and said they were being arrested on drug charges at a police sting set up as a fake wedding in Owosso on Sept. 20, 1990. But in her wedding dress, heels,

and garter that doubled as a gun holster, she helped cuff and arrest 86 local drug dealers. This fake wedding is known as one of the most successful police stings ever.

New \$8 million church underway on Main Street

That was the wish of the last owner of the 13¹/₂-acre parcel of land on Grange Hall Road, before it was sold to Trinity Lutheran Church in 2006 for approximately \$800,000. It's just a "stone's throw" from the current church at 806 Main St. in Fenton.



THE LURE OF A LIGHTHOUSE...

Fenton woman spends a week as a volunteer lighthouse keeper in Ludington

The lure of a lighthouse can be irresistible, especially in Michigan where 129 beacons combine history, the Great Lakes and a sense of solitude. With more lighthouses here than in any other state, it's easy to fall in love with their majesty and mystery.

For Karen Piacentini of Fenton, her love of lighthouses became much more personal after spending a week as a volunteer lighthouse keeper at the Ludington North Breakwater Light in early July.

The Ludington North Breakwater



Light has lighted the way for boaters on the northern breakwater, where the Pere Marquette River meets Lake Michigan, since it was established in 1871. It was first opened to the public in 2006 for climbing







Eating a "row of Oreos" with a glass of milk used to be a nightly guilty pleasure for Dan Ferguson of Fenton Township. Now he prefers healthier snacks and hugs from his family who can easily

from his family who can easily wrap their arms around him. Ferguson, 42, has lost 65

pounds in the last five months, after seeing two of his high school friends post pictures of their newly slim selves on Facebook.

"My friends Mike Collard, Alan Earls and I graduated from Linden High School in '91 and we were all athletes," said Ferguson, who is now principal at Lake Fenton Middle School. "Weight

was never an issue. Somehow, things changed in 20 years and we all had more weight than we wanted. I saw they did something about it and thought I could do whatever it was they were doing, and I was right."

The tool they used for weight loss was Isagenix, a meal replacement shake with a higher protein-to-calorie ratio compared to other brands. He replaces two meals a day (of his choice) with these shakes, and then eats a remaining meal of about 600 calories. "I try to make healthier choices," said Ferguson. "But what I like is that the program is flexible, because I can approach my nutrition based on meals for any particular day outside the system. I certainly have enjoyed open houses, weddings, Super Bowl gatherings. You still have to live."

Like Weight Watchers, Jenny Craig, Medical Weight Loss or other systems, Isagenix for Ferguson has been a means to an end, resulting in weight loss and even more importantly to him, more energy. He adds that he'll continue on the journey even when he reaches his goal weight, because he likes the energy it provides.

> "I always gave my 'day job' at school 100 percent, but in the evenings when I was home with my wife and daughters, I didn't

have much energy left to give them," admitted Ferguson. "I'd sit in the recliner and watch a lot of sports on TV. Without question, I am a better dad and husband now."

Ferguson didn't incorporate exercise into his weight loss plan until he had lost about 30 pounds. When he introduced a little cardio into his routine, he was able to power past the notorious "plateau" that plagues most dieters.

Busch selected as interim Fenton superintendent

■Board of ed says 'both candidates were excellent'

Although Board of Education members said they struggled for a week over which of the two candidates they would choose, in the end they voted 5-2 in favor of giving Busch the job. The other candidate was Mark Suchowski, principal of Fenton High School.

All agreed that both men, who interviewed for the job at the July 13 meeting, were both excellent candidates.

At issue, however, was whether the board wanted someone at the helm who could provide a "fresh set of eyes," with Suchowski, or go with a "proven track record" with Busch.

Busch will continue doing his existing job as well as the interim superintendent job for a year. The search for a permanent superintendent will begin in February 2016.

Trustee Lynn Hopper and Treasurer Tamara Valley cast the dissenting votes.

Hopper said, "I was extremely impressed last week. The presentations (Busch and Suchowski) made were phenomenal. He said he does have a concern, however, with an excessive workload and late hours.

We have to factor in burnout, excess issues could lead to health issues," Hopper said.

Busch laughed and said, "Mrs. Busch shares those concerns."

"New eyes are in order," said Hopper. "New eyes can bring new ideas. If I was to vote right now, I would lean more toward Mark."



The Parks Commission interest is in people using the parks system through the LAFF Pathway, including Linden County Park (Clover Beach on Byram Lake), enabling them to get there with more users

and fewer cars. The trail will be designed for runners, walkers, Rollerbladers, baby strollers, seniors and cyclists, according to LAFF Steering Committee Chairman Victor Lukasavitz of Linden. The newest

estimate of the cost of this project, before the formal engineering study is completed, is \$2.2 million.

"The LAFF Pathway is not a pipedream," said Lukasavitz. "It's going to happen. We're in year one of a three - to five-year process to see a trail on the ground. A lot of the work we're doing now can't be seen, it's preparatory things that are required in a committed, mandated process. We're going for the federal grant money. They want to see the commitment of our local communities and the funding."

By the first week of August, Lukasavitz said that a tax-deductible fund will be set up through the Greater Flint Community Fund, collecting donations from individuals and businesses to help initially with some of the costs of preliminary scoping, then matching funds for grants.

"Fenton Rotary Club has already offered to help us on the funding side," said Lukasavitz. "We're working with Rotarian Noah Morgan, who's also heading our fundraising development committee."

The LAFF Pathway has made its vision more inclusive by recently changing the name from "LAF" to "LAFF," standing for Linden, Argentine, Fenton and Fenton Township.

The steering committee has elected officers, including chairman Lukasavitz, Vice Chairman Denny Duffield, Secretary Shannon Brant and Treasurer Lisa Wismer.

"Our next step this fall is to continue developing our funding for scoping the project, coordinating the project with local communities and keeping our residents informed," said Lukasavitz.

He added that within the next six weeks, an artist's rendering of the trail will be available for the public to see, as well as a detailed layout of the steps required in the See PATHWAY on 15A

Continued from Front Page on wheels — one for garbage and the other for recycling. Markland said at a conference earlier this year that speakers from the Michigan Department of Environmental Quality made a presentation on a new system.

"They informed us that this type of collection system results in doubling the collection of recyclables," he said in April.

The City Council was expected to vote on the matter at its April 13 meeting, but it didn't happen and the matter is yet to be placed on a future agenda.

In the meantime, the city of Linden, Fenton Township and the village of Holly have already implemented the new cart system, much to the dismay of some residents, who have chosen the Times'

Others like the new system, having said the carts are easily wheeled to the curb, keep out critters and don't tip over during gusty winds.

Rudy Mora, a retired school principal from the Carman-Ainsworth district, who has lived and raised a family of 11 children in his Shiawassee Avenue home for more than 50 years, is against the proposed new system.

Among Mora's chief concerns is how senior citizens, especially those with mobility issues, are going to be able to maneuver the carts to the curb.

"They are not going to be able to push those big carts over the snow, the wheels won't move," Mora said. "It's inconvenient. If (seniors) can't shovel their

snow they can't get through with the cart." Another issue is aesthetics. "I came down Linden Road the other day," he said. "It happened to be trash day and there were hundreds of these monsters up and down the road. Some driveways had two of them. It was a horrible sight."

Debbie LaVanway of Tyrone Township, a friend of Mora's family, said her elderly mother lives along Owen Road in Fenton Township. Neither her mother nor her stepfather are in good health.

"She called the company (Republic) to come and get the carts because they are too heavy," LaVanway said. "They told her to try them for a week. She said 'no' so they said someone would be out to get them. So far, no one has picked them up."

LaVanway said her mother's trash pick-up day is Monday. "So every Monday I have to go over there and take out her trash because she can't."

She wonders why the cans have to be so large. "Who has 80 gallons of

enough time to provide education on the new program and give the public a chance to use the tags they have already purchased. Trash collection will continue to take place once a week, while recycling will be collected every other week.

If the new system is implemented, each customer will be charged the same rate and will be invoiced on their quarterly utility bill for the service.

According to Gary Hicks, municipal services manager for Republic Services, the exact charge to city residents has not yet been determined. Currently, city residents pay \$1.60 for each trash tag they use, and are charged \$16 for recycling on the quarterly water bills.

Republic Services plans to charge the city \$10.39 per household for the new system, for a total of \$31.17 per quarter. Hicks does expect some necessary administrative costs to be added by the city.

Hicks said, "I will say the average city resident will see a reduction in cost."

The Senate did not meet this week, while the House convened, but took no votes. This week's Roll Call Report again examines some more recent constitutional amendment proposals of general interest.

House Joint Resolution E: Establish part-time legislature

Introduced by Rep. Michael Webber (R), to place before voters in the next general election a constitutional amendment that would limit annual legislative sessions to 90 days. Legislative proposals to amend the constitution require a two-thirds vote in the House and Senate. Referred to committee, no further action at this time.

House Joint Resolution I: Require property tax assessments to more quickly reflect market declines

Introduced by Rep. Lisa Lyons (R), to establish that if a property's assessed value has decreased, then the property taxes imposed on it must go down in proportion in the following year. Under current practice, assessors use a "moving average" of a property's value over several years, so if values go down an owner could still be assessed more the next year. Referred to committee, no further action at this time.

House Joint Resolution M: Ban "lame duck" legislative sessions

Introduced by Rep. Joel Johnson (R), to establish the first Monday in November as the final day of the legislative session in even years (general election years). In other words, to prohibit "lame duck" legislative sessions held after the election. Referred to committee, no further action at this time.

Senate Joint Resolution J: Increase maximum age of judges

Introduced by Sen. Steve Bieda (D), to place before voters in the next general election a Constitutional amendment to revise the current age limit on judges, from 70 to 75 years old. Referred to committee, no further action at this time.

House Joint Resolution U: Revise effective date of new laws

Introduced by Rep. Edward McBroom (R), to establish that, unless it specifies otherwise, a bill passed by the legislature goes into effect 90 days after the governor has approved it. Under current provisions, the "default" effective date of new bills is 90 days after the legislature adjourns for the year, which can be changed only with a supermajority two-thirds vote. This requirement sometimes is the cause of legislative gamesmanship and "log rolling." Referred to committee, no further action at this time.

House Joint Resolution G: Repeal constitutional ban on private school tuition tax credits

Introduced by Rep. Gary Glenn (R), to repeal a provision in the state constitution that prohibits the state from offering tax credits based on tuition paid to a nonpublic school. Referred to committee, no further action at this time.

House Joint Resolution Z: Ban Obamacare exchange

Introduced by Rep. Todd Courser (R), to prohibit creating a state-based version of the health insurance exchanges that are part of the federal health care law. Referred to committee, no further action at this time.

Senate Joint Resolution E: Ban giving charter school management contracts to for-profit companies

Introduced by Sen. Rebekah Warren (D), to prohibit operation of a public school from being contracted out to a for-profit education management company, which is a common way of operating charter schools. Referred to committee, no further action at this time.

Senate Joint Resolution C: Allow NRTC funds for logging and mining infrastructure

Introduced by Sen. Tom Casperson (R), to include road infrastructure for naturalresource based industries in the things for which Natural Resources Trust Fund money can be used. This money comes from oil, gas, and mineral royalties and leases on state-owned lands, and currently may be used for state land acquisitions, and conservation and recreation projects. Some legislators have expressed concern that, theoretically, nothing prohibits the current constitutional mandate from requiring the state eventually to buy all the land within its borders. Referred to committee, no further action at this time.

Senate Joint Resolution H: Ban welfare for illegal aliens

Introduced by Sen. Joe Hune (R), to place before voters in the next general election a constitutional amendment to prohibit the state from giving any kind of "public assistance" to illegal aliens. Referred to committee, no further action at this time.

House Joint Resolution T: Ban income tax on individuals or businesses Introduced by Rep. Cindy Gamrat (R), to

Introduced by Rep. Cindy Gamrat (R), to place in the constitution a prohibition on imposing a state income tax on individuals or businesses. Referred to committee, no further action at this time.

Aquiles, I would need more information on your vehicle to be able to help with these problems, but here is some information. First, the A/C cutting out when going over hills could be that the engine temp and condenser gets too warm. This system has a switch that will prevent the A/C from running during these conditions. Keep an eye on the temp gauge when the A/C cuts out and see if this is possibly the cause.

As far as the engine not starting after sitting for a couple of days; if the battery is going dead and it is not turning over than you most likely have a battery draw. First things to look for are lights that may be on such as map lights, glove box light, trunk light or visor lights. Sometimes this can be a very hard problem to find and you may need to take it into a shop.



According to Fenton City Manager Lynn Markland and the city's planning consultant, Carmine Avantini, the road was built in the wrong place.

"This property is in the city and a building permit was issued," said Avantini. "As I recall, they met the setbacks using the averaging requirement in the zoning ordinance, and the road is constructed over the private property line.

"Please keep in mind that this road ship Sup was constructed a long time ago and home wa things like this happened," he added.

John Daly, director of the Genesee County Road Commission, said when this happens, it's usually more associated with a gravel road, not a hard surface road.

"It is not common and has not happened on a paved surface that I'm aware of," Daly said. "And I've been here for 15 years."

Fenton Police Chief Rick Aro on traffic safety said, "Fortunately, the location of the curve in the roadway isn't such that the momentum of cars traveling too fast would typically hit it and it's not at a dead end like some homes."

Matt Bacon owns the home directly across the street from the South Long Lake Road house under construction. "It's a monstrosity," Bacon said. "It's a mistake on the lake."

Bacon said the problem is that the speed limit is 25 miles per hour coming

around the curve. "No one goes 25 miles an hour, it's an accident waiting to happen. People fly by. You almost want to put a camera up and watch the accidents happen."

THE OTHER TWO MANSIONS:

The 10,000-square-foot house at the north end of Lake Fenton, first referred to as the "mistake on the lake," was never occupied, and torn down last October.

Prior to tearing it down, Fenton Township Supervisor Bonnie Mathis said the home was set for demolition due to mold and building deterioration.

> As previously reported in the Times, the original building permit for that house was issued in June 2007 and the last inspection recorded was in October 2007. The construction never received final approval and a certificate of occupancy was never issued. According to the permit, the value of the construc-

tion was \$400,000.

A second house, currently located on Enid Boulevard in Fenton Township, is approximately 8,000 square feet in size and very close to the seawall. It was purchased in October 2009 for \$632,000, according to public records.

What people may not realize is the first two large homes are located in Fenton Township, while the house presently under construction on South Long Lake Road is in the city of Fenton — two different jurisdictions.

In order to catch all the drug dealers at once, they decided to get "married" and invited them to the wedding.

Maurice "Vic" Wasylyshyn, a sergeant of the Shiawassee County Sheriff's Department, was 45 years old at the time, orchestrated the entire sting. Debbie and Vic married

a year later on Oct. 20, 1991 and moved to Linden.

At the time of the sting, Flint saw an abundance of drug dealers after General Motors announced the closing of seven plants and thousands of workers were laid off, according to The Atlantic.

The idea was Vic and Moon's, and they



really great idea. I thought it was kind of funny. You couldn't help but laugh about it," she said.

During the undercover work, while they built personas, Vic told them where to buy, whom to talk to, and collected the evidence. On the wedding day, prior to the cer-

emony, Vic and other officers arrested seven people with reverse

buys and took in \$86,000. They had 200 pounds of marijuana and caught the bad guys when they asked to buy.

"There's a lot of tension. When you're going to have as much dope as we have, you worry someone's going to rip you off," he said. Because he was a narcotics officer

who testified in court, some drug dealers knew his face and knew he was an officer.

Flint police officers helped by lending the marijuana and working undercover. They held the dealers incognito at the jail, worried that word would spread in a small community and scare people off from the wedding.

Vic ran surveillance of the wedding in a motorhome stationed outside.



"It was probably the funnest thing I ever did in police work," Debbie said. "Everywhere I go, one of my friends always says 'tell them the story."

• Invitations were sent out, rings were prepared, a few officers formed a band, and food was donated. Part of the cake was cardboard to save money.

• Officers from Shiawassee, Flint, Port Huron, and Davison attended as 'guests" and helped arrest people.

• Debbie found a dress with the help of Moon's wife, Beth, at the Salvation Army for \$17.

• The cue to arrest people was when the band started playing "I Fought the Law (And the Law Won)." One undercover officer asked the cops to stand up and announced that everyone was under arrest.

ARRESTS & CONVICTIONS

During the days after the sting, they served the rest of the warrants, and arrested a total of 86 people.

"The biggest hassle was going to court because the circuit court judge wanted to try these cases jointly," Vic said, explaining that the judge questioned the officers about a few different cases at once and it was hard on their memories.

"I'm thinking we got about 49 people who were actually prosecuted and pled guilty," he said. According to The Atlantic, poor record keeping and a tornado that hit Flint the week of the sentencing made it impossible to know who was convicted

Team loves camaraderie, challenge Great Lakes Relay presents

When Chris Sobczak was asked if he'd like to do an event called the Great Lakes Relay, the Lake Fenton cross country coach thought it didn't sound too tough and decided to go for it.

"When Clint (Lawhorne) asked me to do it, I looked it up and saw every runner had to run 26 miles for the weekend," Sobczak said. "When I saw that, I thought, 'When we go to camp, I do more than that. That's a piece of cake.""

He quickly found out how wrong he was.

But, that said, the experience hasn't soured Sobczak. In fact, Sobczak competed in the most unusual event through the Michigan's Upper Peninsula and northern

The Great Lakes Relay is a three-day outdoor running event which teams of 10 runners race about 300 miles in just about any terrain one can think imaginable in the state of Michigan. Each runner completes about two legs of the relay each day with each leg consisting of about five miles each. One leg may involve running through poorly marked paths through a woods. Another could be through some sand dunes, while another could be on a rocky beach. Another could take you through a river. The event starts at Tahquamenon Falls. One thing is certain — every team is going to have a runner get lost at least once during the three days and by the time the event is over all 10 runners will be exhausted.

Sobczak's team, which included Linden boys cross country coach Clint Lawhorne, Linden resident Dan Skinner and ex-Holly track coach Rob Basydlo, finished 14th during this year's event which was run from July 17 until July 19. Other area runners also compete in the race. A team made up of runners primarily from the tri-county area, won the race last season, but were unable to retain their title this year.

Lawhorne's team wasn't thinking about winning. Finishing the event was the primary goal.

"Our team goal was to finish in the top third, which we did," Sobczak said. "If we had a second goal it was to finish in the top 10 and that didn't happen.

"The greater goal is to have a good time with a good group of guys. We knew we were not going to win anything with the younger teams out there, so having a good time and finishing in the top third were our only real goals."

"I think it's about the camaraderie you get with the team," said Lawhorne, who has done "six or seven" events. "It's a lot of fun from that perspective. And the challenge of running all those miles over that crazy terrain without getting lost."

Skinner, 56, has run the race before, but didn't do it last year due to a knee surgery last July. But this season he helped out the squad

"He asked at the end of April and I told him I just got to running and am not running very fast. But when push came to shove, I reluctantly said, 'yeah.'

"But it's always a great weekend. You get to see all these people you run with. You race with your friends through the years. We see all these people you haven't seen in years."

When the race starts, a runner does his leg while the team takes other vehicles to See **RELAY** on 23A
