## Where else can you 'Drench a Wench'?

### ■ Annual Renaissance Festival fun for all

Repeat visitors to the annual Michigan Renaissance Festival in the shire of Hollygrove know well that there are hundreds of people dressed in period costumes milling about the fair all day on weekends during the season.

It's a misconception, however, that they're just hanging out at the tavern drinking ale. There is much more to these folks who call themselves not patrons, but "playtrons."

At least that's what the people who work there, known as "rennies," call them.

What is likely the one thing people don't know about playtrons, who come from all over the country for the festival, is that they volunteer their time at the festival and conduct many charitable fundraisers.

One is the "Rennie Rescue," in which money is collected for the Renaissance Festival workers to pay for medical expenses and other bills. "Many of them don't have insurance," said Tracy Nussle of Linden.

Another charity fundraiser is called "Drench a Wench," where people pay to throw a wet sponge at a wench. The proceeds go toward breast cancer research.

Nussle, 53, Sherry Smith, 50, of Holly, and Nussle's son, Chad Worden, 33, of Grand Blanc are among the hundreds of playtrons who look forward to playing the part at each year's festival in Holly.

Nussle has been attending for 15 years. Her son has been going for 20 years and

Smith for approximately eight years.

"At least 75 percent of the attendees who come through the gates are playtrons," said Worden.

The three belong to the many different groups that make up the playtron culture.

Nussle, for example, belongs to three different pirate groups, all of which have their own ships, crew and officers. There are about 10 to 15 different ships of pirates at the Michigan Renaissance Festival.

Nussle even has her own pirate name that she uses during the Ren Fest — “One Boot Tracy.” The story behind the name is that she is on a ship with mostly men. Showing she is just as tough as they are, she kicked them in the rear, resulting in the loss of one of her boots. Hence the name.

The three say there are many different groups of playtrons at the festival. They include Vikings, Bulgarians, Washing Well Wenches, Scottish clans, Rogues Guild, elves and fairies and some who dress in only fur. The Washing Well Wenches are among the entertainment.

Why do they do it?

According to Nussle, who is a retired critical care registered nurse, she does it for the camaraderie and it's a great stress reliever. “Have you ever been in a crowd and felt like you didn't belong,” Nussle asked. “It's not

like that at the festival. No one is judgmental, you feel as though you belong.”

Smith said she has made some of her best friends there. “Where can you go play dress up and not feel like an idiot,” she asked.

The friends from the Renaissance Festival get together other times of the year. “Once a month we have the opportunity to get together at other venues, like Frankenfest in Frankenmuth, for example,” said Smith.

Nussle and Worden slide into the English accents when they're at Hollygrove. Smith does not. Nussle performs impromptu skits on the grounds, like the “Let me guess your name” skit, where she keeps shouting out a name until someone says, “that's me.”

Most of the playtrons make their own period clothing. Some purchase the outfits and accessories online and others like to trade. “There is a lot of horse-trading,” said Worden.

Nussle said the playtrons are made up of many professional people. “We have nurses, attorneys and many teachers,” she said. “It's a lot of fun but it's also very expensive. You have to have some money to do this.”

Because of the complexity of the period costumes, especially for the ladies, it is nearly impossible to drive a vehicle, said Nussle. “We bring our costumes to the festival parking lot and help each other get dressed for the day.”

Worden said many of the men are involved in leatherwork and make many of the belts and pouches. “Pouches are critical,” he said. “The costumes we wear do not have pockets.”

Renaissance fairs around the country have specific rules. According to Worden, “In Colorado, they have modesty rules and tattoos are not allowed. “The festival in Tennessee doesn't allow cleavage.”

Many people meet their mates at the Renaissance Festival, which even hosts weddings. “Where else can you get married in a castle?” asked Worden.

Establishments have been more than 2.5 times more likely to experience a decrease in sales than to have experienced increased sales. Survey results show 42.2 percent state their sales are down since the ban was enacted.

Sunday, Aug. 21, 2005

*Trial begins for man accused of strangling wife.* Robert Thomas Parks, 32, sat quietly in court Tuesday as Genesee County Assistant Prosecutor Mark Beckman told jurors that Parks was a man that kept his pimp hand strong, and one who wanted sex anywhere, with anyone at any time. **ASK THE MECHANIC**

**Q:** I have a 2009 impala and the heater will not stay hot when the car is idling. When I touch the accelerator pedal it gets hot almost instant. It makes it very hard to melt ice on the windshield.

- Marty

**A:** Marty, this problem is most commonly caused by a restricted heater core. A good flushing should fix it. To check this when the car is warm and idling; feel both heater hoses. If one is considerably cooler than the other than you have most likely found your problem. Other things to look for are proper coolant level and circulation. If you need to flush the cooling system and heater core, do so by first draining as much of your old coolant as possible, then take off both heater hoses and flush the heater core back and forth from one hose to the other. You should see when the debris comes out and the water should flow free and clear. Next flush the radiator and block from the other end of the heater hose where they hook to the engine and also from your upper and lower radiator hoses in both directions on all hoses. When finished drain as much water out as you can and start by filling the system with straight antifreeze for the first gallon. Then use a 50/50 mix and make sure to bleed the system. On this car, I leave the top heater hose off while filling. Use a small funnel into the heater hose and fill until it comes out the heater pipe at the engine, then reconnect the hose, top off the system and run until hot. Now after it cools down again you will need to check for the proper coolant water mix with an antifreeze tester. It should be good to -34. If not, you may need to adjust this by draining some out then adding more coolant or water to adjust the mix. Don't forget to take your old coolant to a parts store or repair shop that accepts it for recycling purposes as this should not be put down the drain or left outside. Pets seem to like drinking it and it is poison!

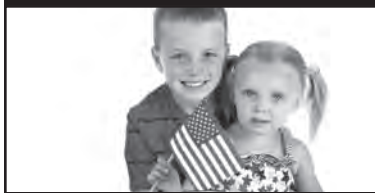

## CITY OF FENTON RESOLUTION NO. 15-15

### TO AMEND THE LOCAL DEVELOPMENT FINANCE AUTHORITY RESOLUTION

At a regular meeting of the Fenton City Council, held at 301 S. Leroy Street, Fenton, Michigan 48430, on the 10th day of August 2015, at 7:30 p.m.

PRESENT: Bland, Grossmeyer, Jacob, King, Lockwood, McDermott, Osborn

ABSENT: None

The following resolution was offered by Lockwood and supported by Jacob.

WHEREAS, in 1988, the City of Fenton ("City") was authorized by the provisions of Public Act 281 of 1986 ("Act 281") to create a local development finance authority ("Authority"); and

WHEREAS, pursuant to Act 281 the City Council was required to hold a public hearing on the establishment of the Authority and the creation of an Authority District in which the Authority would exercise its powers; and

WHEREAS, on May 9, 1988, the City Council conducted a public hearing on the proposed Authority and the designation of the proposed Authority District; and

WHEREAS, on August 22, 1988, the City Council passed a resolution creating an Authority for the City of Fenton, designating boundaries of the Authority District, and providing for other matters related thereto; and

WHEREAS, attached hereto as "Exhibit 1" is a copy of the City Council's August 22, 1988, minutes, including the Local Development Finance Authority Resolution, adopted on the same date; and

WHEREAS, the City Council wishes to amend the City's Local Development Finance Authority Resolution as provided herein; and

WHEREAS, the amendments herein do not alter or amend the boundaries of the Authority district to include or exclude lands from the Authority District or create new Authority Districts.

NOW, THEREFORE, BE IT RESOLVED THAT: the City's Local Development Finance Authority Resolution, Paragraphs 7 (Powers of Authority) and 8 (Fiscal Year; Adoption of Budget) are amended as provided below.

1. Paragraph 7 of the City's Local Development Finance Authority Resolution shall be amended to read: POWERS OF AUTHORITY.

(a) The Authority shall have all powers provided by Act 281 as it now exists or as hereafter amended and shall be subject to all of the duties and limitations therein set forth.

(b) The Board may employ and fix the compensation of a director as provided by Act 281 and subject to the approval of the City Council, provided that the amount of any compensation so fixed shall first be set forth in the budget of the Authority as provided in this resolution and be subject to the approval of the City Council. The director shall serve at the pleasure of the Board. A member of the Board is not eligible to hold the position of director.

(c) The Board may appoint or employ and fix the compensation of a treasurer as provided by Act 281, provided that the amount of any compensation so fixed shall first be set forth in the budget of the authority as provided in this resolution and be subject to the approval of the City Council. Although the Board's treasurer shall keep the financial records of the authority and perform other duties as provided by Act 281, the City treasurer shall be the Authority's fiscal agent, responsible for keeping and depositing all monies and funds in such manner and only in such places as the City Council may determine.

(d) The Board may appoint or employ and fix the compensation of a secretary as provided by Act 281, provided that the amount of any compensation so fixed shall first be set forth in the budget of the Authority as provided in this resolution and be subject to the approval of the City Council.

(e) The Board may retain legal counsel to advise the Board in the proper performance of its duties, as provided by Act 281, provided that the amount of any compensation, fees or costs to be paid to such legal counsel shall

first be set forth in the budget of the Authority as provided in this resolution and be subject to the approval of the City Council.

(f) The Board may employ other personnel, consultants or contractors deemed necessary by the Board, provided that the amount of any compensation fixed for any such personnel, including any contractors or consultants, shall first be set forth in the budget of the Authority as provided in this resolution and be subject to the approval of the City Council.

2. Paragraph 8 of the City's Local Development Finance Authority Resolution shall be amended to read: FISCAL YEAR; ADOPTION OF BUDGET; BUDGET REQUIREMENTS.

(a) The fiscal year of the Authority shall begin on July 1 of each year and end on June 30 of the following year, or such other fiscal year as may hereafter be adopted by the City.

(b) The Board shall annually prepare a budget and shall submit it to the City Council on the same date that the proposed budget for the City, if required by the city charter, is to be submitted to the City Council. The Board shall not finally adopt a budget for any fiscal year until the budget has been approved by the City Council. The Board may, however, temporarily adopt a budget in connection with the operation of any improvements which have been financed by revenue bonds where required to do so by the ordinance, statute or resolution authorizing the revenue bonds. The Authority's budget, which shall be subject to approval by the City Council, must be prepared in the same manner and contain the same information as required for departments of the City in the City's budget and shall include narrative explanations for each line item expenditure. General or vague descriptions of proposed expenditures are not authorized. Such budget must include individual line items for all personnel, including the Authority's director, treasurer, secretary, legal counsel, and any contractors or consultants. If any change in personnel, contractors, consultants or compensation for such personnel as listed herein is proposed during a fiscal year, such shall require submission of a budget amendment, which shall be subject to the approval of the City Council.

(c) The Authority shall submit financial reports to all the City Council at the same time and on the same basis as departments of the City are required to submit reports. The Authority shall be audited annually by the same independent auditors auditing the City and copies of the audit report shall be filed with the City Council and the board.

(d) The City Council may assess a reasonable pro rata share of the cost of handling and auditing the funds of the authority against the funds of the authority, as provided by Act 281.

3. All portions of prior resolutions inconsistent herewith are hereby rescinded.

4. The Clerk of the City of Fenton shall publish this resolution in the manner prescribed by law.

5. This resolution shall take effect upon filing with the City Clerk, filing with the Secretary of State and publication in a newspaper of general circulation within the city.

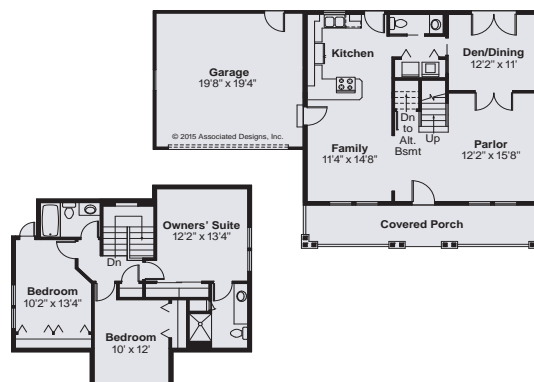

# Brotherly spat over politics should lead to reconciliation

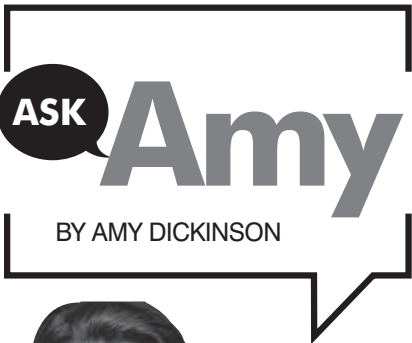
## DEAR AMY:

## DEAR BROTHERLY:

If you have done these things, be patient. Then contact your brother casually — by phone or text — and ask him to hang with you. If there is an errand you can run, or a task you can perform (perhaps for another family member), ask him if he wants to join you. Sometimes it's a little easier to ease back into a relationship through a shared activity.

# Shuffling of feet raises red flag

## DEAR DR. ROACH:

I am 85 and in good health, except for dizzy spells. It was said that I have vertigo, but I do not believe this to be the case. Meclizine is of no help. The symptoms are worse when I close my eyes. When I do, I feel like I may fall. Other symptoms are shuffling of feet, dizziness and dizziness on standing too quickly. Is it possible I have Meniere's disease? —  
A.T.H.

such as we can all get sometimes when standing too quickly; or a disorientation that can happen when blood sugar is low. Meniere's disease is a cause of true vertigo, often with ringing in the ears and hearing loss. Shuffling of the feet is a red flag for Parkinson's disease. Dizziness is a common if not universal symptom in people with Parkinson's. However, only a thorough history and physical exam can make the diagnosis. If your regular doctor hasn't been able to help, you might see a neurologist, who is an expert in making diagnoses about neurologic symptoms such as dizziness. There are many possible causes.
