Flying frenzy

● What you need to know about the busiest travel time of the year beginning at Thanksgiving

Yes, you can “get there from here,” but it helps to know ahead of time what to expect during the upcoming holiday travel season.

If you are planning to fly to your Thanksgiving, Christmas or New Year’s destination, hopefully you already have your seat booked. Otherwise, local travel experts say you’ll be paying top dollar for fares that could have been secured months ago.

Flexibility on travel dates and times will increase your chances for the best value. “The more flexible a person is with their travel dates, the easier it is to find a low fare,” said Randy Church of Travel Brokers.

With Thanksgiving just a few weeks away, the seats that would allow a traveler to fly out on Tuesday, Wednesday or Thursday of Thanksgiving week, coming home on Sunday, are gone, according to John Schmitt of Superior Travel.

“For the best prices, you should be booking your flights a full 11 months ahead on major carriers like Delta, American, United and six months ahead on Southwest,” said Schmitt. “Right now, Southwest is booking through April, which takes you through many warm spring destinations.”

Know before you go...

IF YOU'RE FLYING DURING SOME OF THESE PEAK TRAVEL TIMES, INCLUDING SPRING BREAK 2016, HERE ARE A FEW QUESTIONS YOU SHOULD ASK YOURSELF:

Q. What's the real cost of my airfare?

A. You have to compare not just the ticket price, but also the fees associated with a particular airline, as well as parking and travel to the airport, according to John Schmitt of Superior Travel.

“If you plan ahead of time, flying out of Bishop in Flint will be the same or less than flying out of Detroit,” said Schmitt. “That is, unless you wait ‘til the last minute to book your flight. It doesn’t make sense to ask friends or family to make four trips to Detroit Metro (there and back twice) so you can save \$80 on parking.”

Southwest Airlines is the only carrier that doesn’t charge luggage fees. Otherwise, Schmitt said you can expect to pay fees not only for

SMART HOME SECURITY OPTIONS

■ You don't need a moat and dragons to protect your castle

Cocoon / Cost: \$400

This device is expensive because it's ambitious enough to monitor your entire home from one spot using an HD camera, microphone, motion detector, thermometer, and a loud siren. One attractive feature, the subsound detector, listens for low-frequency sounds below the threshold of human hearing. It can hear if there's an intruder in the house. Since the Cocoon adapts to the regular sounds in the house like pets and vacuum cleaners, it's unlikely to sound off randomly. This system comes with a mobile app that allows you to see the live video feed, set emergency contacts, and sound the siren.



Homeboy Security Camera

Cost: \$150

In order to keep your home safe, you need devices you can set up once and not worry about. The Homeboy Security Camera is easy to move around your house, has no wires, and connects to your smartphone, increasing accessibility. The battery life lasts about three months. Since the body and lens of the camera magnetically attach to the base, it's easy to position where the camera records. It is motion activated and will send you notifications when it senses movements. Using your smartphone, you can watch videos of what's going on in your house.



Smart Doorbell / Cost: \$200

A smart doorbell allows you to answer your door from anywhere in the world. It's nice for catching delivery people, but also for fending off potential thieves. A potential thief will usually ring the doorbell to see if anyone is home. The system alerts your smartphone and the video feed will show you the person at your doorstep. Make it appear as if you are home by speaking with them. It also gives you time to call 911. All you need is Wi-Fi. Different brands can be purchased on Amazon.



Presence / Cost: Free

This company found an inventive way to make use of old phones with the iOS system. By downloading the Presence app, you can turn your old smartphones into video cameras to monitor your home when you're absent. The devices can be motion-activated cameras, but they can also be set on a timer or show you live video feed. Users can switch between different cameras, and create a subscription account of 5 GB to store videos online and allow the cameras to record longer videos.



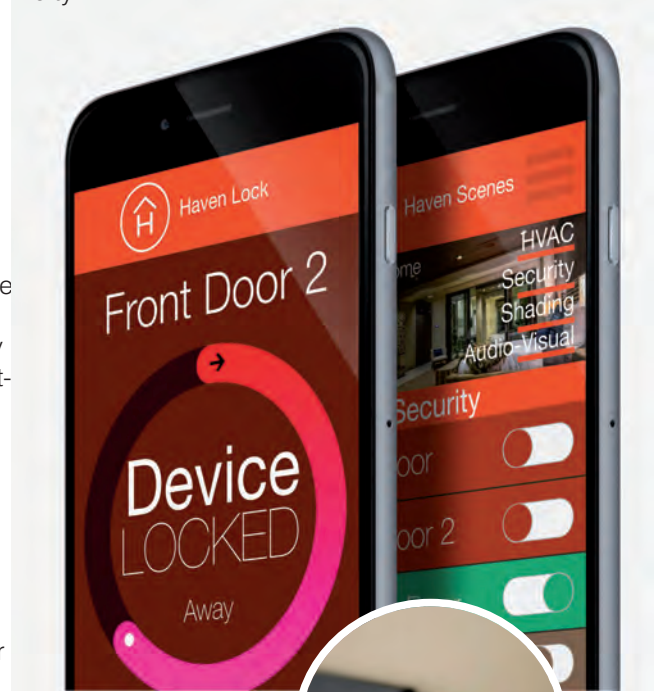
Canary / Cost: \$200

The Canary is an all-house security system that keeps track of sound and movement in your home. It can be placed anywhere with Wi-Fi connectivity and learns more about the patterns of the house the more it's used. Over time, it becomes more effective because it can differentiate more sounds. It records video when it detects movement. When it detects something odd, it automatically sends a notification to the user and the option to watch it live. Users can then sound the siren, call the police, or ignore the notification from their smartphone. It also monitors air quality, temperature, and humidity.

Haven Smart Lock

Cost: \$200

According to Haven Smart Lock, 95 percent of break-ins require force. This device makes it harder for thieves to open the door, but not by dead bolting it. Instead, it attaches to the floor and acts as a barrier, making sure the door stays closed. You can use a key fob to automatically unlock the device when you're close, and you can also lock or unlock it anywhere using the Haven app. It also syncs with other devices in your home.

checked baggage and carry-ons by all major carriers, but also for seat assignment on Spirit Airlines. "You pay an \$8 fee for a middle seat on Spirit and \$12 for a window or aisle seat," said Schmitt.

You can also pay for "comfort seating" on other airlines, including Delta, that provides premium seating at the front of coach, offering a few more inches of leg room.

Q. What's my airport experience going to be like, and how can I prepare?

A. You need to know how you are going to get to the airport, how soon you can check in (usually 24 hours ahead on the airline's website), and how to change planes if your flight is not non-stop.

"For domestic flights, your feet need to be inside the airport terminal one-and-a-half to two hours before

your flight time," said Schmitt. "For international flights, make it two to three hours ahead. Be sure to leave extra time for parking and shuttles to the terminal."

Q. Will I have enough time to get to my connecting flight?

A. If you're changing planes, you need to have knowledge about the airport: is there a shuttle, bus or moving sidewalk to get you to the next flight, and how long will it take

to get there? This is especially true when you go to change planes at large hubs like Minneapolis, Atlanta, LaGuardia, to name a few.

"Airlines are getting less friendly about transferring luggage to connecting flights," said Schmitt. "Sometimes you have to go to Baggage Claim to re-check it. These are things you need to ask about. These practices are more common on cheap flights using multiple airlines."

With Christmas Day, Dec. 25 being on a Friday this year, many travelers will be staying home with family on that date, then traveling on Saturday, Dec. 26 to a vacation destination.

“Dec. 26 will be crazy this year,” said Schmitt. “The holiday season will begin Nov. 21 and 22, with Wednesday, Nov. 25 being one of the busiest days of the year. Meet Bob Harris

- Author
- Retired businessman
- Retired U.S. Marine
- Former college president

Robert (Bob) G. Harris is 92 years young. He and his late wife, Marie, have two children, five grandchildren and 11 great-grandchildren.

Did you grow up in Fenton?

We moved to a cottage on Lake Fenton in the summer of 1936, and I traveled to Flint to finish eighth-grade at Whittier Jr. High. I had enough of that and started ninth grade at Fenton High School in the fall of 1937. My parents bought a house on Swanee Beach, and it is where I have lived since the passing of my mother in 1986.

Where did you go to school?

World War II started when I was a freshman at Michigan State University. I entered the United States Marine Corps (USMC) officer program and was commissioned in June 1945. I decided to make the Marines my career and served almost 25 years, retiring in October 1965 in order to accept a fellowship at MSU. I received a bachelor's degree in math in absentia from MSU in 1956, and received a master's degree in electrical engineering from the U.S. Naval Postgraduate School in Monterey, California in 1957.

In 1968, I received my Ph.D. and soon thereafter became president of

Johnson County Community College in Kansas. I was the first person hired and built a college from scratch, which was a wonderful experience. After seven years, I accepted the presidency of Middlesex College in Edison, New Jersey. I later became the president of McHenry County Community College in Northern Illinois. We stayed there for three years and decided to come home to Fenton.

Tell us about your jobs

I started Harris Financial in 1980. My son, Bob Jr., joined me after 14 years in the FBI. The business is now run by my grandson, Rob. At Harris Financial, we did investment planning and mortgages for a couple years. My son and I wholesaled securities to brokerages in Michigan for a company in Buffalo, New York, but we turned to completely 'retail' investments after a few years. My grandson no longer does mortgages and concentrates on financial planning and investments.

When did you begin writing books?

Writing has always been an interest of mine. Most of it was done in letters when I was overseas in Korea and Okinawa, Japan for a year or more each time. My poor wife almost had to raise our children by herself.

My first 'book' was my autobiography. At first, it was a series of stories I have been telling for most of my adult life, but then I added a more traditional chronological history. The book turned out to be more than 400 pages. I then followed up with one solely about my Marine Corps career. 'Many Come, Few Are Chosen' was the title. It reflected how we Marines feel about those who become Marines. It is an eBook on Amazon.

Now having the 'bug' and no longer going to the office, I looked at the library to see what had been written about Fenton. Largely it was about the 1800s,

so I decided to do a newspaper research book about my FHS years 1937-1941. Then I had to do a follow-up on the War years 1942-1946, etc. Now I am up to 1955 and I have done the research for the next on 1956-1960. God willing, I will run out the century.

Tell us about your travels.

My Marine Corps travels were without the wife and family so after retiring, we did some travelling — to Great Britain on three occasions. The last time was in 2003. We concentrated on Wales and we took the grandchildren with us. There were eight in our party. We found the graves of my great-great-grandparents in a churchyard in Mitchell Troy, Monmouthshire. Wales, and also

my mother's home in England. We found her home where she lived before coming to America when she was 12. We traveled by car through France, Germany, Denmark, Austria, Switzerland, and took one grand trip to the Soviet Union — Moscow and St Petersburg (they called it Leningrad then). We have ventured into Mexico on several occasions, and spent the Christmas holidays in Mexico City with an Army friend who was the military attaché to our embassy there.

What is your favorite high school and life memory?

There are so many ... being captain of the football team for the final game as a senior on Thanksgiving morning versus Holly.

Meeting my future wife as she visited her girlfriend whose locker was next to mine. I didn't give her much thought at the time. I was a sophomore and she was a lowly freshman.

Getting married, having children, promotions, so many good people as friends and associates all my life. I cannot think of anyone I truly dislike.

How would your grandchildren describe you?

My grandchildren? Generous, generous, not easy to change my mind or position, generous.

What don't we know about Bob Harris?

That I'm a political conservative, but still have 'young thoughts.' That is I still have equity investments, not ready to go the CD route. That I'm a rabid Michigan State fan and I would join the Marines tomorrow if I were young again.

I am very comfortable, with two wonderful ladies as my caregivers. I picture myself like the fellow lying on soft pillows, with two slaves waving large fans overhead, scantily clad women dropping grapes into my mouth, and I can hear my wife Marie calling down to me, 'Get up you lazy bastard.'

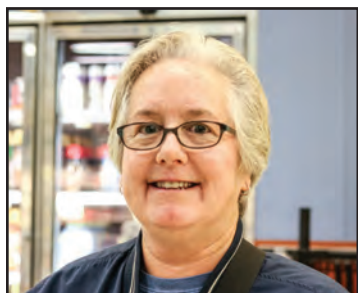

■ 'Yes' to mirrors, 'no' to animal mounts and family photos when marketing your home to sell

November brings thoughts of hunt-

"Not everyone's crazy about animals on the wall," said Trish Zito-Smith, Realtor and stager for Berkshire Hathaway Home Services of Michigan in Fenton. "Mounted animals are a

definite no-no when trying to sell your home, unless you're selling a hunting lodge or cabin."

In addition to the fact that hunting is a negative perception for some home buyers, mounted animals on the wall make your rooms look smaller. "The bigger they are, the smaller the room looks," said Zito-Smith. "These mounts are often in a man cave, basement or garage, and these spaces aren't very big to begin with."

Other wall décor do's and don'ts include:

LESS IS MORE.

DO USE MIRRORS to give the illusion of space. A large mirror can offer this illusion the best, but a collection of small mirrors can also provide "sparkle" and excitement to a room, according to Zito-Smith.

DO HANG A

large piece of art on the wall, especially if it's behind glass. "The light will hit the glass and reflect," said Zito-Smith. "It's important that the art be relevant and up-to-date."

1. Your home's first impression is the only impression that counts. Buyers have already judged your home before they walk in the front door.

6. Conceal the critters. Not everyone loves cats and dogs. Remove all signs of pets during showings so that your home is clean and odor-free.

7. Play the agent field. Make sure your Realtor and broker are totally informed, constantly monitoring Multiple Listing Service (MLS) and are tech-savvy.

8. Light it up. After location, buyers are looking for a house with good lighting. Bring all the natural light in that you can by removing drapes, changing lampshades, increasing wattage, etc.

9. Create half-empty closets. Take half of your stuff out of closets and organize all the rest so people can visualize there's enough space for all their belongings.

10. Price it right. Find out what your house is worth and lower the price by 15 to 20 percent. While some sellers aren't willing to take the risk, this is one strategy that will sell your home quickly.

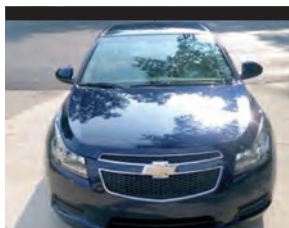

Mom doesn't want to wade through 'mean girl' waters

DEAR AMY:

My daughter has a group of girlfriends I don't particularly care for, but I try to stay out of it and work with her on values to gently move her away from this group. My problem is that the parents of these friends keep asking me to go out with them. I'm sure they may be trying to be nice, but I have been out with them a couple of times, and I don't enjoy it at all. They are gossipy, listen to only one side of a situation and believe it, are impressed by people who have and wear expensive things and need you to agree with their political views, which they have no problem voicing. I don't want to be a snob, but it feels like high school all over again! Some of the kids in the group seem to be a lot like their parents. Obviously mine is too (or is a follower), which is why I have work to do with her. I keep coming up with excuses not to participate, and I can tell one mother is ticked at me. I want to know what to do until I can get my daughter to move away from these girls and to a more genuine friendship group. If I point-blank tell her she can't hang with them, or if

DEAR SICK OF SCHOOL:

You don't say how old your daughter is, but one lesson for you to convey to her is that -- although family members influence one another -- you don't choose her friends. She does. And she needs to choose wisely. But she doesn't choose your friends either. You obviously have a low opinion of these girls and their parents, but you should do your best to continue to be polite toward people who are making a real effort to get to know you. You are not obligated to spend time with them, however. Be honest with your daughter about your own choices. If this upsets her, talk about it. If the mean girls retaliate and toss your daughter from the group, then you will both see up close the reality of this sort of high-stakes socializing.

Could back brace cause swollen feet?

DEAR DR. ROACH:

I am 83 years old. I was lifting a heavy end table back in November, and I heard a crack. I knew I was in trouble, as that had happened on the golf course many years ago. I went to the hospital and was there for six days. They took an X-ray, which showed moderate facet arthropathy, mild degenerative disc disease and a mild compression fracture at T12. I was prescribed a back brace, and have been wearing it for three months. However, both feet have begun tingling in the toes, and my foot is numb all the time. I have had periodic ankle swelling, but now the swelling is up to the knees in both legs. Does the back brace have something to do with it? — L.B.

ANSWER:

Facet arthropathy is a term used by radiologists to describe arthritis in the back. Degenerative disc disease is very common, if not universal, in 83-year-olds. Both can cause back pain. However, the "crack" you heard and the finding of a compression fracture are more troubling. A compression fracture of a vertebra is like what happens to a cardboard box if you put too much weight on top of it. The combination of a compression fracture, tingling and numbness is concerning. It's time to go back and get re-examined. Compression fractures can lead to nerve compression. Kidney, liver and heart problems can all cause swelling of the feet, but I think the most likely cause may be that you aren't elevating your feet as much as before because of the back brace.

BUTTERMILK PUMPKIN SPICE WAFFLES

INGREDIENTS

- PUMPKIN BUTTER**
- 1 can (15 ounces) 100% pure pumpkin puree
 - 2/3 cup packed dark brown sugar
 - 1/4 cup honey
 - 1 tablespoon lemon juice
 - 1/4 teaspoon ground cinnamon
 - 1/8 teaspoon ground cloves
- WAFFLES**
- 1 1/4 cups gluten-free flour or white whole wheat flour
 - 2 tablespoons brown sugar
 - 1 teaspoon baking powder
 - 1/4 teaspoon baking soda
 - 1 1/2 teaspoon ground cinnamon
 - 1/2 teaspoon ground ginger
 - 1/8 teaspoon ground cloves
 - 1/8 teaspoon nutmeg
 - 1/4 teaspoon kosher salt
 - 2 large eggs
 - 1 cup buttermilk
 - 1/4 cup whole milk
 - 1/2 cup canned pumpkin puree
 - 1 teaspoon vanilla extract
 - 2 tablespoons unsalted butter, melted
 - Maple syrup, for topping

INSTRUCTIONS

PUMPKIN BUTTER

1. **Combine** pumpkin, sugar, honey, lemon juice, cinnamon and cloves in medium heavy-duty saucepan. Bring to a boil over medium-high heat, reduce heat to low. Cook, stirring frequently, for 20 minutes or until thickened. Meanwhile make the waffles.

2. **When** pumpkin butter is done cooking, transfer to a bowl and set aside, or refrigerate if not eating waffles right away. Can be store in an airtight container in the refrigerator for up to 1 week.

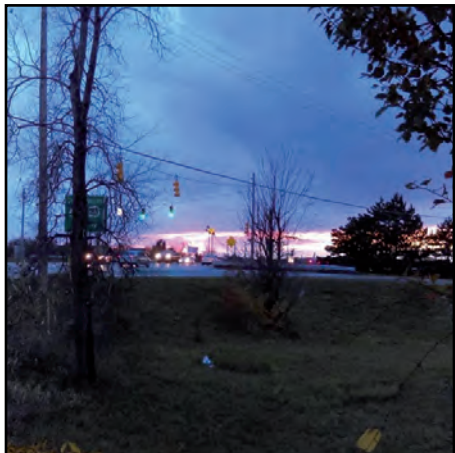
WAFFLES

1. **In** a large bowl, combine the all of the dry ingredients together. In a small bowl, whisk the eggs, buttermilk, milk, pumpkin puree, vanilla and melted butter. Stir wet ingredients into the dry ingredients just until moistened.
2. **Pre-heat** waffle iron. Add about 1/3 cup of batter to the center of each waffle iron section without spreading out (this will give round waffles), close iron and cook as directed by the manufacturer, until golden brown and crisp on the outside and tender on the inside. I cooked my waffles for about 5-6 minutes (setting 5) on an all-clad Belgium waffle iron. Serve with butter, maple syrup, and warm pumpkin butter.
