# Getting ready to sell your home?

■ Holding a garage or yard sale is a great way to clear clutter **before** putting it on the market

So you've decided to sell your house. What are you going to do with all the "stuff" that has been accumulating over the years?

Whether you hold it in your yard, the garage, pole barn or other outdoor structure—a sale to get rid of your unwanted, unneeded items and make a little cash while you're doing it is a great way to go about it.

Holding a garage sale can be a tedious process, but not if you get organized and plan ahead.



It makes most sense to hold your sale before a Realtor lists your house. If you've ever sold a house in your life, you know that the first thing your agent is going to tell you is "Get rid of the clutter."

The following are some tips on how to hold a stress-free (well, kind of), successful garage sale:

### Pick a date

Most local garage and yard sales begin on Thursday morning and end either Saturday afternoon or Sunday. Choose a date that best suits your calendar and check with the National Weather Service

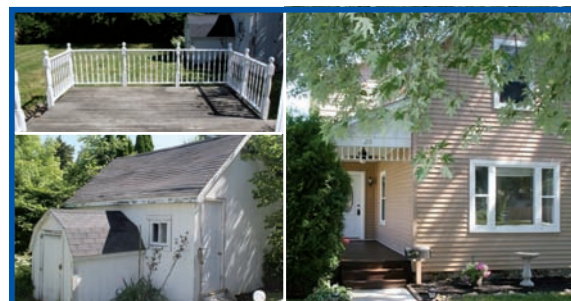

(weather.org) to check what the weather will likely be that weekend. Also, choose a weekend about three weeks in advance, giving you enough time to advertise your sale.

### Advertise

Seasoned local "salers" know to consult the Wednesday, Midweek edition of the Tri-County Times for garage sales that begin the next day or the following Thursday.

Call (810) 629-8282 or visit 256 North Fenway Dr. in Fenton to advertise your sale. The Times has a special garage sale

package. For \$36 for one issue (\$54 for two), you will receive a 20-word ad with color photo in the garage sale section of the Classified Ads. In addition, you will receive five signs for your sale, three sheets of stickers (250 total), a tip sheet and a coupon for \$3 off your next ad.

Your sale will not only be published in the print edition of the Tri-County Times, but will also be featured on our online Featured Top Ad at [www.tctimes.com](http://www.tctimes.com). A text blast also will go out to all our subscribers.

### Get your sale items together

This will likely be the most time-consuming activity involved with holding your sale. Get your girlfriends or kids to help. Go through your house, room by room, and separate unwanted items into two categories — throw away and sell (we'll get to donate later).

Don't forget to look in the basement and attic, too. The more you can get rid of at this sale the cleaner your house will be when it comes time to sell.

Once you have all your items collected, make sure they are clean — that means everything — clothing, cookware, dishware, knick-knacks, paintings, books and more. There's nothing nastier than to look into a garage sale crockpot, for example, and seeing gunk stuck to the bottom.

### Pricing

After everything is clean, you will need to price your items. Unless you want to haul all of this stuff back into the house after your sale, make sure the price is right. Too often, people walk away from yard and garage sales because the prices are too high.

For garage-salers it's all about the bargain and the thrill of the hunt. They literally want to pay for great finds in nickels, dimes, quarters and dollar bills. If you can't find it in your heart to sell something for dirt cheap, maybe you shouldn't sell it.

Please do price everything. There is nothing more annoying than to have to ask for prices at busy garage sales.

At the sale, be willing to entertain lower offers. People like to bargain so when you hear "Will you take this

much for this ..." bite your tongue and try to say yes.

Whether you decide to end your sale on Saturday or Sunday, take at least the last half of the day and offer the remaining items for half price. This is your last chance to get things out of your garage.

### Presentation

Either the night before or early morning of the sale, lay out the items you are selling on tables or other surfaces (that hopefully your husband has already figured out and put into place) around the garage. If there are items in your garage that are not for sale, cover them with a sheet so people know they are inaccessible.

Keep like items together — neatly folded T-shirts, jeans, shorts, etc. together on one table. Coffee mugs, dishware, silverware, cookware and kitchen appliances, if there's room on another surface. Put the small kitchen appliances like toasters, blenders, crockpots, etc. on another table if necessary.

Hardcover and paperback books can be placed inside cardboard boxes like a library shelf, showing the title on the spine. These can be placed on the garage floor or in the yard with other items such as indoor and outdoor furniture, toys, large pieces of artwork, etc.

If your husband has tools he wants to sell, make sure those are all displayed in one area. Make sure he prices them and make sure he tells you what "rock bottom" offer he will accept if he's not planning to be there.

### Have fun

Holding a garage or yard sale is not only a great way to get rid of your unwanted items and make some money, but also to visit with friends and neighbors you haven't seen in a while.

If you've chosen a Realtor to work with by the time of your sale, make sure you have plenty of that agent's business cards on hand to give to your friends and neighbors, who may know people looking for a home in your area.

### After the sale

Here's the easy part — after the sale, pack and bag up all the items you didn't sell and donate them to local charities like Goodwill, Salvation Army or St. Vincent DePaul. Many of them will pick your items up for free.

If there are items you think are still too valuable to give away, consider taking them to a local consignment store and give them a crack at selling your goods for you. Your net earnings will be about 50 percent of the sale price.

Steven Spielberg didn't come back for the reboot, which was a wise choice. The budget was big, but the plot was familiar to the original. The other two sequels also did poorly.



## GREASE 2

Any song from the original "Grease" movie is as memorable as the movie. Such is not the case for "Grease 2," a movie not many people know about because it did so poorly.

## Boom! Local man opens Fenton Fireworks

■ New year-round business caters to those who love the thrill of fireworks

Jerry Srp of Argentine Township grew up loving the thrill and excitement of fireworks.

When consumer fireworks became legal in Michigan in 2012, Srp kept in the back of his mind his dream job of opening a fireworks store. He decided to take a crack at selling fireworks year-round in Fenton, by opening Fenton Fireworks.

Fenton Fireworks opened in June at

Berry Skewers with White Chocolate Drizzle



**INGREDIENTS**

- 1 Pint Blueberries
- 1 Pint Strawberries, stems removed and halved
- 4 Ounces White Chocolate, chopped (or white chocolate chips)
- Appetizer Skewers

**DIRECTIONS**

1. Alternate blueberries and strawberries on skewers.
2. Melt white chocolate either in the microwave or a double boiler.  
**For Microwave:** Melt chocolate in 30 second increments, stirring in between, until chocolate is silky and just melted.  
**For Double Boiler:** Add one inch of water to a large saucepan and set the pan on the stove over medium high heat and bring to a simmer. Set a heatproof glass bowl inside the saucepan; be sure that the bottom of the bowl is not touching the water, you just want the steam from the water to heat the chocolate in the bowl. Place the white chocolate in the bowl and melt, stirring often, until chocolate is smooth and silky.
3. Using a fork, drizzle the white chocolate all over the skewers. Chill in the refrigerator to set/store.

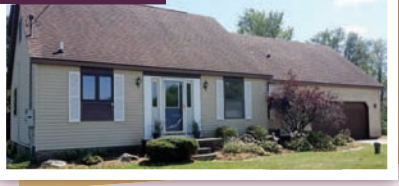

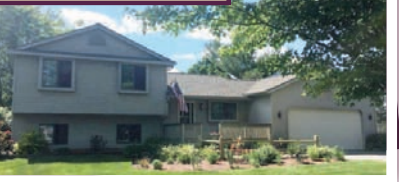

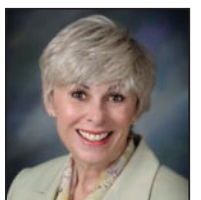
