"This homicide is tied to this victim," said F/Lt. Michael Shaw of the Michigan State Police Metro North Post.

Alexandra "Ally" Brueger, 31, was fatally shot four times in the back while running on Fish Lake Road the afternoon of Saturday, July 30. Her killer remains at large.



he could testify against his co-defendant, Kody Brewer, 16, of Wolverine Lake, who has a trial set to begin on Oct. 12.

During the court hearing, Stevens' attorney, Marc Hart, requested that certain language be changed and the prosecutor said he worried that Stevens wouldn't be truthful on the stand. This could affect Stevens' plea deal. The judge is taking a bond agreement under consideration.

Circuit Court Judge Joseph J. Farah told those in the courtroom who were crying to dry their tears because Stevens did a very bad thing. "We'll take the joker at his word," Farah said.

Stevens was already sentenced in August to three years probation in an unre-

lated case of a child pornography video he made involving juveniles from Linden.

Sentencing on Tuesday was supposed to take place after Stevens accepted a deal in August, and pleaded guilty to false report or threat of terrorism, a five-year felony. He was originally charged with two counts in October 2015—conspiracy to commit murder, punishable by up to 20 years in prison and false report or threat of terrorism.

Stevens, and his two co-defendants, Brewer, 16, and Lamarr Dukes, 16, of West Bloomfield, were apprehended after Argentine Township Police discovered social media posts about carrying out a potential school shooting at Linden High School and Linden Middle School in late October 2015.

During his plea hearing last month, Stevens admitted that what he did was childish and that it was supposed to be a joke, but that it wasn't funny.

Argentine Township police discovered the child pornography video while investigating the school shooting plot. Stevens reportedly used a cell phone to record a 13-year-old having sex with a 15-year-old male, who attended Linden schools, at a Red Roof Inn on Miller Road in Flint Township in October 2015.

> Brewer appeared in court on Sept. 7 from the Regional Detention Center and a new trial date was set. The required 10 percent of the \$100,000 bond was posted on Sept. 8. He is required to wear a tether and stay at the home of his parents. The judge ordered no cell phone

use, no computer use and no contact with victims. Brewer also was ordered to stay away from Linden Community Schools property. His trial date has been set for Oct. 12 at 8:30 a.m.

Dukes is expected to plead in juvenile court on Sept. 26.

Unhealthy eating habits growing in America

Huge portions, bad food choices, too many calories are some of the mistakes we make

Fast food, slow foods, all-you-can-eat buffets and vending machines surround the average American with food choices 24 hours a day, making it difficult to stick to any kind of a healthy diet.

Some people choose their own path to healthy eating by following a strict pattern of meal planning, whether it's vegan, gluten-free, Paleo, low carb or clean eating.

How do you know what the healthiest plan is for you and your family? "There really isn't a 'best' diet for everyone," said Lewis Strong, lead dietician at McLaren-Flint.

"We all have our own very individual needs. Some people can eat a lot of carbs and feel fine, while others will get drowsy from too many carbs. Look at respectable sources and know what healthy foods look like."

One way to start is to visit a website like eatright.com, sponsored by the Academy of Nutrition and Dietetics. Other good sources are mayoclinic.com and webmd. com, according to Strong.

Here are the pros and cons of some of the most popular diets making the rounds of celebrities and trendy eating.

Vegan

Former president Bill Clinton and comedian Ellen DeGeneres have forsaken all meat and animal products in their diets, joining the approximately 16 million people in the U.S. who call themselves "vegan."

Vegans don't eat any animal products or by-products — no meat, fish, fowl, eggs, dairy or honey. Such a diet may help lower cholesterol, blood pressure, increase antioxidant intake, promote discipline and other positive behaviors, etc.

However, a vegan lifestyle is a radical change for most people and can be a challenge to learn how to put together complementary foods that form vegetarian proteins.

A vegan diet can also interfere with existing medical conditions, such as osteoporosis or diabetes. Dining out can be tricky because not many restaurants offer true vegan choices. Evidence also shows that vegan diets don't contain vitamin B12, but vegans can get this essential nutrient from some fortified foods and from supplements.

"You can make a vegan or vegetarian diet a healthy choice if you choose the right foods to meet your nutritional needs," said Strong. "Make sure you have enough vitamin B12, vitamin D, calcium and omega-3 fatty acids." Paleo

Also known as the "Caveman Diet," the Paleo diet is high in protein and fat, supposedly from eating as your ancestors did, with an emphasis on animal protein, especially from wild salmon, game meats, free-range chicken and grass-fed beef, plus natural carbohydrates (essentially fruits and vegetables) and some nuts. Most people who follow the diet avoid carbohydrates and processed grains.

This diet's phases are the opposite of many other diets, getting more restrictive as you progress, which may provide a transition for people that's easier to stick to. Because the Paleo diet eliminates dairy products, people may be short on calcium

■\$20,000 monument installed with volunteer time, full of symbolism

tjagielo@tctimes.com; 810-433-6795 Fenton — A solemn occasion brought both remembrance and pride to the city's own fire department Sunday afternoon.

Under the warm sun and the sound of bagpipes, approximately 250 visitors watched as the Fenton Fire Department revealed its new 9/11 memorial, built and installed over a period of weeks in front of the Fenton Fire Department.

After a brief ceremony, which included the Pledge of Alle-

giance, the Star Spangled Banner and words from several speakers, the monument was revealed to the group of onlookers, many taking photos and videos of the event.

every day 77 Describing the mo-LYNN MARKLAND ment it was unveiled, Fenton City manage Mayor Sue Osborn said, "It was so emotional I started crying. It's just such a beautiful memorial and such a great dedication from the city of Fenton."

"It was very emotional for me," said Deputy Fire Chief Ed Hadfield, because of the work that had gone into the monument -many hours. It's very personal for me."

A team of firefighters constructed the base on which the monument sits — the concrete work, landscaping and fundraising was done by Fenton firefighters.

Firefighters raised funds and built the memorial themselves, with half of the \$20,000 overall cost coming from the city of Fenton. The monument was supplied by Fenton Memorials.

The memorial has several pieces, all with symbolism. The concrete path leading to the monument is flanked with spots of tall grass — symbolizing the field in Pennsylvania where one of the planes crashed. The concrete where the monument sits is in the shape of a pentagon, for the Pentagon building, which also was attacked.

The monument is made up of two vertical pieces of granite representing

the two World Trade Center towers, with images and inscriptions on either side, and includes a piece of steel from one of the towers, which the fire department was given in 2011 by the Port Authority of New York & New Jersey.

"It shows our appreciation not just for the people who lost their lives that day, but for what the first responders do every day," said City Manager Lynn Markland, who delivered an emotional speech before the dedication.

Remembering the unity, faith and common vision following the months of Sept. 11, 2001, Hadfield said, "We need to become a united country again."

The monument is complete and can be viewed at the Fenton Fire Department, at 205 E. Caroline St., in Fenton.

in a field in Shanksville, Pennsylvania, causing even more death and destructon.

"What an honor and amazing experience," said Ludwig of his trip last weekend. "It was an honor to be there and support Tom and his family. We were allowed access to an experience I will never forget as we were part of Tom's family. The families of the firefighters and civilians who died are only allowed the type of access we experienced."

Ludwig said the day started out at Station 288 HazMat 1 with breakfast. At the precise times each plane hit each tower, there was a dispatch and moment of silence followed by a reading by the Station's Officer.

"Every member of that station, including me, stood at attention," Ludwig said. "We then went down to Ground Zero for the reading of the names of each individual who perished.

"The museum was amazing with interactive and heart-breaking exhibits," he added. "It is built on the exact footprint of the north tower and the slurry wall and stanchions are still in place. You could listen to the actual calls being made from the people, who were trapped, to their loved ones.

"Many artifacts are housed there which included destroyed vehicles and beams, clothing and personal items. There is a repository that still contains human remains that have yet to be identified and we were allowed

access to that room," he said.

"Over 1,000 people have yet to be accounted for," Ludwig said. "We were also allowed access to the Freedom Tower and the observatory. It is an amazing view at the top.

"Truly, the best experience was being there to support Tom and his family and to see the honor and pride of the FDNY after this attack and the honor they bestow on the deceased," he added. "I am very proud of Tom and his family as they have risen from a tragedy many people could not have done.

"I believe I also exorcised some personal demons and have come to terms with my initial experience at Ground Zero 15 years ago," Ludwig said. "We were treated with so much grace and appreciation by the firefighters and civilians. It is an experience I will never forget."





The Health Insurance Portability and Accountability Act and the health of presidents

In last week's column I discussed the impact that this year's presidential election might have on filling the current vacancy on the United States Supreme Court and noted the great interest in this year's race.

The events of the past few days have underscored this interest with Donald Trump continuing to question Hillary Clinton's health, calls for the release of both candidate's health records, and this past Monday the nation learning that Mrs. Clinton has been diagnosed with pneumonia.

No one can be totally sure of where this all will go but when it comes to health records, the law is clear that unless a person voluntarily releases personal health information to the general public, it remains private subject to the requirements of a federal law called the Health Insurance Portability and Accountability Act of 1996 or 'HIPAA.'

Under HIPAA, there are national standards to protect an individual's medical records and other personal health information. Generally speaking, such information can't be released without the patient's authorization.

There are numerous regulations that have been established to implement this law including what is required for the electronic exchange, privacy and security of health information.

The entities that are covered by the law are health plans, most health care providers and health care clearinghouses.

Well before HIPAA, the health of presidents was an important national issue.

It appears President Dwight Eisenhower was the first president to release his health information and medical records to the public while in office.

There are a number of other presidents who have had notable health issues with perhaps the most well-known being Franklin D. Roosevelt who developed polio when he was 39 years old and was paralyzed from the waist down while he served as president.

Some other presidents had less publicized conditions including Lincoln — possibly Marfan Syndrome, Kennedy-Addison's disease, and Wilson — a stroke.

As to the present candidates, I'm sure everyone wishes them nothing but the best of health whether they choose to disclose their health histories.

This bill was introduced by Sen. Margaret O'Brien, (R-Portage).

Restaurant owners could decide if they want to allow dogs on their patios. If restaurants do want to allow dogs, there are certain rules they will have to adhere to (See sidebar).

A new Michigan bill

The restaurant would be able to establish limits on the size or type of dogs, as well as deny entry to or eject a customer and their dog.

Mark Hamel, co-owner of The Laundry, CRUST, and El

Topo, said this is a topic they've struggled with for a while.

If this bill becomes law, dog owners might be able to take their pets to the outdoor patios at The Laundry or CRUST.

"The struggle is that for all the thousands of people that love their pets and consider them part of their family, there are many people who are not pet lovers and prefer not to have them at the table next to them when they are dining, especially if the dog is misbehaving," he said.

Behavior is a big issue. Hamel said some dogs are perfectly behaved being in a social setting with other dogs, but some are not and it could cause problems. Many people are irritated by barking dogs,

or ones who beg for example. "We would not be opposed

to letting people dine with their pets but the owners would have to take responsibility for the behavior of their pet and be willing to leave

if they became disruptive, which could be challenging — we live in a society where we feel entitled to do what we want regardless of the policies of the establishment," he said.

Hamel said they have a large group of "Leader Dogs" that visit The Laundry frequently, and they've never caused problems.

Senators Dave Robertson (R-Dist. 26) and Jim Ananich (D-Dist. 27) both voted in favor of the bill.

"The goal of the legislation was to make it be permissive legislation to allow restaurants to allow dogs in patio areas under certain conditions," Robertson said. "I'd never heard of the issue until it was raised by (O'Brien) but apparently this can be something of an issue in resort communities."

On her website, O'Brien wrote, "Michiganders love their pets. Dogs have become important members of the family. With so many pet-friendly amenities like dog parks and hotels that accept dogs, it is reasonable to allow restaurants to decide if dogs are allowed on their outdoor patios."

In communities with beaches and boardwalks, Robertson said he heard there were issues with patrons taking their dog to the beach or for a walk, and then not being able to dine.

"People don't want to be excluded from the possibility of dining if they had their dog with them," he said. "It's permissive legislation so a restaurant has to opt into it. It is not a mandate."

Ananich said, "I felt it was a good compromise that allowed businesses and local officials the ability to decide what is best for their situation. We've heard from a number of people who would like to have the option of bringing their pet with them when they go out to eat outdoors, and there are other places that have successfully implemented policies like this. My wife and I adopted our dog, Maddie, from a shelter several years ago and she's been a big part of our family ever since."

The bill passed 32-4 in the Senate. It is currently in the House, and was referred to the Committee on Regulatory Reform on Sept. 7.

Rules

 Dogs brought to a patio must be on a leash.

• Dogs wouldn't be allowed inside the restaurant or any place where food is prepared, just on the outside patio. The dog must be attended by someone at least 18 years of age at all times

• The outdoor area must be kept clean and free of dog hair and dander, and any accidents left by the dogs must be immediately picked up and disposed of.

• If the waitstaff pets the dog, they must immediately wash their hands before returning to work.

and vitamin D. It's also low in carbohydrates, which may impact your memory. **Gluten-free**

Gluten, a protein found in wheat, grain, barley and other derivatives, is a relative newcomer to the human diet, so some people haven't adapted to digesting this substance.

People who eat a gluten-free diet steer clear of white, barley, rye, triticale (a mix of wheat and rye), seitan (an Asian food) and oats, which are vulnerable to contamination with gluten. Wheat may be called by many other names, including bulgur, semolina, spelt and farro and can be found in sauces, salad dressings, even cosmetics and medication.

A gluten-free diet can include grain alternatives like rice, millet, quinoa and amaranth, plus whole, unprocessed foods, such as meat, poultry, fruits, vegetables, nuts, beans, legumes, eggs and dairy.

This eating plan is essential for people with celiac disease, about 1 percent of the U.S. population for whom ingestion of gluten triggers an autoimmune attack of the intestinal lining. This can cause gastrointestinal distress and the inability to absorb important nutrients.

It will also benefit those who are considered "gluten sensitive," about 16 to 18 million Americans. Eating gluten can cause many of the same symptoms for them, without the intestinal damage.

Strong suggests that people with celiac disease or gluten insensitivity should follow a gluten-free diet. "But we don't recommend it for people who don't have an issue with gluten. There's no reason to restrict yourself from so many healthy foods."

Low carb

A low carb diet restricts carbohydrates and focuses on proteins, including meat, poultry, fish and eggs, and some nonstarchy vegetables. A low carb diet usually excludes or limits most grains, legumes, fruits, breads, sweets pastas, starchy vegetables and sometimes nuts and seeds.

Some low carb diets allow small amounts of certain fruits, vegetables and whole grains. A daily limit of 60 to 130 grams of carbohydrates is typical.

A low carb diet is generally used for losing weight, but also has health benefits beyond weight loss, such as reducing risk factors associated with diabetes and metabolic syndrome.

However, if you restrict carbohydrates too much, it can result in vitamin or mineral deficiencies, bone loss and gastrointestinal disturbances, and may increase risk for various chronic diseases.

Eat-clean diet

This lifestyle diet recommends avoiding all saturated fats, trans fats, overprocessed, refined foods, especially white flour, sugar, colas, juices and alcohol.

Foods allowed include a variety of whole grains, fruits, vegetables, lean proteins, nonfat dairy and healthy fats.

There are many pros to this type of eating, as it focuses on whole and natural foods. It can be used as a general eating philosophy or as part of a healthy diet with calorie limits for losing weight.

Clean eating can be hard to follow for the long haul because you have to eliminate certain foods, including white flour and sugar, plus processed foods. It also involves more food preparation and cooking, since most foods begin in a whole and nature state.

mation leading to the arrest and conviction of Brueger's murderer.

"We are still very actively investigating this incident and while I won't get into specifics about the case we are working every lead and tip we receive," Shaw said.

"As far as the kids go, there is no indication this homicide had anything to do with children," he added. "With that being said I think that parents do need to keep an eye on their kids as a matter of routine."

Because some of the township is dark and isolated, especially after the time changes in the fall, Shaw says to make sure there is lighting in your yard. If you see something suspicious call police.

"Talk to your kids about strangers and have a plan of what they should do," said Shaw. "Explain the rules of the road if they ride their bikes in the area. Make sure kids know if they need help it's OK to contact police.

Vehicles affected by Louisiana flooding back on the road, up for sale

The concerns that vehicles damaged by the Louisiana floods and Hurricane Hermine will wind up being resold are real. New research from Carfax suggests more than 271,000 vehicles reported as flood damaged from previous storms are back on the road, in driveways and up for sale around the country — a 30 percent increase since 2013. These cars can be a nightmare for the new owners as they rot from the inside out, compromising vehicle safety, performance and even causing health issues. Carfax data suggests 11,000 flooded vehicles are back in use in Michigan, some possibly in the tri-county area, according to Christopher Basso of Carfax. To find out if a used car you are considering to buy has been affected by flooding, check for flood damage free of charge at www.carfax.com/flood.


