

# Diet soda health hazard?

# You may never drink it again after reading this

It works as a great toilet cleaner, rust remover, insect repellant, battery cleaner, and paint and odor remover — but do you really want it passing through your stomach?

Diet cola, as thirst-quenching as it may be, is not really a healthy beverage choice. It may seem like a better choice than a sugary soft drink by saving about 140-plus calories.

But there is more to this "chemical cocktail" than meets the lips and throat — such as artificial sweeteners like aspartame, saccharin and sucralose.

Artificial sweeteners have more intense flavor

than real sugar, so over time, they can dull the senses to naturally sweet foods like fruit. Artificial sweeteners trigger insulin, which sends your body into fat storage mode and leads to weight gain.

Diet soda is calorie-free, but it won't necessarily help you lose weight. According to health.com, researchers from the University of Texas found that over the course of about 10 years, diet soda drinkers had a 70 percent greater increase in waist circumference compared with non-drinkers.

Drinking one diet soda a day was associated with a 36 percent increased risk of metabolic syndrome and diabetes. Metabolic syndrome describes a cluster of conditions, including high blood pressure, elevated glucose levels, raised cholesterol, and large waist circumference, that put people at high risk for heart disease, stroke and diabetes.



### Pain neutralizer

If you have been bitten by a bug, strung by a bee or a jellyfish then you do not have to panic in pain, just pour some Coca-Cola on the affected area and your pain will be neutralized in seconds.

### **Dish washer**

When you drink diet soda, you're not taking in any calories — but you're also not swallowing anything that does your body any good, either. The best no-calorie beverage is plain old water. If it's the carbonation you crave, sparkling water should do the trick.

Early studies on aspartame and anecdotal evidence suggests that this artificial sweetener may trigger headaches in some people.

Using diet soda as a low-calorie cocktail mixer has the dangerous effect of getting you drunk faster than sugar-sweetened beverages, according to research from Northern Kentucky University. The study revealed that participants who consumed cocktails mixed with diet drinks had a higher breath alcohol concentration than those who drank alcohol blended with sugared beverages. The researchers believe this is because our bloodstream is able to absorb artificial sweetener more quickly than sugar.

A recent study presented at a the American Academy of Neurology meeting found that over the course of 10 years, people who drank more than four cups or cans of soda a day were 30 percent more

likely to develop depression than those who steered clear of sugary drinks.

Women over 60 are already at a greater risk for osteoporosis than men, and Tufts University researchers found that drinking soda, including diet soda, compounds the problem. They discovered that female cola drinkers had nearly 4 percent lower bone mineral density in their hips than women who didn't drink soda. Additionally, a 2006 study in the "American Journal of Clinical Nutrition" found that cola intake (all kinds, not just diet) was associated with low bonemineral density in women.

Just one diet soft drink a day could boost your risk of having a vascular event such as stroke, heart attack, or vascular death, according to researchers from the University of Miami and Columbia University. Their study found that diet soda devotees were 43 percent more likely to have experienced a vascular event than those who drank none. Regular soda drinkers did not appear to have an increased risk of vascular events.

Researchers say more studies need to be conducted before definitive conclusions can be made about diet soda's effects on

During the last joint meeting in August, Corlin Builders presented a \$7.5 million building project, which would have been much like the first Cornerstone building at Silver Lake Road and LeRoy Street, which was a \$4.7 million project.

After giving an impressive look at what they had planned during that August meeting, Ghassan Saab of Corlin Builders dropped a bombshell that was met with dead silence — they needed \$400,000 from the city for the project.

"Without it, the project can't happen," said Saab at the time.

The \$400,000, had city leaders agreed to

pay it, would have covered architectural and engineering costs.

Stunned by the surprise request, city administrators and officials decided to take the matter under advisement and discuss it again at a future meeting.

After that August joint meeting, Corlin Builders went back to the drawing board and sharpened their

pencils, coming back Monday with a plan to construct a building much like what they had originally planned. They did switch some of the types of materials used and other cost saving measures through design changes.

Doing so shaved several hundred thousand dollars from the total cost of the project with the new total cost figure close to \$6.8 million.

Saab said the new building proposed will still have the highest level of in-

Corlin Builders anticipates receiving a significant grant from the MDEC (Michigan Development Economic Corporation), which they say will help cover costs, making it unnecessary to ask the city to contribute funds this time.

The building proposed Monday night features four stories for a total of 40,400 square feet. Floors one through three will feature 10,780 square feet of space and the fourth floor 9,460 square feet.

Two terraces proposed at each end of the building on the fourth floor make up the remaining square footage. The total overall square footage is 41,800.

Like the first Cornerstone building, the first floor of the building will feature five retail spaces. The second floor will be offices, and the third and fourth floors will feature condominiums.

There will be five condos on the third floor that are between 1,588 and 1,900 square feet in size and will feature an open floor plan.

There will be four condos on the fourth floor. The terraces at each end of the building on the fourth floor will be shared common areas for owners.

The terraces and first-floor pedestrian plaza, which could feature a café, would serve as a buffer to the Fenton United Methodist Church.

There will be 14 covered parking spaces and 21 public parking spots, two of which will be handicap parking. Nine of the covered parking spots will be for condo owners. Saab said it has not yet been determined if the remaining five spots will be for office and retail use, or if they will be offered to the condo owners for a premium, for example.

Councilwoman Cherie Smith questioned

the need for four floors versus three, referencing the Horizon Building going in at Silver Lake Road and North LeRoy Street on the northwest corner.

"Then we have two huge buildings next to each other looming up ... it's overwhelming," she said.

She was reminded that the Horizon Building decided against condos be-

cause of the close proximity to the railroad tracks.

Smith also questioned the process for soliciting bids. She referred to Fenton as the "hottest city" in Genesee County and suggested requests for proposals could have been solicited from other areas in the state and beyond.

DDA member Terry Green, who owns Billmeier Camera across the street from the proposed project, asked about the construction. He said every time there is construction in the downtown area, plaster comes down and there is damage to his building and the adjacent historic buildings.

Saab and city administrators said they will do everything to limit the impact construction has on those 100-year-old buildings and that of the church, which is also historic.

Both the Fenton City Council and DDA voted unanimously to accept the development proposal and authorize the city attorney to prepare a development agreement.

Councilwoman Pat Lockwood thanked Saab and Corlin Builders for bringing forward a great project and referencing the last meeting, avoiding the 20-second period of complete silence, which she said was the "longest delay in the history of the Fenton City Council.'

Once all approvals are met and their MDEC grant is received. Corlin Builders expects to break ground on the project in the spring or early summer of 2017. They have a projected completion date of May 2018.

### **Making decisions**

Did you ever have to make up your mind? Pick up on one and leave the other behind. It's not often easy and not often kind. Did you ever have to make up your mind?

If these lines seem familiar, it's because they're part of a song written by John B. Sebastian for his band the 'Lovin Spoonful' some 50 years ago.

At the song's end, a father says, 'You better go home son and make up your mind.'

'Making up one's mind' by definition means making decisions. Although we all make decisions every day, there are times in life when making decisions involves more serious matters.

For example, in the law we see lawyers and judges who are required to make decisions every day that affect people's lives in very significant ways.

When I was in my early years of private practice, I had a partner who always used to say that he would make a decision when he had all the information.

I have never forgotten this advice and I have used it both in my legal career and personal life.

Occasionally there are times when one has to make a decision based on incomplete information, as there isn't time to have all of the facts.

In those situations, Winston Churchill told us that 'the maxim 'nothing avails but perfection may be spelt shorter:' 'p-a-r-a-l-y-s-i-s.' This is another way of saying that sometimes you have to go ahead and make a decision based upon the best available but incomplete information.

In the courts, there is a history of ensuring that before decisions are made, all relevant information is available to the parties, the judge and/or the jury. This information is seen in the examination of the facts of a particular case, statutes, court rules, the rules of evidence, case law, and other sources.

At times, this can be a long process and this brings to mind another legal maxim that 'the wheels of justice grind exceedingly slow but grind exceedingly fine.'

This means that to the extent humanly possible the justice system wants to get it right no matter how long it takes.

Whoever we are or whatever we do when making up our minds making good decisions should always be our goal.

Kody Brewer, 16, appeared in court

with his family. Since he is a minor, the judge prohibited photographs of Brewer.

In October 2015, Brewer, along with Ryan Stevens, 19, and Lamarr Dukes, 16, were charged with conspiracy to commit first-degree, premeditated murder, a felony punishable by up to life in prison, and false report or threat of terror-

ism, a felony punishable by up to 20 years in prison. This came after a school resource officer at Linden High School discovered an alleged plot to potentially carry out a school shooting.

Brewer was released on bond in September. He has a GPS tether, must stay at the home of his parents, and cannot use computers, cell phones, or contact anyone through social media.

Judge Joseph Farah said to Brewer, "I gave you some strict bond restrictions. You haven't been on the computer right?

Brewer said "no."

"Nothing. None of it. Zero. You can't tell your friends to contact people. None of this can happen or you go back to jail," he said.

Brewer said he hasn't used any computers.

Brewer's attorney, Elbert Hatchett, said, "For the record, his conduct since his discharge has been exemplary. He's working full time. He's trying to get back into school.

All adult charges were dismissed in Dukes' case, and he was admitted into a year-long juvenile rehabilitation center, George Junior Republic, in Pennsylvania.



Sexual Conduct (CSC) with someone under the age of 13 in Genesee County.

The pretrial hearing will be held on Nov. 16, at 8:30 a.m. before Genesee County District Court Judge David J. Goggins.

A pretrial hearing occurs before a regular jury trial and is when the accused tells the judge whether he is guilty or not guilty. If he pleads not guilty, the judge will decide issues that the defense attorney or the prosecutor want to clear up before trial.

Dennis' arraignment took place by video on Thursday, Oct. 5 in the Genesee County Jail. Bond on the eight charges combined equals \$3.5 million.

If Dennis is found guilty of the charges, he faces life in prison.

According to Genesee County Court records, the offense occurred on Oct. 1, 2014. Dennis reportedly assaulted someone he knew, a person under the age of 13, over a three-year period in Fenton.

Dennis has also been charged with first-degree criminal sexual conduct in Oakland County. His trial in the Oakland County case is set to begin Nov. 7.

It is unknown if the victims in the Genesee County and Oakland County cases are the same.

According to Genesee County District Court records, Dennis resides on Parallel Street in Fenton, one block west of State Road Elementary School property.

It is unknown whether he resides at this home at the present time. His wife successfully filed for divorce in June of this year.

in favor of the ordinance, while the remaining six members voted against it.

"I'm disappointed in the decision of the council to not support equality for all of our citizens and visitors," said Bladzik.

"Fighting for civil and human rights requires courage and conviction. This setback simply demonstrates the need for both leadership and empathy on the Village Council through the next election."

Bladzik is not seeking re-election to the Holly Village Council, but rather is running for the State Representative position in the 51<sup>st</sup> District.

was held at the Holly Village Council's Aug. 23 meeting. An opinion also was solicited from the village attorney, Michael Gildner.

In his opinion, Gilder said the ordinance obligates the village to honor constitutional rights by not discriminating against people who enjoy those rights. "If you did nothing, and did not adopt this ordinance, you

would still be prohibited from discriminating against any person's constitutional rights," said Gildner in his opinion.

Gilder said he does see some value in doing so, even if it is only symbolic.

"My primary concern is promising to enforce constitutional rights that in some cases have been recognized only recently, like same-sex marriage, or other rights that have not been explicitly recognized, like gender identity," he said.

"The proposed ordinance prohibits discrimination based on some constitutional rights that are 'cutting edge, undefined, and are the subject of intense debate in society and in the courts," "Gildner added.

"I am concerned about the village promising things that are presently unknown," said Gildner.

Village Council Member Chris Rankin said, "I voted against the ordinance because of the legal murkiness of the definitions of the groups that this ordinance was attempting to protect.

"I felt it was unwise to place on the village the legal responsibility of protecting that which has an unclear legal definition," he added.

"Of course I want all people to be

treated fairly and equally," Rankin said.

"In the aftermath of this vote, I have received numerous emails and social media messages with a common theme of, 'shame on you,' which I expected to receive given that this type of legislation is something that needs to be moved forward," Rankin added.

"The village attorney advised that if we did not adopt this ordinance, and did nothing instead, we would still be prohibited from discriminating against any person's Constitutional rights," said Council Member Suzanne Heiple.

"It is not necessary to adopt something in writing which explicitly states it, in that sense, the proposed ordinance is not necessary," she added. "The primary concern is enforcement. If we are going

> to recognize gender identity as a Constitutional right, for example, we ought to know what that means.

> "Until the courts delineate the contours of them, it is not clear what those rights cover and there is concern about the village promising things that are presently unknown," Heiple said.

"It's unbelievable to me that in 2016 we

are still having this conversation," said April Boucké of Holly. "The LGBTQ community is not asking for 'special rights,' they are asking to be treated like everybody else.

"I'm sad to say that a citizen of our community involved in the Facebook conversation I started regarding the vote was harassed by another member for being gay," she added. "This is exactly why we need the council to stand up and vocally say this will not be tolerated in our town," said Boucké.

"As a B in the LGBTQ, I have the privilege of not being seen as LGBTQ because I'm married to my awesome husband. But the whole reason we bought a house here is because we stayed in a Bed and Breakfast to start our honeymoon and fell in love with the town.

"I can tell you there are more LGBTQ in our new hometown than you realize because people don't feel safe enough to be open," she said. "And for this community to grow and thrive, that needs to change. I see that the village wants to attract more families to live here, and the way to do that is to be openly, vocally accepting of every family."




