LaJoice pleads guilty to embezzling more than \$18 million

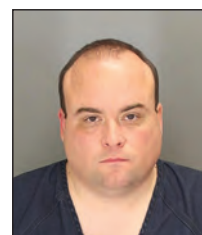
■ Could face up to 30 years in federal prison for bank fraud

Detroit—A plea agreement was reached Thursday, Nov. 3 in United States District (federal) Court with Michael LaJoice pleading guilty to embezzling more than \$18 million from the credit union at which he was chief financial officer. His Oakland County Circuit Court case is pending.

LaJoice, 37, of Tyrone Township, appeared in federal court in a red prisoner's uniform, bound with chains at the hands and feet. He appeared thinner than when he first appeared in court. His wife, Ashleigh, was in the courtroom.

By agreeing to the plea deal, LaJoice pleaded guilty to one count of bank fraud, which comes with a sentencing guideline of 121 to 151 months with a maximum fine of \$1 million. He faces a statutory maximum term of 30 years imprisonment.

Sentencing is scheduled for March 21, 2017.

The plea deal was agreed upon by LaJoice's defense attorney, Michael Manley, Philip Ross, assistant U.S. attorney with the Asset Forfeiture Unit and John Neal, chief of the White Collar Crime Unit.

LaJoice was also ordered to pay restitution of \$17,748,380.

Manley said his client agrees with the terms and conditions.

“At this point, I don't know what type of sentencing I'm going to impose,” said Judge Gershwin A. Drain.

In January 2015, LaJoice admitted to Oakland County authorities that he embezzled \$20 million as Chief Financial Officer (CFO) for the

Clarkston Brandon Community Credit Union, which has been taken over by the Michigan State University Federal Credit Union.

He's been lodged at the Oakland County Jail since.

On Thursday, LaJoice admitted his guilt in court.

“Between the dates of Oct. 23 2007 to Dec. 13, 2015, I embezzled from my employer, the Clarkston Brandon Community Credit Union, in the amount of approximately \$18.5 million,” he told the judge.

Drain asked him how he was able to embezzle that amount of money. LaJoice said he committed check fraud by

County's oldest historical building is in Linden

■ The first Linden Mill building was built 166 years ago

While the Linden Library holds thousands of books and movies that each tell a story, the building they're housed in is a tale as old, and historic, as time.

The Linden Mill building dates back to the start of Linden.

The city's history is known back to the 1830s, when settlers started building mills along the Shiawassee River, according to michmarkers.com.

As other industries followed, the city became a center for buggy and barrel manufacturing, cement production, and foundry work.

The current Linden Mills building isn't the first one. The first mill was used to cut lumber, according to michmarkers.com.

Seth Sadler and Samuel W. Warren, who were local residents,

built a saw and gristmill from 1845-1850, which operated with the earlier facility. This complex became known as the Linden Mill building, which is on Tickner Street along the Shiawassee River.

The current mill is the third one, built in 1871 after the first two were destroyed by fires.

According to a report by John Dziurman Architects, Ltd., the Linden Mill building operated as a gristmill until 1956. The machinery was dismantled and sold at auction that same year.

It was purchased by the village of Linden, which is now a city, that year to be used for municipal offices and a library.

Approximately four years later, the municipal offices were moved to the current city hall on East Broad Street and the first floor was remodeled for a meeting room.

The second floor was remodeled for the library. In 1961, the mill reopened as the community center, and in 1976, the Linden Mills Historical Society Museum opened.

Are you worried about your investments?

■ Local financial expert weighs in on stock market and election

Financial advisors around the world are gearing up for the unknown — that being what will happen to the stock markets after Tuesday's presidential election.

Fred Hensler, president and CEO of Sapphire Blue Investment Partners in Fenton, said he is not worried at all.

“We have positioned our clients to potentially help them avoid any major catastrophic events that could take place in the market,” Hensler said.

“One would expect that based on the volatility we've seen in this election, the outcome is going to create some uncertainty as far as the direction of the market is concerned,” he added.

Hensler said regardless of who is elected president, the results could potentially be contested, which will exacerbate or lengthen the process.

“Historically, we have found that the first year of a new president has statistically been the most volatile year of the four years of a presidency,” said Hensler.

“Likewise the year of a presidential term has statistically been the best. This has not been one of those years,” he added. “The market has not gained much this year. We're positioning our clients to accept the potential for some significant volatility.”

Instead of jailing heroin and opioid addicts, the Gaylord post of the Michigan State Police has started seeking help for these drug abusers as part of a new rehabilitation program.

Communities see success with new drug addiction program

■Gaylord state police post is first in state to offer help instead of jail

The Michigan State Police-Gaylord Post is the first division of the state police to partake in a different kind of rehabilitation program for heroin and opioid addicts.

The Police Assisted Addiction and Recovery Initiative (PAARI) does not jail addicts — it finds them help.

Trp. Corey Hebner of the Gaylord MSP post said the program is in its infancy there. They trained a group of “Angel Volunteers” last week, and their first person was admitted to the program Tuesday, Nov. 1.

“We want to try to assist as many people as we can,” Hebner said. “We don’t know how busy or how active we’re going to be but that’s why we’re piloting it here,” he said.

With this program, addicts can seek help by going to the Gaylord post and asking for help with their addiction. Instead of being arrested, they go immediately

in to treatment.
There are two main conditions to participating in the program — the person seeking treatment cannot have any active warrants, pending court cases, or be a registered sex offender. The other condition is that the program is voluntary for people with addiction problems.

Angel Volunteers help the post by finding the best treatment program for each individual, and transporting that person to the treatment facility.

“We’re (Michigan is) fifth or sixth in heroin and opioid overdose in the country,” he said, adding that a study has found that the northern lower peninsula prescribes more opioids and pain killers per capita than anywhere else in the state.

“A lot of it is based on the fact that we have an older population,” he said. “The ability to abuse and find medications that don’t belong to you are also greater because they’re here.”

The program first started with the Gloucester Police Department in Massachusetts in June. Since then, it has saved the department taxpayer money and has significantly decreased ancillary crimes

"That does not mean you should abandon being involved in the stock market," Hensler said. "With volatility comes opportunity. What we don't necessarily believe is the 'buy, hold and hang on for dear life' theory."

There are signals in the investment markets that can help to forecast when certain sectors of the market are likely to do better, and when they're likely to do worse, according to Hensler.

"So we take an active role in managing a client's investments based on the research that we have available to us, and make adjustments to a portfolio on what we believe is to be an as-needed basis," he said.

Hensler, who is not endorsing any political candidate, said there is a lot more to who wins — it's going to depend on who controls the Senate and who controls the Congress.

As far as his own clients who may be worried about their investments, Hensler said, "We strive to keep in close contact with our clients and calm any fears they may have."

Linden's cultural land marker was the first structure in Genesee County to be placed on the national register of historic places in 1972.

Linden's Bridge Street Historic District was listed on the National Register of Historic Places in 1982.

On the bottom level of the building, civic meetings take place. The second floor hosts the Linden Library, a branch of the Genesee County District Libraries.

SUMMARY

Few area buildings hold as much history as the Linden Mill building. The building was first a gristmill and is now used for city council meetings, the library, and the Linden museum.

Librarian John Ekleberry, who has worked for the Genesee District Library since 1998, has been librarian at the Linden Library since February 2015.

"I couldn't ask for a more charming, beautiful place to work. Seeing the Shiawassee River just outside the window every day is a pleasure," he said.

The Linden Mills Historical Society and Museum can be found on the top floor of the old building, with memorabilia and historical items from Linden's history.

New industrial site adds 50 jobs, plans for 500 total

■ Shannon Precision Fastener breaks ground on \$7.5 million facility in Holly Township

Holly Township is about to get a substantial economic boost with the construction of a new \$7.5 million distribution facility employing about 50 workers, with the future potential of 500 employees.

Groundbreaking took place on Friday, Nov. 4 for Shannon Distribution Center, a 71,000-square-foot, state-of-the-art distribution facility east of I-75 and west of Dixie Highway, between Evans and Belford roads.

This facility is the first in a proposed development of multiple industrial manufacturing sites for Shannon Precision Fastener, a business founded in 2004 by Chuck O'Brien and Paul Morath.

This Madison Heights-based company manufactures precision engineered fasteners that hold together high-stress parts in powertrain, body, chassis and safety applications primarily for automotive OEMs (original equipment manufactur-

ers). Today, they sell high-quality precision fasteners on six continents.

Ed Lumm, a Holly native and 1983 graduate of Holly High School, became president and CEO in 2009 during the deepest part of the recession, and credits a staff of 250 very hard working individuals for the company's success.

"The credit goes to our founders and the

great people who support our mission," said Lumm, who operates manufacturing and distribution facilities in Madison Heights and Auburn Hills. "We are excited to add Holly to our list of communities in which we operate. When we found this site, I knew it would be able to handle all our expansions for the next 20 years."

He also said he appreciates the support of the Michigan Economic Development Corporation, Oakland County Economic Development and Community Affairs group and the township of Holly.

"As we have proven in Madison Heights and Auburn Hills, we are confident that Holly will see that Shannon Precision Fastener is a company you'll be proud to have in your community."

Holly Township officials welcome this new industrial facility as well. "It's been in the works for a long time," said Karin Winchester, Holly Township clerk. "It's very exciting. We are ready for them."

Rhoads & Johnson in Fenton is working with Asselin McLane Architectural Group of Flint and Nowak & Fraus Engineers of Pontiac.

"The foundation will go in this December, steel will go up over the winter and we'll close things up in the spring," said Lumm. "By October of next year, we're hoping to be putting in equipment and shipping out our first parts in early January 2018."

at this week in

NATIONAL HISTORY

NOV. 6

1982: Shirley Allen is arrested for poisoning her husband, Lloyd Allen, with ethylene glycol, commonly known as anti-freeze. After witnessing her mother spike Lloyd's drinks with the deadly substance, Shirley's own daughter turned her in to the authorities. Lloyd Allen was Shirley's sixth husband and the second to die from mysterious causes; the other four had divorced her.

NOV. 7

1991: Basketball legend Earvin "Magic" Johnson stuns the world by announcing his sudden retirement from the Los Angeles Lakers, after testing positive for HIV, the virus that causes AIDS. At the time, many Americans viewed AIDS as a gay white man's disease. Johnson who is African American and heterosexual, was one of the first sports stars to go public about his HIV-positive status.

NOV. 8

1895: Physicist Wilhelm Conrad Rontgen (1845-1923) becomes the first person to observe X-rays, a significant scientific advancement that would ultimately benefit a variety of fields, most of all medicine, by making the invisible visible. Rontgen's discovery occurred accidentally in his Wurzburg, Germany, lab, where he was testing whether cathode rays could pass through glass when he noticed a glow coming from a nearby chemically coated screen. He dubbed the rays that caused this glow X-rays because of their unknown nature.

NOV. 9

1938: In an event that would foreshadow the Holocaust, German Nazis launch a campaign of terror against Jewish people and their homes and businesses in Germany and Austria. The violence was dubbed "Kristallnacht," or "Night of Broken Glass," after the countless smashed windows of Jewish-owned establishments, left approximately 100 Jews dead, 7,500 Jewish businesses damaged and hundreds of synagogues, homes, schools and graveyards vandalized. Kristallnacht represented a dramatic escalation of the campaign started by Adolf Hitler in 1933 when he became chancellor to purge Germany of its Jewish population.

NOV. 10

1969: "Sesame Street," a pioneering TV show that would teach generations of young children the alphabet and how to count, makes its broadcast debut. "Sesame Street" went on to become the most widely viewed children's program in the world. It has aired in more than 120 countries.

NOV. 11

1942: Congress approves lowering the draft age to 18 and raising the upper limit to age 37. In September 1940, Congress, by wide margins in both houses, passed the Burke-Wadsworth Act, and the first peacetime draft imposed in the history of the United States. The registration of men between the ages of 21 and 36 began exactly one month later. There were some 20 million eligible young men, of which 50 percent were rejected the very first year, either for health reasons or because 20 percent of those who registered were illiterate.

NOV. 12

1954: Ellis Island, the gateway to America, shuts its doors after processing more than 12 million immigrants since opening in 1892. Today, an estimated 40 percent of all Americans can trace their roots through Ellis Island, located in New York Harbor off the New Jersey coast and named for merchant Samuel Ellis, who owned the land in the 1770s.



addressing cashier checks out to himself, along with a few other methods. As CFO, he was able to write large deposits, and then approve them with no oversight.

According to U.S. Attorney Barbara McQuade, to conceal the fraud, Lajoice created fictitious investments in certificates of deposit and bonds, and represented to auditors and bank examiners that the money he stole had in fact been invested in these vehicles.

Drain asked if there was anyone above him in the chain of command.

"The CEO wasn't checking up on you?" he asked.

"No. She trusted me," he said.

"You did all those transactions with intent to defraud the credit union?"

Drain asked.

"Yes, your honor," LaJoice said.

Drain accepted the plea agreement.

LaJoice waived his right to a trial with this deal.

Ashleigh is allowed to keep certain personal items in agreement with the deal and Rule 11, such as her 2014 Grand Jeep Cherokee, personal items, like her wedding ring, and certain bank accounts.

She'll be able to retain her personal bank account of her own money totaling \$28,383.36, a PayPal account with approximately \$4,100, which is money obtained by from selling assets like Pistons tickets and concert tickets.

A trust fund totaling \$18,568.60 was set up in Manley's name, which allowed Manley to work as LaJoice's attorney.

LaJoice's case will be sent to the pro-

bation department for a pre-sentencing investigation, and he will appear in court on March 21.

LaJoice also faces 19 felony charges in Oakland County, including 14 counts of embezzlement, each count in excess of \$100,000.

Manley said LaJoice is expected in Oakland County court on Dec. 12, but he hopes to have it adjourned to settle the federal charges first.

LaJoice-owned properties in the city of Fenton, including the site planned for the "Riverview" project, have all been sold to SkyPoint Ventures.

Manley said restitution from selling LaJoice's multimillion-dollar home in Tyrone Township and business properties was given to his former credit union.

Will you let 'apathy' choose your next president?

There is no doubt that the road to the Nov. 8 presidential election will go down as one of the most bizarre events in United States history.

The outcome of this race, where voters will likely vote not "for" one candidate, but "against" the other, goes far beyond voting for the "lesser of two evils."

The consensus seems to be that the current candidates are two evils of equal badness in this presidential race.

How this will affect voter apathy and voter turnout remains to be seen.

According to a 2015 article in think-progess.org, voter turnout in the U.S. during the last midterm election hit the lowest point since the 1940s.

The number of Americans heading to the polls each election has been declining for the last 50 years. People do not exercise their right to vote for a variety of reasons, some of which are easier to solve than others.

According to a U.S. Census report, from 2013, 14 percent of non-voting respondents were unable to participate because of an illness or disability, 8.6 percent were out of town, 12.7 percent did not like the candidates or campaign issues and almost 19 percent were too busy.

Some people cannot take time off from work on a Tuesday in November, which has led lawmakers including Sen. Bernie Sanders (I-VT) to call for making Election Day a federal holiday. Others may not feel engaged in politics or informed enough to vote, while 5.85 million U.S. citizens are prohibited from voting due to a felony conviction on their records.

Voting advocates have been developing and pushing for new ways to get more people to the polls. Unlike laws that restrict access through voter ID laws, shorter registration and early voting periods and disenfranchising felons, these proposals are likely to have support from lawmakers on both sides of the aisle and would not be difficult to implement to get voters to turn out in higher numbers.

Make registering online possible

The first step in getting more people to vote is to register more people to vote. While many voter expansion supporters have advocated for same day or automatic voter registration, voting advocates agreed that it is not likely to be a reality in all 50 states anytime soon.

In the meantime, more states have been pushing to allow people to register online, a proposal that has bipartisan support. As of December 2015, 20 states had implemented online voter registration and four others had passed legislation to implement the technology.

Voting advocates have also made efforts to register and restore voting rights to convicted felons in states where it is not automatic.

Simplify voting

Voters can already use their smartphones in some cities to simplify daily tasks like tracking how long they have to wait for a bus or train. So why shouldn't information about polling places be easier to find online?

Allow people to vote online

While the ease of voting on the internet is appealing, privacy experts have cautioned against rushing to implement the technology due to cybersecurity concerns. Still, online voting is already standard procedure in some countries.

Hire invested and engaged poll workers

Many of the problems associated with Election Day disasters involve poll workers who are not properly trained for their jobs. To ensure that every vote is cast and counted correctly, skilled, paid poll workers may be needed.

Get people excited

If more people are involved with democracy and politics between election cycles, it will lead to a higher voter participation rate. Civinomics is a website that allows voters to answer polling questions while reading online news.

"By letting people vote on what they read, listen or watch in the news, Civinomics will make democracy a part of our daily lives," cofounder Manu Koenig told Think-Progress. "This will increase the likelihood people vote in official elections as well."

in the area like theft, shoplifting, breaking and entering, and larceny.

Now, approximately 200 police departments across the nation use the PAARI, also called the Angel Program.

The Gaylord post is the third agency and first state agency in Michigan to have the program.

The goal over the next six months is to have the program active across the entire northern Lower Peninsula.

Within a year, the MSP hopes to have it in the Upper Peninsula and then have the program statewide in the next two-and-a-half years.

Hebner said approximately 80 percent of heroin users started out as prescription medication users from an injury or a surgery, and became addicted.

"It's all about dopamine reward. Getting high is obviously a part of it, but the problem is once you crash, you don't have any dopamine," he said.

He explained opioid addiction is similar to when someone has diabetes and needs insulin to function.

"That's why they abuse methadone and other things. They just want to be able to get to a certain level to function and just feel normal," he said.

Nancy Becker Bennett, division director of grants and community services at the MSP, said there are almost no costs with the program.

Treatment costs are covered by the Department of Health and Human Services using publically funded treatment dollars. A small grant from PAARI covers incidentals, and the volunteers are reimbursed.

The program is also taking donations.

Becker Bennett said you do not have to live in Gaylord to join the program, but if you travel there for help, you will receive treatment in Gaylord.

"We're going district by district, making sure it's as it should be," she said. "It's going to be everywhere."

Genesee County heroin addiction services and programs

Wellness Services, which partners with the Genesee County Health Department, offers free training for Naloxone, also known as Narcan, in order to save someone who is overdosing from heroin. Call (810) 232-0888 for more information.

Narcan legislation

Sen. Dale Zorn and Senate Minority Leader Jim Ananich sponsored legislation that would allow Michigan school districts to stock Naloxone, or Narcan, as an antidote for an opioid or heroin overdose. Senate Bills 805 and 806 passed 36 to 0 in the Senate on Oct. 20.

• **After Fox News reporter** Megan Kelly asked Trump some hard-hitting questions during an August primary debate, Trump said, "She gets out, and she starts asking me all kinds of ridiculous questions. Tigers' historical season ends in state semis

Auburn Hills — The Fenton varsity boys soccer team's historical season came to an end in the Division 2 state semifinals on Wednesday night at Auburn Hills Avondale High School against Dearborn Divine Child.

Divine Child scored two first-half goals and made the lead stick as the Falcons defeated the surprising Fenton Tigers 2-0 in pretty damp conditions.

The loss ended what was a memorable season the Tigers. During it, the Tigers ended a long winless streak against Linden, captured a co-Metro League championship and won a district and a regional crown. Of course, this also marked the first time the squad was in a state semifinal contest.

But what probably mattered to the squad more than those results were the bonds they created with each other. Consequently those bonds probably created the success the team enjoyed, finishing the year with a 14-2-5 record.

"The season was not about winning or losing to us. It wasn't about winning another game so we could get to the next bracket in the tournament. What it meant was we'd be able to spend another four or five days together," Fenton senior Patrick Conroy said.

"This team is not about winning. It's about building that bond and creating the best memories you can about the season. Winning doesn't matter. Winning Metro titles, district titles or regional titles — it doesn't matter. It's about us."

"I see some of us are down and crying, but we could care less that they just won," senior Adam Gornick said. "What we have going on here right now is over, the season is over, and I'm getting emotional just thinking about it right now. To do what we did has nothing to do with winning a regional championship. It's about what we did for the program and our brotherhood, just like (coach Matt Sullivan) was saying."

The 'brotherhood' or the term the Tigers use to discuss the tight emotional bonds they have among each other is a common theme you'll hear when talking to the players.

"This season means a lot. Just the brotherhood we had and the bond we've had together is what it's all about," sophomore Brady Young said. "We made it far, but that's not what we are crying about. We are crying because we realize the bond we share. Not everyone can understand that bond we have. It's beyond words."

Just 8:38 into the contest Divine Child's defender Kevin Gondoly broke the scoring ice with a goal from about 15 yards out into the far top corner, putting the Falcons up 1-0.

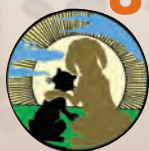

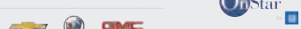
