■ Mother: ‘They said they didn’t see my kid. I don’t believe that’

A 12-year-old Fenton Township girl is recovering from injuries at Mott Children’s Hospital in Ann Arbor, after being struck by a speedboat Sunday evening while swimming in

Lake Ponemah.
The girl’s mother, Michelle Thomas, said her daughter, Cora, who turns 13 next week, has had surgery to repair lacerations and tendons on her foot and leg, and to hold bones together. A concern now is infection. Tuesday was a day of rest and more surgeries were scheduled for Wednesday.
The Genesee County Sheriff’s Office responded to a 911 call at 8:49 p.m. on Sunday, June 4.

The caller reported that a girl had been struck by a speedboat, near the Lake Ponemah Mobile Home Park on Eastview Drive. The dispatch operator alerted responders that the girl may have suffered a broken leg.
Thomas, who has lived at the park for the past 15 years, said she works third shift at a local food store and was five minutes

Police, fire seek new radios after 13 years

■ Taking advantage of Genesee County 911's buying power will save city close to \$30,000

The Fenton fire and police chiefs have asked the Fenton City Council to allow them to replace the 800 MHz Radios they've been using since 2004.

Fire Chief Bob Cairnduff and Interim Police Chief Jason Slater presented their case to the Fenton City Council at its Monday, June 5 work session.

"We have now had the radios for 13 years and they are due for replacement," said Cairnduff.

The current radios being used by both departments are Motorola, which has put an "end of life" on them. This means they can no longer be purchased or repaired, and as a result are no longer supported.

The police and fire departments have worked on this project for well over a year. "We had been waiting for the Genesee County 911 Consortium to move forward with its radio replacement project," said Cairnduff.

With the rest of Genesee County replacing its radios, Cairnduff and Slater were able to utilize the 911 Consortium bid process and benefit from its pricing.

"They were seeking bids for the replacement of over 2,500 radios and this would most certainly drive the pricing down well below what we could achieve with the replacement of our 66 radios alone," Cairnduff.

The plan worked and Fenton was able to work with its manufacturer of choice, Motorola, and lock in the county pricing for the city of Fenton.

Even if Genesee County 911 chooses another vendor, Fenton will still be able to use Motorola equipment at the prices received.

"We received a substantial reduction in the per-radio pricing based on the Gen-

esee County bid, and receive a 10-year warranty on all radios. Using the same vendor they used for the 2004 purchase, Blumerich Communications of Flushing, the city's order with all equipment, labor and a service contract is \$245,112.

The equipment listed in Fenton's order involves the direct replacement of equipment they have now. They are adding two portable radios, one additional mobile and one additional control station. The additional portables are for the fire department and the extra mobile is for the police department.

"These are being added due to increased need," said Cairnduff.

The additional control station is a backup for the dispatch center. The pricing on the bid for single control station was \$2,575. "Our normal cost is almost \$7,000," said Slater.

"We felt that this was such a great price that buying one to have as a backup for our dispatch center just made sense."

The state of Michigan requires that any new radio added to the MPSCS (Michigan's Public Safety Communications Systems) must pay a one-time activation fee of \$250 per radio. With 66 radios, the amount to be paid to the state is \$16,500.

This brings the total expenditure up to \$261,612, which is \$28,388 under the budgeted figure of \$290,000.

City Manager Lynn Markland told the council to expect a request to seek a loan for this equipment, one that will be paid off in seven years.

The Fenton City Council is expected to approve this expenditure at its Monday, June 12 regular meeting.

Fire chief seeks new fresh air system

■ Thirty-year-old air compressor and fill station to be replaced

Fire Chief Bob Cairnduff has appealed to the Fenton City Council for approval to purchase a new Self Contained Breathing Apparatus (SCBA) air compressor and fill station system.

At the Monday, June 5 work session, he explained that the current system was moved to the new fire station from the old fire hall and that the compressor is almost 30 years old.

"It has served us well but it is at its end of life and has begun to cost us more in repairs," he said.

On 30 years of use, Councilwoman Cherie Smith said, "It owes us nothing."

Cairnduff said he has applied for federal FEMA grants to replace the system for the past two years, but has been unsuccessful.

In anticipation of the needed replacement, \$52,000 was budgeted for fiscal year 2017.

Cairnduff sent bid requests to four potential bidders and received three back. He is recommending the second highest bidder, Douglas Safety (Bauer Air) for \$45,000, minus \$1,500 for trade in, for a total of \$44,000 for the system.

The lowest bidder, West Shore Fire (Eagle Air) met all of the fire department's specifications except one critical item. The maintenance room, where the equipment will be housed, has a 35-inch door opening and West Shore's unit is 41 inches wide and won't fit through.

Cairnduff said he also needs to have the electrical system modified to meet the requirements of the new system for about \$850, and a new fresh air line from the outside of the building to the inside and connected to the new system for approximately \$500. This brings the total up to \$45,350.

He also is asking to purchase a six-year service and testing package at a cost of \$6,382. This would include the required quarterly air testing and an annual compressor maintenance that would include oil, filter and cartridge replacement.

The Fenton City Council is expected to approve Cairnduff's request at its regular Monday, June 12 meeting.

Exercise trail opens for public

■ Freedom Center opens 'Freedom Trails' with exercise stations along 1.1-mile road

Fenton — It was a colorful ribbon-cutting ceremony Friday, June 2, minutes before The Freedom Center's annual 5K Rave Run, when Pastor Jim Wiegand declared "Freedom Trails" open.

The trail is 1.1 miles of paved, private road. It used to be known as the Old Truck Road, but is now an exercise trail for anyone wishing for a different kind of workout.

"This dog-friendly, kid-friendly, bike-friendly, walk/run-friendly road has been repurposed to become an incredible place to enjoy friends, relax or get in a great workout. Already in place along the trail are 'sta-

tions' to work different muscle groups," Wiegand said.

People can workout at 10 different stations. They focus on abs, chin-ups, push-ups, and tricep dips. There are stations for stretching, balance and agility, as well as one for low crawling.

"No motor vehicles will be allowed so everyone can enjoy their time in a quiet, safe place," he said.

The runners at the rave run were the first to grace the trail.

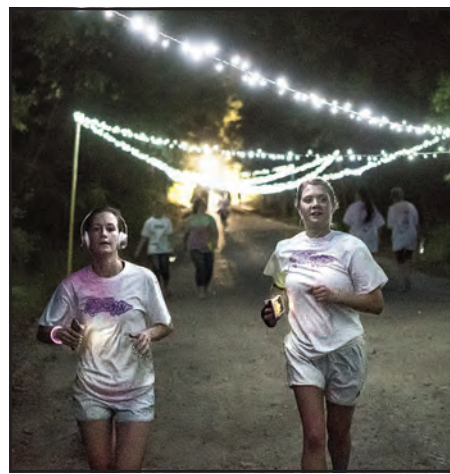
The Freedom Center was able to purchase the road with a grant from The Hagerman Foundation.

"Phil and Jocelyn Hagerman played a huge role in this. They have walked it with us and looked forward to this day for about a year," Wiegand said.

Becky Foerster, executive director at The Hagerman Foundation, said the church's plan for the road matched their mission to create

transformational change for Fenton and surrounding areas. She said they started working on it in July 2016.

"We believed in their vision and what they wanted to do to give Truck Road back to the community for wellness," she said. "When we saw what they wanted to do with truck road...we were on board. At the Hagerman Foundation, we're proud of the work that they're doing and we look forward to the years of outreach and what it can become."

Local girl's charity grows with national attention

■ Snuggle Sacks, which helps the homeless, has more than tripled in size

About a year and a half after the Times wrote about then-8-year-old Addisyn Goss starting a charity because she learned her grandfather was homeless, Snuggle Sacks has received national attention and has more than tripled in size.

Goss, a Linden student, and her mother, Stacey Daul, started Snuggle Sacks in October 2015 for homeless people after meeting Addisyn's grandfather, who was homeless at the time. Daul said he now lives in the Indiana Veterans Home in Indiana.

When they first started, the sacks included items like snacks, toiletries, hand sanitizer, shampoo, soap, lotion, socks, gloves, coins to make phone calls, Chapstick, hand warmers, and occasionally blankets. Daul said they were able to make about 50 a month. They dropped the sacks off at Catholic Charities in Flint, because Daul said they're more knowledgeable about who actually needs them.

Now, Daul said they make about 200 a month and the charity is an official nonprofit with 501c3 status.

"We continue to have donations on the porch when we get home, and are now able to make sacks specific to men, women and children," Daul said.

The story was picked up and Goss, now 10, was interviewed on radio shows like

SuperTalk 1570, Banana 101.5 and Nash 95.1 at various times, and was recently featured in USA Today on their "I am an American" campaign.

She was also on the nationally syndicated radio show America's Morning Show out of Nashville.

On being asked if she likes being interviewed this much, Goss said "I'm getting used to being interviewed and I just see it as a way to let more people know that there are people right here that need help bad and hopefully they want to help me do that. There have been some people that emailed us wanting to start something like this where they live, so that makes me happy."

Daul said her daughter is even more

passionate about it now.

"She has developed a relationship with many local shelters, as well as the homeless themselves. She is able to talk and joke with them, which just seems to lighten the mood all together. She is now also 10 years old, and has a better understanding of the issues surrounding homelessness, which is a big motivator as well. It also has given she and her sister, Sheridan and brother, Jaxson, a way to come together for a good cause," she said.

Dower rights in Michigan

"I read with interest your column on the abolishment of dower rights in Michigan. I am one of the few women who actually planned to exercise this right as our house is only in my husband's name. We always assumed it wouldn't be an issue, but now I'd like to protect myself. Would a quit claim deed do the trick to add my name to the deed? We don't have a mortgage to worry about."

The abolishment of dower is a relatively recent development as the new statute went into effect on April 6, 2017.

As you have pointed out, when your husband is the sole owner of the house, there may now be an issue for you.

However, if you are the sole beneficiary of his will, then upon his death, the house would be yours as a part of the Probate proceedings. Of course, this would not be a happy circumstance.

If your husband sells the house, the purchase monies paid would presumably be a part of the marital estate and you would be entitled to your share.

There are other scenarios that would not be positive ones for you including a transfer of the property to others. With the abolishment of dower, this is a possibility. Dower is what is called an "inchoate" right. Inchoate means something that will vest or be effective in the future.

Before dower was abolished, your husband's death would have made your dower rights vested, thus entitling you to one of three options under the Probate Code including taking your one-third life estate dower rights.

To avoid this potential set of problems, you have correctly suggested that one solution to protect yourself is for your husband to deed the property to you and him by way of a quit claim deed. However, you really should consult with a real estate attorney as there are other options including a trust.

The group handled three flats of flowers and 75 bags of mulch in an effort that ran from 9 to 11:30 a.m.

Piacentini said the “planting” day is more about maintenance than planting. She said the goal is to spend less time planting in order to use the funds on other programs, which can include community education. “We’re always looking for more ideas to educate the community,” she said.

Since 2016, Gerych’s Flowers & Events has handled the bulk of the flowers throughout downtown, and the Streetscape program included new shrubs and perennials, making planting by hand every year less necessary.

The lamp posts also include an irrigation system so that watering these 60 planters is automated.

On the city Beautification Program

Overall, the city of Fenton spends approximately \$20,000 annually on beautification. Between \$12,000 and \$15,000 is Downtown Development Authority (DDA) funds.

Gerych’s Flower & Events in Fenton handles most of the downtown flower

program, including approximately 60 hanging planters, which were placed by the Fenton Department of Public Works.

These funds also go toward winter flowers, which they are planting at Gerych’s now.

There are 12 planters around municipal buildings, and 16 rectangular boxes on the LeRoy Street bridge.

Doris Knight, Gerych’s greenhouse designer, researched the project, and installed the other planters downtown.

In February, Doug Dormer, Gerych’s grower, started growing special “enormous” petunias in their planters. They were fertilized, watered and grown with a May 20 delivery goal.

And the result? “It’s absolutely spectacular,” said Knight. “It was very successful last year, and it’s looking awesome this year.”

The other \$8,000 is paid directly from the city’s general fund, which covers the community planting day materials and “loose” flowers at City Hall and other municipal buildings. It also covers banners on Silver Lake Road, fall mums in the hanging baskets, the butterfly garden and educational programs, according to Councilwoman Pat Lockwood.

Board repeals medical marijuana ordinance

■ Would have regulated large grow houses in township

Fenton Twp. — The Fenton Township Board of Trustees voted 5-0 to repeal an ordinance that would allow for large medical marijuana grow houses.

Having Ordinance 720 on the books allowed for the regulation of large grow houses with numbers of plants in the thousands. Supervisor Bonnie Mathis and Treasurer John Tucker were absent.

At the May 15 meeting, township attorney Jack Belzer said the state legislature recently passed a law to allow for these large centers, and the township needed to repeal this ordinance if they wanted to keep medical marijuana facilities out

of the township.

The ordinance was originally adopted years ago, in an effort to protect the township, Clerk Robert Krug said at the May 15 meeting. “By repealing it, we are controlled by what the state says and they are much more restrictive than we could be,” Krug said. “The federal government still looks at it as an illegal drug.”

There is one medical marijuana caregiver in the township that has the appropriate licensing from the state to grow 12 marijuana plants for five patients.

This was the second action taken by the board in recent months to keep medical marijuana out of Fenton Township. In April, the board discussed certain facilities allowed under the Medical Marijuana Facilities Licensing Act. The board decided not to adopt an ordinance in favor or against, meaning those facilities are not allowed.

WT Development Corp. for Taco Bell of America and property owner Richard L. Jacobs requested approval to build the restaurant. It will be near McDonald's.

According to a draft of the May 1 Planning Commission meeting minutes, all concerns from engineering consultants and planning consultants have been corrected, and the Zoning Board of Appeals approved the two variance requests.

The first request was not to provide a bypass lane adjacent to the drive-through lane.

At the meeting, Developing Consultant Bill Beckett, said, "As a national design standard for Taco Bell, they discourage any potential conflicts between the drive-through and pedestrians so they would just...have a dedicated drive-through lane, keep the pedestrians on the south side or the main entry side of the building, and let the drive-through function the way it's designed to."

He said not having a bypass lane is not a problem on a day-to-day basis with other sites.

The other variance approved was a larger outdoor menu board.

Taco Bell patrons will also not be allowed to turn left onto West Broad Street to leave the site.

Linden City Planner Adam Young said not allowing left-hand turns out of

Taco Bell was one of the Planning Commission's conditions of approval for the preliminary site plan.

"That took Taco Bell a couple months to digest and decide whether or not they wanted to continue with development," Beckett said at the May 1 meeting. The decision was based on feedback from residents at Planning Commission meetings.

City councilor and planning commissioner Brad Dick said residents didn't want any left turns at Broad Street because it's very close to the intersection, and they didn't want left turns on Hyatt because the zoning becomes residential.

from waking up to get ready for work when Cora's friend ran up to her trailer and alerted her to the boat accident. Cora, with the help of her friend and the inflatables, had already made it to shore.

Thomas said she called 911 and within minutes, several sheriff's deputies and emergency personnel arrived to help.

The girls described the ski boat as black and green, with some yellow on it.

It was a warm evening and the girls were out swimming in the water together on inflatable flotation devices. It was still daylight. Thomas said Cora was very familiar with the beach and lake as she has played in the water every year since she was a baby.

When the accident occurred, the girls were out just a bit further than a long dock, which belongs to a house just south of the park property.

Thomas said the girls told her and the sheriff's deputies that they saw the boat, pulling a skier, approaching them from the south and they tried to get out of the way. The girls reported that the skier fell in front of the mobile home park and the driver of the boat went back, picked up the skier and kept going.

Sheriff's marine patrol boats cruised around Lake Ponemah and Squaw Lake

shining spotlights along the shoreline in search of the boat.

Thomas was later told that a boat matching the description provided by the girls, as well as the boaters, were located at the DNR public launch while they were trying to remove the boat from the lake.

Thomas said an investigator told her that the boat driver had not been drinking, but the others in the boat had been. She was also told that if the driver of the boat had seen the girls, they would have gone back.

"Cora's friend had a hot pink bathing suit on," said Thomas. "They said they didn't see my kid. I don't believe that." She added that had Cora been facing the other way, it could have been her head, not her leg, being hit by the prop. "If I can press charges, I will."

Frustrated and concerned for her injured daughter, Thomas said she has regrets. "I should have been down there," she said.

This incident is currently under investigation by the Genesee County Sheriff's Office. Tuesday morning, Undersheriff Chris Swanson said there was no update to report on their investigation.

St., where it has operated for many years under different ownership. The sole stockholder now is Norman Barman.

After conducting a background investigation on Barman, Slater said in the early 1990s, he was found guilty of the crime of felony larceny. In 2000, he was charged with and pleaded guilty to misdemeanor possession of fireworks and was fined \$100, according to Slater.

From 1989 to 1991, Harman was a stockholder in a Fowlerville bowling alley named Super Bowl of Fowlerville, Inc. During his time as a stockholder of Super Bowl, Inc., there was no violation history, said Slater.

"In 1991, Mr. Barman relinquished his interest in the business and moved out of state," Slater said.

It was later learned that the remaining shareholder never removed Barman's name from the liquor license and between 1992 and 1997, while under the management of the remaining shareholder, it amassed an extensive violation history.

"Barman understands that it was his responsibility to notify the Michigan Liquor Control Commission and he regrets that he did not follow up to make sure MLCC was notified," Slater said.

The restaurant's day-to-day operations will be handled by its general manager, Steven Kizy. Nothing in Kizy's background would prevent him from running the business, said Slater.

Notice of Barman's intentions was also made by the MLCC to the two nearby churches. The First Presbyterian Church first filed an objection letter over the intended request, but this objection was later rescinded after a successful meeting between church leaders and Fenton House Restaurant, Inc.

Slater said Fenton House has been a successful restaurant in the downtown area for many years. Since Barman has taken over, major improvements, via interior renovations, have been completed resulting in an updated atmosphere in which to have lunch or dinner. The arcade room in the back of the restaurant has also been remodeled and is an appealing place for youngsters, he added.

However, Slater said Barman's felony convictions are in direct conflict with a Fenton City ordinance. "I cannot make a recommendation relative to the Class C/SDM transfer at this time," he said.

In a straw poll, city council members one by one said they would support the liquor license transfer anyway. It was their collective opinion that something that happened 25 years ago should not be cause to penalize this business owner today.

"Fenton House has been a mainstay in our community for many many years," said Councilwoman Pat Lockwood. "They have employed numerous young people over the years."

Councilman Scott Grossmeyer said 25 years was a lifetime ago. Councilman Brad Jacob said what happened was a long time ago and he would support the transfer.

Councilman Dave McDermott said if an agreement had not been worked out with the church he would not be able to support it. But since they did, he has no problem supporting this.

The Fenton City Council is expected

to make a decision on these liquor license requests at its Monday, June 12 regular meeting. The MLCC has final authority over who does or does not get approval.

Marathon Gas Station

While it may not include a busy auto repair shop anymore, the Marathon Gas Station at 402 W. Silver Lake Road (at Adelaide) is reinventing itself into something that may be equally as popular — a new convenience store.

"This property is currently being renovated, where they are removing the existing vehicle service bays and converting the structure to house a convenience store with existing gas pumps," said Slater.

Three Lake Fenton seniors made sure they ended their Blue Devils' athletic careers in grand style Saturday at the D2 state track and field meet held at Zeeland High School.

Seniors Thomas Mueller, Remington Clements and Isaac Golson teamed with junior Elijah Bourdeau to earn the 4X800 meter relay state championship with a time of school record time of 7:50.92.

Breaking school records wasn't a surprise for the four. It was the fourth time they broke the school record in the event this season. The Lake Fenton group beat Otsego's second-place team by more than one second. They recorded a time of 7:52.47. They helped the Blue Devils record 14 team points, good enough for 16th place.

"It was amazing. It was really cool having four guys be able to do something like that. It's a lot

Clements ran the first 800 and finished in about eighth place. He handed off to Golson who ran a pretty similar split as Clements' split, putting the team a bit closer to first. Then Elijah Bourdeau ran and put the team in front. When Mueller finished the race, he did so with hands in the air.

Fowlerville — The Linden varsity girls soccer team seemingly always has a strong squad.

During recent seasons they've been ranked, expected to contend for Metro League titles and have been a good pick to win postseason tournament honors as well.

But it seems one squad has kept them from a lot of those accolades in recent seasons — their No. 1 rivals, the Fenton Tigers.

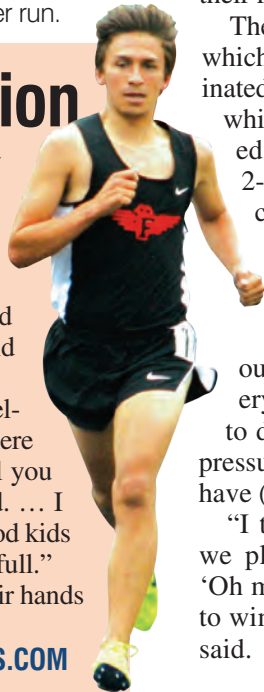
West (200 and 400) and Andrew Bond (3,200).

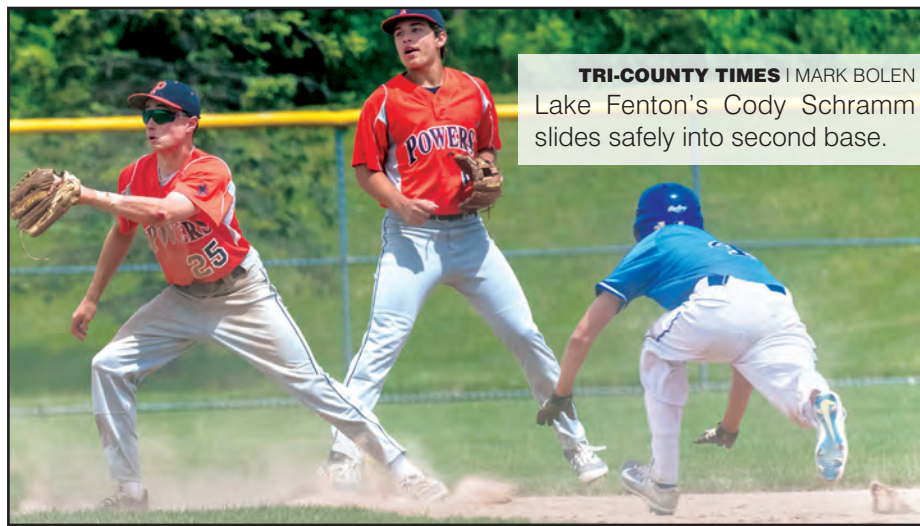

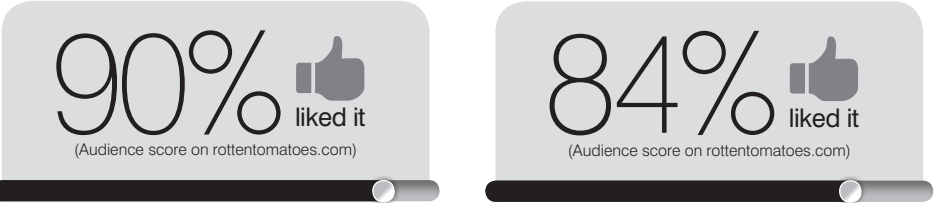

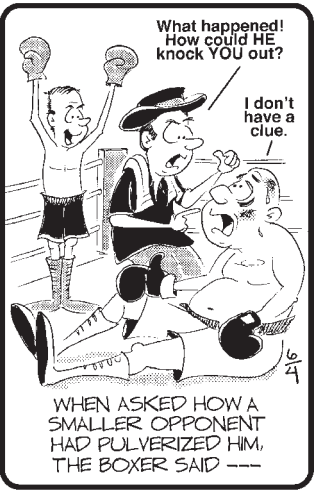
