# One year later — shooter still deemed incompetent

## 'He was clinically dead when we arrived on scene'

■ Emergency personnel, citizens recognized for saving life of local teen

**Holly Twp.** — On May 27, Robert McConnaughey, 16, of Holly Township was driving along Addis Road in Holly Township, when he lost control of his car, and slammed into a tree. He was knocked unconscious and the crash caused the vehicle to catch fire.

Henry Weis, a passerby, happened to see the crash and immediately began working to save his life. Weiss pulled McConnaughey from the wreckage of his car and pulled him to safety.

Property owner Tim Miles soon saw the incident and came out to help. Emergency responders from The North Oakland County Fire Authority (NOCFA) and Michigan State Police (MSP) soon arrived to handle the crash that more than likely should have ended in tragedy.

"It doesn't usually turn out this way," said NOCFA

# Board delays vote on marijuana ordinance

■ New criminal ordinance would prohibit possession of marijuana

**Fenton Twp.** — On Monday, the Fenton Township Board of Trustees discussed striking language from the disorderly persons ordinance pertaining to growing and cultivating marijuana in preparation for a separate ordinance that would prohibit the possession of marijuana.

Attorney Amanda Doyle, who stepped in for township attorney Jack Belzer, said Belzer was concerned with the marijuana language in the statute. It references the Michigan Medical Marihuana Act and includes language about growing and cultivating marijuana. Neither is legal in the township unless the individual has the appropriate license.

“We don’t want any confusion. The pro-

posal is to remove that from the disorderly ordinance and create a stand-alone criminal ordinance for marijuana,” she said.

Doyle said while it’s legal to have marijuana with a medical marijuana card, it’s not legal to drive while under the influence.

“We’d like to make that a stand-alone ordinance so that it doesn’t reference anything aside from possessing. We don’t want to talk about ... growing, cultivating, transporting,” she said.

Doyle recommended waiting to adopt this change until they vote and adopt the new ordinance prohibiting the possession of marijuana.

Changing the disorderly persons ordinance will be effective upon publication because there’s no penalty. Since the ordinance prohibiting the possession of marijuana would have a

penalty, it won’t be effective until 30 days after publication.

If the township changed the disorderly persons ordinance before adopting the new ordinance, there would be a window of time

when no ordinance on the books would prohibit the possession of marijuana.

The board decided to table the vote until the new ordinance was ready.

## Marijuana in Fenton Township

It is illegal to drive while under the influence of marijuana, with or without a medical card.

The Medical Marihuana Facilities Licensing Act allows the state of Michigan to license five types of medical marijuana facilities including growers, processors, transporters, provisioning centers, and safety compliance facilities. The Fenton Township Board of Trustees did not vote to approve or reject these facilities, meaning they are prohibited in the township.

It is legal for caregivers to grow and distribute medical marijuana as long as they have the proper licensing.

## Marihuana vs. Marijuana

Since the act spells “marihuana” with an “h,” the Times will use an “h” when referring to the act, but will use “marijuana” with other references due to the “j” being more common.

## Respect, civility and the law

I recently read a wonderful article in Time Magazine by Yale Law School Dean Heather Gerken titled, “One Campus Arena Where Free Speech Is Not Up For Debate: Law Schools.”

In her article she talked about some recent protests that have occurred when certain “controversial” individuals were guest speakers and how such disruptions were “ugly free-speech incidents.”

She then went on to point out how law schools throughout the country have not had such incidents and that so called controversial speakers have appeared on law school campuses and not only have they been allowed to speak, but any protests which occurred did not disrupt the exercise of their free speech rights.

Why did this happen only at law schools? The answer given by Dean Gerven was that in law schools and then in courts, respect for the other side is the rule. Law students are taught that the day they really become lawyers is the day they realize that the law doesn’t and shouldn’t match everything they believe.

A different way of putting this is to understand that lawyers know how to go to war without turning the other side into an enemy, and perhaps it’s time for the rest of the country to take a lesson from the legal profession.

I wholeheartedly agree with the Dean and will simply indicate that today we seemingly are living in a world where arguing and not getting along with one another is becoming more the norm as opposed to the exception.

The legal profession emphasizes having respect and civility in its Michigan Rules of Professional Conduct for lawyers and the Code of Judicial Conduct for Judges.

For example, one Canon in the Judicial Code specifically indicates that judges must be patient, dignified and courteous to everyone he or she encounters in an official capacity and require lawyers and others to do the same.

Being respectful and civil never hurt anyone and there is nothing wrong with behaving this way being our daily goal.

Even though lawyers and judges on occasion may not act the way they should, there are mechanisms in place to deal with this. I believe that when it comes to respect and civility the law has set the bar high.

## Council supports CRUST liquor license request

■ Expansion project to be completed by fall of this year

The Fenton City Council voted Monday, July 24, to support the transfer of a Class C liquor license to CRUST, LLC. The license, being transferred from Makuch's Red Rooster, LTD, comes with a new Sunday Sales permit (a.m.) and outdoor service.

Makuch's Red Rooster of Flint closed in 2012 after 50 years in business.

The recommendation to support CRUST's request came from Police Chief Jason Slater. In his memo to City Manager Lynn Markland, he said, "CRUST Bakery has been a successful business in the downtown area since it opened in 2012. Currently, a renovation project is being completed, which will allow CRUST, LLC to become a full-service restaurant serving breakfast, lunch and dinner."

As required by ordinance, background investigations of Chad Brennan and Mark Hamel, owners of CRUST and The Laundry, Fenton Relief & Resource and El Topo, were conducted.

"The results of my investigation show no history of any criminal

## KEEPING THE RIVER CLEAN

■ Volunteers notice less trash in Shiawassee River than in past years

**Argentine Twp.** — The work of keeping a river clear for kayaking is never done.

There will always be more fallen trees and more garbage tossed into the Shiawassee River, but local nonprofit organizations work to keep the river that connects the tri-county area clear for canoeing, kayaking, and stand-up paddle boarding.

On Sunday, July 16, 17 volunteers from

Headwaters Trails, Keepers of the Shiawassee, Friends of the Shiawassee and Flint River Watershed Coalition held a river cleanup that started at Hogan Road in Fenton Township and ended at McCaslin Lake Road in Argentine Township.

Previous cleanups have been held in Fenton, Linden and Holly.

To decide which section of the river to attack, Chuck Julian of Headwaters Trails Inc. takes feedback from Facebook posts about the river as well as from users and members of the organization.

They had reports of several trees blocking the river between Hogan and Cole Road, and decided that they should go to McCaslin Lake Road to ensure it was open. He said they cut five trees that were between eight and 15 inches in diameter, and moved several dozen small trees and "nuisance" branches.

While the logs and branches were removed from the river pathway, they will stay on the banks of the river, per Michigan Department of Natural Resources (MDNR) request. Julian said the fallen timber provides

fish habitat and shore protection. Some larger trunks were anchored to

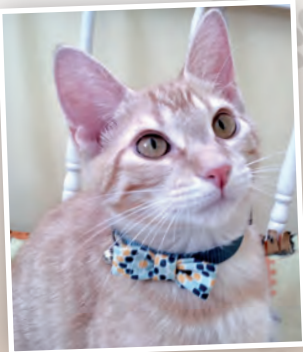

# Saving your senses

■ You can help protect your hearing, sight, taste, smell and touch with a healthy lifestyle

When legendary guitarist Eric Clapton listens to music today, he chooses soft classical sounds rather than the hard rock music he and fellow rockers have been playing for decades.

At age 72, he wants to protect the hearing he has left, and he's not alone — many of today's aging rock stars are living proof of the importance of protecting your hearing.

You may not be an aging rock star, but chances are you've attended your share of rock concerts, no matter what generation you're in.

Hearing loss affects not only your ability to hear, but can accelerate the shrinking of your brain, which can more than double the risk of dementia, according to AARP magazine. It can also increase your odds for depression and loneliness.

"It's estimated that one of every four people over the age of 65 has a hearing disorder," said Gary Kade, senior master hearing care practitioner for Beltone, with an office in Fenton. "However, hearing loss can affect you at any age."

## How to protect your hearing:

- Wear hearing protection in any loud environment, from mowing lawns to using power tools
- Watch your weight, blood sugar level and blood pressure to keep the tiny arteries that fuel hair cells in your ears healthy
- Get an annual hearing evaluation by a licensed professional
- Use hearing aids or devices to amplify the sound of your phone or TV

## Here's how to protect your other senses:

### Sight

Chances are you've already noticed some age-related vision changes if you're over the age of 40.

Focusing up close gets difficult as the eye's crystal-clear lens stiffens and muscle fibers that control it weaken, putting you in need of reading glasses. You may need more light for reading due to lens and pupil changes.

If you're between the ages of 45 and 55, your rates of macular degeneration and glaucoma have doubled and the risk of cataracts has tripled.

## How to protect your eyesight:

- Exercise regularly to maintain blood

flow to your eyes

- Get plenty of sleep to keep eyes lubricated and help remove irritants.
- Consider refractive surgery to correct your vision, if you have no signs of cataracts
- Treat dry eyes with your eye doctor to make your eyes feel less gritty and tired

### Taste

If you find yourself putting more salt in your soup or sugar in your tea, you may be experiencing a change in your taste buds. They don't regenerate at the same rate as when you were younger, and some diseases can also affect taste sensitivity.

## How to protect your taste buds:

- Take care of treatable conditions, such as high blood sugar, infections and inflammatory bowel disease
- If you are experiencing a lack of saliva, check with your doctor
- Pump up sweet and salty flavors in a healthy way, by sprinkling a little sugar on sliced fruit or a little sea salt on vegetables

### Smell

Every aroma is processed by a patch of nerve endings high in your nose. They wear out and may even die off with age. Because smell and taste are so closely related, you may find that food isn't as enjoyable as it used to be.

Your sense of smell can also be a matter of life and death. Twenty percent of those age 70 and older in one study couldn't detect the smell of smoke and 31 percent didn't notice the smell of natural gas.

## How to protect your sense of smell:

- Exercise regularly
- Don't drink excessively
- Avoid strong fumes from cleaning products and other chemicals
- Train your sense of smell by gently sniffing familiar aromas, such as lemon, clove, eucalyptus and rose.

### Touch

Touch-sensing receptors in your skin may decline in their ability to detect pain, heat and cold. Aging can also affect sensors in joints, muscles, tendons and skin that give your brain input about where your body is in space. As a result, you may feel unsteady or clumsy.

## How to protect your sense of touch:

- Keep moving. The more your body has the experience of moving in space, the more these receptors will stay active.
- Wear body-hugging clothing to stimulate touch receptors
- Be generous with physical affection
- Schedule a massage

# Girl struck by boat recovering at home

■ Sheriff's office to turn case over to prosecutor's office for possible charges against driver

The 12-year-old girl who was hit by a boat on Lake Ponemah in early June has returned home.

Cora Thomas, who's now 13 years old, is the victim of an alleged hit-and-run accident that took place June 4, at approximately 8:45 p.m. She was swimming when a speedboat pulling a wake surfer drove by and struck her.

Cora suffered injuries to her right leg. She had a broken tibia and fibula, and her

third toe is broken. She has a large open wound right above her ankle, and other lacerations below her ankle and on the ball of her foot.

She was taken to Mott Children's Hospital in Ann Arbor where she had surgeries to repair tendons and to hold bones together.

Her mother, Michelle Thomas, said, "She's in in good spirits for the most part." Cora was in the hospital from June 4 to 29. She was brought home for 12 days, but had to return July 13 to 15 so doctors could put a new layer of artificial skin on her leg.

"She came home with a device called a wound vac. It helps heal the open wounds faster," said Thomas. Cora was able to come home in time for her 13th birthday

on July 19, but had to go the hospital that day for a check up on her leg.

Thomas said Cora will need more surgeries, including more skin grafts. Thomas is a single mother working full time at VG's. She's had to take time off to take care of Cora.

A gofundme account has been established to help with expenses (www.gofundme.com/corarae).

A fundraising event is also planned for Cora on Aug. 26 at 2 p.m. at the VFW Hall Post 3243, 1148 N. LeRoy, Fenton.

"I've been off work now since the day it happened ... I've worked there for 20 years," she said. "I've been having to get up every four hours to give her meds and

help to shower and use the bathroom. She has a walker and a wheelchair that she uses to get around.

"I hope to return to work by the end of August. I'm praying she will be done or almost done with surgeries by then," Thomas said.

According to the Genesee County Sheriff's Office, there were three occupants in the boat, and one person wake surfing behind the boat when the accident occurred. A 21-year-old man and his 19-year-old girlfriend, both of Swartz Creek, were in the boat with a 22-year-old Fenton Township man. A 39-year-old Fenton Township man was the wake surfer.

The prosecutor's office has not yet announced any charges.

## Tale of a fateful trip

■ 'Gilligan's Island' still popular after 50 years

If you were a child old enough to watch TV in the fall of 1964, you probably still know all the words to "The Ballad of Gil-

ligan's Island." (See sidebar if you want to relive the joy.)

Though it wasn't wildly popular among critics, Gilligan's Island had solid ratings as a fun, family friendly sitcom from the time it first aired on Sept. 26, 1964.

The story line is that seven people set sail on what was scheduled to be a three-

hour sight-seeing tour on the charter boat, The Minnow. They get caught in a storm and end up stranded on an uncharted tropical island together.

According to tv.com, the comedy comes from the failed attempts at getting off the island and the interaction between those stranded, a very diverse group.

The castaways include a rotund but happy-go-lucky skipper, Jonas Grumby, known as "The Skipper," and his bumbling but well-meaning first mate, Gilligan.

Stranded with them was the snobby well-to-do millionaire, Thurston Howell III and his wife, Lovey; a buxom sexy movie star bombshell, Ginger; a high-school science professor, Roy Hinkley

(called "The Professor"); and a nice country girl, Mary Ann.

Fifty years later after that final wrap party in 1967, Gilligan's Island is still on the air. It was sold into syndication and has been broadcasting reruns continuously in 30 different languages around the world.

### How it all started

One day in a public speaking class at New York University, the professor had students compose an impromptu one-minute speech on this topic: If you were stranded on a desert island, what one item would you like to have? Sherwood Schwartz was a student in that class, and the question so intrigued him that it remained lodged in the back of his mind for many years.

After working for some time as a comedy writer for other shows, Schwartz decided to pitch his own idea for a sitcom. Thinking back to that desert island question, he thought it would make for an interesting dynamic to have a group of very dissimilar individuals stranded together and have to learn to live and work together.

### Gilligan

Schwartz chose the name of the bumbling first mate, Gilligan, from the Los Angeles telephone directory. Gilligan's first name was never mentioned during the series, but according to Schwartz's original notes, it was intended to be "Willy." Yet Bob Denver always insisted that "Gilligan" was the character's first name.

### The Skipper

The Skipper was the toughest, and last, character to be cast. Schwartz auditioned dozens of actors (including Carroll O'Connor), but no one was quite right. He wanted someone strong and commanding, sometimes blustery and short-tempered, but able to show a genuine affection for Gilligan even when smacking him over the head with his hat.

### Mrs. Lovey Howell

Natalie Schafer, who played Mrs. Lovey Howell — and allegedly only accepted the invitation to play Mrs. Howell because it meant a free trip to Hawaii to film the pilot — was a real-life millionaire. When she died in 1991, rumor has it that Schafer left a tidy sum to her Gilligan's Island co-star Dawn Wells (Mary Ann), who lived with and helped care for Schafer as she battled breast cancer.

### DUMP TRUCK REPAIRS APPROVED

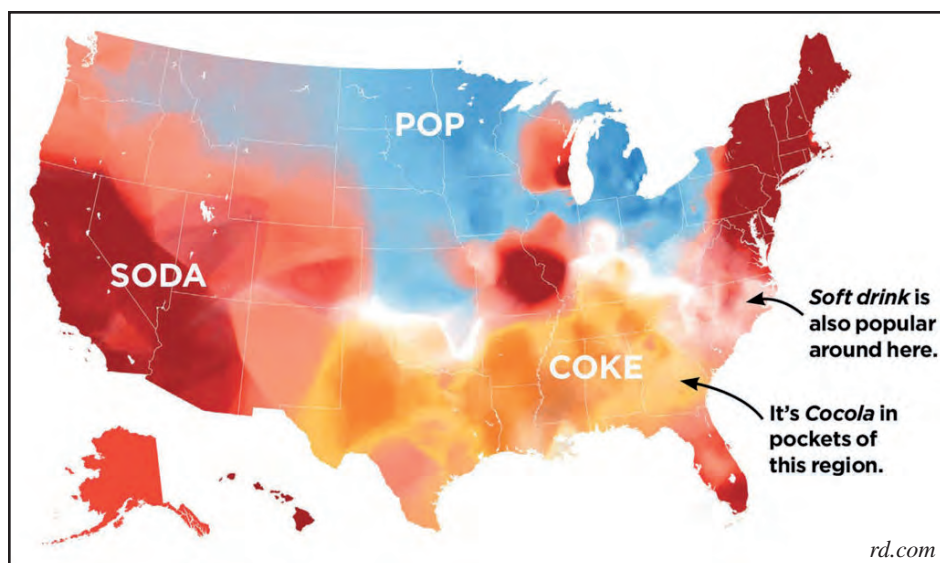
On Monday, July 24, the Fenton City Council approved spending \$80,836 to repair two of the Department of Public Works' dump trucks. Ninety-thousand dollars has been budgeted in the current year budget for this work, according to DPW Director Dan Czarnecki. One truck is 18 years old and the other is 11 years old. Both have less than 40,000 miles on them. Czarnecki said the chassis and engines are in good working order because the DPW crews continue to do a good job on routine maintenance. "With continued routine maintenance and repairs we should be able to get many more years of service out of the vehicles," Czarnecki said in his memo to City Manager Lynn Markland. Components are in need of work. These trucks are used to haul everything from gravel, wet dirt, broken concrete, asphalt and road salt, he added. Truck and Trailer in Howell was contacted for the quote on this work. "They performed the work on the other trucks and we wish to have the same setups in all the trucks so they all operate identically and drivers only need to learn one system. Replacement costs for a new dump truck are in the \$180,000 to \$200,000 range.

## News briefs

### PAVEMENT LINES TO BE REPAINTED

Thirty-six miles of yellow lines and nine miles of white lines will be repainted in the city of Fenton. On Monday, July 24, the city council voted to approve a quote from M & M Pavement Marking to do the job. According to Department of Public Works Director Dan Czarnecki, the same company also painted all the arrows, crosswalks, stop bars and other miscellaneous markings in 2013. This year, the DPW work crew will perform that work. M & M. Pavement Markings does the same line painting for the county. The Fenton job will cost \$11,082, the same price they charged last year.





## You know you're from Michigan when...

■ The words you use depend on where you live, called 'regionalisms'

In Michigan, it's called "pop." In the western and southern states, it's called "soda."

Certain items are called different things depending on where you're located. These can be an indicator that someone is not from a certain region, and sometimes it can cause a language barrier.

Author of "Speaking American," Josh Katz, surveyed 350,000 people for his book on the topic of what he calls "regionalisms."

Here's what he discovered:

### Fireflies vs. Lightning Bugs

The little insects that fly around at night with a light for a butt have different names, mainly separated by east and west. In the West, along with Wisconsin, Michigan, and the Upper East Coast states, people call them "fireflies." Most of the eastern states refer to them as "lightning bugs."

### Garage Sale vs. Rummage Sale

When people sell stuff they don't want in their garage or on their front yard or driveway, the U.S. has a few different names for it. In the southeastern states and many of the western states, it's called a "yard sale." In the middle of the country, including Michigan and parts of the very western states, it's called a "garage sale."

People in eastern Wisconsin call it a "rummage sale," and some people in a few East Coast states call it a "tag sale."

### You guys vs. Y'all

People in the southeastern states, plus Texas, commonly refer to a group of people as "y'all," while most of the country uses "you guys." However, some people in Pittsburgh say "yinz." In parts of New York, New Jersey and Pennsylvania, some people say "youse," and some

people in Kentucky use "you all."

### Pop vs. Soda vs. Coke

One of the most notable examples of regionalisms is what people call a carbonated beverage. In Michigan, parts of Ohio and Indiana, and the upper middle states, people call the beverage "pop." The word "soda" is used on the East Coast, West Coast, Hawaii, and Southern Florida.

People use the word "coke" in the south. "Soft drink" is popular in certain parts of the East Coast, and "Coccola" is used in the heart of the South.

### Garbage Can vs. Trash Can

Most of the northern states, except a few East Coast states, use the term "garbage can" to refer to a waste receptacle. Most of Michigan, and the rest of the country, use "trash can."

### Semi vs. Tractor Trailer vs. Eighteen-Wheeler

Except for the South and the East Coast, most of the U.S. uses "semi" or "semi-truck" when talking about the vehicle that hauls freight. The South uses "eighteen-wheeler," and the East Coast uses "tractor trailer."

### Drinking Fountain vs. Water Fountain

In the Upper Midwest states and the West, people use "drinking fountain" to refer to a machine that dispenses water in public places. In the South and East, it's called a "water fountain." Some people in eastern Wisconsin and eastern New Hampshire and Massachusetts use the term "bubbler."

### Tennis Shoes vs. Sneakers

When referring to athletic footwear, most of the country uses the term "tennis shoes." The northern East Coast and southern Florida use "sneakers." In Chicago and Cincinnati, people say "gym shoes."

### Two syllables or three for caramel?

Most of the country forgets about the second "a" in caramel, and pronounces it with two syllables. The only parts of the country that say it with three syllables are the South and the East Coast.

the banks with steel cable, and others were settled among the existing trees and foliage.

The group also pulled out four tires, a child's car seat, a seat cushion, a steel fence post, and a large chunk of black plastic. They filled one 33-gallon bag of miscellaneous bottles, cans, footwear, food wrappers and others. "We left a couple of sheets of plywood we found that were too big for us to carry," he said.

Julian said they are pulling out far less trash now each year than in the past, especially bottles, cans and food containers. Some of the bottles are over 100 years old, said Julian.

The trash was disposed of either by Argentine Township or volunteer Bruce Allan.

This effort is all volunteer, and self-funded, including the hardware and tools needed. Julian buys pizza, and Maggie Yerman of Keepers of the Shiawassee hosted

the group at her house.

Julian said that the effort to keep the river clear came from the urge to be able to "paddle a beautiful mostly natural river that was nearby. We refer to the experience as being 'up north nearby.'"

"The Shiawassee is considered a model for a river that has natural features intact, that regulate water flow, making it one of the least flood flashy rivers in south east Michigan," she said.

The river is home to several rare Michigan species, such as Karner Blue butterflies, the Blandings Turtle and endangered flowers, such as the Fringed Gentian.

These organizations are always looking for assistance through volunteer time and membership dues. "They can help by preserving their land along the river watershed for the plants and wildlife that make this riverso special," said Julian. "They can pick up trash if they see it on the river, while they are enjoying paddling. They can ask their elected officials to support this and other trails in the area."

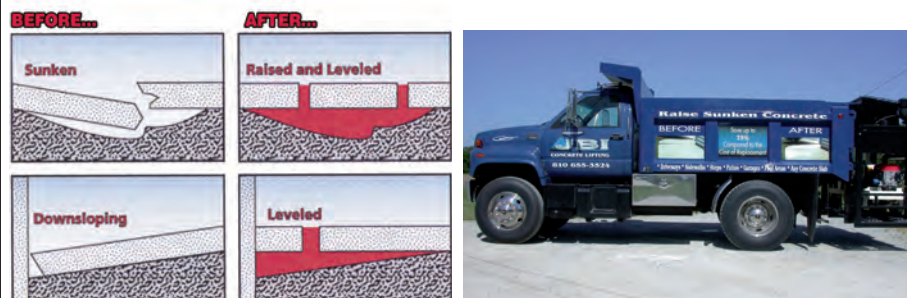

### Mr. Howell

Jim Backus, who played Mr. Howell, was beloved by his cast-mates. In addition to being the source of endless jokes and a willing coach to the less experienced actors, he was also notoriously cheap. Dawn Wells (Mary Ann) recalled how during the show's first season he would often invite her and Natalie Schafer out to lunch ... only to realize that he had left his wallet back at the studio when the check came.

### The movie star

There was alleged on-set tension between Ginger (Tina Louise) and the rest of the castaways. Bob Denver would not say why he and the glamorous Tina Louise did not get along, nor would any of the castaways. They just ignored her, and she ignored them. Between scenes she sat off by herself. Part of Louise's dissatisfaction with the series was that she had expected to be the star of the show. Her agent had allegedly pitched it to her as the story of an actress stranded

on an island with six other people.

### The professor

On July 18, 2014, "Empire News," a self-proclaimed satirical and entertainment website, published an article that said the late Russell Johnson, the Professor in Gilligan's Island, had been identified as the Zodiac Killer, a serial killer who targeted victims in northern California in the late 1960s and early 1970s (and whose identity remains unknown to this day).

Notorious in the late 1960s and early 1970s for the grisly murders of at least six people and a slew of threatening letters to the San Francisco Chronicle, the serial killer was never identified.

Johnson died of kidney failure in January 2014.

Detectives investigating this case thought they had their man and thought he was literally hiding in plain sight. But once links and excerpts were circulated on social media, it became clear the "Empire News" piece was being mistaken for a genuine news item. According to snopes.com, Johnson was not the Zodiac Killer.

But most importantly, McConnaughey was able to hug his rescuer, and his mother, Jenny Johnson, was able to personally thank the people responsible for saving her son's life. Seeing her son's rescuers, she said she felt "grateful, emotional."

McConnaughey said, "I just want to thank them all for being there, and doing what they did."

Despite being in a crash that left his vehicle mangled

and on fire, McConnaughey was at the meeting with only a cast on his lower leg.

Lintz said a full recovery of full brain and body functions after such a crash is amazing. "He was clinically dead when we got on scene," he said. Lintz added that without Weiss and Miles, McConnaughey would not have survived.

responded to the medical emergency at approximately 7:30 p.m.

NOCFA received the call that a 25-year-old male dove into shallow water and struck his head. He was pulled out of the water, unconscious and not breathing. Two registered nurses and the DNR provided care to him before NOCFA medics arrived.

NOCFA Chief Jeremy Lintz said that the man had a pulse, but could not breathe on his own. He was transported Genesys Regional Medical Center in Grand Blanc Township. Lintz said he is currently in serious but stable condition.

Lintz said that his agency handles three to four water-related emergencies each summer at Seven lakes State Park.

"Most are drownings or near drownings from persons that do not know how to swim," said Lintz. "This is the first diving incident that I am aware of that we have had out there."

Lintz said there are no lifeguards

at this beach, and that there are buoy markers outlining the public swim area.

### SAFETY TIPS FOR AREA LAKES

- Before you go swimming, the most important thing is to know how to swim.
- If you cannot swim, do not wade out to try to see how deep you can get in the water. Stay in shallow water.
- Never swim while under the influence of alcohol or recreational drugs. If you're taking any medication, ask your doctor about any possible side effects, such as drowsiness or impaired motor skill, and avoid swimming if they do.
- Closely monitor children even if a lifeguard is present. Make sure that small children wear U.S. Coast Guard-approved life jackets and use flotation devices. If you need to leave the swimming area, always take your children with you.
- Always swim in designated areas.
- DO NOT dive in shallow water. Always enter water feet first.

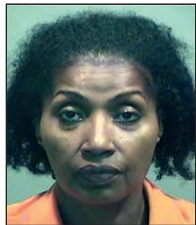
and the baby survived. Work died July 29.

Tyson was declared incompetent to stand trial in December 2016. Defendants declared incompetent are given 15 months for rehabilitation. She has been declared incompetent multiple times since December 2016. If she's found incompetent after the 15 months, the case will be dismissed. It's almost been nine months since the incompetency ruling.

Tyson's defense attorney, Michael Ewing, said, "She has not yet been found competent. Once she is, the case will proceed to trial."

Another hearing is scheduled for Aug. 9 to determine competency.

torney John Potbury explained in a previous Times article that, "In general, 'incompetent to stand trial' typically means that a psychiatric evaluation indicates the defendant does not presently understand the basic aspects of the criminal justice system and the adjudication process and is unable to assist their attorney in their own defense."

A defendant found incompetent may not understand the role of their defense attorney, the role of the judge or prosecutor, and does not understand or are unable to comprehend their basic rights in the system, like their right to cross exam witnesses, or right to not testify among others, Potbury explained.

**Linden** — Fourteen years ago when the Wednesday Night Races at the Park began, children like Fenton's Dominic Dimambro and Linden's Brad Ferrara were among those who competed in the event held at Linden County Park.

While they were reasonably unknowns at the time — Dimambro was just in the second grade — eventually, those names became some of the star runners in the tri-county area's cross country and track scene.

Advance the date 14 years to this summer. This June and July there were runners as young as 3-year-old Abigail Wright running the 400-meter race at the Wednesday Night Races at the Park series. About 40 runners that have yet to reach their teenage years have continued on the Wednesday tradition began by those young runners over a decade ago. Some probably will never continue their running "careers" beyond the Wednesday events, but could some end up being tomorrows future All-State athletes? Who knows.

### I'm an Extr EmE runner once again

Well, I did it. For the third straight year I have earned the distinguished title as an 'extreme runner' at the Wednesday Races at the Park held at Linden County Park.

It's not hard to get the medal. You don't have to take first place. In fact, I teased my wife saying I was pictured on the medal — the guy in last place. All you have to do it show up each of the four weeks of the event, finish one of the races (for me that's the two-mile event) and receive your medal.

Whatever people do and whatever time, is fine. The point is they are out there trying — at least that's what I tell myself every time I finish in last.

So until next year, I guess we remain tied at 3-all in the extreme medal race. And as long as Linden Community Education runs it again next year it looks like I'll be writing out our family 4-4 tie in about a year.
