

Fenton man charged with child porn

■ Accused of posing as high school student to lure girls to send him nude photographs

A 46-year-old Fenton man is in custody after being arrested Nov. 6 for attempted production and actual production of child pornography on March 9 and possession of child pornography.

The suspect, Ray Matthew Moore II, appeared in U.S. District Court – Eastern District of Michigan on Nov. 6.

According to court records a Michigan State Police detective, who is also a Task Force Officer with the FBI, told Magistrate Judge Stephanie Dawkins Davis that he was assigned to investigate Moore.

According to the six-page complaint, Facebook submitted seven cyber tips to the National Center for Missing and Exploited Children alleging that

Moore used multiple associated Facebook accounts to solicit juvenile females for photos of themselves, constituting child pornography.

The four accounts were Ray Moore II, Matthew Johnson, Ray Matthew (#1) and Ray Matthew (#2). These four accounts were connected through digital cookies, a small text file that contains a unique ID tag that is placed on the user's computer by a website. From this cookie

Semi vs. SUV ends in fatality

■ South Lyon man dies in Monday morning crash

Tyrone Twp. — A Monday morning crash in Tyrone Township proved fatal for 67-year-old Michael Joseph Martus of South Lyon.

At approximately 7:26 a.m. on Monday, Nov. 13, the Fenton Fire Department and Livingston County Sheriff's Office were dispatched to a personal injury crash on northbound U.S. 23, south of the White Lake Road exit.

A semi tractor-trailer left the roadway and jackknifed in the shoulder between Runyan Lake Road and the highway.

1,500 attend Holly Ladies Night Out

Holly — It was so busy that it took a little patience and a lack of regard for personal space to make it through all the stops at Ladies Night Out.

Businesses like Pigeon in the Parlour experienced log jams to get in and out of the building, which visitors handled with good nature and a sense of humor.

On Friday, Nov. 10, downtown businesses were full, sometimes beyond capacity, with strolling shoppers, motivated by fun and the possibility of prizes and good deals for the 12th annual Ladies Night Out in Holly.

Katy Hughes, director of the Holly Downtown Development Authority (DDA), said that the evening was mostly staffed by volunteers, and sponsored by 54 businesses, which included downtown spots, along with mid- and north-end shopping district businesses.

Each business had its own deals and specials, like substantial discounts on an entrée, live music, free samples and other giveaways.

The DDA also conducted a mini survey of 250 attendees, which included questions about where they live, have they attended before and would they attend again.

The DDA found that 52 towns and cities were represented, half had attended already, and all the respondents would come back next year.

City approves more than \$51,000 in upgrades

■ Expenditures will take care of fire and water department, as well as library needs

The Fenton City Council agreed to spend some money at its Monday, Nov. 13 meeting.

The first item was at the request of Fire Chief Bob Cairnduff, who asked for a Ram-air dryer, which including shipping will cost \$7,624.

According to his memo to City Manager Lynn Markland, Cairnduff said the new air gear dryer will be used by firefighters to dry their Personal Protective Equipment (PPE) after it has been washed.

"In the past we were fortunate to have two sets of PPE for most of our firefighters but due to the increased costs we are unable to do that anymore," he said. "A typical set of structural firefighting coat and pants cost approximately \$1,900. With only one set per firefighter it is very important that the gear is washed and dried, and put back into service as quickly as possible."

Cairnduff said he budgeted \$8,500 for this equipment. He also provided with the council with data that claims the rate of cancer in firefighters is six times that of a normal citizen. This is due largely to their encountering entirely different chemicals in fires than they did 20 years ago.

"These carcinogens are on their PPE and then are transferred to their skin," Cairnduff said. "The National Fire Protection Association has now made recommendation that our firefighters wash their gear every time it is used at a fire or after training."

Overhaul at water plant

Dan Czarnecki, public works director, asked for \$27,500 to pay for the overhaul of High Service Pump #1 and the installation of a Variable Frequency Drive at the Fenton water treatment facility.

"In the past, Steve Guy has been working to keep the water supply coming into the treatment facility at the necessary flow rates," Czarnecki said in his memo to Markland. "With the wells/pumps updated, he is now concentrating on the high service pumps found inside the treatment facility."

that need to be addressed, Czarnecki said.

The council agreed and Peerless Midwest will be hired to do the rehabilitation work.

Meter reading device replacement

Czarnecki said in October 2015, the water department purchased two new handheld meter reading devices. They replaced three of the four older meter reading devices that were failing.

"Three units are optimal for reading all the meters efficiently each quarter," Czarnecki said. "Unfortunately, the remaining older device is now failing and needs to be replaced."

The cost for all the items necessary to replace the failing unit complete is \$9,000 from ETNA Supply. The cost for this device would be split between the water and sewer departments.

Library desk

Fenton's Jack R. Winegarden Library went through extensive renovations in 2015 to the tune of \$315,000. One thing that was not replaced was the children's circulation desk in the lower level.

In recently examining the desk with library employees, it has been declared past its service life as a built-in piece of furniture, according to Assistant City Manager Michael Hart.

Hart said a proposal to build and install a new children's circulation desk has come in at \$7,091, which includes delivery. The city actually budgeted \$5,091. A \$2,000 contribution was received from the Friends of the Library.

The city council approved paying \$7,091 to Library Design Associates, Inc. for the new circulation, which includes delivery and installation.

Convenience store in Fenton robbed

■ One suspect in custody, police searching for two accomplices

Fenton police arrested a Flint man, in his mid 20s, for his suspected involvement with a robbery of a convenience store in Fenton early Monday morning. Police continue to attempt to locate two more accomplices.

Officer Bill Andringa said Fenton police responded to a report of a breaking and entering of a store in the 2400 block of North Road at 12:19 a.m. on Monday, Nov. 13.

In addition to the store's security alarm being activated, a witness called police to say that they heard a loud noise and then saw two individuals

exiting the store and fleeing on foot.

Fenton police called for assistance from Mt. Morris Township K-9 unit as well as the Genesee County Sheriff's K-9 unit to search for the suspects.

When police arrived, they saw that the front door of the business was smashed open. Checking the inside, they learned that an undisclosed amount of liquor and cigarettes had been stolen.

As police investigated, one suspect was located walking on Torrey Road, near South Long Lake Road. Police recovered liquor and cigarettes from that area. The male was arrested and transported to the Fenton Police Department for processing. He was later transferred to the Genesee County Jail, pending his arraignment.

The break-in and robbery remains under investigation.

Linden City Council supports Safe Routes to School program

On Monday, Nov. 13, Linden City Council passed a resolution in support of the Safe Routes to School program, started in Argentine Township, which aims to build sidewalks around Linden schools to give students a safe place to walk on their way to school. Argentine Township Trustee Tom Hallman told the council the plan is to construct a sidewalk from the edge of the Linden city limits, connect it with the Linden, Argentine, Fenton and Lake Fenton (LAFF) pathway, through Fenton Township down Silver Lake Road to the high school complex, and then south on Lobdell Road. He said he expects the project will cost \$1 million. He said it will be built to federal standards. The vote was unanimous.

Orchard Hills environmental study approved

■ Could cost city up to \$12,000 to find level of arsenic in ground

The city of Fenton received a number of properties in the Orchard Hills Development through tax foreclosure during the most recent economic downturn. The subdivision is located off State Road, immediately south of State Road Elementary School, on the right.

Some of the properties are vacant residential land parcels for future development, according to City Manager Lynn Markland.

"The third recent batch the city is considering putting up for sale comprises approximately 30 acres totaling 86 vacant land parcels," he said.

Part of the phase II master parcel contains approximately seven acres of arsenic contamination from its prior use as a fruit orchard.

In order to market the site, the city as seller needs to perform additional investigation of the arsenic contamination. This will involve an environmental study where soil borings are completed and the findings provided in a scientific report confirming a specific outline of the arsenic contamination and degree, or amount that pervades the soil.

Markland asked that the study be completed by the city's environmental science company, McDowell & Associates at an estimated cost of \$9,000 to \$10,000. At Markland's request, the council approved an expenditure not to exceed \$12,000 for the study.

A second vehicle, a Chevy Trailblazer driven by a 45-year-old Highland woman, also left the roadway and came to rest off to the side of the highway.

According to a news release by the Livingston County Sheriff's Office, the vehicles collided, sideswiping each other, which caused them to veer from the roadway.

According to Fenton Fire Chief Bob Cairnduff, the truck driver, Martus suf-

fered critical injuries and was transported to Genesys Health Park in Grand Blanc Township where he later died.

The driver of the Trailblazer was not injured, and refused treatment.

One lane of the highway was closed for approximately four hours during the incident, and Runyan Lake Road was closed for six hours until the vehicles were removed.

The crash remains under investigation by the Livingston County Sheriff's Office.

that will prohibit front-yard parking nearly eight months after Councilor David Franz brought the issue back to the council.

The vote was unanimous, and the law goes into effect 30 days after publication.

Franz said the ordinance will help prevent people tracking mud from their lawn into the road, and it will help property values stay where they belong.

"That's all it is," he said.

The Linden Planning Commission drafted the ordinance.

According to the ordinance, parking on a front yard would only be allowed on a constructed driveway, which is defined as an area surfaced with concrete, asphalt, brick, cut stone, or a minimum 4-inch depth of crushed material that's at least ½ inch in diameter. Driveways must be properly graded for drainage and stay in good condition free of dust,

trash and debris. Newly constructed driveways cannot be less than 10 feet wide, and cannot be wider than 32 feet or the width of the garage, whichever is greater.

For a single- and two-family dwelling, the total driveway surface area cannot exceed 40 percent of the front yard, and off-street parking within the right-of-way adjacent to a lot would be prohibited, except within the street or driveway approach. If no properly constructed driveway exists on a lot, off-street parking is allowed with an area no wider than 12 feet, or the width of an existing garage, whichever is greater.

Exceptions in the proposed ordinance allow for front-yard parking during special events like graduations and holiday parties.

Violation of this ordinance is a misdemeanor, punishable by a \$500 fine, 90 days in jail, or both.

file, Facebook was able to determine all four accounts were being accessed from the same computer.

According to court records, federal prosecutors allege that Moore used his Matthew Johnson, Ray Matthews (#1) and Ray Matthews (#2) accounts to solicit juvenile females for nude images, even going so far as to request specific images. These three accounts depicted a younger aged male, and information contained in the accounts would lead someone to believe the user was of high school age.

Moore's main Facebook account listed above appeared to be his actual account.

According to the complaint, one Facebook interaction detailed photos and a conversation between Moore and a young female.

Because of investigation, a search warrant was executed on Nov. 6 at the residence where Moore was living in Fenton. Court records show that Moore admitted to creating and using the fake Facebook accounts for the purposes of meeting minor females and acquiring nude images from them. He admitted to knowing the females were under the age of 18 and he knowingly misrepresented his name and age to the minor females in order to get them to interact with him and to provide him with photographs.

Federal public defender Joan Morgan was assigned to Moore's case and after interviews with family members, it was decided on Nov. 7 that Moore would remain in custody rather than be released on bond.

A preliminary probable cause hearing has been scheduled at the U.S. District Court – Eastern District of Michigan for 1:30 p.m. on Nov. 20.

Eagles fall short in regional title game

■ Linden has its chances vs. Harrison, but loses 34-21

Linden — Less than a minute into the second half, the Linden varsity football team came up with its biggest play of the game against state-powers Farmington Hills Harrison.

Trailing 14-7 at the break, the Eagles tied the game up at 14-all on a 48-yard touchdown pass from George Walterhouse to Corbin Sines, sending a message to the Hawks that the Eagles were eager to earn their first-ever regional championship in school history.

However, Harrison made just enough plays on offense the rest of the way and Linden's offense had three possessions end on Harrison's side of the field, clinching the Hawks a hard-earned 34-21 Division 3 regional championship victory at Linden's Claude Cranston Field Friday night.

The loss ended the Eagles' season with their second-ever district championship and at 9-3 overall. They also gave Harrison a fight that they won't soon forget.

"They are a powerhouse football team, but I think we gave them a run for their money," Sines said. "I don't think they thought we were going to make a game out of it. We gave it all we had."

"I'm real proud of them. It was great," Linden's varsity co-head coach Denny Hopkins said. "The kids did OK. They did well. A 9-3 record is pretty doggone good. There are many schools in the state that wish they were playing in a regional final and winning nine games."

The season also marked the first time ever Linden hosted three playoff games in the same season.

Sines' TD early in the third created the game's final tie score after Koleton Strauss kicked the second of his three extra-points with 11:05 left in the third quarter.

"They decided to call my number and things went through and I got that touch-

down," Sines said.


However, Harrison responded with a TD drive of its own. The pivotal play was a third-and-12 play from the Linden 46. A completed pass of 26 yards from Noah Hendricks to Moet Andrews gave Harrison a key first down. Two plays later, Rapana Filemu scored on a two-yard run. Harrison led 21-14 with 8:25 left and never trailed again.

The Eagles tried to put another scoring drive together, and appeared on the way of doing just that after a 31-yard slant completion to Sines, putting Linden on the Hawks' 24. However, four plays later a Hendricks interception ended that drive.

The Linden varsity football team has made a habit of making the playoffs.

This year's District 3 run was Linden's 16th straight playoff run. Or in other terms, the run has lasted longer than the age of some of the athletes that were on the Eagles' sidelines during the team's regional championship game against the Farmington Hills Harrison Hawks.

City of Linden
ORDINANCE NO. 381

AN ORDINANCE TO AMEND SECTION 2.2, SECTION 4.5.1 AND SECTION 10.2.6,(1) OF THE CITY OF LINDEN ZONING ORDINANCE (ORDINANCE NO. 285) TO ADDRESS DRIVEWAYS AND FRONT YARD PARKING; EFFECTIVE DATE; PUBLICATION

THE CITY OF LINDEN ORDAINS:

Section 1. Amendment of Section 2.2 of Article 2 of the City of Linden Zoning Ordinance No. 285 by the Addition of a Definition for “Driveway.”

Section 2.2 of Article 2 of the City of Linden Zoning Ordinance No. 285 is hereby amended by adding thereto the following definition:

Driveway. A way located upon a parcel, lot or limited common area, specifically constructed and maintained to provide ingress and egress from the road or street onto the site and circulation about the site. In order to be considered a driveway under this Ordinance, such an area must be surfaced with concrete, asphalt, brick, cut stone, or a minimum four (4) inch depth of crushed materials (stone, concrete, asphalt, etc.) having a size of at least one-half (1/2) inch in diameter. Further, such driveway must be properly graded for drainage and be maintained in good condition free of dust, trash and debris. Within a front yard, newly constructed driveways shall be no less than ten (10) feet in width, and shall be no wider than thirty-two (32) feet or the width of the garage, whichever is greater.

Section 2. Amendment of Section 4.5.1 of Article 4 of the City of Linden Zoning Ordinance No. 285 by the Addition of a Footnote to the Schedule of Area, Height, Width and Setback Regulations, to be Applicable to the R-1, R-2 and R-3 Districts.

Section 4.5.1 of Article 4 of the City of Linden Zoning Ordinance No. 285 is hereby amended by adding a new Footnote K thereto, to be applicable to the R-1, R-2 and R-3 Districts:

K. Within the front yard, the total driveway surface area for single- and two-family dwellings shall not exceed forty percent (40%) of the total front yard area.

Section 3. Amendment of Section 10.2.6,(1) of Article 10 of the City of Linden Zoning Ordinance No. 285 Regarding the Location of Parking for Single and Two Family Dwellings.

Section 10.2.6,(1) of Article 10 of the City of Linden Zoning Ordinance No. 285 is hereby amended to read as follows:

- 1. Single and Two Family Dwellings.
 - a. The off-street parking facilities required for single- and two-family dwellings shall be located on the same lot or plot of ground as the building they are intended to serve, but shall not be considered a parking lot under the provisions of this Article.
 - b. Off-street parking shall not be permitted within the right-of-way adjacent to the lot except within the street or driveway approach.
 - c. Off-street parking shall not be permitted within the front yard, except within a properly constructed driveway, as defined in this Ordinance.
 - d. Where no properly constructed driveway exists, an exception to Subsection c, above, shall be made for an existing driveway within the front yard that is not properly constructed. In such case, off-street parking shall be allowed within an area no wider than twelve (12) feet, or the width of an existing garage, whichever is greater, centered on such existing driveway, but not within any area between the dwelling and street.
 - e. The requirement of Subsection c, above, shall not apply to parking for temporary special events normally associated with the residential use of the property such as graduation and holiday parties.

Section 4. Effective Date. This Ordinance shall become effective thirty (30) days following publication.
