Owosso trio facing life in prison for stabbing death

The individuals charged with murdering 20-year-old Austin Culkins of California began their preliminary hearings in court on Monday, June 4.

Culkins was found stabbed to death in a Mundy Township field, near Baldwin and Jennings roads, on Saturday, April 21.

Residents in the 9300 block of S. Jennings Road called 911 just before 11 a.m. that morning. They said they saw a truck, which turned out to be an older model GMC pickup with California license plates, by some trees in the middle of their farm field at the northwest corner of S. Jennings and Baldwin roads and found the dead man, now identified as Culkins, lying next to it.





■Big island hit by 9,900 earthquakes in last 30 days

Paul Taylor, 29, watched the lava flowing from the big island of Hawaii's Kilauea Volcano, a once-in-a-lifetime sight for his first trip to the Hawaiian Islands.

Of course, the beauty of the lava as it lit up the nighttime sky at Hawaii Volcanoes National Park on the big island of Hawaii turned into the horror of destruction when

eruptions began to destroy everything in its path more than a month ago.

The big island of Hawaii is home to five volcanoes, three of which are currently active, according to Fodors.com. Kilauea has been erupting nearly continuously since 1983, but not always at the level seen in recent weeks.

These active sites have

been far away from Taylor on his twomonth traveling and hiking adventure in Hawaii, which began April 7. Most of his travels have been about 200 miles away from the Kilauea eruptions and safe from harm's way.

"We got our news about what was going on from CNN, like everyone else," Taylor said.

He was in Hawaii to visit his cousin, Bill Thomas, who lives and works in Honolulu, on Hawaii's third largest island of Oahu. Taylor hiked at the volcano site for about four to five days (before the eruptions started), staying at a hostel at Hawaii Volcanoes National Park. "Most of the time it was raining, which blocked our view because of the steam," he said.

Most of the park is currently closed because of the increased earthquakes, corrosive ash fall and an expected explosion at the summit of Kilauea Volcano, according to a report from Hawaii's National Park Service on June 5.

Earthquakes are now one of the biggest issues because of the volcanic eruptions. A 5.6 magnitude earthquake struck the big island of Hawaii on Tuesday morning, June 5. According to the U.S. Geological Survey, the big island has been hit by 9,900 earthquakes since May 4.

Taylor returned home earlier this week to spend time with his parents, Dan and Cynthia Taylor of Fenton, after the final leg of his trip took him to Japan.

Despite the devastation of homes and property, it is mostly "business as usual" when it comes to travel to Hawaii.

"I've been watching all the reports," said Diane

Roberts, manager of the Fenton office of Superior Travel. "There have been postings from the Hawaii Bureau of Tourism."

The biggest change in itineraries has been cruise lines altering their normal ports of call at Hilo (pronounced Hee-low) on the big island of Hawaii. Passengers on Norwegian, Royal Caribbean and Princess cruise lines will be spending extra time on the islands of Oahu and Maui.

Fenton residents Bob and Debbie Schlenke and Scott and Tricia Overfield have been planning their dream trip to Hawaii for more than a year. They'll be traveling in July, with most of their itinerary taking them to the islands of Kauai and Maui.

NATIONAL HISTORY

JUNE 10

2002: Clint Messina, 21, of Lacombe, Louisiana, is arrested and charged in the attempted murder of a police officer after driving into a patrol car while attempting to flee from sheriff's deputies. Soon after, police discovered that he was already a wanted man. At about 3:30 a.m. on March 27, Messina and an associate, stole a Krispy Kreme doughnuts delivery truck in Slidell, Louisiana. The deliveryman called police, who pursued and caught up to the vehicle. Messina then led police on a 15-mile chase, leaving a trail of doughnuts behind them as they fled.

JUNE 11

1982: Then 34-year-old director Steven Spielberg reportedly drew on his own experiences as an unusually imaginative, often-lonely child of divorce for his science fiction classic "E.T.: The Extra-Terrestrial," which was released on this day in 1982.

JUNE 12

WEEKEND TIMES

1994: Nicole Brown Simpson, famous football player O.J. Simpson's ex-wife, and her friend Ron Goldman are brutally stabbed to death outside Nicole's home in Brentwood, California, in what quickly becomes one of the most highly publicized trials of the century. With overwhelming evidence against him, including a prior record of domestic violence toward Brown, O.J. Simpson became the chief suspect.

JUNE 13

1805: Having hurried ahead of the main body of the expedition, Meriwether Lewis and four men arrive at the Great Falls of the Missouri River, confirming that the explorers are headed in the right direction. Lewis and William Clark had set out on their expedition to the Pacific the previous year. They spent the winter of 1804 with the Mandan Indians in present day North Dakota.

JUNE 14

2003: Britain's Queen Elizabeth II publishes the list of those she has chosen to appoint as Officers of the Order of the British Empire as part of the traditional Queen's Birthday Honours. Included on the list were (among others) the soccer star David Beckham, the musician Sting, the actor Roger Moore of James Bond fame and the actress

Helen Mirren. An acclaimed veteran of the London stage, Mirren had earned numerous awards for her starring role in the British television series "Prime Suspect" and would go on to win an Academy Award for Best Actress several years later for her portrayal of none other than Elizabeth II, in the 2006 film, "The Queen.

JUNE 15

1945: The 23-year-old actress and singer Judy Garland marries the director Vincente Minnelli, her second husband. The couple had one daughter, the actress and singer Liza Minnelli. Garland became a star in 1939 with "The Wizard of Oz," in which she played Dorothy, a role originally intended for Shirley Temple. In the film, she performed the plaintive ballad "Somewhere Over the Rainbow," which would become one of her signature songs.

JUNE 16

1884: The first roller coaster in America opens at Coney Island, in Brooklyn, New York. Known as a switchback railway, it was the brainchild of LaMarcus Thompson. It traveled approximately six miles per hour and cost a nickel to ride. The new entertainment was an instant success and by the turn of the century there were hundreds of roller coasters around the country.



Cherie Smith of Fenton said, "I'm not an Amazon shopper. Even though it's the 'regular' way people choose to shop now, I can't do it.

'Studies show that local businesses reinvest in local communities at a higher rate than national corporations.

"Small businesses create local jobs, enhance diversity of products and services, and they seem to have more interesting merchandise," Smith said.

"Communities serviced by small businesses tend to have high home values. If your neighborhood is full of vibrant local businesses, then the value of your neighborhood will increase as it becomes more desirable," she added. "As real estate prices grow, communities can attract new investments to spur continued economic growth. An influx of new residents increases local tax revenue, which can be used to invest in infrastructure, schools, public safety departments, libraries and parks that strengthen communities and drive future growth."



■New WhoaZone floating water park at Holly Recreation Area attracts people of all ages

Kids and families are splashing, jumping, sliding and bouncing from one water obstacle to another at the new WhoaZone floating waterpark on Heron Lake in Groveland Township.

Heron Beach, located at Holly Recreation Area, is now home to an inflatable water playground that opened to the public May 25.

"It's great for all ages," said Maddy Meece, assistant manager of this WhoaZone location, now the second of its kind in the Midwest. "It's getting whole families together outdoors doing something fun."

WhoaZone at Whihala Beach on Lake Michigan in Whiting, Indiana was the first, opening in 2017 and three more are planned in Texas and California this year.

The floating network of slides, trampolines, climbing towers, monkey bars and "wiggle bridges" is designed for water more than 8 feet deep. There are four areas with varying degrees of difficulty meant for people of all ages — but you have to be at least 7 years old and 45 inches tall for entrance into the floating water park. You also must be able to swim, and life vests are provided and required.

Sessions are one hour long, including a 15-minute safety and park usage

message presented to each WhoaZone visitor. Each session is \$15, with a discount available for a double session, early bird and happy hour time slots. Visitors must also have a recreation passport from their vehicle reg-

istration in order to enter Holly Recreation Area.

Visitors who don't have a recreation passport can stop at the booth and purchase one for \$16. The passport will be valid until the vehicle registration expires (on owner's birthdate), at which time another one can be purchased with renewed registration for \$11.

Holly Recreation Area has signed a three-year contract with WhoaZone, so this floating water park will be an

enhancement to Heron Lake through Labor Day of 2020. "We've had nothing but positive feedback from the people who have used it and especially the park rangers," Meece said.

While these inflatable parks aren't a direct competitor to water parks, they are one way that operators of pools, lakes and beaches are drawing people in to use their natural water resources. "It's definitely a physical activity," Meece said. "We've had people in their 60s and 70s, as well

as younger people."

WhoaZone is open Monday through Thursday, from 9:30 a.m. to 7 p.m. and Friday through Sunday, from 9:30 a.m. to 8 p.m., weather permitting.

About WhoaZone ...

• What is it? It's a

floating water obstacle course with four different levels to challenge visitors of all abilities.

- Where is it? On Heron Lake at Holly Recreation Area, 8100 Grange Hall Rd., Groveland Township, near Holly.

Argentine Township Fire Chief Matt Lafferty said it's getting harder for people to commit to being a firefighter. The department lost three or four firefighters this past year because of scheduling issues.

"The requirements have increased. There's a lot more commitment," he said.

Fenton Fire Chief Bob Cairnduff said all volunteer/on-call fire departments in the nation struggle with the hiring and retention of firefighters. The city currently employs 29 paid on-call volunteer

firefighters. Cairnduff would rather have 34 and is in the process of hiring three more.

Fenton City didn't have the retention problem until 10 years ago, and it's gotten worse.

"The required hours for training has increased and the 'free time' that people have has decreased," he said. They currently have seven members with over

30 years of experience with the depart-

"The way our society is now, I am unsure if we will ever see people make a commitment to our department for that long again," he said. "I would estimate that for every three new people we hire, we only keep one beyond two years. The other two leave within the first two years."

Cairnduff said they don't see as many people who grew up in Fenton applying to be a firefighter in Fenton. Many of their applicants moved here recently and then they move again. They hold events to interact with the local youth in hopes of inspiring them to join the department when they're older.

Fenton Township Fire Chief Ryan Volz said firefighters will spend eight hours at their 9 to 5 job, and possibly respond to a structure fire in the evening and they're on scene until 2 a.m.

"It's hard for them to get up and go back to work the next day. They have to put food on the table at home," he said. "They have to be on top of protecting our township.'

Volz said there is a lot of training that

comes with keeping up on continued education. Firefighters have to stay knowledgeable on what materials cars and buildings are made from so they know how to extinguish a fire. Homes burn faster than they did years ago and firefighters have to train to deal with different models of cars, such as battery powered cars.

For firefighters trained in EMS, there's even more work with keeping up on first responder certification. On Monday, June 4, Fenton Township firefighters certified in EMS trained with Narcan (emergency treatment for opioid overdose) and epinephrine (emergency treatment for life-threatening allergic reactions), which is required every

"The township has a lot more (training) than others because we do specialized stuff," he said.

Firefighters have to do hazmat (hazardous materials) recertification, and those



who become divers train twice a month in the water. They also have to pass physicals and agility tests, on top of medical training and continued fire training. "It adds up," he said.

The Fenton Township Fire Department employs 25 paid on-call firefighters to cover approximately 17,000 residents. They're paid for training and when they go on call. If there's a lot of work, Volz said he can give them "a good chunk of change" at the end of the month.

"The majority of firefighters are paid on-call because it's what the municipalities can afford. They need to have a job because this doesn't support them enough," Volz said. "This is just something they choose to do because they want to help their community."

National Fire Protection Agency

Across the U.S., volunteer fire departments save municipalities, and taxpayers, \$139.8 billion per year in firefighting costs, according to a 2014 report. Approximately 70 percent of America's firefighters are volunteers, and 85 percent of the nation's fire departments are all or mostly volunteer.

HOW MUCH ARE ON-CALL FIREFIGHTERS PAID?

The amount firefighters are paid varies on the department

- Firefighters at **Argentine Township** earn \$10 when they start, and pay goes up to \$16 an hour. The department currently has 24 paid oncall firefighters.
- Fenton City Fire Chief Bob Cairnduff said the department's firefighters are paid \$25 for the first hour and \$17 an hour for overtime. Those rates come into play after they are off probation and finish all required training.
- At Fenton Township, Fire Chief Ryan Volz said the pay is determined by training. Starting pay is \$11 an hour. At level one, it's an added \$1. At level two, it's another \$1. If they're trained in hazmat operations or medical first responder training, that's another \$1 each. If the firefighter is also an EMT, it's another \$2. Firefighter officers one and two receive another \$2. Volz said the top pay is \$19 per call.



'It's a beautiful day in the neighborhood'

■ Movie about children's TV icon, Mr. Rogers, opened Friday

He's been everyone's friend and neighbor since "Mister Rogers' Neighborhood" was launched in 1966. Throughout the decades, children have perched before the TV, watching this quiet man teach them about life, kindness, love and friendship for 30 minutes each day — in his own gentle way.

We are, of course, talking about Fred Rogers, who is featured in a new film called "You are my friend." The movie, which opened in theaters Friday, June, 8, starring Tom Hanks, is not a biographical picture, however.

The movie, which stars Hanks as the beloved children's show host and pop cultural icon, is largely focused on a reporter and Rogers' relationship to his life, and how the reporter's whole world changes when coming in contact with Rogers.

The story follows the life of Tom Junod, who forged an emotional bond with the "Mister Rogers' Neighborhood" star while profiling him for "Esquire" magazine in 1998.

It's a story about kindness and family connection and trying to tap into one's better self. In the research for the movie, the writers found that more people than they could possibly count credited Rogers with changing their lives.

It's about one man, who's at a critical point in his life becoming a new father, having issues with his own father, and meeting Rogers to write a piece about him, thinking it's going to be a bit of a puff piece, but it ends up changing his entire life.

About Fred Rogers

Born on March 20, 1928, in Latrobe, Pennsylvania, Fred Rogers was a puppeteer and ordained Presbyterian minister who became the host of the TV program "Mister Rogers' Neighborhood." With a degree in music composition, he wrote 200 songs for the show, including the theme, "It's a Beautiful Day in the Neighborhood."

Rogers loved Latrobe, a small town tucked between the western-most ridge of the Allegheny Mountains and the Pittsburgh region. It is a community heavily influenced by the Rogers family, which exemplified the strong, hard-working, and faith-driven culture of Western Pennsylvania. He always loved Latrobe, which became the basis for the television neighborhood he later created.

His father, James Hillis Rogers, was a very successful businessman who was

relied upon by many of the local residents. His beloved mother, Nancy McFeely Rogers, was the daughter of a similarly successful businessman. The whole family was steeped in a strong sense of service and strong ties to community, friends, and relatives.

For a time, Rogers' childhood was difficult. He was overweight, somewhat shy, and introverted. Although respiratory ailments were not uncommon among children in the heavy-industry environment of Western Pennsylvania, Fred was sometimes homebound because of his childhood asthma, even kept inside in air-conditioning during the worst air congestion of the summer months. He felt his physical and emotional childhood isolation acutely in ways that built

the depth of sensitivity and empathy that characterized his life and work as an adult.

Grown-ups who noticed his sensitivity as a child advised him: "Just don't let on you care, then nobody will bother you." But he did

care and ended up taking great solace, and guidance, from his maternal grandfather.

That first Mr. McFeely, the namesake for the character later made famous on "Mister Rogers' Neighborhood," patiently taught Rogers to have a sense of self-esteem. He would say, "Freddie, you make my day very special."

Rogers' own sense of loneliness and self-doubt taught him to be aware of the insecurities and needs of small children. By the time he got to high school, he had become more confident and capable. He had developed into an accomplished student and musician, and his popularity

"Mister Rogers' Neighborhood" ran on PBS from 1968 to 2001, with reruns that aired until August 2008.

In the very first show that aired on PBS, Rogers began the program much as he would over the next 33 years by walking through the front door of his television house and trading in his raincoat and suit jacket for a zippered

sweater. The sweaters soon became as much a part of the program as his puppets. In all, Rogers had about two dozen of them, all made by his mother. In 1984, the Smithsonian Institution chose to put one of the famous sweaters on exhibit.

Rogers and his wife, Joanne, raised two sons. He died of stomach cancer on Feb. 27, 2003.



Guests who consumed food or drinks at the facility on May 26 through May 31 may have been exposed to Hepatitis A, according to the Genesee County Health Department (GCHD). This does not include the retail portion of the winery/brewery business (bottled product).

The Genesee County Health Department recommends anyone who visited the Fenton Winery & Brewery during these dates and has not been vaccinated for hepatitis A or who has a sudden onset of any symptoms should contact their health care provider. It is important to get the vaccination as soon as possible.

Fenton Winery & Brewery released a statement Wednesday on its Facebook page, "As a precautionary measure, the Genesee County Health Department informed us that, prior to working here, one of our former trainees may have been exposed to Hepatitis A. The window of possible contact was only between May 26-May 31. This employee was never involved in any kitchen or production duties. The case did not originate here and as of June 1, there is zero risk at Fenton Winery & Brewery."

Matt Sherrow, owner of Fenton Winery & Brewery, said Thursday, "To be clear, the Hepatitis A case was not contracted here. A person who already had it started working here and it wasn't until we received a call from the Oakland County Health Department that the true nature of their status was confirmed."


Sherrow and his wife, Ginny, who founded their Fenton business in 2007 both say, "The protection of our employees and the public is our number one priority. No matter how small the risk might have been, an onsite immunization was scheduled immediately upon learning from the Oakland County Health Department that there was a potential risk."

Sherrow added that the reality is exposure can happen anywhere at any time and they wanted to do their part to help eliminate risk in Southeast Michigan.

The Sherrows and their staff shared a post on the FWB's Facebook of a complete staff immunization. Following that, Sherrow said, "We were elated to receive a call from another local, well-known restaurant wanting information about holding their own in-house vaccine day. This was very exciting for us. If we stand together, we can reduce the risk in our community."

Hepatitis A is an infection of the liver caused by a virus. The virus is shed in feces and is most commonly spread from person to person by unclean hands. Symptoms of infection may include sud-

den abdominal pain, diarrhea, nausea, headache, dark urine, and/or vomiting often followed by yellowing of the skin and eyes (jaundice). Symptoms may appear from 14-50 days after exposure, with

an average of about one month.

Michigan is currently experiencing a serious outbreak of hepatitis A. Genesee County is considered to be an outbreak county.

TO REDUCE THE RISK OF HEPATITIS A:

15A

- · Get the Hepatitis A vaccine.
- Wash hands frequently, especially after using the bathroom, changing diapers, and before preparing and eating food. Rub hands vigorously with soap and warm running water for at least 20 seconds.
- Clean and disinfect all surfaces areas, especially while someone in the household or workplace has symptoms. Particular care needs to be taken with areas such as toilets, sinks, trash containers, door knobs, and faucet handles.
- At home, do not prepare food if you have symptoms, and refrain from food preparation for at least three days after symptoms have ended.

enjoy the solitude and primitive experience of camping away from developed campgrounds and other campers.

There are extra responsibilities and skills necessary for dispersed camping. It is the camper's responsibility to

know these before trying this new experience. You need to be self-contained and strictly adhere to the "leave no trace behind" rule.

Be "bear aware." There are bears in the national forests so camp accordingly. They are always on the hunt for food.

To experience dispersed camping, you need to have the right

motivations. Saving a few bucks is great. But don't disperse camp just to save \$10. Do it because you crave solitude and adventure, because you're doing an overnight trip that requires it, or because there's a picturesque lake where you want to wake up on a beautiful summer morning.

Be prepared for the fact that there won't be a toilet nearby. If you're base-camping for a few days, or with a large group, this can become gross at best and downright dangerous at worst. Be sure to dig a cat hole 8 inches deep, pack out your toilet paper, and don't defecate anywhere near water.

Dispersed camping can be tough on the land. This is especially acute at lakes and along rivers where everyone and their Instagram feed want to spend the night. No one wants to roll up to a beautiful riverside campsite and find litter, three different fire rings, half burnt logs, and a house-sized swath of dusty ground bereft of any vegetation.

Work extra hard to reduce your footprint.

Use existing fire rings and break up the extra ones you find.

Set your tents up closely and avoid the temptation to follow or create a web of social trails.

Only put logs that will burn completely on the fire and make sure the fire is dead out (douse, stir and feel) before you leave the campsite.

Don't become a landscape architect because there's no perfectly flat spot. Making due with the land as it exists is pretty much the whole point of dispersed camping.

Lastly, respect closures. The Forest Service will often close off an area that has been overused so it can recover. Let it.



Finally, be aware that dispersed camping turns the danger quotient up a few notches. Look up to see if there are dead limbs or even trees that could crash down in the wind. Look around to see where rainwater might flow if a storm blows through. Be sure you're out of the flood plain in case a dam release or rainstorm

raises the water level. Don't camp in the middle of a game trail or, for that matter, a trail at all (illegal and annoying).

In addition to bear, be snake aware, deer aware, rodent aware, raccoon aware, bird aware and more.

Despite this list of finger-wagging admonishments, dispersed camping is truly special. It's also

pretty much essential if you're going to be doing overnight trips in national forests, whether on trails or rivers. Getting comfortable with dispersed camping will help you reap the rewards that come with breaking free of the traditional campground.

Frederick Daniel Clark, 28, Christian Lee Lover, 23 and Mataya Delores Shaw, 23, were apprehended less than a week later and were charged with first-degree premeditated murder and conspiracy to commit murder.

The three suspects, all from Owosso, face life in prison without possibility of parole if convicted of the charges.

Six witnesses took the stand Monday, including Anne Davies, a Metro Police Authority of Genesee County officer. Davies was the first to respond to the 911 call on a body being found in a Mundy Township field.

She said the body appeared to have blood all over his face and it looked like lividity (bluish appearance, indicating death) may have set in.

After allegedly stabbing Culkins to death, it is believed the trio went to a nearby gas station. After they left, the gas

station clerk noticed the wrapper from a stolen store item in the restroom and called 911.

Officer Gunner Wright of the Grand Blanc Township police stopped the three on foot. He said he found a pair of blue latex gloves with a red substance on them. Clark admitted to Wright that it was blood. He said he was drunk at a bonfire the night before and had hit his head on a tree.

The preliminary exams are scheduled to continue at 1:30 p.m. on Tuesday, June 19.

Shaw, Lover and Clark also face one count of retail fraud in Grand Blanc Township. They were in court Tuesday, May 1 for a pretrial for the fraud that allegedly took place April 21, the same day as the murder.

This is not Lover's first brush with the law. According to the Michigan Department of Corrections, Lover was sentenced to 20 months in prison in December 2012 for breaking and entering and unlawful use of a vehicle in Shiawassee County. He was paroled in December 2013.

■Lobdell lakefront restaurant has had nine name changes

Argentine Twp. — If you Google 8291 Silver Lake Road, you'll get search results for Ekklesia on the Water, Navistarz Bar and Grill, Plank's on the Lake, Lakeview Bar and Grill, and more recently, The Deck.

The same building, and only restaurant on Lobdell Lake in Argentine Township, is an icon where customers can come from boat or car. Philip Martinez, who took possession of the restaurant on Oct. 16, 2017, renamed it The Deck.

Martinez has been in the food business for 10 years, and used to own a sports bar in downtown Northville. Two years ago, he sold it and moved to Lobdell Lake with his wife. At that time, the Lobdell Lake restaurant was in bankruptcy. He tried to buy it, but he wasn't able to.

For a building with a reputation to change hands and names, Martinez said, "It's been really good" since opening this past fall.

"The neighbors, the people who live on the lake, the surrounding people have been very very positive," he said. "It's a little bit ironic that instead of me thanking everyone for coming in and supporting us, they are going out of their way to thank me for opening it because they want it so bad."

History of The Deck

According to municipal records, the building was built in 1947. The earliest information available shows that Annetta Hatfield owned the building until 1998. The building was named Lakeview Tayern at this point. It was sold that year to Mark Bowser, when it was

renamed Bowser's. In 2002, it was renamed Waters Edge Grill and Bar.

Then in 2009, Citizens Bank sold the building to Owen Point Properties Company LLC for \$90,000 in a foreclosure sale. The restaurant went through numerous name changes from 2009 to

2016, including The Pier, Navistarz Bar and Grill, which was the name in 2013 and 2014, and Planks on the Lake in the summer of 2015.

On March 28, 2016, LeRoy Street LLC bought the property for \$390,000 in a duress sale. Then on June 7, 2016, Leonard Brousseau bought the property from Joseph Birchmeier for \$650,000.

Brousseau changed the name to Ekklesia on the Water for the summer of 2016, but then changed the name to Lakeview Bar and Grill months later.

Martinez said the name changes didn't bother him, but they didn't want to be associated with the previous names.

"We did struggle with the name at first. But at the end of the day, when he kept coming here, the first thing that jumped out at us was the large deck that's out there," he said. "We weren't too concerned with previous names."

Martinez said they plan to make the deck bigger toward Silver Lake Road.

"The community has been very very supportive to the point where I'm just kind of ecstatic. It's a little mind boggling," he said.

The 2018 World Cup

What you need to know about the planet's largest sport tournament

Since 1930, there has been an international soccer event called the World Cup. It was created to find what country is the world champion in soccer and is played every four years.

Teams from six different regions in the world compete in qualifying matches for about three years prior to the World Cup for the right to be one of the 32 teams to compete. The host country (Russia is this year's host) automatically qualifies.

Squads are placed in one of eight pools (four-team leagues) with each team playing each squad in the pool. The top two teams in each pool qualify for the round of 16, and from there single-elimination play continues until a champ is crowned on July 15 in front of what will be the world's most watched sporting event in 2018.
