## Local HAUNTS

### Fenton Hotel, Holly Hotel and historic homes feature more than the eye can see

Thrill-seeking people are fascinated with the paranormal. Are there actual haunted houses? Do they really exist or are they the figments of vivid imaginations?

Residents who occupy tri-county area haunted buildings and dwellings are adamant that spirits or ghosts exist.

#### The Fenton Hotel

(now Fenton Hotel Tavern & Grille)

The historic **Fenton Hotel**, now the Fenton Hotel Tavern & Grille, has long been said to be haunted. Stories of strange noises, doors slamming shut by themselves, water turning on by itself and eerie voices are among the hauntings.

There are tales about Emery, the former

hotel bartender, whose favorite drink was Jack Daniels (whiskey). This drink just happens to show up on a certain table in the bar area. But, when it is served, no one at the table actually ordered it.

Many years ago, a cleaning woman, early one morning after the hotel had closed, was scared out of her wits when someone (no one was there) tapped her on the shoulder while she was vacuuming. Other staff members have been frightened when entering a storage area.

#### The Holly Hotel

Professional “ghost hunters” have documented the historic **Holly Hotel** as a spirited location. Strange occurrences include the sound of a child crying, eerie

noises and lights going on mysteriously. The Holly Hotel has been referred to as the most haunted historic building in Michigan, and perhaps the most haunted in America. By all accounts, the Holly Hotel does seem to be one of the few active haunted hotels where the occurrences continue over and over.

The haunting and strange happenings have been observed by employees and guests. Very few of these can be easily discounted. The ghostly residents seem to follow certain “habits,” and even if one is ignorant to the fact that the restaurant is haunted, their experience will often fit into a known set of occurrences.

For example, many people have smelled cigar smoke, even though they

did not know that the original owner of the inn smoked cigars. The descriptions of flowery perfume is often strikingly similar as well, and, for some reason, the meat cleaver is the favorite toy for a little girl’s spirit who still plays in the kitchen and on the banquet room steps.

#### Private homes

There are reportedly many “haunted” houses in Fenton, particularly in the Dibbleville area and on streets heading south toward High Street.

A family lived in an old 1880s Fenton home on South Holly Road for many years without ghostly occurrences. However, when they moved to a home built in the


### I didn't win, but if I did ...

'30s, it was a different story. Pictures on the walls began to tilt and keys disappeared, only to return a day or two later. One time, the missing keys were found outside in the mailbox. The television and stereo would sometimes go on "full blast" at about 3 a.m., awakening the household.

One day, birdseed was found on the floor in a perfect symmetrical cone shape. While the woman of the house was sorting clothing one day, wild birdseed fell from the clean laundry. The family didn't have a bird.

The piano in the music room would occasionally play unrecognizable tunes for about five minutes and stop. One day the china cabinet opened suddenly and a delicate crystal goblet fell to the floor undamaged. Family members

decided to always say "good morning" to the spirit.

Both apparitions and strange happenings have occurred at a Shiawassee Avenue home. The heavy front door has flown open; things have mysteriously fallen off walls and a rocking chair in a bedroom rocked by itself.

The feeling of force pushing the owner down the staircase was experienced and drapes and sheers in the living room would whip out and strike those walking by, when there was no breeze or no window open.

A minister who lived there more than a century ago was seen in apparition form on the front steps one evening when a teenage neighbor boy was walking his dog across the street. The dog stopped dead in his tracks until the apparition disappeared.

We're Americans, and we love chocolate, lots of chocolate. And with Halloween just around the corner, these are the best candy bars, ranked in order. These are all candy bars that are popular and sold in America. Come on this journey through peanuts, coconut, nougat, caramel and (of course) chocolate, and see how your favorite candy bar stacks up.

10

### HEATH/SKOR

The Heath bar is a candy bar made of toffee, almonds and milk chocolate, marketed by L. S. Heath beginning in 1914, subsequently by Leaf, Inc., and since 1996 by Hershey ... It is similar to Hershey's Skor bar and Mondelez's Daim bar.

### 100 GRAND

100 Grand Bar (formerly known as \$100,000 Bar, spoken as "hundred thousand dollar bar" until the mid 1980s) is a candy bar produced by Nestlé in the United States. The candy bar was created in 1966, and named after a series of successful game shows.

### NESTLÉ CRUNCH

Nestlé Crunch was invented in Fulton, New York, in 1938, and originally sold for five cents as "Nestlé's Crunch" milk chocolate bar with crisped rice. In the 1950s, the bar was sold for 10 cents.

### SNICKERS

In 1930, Mars introduced Snickers, named after the favorite horse of the Mars family. The Snickers chocolate bar consists of nougat, peanuts, and caramel with a chocolate coating.

### BUTTERFINGER

The Curtiss Candy Company was founded near Chicago, Illinois, in 1922 by Otto Schnering, using his mother's maiden name. He invented the Butterfinger candy bar in 1923. The company held a public contest to choose the name of this candy.

### TWIX

The Twix bar was originated in the United Kingdom in 1967. With its delicious butter cookie center, topped with caramel, and coated with milk chocolate, the Twix candy bar quickly became a popular treat around the world.

### SKY BAR

Sky Bars were first introduced in 1937 by Necco, the makers of Necco Wafers. It was the first molded chocolate bar with four distinctly different centers. Each bar consists of four milk chocolate-enrobed sections each with an interior of caramel, vanilla, peanut or fudge.

### 3 MUSKETEERS

The 3 Musketeers candy bar was invented in 1932 in the United States by M&M/MARS. It was the third candy bar produced by the company. It was originally packaged as three, individual mini bars of chocolate, vanilla and strawberry nougat — hence the 3 Musketeers.

### CARAMELLO

In the United States, a similar bar is produced under license by the Hershey Company and sold under the brand Cadbury's Caramello. It uses caramel filling, the chocolate has a sweet taste, and is chewy. The flavor of Cadbury's Caramello is often used in ice creams in the United States.

### MILKY WAY

The Milky Way bar was created in 1923 by Frank C. Mars and originally manufactured in Minneapolis, Minnesota. The name and taste were taken from a famed malted milk drink (milkshake) of the day, which was in turn named after the Earth's galaxy.



# Pets and holiday gifting

Furry, finned and feathered friends help make a house a home. These companions are more than just pets; they're often cherished family members. So it should come as no surprise that, come the holidays, people want to lavish extra attention on their animals by way of presents.

The American Pet Products Association says pet owners spend billions of dollars on their pets each year. The majority of pet owners plan to gift their pets on holidays such as Valentine's Day, Halloween and Christmas. DogTime.com says that pet presents are not a North American phenomenon, either. Pet owners in the United Kingdom are expected to spend the equivalent of \$46 U.S. per pet on gifts.

While dog owners are more likely to buy their pets gifts, cat owners have been

closing that gap over the years. Some pet parents even offer Christmas cards or hang Christmas stockings for their pets.

According to data from PricewaterhouseCoopers, shoppers between the ages of 17 and 21 are willing to spend more than anyone else (\$70) on holiday gifts for their pets.

Gifting pets has become the norm, but various animal welfare organizations advise that

giving companion animals as pets should be avoided. Pets given as gifts may be at a higher risk for surrender to shelters by families who miscalculated the amount of time and money that's necessary to care for pets. Welcoming a pet into the family is often a personal decision, and one that should be weighed carefully by all members of the household.

## Attention Argentine Township Residents:

**This is an amended summary** for the summary published on September 2, 2018 regarding the August 27, 2018 meeting of the Argentine Township Board, wherein the Board did adopt the Argentine Township Non-Motorized Pathway Ordinance #76, an ordinance to regulate the use of non-motorized pathways, public ways and property, within the township and to provide penalties for violations. Copies of the entire ordinance may be viewed at the Township of Argentine Hall, 9048 Silver Lake Road, Linden, Michigan, during regular business hours. The following is a summary of the ordinance. This ordinance shall become effective immediately after publication.

### Section 1 – Definitions

**Section 2 – Non-Motorized Pathway Location, Design, And Construction --** states where pathways shall be located and construction standards.

**Section 3 – Maintenance –** adopts the Genesee County Parks maintenance and inspection policy for non-motorized pathways within the township.

**Section 4 – Prohibition of Motor Vehicle Use –** states no motorized vehicles are to be used on any non-motorized pathways and exemptions.

**Section 5 – Safe Bicycle Operation –** states all persons will travel in a consistent manner at a reasonable speed, shall yield to motor vehicles and pedestrians.

**Section 6 – Prohibition of Horse Riding –** states no horses are allowed on non-motorized pathways.

**Section 7 – Township Policies Regulating Pathway Use –** describes regulations of pathway use and states the board may adopt policies regulating pathways consistent with the terms of this ordinance.

**Section 8 – Damage –** states no person shall destroy or damage in any way a non-motorized pathway, and the repair or cost of repair of such damage shall be the responsibility of the person causing the damage.

**Section 9 – Non-Motorized Pathway Obstruction –** states no person shall obstruct non-motorized pathways, deposit or burn litter, or cause snow or ice to be dumped or deposited on any non-motorized pathway.

**Section 10 – Animals –** indicates pets must be on a leash no longer than six (6') feet, under control of owner at all times and any fecal matter removed immediately.

**Section 11 – Vegetation –** states no person shall plant any trees, shrubs or other vegetation within designated easement for a non-motorized pathway.

**Section 12 – Irrigation –** indicates no person shall leave any irrigation device unattended when the device is in contact with or runs across the surface of a non-motorized pathway.

**Section 13 – Construction Projects –** describes if any construction project on lands adjoining a non-motorized pathway results in damage, then all damage shall be fully repaired, and the pathway restored to its former condition and states conditions of non-compliance.

**Section 14 – Cuts or Openings in Sidewalk or Pedestrian Pathway –** indicates a Non-motorized Pathway Opening Permit is required to make a cut or opening in a non-motorized pathway and restoration of pathway.

**Section 15 – Signs –** indicates no signs, banners, etc., shall be affixed on or above any non-motorized pathway or designated easement without written prior approval of the Township.

**Section 16 – Exemption –** describes who is exempt from this ordinance.


**Section 17 – Sanctions for Violations –** describes fines and penalties for violators of this ordinance.

**Section 18 – Severability –** states this ordinance and the sections and subsections thereof are severable. If any portion of this ordinance is adjudged invalid, the remainder of the ordinance shall not be affected thereby but shall remain in full force and effect.

**Section 19 – Repeal –** states all ordinances or parts of ordinances in conflict with this ordinance are repealed to the extent of such conflict.

**Section 20 – Publication and Effective Date –** this ordinance shall take effect upon publication.




