If you're getting married soon, the Hawaiian Islands just might be one of the top destinations to consider for your honeymoon.

up, depending on the time of year and the island you're visiting.

You can also cruise the Hawaiian Islands with Norwegian Cruise Line, Carnival, Princess, Holland America, Celebrity, among others.

Expect to budget about \$5,000 for a one-week Hawaiian honeymoon.

Which island should you visit?

The Hawaiian Islands are made up of about 137 islands in a chain, all formed from underground volcanic hotspots. The eight main Hawaiian Islands are Oahu, with the state capital of Honolulu, Hawaii (Big Island), Maui, Kauai, Molokai, Lanai, Niihau and Kahoolawe.

No Hawaiian island is like any other. **Kauai** is lush and green with the amazing sea cliffs of the Na Pali Coast and the Waimea Canyon, the Grand Canyon of the Pacific.

Lanai offers beautiful beaches on a private-island paradise with a relaxed atmosphere, wild landscapes and plenty of adventure and exploration.

Molokai isn't as popular a destination as Oahu, Maui and Kauai, but there's still plenty to do. Check out Papohaku Beach,

also known as "Three Mile Beach," perfect for a romantic stroll.

Oahu boasts Diamond Head, the beautiful Hanauma Bay and, of course, the

world famous North Shore.

Maui has 'Iao Valley, the Hana Coast, and Haleakala, the House of the Sun.

Hawaii Island, the Big Island, has

the stark beauty of volcanic landscapes, amazing waterfalls, and the Waipio Valley, where you can descend 2,000 feet to ride horseback through taro fields and tropical rainforest to a black sand beach.

The most popular volcano of all is Kilauea on Hawaii Island, which has been in a state of constant eruption since Jan. 3, 1983.

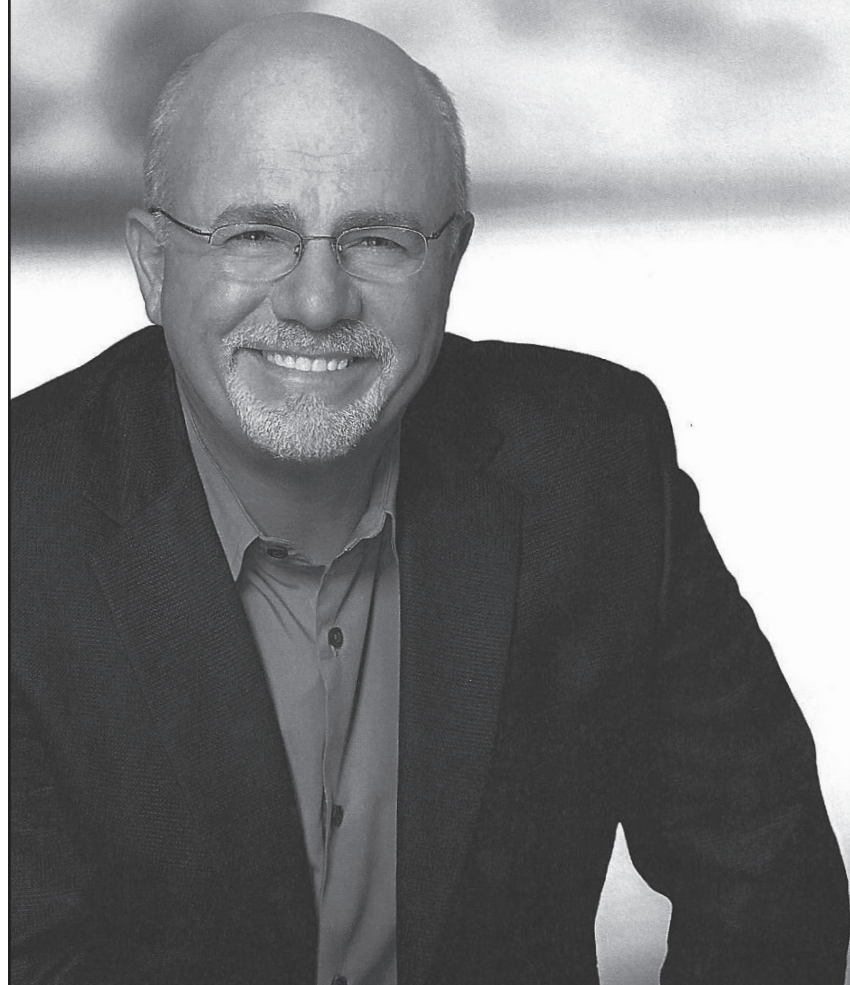
- The Hawaiian greeting is with a kiss on the cheek.

Try these traditional Hawaiian foods

- Authentic Hawaiian meal: Kalua pork, chicken long rice, squid luau, poi, laulau and lomi lomi salmon.
- Don't knock SPAM — it's widely consumed in Hawaii, mostly grilled and rice-wrapped in nori (dried seaweed).
- Manapua — pillowy buns filled with char sui, chicken, beans or anything else you'd like.
- Loco Moco — rice and hamburger patty + fried egg + gravy.
- Shave Ice topped with natural syrups, ice cream or other toppings.
- Acai Bowl — thick acai berry blend topped with fruits, granola, honey and other goodies.
- Plate Lunch — white rice, macaroni salad, meat of your choosing, maybe mahi mahi, fried chicken or teriyaki beef.
- Malasadas — deep-fried balls of dough coated in sugar.
- Poke — raw seafood marinated in the sauce of your choice. The most popular variety is ahi poke made with yellowfin tuna.
- Saimin — Hawaii's version of classic Asian noodle dishes. It's a culinary representation of Hawaii as a cultural crossroads.

JAN. 20

1987: British negotiator Terry Waite disappears while attempting to win freedom for Western hostages held in Lebanon. Waite, special envoy of the archbishop of Canterbury, secured the release of missionaries detained in Iran after the Islamic revolution. He also extracted British hostages from Libya and even succeeded in releasing American hostages from Lebanon in 1986. A total of 10 captives had been released through Waite's efforts before Shiite Muslims seized him during a return mission to Beirut on Jan. 20, 1987. He was not released for more than four years.

JAN. 21

1977: President Jimmy Carter grants an unconditional pardon to hundreds of thousands of men who evaded the draft during the Vietnam War. In total, some 100,000 young Americans went abroad in the late 1960s and early '70s to avoid serving in the war.

JAN. 22

1998: In a Sacramento, California, courtroom, Theodore J. Kaczynski pleads guilty to all federal charges against him, acknowledging his responsibility for a 17-year campaign of package bombings attributed to the "Unabomber."

JAN. 23

1849: Elizabeth Blackwell is granted a medical degree from Geneva College in New York, becoming the first female to be officially recognized as a physician in U.S. history. In 1875, now living in

London, she became professor of gynecology at the London School of Medicine for Women, a medical discipline she had helped to establish.

JAN. 24

1935: Canned beer makes its debut. In partnership with the American Can Company, the Gottfried Krueger Brewing Company delivered 2,000 cans of Krueger's Finest Beer and Krueger's Cream Ale to faithful Krueger drinkers in Richmond, Virginia. Ninety-one percent of the drinkers approved of the canned beer, driving Krueger to give the green light to further production.

JAN. 25

1995: Russia's early-warning defense radar detects an unexpected missile launch near Norway, and Russian military command estimates the missile to be only minutes from impact on Moscow. Moments later, Russian President Boris Yeltsin, his defense minister, and his chief of staff were informed of the missile launch. The nuclear command systems switched to combat mode, and the nuclear suitcases carried by Yeltsin and his top commander were activated for the first time in the history of the Soviet-made weapons system. Five minutes after the launch detection, Russian command determined that the missile's impact point would be outside Russia's borders. Three more minutes passed, and Yeltsin was informed that the launching was likely not part of a surprise nuclear strike by Western nuclear submarines.

JAN. 26

1986: In New Orleans, Louisiana, the Chicago Bears score a Super Bowl record number of points to defeat the New England Patriots, 46-10, and win their first championship since 1963. Led by Coach Mike Ditka, a tight end for the Bears during their last Super Bowl win, Chicago won 17 of 18 games to reach the championship match-up with the Patriots.

It's hard to believe that it has been almost 37 years since I enjoyed a Hawaiian vacation. The trip was made possible by my employer, an international courier company. Not only did all employees worldwide enjoy flight benefits, there were certain destinations, like in Hawaii, where a company-owned house existed for the exclusive enjoyment of vacationing employees.

I flew out the day before my traveling companion, from Chicago to San Francisco to Honolulu. Before we were about to land, the pilot pointed out some sights, like Pearl Harbor. During the flight, I learned that more than 150 of my flight mates were Japanese ladies, winners of a Tupperware sales contest in Tokyo. They were quite lovely and we laughed about flying over Pearl Harbor together.

On my first night there, friends who moved to Hawaii a few years prior, took me to the famous Ilikai Hotel in Honolulu. Remember the original TV show "Hawaii Five-O?" Actor Jack Lord stood on top of this hotel at the opening of this TV police drama.

We then flew to Maui where we would be staying for the week. The home where we stayed was in Kihei, right on the ocean. We spent many hours sitting on the beach, sipping wine. About every two hours one of us would say, "Hmmm, isn't this nice."

Should you try a fad diet?

■ Carbs, protein, calories — research what is healthiest way to lose weight

Losing weight is a common goal at the beginning of each year.

Every month, scientists publish new information on super health foods, foods everyone should avoid, sodium, sugar, alcohol and the effects of popular diets among other health fads.

Those looking to lose weight have multiple diets to choose from, if they want. Atkins. Paleo. Keto. South Beach. Weight Watchers. All of these weight loss plans have their different methods.

However, Connor Everhart, a 2010 Linden High School graduate who works as a fitness instructor personal trainer and fitness specialist at Genesys Athletic Club, said diets aren't the healthiest way to lose weight.

"A lot of these diets are not something you can sustain for a lifetime. Yes, there are some individuals who find a diet that works well for them and they can do it forever. But eight times out of 10, once the 30 days are up, the person goes back to what they were doing before and gains all their weight back," he said.

The diets

On the Paleo diet, people only eat foods that people would eat in the

Paleolithic era, also called the Stone Age which began about 40,000 years ago. These foods include meat, fruits, vegetables, and anything else grown naturally.

On the Atkins Diet, people do a two-week induction phase that restricts carbohydrates (carbs) to 20 grams per day and allows unlimited amounts of protein and fat. Your body then uses fat as its main energy source. After the two weeks, people doing the Atkins diet add carbs back to their schedule in small increments. Studies in the United Kingdom and the United States have proven the effectiveness of Atkins, according to the National Center for Biotechnology Information (NCBI).

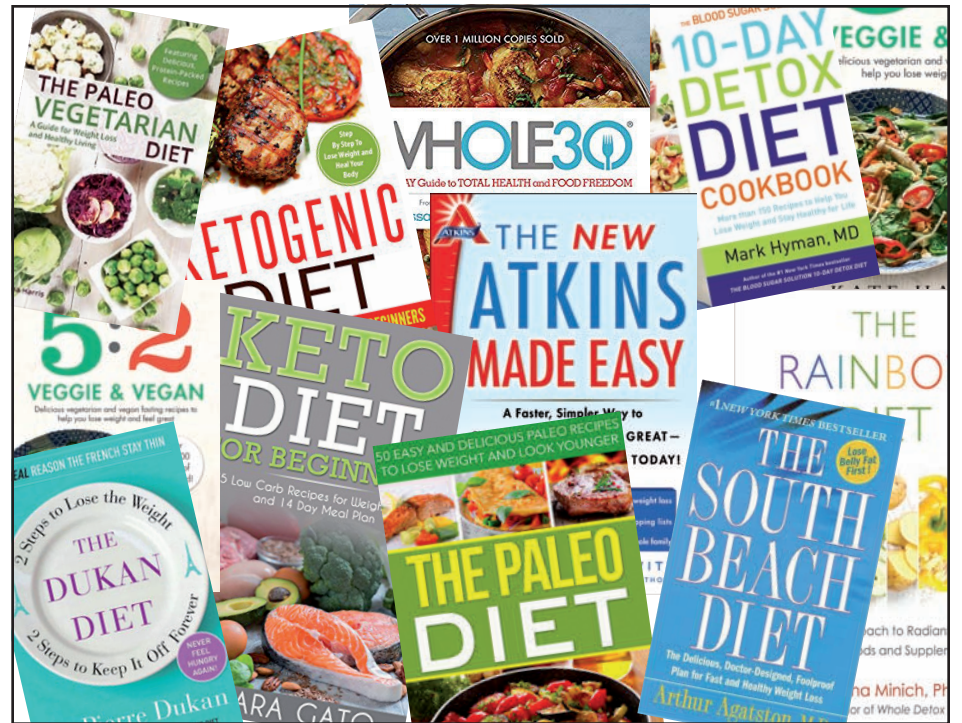
The Ketogenic (keto) diet is similar. Its focus is very low carb and high protein so your body uses its fat stores as an energy source instead of sugar. This diet does not gradually increase carb intake, but keeps it low, usually less than 30 grams of carbs a day. After analyzing 13 studies, the NCBI found that the ketogenic diet boosts weight loss and body fat, and also reduces inflammatory markers and disease risk in obese test subjects.

Celebrity trainer and fitness guru Jillian Michaels slammed the keto diet in a blog post in April 2018, calling the diet "downright dangerous." She wrote that the keto diet can be damaging because it

completely cuts out certain food groups, does not promote caloric restriction, nor does it address what types of proteins and fats are ideal.

"When we aren't eating all the macronutrients in a balanced way, we are literally starving our cells," she wrote.

On the South Beach diet, people eat few carbs and fats, but high protein levels. Phase one is low in carbs, but becomes less restrictive in phase two and three, and allows for unprocessed foods with high protein intake. The hormones released from proteins can suppress hunger longer than other foods.

"Something I really focus on, and a lot of trainers at Genesys, is changing people's perspectives on health, diet,

and working out. Health is a lifestyle, not a quick fix routine," Everhart said. "People need to understand that fad diets are temporary and they need to learn how to manage their relationship with food. Everything is all about balance and moderation."

One program that focuses on moderation is Weight Watchers. Weight Watchers helps people lose weight by promoting self-discipline. Every food you eat has a certain amount of points, and you have an allotted amount of points each day. The company recently rolled out a new program called Freestyle. It keeps the SmartPoints system, but certain foods, like chicken, fish, eggs, corn and beans, have a value of zero.
