Back in the days of the 1970s, high school choirs and glee clubs, black robes and bleachers were the norm as students performed hymns, a cantata or two or maybe chamber music for a polite audience of parents and grandparents.

Just imagine the excitement of performers coming out on stage at Fenton High School in 1979, clad in brightly colored outfits, singing Top 40 hits of the day and intermingling with the audience.

Those were the early days of the Ambassadors, a group of performing singers and dancers that are officially celebrating their 40th anniversary this year. Their concert finale Friday and Saturday, May 10 and 11 at the FHS Ruby M. Zima Auditorium begins at 7:30 p.m. and will include many

A beacon in the night

Whenever the last leg of our travels had us heading north on U.S. 23, whether we were driving home from nearby Ann Arbor or from Chicago about 275 miles west, we knew that when the Oasis Truck Stop lights came into view, we were almost home. It was a beacon in the night.

In its hey-day, the Oasis, which sat on about 26.6 acres at M-59 and U.S. 23, attracted tens of thousands

of truckers and travelers passing through the area. In the dead, freezing cold of winter, I was always amazed by the 50 or more big rigs parked in the back with their engines running. They would run all night long to prevent dead batteries.

VERA HOGAN Although I never went up to the second floor, the Oasis featured sleeping areas and showers for weary truckers. It also featured a general-type store where drivers and any traveling companions could purchase all of the necessities they needed while on the road.

Other travelers and the locals would visit the store and marvel at all of the novelty items. They had ball caps featuring every college and professional sports team in Michigan, as well as many from across the country. There were funny license plates and the most hilarious bumper stickers and T-shirts I have ever seen anywhere. The store was packed with snacks and candy, soft drinks and gag gifts of all description.

One of the best parts of the Oasis was the restaurant. It's no secret in this country that if you want to find where the best food is served, look around the parking lot. If there are a lot of trucks, you've come to the right place.

About 20 years ago, the truck stop, which brought in about \$12 million in annual revenue, was sold for \$3.3 million.

My husband, who grew up in nearby Parshallville, and his brother worked at the Oasis Truck Stop when they were Hartland High School students. They have many fond memories and

dozens of great stories to tell about their time working there.

My husband is an extraordinary cook. His Sunday morning breakfasts are incredible. I don't know anyone who can prepare eggs over easy to perfection every single time, or make the lightest, fluffiest scrambled eggs ever. Whether it's the sausage, bacon or ham, the meat is always perfect and his sausage gravy is delish.

I am going to assume that his culinary skills had to come from, in part, his part-time job at the Oasis — and for that I thank truckers everywhere.



GREATEST BASKETBALL FLICKS OF ALL TIME

It's difficult to imagine that games involving basketball and other sports could inspire so many movies featuring a variety of plot twists and turns, but it happens every time.

Here are a few basketball favorites:

SPACE JAM (1996)

Swackhammer (Danny DeVito), an evil alien theme park owner, needs a new attraction at Moron Mountain. When his gang, the Nerdlucks, head to Earth to kidnap Bugs Bunny (Billy West) and the Looney Tunes, Bugs challenges them to a basketball game to determine their fate. The aliens agree, but they steal the powers of NBA basketball players, including Larry Bird and Charles Barkley — so Bugs gets some help from superstar Michael Jordan.

HOOSIERS (1986)

Failed college coach Norman Dale (Gene Hackman) gets a chance at redemption when he is hired to direct the basketball program at a high school in a tiny Indiana town. After a teacher (Barbara Hershey) persuades star player Jimmy Chitwood to quit and focus on his long-neglected studies, Dale struggles to develop a winning team in the face of community criticism for his temper and his unconventional choice of assistant coach — Shooter (Dennis Hopper), a notorious alcoholic.

WHITE MEN CAN'T JUMP (1992)

Billy Hoyle (Woody Harrelson) is a white basketball hustler who banks on black players underestimating his skills on the court. When he pulls one over on Sidney Deane (Wesley Snipes), his victim sees a lucrative opportunity, and they become partners in the con game, plying their trade across the courts of Los Angeles. Meanwhile, Billy has to keep one step ahead of mobsters, to whom he owes money, while staying on the good side of his "Jeopardy"-obsessed, motor mouth wife (Rosie Perez).

AIR BUD (1997)

Diffident in the wake of his father's death, high schooler Josh (Kevin Zegers) struggles to adapt to his new home in Washington State. That all changes, however, when he signs up to be the school basketball team's manager and discovers that his pet dog Bud, a stray golden retriever he took in, can play the sport amazingly well. After Bud joins the team, Josh's life brightens considerably, until the dog's former owner Norm Snively (Michael Jeter) returns in hopes of reclaiming the pooch.

THUNDERSTRUCK (2012)

A teenage klutz (Taylor Gray) becomes the star of his high school basketball team when he magically acquires the abilities of his hero, NBA star Kevin Durant — but the switch leaves Durant unable to score.


REBOUND (2005)

Roy McCormick (Martin Lawrence) is a college basketball coach more famous for his temper than for his coaching ability. After one of his rages gets him banned from the sport, Roy takes a job coaching basketball at a middle school in an attempt to repair his reputation. Amazingly, what Roy began as a show of rehabilitation begins to genuinely change him, and he learns to care for his team. His relationship with local mom Jeanie (Wendy Raquel Robinson) is a good influence as well.

HURRICANE SEASON (2009)

One year after the devastation of Hurricane Katrina, high school basketball coach Al Collins (Forest Whitaker) gathers displaced students and rebuilds the school team, the Patriots. Though the young athletes originally hailed from five different schools, Collins builds them

into a cohesive unit and takes aim at the high school basketball championship.

popular songs from the past four decades.

This year is a 20-year milestone for Vocal Director Brad Wright, the longest-running director in Ambassador history. Previous directors were Maxine Archie, from 1979 to 1986, Ray Voorhees, from 1987 to 1988,

Lynn Ferguson, from 1989 to 1998 and Cathy Letovsky, from 1998 to 1999.

This year is also a milestone for choreographer Karen Whittaker, who has been designing the group's dance moves for more than 20 years.

"Several things make the Ambassadors unique," Wright said. "The original intent that Maxine (Archie) laid out was that students would strive for the highest levels of citizenship, musicianship and leadership."

It's been a winning formula throughout the years. The Ambassadors have brought home many awards and accolades.

"We have competed every year except one year we performed at Disney in Florida," Wright said. "In 2017, the Ambassadors competed in Williamsburg, Virginia. We won the Adjudicator Award, given to groups with a combined score of 95 or higher out of 100. We also won Outstanding Choir at Festival for being the highest scoring choir, a 98, the group's highest score at a competition.'

The most meaningful accolade was from a festival in Toronto in 2012.

Currently, there are 18 Ambassadors for the school year 2018-19. "The typical number is right around 20, but we've had groups as small as 16 and as large as 33," Wright said.

The Ambassadors usually have five school concerts on their own,

> including the one finale concert coming up in May. They also sing at all three FHS choir concerts throughout the year. "Then there are various performances we do around the community," Wright said. "Christmas is an especially busy

time for us."

The Ambassadors are also well known as the kick-off act for the Community Expo in Fenton every year in March.

Some of Wright's most vivid Ambassador memories include the year 2001 when they did their first medley — a short, musical play that the Ambassadors write, costume and choreograph. "That year we did a tribute to Television Theme Songs," Wright said. "It was a riot. The kids did such a great job with costumes."

Another memory was when the Ambassadors learned Country Dances, Wright said. "It's an exceptionally difficult piece of music usually sung by college-level choirs. I told the kids it would be cool. We started learning it that night and I still remember how excited the Ambassadors were to be singing it."

Before The Ambassadors

The Fenton Chorale preceded the Ambassadors, under the direction of Ray Voorhees. Mrs. (Maxine) Archie changed the name to the Ambassadors and went all in with dance. We were a small group, 16 or 20 and we used modest movement and more contemporary music. One of the guys also played the drums. Song and performance have always had a strong home at FHS: Mrs. Zima in theatre and Mr. (Ray) Voorhees in choir. I am proud that music is still being made at FHS."

Alloy Drive, Tax ID #53-34-526-024. The property is located on the east side of S. Alloy Drive at the intersection of Copper Avenue, and is zoned IND, Industrial District, where industrial uses are permitted uses.





Senate Bill 115: Mandate corporate board female membership quota

Introduced by Sen. Sylvia Santana (D), to mandate that publicly held corporations (those that have sold stock to the public) must have a specified number of females on their board of directors. If the board contains four members, the bill would mandate that at least one would have to be female, or two females on a five-member board, or at least three females on a board with six or more members. Referred to committee, no further action at this time.

Senate Bill 121: Give tax breaks to some home buyers

Introduced by Sen. Kenneth Horn (R), to authorize a \$5,000 state income tax deduction, and \$10,000 for joint filers, if the income is contributed to a specialty savings account for home purchases by individuals who have not bought or owned a home in the past three years (dubbed by the bill a "first time home buyer"). A

taxpayer could claim this deduction for up to 20 years for purposes of buying a principal residence. A version of this proposal was vetoed by Gov. Rick Snyder in 2018. Referred to committee, no further action at this time.

Senate Bill 156 and House Bill 4283: Authorize "extreme risk" firearm seizures from individuals Introduced by Sen. Mallory McMor-

Introduced by Sen. Mallory McMorrow (D) and Robert Wittenberg (D), respectively, to authorize courts to order firearms to be seized from an individual based on a "reasonable cause to believe" that the person poses "a significant risk of personal injury to himself or herself or others." Family members, a former or current spouse, an individual who has a child in common with the target, roommates, or a person in a "dating relationship" with the target could petition a court to issue an order to seize the individual's firearms, and the court could issue this order without any notice to the target. The bill prescribes standards and procedures for this, and for an appeals process. The court order would be in effect for up to one year and could be renewed. Referred to committee, no further action at this time.

Senate Bill 222: End state oversight of post-bankruptcy Detroit bail-out reforms

Introduced by Sen. Sylvia Santana (D), to repeal the state oversight provisions that were included in the 2014 law granting a bailout to the bankrupt city of Detroit, and terminate the state oversight commission that was created to monitor the city's finances going forward. Referred to committee, no further action at this time.

Why it pays to use crates when training puppies

Puppies make great additions to a household. Parents often find that dogs can teach youngsters lessons about compassion and responsibility, while moms and dads enjoy the companionship and unconditional love their dogs provide.

As first-time dog owners learn shortly after bringing their puppies home, pets require a lot of work. That's especially true of puppies, which must be housebroken so they can learn

to live within the structure of a family. Crate training, which is supported by the American Kennel Club, is a great way to teach puppies proper behaviors and to get them to adjust to their new lives.

Many dog owners, particularly those who have never before had a dog, may hesitate to employ crates to train their puppies. That's understandable, as on the surface

it can seem cruel or inhumane to confine a living animal to a cage. However, the AKC notes that dogs are den animals that naturally seek out canine caves for security. That's true whether dog owners

provide crates for their puppies or not. So while humans may see crates as cruel, dogs very likely view their crates as secure places where they can go if they get scared or feel skittish. In fact, according to the AKC, dogs' perception of crates is one reason why dog owners typically find it relatively easy to get their dogs to adjust to crates and ultimately enjoy them.

The AKC urges dog owners who plan to crate train their puppies to find appropriately-sized crates before they begin training. Crates should be just large enough for dogs to lie down, stand up and turn around. Dogs won't embrace crates that are too small, and crates that are too big will give dogs the impression that they can use one corner to defecate and use the rest for sleep or play. That's the wrong message to send, as dogs should never be encouraged to relieve themselves in their crates.

Pecan Praline Cookie Triangles

Pecans are a species of hickory native to northern Mexico and the southern United States. Pecan trees are cultivated for their edible nuts, and it can take 12 years for a tree to reach maturity and begin producing.

The history of pecans, which are the only major tree nut that grows naturally in North America, can be traced to the 16th century. Pecans are frequently enjoyed in southern cooking, particularly in desserts.

There are many different ways to incorporate pecans into recipes, such as in delicious, chewy cookie bars. Enjoy this recipe for "Pecan Praline Cookie Triangles" from "The Pampered Chef® Stoneware Inspirations (The Pampered Chef®, Ltd.)" by The Pampered Chef® Test Kitchens.

INGREDIENTS:

CRUST

- 2 1/2 cups all-purpose flour
- 3/4 cups powdered sugar
- · 1 teaspoon baking soda
- 3/4 cups butter or margarine, melted

FILLING

- 3 cups pecan halves, divided
- 2 cups packed brown sugar
- 3 eggs
- 4 tablespoons butter or margarine, melted
- 2 teaspoons vanilla extract
- 1/4 teaspoon salt
- Powdered sugar, optional



DIRECTIONS:

Preheat oven to 350 F. For crust, combine flour, powdered sugar and baking soda in a batter bowl. Add butter; mix until crumbly. Lightly press crumb mixture over bottom of stoneware bar pan; roll lightly. Bake 15 minutes; remove from oven to a cooling rack.

Meanwhile for filling, reserve 1 cup of the pecans for garnish; chop remaining pecans. Combine chopped pecans, brown sugar, eggs, butter, vanilla, and salt; mix well. Pour filling over warm crust, spreading to edges of pan. Arrange remaining pecan halves over filling. Bake 17 to 19 minutes, or until filling is set in center. Remove from oven; cool completely.

Sprinkle with additional powdered sugar, if desired. Cut into 32 squares using a utility knife; cut each square in half diagonally.
