# 2019 saw major growth in city of Fenton

■ Road conditions continue to be a problem, especially with added new traffic

If two words could best describe what happened in the city of Fenton in 2019, they are "explosive growth." In all corners of the city, there have been new buildings erected and existing facilities renovated.

The following is just a sampling:

The eagerly anticipated Horizon Building at Silver Lake Road and N. LeRoy Street was completed and now houses the popular Andiamo restaurant, featuring Italian fare.

The third floor is occupied by Serra Automotive personnel, and the second by The Horizon Group of Raymond James Financial Advisors.

Just down the street, 111 LeRoy Place is currently under construction. Although there were several delays, the new building will be open for residential and retail uses some time in 2020.

At least two of the historic buildings in downtown Fenton were repurposed in 2019. Jason Warda, owner of The Barn Restaurant on Torrey Road opened the Fenton Pub on S. LeRoy Street. Ciao

Italian Bistro and Wine Bar opened on the same stretch nearby, giving patrons another Italian food option.

Preferring a downtown location, REJUVE AVE Skin Spa moved from its S. LeRoy Street location to its newly constructed building at the corner of Mill Street and Adelaide.

Across town, a new development was constructed where the Big Boy and Pizza Hut once stood. This new development houses a Verizon store, Jersey Mike's sub shop, a Thai restaurant, Sports Clips haircuts and Starbucks.

The Meeting Place restaurant is now open where the Bob Evans Restaurant used to be and around the corner on Silver Parkway, the big Kmart renovation project is now complete. It houses TJ Maxx, Skechers and Five Below. In the spring of 2020, Oshkosh B'Gosh/Carters and Michael's will locate in the same complex.

Further down Silver Parkway a major facelift took place where Sally Beauty Supply, the UPS Store and other retailers are located. A courtyard was added and more improvements are expected.

#### **ROADS**

With all the new restaurants and stores that have come to the city, it appears that the economy is alive and well in the city of Fenton, unlike the city's roads. Voters rejected paying 5 mills for 10 years in November of 2018, and officials and

administrators have yet to find a way to fund much-needed road repairs.

In the meantime, the Department of Public Works worked on a new roadpatching program. They started on major streets first before moving on to residential streets.

#### **ROUNDABOUT**

While it was the subject of many complaints, the new roundabout at Torrey and North roads was completed in 2019, and it appears to have aided in regulating a once-difficult intersection.

The cost for the entire project was \$1.34 million. It opened to traffic in early November — finishing touches will be completed in the spring of 2020.

#### **FAILED PATHWAY**

Citizens in the three municipalities that make up SLPR (Southern Lakes Parks and Recreation) were asked to amend the SLPR charter to include a levy and collection of 1.2 mills for 10 years, from 2019 to 2028, to provide funds for non-motorized recreational paths and facilities in Fenton, Fenton Township and Linden.

The millage was expected to raise just over \$1.4 million in the first year. The estimated cost of the pathways is almost \$14 million.

In May, the ballot question failed in all three communities. In order for the proposal to pass, each municipality would have had to have approve it. The reasons for failure were many, including people who claimed they want their roads fixed first. Others still said they simply could not afford another millage.

Organizers vow to keep at it and find a way to fund the pathway.

#### **ELECTIONS**

Fenton City Council elections resulted in two incumbents being ousted in November. Nancy Draves and Cherie Smith lost their seats on the council, while former councilman Brad Jacob, newcomer Sean Sage and incumbent Pat Lockwood were elected.

Although Mayor Sue Osborn was challenged by long-time former Councilwoman Cheryl King, Osborn was re-elected. She has served more than 20 years as mayor.

# Holly area — progress and exciting projects

■Village and townships experience growth in unique ways in 2019

The Holly area might be enjoyed and known as a sleepy "bedroom" community for residents, but the area comprised of Holly Village, and the townships of Holly, Rose and Groveland, have been anything but sleepy in 2019.

This area continues to grow along with their neighboring cities like Fenton and Grand Blanc.

Big changes came to Holly Village as a new police chief was hired. Chief Michael Story resigned suddenly in August. Lake Orion Police Chief Jerry Narsh was hired and his first day was Dec. 9.

The Holly Fire Department moved to a new location in midtown with official occupancy in October. The project cost just under \$500,000 and is twice the size of the former Broad Street location.

"We accomplished a lot and made progress on so many projects," said

Katy Golden, Holly Downtown Development Authority director and assistant village manager.

Holly Village acquired a \$150,000 grant for the Union Depot project. The DDA offered matching funds to refresh the look of several downtown properties.

Ongoing projects in Holly Township achieved milestones, such as the heritage farmstead structural work that was needed before development could

the way for more projects to come. "We've spent time with new ordinances, for the wind and solar, agro tourism," Supervisor George Kullis said. "Holly's growing."

Some policies and procedures need to be updated to allow for growth to come, such as in the Dixie Highway corridor project. "We're not going to be a sleepy little burg anymore," Kullis said.

The first resident in Riverside Gardens, of the Pulte subdivision moved in this October. Kullis said approximately 15 homes are under construction in the previously stalled subdivision.

Kullis said numerous meetings have been held to rebuild North Holly Road. They're also working to make it easier for residents to divide and sell land.

### **Many changes for downtown Linden**

From Dr. Wax building to proposed changes at corner gas station to hiring of new clerk

In 2019, Linden City saw dramatic changes in the downtown area. Construction started on the new two-story building owned by Dr. Nicole Wax of Dr. Wax Orthodontics at the northeast corner of Bridge and Broad streets. When it's completed in 2020, it will

be home to three businesses and Dr. Wax Orthodontics. Included in the plans are about two dozen new parking spaces.

Right across the street from the new building could be the new Beacon & Bridge gas station and market. Owners Quick-Sav Food Stores are working on plans to rebuild with the market at the intersection. The property currently has four pump stations on the north end of the property and a 2,240-square-foot convenience store on the south portion.

The owners wish to expand to eight pump stations and a 2,592-square-foot convenience store, with the gas station located south of the building. The plans involve tearing down the current gas station and the vacant building at 111 S. Bridge St.

Another significant change in 2019 were the efforts to monitor and clean up the underground gasoline leak discovered in 2014 with the installation of 22 monitoring wells. The wells connect to an underground piping system that will remove contaminated groundwater and soil gas as corrective action.

The public restroom at Eagle's Wooden Park was finished in 2019.

The Linden City Council hired Ellen Glass as city manager, relieving Police Chief Scott Sutter who took over as interim. The city also hired a new clerk, Tessa Wightman, following the departure of former clerk Erica Armstrong.

In May, voters shot down a millage that would have collected funds for a non-motorized pathway through Linden, Fenton and Fenton Township.

In April, a motorist struck the side of Linden City Hall, damaging the side of the building. The damage has not yet been fixed.

When it comes to events, Linden saw thousands of participants. In November, while the city was adorned with Christmas decorations along the streets, volunteers held a tree lighting ceremony for the first time called Cocoa and Carols.

In December, the 2019 Linden Holiday Happening attracted more than 5,000 to the Frosty Parade, fireworks, and a chance to meet Santa.

In June, the annual Gus Macker basketball tournament was a huge hit with thousands of participants.

the LaFontaine automotive group.



hear this case for Dec. 3, which was adjourned. No new court dates are scheduled. Akl is charged with the fatal shooting of Brady Alan Morris on March 4, 2017 at Akl's family home on Lake Fenton in Fenton Township.

If Akl is found guilty as charged, "He could be sentenced to life without parole or he could be sentenced to a term of years with 25-40 years as a minimum," said John Potbury, deputy chief assistant prosecutor for Genesee County on Monday, Sept. 30.

Akl, now 18, was 16 when the shooting occurred. Morris also was 16. Akl was arrested the night of the shooting and with bond denied, he has been in custody at the Genesee Valley Regional Center ever since.

#### Eric Scott Andrews Jr.

Eric Andrews Jr., 21, of Grand Blanc, was charged earlier this year with recording five coworkers in the Fenton Tim Hortons bathroom. He pleaded guilty to

three of the 26 felony charges against him for six different crimes. The plea deal was in exchange for dismissing the remaining 23 charges. On Nov. 22, he was sentenced to 36 to 240 months in prison.

The Michigan State Police said Andrews illegally videotaped coworkers. He also videotaped his best friend and her boyfriend in the bathroom at Andrews' grandparents' home in Grand Blanc Township without their knowledge.

#### **Stephanie Blackburn**

Along with paying restitution of \$5,000, Stephanie Suzanne Blackburn, 41, of Argentine Township, was sentenced July 17 to pay court fines of \$770 and be on probation for one year. She also wrote an apology letter to the victims. She was arraigned in Genesee County 67th District Court on one felony count of embezzlement (agent or trustee) of an amount between \$1,000 and \$19,999. She pleaded no contest.

She entered a plea agreement in May, which reduced the charge to a misdemeanor. She paid the full restitution amount May 31.

Argentine Police Chief Daniel Allen said police were told that Blalock removed the magazine from the weapon and believed the gun was unloaded when he aimed it at his friend. The police chief said, despite pulling out the magazine, a bullet remained in the chamber.

#### Frank Borge Fell III

Frank Borge Fell III, 73, of Linden has two court cases involving child pornography in Genesee County. One court case dates back to June 2017 with Argentine Township Police Department. The second court case dates back

to February 2018 with the Michigan State Police-Flint Post (MSP).

With the Argentine case, Fell faces 10 felonies related to possessing child sexually abusive material and using a computer to commit

the crime. With the case investigated by MSP Computer Crimes Unit, Internet Crimes Against Children Task Force, he faces 20 felonies related to possessing child sexually abusive material and using a computer to commit the crime. A combined jury trial is set for March 17, 2020.

#### **Robert Abraham Clark**

Robert Clark, 31, of Fenton, was arraigned Nov. 7 in Genesee County 67th District Court on five charges including malicious destruction of a building, larceny from a building, indecent exposure and two counts of resisting/assaulting a police officer.

The charges stem from incidents in

downtown Fenton in the early morning hours of Sunday, Sept. 22. Fenton police obtained arrest warrants from the county prosecutor's office. On Dec. 11, Clark pleaded guilty to a

Clark also faces pending charges of burglary, criminal damage to property, concealing identity, falsifying title and registration (altering), and resisting, evading or obstructing an officer in Roswell, New Mexico stemming from an Oct. 1 incident.

#### Frederick Clark, Christian Lee Lover and Mataya Delores Shaw

The three individuals charged with premeditated, first-degree homicide and conspiracy to commit murder in the death of Austin Culkins, 20, were scheduled to begin a jury trial in

Genesee County Circuit Court on April 30. It didn't happen.

Clark and Lover's jury trials were set to begin Nov. 19, however, the court postponed the start of the jury trial to March 10, 2020.

Shaw pleaded

guilty to an amended charge of second-degree murder and to deliver a controlled substance causing death. She could be sentenced 25 years to life. Her sentencing date is set for March 27, 2020 at 8:30 a.m.

Leonard Cwiklinski, 67, of Fenton Township was arraigned Oct. 5 on one count of false report or threat of terrorism in Genesee County 67th District Court. The charge is a 20-year felony if convicted. Fenton police said the manager of a bank in Fenton called police to report a threatening voicemail left for bank employees. A man, later identified as Cwiklinski, left the message allegedly saying he was upset with bank services and wanted to withdraw his money.

During a court hearing Oct. 30, the Cwiklinski was referred for a competency evaluation. A review hearing is set for Jan. 6, 2020.

#### **Elena Danishevskaya**

Elena Danishevskaya of Davisburg, a former Holly police chief, pleaded guilty April 25 to two misdemeanor counts of willful failure to uphold the law in Van Buren County Circuit Court. As part of her plea agreement, 15 related felonies were dismissed by the court.







### **Fenton Township man** faces 14 felonies

■Arraigned Dec. 20 on charges related to possessing child sexually abusive materials

The Michigan State Police (MSP) Computer Crimes Unit, Internet Crimes Against Children (ICAC) Task Force announced the arrest of Robert Allen Langdon, 53 of Fenton Township, for possession of child sexually abusive materials and using a computer to commit a crime.

Langdon turned himself in following an investigation in which digital evidence was seized from his home.

The investigation was initiated when it was learned that Langdon was viewing child sexually abusive materials on the internet.

Following a forensic examination of the digital evidence, Langdon was charged with seven counts of possession of child sexually abusive materials and seven counts of using a computer to commit a crime.

Langdon was arraigned in 67th District Court on Friday, Dec. 20.

The MSP Computer Crimes Unit encourages parents to speak to their children about the safe use of the internet. There are many resources available to parents to assist in keeping children safe online. The National Center for Missing and Exploited Children provides a comprehensive list of resources on their website at missingkids.org.

that caught fire at the Owen Road overpass of southbound U.S. 23. Fenton Township Fire Department responded with a tanker.

The highway and Owen Road were shut down while firefighters extinguished the flames. Motorists were urged to avoid the area.

The driver of the semi, a 63-year-old Jackson man, was able to get out of the truck and was treated for non-life threatening injuries. No other injuries were reported.

Lt. Jeff Cross of the Fenton Police Department said the driver reported that while he was traveling southbound on U.S. 23, the steering wheel of his truck became stiff to the point that he could not steer the truck. He braked and the truck veered to the right and up the embankment, where the truck hit the Owen Road overpass.

Cross said gawkers and stopand-go traffic caused numerous secondary crashes in the area.

Just after 4 p.m., a tow truck equipped to handle this size of crash used a crane to lift up the damaged semi and remove it.

Representatives with the Michigan Department of Transportation (MDOT) were on site so that they could inspect the Owen Road overpass once the debris was cleared.

Westbound Owen Road, from the east side of U.S. 23 to the west side of the highway was closed through the afternoon.


There were several important projects in Rose Township that were either finished or made progress in 2019, according to Supervisor Dianne Scheib-Snider. Milford Road was completely repayed inside Rose Township and a new culvert was installed.

# Olsen's two state title day is top effort of 2019

She's won three individual state titles, earned runner-up status in another individual event and has helped the Fenton varsity girls swim team earn All-State honors in two relays.

Yet, Gracie Olsen prep career has only begun. The Fenton standout swimmer has only finished her sophomore season with the Tigers' squad.

Olsen became the first-ever swimmer in Fenton history to win two individual state titles at the same state meet when she won the 200 yard freestyle (1:48.98) and the 100 butterfly (54.62) at November's Division 2 MHSAA Girls State Swimming and Diving Championship at Oakland University. Her performance also made Olsen our top sports story in the tri-county area of 2019.

Olsen began the meet by helping the 200 medley relay team earn All-State status with a fifth-place finish (1:49.19).

# Expansion creates new vibe to Flint Metro League

Maybe the only constant in the Flint Metro League's history can be represented with one word — change.

When the league began in 1968, there were six squads within the organization. Of those six, only Fenton and Holly have been members every single year. Swartz Creek left during the mid-1970s, only to come back during the 2000s.

Many changes have happened over the decades, but never has one happened that took place before this school year.

The Flint Metro League grew to 12 teams, and for the first time ever has two divisions for a variety of sports. It also represents the first time that all four tri-county area squads are in the Metro League as well. For those reasons, the changes in the Metro League rank as the No. 2 story in the tri-county area spots scene during 2019.

The 2019 fall season was the first to experience the expansion. It created a thrilling boys soccer race with Fenton, Linden and new member Goodrich each earning a share of the league crown. In football, there were divisions and the two division winners were Fenton (Stripes Division) and Goodrich (Stars Division). It set up the first-ever cross-over Metro League championship when the Tigers traveled to Goodrich.

The title game at Goodrich received plenty of hype, but it eventually became evident that the Tigers would win the contest.


