Crestmont nursing home closes doors

Administrator claims 'it was a business decision' for Fenton facility

Over the years, in addition to caring for senior citizens and others needing its services, Crestmont Nursing Home Care Center on Trealout Drive in Fenton was a place where volunteers were recognized, nurses were honored, homecoming dances took place, and classic car shows and Christmas bazaars were held.

Today, the nursing home is closed for good, having transferred its last patient Friday, Feb. 14, according to Birdie Goynes, administrator.

Goynes would not comment on why the nursing home closed, or what the plans are for the empty building now. "It was a business decision," is all Goynes would say.

Mike Reilly, building and zoning administrator for the city of Fenton, said, "The building is not owned by Crestmont's management. The landlord did not renew their lease and told them to vacate. That's all I know. I don't know what's going to happen to the building."

Rollover crash on U.S. 23 in Fenton

departments responded to U.S. 23 between Owen and Silver Lake roads in Fenton for a rollover crash, involving three vehicles. A red Saturn Vue was traveling northbound on U.S. 23, driven by a male from Clio. According to Lt. Jeff Cross of the Fenton Police Department, he attempted to pass vehicles in the fast lane from the right lane when he clipped a green Subaru. His vehicle

PRISON SENTENCE Continued from Front Page 18 to two years and four months in federal prison, on conspiracy to commit honest services wire fraud and conspiracy to commit money laundering.

According to federal court records Grimes is a former United Auto Workers official who was convicted of receiving more than \$1.5 million in bribes and kickbacks from a union vendor, including \$10,000 worth of cosmetic surgery for a relative.

Grimes and his wife, Karen, are residents of Fort Myers, Florida but owned a home on Enid Boulevard on Lake Fenton for several years until they sold in 2016.

Grimes pleaded guilty in September 2019 to wire fraud conspiracy and money laundering. Though sentencing guidelines call for almost five years in prison, prosecutors recommended a two-year sentence because Grimes cooperated with an ongoing investigation, according to court records.

Tyrone Township man 'leaps' to age 92

Having a Leap Day birthday on Feb. 29 is a one in a 1,461 chance

Ed Hyypio of Tyrone Township was born Feb. 29, 1928, but he's only 23 years old.

That is, if you count the number of birthdays he has actually celebrated, according to our current calendar.

Hyypio is what is known as a "Leaper," born on

Leaper, born on Leap Day. While he does look and act younger than his 91 years, he's older than 23 — he'll be celebrating his 92nd

birthday this Saturday, Feb. 29, a date that occurs on the calendar only once every four years.

Hyypio was born in 1928 in Tapiola in Michigan's Upper Peninsula, to Finnish parents — a midwife mother and a father who was a logger. His mother listed his birth date as Feb. 28, 1928, following his Leap Year birth.

"I grew up in a tar paper shack, but so

did everyone else, so we didn't know it," said Hyypio, the youngest in a family of two boys and three girls. He didn't learn English until he started school, and today, he speaks several other languages.

But he learned a hard work ethic at a very young age and it continues through today. "It's the road to happiness," he said. "When I was 13, I had the biggest dairy herd in the area."

He moved from the U.P. to Fenton in 1949, and started working at the Fenton Hotel before moving on to police

work in Flint, where he worked 16-hour shifts.

He also worked in heavy equipment, as a truck driver and hauled cars, a career

he continues to this day. "I drive cars for LaFontaine, anywhere from 40 to 60 hours a week," Hyppio said. "If they need a car driven somewhere at 1 in the morning, I'll do it. I don't sleep; I work."

Hyypio had wanted to be a fighter pilot, but his brother, who was 10 years older, was killed in World War II, so the military wouldn't take him.


He does find time for other pursuits,

including delivering leftover bread from VG's Grocery to churches and shelters. He also attends local high school basketball games every Tuesday and Friday evenings for the past 40 years. "I like to watch kids compete," he said. "I was in school during the war, so I never had a chance to play."



House approves plan to remove license fee

Measure would rid \$5 service fee for Vietnam War specialty license plate

On Wednesday, Feb. 19, the Michigan House of Representatives approved State Rep. Hank Vaupel's

(R-Dist. 47) plan to eliminate the service fee for a Vietnam War Veteran specialty license plate. The measure is part of a bipartisan, multi-bill package removing the

\$5 service fee for various veteran and military license plates.

"Imposing a service fee for special military license plates is not the appropriate way to greet service members who have sacri-

ficed so much to protect our great nation and preserve the freedoms we cherish upon returning home," said Vaupel of Fowlerville who served during the Vietnam War as a captain in the Army.

As required by state law, the Secretary of State provides for the issuance and creation of each li-

> cense plate issued in Michigan. There are differentiating fee requirements for each license place issued, with veteran and military

license plates having a \$5 service fee.

House Bill 4684, along with the rest of the bill package, now moves to the Senate for further consideration.

revealed no current violations. "The building was in compliance," Goynes said.

Department of Health and Human Services Medicare reports (with dates not recorded) revealed some deficiencies involving privacy issues with patients, and failing to record in the appropriate paperwork and electronic charts a patient's advance directive to "not resuscitate," which could have resulted in the potential for incorrect end of life treatment, according to the report.

A July 2019, Medicare report shows a deficiency in a resident's right to a safe, clean, comfortable and homelike environment, including but not limited to receiving treatment and support for daily living safely.

The inspector noted that this particular resident was reported to be difficult and uncooperative with staff, refusing care and to be bathed, for example.

The staff was ordered to develop the complete care plan within seven days of the comprehensive assessment to be prepared, reviewed, and revised by a team of health professionals.

It is unknown if Crestmont complied.

2016 federal complaints

In June 2016, The Michigan Protection and Advocacy Service, Inc. (MPAS) filed federal complaints June 2 against Crestmont Nursing Care Center.

Crestmont was charged with one count of violating the Protection and Advocacy for Individuals with Mental Illness (PAIMI) Act's access to records provision; one count of violating the Developmental Disabilities (DD) Assistance and Bill of Rights Act's access to records provision; and one count of violating the Protection and Advocacy of Individual Rights (PAIR) Program of the Rehabilitation Act's access to records provision.

According to the complaint, MPAS reviewed licensing surveys from May and November of 2015, which indicated that

individuals with disabilities might have been subject to abuse and neglect.

The survey identified approximately 10 residents who may have been subject to abuse and neglect relating to a failure to develop care plans, failure to properly treat pressure sores, the administration of psychotropic medications and failure to provide appropriate social services.

Crestmont Nursing Care Center failed to turn over all of the requested records relating to the investigation, according to the complaint. MPAS asked the court to require Crestmont Nursing Care Center to provide all of the requested records and to have plaintiff's costs and reasonable attorney fees covered, related to this investigation.

It is unknown if Crestmont complied with the order or if any of these reports or charges had anything to do with the home closing last week.

About Crestmont

Crestmont Nursing Home Care Center (then called Crestmont Medical Center) was opened in 1968 by Dr. Frederick H. Bostick, a long-time Fenton osteopathic physician. His office was located in the facility until his retirement in 1989. In its prime, Crestmont was a 152-bed full-care facility. Bostick died Oct. 17, 2000 at the age of 88.

Confidential informants

Consider the following hypothetical case.

The police learn from a reliable confidential source that a Mr. Smith is selling drugs out of his house. This information was supplied because the tipster hoped to receive leniency in his own pending criminal case.

As a result of this information and further investigation, a search warrant for Mr. Smith's house is obtained, illegal controlled substances are seized and Mr. Smith is arrested.

Thereafter Mr. Smith's attorney requests that the prosecutor give her the name of the individual who supplied the tip to call as a witness. The prosecutor responds that this person is a "confidential informant" and disclosure isn't required.

The question then becomes should the court order disclosure? The answer depends on a number of factors with the general rule being that the prosecutor and/or police are not reguired to disclose the name subject to certain exceptions.

The law in this area is based on a 1957 United States Supreme Court

What is Leap Year?

February has 29 days this year. with the extra day called Leap Day. The calendar normally has 365 days in year; however, it actually takes 365 days, 5 hours, 48 minutes and 46 seconds for Earth to complete an orbit around the sun.

The ancient Egyptians were among the first to notice the discrepancy and began adding an extra day to their calendar every four years.

Our Gregorian calendar today, named after Pope Gregory XIII, (introduced in 1582) continues to add an extra day every four years, but to be even more precise, it adds that extra day except in years evenly divided by 100, but not by 40. That means the year 2000 was a leap year, but 1900, 1800 and 1700 were not.

case called Roviaro v United States. Roviaro also was a drug case with a confidential informant. The court held that there is no fixed rule as to when disclosure of identity is required, rather it calls for balancing the public interest in protecting the flow of information against the individual's right to prepare his defense.

In determining the proper balance, the circumstances of each case must be reviewed taking into consideration the crime charged, the possible defenses, the possible significance of the informant's testimony and other relevant factors.

Subsequent case law has established that disclosure is usually required where the informant was an active participant in the charged crime or if it is shown that they could provide evidence of the defendant's innocence.

If the evidence against the defendant was personally obtained by the police or the informant was a mere tipster or introducer, disclosure isn't required.

Under Michigan law, when a defendant is able to demonstrate a possible need for disclosure the trial court should require the informant to be produced for a confidential in chambers hearing to consider all of the factors.

Looking at the facts of our hypothetical case, disclosure likely would not be required.

Important innovations by African Americans

Black inventors have changed the lives of Americans and people all over the world with myriad innovations and inventions.

Some are serious life-saving devices and others are just plain fun. These are just a few contributions of black inventors — there are many, many more.

Potato chips

These were created by restaurant Chef George Crum in 1853 in a fit of irritation. A customer complained their fries weren't crispy or salty enough, so Crum sent back what would become an unexpected hit - potato chips.

Affordable shoes

"Shoe lasting" is the process of attaching the shoe leather to the sole. It was expensive and done by hand in the 1850s. Jan Matzeliger invented a machine that tripled lasting output, thus making shoes more affordable.

Carbon filament light bulbs

Thomas Edison is credited with the lightbulb's invention, though many

worked on it at the time. Edison first tried a paper filament. It was Lewis Latimer who suggested the carbon filament, which is still used today.

Synthetic bristle hairbrush


WOMAN SAYS HUSBAND ATTACKED HER

Proving Linden's birthday ■Logo contest open to everyone, deadline March 31

Linden — Linden turns 150 years old in 2021. A 150th birthday is called a sesquicentennial, and city volunteers are in the early stages of discussing a celebration.

But first, Pete Maas, president of the Linden Mills Historical Society, has to prove the city's birthday was in 1871 to the Historical Society of Michigan (HSM).

It's harder than Maas thought.

The HSM wanted to see an article printed in a newspaper at the time of the municipality's inception. However, Linden didn't have a newspaper in 1871. Maas found an article in the Linden Leader from 1957, which stated that Linden was incorporated in 1871, "just 36 years after the first settlers pioneered here from

the East."

The article wasn't enough.

Maas submitted a diary excerpt from Seth Sadler, one of the first pioneers of Linden who came from Oakland County in 1851. He also submitted

some documents containing the history of Genesee County with Linden's information. Neither were enough.

"The biggest thing was we had to get the articles of incorporation," he said, adding that these documents aren't online anywhere. "We had to send to Lansing, to the archives of the Lansing library, to get that information. It's not even in Genesee County anywhere."

The articles of incorporation are dated March 2, 1871. If the HSM accepts the articles, Linden can apply for a Michigan Milestone Award Plaque. The HSM commemorates business organizations and municipalities with the Michigan Milestone Award Plaque for anniversaries of 50 years, 100 years and 150 years.

The money to buy the plaque would actually come from Holly.

After the 2007 fire that destroyed

the Union Block property, Linden received a letter from a group of Holly merchants who donated money to the city. Mass said the Linden Mills Historical Society plans to use the money, just more \$700, to purchase the plaque. Maas said he wants to give recognition to Holly and these businesses because, "We're all little communities close together here."

To celebrate Linden's sesquicentennial, volunteers are discussing plans for a big event. Everything is in the early development stages.

"The 150th anniversary of the incorporation of Linden will be a huge celebration. One of the first things needed is a design of a logo for this event," Maas said.






Thomas Norman James 1948-2020


Barbara Kay Church
