## ■ Family hosts public visitation, ceremony

Funeral arrangements were announced May 27 for Lexi Simon, 17, of Fenton, who died from injuries she suffered in a Waverunner accident on Lake Fenton on Sunday, May 24.

Simon had just finished her junior year

at Lake Fenton High School.

Neil Thompson, director of ministry operations at The Rock Church of Fenton, said the Simon family made arrangements for a Celebration of Lexi's Life on Saturday, May 30 at 3 p.m. at The Rock Church, 11400 Linden Rd., Fenton.

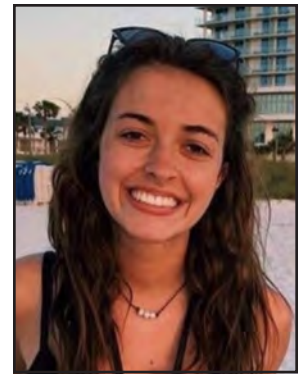
Public visitation would begin at 2 p.m. and the ceremony would begin at 3 p.m. Pastor Wes Morris will officiate.

Thompson said both the visitation and

ceremony would take place under a large, white tent on the softball field on the east side of the property.

"After carefully seeking counsel, it is our understanding that the ceremony is permitted under both the recent Presidential mandate and the religious exclusion that has been provided in Governor Whitmer's previous executive orders regarding places of worship," Thompson said.

## Officials expect revenue sharing to decrease

■ Tax revenues from state to local government will decrease due to pandemic

Due to the COVID-19 pandemic, local municipalities are expecting a decrease in revenue sharing from the state of Michigan.

Revenue sharing is the distribution of a portion of federal tax revenues to state and local governments.

The money is sent to municipalities in six payments for each fiscal year in the following months: October, December, February, April, June and August. Revenue sharing funds for the FY 2019-2020 have

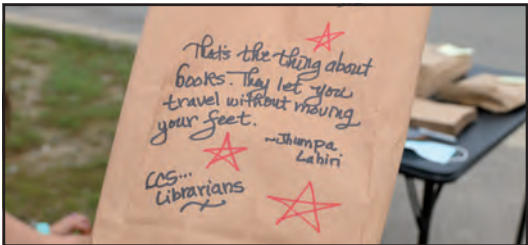

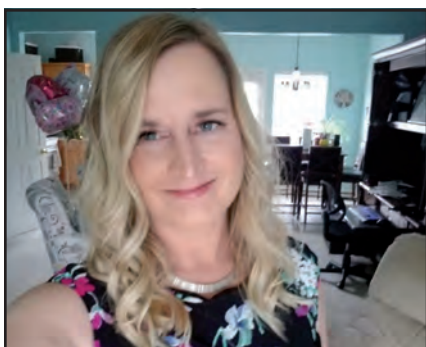

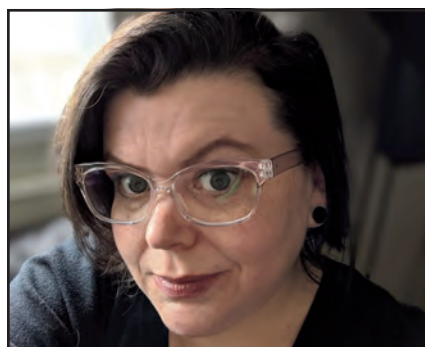

# Watercraft rules for Michigan lakes

■ Must have enough life jackets on board for everyone

With the weather warming, area lakes are getting busier and boaters can expect to see marine patrols cruising the waters.

Here's are the rules of the lake, which are set by the Michigan Department of Natural Resources:

- Kids under age 12 may operate a boat powered by a motor of no more than 6 horsepower (hp), legally without restrictions. They may operate a boat powered by a motor between 6 hp and 35 hp, if they have been issued a boating safety certificate and are supervised on board by a person who is at least 16 years old.

- People age 12 through 15 years old may operate motorboats if they are accompanied by at least one person 16 years or older, or, the person has a boating safety certificate.

- The number of people in the boat must not exceed the number of seats on the vessel.

- Don't drink and drive. Michigan law prohibits driving a boat with a blood alcohol content over .08 percent.

- Don't go near docks or swimmers. All watercraft are supposed to stay at least 100 feet away from any fixed objects, diver flags and other boats. Give swimmers a wide berth.

- Having enough life jackets for every person on board is required by law. All passengers under age 6 must wear a life jacket, and everyone tubing, skiing or riding a personal watercraft

must wear a life jacket.

- Water skiing is not allowed between the timeframe of one hour after sunset and one hour before sunrise.

- At least one person, in addition to the driver, shall be in the boat to watch the people being towed. With a driver and spotter on a two-person PWC, there's no seat for the person they're pulling if they get injured.

- The tow boat must have a 170 degree wide angle rear view mirror affixed to permit the driver to see those being towed.

- Boaters must drive counterclockwise around the lake.

- Sit in the correct spot of the boat. Pontoons have an enclosed area and passengers are not allowed on the outside front end or on the raised back area while the pontoon is moving.

- Motorboats are required to have mufflers or an underwater exhaust system so it does not produce sound in excess of 90 decibels (dB).

- Motorboats shall give way to non-motorized vessels.

- If two vessels are approaching each other head on, the operators shall pass on the left side. When overtaking a slower vessel, the operator must pass on the left side.

■ Appointment-only transactions due to COVID-19 guidelines

Secretary of State branch offices will reopen Monday, June 1 by appointment only for essential transactions not available online in order to continue to balance the need to provide critical services and protect public health.

Beginning the week of June 1, all 131 branch offices in Michigan will be open Monday through Friday, 9 a.m. to 5 p.m. for appointment-only services for transactions.

Advance appointments can be made up to 180 days ahead of time. Same-day appointments become available 24 hours prior to the appointment time.

## Two local organizations awarded \$4,000 combined

■ Fenton Community Orchestra and Fenton Arts Council eligible for portion of \$502,400 Emergency Relief Fund grants

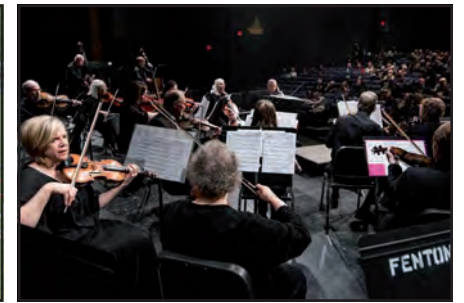
The Michigan Council for Arts and Cultural Affairs (MCACA) has awarded a total of \$502,400 in Emergency Relief Fund grants to 176 nonprofit arts and cultural organizations around Michigan to provide relief from the negative impacts of the COVID-19 outbreak, according to the Michigan Economic Development Corporation (MEDC).

Locally, the Fenton Arts Council (FAC) received a grant of \$1,000 and the Fenton Community Orchestra (FCO) received a \$3,000 grant.

Eric Szczepanski, board chair of the FCO and board member of the Fenton Arts & Culture Commission, said, "This grant will support FCO's part-time operations manager. FCO Manager Tetyana Clarke plays a vital role in ensuring continuity of FCO programming and services. Mrs. Clarke,

with the board, has been working diligently to prepare the FCO for the next orchestra season.

"Plans will include both traditional and virtual engagement opportunities pending recommendations by the state."

Sally Bright of the FAC said that the free "Arts Are The Heart" community events hosted by the FAC for the last four years have been funded by grants, sponsors and donations. These events are organized by the all-volunteer FAC to help promote all forms of art in the community.

"Due to the current pandemic, it has been difficult to procure sponsors and donations," Bright said. "The Fenton Arts Council is especially grateful as this assist will help to continue the free

community events."

New this year for the "Arts Are The Heart" series is the collaboration with local art gallery, Cause & Affect, and local artists to bring a fine art exhibit to downtown Fenton, which opens July 10 and will close Aug. 8, said Bright.

"Creative minds are forging forward to make this happen during our social distancing times," Bright said. "Reservations will be taken for daily viewing time slots and also a virtual gallery exhibit will be available.

"In addition, the Fenton Arts Council continues to plan the Aug. 15 'Arts Are The Heart' and Back to School Community Resource Fair and also an 'Arts Are The Heart Mini Maker Fair' for Nov. 7."

## Fenton Arts Council plans July art exhibit

■ Organizers will follow state guidelines for social distancing and other precautions during the pandemic

The Fenton Arts Council is planning a showcase in July at the Cause & Affect Gallery at 126 N. LeRoy St.

According to the press release, all fees are waived and participants will become a member of the Fenton Arts Council. The exhibition will run from July 10 to Aug. 8.

"This outreach is to help support artists during this difficult time when many summer events are canceling," according to the release. "Public attendance and social distancing requirements are unknown currently, however creative minds are forging forward to work out details for

our changing times. Our plan is to follow state guidelines at the time of the event."

Submission guidelines can be found [fentonartscouncil.com](http://fentonartscouncil.com). The application deadline is June 8. Application by mail must be postmarked by June 6.

This is a juried exhibit. The jury panel is comprised of three people with a diverse background and skillset, including working artists and members of the arts community at large, according to the council. Jurying will occur in May/June 2020.

Three jpeg images of the artwork must be submitted with the application.

There will be two ways to see the exhibit. The first is virtually on the Cause & Affect Gallery website and Fenton Arts Council website. The second is by appointment.

# More cancer patients to benefit from proton therapy

## ■McLaren Proton Therapy Center adds second treatment room, upgrades imaging capabilities

More people fighting cancer may receive radiation oncology treatment with superior precision. The McLaren Proton Therapy Center has opened a second cone beam computed tomography (CBCT) for better imaging prior to each treatment.

Adding an additional treatment room makes the McLaren Proton Therapy Center the largest in Michigan, and the first proton therapy center in the state to operate cancer treatments in two rooms. In addition to having two rooms operational, McLaren has developed new imaging modality, adding the CBCT in both treatment rooms.

All of this comes at a time when the number of physician referrals and self-referrals have significantly increased.

“We have an increasing demand for proton technology as we have been treat-

ing at almost capacity with one gantry room,” said Hesham Gayar, MD, medical director of the McLaren Proton Therapy Center. “Having a second 45-ton gantry room, coupled with integrated CBCT volumetric image guidance to accurately target our proton pencil beam, makes McLaren Proton Therapy Center the largest and most advanced technological center in the state.

“Patients are coming to us from all over Michigan and the neighboring states. I am glad to have the additional room to help more patients receive life-saving treatments, at the highest possible precision and accuracy of positioning to reduce side effects and improve quality of life.”

The CBCT is a volumetric imaging modality. This technology allows for six-degrees of freedom when aligning patients for treatment. This means patients are accurately aligned for treatment quicker, even in the most challenging scenarios. A traditional image guided radiation therapy uses two-dimensional radiographic images,



which do not delineate soft tissues. With a CBCT, therapists can see a more detailed image to distinguish the tumor from healthy tissue. The McLaren Proton Therapy Center is one of a few centers in the country with this technology.

“We’re at a good place, treating more patients than we could have imagined with only one room, utilizing this exceptional cancer treatment resource more efficiently” said Vahagn Nazaryan, Ph.D., executive director of the McLaren Proton Therapy Center. “While we begin treatments in the second room, we will continue to develop our center by focusing on getting a third

treatment room operational. This will allow us to treat even more patients in the future with the most advanced technologies available.”

The addition of the second treatment room allows for a more efficient workflow, and for a better patient experience. As the proton beam is being delivered to one of the treatment rooms, another patient will be positioned and prepared for their treatment in the second treatment room.

Gayar added that the McLaren Proton Therapy Center has continued operations throughout the coronavirus pandemic to ensure patients battling cancer receive their needed treatments. This further emphasizes commitment of the Karmanos Cancer Institute to serve our communities.

“Cancer doesn’t wait, even in a pandemic, so we continue our dedication to help our patients fight this disease no matter what,” Gayar said. “We continue to adhere to the most current safety measures to make sure our patients and staff are safe during this time.”

The officers searched the area and located a vehicle occupied by two individuals who were detained and questioned. While questioning the two individuals, alcohol, marijuana and what appeared to be stolen property was recovered from the vehicle.

The officers identified a third male

subject who may have been involved in the larcenies. He matched the images posted on Holly area social media, which had been captured on home surveillance systems during the crimes.

On Wednesday, May 27, Holly officers located the third suspect and obtained a confession to the thefts from vehicles.

The Holly Police Department is asking that victims of these crimes review the picture of recovered property. If this is your property, contact the Holly police department at (248) 634-8221 to come in, make positive identification, and recover your property.

Once the investigation is complete, police will submit the case to the Oakland County Prosecutor's Office for review.

not been fully paid to municipalities yet.

### Fenton Township

The estimated revenue sharing numbers for the fiscal year 2020-2021 for Fenton Township is \$1,308,237, according to the Michigan Department of Treasury. For the FY 2019-2020, the township will receive an estimated \$1,368,981.

Thomas Broecker, operations manager and deputy clerk, said using the current projections from the Michigan Treasury, Fenton Township's annual revenue would be reduced by approximately \$140,000, which is about 10 percent, from the original projections.

"While that number is significant, it is not as severe as the 'up to 50 percent' discussion that was occurring about a month ago."

The next revenue sharing payment should be a good indicator as to the accuracy of the state's projections," he said.

The Township expects a payment June 30, and this will be based on sales tax collections for the months of March and April, which were the first two months of the pandemic.

"Even if that number is close to the state's estimate, the ever-changing nature of the pandemic makes it difficult to assume that the longer range projections will be accurate," he said.

### Fenton City

In Fenton City, the Treasury estimates the full 2019-2020 payment will be \$1,042,234. The estimated 2020-2021 payment is \$996,563.

### Argentine Township

Clerk Denise Graves said they expect less revenue this year. In the 2019-2020 fiscal year, the township received approximately \$584,081, according to the Michigan Department of Treasury.

For the FY 2020-2021, the estimate is \$556,469.

"Our Fiscal Year ends June 30th, so we have only one more payment in this FY. We do expect that we will receive less for the new FY that begins July 1. Serious consideration will have to be given to our next budget year due to the state shared revenue reduction," she said.

### Linden

In Linden, the estimated 2019-2020 fund is \$355,426. For FY 2020-2021, that number is \$339,940.

### Holly Township

Clerk Karin Winchester said, "There have been projections of up to 50 percent discussed by government resources. The state has yet to update our revenue sharing estimates."

The Department of Treasury estimates the township will receive \$445,771 for the 2019-2020 FY. The estimate for the 2020-2021 fiscal year is \$424,697.

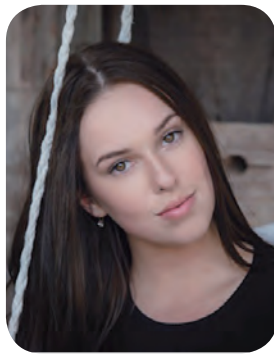

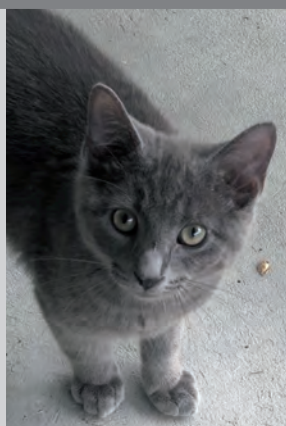

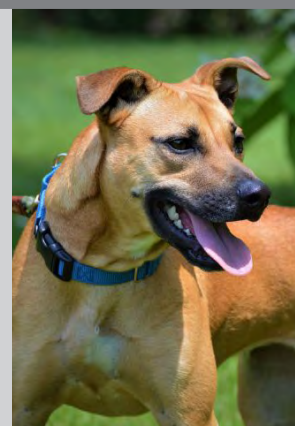

**R**emember the Neil Diamond song, “Brother Love’s Travelling Salvation Show?” “... pack up the babies and grab the old ladies and everyone goes ...” It reminds me of the old-fashioned revival meetings I’ve read about from days gone by.

If anything has been reinforced during the nationwide stay-at-home orders, it is that people want to be together and outdoors. In addition to concerts and festivals, we host graduation open houses, weddings, family reunions and many other events outside.

So I’m wondering if lo-

cal churches would consider holding outdoor services for those who wish to worship together. Maybe they will but it appears that most of our local churches have only “virtual” services scheduled. Don’t get me wrong, YouTube is a wonderful thing, but it doesn’t get people together, or outside.

Many churches have massive lawns and/or parking lots, or both. Like some parks and beaches nationwide, family circles could be created with chalk, circles that are at least 6 feet apart. Churches could ask parishioners to bring their own lawn seating or blankets. As far as the older folks and those with physical and mobility issues, an area cordoned off within earshot of the minister and music should work nicely.

Attendees would wear masks and bring their own hand sanitizer if they wish. Skip the hymnals, too many germs. Instead, the church could have that week’s song and prayer selections printed on handouts from a home computer.

It’s unlikely that anyone is going to drag the organ outside, but most churches today have instruments like the clarinova, for example, a digital piano that does amazing things. Guitars and other (non-spit blowing) instruments could work, too.

As far as communion, place the wafers (body of Christ) in a bowl with small tongs, and provide wine or juice (blood of Christ) in a tiny cup with a lid. Hey, you do it for Jell-O shots! An associate pastor and one or two church members could be charged with safely walking these items around to the people. Those individuals also could carry around the collection basket with the long-reaching handle.

Many large churches have their own, or rent, big top tents for annual picnics and festivals. These could be set up to protect attendees from inclement weather. If it storms, people can simply go home. If it’s too hot, they can use the handout as a fan.

I’ve seen some amazing planning go into local church festivals and events, and truly believe this can happen. So, if your church doors remain closed, please think about taking it outside.

That song is in your head now isn’t it? “Hallelujah!”

### **House Bill 5417: Authorize child Do-Not-Resuscitate orders**

related procedures and requirements. DNR orders apply in a setting outside a hospital, and current law does not provide for DNR orders for a minor. Under the bill, the orders would state: "I authorize that in the event the minor child's heart and breathing should stop, no person shall attempt to resuscitate the minor child. I understand the full import of this order and assume responsibility for its execution."

"In this time of COVID, we miss the kids. We miss them so much," O'Connell said. "We just wanted to put some books in their hands and tell them that we're thinking of them and that we want them to read."

O'Connell and other Linden schools librarians, including Baldwin, Marsha Strobel and Mary Ann Goodhue, all contributed by pooling funds they would have used for the Scholastic Book Fair to purchase books through Scholastic. They also received books from the Genesee Intermediate School District. It amounted to more than 1,000 books.

O'Connell organized the books into 100 lunch bags. She included about four or five books for K-2, and about four books for grades three through six.

"So many parents would say, 'oh my gosh, this is so cool, my kids were griping because they read through all their books,'" she said.

Goodhue, librarian/media aid from Linden Elementary, decorated the bags with a quote from an author or celebrity, and made homemade bookmarks.

This is the second time O'Connell has given out books. The first time was when she handed out 100 bags at the drop-off location at Linden Elementary. The librarians will give out another 100 bags at the Pine Ridge Mobile Home Park on Monday.

"I'm just really thankful to be able to do something and get them a little bit further along. Let them know that we miss them," O'Connell said.

Michael Gagne, principal of Central Elementary, also came to greet students Wednesday.

"I just want to say how proud I am that these librarians took this on themselves and just really ran with it. Kelly headed it up, and the other librarians jumped on board," he said. "They worked together and got this done. I'm extremely proud of them and happy that I get to work with such great people."

# A vegetable garden timeline

■ What to do with your garden in May, June and July

While spring was here in March, it really hasn't been safe to get your outdoor garden going until now. May 27 is the last projected frost date for the Flint area. To the south in Pontiac, it's May 25, according to the State Climatologist Office.

The Michigan State University Extension (MSU-E) has voluminous online resources for gardening, which includes a timeline for Michigan vegetable gardens.

Proper garden size depends on what's being planted. Seed packets will include information about proper spacing outside in the garden.

Here is some monthly guidance by MSU-E, with clarification added where needed:

## May

- Plant seeds of cool weather crops for the second and third times. These can include broccoli and onions, which should start indoors in planters as opposed to direct seeding. Spinach, kohlrabi and peas can be planted right into the ground.
- Thin out seedlings of crops planted earlier inside to their proper spacing. This is in case several seeds were planted indoors. If they're sprouting, they should be separated. See seed packet for distances.
- Plant warm season seeds after the danger of frost is past, including cucumbers, squash, pumpkins and melons.
- If you've been transitioning seedlings to live outdoors (hardening off), plant the hardened-off transplants of peppers, tomatoes and eggplant.
- Plant warm season crops where cool season crops have been harvested.
- Mulch around plants and in rows to keep soil moist and reduce soil compaction.

## June

- Thin vegetables seeded in May to proper spacing.
- Plant successive crops of beans every two weeks until the end of the month.
- Continue to harvest frequently as crops mature.

- Remove cool season crops as they bolt (form seed stalks). Additional plantings may be made of lettuce, spinach and radishes, which need some shade and cooler temperatures so planting them under taller crops will extend the harvest.
- Stake tomatoes for improved health and easier harvest. Remove suckers (branches that form where the leaf joins the stem) when they are 1 inch to 1.5 inches long.
- Weed the garden. Weeds compete with vegetable plants for nutrients and moisture.
- Monitor regularly for insect and disease problems and take needed control measures to limit damage.

## July

MSU-E suggests continual weeding and harvesting through July. Seedlings should also be thinned and properly spaced. Some may require hardening.

- Cover potato tubers, carrot shoulders and onion bulbs with soil to prevent development of green color. Soil or mulch may be used to keep them covered.
- After harvesting central heads of broccoli, allow the plants to produce side heads for an extended harvest.
- Garden crops can be given nitrogen fertilizer at the beginning of July. Wait until tomatoes, peppers and eggplant have set some fruit before you fertil-

ize them. Work fertilizer into soil a few inches away from the plants, then water. Do not allow the fertilizer to touch the plant stems.

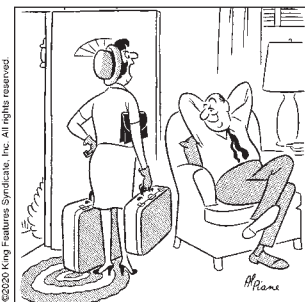

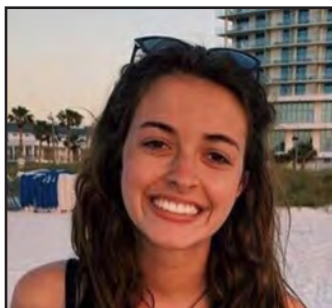

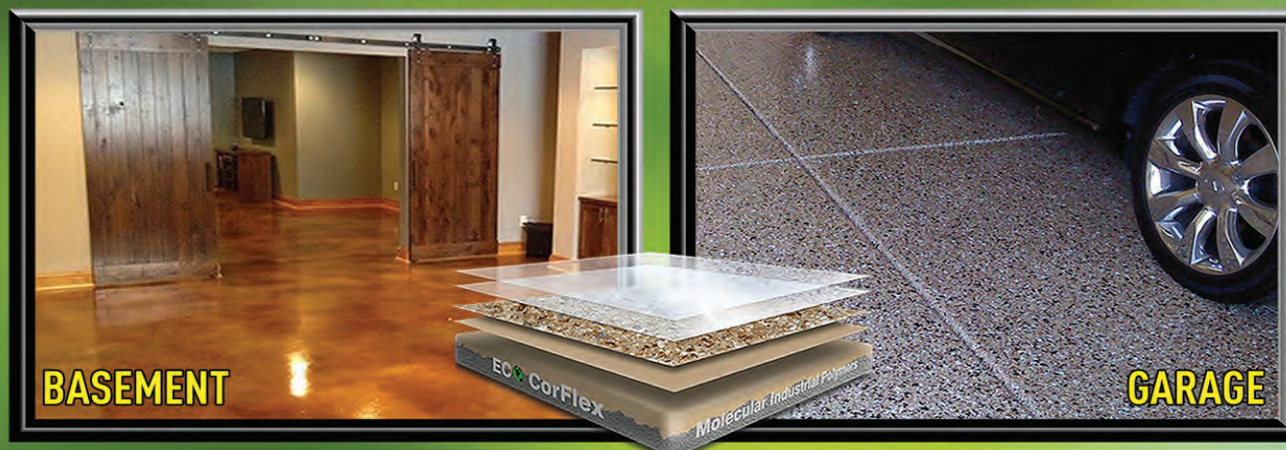
