■ Suspects flee, Fenton police chase ends on I-96 in Wixom

Two suspects are in custody following a break-in at Tractor Supply Co. off Owen Road in Fenton City

just before 5 a.m., Sunday, Sept. 13.

Fenton police responded to a store alarm at 4:52 a.m. The responding officers observed an idling box truck parked near TSC. When officers approached the truck, it began leaving the

parking area. A traffic stop was initiated to the truck, however, the truck did not stop.

Fenton police pursued the truck as it entered northbound U.S. 23 at Owen Road. The truck exited at Grand Blanc

Aerial mosquito spraying to begin today

■ Oakland County one of 10 counties impacted by confirmed cases of horses with EEE

In an effort to prevent spread of Eastern Equine Encephalitis (EEE), the Michigan Department of Health and Human Services (MDHHS) has announced plans to conduct aerial mosquito control treatment in certain high-risk areas of Michigan.

Impacted counties include Barry, Clare, Ionia, Isabella, Jackson, Kent, Mecosta, Montcalm, Newaygo and Oakland. Additional areas may be selected for treatment if new human

Teen jailed after partygoer shot in arm

■ Party swells to more than 100 young people, some from Holly, while parents out of town

A large party in Brandon Township, attended by more than 100 individuals from the cities of Flint, Burton, Clio, Lansing, the village of Holly, Brandon Township and other areas, led to a shooting in the early morning hours of Sunday, Sept. 13.

Oakland County Undersheriff Mike McCabe said multiple deputies and the Brandon Township Fire Department responded to the 1500 block of Perry Lake Road on a report of multiple shots fired outside a residence at 2:16 a.m.

More than 100 young people from the ages of 15 thru 20 years old had gathered at the residence for a party. An argument ensued between two of the groups.

A large window in the residence was

broken out by a male subject.

A 17-year-old male who resides at residence retrieved a 9 mm handgun and fired multiple rounds. An 18-year-old male from Flint was struck in the right arm and he sustained cuts from the broken glass.

The victim told deputies that he had engaged in a verbal argument with someone prior to him being shot. Two handguns were reported stolen from the residence and have not been recovered.

The victim was transported to McLaren Oakland Hospital by the Brandon Township Fire Department with a gunshot wound to his arm. He was treated and released.

Detectives arrived and began their investigation.

The suspect has been lodged at the Oakland County Jail pending issuance of charges. The incident remains under investigation. The 17 year old, whose parents were out of town, told deputies that originally 15 people were invited but someone posted the party on social media and more than 100 people showed up.

Road and then re-entered southbound U.S. 23.

The box truck traveled on southbound U.S. 23 at speeds between 65 and 70 miles per hour.

The truck entered eastbound I-96 and eventually stopped on its own east of Kensington Road near Wixom.

Lt. Jeff Cross of the Fenton Police Department said the driver, a 39-year-old man from Redford, and his female passenger, his 38-year-old wife, were taken into custody without incident.

There were no injuries to the suspects or police and no damage to the vehicles.

The couple was transported back to the Fenton police station for booking and the truck was impounded.

Cross said there was damage observed at the store and it appears that entry was gained to a secure area of the business. The investigation continues.

Neither suspect has yet been arraigned in Genesee County 67th District Court. Pending charges could include breaking and entering of a building and fleeing and eluding police. The driver also was driving on a suspended license and there is an outstanding arrest warrant against him from MSP-Brighton Post.

Cross said there are reports of recent break-ins at other TSC stores. Those incidents are under investigation and it is unknown at this time if these two suspects are believed to be involved.

In addition to Fenton police, Michigan State Police-Brighton troopers, one Livingston County Sheriff's deputies assisted with trying to pull over the truck. Linden police assisted by securing the scene at TSC.

Fenton Express Towing removed the truck from the highway.

volunteers to keep the annual fundraiser providing support for the community.

- **Virtual road race** – Much like what the Fenton Freedom Festival did and the Crim race will do, Applefest will hold




a virtual race where participants will be accountable to log their time.

Orchard hosts successful car show

■ Proceeds benefit the Cystic Fibrosis Foundation

Fenton Twp. — Mueller's Orchard "The Apple of Your Eye" Car Showcase for Cystic Fibrosis was graced with sunny weather Saturday, Sept 12 and Sunday, Sept 13.

Hundreds of attendees came out to walk through the rows of cars and booths selling craft items, and buy apples, cider and doughnuts.

Wendy Mueller, event chair, said, "Mueller's Car Showcase for Cystic Fibrosis was a far reaching success. The expansive front yard acre off Linden Road was often filled to capacity with show cars. The southeast corner was off limits to cars as it was taken over by the military display."

Approximately 150 cars were on display throughout the weekend. This included a 1972 Jaguar XKE, series 3, V-12 that was brought in on a trailer and the legendary Chevamoco Dragster Race Car built originally by NHRA top driver

"People mingled outside with lots of space and smiles. We were blessed with weather, many beautiful machines displayed with love and pride, and strong community support. People were happy and excited to be out safely with each other," she said.

The event featured a food concession

by Kiwanis, music from Throttle Up DJ services by Todd Payne, youth activities, and a free Moonwalk brought by Great Party Productions. There were raffles, arts and crafts, and the usual orchard items, such as apples, cider and doughnuts.

"Several community groups made their presence known; my Linden Presbyterian Church family. Kiwanis Club of Linden members, individual business owners and community family groups, and a strong showing from the local families living with memories of children lost to Cystic Fibrosis," Mueller said.

The legal challenges to Governor Whitmer's executive orders - Part I

On March 10, Gov. Gretchen Whitmer issued Executive Order Number 2020-4, which declared a State of Emergency in Michigan under the Emergency Management Act (EMA), the Emergency Powers of Governor Act (EPGA), and Michigan's Constitution.

As we all know, this declaration was made because of the COVID-19 pandemic.

Since the initial Executive Order, there have been more than 170 additional orders impacting many aspects of daily life in Michigan. The State of Emergency and certain limitations on activities remain in effect.

There have been a number of federal and state legal challenges to the governor's authority to issue these Executive Orders.

I won't detail them all here but suffice it to say there are two cases presently pending in the Michigan Supreme Court which could change everything.

The first was initiated in the Michigan Court of Claims by the Michigan legislature against the governor. The complaint alleged that the governor did not have statutory authority to issue Executive Orders after April 30, 2020; the EMA and EPGA are unconstitutional; and an epidemic does not constitute an "emergency" under the EPGA.

The legal argument behind the first claim is that under the EMA, there is a 28-day time limit for an emergency declaration unless the legislature votes to extend it. Since that did not occur, no other orders can enter and the State of Emergency is over.

As to the statutes being unconstitutional, the claims are that they give inappropriate unrestricted power to the governor and also give her the power to make laws as opposed to the legislature, thus violating the constitutional Separation of Powers Doctrine. This Doctrine provides that our three branches of government

■ Family and friends search for newly adopted animal that escaped Rose Township property





or animal cases occur outside of the currently identified zones.

Treatment is scheduled to occur starting the evening of Wednesday, Sept. 16. However, treatment can only take

place under certain weather conditions, so the schedule may need to change.

As of Sept. 13, EEE has been confirmed in 22 horses in 10 counties in Michigan. Additional animal cases are under investigation. This is twice as many animal cases as the same time last year.

To date, no human cases have been identified. There is an EEE vaccine available for horses, but not for people.

In order to prevent the loss of life and protect public health, MDHHS has determined a targeted aerial treatment plan is necessary. When there are high rates of animal infections, humans are just as at risk.

EEE is one of the most dangerous mosquito-borne diseases in the United States, with a 33-percent fatality rate in people who become ill. People can be infected with EEE from one bite of a mosquito carrying the virus. Persons younger than age 15 and over age 50 are at greatest risk of severe disease following infection.

More than 25 percent of the nation's EEE cases last year were diagnosed in Michigan.

"We are taking this step in an effort to protect the health and safety of Michiganders in areas of the state where we know mosquitoes are carrying this potentially deadly disease," said Dr. Joneigh Khaldun, MDHHS chief medical executive and chief deputy for health. "As people are spending more time outdoors because of COVID-19, they also need to be protecting themselves from mosquito bites."

Signs of EEE infection include the sudden onset of fever, chills, body and joint aches which can progress to a severe encephalitis, resulting in headache, disorientation, tremors, seizures and paralysis. Anyone who thinks they may be experiencing these symptoms should contact a medical provider. Permanent brain damage, coma and death may also occur in some cases.

The Michigan Department of Agricultural and Rural Development (MDARD) has issued an emergency rule temporarily amending the rule on notification and participation for community pesticide applications for aerial spraying treatment across affected counties. This means mosquito control treatment will be required for those areas that are identified by the aerial treatment plan with exception of federal properties and tribal lands.

Treatment will be conducted using Merus 3.0, the same product used in 2019. Merus 3.0 is registered with the U.S. Environmental Protection Agency and MDARD, and is labeled for public health use over residential areas. It contains 5 percent pyrethrins, a botanical insecticide extracted from chrysanthemum flowers. Pyrethrins are commonly used to control mosquitoes, fleas, flies, moths, ants and many other pests, and are approved for use in organic agriculture as well.

In general, health risks are not expected during or after spraying. No special precautions are recommended; however, residents and individuals who have

known sensitivities to pyrethrins can reduce potential exposure by staying indoors during treatment. Aerial treatment is not expected to have any impacts on surface water or drinking water.

To reduce the potential for people to be bitten by mosquitoes, MDHHS is

continuing to encourage local officials in the affected counties to consider postponing, rescheduling or canceling outdoor activities occurring at or after dusk, particularly activities involving children until the first hard frost of the year.

How to protect yourself from mosquito bites:

- Avoid being outdoors from dusk to dawn when mosquitoes carrying the EEE virus are most active.
- Apply insect repellents containing the active ingredient DEET, or other EPA-approved product to exposed skin or clothing.
- Wear long-sleeved shirts and long pants when outdoors. Apply insect repellent to clothing to help prevent bites.
- Maintain window and door screening to help keep mosquitoes outside.
- Empty water from mosquito breeding sites around the home.
- Use nets and/or fans over outdoor eating areas.

It is also claimed that the EPGA has no time limit for emergencies, which could result in an endless State of Emergency, and the word "epidemic" is not a listed emergency in the statute thus making the original declaration invalid.

The governor denied all of the plaintiffs' claims.

The Court of Claims and the Michigan Court of Appeals agreed with the plaintiffs on the first claim but upheld the governor on the rest and confirmed the validity of the EPGA.
