

FBI foils conspiracy to kidnap Gov. Whitmer

■ At least six men arrested for alleged plot, seven more men of 'Wolverine Watchmen' also charged with related crimes

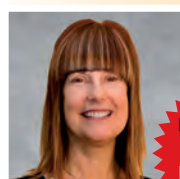

The FBI and Michigan State Police (MSP) are investigating a conspiracy to kidnap the Gov. Gretchen Whitmer.

The FBI relied on information provided by confidential human sources (CHS) and undercover employees (UCE) over several months.

The evidence set forth in the affidavit demonstrates probable cause to issue a criminal complaint charging **Adam Fox, Barry Croft, Ty Garbin, Kaleb Franks,** See **KIDNAP** on 25

FBI agents executed a search warrant Wednesday night at a property near Lansing Avenue in the Hartland Meadows manufactured housing community, off M-59 between Pleasant Valley Road and Tipsico Lake Road. The raid was caught by a neighbor on video, which was posted to YouTube.

Statewide proposal on ballot

■A ‘yes’ vote supports making changes to how revenue in the state’s park-related funds can be spent, and more

Voters in Michigan will cast their Nov. 3 ballot on a statewide proposal called Proposal 20-1.

This proposed constitutional amendment would allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities. It also would describe how money in those state funds can be spent.

This proposed constitutional amendment would:

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund

Celebration set for Oct. 14

■Community invited to LAFF Pathway ribbon-cutting at Linden’s Central Elementary

A ribbon-cutting ceremony and grand opening of the long awaited Phase 1 of the LAFF Pathway will be held Wednesday, Oct. 14, at 12 p.m. (rain or shine) beside the pathway at Linden’s Central Elementary School entrance (7199 W. Silver Lake Rd., Linden).

The public and media are invited to attend. A short program will precede the actual ribbon-cutting ceremony, with comments from representatives from Argentine Township, the Michigan Trails and Greenways Alliance (MGTA) and LAFF Pathway.

The 2.1-mile pathway was designed by Fleis & VandenBrink Engineering and starts at Haviland Beach Drive and Lobdell Road, traverses through the Linden schools’ campus to Silver Lake Road and then continues east on Silver Lake Road, through Fenton Township and connects into the existing city of Linden’s sidewalk and bike lane.

The trail construction began June 15 and was completed a few weeks ago. Already, many residents and visitors alike

are using the pathway for non-motorized transportation, walking, biking, running and exercising the family dog.

This \$1.4-million project was a joint effort from federal, state, local and private dollars. This pathway provides a safe route for school children to walk or bike to and from school and brings outside visitors to the area.

The Argentine pathway segment is the first of two phases of development along Silver Lake Road in southern Genesee County. The second phase of the pathway development along Silver Lake Road will pick up at Triangle Park in the city of Linden and traverse east on the south side of Silver Lake Road, through Fenton Township and end at Jennings Road in the city of Fenton.

Fundraising efforts are ongoing at this time to leverage state and federal grants for Phase 2. When Phase 2 is completed, the pathway will provide non-motorized transportation and recreation opportunities and connect all four communities — Argentine Township, city of Linden, Fenton Township and the city of Fenton.

A message from the superintendent

As Bronchos United, we continue facing the immense challenges of the new school year head-on.

At the same time, we must also plan ahead to continue preparing all Bronchos for careers and the real world. That's why voters in the Holly Area Schools district will see our non-homestead millage operating proposal on the Nov. 3 ballot.

If passed, our proposal will help Holly Area Schools continue providing a safe learning environment for all students, teachers and staff. 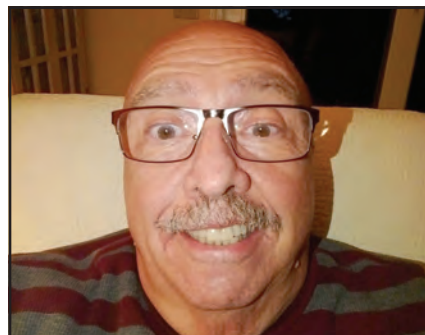

The Secretary of State's Office, however, encourages voters to get registered ahead of time. A good place to start the registration process is the Michigan Voter Information Center and can be found at mvi.sos.state.mi.us.

HOW DO I GET AN ABSENT VOTER BALLOT?

Your request for an absent voter ballot must be in writing and can be submitted to your city or township clerk. Local clerks' offices are listed in the Tri-County Times 2020 Sourcebook. You must request an absent voter ballot by mailing the application, large print application, a letter, a postcard, or a pre-printed application form obtained from your local clerk's office. Requests to have an absent voter ballot mailed to you must be received by your clerk no later than 5 p.m. the Friday (Oct. 30, 2020) before the election.

Once your request is received by the local clerk, your signature on the request will be checked against your voter registration record before a ballot is issued. You must be a registered voter to receive an absent voter ballot. Requests for absent voter ballots are processed immediately. Absent voter ballots may be issued to you at your home address or any address outside of your city or township of residence.

After receiving your absent voter ballot, you have until 8 p.m. on election day (Tuesday, Nov. 3) to complete the ballot and return it to the clerk's office. Your ballot will not be counted unless your signature is on the return envelope and matches your signature on file. If you received assistance voting the ballot, then the signature of the person who helped you must also be on the return envelope. Only you, a family member or person residing in your household, a mail carrier, or election official is authorized to deliver your signed absent voter ballot to your clerk's office.

HOW DO I REGISTER TO VOTE ON ELECTION DAY?

You can register to vote and vote in person on Election Day at your city or township clerk's office (not the poll-

You can register at any time up to 8 p.m. on Election Day (Nov. 3) at your city or township clerk's office.

If you're registering another way, in order to vote in the Nov. 3, 2020 election, your completed voter registration application must be received or postmarked by Oct. 19, 2020.

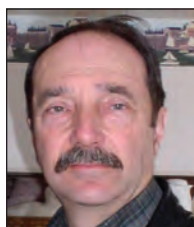

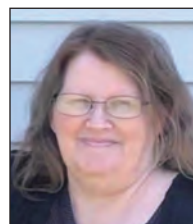

2029. The .35 mills is equal to 35 cents per \$1,000 of taxable value.

The millage, if approved and levied, will generate approximately \$22,026,860 in 2020.

The purpose of the millage is to improve, operate, and maintain parks, open space and water areas, trails, and recreation facilities; to allow for free day-use park admission for seniors (62 and over), military, veterans, and residents with permanent disabilities; to expand trails; to enhance local recreation programs; and to increase environmental conservation and recreation activities. Revenue from this millage will be disbursed only to the Oakland County to be used solely for the purpose of funding the Oakland County Parks and Recreation Commission with external audits and oversight by the Oakland County Board of Commissioners.

BALLOT LANGUAGE

Village Charter Amendment

Shall section 3.4 of the Village Charter, which calls for the President and each council member to receive as compensation for his/her services to the Village the sum of \$900 be amended to read as follows: 3.4 Compensation of members of the Council. Each member of Council shall receive as compensation for his/her service to the Village a sum of \$2,000 beginning November 2022, when each current Council term has expired. The Village President shall receive as compensation for his/her service, the sum of \$2,500 beginning November 2020. Such salaries shall be payable annually as determined by the Council and shall constitute the only salary or compensation which may be paid for services performed by the President or any Council Member for the discharge of any official duty for or on behalf of the Village during their term of office. Upon prior authorization of the council, reasonable expenses may be allowed when actually incurred on behalf of the Village. Until November, 2022, each member of Council shall receive as compensation for his/her service to the Village a sum of \$900 per year.

Holly schools asks for millage renewal with .5 mill increase

■ Voters in school district will decide at Nov. 3 election

By Sharon Stone

Holly Area Schools are asking voters in the school district to approve an operating millage proposal at the Nov. 3 election.

If approved, this millage would allow the school district to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation

allowance and restores millage lost as a result of a reduction required by the "Headlee" amendment to the Michigan Constitution of 1963.

If approved, the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Holly Area Schools district, be renewed by 17.9047 mills (\$17.9047 on each \$1,000 of taxable valuation) for a period of 10 years, 2023 to 2032, inclusive, and also be increased by .5 mill (\$0.50 on each \$1,000 of taxable valuation) for a period of 12 years, 2021 to 2032, inclusive, to provide funds for

operating purposes. The estimate of the revenue the school district will collect if the millage is approved and .0953 mill of the additional .5 mill is levied in 2021 is approximately \$4,323,146. This is a renewal of millage that will expire with the 2022 tax levy and the addition of millage to restore millage lost as a result of a reduction required by the "Headlee" amendment to the Michigan Constitution of 1963, which will only be levied to the extent necessary to restore that reduction).

Daniel Harris, and **Brandon Caserta** with conspiring to kidnap Whitmer. Fox, Garbin, Franks, Harris and Caserta are residents of Michigan, and Croft is a resident of Delaware.

The affidavit was filed hours after a team of FBI agents raided a Hartland Township home Wednesday. Federal agents executed a search warrant Wednesday night at a property near Lansing Avenue in the Hartland Meadows manufactured housing community, off M-59 between Pleasant Valley Road and Tipsico Lake Road. The raid was caught by a neighbor on video, which was posted to YouTube.

Michigan Attorney General Dana Nessel said it was one of several raids that were carried out across the state, including in Grand Rapids, Luther, Canton, Orion Township, Waterford, Belleville, Milford, Cadillac, Shelbyville, Plainwell, Zeeland, Munith, Ovid, Kalamazoo, Charlotte, Clarkston, Sterling Heights and Shelby Township.

In early 2020, the FBI became aware through social media that a group of individuals were discussing the violent overthrow of certain government and law-enforcement components. Among those individuals identified were Croft and Fox. Through electronic communications, Croft and Fox agreed to unite others in their cause and take violent action against multiple state governments that they believe are violating the U.S. Constitution.

On June 6, Croft, Fox and approximately 13 other people from several states gathered in Dublin, Ohio. The group talked about creating a society that followed the U.S. Bill of Rights and where they could be self-sufficient. They discussed different ways of achieving this goal from peaceful endeavors to violent actions.

At one point, several members talked about state governments they believed were violating the U.S. Constitution, including the government of Michigan and Governor Gretchen Whitmer. Several members talked about murdering “tyrants” or “taking” a sitting governor.

As part of that recruitment effort, Fox reached out to a Michigan based

militia group.

On June 14, 2020, a CHS participated in a consensually recorded telephone call with Fox, who described the meeting in Dublin, Ohio. Fox said he needed “200 men” to storm the Capitol building in Lansing, Michigan, and take hostages, including the Governor. Fox explained they would try the Governor of Michigan for “treason,” and he said they would execute the plan before the November 2020 elections.

On July 27, Garbin told a CHS and others that he did not want to go after the Capitol. He said he was “cool” with going after the Governor’s vacation home, however, even if it only resulted in destruction of property.

On July 28, Fox posted the following to a private Facebook page: “We about to be busy ladies and gentlemen ... This is where the Patriot shows up. Sacrifices his time, money, blood sweat and tears ... it starts now so get ... prepared!!”

On Sept. 12, while driving from Garbin’s property to Cadillac to bring others to the property, Fox told a CHS and another individual that the vacation home is the Governor’s actual house, “And it’s a perfect ... setup. Out of everywhere that she resides, this is the only one that’s probably actually feasible with a success rate.”

FBI’s review of recent encrypted group chats indicated that, in preparation for their plan to kidnap Governor Whitmer, Fox, Garbin, Harris, and

Franks planned to meet with a UCE on Oct. 7, to make a payment on explosives and exchange tactical gear. Caserta said he could not attend because he will be at work. Croft had returned to Delaware and is not available for this exchange.

On several occasions, Fox had expressed his intention and desire to kidnap Governor Whitmer before November, 3, 2020, the date of the national election.

During a press conference Thursday afternoon, Oct. 8, Nessel said charges are pending and the investigation is ongoing.

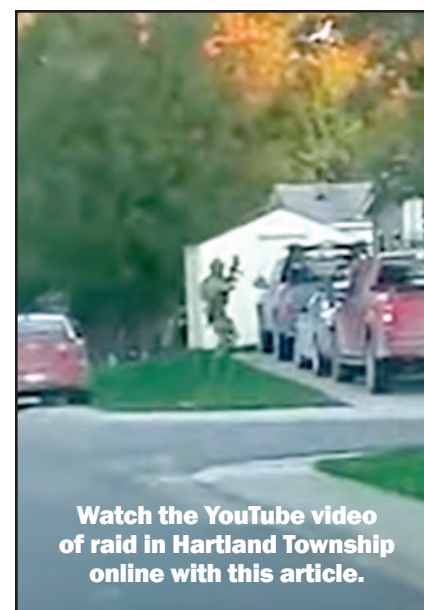
Andrew Birge, U.S. Attorney for Western Michigan, said the arrests of the individuals took place Wednesday evening, Oct. 7, while the groups was

meeting on the west side of the state.

If the individuals are found guilty as charged they face any number of years up to life in prison. “We must make sure violent extremists are never successful,” Birge said.

Birge said the FBI became aware of the plot through postings on social media. In their alleged plot to kidnap the governor, he said they used encrypted platforms and code words, as well as coordinated surveillance of the governor’s vacation home.

Nessel said there also charges pending against another seven individuals linked to the group, “Wolverine Watchmen” using the anti-terrorism act. These charges, too, are pending and may change.

Voters in the Linden Community Schools District will be asked Nov. 3 to vote on a \$55 million millage proposal. The money would go to enhancing school safety and security, enhancing the instructional environment, remodeling, building a new athletic building near the Linden Middle School area, and more.

The district has approximately 3.9 mills in existing bonds, and 1 mill would be added in 2020, totaling 4.8 mills. The maximum number of years for the bond is 25 years, and the increase is estimated to raise \$55 million.

One of the questions often asked during the job interviews I had in previous years was, "Where do you see yourself in 10 years?" That's a pretty easy question to answer when you're a young person with big plans and somewhat of a timeline for your life — or at least it used to be.

Today, that's not as easy for young people as it was for me when I was their age. It is for that reason I am appealing to young voters to do themselves a critical life favor and vote on Nov. 3. Your futures will depend on it.

When I was the age of today's millennials, I had a good job, my own apartment, nice clothes, my own car and the ability to go on some nice vacations (thanks to second, part-time jobs). I was able to afford good times with my friends about once a week, go to the movies and concerts when I wanted to, and generally not worry about much. My dreams for the future included getting married, owning a house, having children and traveling, and that happened.

I honestly don't know how young people today do it. The majority of millennials I know are earning somewhere between \$12 and \$15 an hour, if they're lucky. And these are college-educated kids. That shakes out to be just over \$400 to \$500 a week after taxes, or \$1,600 to \$2,000 per month.

The average rent in our local communities is around \$900 per month for a one-bedroom apartment, according to apartments.com. Two bedrooms will cost around \$1,200 or more. This usually does not include

utilities so that's an add-on.

Then there's the cell phone bill, the car insurance bill, the health insurance cost, food and other monthly necessities, and last but not least, the monumental student loans many young people are saddled with paying. I've heard some are as high as an outrageous \$300 to \$500 a month.

It's impossible and this is the reason many millennials still live with their parents and likely will for several more years to come. Through no fault of their own, they have been priced out of independent living and the ability to even think about getting married, buying a house and having children. Ask any local school superintendent what the financial picture of their district will look like in five years with a greatly reduced number of "butts in seats."

My point is that this year more than ever, millennials have a strong reason to vote in the upcoming election. I know the drill because I used to say it, too. "I don't like either of the candidates so I'm not gonna bother." But that's wrong. You're not just voting for one person. You're voting for that person's potential executive team and administration, and more importantly, which party will have control over the U.S. House of Representatives and Senate. The President does not alone decide on things that will affect your future.

If young people want a better life in 10 years they can do something about it today — get out and vote. Your future depends on it. Just sayin'!

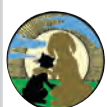

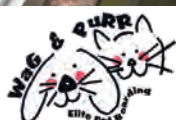

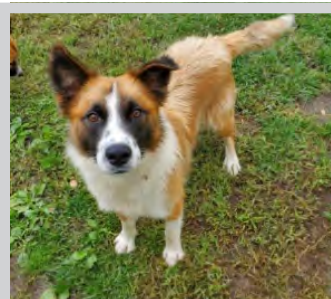

Eagles capture co-league crown, gun for outright championship Monday

Lake Fenton — The Linden varsity boys soccer team are at least co-Metro League champions.

The Eagles earned that position by beating the Lake Fenton Blue Devils 5-0 on Wednesday at Lake Fenton High School. With the win all Linden needs to do in order to get an outright championship is tie or beat Goodrich at home on Monday. The Eagles earned a three-way tie for the title with Goodrich and Fenton a year ago.

Linden is 10-0 in league play and have outscored league teams by a combined 49-7 margin. Yet, Linden varsity boys soccer coach Kevin Fiebertz still thinks his Eagles can still play better, a tune he's sung a few other times this fall. He knows what will be the key to Monday's game.

left in the opening half. At that time Devin Nowak scored the first of his two goals when he put his own rebound back into the net for the Eagle's second goal.

The lead grew to 3-0 before halftime when a cross from Bishop Lawrence resulted in a shot by Hunter Hall. The initial shot was saved, but Hall put in the rebound. Linden's first goal was provided by Lawrence early in the contest.

The Eagles locked up the victory with two more goals in the second half. Nowak scored his second goal of the game with 37:14 left in the contest. The final goal came with 4:56 left when Brendan Johnson took a lead pass and scored.

In defeat the Blue Devils (4-5-1 in the Metro) fought hard.

"I am so proud of them," Lake Fenton boys soccer coach Sam Jawhari said.

"Having a home escape plan is an important aspect of fire safety, especially for families with children," said Sean Caldwell, a fire prevention specialist at the Fenton Fire Department. To make a home escape plan, use a piece of paper and draw a top down view of your home. Make sure to include doors and windows. Talk to your family about two ways out of every room and draw lines to get out of rooms and the home. Because of COVID-19, Fenton Township Fire Chief Ryan Volz said they are keeping the public out of the stations for their safety and for the safety of the residents.

“We just ask that all of our residence check the batteries in their carbon monoxide and smoke detectors,” he said.

If residents have an extinguisher, make sure it is at 100-percent charge. If anyone has a wood burning fireplace and it hasn’t been cleaned or inspected to have that done.

“Doing a lot of these things don’t only keep them safe, it saves us from having to make an unneeded response to their home for a false alarm,” Volz said.
