Voters renew \$1.86 monthly 9-1-1 surcharge

Five-year surcharge passes by vote of 26,428 to 16,867 in special election on May 4

By a vote of 26,428 (61.04 percent) to 16,867 (38.96 percent), voters in Genesee County renewed the monthly 911 surcharge of \$1.86 on landline, wireless, and voice over the internet protocol (VoIP) service users within the county during the special election Tuesday, May 4.

According to the Genesee County Clerk, the unofficial results show that 43,458 of the 343,074 registered voters in Genesee County voted in the election. This is a 12.67-percent voter turnout.

Mental Health Millage passes

■With 12.67-percent voter turnout, millage passes by vote of 23,636 to 15,507

By a vote of 23,636 (54.79-percent) to 15,507 (45.21-percent), citizens in Genesee County passed the proposed Genesee Health System Community Mental Health Millage on Tuesday, May 4.

Voter turnout in Genesee County was 12.67 percent.

Genesee Health System is a behavioral health organization set up under state law to serve the mental health needs of Genesee County.

The measure will add a new 0.94-mill property tax on Genesee County residents to be in place until 2030. It's expected to raise \$9.5 million in the first year. See MILLAGE on 16



Daily vaccinations slowing down

■Vaccine hesitancy may be a factor; check county site for daily walk-in vaccination clinics

Genesee County has enough vaccines to meet the demand, and officials are reporting that the number of daily vaccinations is slowing down.

Ashley Herbig, emergency preparedness coordinator at the Genesee County Health Department, said, "Vaccine distribution is experiencing a decrease in recipients at this time. A number of factors can contribute to the decline that is being experienced in other areas and not just specifically Genesee County."

As of Thursday, May 6, 250,563 vaccines have been administered in Genesee County, with 146,881 first shots. Approximately 44 percent of eligible people have received one dose, and 31 percent are fully vaccinated.

Capt. Richard Cronkright from the Genesee County Sheriff's Office said the number of people coming to vaccine clinics has been decreasing.

On April 1, the vaccine dashboard showed 160,180 vaccines administered in the county. That number was 167,127 on

April 2, which is an increase of approximately 7,000 vaccines in one day.

From May 3 to May 4, the daily number of vaccines administered rose

from 243,144 to 244,868. This is an increase of 1,724 in one day, which is one of the smallest daily vaccination numbers in the county since vaccines have become widely available.

On Saturday, May 1, they held a vaccination clinic at Flint Northwestern High School, and he said it was "very slow." "At this point, we have more vaccines than we have people in seats getting the vaccine. I don't know if we just reached the threshold where the people who wanted it have gotten it" or if the pause with the Johnson & Johnson vaccine scared people off, he said.

"We would like to see more people vaccinated," he said, adding that the sheriff's office is supporting the GCHD in vaccination efforts.

The front of the coronavirus page of the Genesee County Health Department states, "With vaccine supply increasing, we are no longer using a pre-registration process. We are now offering walk-in, NO APPOINTMENT NEEDED, vaccination clinics."

Go to gchd.us/vaccinescheduler/ to find daily locations to get a vaccine.

Herbig said lack of vaccines is not an issue anymore.

"Vaccine hesitancy may be a contributing factor to a decrease in administration rates, however, we are in the understanding that this is not the only factor being considered. There is always the potential for conversations on educational campaigns to promote vaccine awareness so that individuals will be encouraged to opt into vaccination based on their specific circumstance," she said. "Public perception of vaccination is a fluid element that we remain aware of considering current circumstances and guidelines."

The GCHD is prepared to administer vaccines to anyone age 12 and up as well.

"We await confirmation from the CDC, ACIP, and MDHHS on immediate steps upon approval," Herbig said.

Gaines Township to disband police department

Millage fails by vote of 1,223 to 594 in Tuesday's election

Irocha@mihomepaper.com **Gaines Twp.** — Gaines Township voters have pulled the plug on the township police department.

The small, rural department had been on life support since funding dried up March 31, the end of the previous fiscal year. The only hope of survival was the request for 0.89 mils, which failed by a vote of 1,223 to 594 with just less than a third of the 5,558 registered voters casting ballots in Tuesday's election.

"Everything went down here," said Treasurer Diane Hyrman. "The 911 millage (and) mental health (millage) was voted down in our township. At least we got protection from mosquitos. But we won't have any police in our township."

A request for a \$35 per-property assessment to pay for mosquito control passed by a vote of 950-862.

Gaines Township voters opposed the Genesee County mental health millage by a vote of 1,175 against to 619

in favor, and the county 911 surcharge, by a vote of 929 against and 885 in favor. Countywide, both of those millages passed.

Police funding has long been a source of division among township residents.

"That is ridiculous," one township resident said of the election results. "I couldn't believe

all the 'no taxes' signs. Of course, tax dollars pay for police. Now we have none. Fools."

"We might as well put out an ad to every stinking thief in the surrounding area, we now will have no local police protection," another township resident commented. "To those who are complaining of higher taxes, Gaines Township is one of the lowest-taxed townships in the county."

"The people of Gaines Township have spoken again," said resident Melissa Neal. "Most would agree, we would be

willing to approve a restructured police department with an actual police board separate from the township board to monitor the new department."

The five-year police millage would have raised about \$179,000 in the first year to maintain the local department on a shoestring. Previously, the township had funded the agency via a 0.5mil levy, which raised about \$90,000 in its final year. The millage expired in December 2019.

The township supplemented the police budget with money from the general fund. But with no millage, and rising expenditures in other budget categories, there was not enough

money left over to keep the department going.


The three part-time officers turned in their badges, guns and protective gear April 1, and Chief Mark Schmitzer stayed on part time to "keep the department on life support" pending the election.

Now, Schmitzer will help the township liq-

uidate the police assets. Open cases will either be wrapped up in the next few months or turned over to the state police. The township may incur some costs if the former officers have to appear in court on any of the open cases.

In the moments after the final votes were counted Tuesday night, Hyrman remarked, "Tomorrow, we will have to announce at our meeting that the police department is going to be disbanded. We have no police in Gaines Township. We're not happy, but what are we going to do?"

Voter turnout low in May 4 election

Stats show local voters support 911 surcharge, vote 'no' on mental health millage

Voter turnout was low in the Tuesday, May 4 election.

All four local municipalities in Genesee County supported the 911 Surcharge proposal, which funds county 911 operations. Although the Genesee County Mental Health millage passed countywide, the majority of local residents who cast a ballot voted no.

Professional photographer runs workshop for elementary and middle school students

The public can view photography by Linden Community Schools' students at local businesses in downtown Linden from May 8-14.

businesses if they would mind if we put pictures in the windows of their business so our students and their families could walk through town and see the exhibit. Hence, the Walk Around Town Photography Exhibit. Every business we asked said yes. This brings people into town and our students get their work observed from not only family but anyone walking through town," Brindle said.

These ratings come from a 2020 PASER study, which stands for Pavement Surface Evaluation and Rating. The system rates paved roads on a 1-10 scale with a rating of 10 being the best. It's used by municipalities and road commissions across the state.

BACKGROUND

As previously reported in the Times, Holly Village Manager Jerry Walker, said, "The village owns a 40-acre parcel of property off Falk Road in Holly Township in which nine of the 40 acres was used as a municipal landfill.

"The landfill was closed in 1970, 50 years ago, and has not been used since except for a short time period in which it was used to burn brush from tree trimming in the village," Walker said. "In 1994, the village studied the former landfill site at which time Geo Environmental, who were consultants, conducted testing and submitted a report to the village which was sent to the State of Michigan DEQ (now referred to as EGLE). At the time of the testing, there were not significant findings and the dump remained closed and was not used.

Holly Township Supervisor George Kullis had previously said the township no longer has a say in the matter. "We are left out of the loop because Michigan has a mobile home commission," he said.

Today, the Holly Hills owner, Meritus Communities, Inc., plans to bring 191 more homes and 618 more paved parking spaces into the park. Phase II will cover 36 acres of the park.

Several neighboring property owners are concerned about the safety of the wells and drinking water in the township, the increase in traffic on Falk Road, the additional burden on Holly Area Schools and taxes.

BASIC INFORMATION ON PFAS

The surcharge funding is used to run the total operation of the Genesee County 911 Dispatch Authority. They are 100-percent funded by the surcharge and this is the only source of income for 911 emergency call answering and dispatch services within Genesee County, including our facilities, equipment, maintenance and operating costs.

This fixed \$1.86 rate was set in 2017 by a vote of the residents of Genesee County and accepted by the State of Michigan.

Genesee County 9-1-1 Dispatch Authority represents 31 local units of government and dispatches for all EMS, fire and police agencies within Genesee County with the exception of Fenton City. The city of Fenton has its own 9-1-1 Dispatch Center that

dispatches EMS, fire and police within the city of Fenton.

This would raise in the first year an estimated \$9,595,118 to be used as follows: 100 percent shall be allocated to the Genesee Health System for mental health crisis, stabilization and prevention, and to meet mental health needs in an appropriate setting, thus reducing the burden on jails and improving care of all Genesee residents who seek help.

In Genesee County, local authorities, including Fenton and Linden cities, capture and use for authorized purposes tax increment revenues from property taxes levied by the county. Such captured revenue would include a portion of this proposed millage levy. The total amount of captured tax increment revenues from the proposed millage levy in the first calendar year of the levy is estimated to be \$298,584 countywide.

Dan Russell, the CEO of the Genesee Health System, said, "On behalf of my colleagues and our Board of Directors of Genesee Health System, we would like to thank the voters of Genesee County for their support in passing the Community Mental Health Millage today. The passage of the millage today will go a long way toward working with law enforcement and providing training for dealing with residents who are suffering from

"We will be organizing community based teams around the seven focus areas seeking input from on the needs and following best practices by those in the field."

Genesee County is now the sixth county in Michigan to provide millage support for mental health services. The other five counties include Ingham, Eaton, Jackson, Hillsdale and Washtenaw.







The Lake Fenton varsity softball team opened the season with a doubleheader sweep of Corunna on April 15.






