■ Historic structure renamed after donations and restoration

Linden — The Linden Gazebo and park is now called the Kimble-Sharp Gazebo & Park.

Linden Mayor Danielle Cusson made the announcement Saturday, July 17 during the dedication for the city to receive the Michigan Milestone Award for reaching 150 years of incorporation.

Roger Sharp, CEO and founder of Sharp Funeral Homes, and Joe Kimble, Emeritus Professor at WMU–Cooley Law School, donated the money to make the Linden Gazebo restoration possible. They made the donations to honor their parents.

"The gazebo and waterwheel were restored in 2021 with generous support provided from Joe Kimble and Roger Sharp in honor of their parents, Ralph and Marge Kimble and Ken and Opal Sharp. Without their support, this project would not have been possible," Cusson said.

Both Sharp and Kimble grew up in Linden and spoke at the ceremony about the impact the city had on them and their families.

committee. The slogan was 'control our destiny.' According to an article in 'The Independent,' he was asked to chair the public meetings because of his "amiable personality." And later in the '80s, Mom

served on the charter-drafting commission. So they, along with many others, brought that to a successful vote in 1988, and Linden

Southern Lakes Parks & Recreation, Street Experience and more

outhern Lakes Regional Parks & Recreation is a collaborative effort between the city of Fenton, Fenton and the city of Linden, whose mission is to establish, maintain and operate a system of parks, recreation facilities and programs that enhance the education, physical health, and social interactions within the communities.

In 1993, the city of Fenton, Tyrone Township, Fenton Township and Fenton Area Public Schools came together to form "Tri-County" Parks & Recreation after the need was identified to establish a consolidated summer recreation program that incorporated municipal funding, grants, local parks, school facilities and existing community education programs. By 1999, the success of Tri-County Parks & Recreation programs created the incentive to launch a year-long series of town hall meetings and strategic study sessions to solidify plans for a year-round operation.

In November 2000, the townships

of Tyrone, Fenton and Argentine, and the cities of Linden and Fenton, acting under the authority of MCL Act 312, put the idea to a vote of the people, a perpetual millage proposal of .4 mils to operate a year-round Metropolitan Parks & Recreation District. The millage passed in the cities of Fenton. Linden and in Fenton Township and failed in the townships of Argentine by 67 votes and Tyrone by 150 votes. In December of 2000, the newly formed SLPR was established as a year-round Charter operation, the first of its kind in Michigan.

Fast forward to today, 21 years later, SLPR is alive, well and successful, operating under a Board of Commissioners composed of two representatives from Fenton, Fenton Township and Linden, an executive director, and staff of eight professionals, enabling 75 instructors to bring programming to the youth, adult, and seniors of our communities. Programs are held in our partner schools, gymnastics, swim, dance, fitness, multiple sports and skills camps, summer camps, art, drivers education, and more. SLPR continues to look toward additional programming and invites you to share your ideas with them.

Staying flexible through multiple office locations, SLPR has been able to move around as office and program space allows, with its office now at the Fenton Community & Cultural Center, programming in all schools districts and a growing presence in outdoor programs and recreation. SLPR works with its partner municipalities, overseeing farmers markets, engaging in special events including Back to the Bricks Tune Up Parties, two upcoming concerts in the park in Fenton, and a Veterans and First Responder event for later this summer in Linden. SLPR's contracting with the Genesee County Parks Board for the operation of Deer Run Soccer Park, participating on the advisory Board for the Thompson Road Regional Dog Park, and partnering with The State Bank Trail

Fenton Township passes emergency plan

■Plan outlines which agencies would coordinate resources during a disaster

The Fenton Township Board of Trustees voted to approve a support operations plan on Monday, July 19.

The board was required to pass a new plan because the other plan, dated May 17, 2019, was signed by former supervisor Bonnie Mathis. The state requires any jurisdictions with a population greater than 10,000 must have a plan signed by the current chief executive official. The township was required to update the plan in order to be eligible for financial assistance under Section

19 of Public Act 390.

Section 19 assistance is funding, or direct state assistance that may be provided to eligible counties and municipalities when the governor determines that local efforts to protect the health and welfare of the public have been exhausted as a result of a disaster event, according to a letter from Jeff Wilson, emergency management coordinator of Genesee County.

This plan, developed by key departments including law enforcement, fire, public works and public heath, outlines how Fenton Township will handle emergency situations in cooperation with the Genesee County Emergency Management Program in coordination

with the county's emergency operations plan (EOP). The goal is to save lives, reduce injuries and preserve property.

Different agencies are assigned different roles

In the plan, Supervisor Vince Lorraine is assigned the tasks of direction, control, coordination and public information. Spring Tremaine of Genesee County 911 has the role of communications and warning.

Julia Wilson, township assessor, is assigned to damage assessment, Fire Chief Ryan Volz is in charge of fire services, and Undersheriff Michael Tocarchick is in charge of public safety and law enforcement.

The following responsibilities have

been assigned to each organization:

- A. Assist in the development, review and maintenance of Support EOP and County EOP.
- B. Report to the local EOC when activated for scheduled exercises or emergencies.
- C. Build capabilities and develop/maintain SOPs for specific functions or actions identified in the plan. Continuously review and update procedures.
- D. Maintain a list of resources available through the departments.
- E. Establish MAA/MOUs and contracts with other jurisdictions and organizations to supplement municipal resources.
- F. Activate MAA/MOUs and contracts with other organizations to supplement response activities when local resources become exhausted.
- G. Train personnel in emergency management functions and NIMS/ICS concepts.
- H. Protect vital records and other resources deemed essential for continuing government functions and each agency's emergency operations in accordance to procedures and policies.
- I. Ensure compliance with this plan and the County EOP, and any pertinent procedures and documents that impact the provision of emergency services in the municipality.

The plan goes into the specifics of coordinating aid, alerting the public to a disaster, damage assessments, providing security and access control at critical facilities in the event of a disaster and more.

The plan defines "disaster" as "an occurrence or threat of widespread or severe damage, injury or loss of life or property resulting from a natural or human-made cause, including but not limited to, fire, flood, snowstorm, ice storm, tornado, windstorm, wave action, oil spill, water contamination, utility failure, hazardous peacetime radiological incident, major transportation accident, hazardous materials incident, epidemic, air contamination, blight, drought, infestation, explosion, or hostile military action or paramilitary action, or similar occurrences resulting from terrorist activities, riots, or civil disorders."

Rose Township hires architectural firm

■Will detail renovations and estimated costs of rehabilitating historic hall

The Rose Township Board of Trustees voted unanimously July 14 to contract with H2A Architects for architectural and design services for Rose Township Historic Town House for a cost not to exceed \$23,000.

Trustee Glen Noble motioned to approve the contract and it was supported by Trustee Patricia Walls.

Noble said the services H2A would provide will help the township decide what to do with the old hall to make it usable and handicap accessible. He said the township board would make the ultimate decision once estimated

costs are known.

The overall scope of the project would be completed in three phases.

The first phase would include the removal of the existing ramp, restoration of the front stairs, an addition providing barrier free access to both levels, a second means of egress from the main hall and restoration of the double doors at the original front entrance.

The second phase would include rehabilitation of the basement for public restrooms, table and chair storage and warming kitchen.

The third phase would include site enhancement, parking, landscaping and more.

H2A will be responsible for:

- Reviewing existing drawings, plans and actual conditions
- Measuring and preparing as-built drawings to work from


DRUNK DRIVER PARKS HALFWAY IN ROAD, FALLS ASLEEP AT WHEEL

Harmful invasive species in Shiawassee River

■ 'They cause extinction of native plants that our wildlife depends on'

Linden — The Shiawassee River is an important part of the community, but not every organism in the river is good for the environment.

On Sunday, July 18, the last day of River Fest in Linden, Patrick Scanlon, from the Genesee, Lapeer, Livingston, Shiawassee Cooperative Invasive Species Management Area (GiLLS CISMA), led a paddle down the Shiawassee River to educate people on the invasive species giving waterways trouble.

He paddled backward so the group could hear his voice.

CISMA was established in 2019 with the goal to partner with local, state and federal groups, as well as homeowners and organizations, to educate communities on invasive species in waterways.

"Invasive plants are more aggressive than native plants. They eat the food

and nutrition that native plants need to flourish. They cause extinction of native plants that our wildlife depends on," said Patricia Cockfield, from Keepers of the Shiawassee. "The spotted lantern fly which is not in our area but is heading this way from the Ohio area can damage fruit trees. Michigan has many fruit trees such as apple and cherry and destruction of these trees will have a big impact on our economy."

INVASIVE SPECIES IN THE SHIAWASSEE RIVER

Flowering Rush: a white, umbrellalike flower with light pink petals in the center, this species grows with upright foliage in shallow water or submerged with flexible leaves. Its native range is Europe and Asia, and the concern is that it out-competes native species for resources and can hinder recreational activities.

Eurasian Milfoil: with long white stems and greyish-green leaves with finely divided pairs of leaflets, this invasive species is native to Europe, Asia and North Africa. It forms large mats in water that shade out native aquatic plants and impedes activities. It is not a valuable source of food for waterfowl and interferes with fish pre-

residential or industrial water intakes.

Starry Stonewort: this plant is identified by the whorls of four-six branchlets/ leave with blunt tips and star-shaped bulbils produced at the nodes. It's native to Europe and western Asia, and in nonnative environments, it forms dense mats in bodies of water that can significantly reduce the diversity of other aquatic plants. It can impede the movement of fish, spawning activity, water flow and recreational activity.

Purple loosestrife: this magentaleafed plant has a woody, square stem covered in downy hair is native to Europe and Asia. In non-native environments, it can rapidly establish and replace native vegetation, leading to a reduction in plant diversity.

There are a few invasive species that experts expect to see in the area, including Tree of Heaven, a fast-growing deciduous tree with roots that damage sewers and structures and produce chemicals that inhibit the growth of other plants. Japanese knotweed, a shrub with white flowers, grows very aggressively and excludes native plants by light limitation and releasing a toxin that suppresses their growth.

MOVEMENT OF INVASIVE SPECIES

These species can be attached to boats that drop in and out of different bodies of water.

"That is why it is important to empty the bilge water and wash the boat after leaving one body of water and before entering another. We are looking into putting in some boat washing stations at some of the launch sites," Cockfield said. "Invasives also arrive

> when people let their pets loose in the river or lake when they do not want them any longer. People also dump their aquarium plants and animals in the river or lake."

> Seeds also can become airborne and travel with the wind, and dumping live bait into a river or lake is another way invasive species travel and spread.

HISTORY

JULY 25

1978: Louise Joy Brown, the world's first baby to be conceived via in vitro fertilization (IVF) is born at Oldham and District General Hospital in Manchester, England, to parents Lesley and Peter Brown. The healthy baby was delivered shortly before midnight by caesarean section and weighed in at 5 pounds, 12 ounces. Louise's birth made headlines around the world and raised various legal and ethical questions.

JULY 26

1775: The U.S. postal system is established by the Second Continental Congress, with Benjamin Franklin as its first postmaster general. Franklin (1706-1790) put in place the foundation for many aspects of today's mail system. During early colonial times in the 1600s, few American colonists needed to send mail to each other; it was more likely that their correspondence was with letter writers in Britain. Mail deliveries from across the Atlantic were sporadic and could take many months to arrive. There were no post offices in the colonies, so mail was typically left at inns and taverns.

JULY 27

1996: In Atlanta, Georgia, the XXVI Summer Olympiad is disrupted by the explosion of a nail-laden pipe bomb in Centennial Olympic Park. The bombing, which occurred during a free concert, killed a mother who had brought her daughter to hear the rock music and injured more than 100 others. Police were warned of the bombing in advance, but the bomb exploded before the anonymous caller said it would. Within a few days, Richard Jewell, a security guard at the concert, was under investigation for the crime. However, evidence against him was dubious at best. and in October he was fully cleared of all responsibility in the bombing.

JULY 28

1868: Following its ratification by the necessary three-quarters of U.S. states, the 14th Amendment, granting citizenship to all persons born or naturalized in the United States — including formerly enslaved people — is officially adopted into the U.S. Constitution. Secretary of State William Seward issues a proclamation certifying the amendment.

JULY 29

1967: By the beginning of 1967, The Doors were well-established members of the Los Angeles music scene. It was a secondary release from their debut album, The Doors, which would become their first bona fide smash. "Light My Fire," which earned the top spot in the Billboard Hot 100 on July 29, 1967, transformed The Doors from cult favorites of the rock cognoscenti into international pop stars and avatars of the '60s counterculture.

JULY 30

1976: American Caitlyn Jenner, who was competing as Bruce Jenner, wins gold in the men's decathlon at the Montreal Olympics. Jenner's 8,617 points set a world record in the event. The secret to Jenner's success was preparation. In the 1970s, most decathletes trained with other decathletes. Jenner, however, trained with some of the world's best athletes in each of the 10 decathlon events. After the win, Jenner enjoyed the unofficial title of "world's greatest athlete" and appeared in movies, on television and, of course, adorned a Wheaties box.

JULY 31

1975: James (Jimmy) Riddle Hoffa, one of the most influential American labor leaders of the 20th century, is officially reported missing after he failed to return home the previous night. He disappeared the prior afternoon from the parking lot of a restaurant in Detroit, not far from where he got his start as a labor organizer. His family filed a missing persons report to the Bloomfield Township police the next day. Though he is popularly believed to have been the victim of a Mafia hit, conclusive evidence was never found and Hoffa's fate remains a mystery.

Andrew Snyder of the Genesee County Sheriff's Office said deputes responded to the intersection of Linden and Lahring roads for a personal injury crash. Upon arrival, deputies observed a GMC Sierra rolled on its side in the ditch on Linden Road. Deputies observed the driver of the vehicle still inside. The male driver was removed from the vehicle and determined to be deceased by responding paramedics. The driver was identified as an 86-yearold Mundy Township resident. Preliminary reports indicate the driver was driving southbound on Linden Road. He lost control of his vehicle somewhere just north of Lahring Rd. This investigation

remains under investigation, although the driver may have suffered a medical emergency.

Local jeweler to repair historic bell tower clock

■Restaurant group commissions Ronny Medawar to make it 'come alive again'

Medawar Jewelers of Fenton has been commissioned to repair the clock on the tower at the old Fenton City fire station, now the Fenton Fire Hall restaurant.

Ronny Medawar made the announcement on social media Thursday, July 22. "We are excited to be commissioned by Union Joints to make the Fenton Fire Hall clock tower come alive again," he said.

Medawar said they have begun their assessment of this Fenton landmark in hopes to complete it within a few months.

They took photos of the original inner workings that they will preserve as Medawar starts making adjustments and taking measurements for the new inner movement additions to ensure this iconic clock will last another generation.

"We have been clock and watch makers since 1920," Medawar said.

Medawar has built, assembled and serviced thousands of clocks around the world and he said they are proud to do it right here in our own backyard of Fenton.

On Thursday, Medawar said several years ago, when Union Joints restaurant group established the Fenton Fire Hall restaurant, he reached out to them about the clock, however, he said they were too busy at that time to fix the clock. Recently, Medawar and the owners made contact again. He said, "It was apparent that we'd be a very good fit."

Medawar said repairing the clock will not be an easy fix. The 1938 clock will need new parts fabricated and adjustments will need to be made. "There's a lot we have to do," he said.

On Wednesday, Medawar said that he rang the bell in the tower and at just one-quarter of the sound, it was

extremely loud. Instead of making that bell ring again, Medawar will install a digital chime to be used during the day. It will not be as loud as the old bell.

Medawar will focus on making sure the lighting behind the clock is up to date and redoing the hands of the clock. He said he'll integrate the old movements as much as he can and keep the nostalgia alive.

Fenton Fire Chief Bob Cairnduff said there's a lot of history and stories with the old fire hall. Just to name a few, he said, "The clock tower served multiple purposes. Inside the tower was where the fire department hung our hoses to dry. The hose would hang all the way into the basement of the building, allowing it to drip dry.

"The lights on the side of the clock tower also served as a means of communication for the police department that was located in the building as well. When the policemen were out on foot patrol and if a phone call came into the station that needed an officer (before radios), they would turn on the lights on the side of the tower. The tower could be seen from a distance in those days and the officer would come back to find out where he was needed."

What started as a desire to support and keep our local businesses has also turned into the family go-to event in Fenton. 


HOLLY TOWNSHIP MAN ARRESTED FOR DRUNK

Dan Forbush said a Fenton police officer spotted the vehicle and caught up with it on N. LeRoy Street near VG's, where they observed the Ford Focus nearly strike another vehicle. A traffic stop was initiated and contact was made with the driver, identified as a 33-year-old Fenton man. A

preliminary breath test revealed the driver was three times above the legal limit for alcohol. He was arrested and transported to Ascension Genesys because of his high level of intoxication. After his release from the hospital, he was cited for operating a vehicle while intoxicated.

The man showed the letter to village office staff, who advised the man the letter was mailed from the Holly Township offices and that he resides in Holly Township, not the village. Office staff explained to him that he would have to speak with township officials about the letter.

Narsh said the man became verbally abusive and aggressive with employees.

The village code enforcement officer tried to explain that he simply needed to go to the township offices for a clarification, as this was a township issued letter. The man became loud and argumentative. The code official tried to deescalate the matter reassuring the man he was simply at the wrong location.

Instead of leaving, the man forced his way into the secure area of the village offices and lunged at the code enforcement officer, knocking him to the ground. The code enforcement officer was able to gain control of the man, being assisted by Village Manager Jerry Walker.

Holly police officers were tied up on other serious calls and requested assistance from the Michigan State Police (MSP) and the Oakland County Sheriff's Office. Deputies and am MSP trooper arrived and secured the man in a patrol vehicle until a Holly police officer was able to respond.

Holly police took the man into custody and arrested him for disorderly conduct and assault and battery. He has previous convictions for assaultive behavior and fraud.

The code enforcement officer sustained minor injuries from the assault, but was able to continue his duties. Alcohol did not appear to be a factor. The case was presented to the Oakland County Prosecutor's Office for charges.

"Roadside invasive plants come from seeds that attach to tires of cars and construction equipment," Cockfield said. "That is one of the reasons we have so many phragmites along the roadside. Birds eat the seeds of invasive plants and spread them undigested in their droppings."

Firewood is another vessel for invasive species because it can carry the larvae of invasive beetles. Some plants have long tubers or underground roots.

What can the community do?

The Keepers of the Shiawassee schedule numerous paddles to clean the river. She said being knowledgeable on what is invasive and learning how to report them is important. The public

can use the Midwest Invasive Species Information Network at misin.msu. edu/report.

"Homeowners on the river and lakes should learn how to protect the banks from erosion. They should think about planting a natural shoreline using native plants vs. a cosmetically beautiful landscape," Cockfield said.

Limiting the use of fertilizers and pesticides that can wash into lakes will help, and limiting the road salt that gets into drains.

Invasive species also can be found on trash floating along the water.

"Please pick up trash as you navigate the river. Carry a trash bag with you. We have river cleanup days in spring and fall during which we pick up trash and open up passages through fallen trees and log jams," Cockfield said.

city officials that the city of Fenton has had several ballot considerations for a street/road millage. Although the margin of "no" votes has decreased, each ballot initiative has been unsuccessful. The roads designated as local and many major streets/roads have continued to deteriorate with the exception of streets that are classified as those eligible for federal aid.

A bond issue would be decided by the voters as a ballot issue.

The most recent millage question on the ballot was for 5 mills each year for 10 years. The plan was to invest \$2 million per year in street/road improvements for a period of 10 years. Voters rejected this.

Markland said Paul Stauder, the city's financial consultant, will be on

hand at the Monday, July 26 Fenton City Council meeting to present a proposed bond to finance road improvements, which could be placed on the November ballot. He also will answer questions from council members or the public.

Markland said no decision was made at the July 19 meeting, but a \$24 million millage lasting 10 years was discussed. Stauder has been working on language for the proposed millage. Markland said with the estimated 2.5% interest rate, they are looking at a millage request of 3.5 mills the first year, instead of a previous request of 5 mills, with amounts decreasing over the years. The city is looking at an average of 3.03 mills over the life of the bond.

To learn more about this millage proposal, Fenton City Council is now meeting in person again and the meeting begins at 7:30 p.m., at Fenton City Hall.

The distribution of the funds will come through the State of Michigan from the U.S. Department of Treasury.

The funds cannot be used for roads or to reduce legacy costs. There are several other restrictions for the use of the funds.

City Manager Lynn Markland told council members that he is exploring

a use of the funds that will benefit the community and that additionally enhance economic activity in the community.

"The city has not decided on how the funds will be used," Markland said.

The period of performance for this award ends Dec. 31, 2026. Local units of government may use award funds to cover eligible costs incurred during the period that begins March 3, 2021 and ends Dec. 31, 2024.

mately 40 runners) that attended the events two years ago. The races didn't happen last summer due to COVID-19.

"(Linden Community Education and Food Service Director) Debbie (Brindel) just told me we are over 200 runners for the first time over the last five years, so that's awesome," Linden girls cross country coach and race organizer Ben Cox said. "I couldn't ask for better community support and participation. I'm just happy to carry the torch and keep it going. I know these races have been going on for close to 20 years."

New Linden varsity boys cross country coach Trevor Hall actually was a young half-mile runner in the races when he was a child. Now, he's one of the people helping run the event.

"Oh yeah, I started when I was 4 or 5 years old," Hall said. "I was the little one with the giant head.

"It's awesome to see the community get involved. I think cross country is a sport where if you are not familiar with it, it's hard to get involved, so I just want to get people out here running and doing something with other people. ... The best race is the half-mile event with all of the little kids running it. 1965 Detroit Tigers already look a lot like the 1968 World Champions

Editor's Note: Through the years sports editor David Troppens has collected historical radio and television broadcasts of Detroit Tigers games. During the summer, he'll be featuring some of these games through his collection.

July 25, 1965 Chicago 10, Detroit 6 First game of doubleheader Network/Announcers: Chi-

cago radio announcers Bob Elson and Milo Hamilton.

Background: By 1965, the Tigers were starting to look like the 1968 squad. Don Wert, Norm Cash, Al Kaline, Bill Freehan, Roy Oyler, Dick McAuliffe, and Mickey Lolich played in this contest. Jim Northrup and Denny McLain played in the second game. Basically the World Championship team was already at Tiger Stadium. The Tigers ended the season with an 89-73 mark, but only finish in fourth place.



"Tiger baseball is on the air."

Game summary: The contest started so promising. Lolich didn't allow a run through the first four innings, and minus a Ken Berry solo home run to start the fifth, seemed to be pitching reasonably decent. Offensively, Detroit scored three runs in the bottom of the third with a Wert solo home run, ann RBI-double by Cash and an

RBI-single by Kaline. The Tigers scored a fourth run in the fourth when Don Demeter hit a solo home run. The game felt under the Tigers' control with them holding a 4-1 lead entering the top of the sixth.

But, suddenly, the Tigers' pitchers couldn't get anyone out. After a first out, the next three hitters reached base against Lolich, chasing him from the game with still a 4-2 Detroit lead. Terry Fox couldn't get the two batters he faced and Ron Nischwitz faced one batter, walking him.

Consequently, the sports staff had to use a few other means to try to figure

a good place to place Linden in this poll.

The Eagles had an outstanding regular season, capturing the Flint Metro League Stripes Division title, while finishing the regular season with a 17-1 overall dual meet record.

The Eagles were entering the individual and team state tourney series with great credentials to think they could have the team and many individuals go deep into the post season. The team had plenty of wrestlers ranked high including Jimmy Roti (No 2 at 160), Bryce Shingleton (No. 3 at 119) and Wyatt Gocha (No. 10 at 215).

In the team state series, the Eagles were the overwhelming favorites in the district considering they defeated the other three squads at it (Lake Fenton, Holly and Brandon) by at least 21 points each. They would've been on the collision course to have a rematch with Goodrich in the regional title match, but COVID took those chances away. We think placing the squad at No. 10 is a good spot.

No. 9 - Lake Fenton girls basketball: The squad was our No. 5 team a year ago in what was the Blue Devils' first-ever appearance in our top 16. This season, the Blue Devils were supposed to be rebuild-

Julio Navarro got the final two outs, but the first batter he faced was John Romano who hit a grand slam. The other big hit in the eight-run Chicago stanza was a two-run double by pinch hitter specialist Smoky Burgess.

Why pick a loss?: It was selected because it was the only game from the 1965 season I own. It also showed what may have been the Tigers' issue of that season — pitching. The Tigers led the American League in runs scored but was only fifth in runs allowed. McLain had a strong season, but the rest of the staff was so-so. Lolich wasn't the pitcher he was in the late 1960s and early 1970s, as he was up-and-down, much like this game symbolized.

Manager health issues: Detroit manager Chuck Dressen suffered a heart attack during spring training and didn't return until May 31. Ex-Tigers catcher Bob Swift managed while Dressen was gone. However, on May 16, 1966 Dressen suffered a second heart attack and Swift replaced him as well, but then Swift fell ill before the end of the season. Swift had

lung cancer and Swift died Oct. 17, 1966. Dressen also died that year on Aug. 10.

Record broken: Chicago pinch hitter Burgess made a career being a quality pinch hitter, and on this date he broke the Major League record for most pinch hits by collecting his 108th with his two-run double. The fans at Tiger Stadium gave him a nice applause as the ball was retrieved for Burgess. Burgess would finish his career with 145 pinch hits and would hold the pinch hit record for many years. He still holds the record for driving in 142 RBI in pinch hit situations. No one else has ever driving in 100.

Hopefully you know everyone's first names: The Chicago announcers hardly ever said the first name of the players in this contest. In some ways it was fun because I got to test my knowledge, but in some ways it just seemed silly. I have heard other games from older dates when this was done a little bit, but never to the extreme of this game. I was able to figure out all of the Tigers' players and did a pretty good job with the White Sox players as well. There were one or two I didn't know.
