County 9-1-1 director charged with disorderly conduct

■Issues stemming from property dispute

The director of Genesee County 9-1-1 was cited for disorderly conduct after a dispute with a neighbor who's also her ex-sister-in-law.

Mary Ann Spring Tremaine, director

of Genesee County 9-1-1, lives next to Cathy Tremaine in Fenton Township. Cathy Tremaine said she's experienced harassment since March of 2020 when divorce proceedings began between her and Spring Tremaine's brother.

Police have responded to calls at their homes multiple times.

She recorded one of their interac-

tions on Aug. 7, after issues regarding yard waste. The police report from the Genesee County Sheriff's Office states that officers were dispatched to the 1200 block of Margaret Drive for a neighbor dispute. Cathy told police she was trimming trees and shrubs and placed the yard waste on a piece of property she owns across the street.

"The victim stated she observed (Spring) Tremaine and another male carry the garbage cans of yard waste across the street and dump them in her driveway. The victim captured (Spring) Tremaine dumping the waste in her driveway with her cell phone," the police file states.

He's recovering from two recent surgeries, a 13-hour surgery on Aug. 13 and another surgery on Aug. 20 after he went into cardiac arrest.

It hasn't stopped his love for sports. He watched the Tigers game against the Toronto Blue Jays on Sunday, Aug. 22.

His father, Brad Reichert, posted in the Andrew's Journey Facebook group, that he loves playing basketball and baseball. He's an eighth grade student at Lake Fenton Community Schools.

"He is a huge MSU, Tigers, Red Wings, and Lions fan. Andrew watches sports all the time. He usually checks the scores first thing when he wakes





Informations and indictments-Michigan's unique grand jury law

Under Michigan law, criminal felony prosecutions in circuit court are commenced by either an information or an indictment.

An information is a document which gives notice to the defendant of the charges against them and the possible penalties.

It is filed in the circuit court by the prosecutor after preliminary proceedings and hearings have been completed in the district court. These include the preliminary examination where the prosecutor must prove to the district court judge that there is "probable cause" to believe that crimes were committed and that the defendant committed them.

Probable cause means there is a reasonable ground of suspicion supported by circumstances sufficiently strong to warrant a cautious person to believe the accused is guilty of the offense charged.

When proved (or the defendant waives their right to an exam) the case is sent to circuit court for the information filing and further proceedings.

An indictment is also a charging instrument. However, the decision to approve it is made by a grand jury after hearing the evidence against an accused and then finding probable cause. It, too, is filed by the prosecutor in circuit court.

There are a number of important differences between the information and indictment process, not the least of which being that grand jury proceedings are conducted in secret and the defendant first learns that they've been charged after the indictment is issued.

While all states have grand juries of one kind or another, Michigan has a unique system providing for two types of grand juries - one with 13 to 17 citizen jurors and a second called a "one person grand jury" presided over by a single judge.

Cathy Tremaine provided police with documents validating her rights to the property that is in dispute, according to the police file.

"Contact was made with (Spring) Tremaine, who argued with deputies' reference the property. (Spring) Tremaine was advised not to trespass on any property owned by the victim. (Spring) Tremaine was cited for disorderly person with a future court date. Deputies have responded to the victim's house on other occasions reference civil disputes," the police file

Cathy said she's owned that lot for 22 years and due to a judge's orders, the property remains hers as part of the divorce proceedings until Spring Tremaine's family pays her what's owed in a settlement.

Police charged Spring Tremaine with disorderly conduct, which is a misdemeanor.

Spring Tremaine said the main issue between her and Cathy involves the vacant lot of land across from their properties. She said the property was purchased by her mother in 1988, and it's now in a trust. Spring said she is the trustee who takes care of the maintenance and property taxes.

Spring said she wasn't aware that the ownership of the trust had come under challenge in the divorce between her brother and Cathy. During the Aug. 7 incident, Spring said she was acting on the basis that she was responsible for the lot.

"I have since found out that there is a challenge to the trust ownership and at the time, Ms. Lufkin felt I was trespassing on the property," she said. Lufkin is Cathy's maiden name.

The question of who owns the property will be decided by the courts.

"We have to allow the courts to take the course which, as we know, takes a considerable amount of time," she said.

"Going forward, I'm sure Ms. Lufkin and I agree that we want our neighborly existence, along with our children of which we share a bloodline, to be happy and healthy and I'm sure she would want that for our children as well. I hope that's the course of action going forward," Spring Tremaine said.

She said this incident is a personal matter and has nothing to do with her professional work as director of County 9-1-1.

"I'm here to answer any questions that anyone might have. I am 100 percent transparent with my actions in the past and in the future," she said.

Cathy said Spring Tremaine was served papers by a judge about the ownership of the lot. She also states that she's dealt with harassment from Spring ever since divorce proceedings began.

traffic hours, according to a traffic study done by ROWE Professional Services.

The study was completed this summer at the request of Lombardo Homes, a developer wishing to build a 122-unit subdivision in Fenton Township with access to Linden and Lobdell roads. School was not in session during the length of study.

Ultimately, the study determined most traffic flow operates at acceptable levels during peak times. However, there are exceptions with the Linden and Owen roads intersection and the Lobdell and Linden roads intersection.

Lombardo Homes is requesting to rezone property behind Mueller's Orchard, which is currently farmland, from R-3, single family residential, to planned unit development (PUD). They are requesting to build 122 homesites with a minimum lot width of 70 feet and a minimum lot size of 9,100 square feet.

In May, the Fenton Township Planning Commission recommended approval for the rezoning request, but plans slowed down in June when it came to the Fenton Township Board of Trustees meeting. Treasurer and Planning Commissioner John Tucker said their ordinances do not allow for a minimum lot width below 75 feet or lot sizes smaller than 12,000 square feet.

Numerous residents have spoken against the smaller lot sizes and the potential increase in traffic if approved.

Lombardo requested a traffic study be done, and ROWE Professional Services set up the equipment on these four intersections to collect data during the weekdays from 7 to 9 a.m. and from 4 to 6 p.m., which are called "peak periods."

- Linden Road and Owen Road
- · Lobdell Road and Linden Road
- Linden Road and Deer Trail
- Lobdell Road and Trotter Lane

The site plan ROWE used shows 122 lots on 67.5 acres with an anticipated completion date of 2028. ROWE uses a grading system to classify levels of service (LOS) analysis. A is the best and D is considered acceptable.

The study found that most approaches and movements of these intersections operate at an LOS C or better in peak hours with a few exceptions.

Linden and Owen intersection

Unsignalised, approximately 3,040 daily trips occur at this intersection during

peak hours of 7 to 9 a.m. and 4 to 6 p.m. The study found that with existing conditions, the westbound left turn movements (turning left onto Linden from Owen) operates at LOS F during the PM peak hour.

The Genesee County Road Commission recently turned this intersection into a three-way stop due to increased traffic from construction in Fenton encouraging drivers to use Linden and Owen roads. The study classifies this as "all-way stop control."

ROWE recommends keeping the all-way stop control and adding a 100-foot right turn only lane on Owen Road. However, a complete analysis needs to be completed by the Michigan Manual of Uniform Traffic Control Devices (MMUTCD) prior to implementation.

Lobdell and Linden intersection

The study found that approximately 2,830 vehicles pass through this intersection during peak hours. The eastbound left turn movements (turning left onto Linden from Lobdell) operates at LOS E in the PM peak hour.

ROWE recommends all-way stop control at this intersection.

Driveways

The study found that at Linden and Deer Trail, classified as Driveway 1, and at Lobdell and Trotter Lane, classified as Driveway 2, a left turn passing lake or a right turn lane is not warranted.

At Linden and Deer Trail, which is an unsignalised intersection, there are approximately 1,682 daily trips during peak hours. At Lobdell and Trotter Lane, which is also unsignalised, the study determined there are 1,757 daily trips.

Future conditions with subdivision

The proposed development is forecast to generate 91 new trips in the AM peak hours and 123 new trips in the PM peak hours

Lyle Winn, development compliance manager at Lombardo Homes, said they are in favor of implementing the recommendations in the report. However, additional studies need to be done to install all-way stops.

He says it would be "appropriate" to make the Linden/Lobdell an all-way stop based on the study, as well as keeping the three-way stop and adding the right turn lane at Linden/Owen. Their next step is to go in front of the Fenton Township Board of Trustees again with the results of the study. Winn said that could be in September. Zoning Administrator Michael Deem said the traffic studies will be included in the final site plan review, and it will be included in the township board's review of the rezoning application. The Genesee County Road Commission has final say on if the stop signs at Linden/Owen will remain permanent, and the township has encouraged this to happen.

Linden City Council made it official in a unanimous vote on Monday, Aug. 23.

The Michigan Water/Wastewater Agency Response Network (WARN) is a conglomeration of 53 public works agencies across the state that have agreed to share resources and assist each other in the form of personnel, equipment, material and supplies in the event of emergencies that disrupt utility services.

WARN is recognized by the Michigan State Police as a National Incident Management System first responder.

Linden is the 53rd community to join.

Thomas Trice, interim public works director, said at a previous meeting, "If we need aid, we can ask for it. If somebody else needs aid, they can ask us for it. It allows us to provide

aid if we can."

Disasters or emergencies include major storms, tornadoes, flooding, water and sewer supply interruptions, blocked

sewer supply inter-

ruptions, blocked

roads and more. The Urban Cooperative Act of 1967 authorizes public bodies and private entities to work together to provide mutual aid. Approximately 49 states have WARN programs.

The agreement gives sole discretion to the members whether to respond to a request for assistance, or to what extent to respond if they choose to. Members

> can request cost reimbursement after giving aid.

> "It is very simple and clear. If an agency asks for assistance from the city, we can choose to provide it or not

depending on our situation at the time of the request," Trice said at the Aug. 9 meeting. "The greater value to the WARN program is that it is statewide... The agreement is to provide initial aid

until an agency can get control of the situation and provide what is needed through other means, such as private contracts."

There is no cost to join WARN.

Councilor Brad Dick said he thinks it's a great idea and he wishes they could have gotten a demo of it two weeks ago during the storm that wiped out power in Linden for days.

"It'll be great for the city," said Councilor Ray Culbert.

Councilor/Mayor Pro Tem Brenda Simons said she likes the line in the meeting packet and agreement that reads, "It's not a question of if the city of Linden will need assistance, it's just a matter of when."

By no means was his heart fixed; he was taking several medications and was followed by doctors in order to live as safely as possible," Reichert wrote in the Facebook group





Other differences include: (1) there is no right to a preliminary examination after an indictment; (2) the Rules of Evidence do not apply; (3) after the indictment, the defendant is entitled to receive transcripts of all witness testimony and records of the proceedings that touch upon the guilt

or innocence of the accused as determined by the county's chief circuit court judge; (4) every witness is entitled to legal counsel being present in the grand jury room.

Michigan's grand jury law has been upheld as being constitutional. It is a readily available alternative to the more frequently used information prosecutions.


