Old Sunoco gas station to be redeveloped

■Owen Road property near U.S. 23 to be store, gas station, fast food drive-thru

The closed Sunoco site on Owen Road will be redeveloped into a new gas station, convenience store, and fast food restaurant with drive-through.

Barrels & Vines, which owns multiple mini-mart facilities in Michigan, has plans to redevelop the site at 3325 Owen Road in spring 2022.

The gas station and convenience store has been closed for months. It's located next to the

Millage request on August ballot

■Rose Township approves 4 mills for fire and EMS coverage in split vote

By a vote of 3-2, the Rose Township Board of Trustees approved a motion during its meeting Jan. 12, to place a millage request on the ballot for the August election for fire and EMS coverage.

Clerk Debbie Miller and Trustee Glen Noble voted against the motion.

The township will be asking voters to approve 4 mills for the next six years to cover the township's portion of costs for coverage from the North Oakland County Fire Authority (NOCFA). Property owners have been paying 2.1 mills for approximately the past 12 years.

Noble said he would have preferred a millage of 3.28 mills. "I don't like my taxes going up 100%," he said.



LAFF Pathway continues in new year

■Non-motorized pathway will connect areas from Argentine to Fenton

A non-motorized path connecting areas from Argentine Township through Fenton are progressing and organizers are working tirelessly to promote the healthy lifestyle project and raise funds to cover the costs.

People of all ages are already taking the opportunity to walk, bicycle and run along the completed portion in the Argentine/Linden area.

In July, Fenton City Council approved an agreement with The State Bank, which offered \$500,000 for the construction of Phase Two of the LAFF Pathway and naming rights. The State Bank Trail will be a two-mile long, 10-foot wide paved trail that will be built along the south side of Silver Lake Road from Jennings Road in Fenton west to Triangle Park in Linden, where Phase One ends.

Phase One, the Silver Lake Road Trail, was completed in October 2020 and goes

from Argentine Township to the city of Linden.

With financial support from Argentine Township, Fenton Township, Fenton City, and Linden City, the LAFF Pathway is expected to continue expanding.

Phase 1 is called the Argentine Trail. Phase 2 is called The State Bank Trail. Phases 3 and 4 will run along Owen and Fenton roads.

An initial attempt to complete the four-phased, approximately 10-mile plan using a millage did not pass. Polling after the vote showed support for the pathways, but not with an increase in taxes. Local municipalities along with LAFF and Southern Lakes Parks and Recreation (SLPR) have continued the effort leveraging grants and fundraising, which takes time.

At this time, organizers have secured more than \$2.5 million in funding commitments, toward a total of just over \$2.9 million. Additional grants and private donations are pending.

Identification of defendants in criminal cases - Part I

Whenever a criminal case goes to trial, the prosecutor has two essential elements to prove beyond a reasonable doubt: (1) that a crime was committed and (2) that the defendant committed the crime. I will leave detailing the first element for a future column.

As to the second, what I'm referring to is simply called "identifying the

defendant" as the person who did it.

Generally speaking, there are two ways that a defendant can be identified at a trial. These are by eyewitness testimony and scientific evidence testimony by an expert witness.

Eyewitness testimony is from a person who has firsthand knowledge of an event from seeing the defendant allegedly commit a crime.

In most trials, it's as simple as that, but sometimes things are done before trial to ensure that the right person has been arrested and can be accurately identified in court.

Among these procedures is the "one person show up." This describes what happens immediately after a crime is

committed and the arrest of a suspect at or near the scene. The eyewitness is promptly taken by the police to view the in custody suspect to determine if he or she is the responsible person. If the answer is yes, the witness thereafter testifies at trial as to the identification. Another method is a "corporeal or body lineup."

Here the police have the suspect and four or five other individuals stand side by side in front of the witness (who is hidden) to determine if the suspect can be "picked out."

The other individuals must be of similar age, weight, height and race and the same sex. If they are not and the suspect is identified, the subsequent testimony might be barred as "impermissibly suggestive" lineups are prohibited.

There is also a police lineup procedure called the "six pack photo

This is when the witness is shown the suspect's picture and those of five other similar looking individuals to see if the suspect can be identified.

Finally, when no one is in custody, a composite drawing can be made by a police artist based upon a witness's description. This is then distributed to the general public in the hope that someone recognizes a possible suspect.

Miller had motioned the board to look into the possibility of allowing NOCFA to be its own taxing authority, similar to a school district when asking for funding from the residents. Her motion failed by a vote of 3-2. She and Treasurer Paul

Gambka voted in favor of researching the possibility of NOCFA being its own taxing authority.

"I'm willing to look at a tax authority," Gambka said.

Noble said if NOCFA became its own taxing authority, Rose Township residents would pay more than Holly Township residents since Rose Township's current taxable value is higher than Holly Township.

Trustee Patricia Walls said costs for everything keep going up and the fire department is always in need of new equipment. She was in favor of 4 mills. She said if the millage generates more money, it would go into the fire fund.

Miller told the board that the fire department would have to handle its budget and that Rose Township residents would pay less money. She also said the move would take politics out of it with the NOCFA Board.

The NOCFA Board is comprised of two Rose Township Board of Trustee members, two Holly Township Board of Trustee members and one citizen at large. Representing Rose Township are Supervisor Dianne Scheib-Snider and Treasurer Paul Gambka. Representing Holly Township are Clerk Karin Winchester and Supervisor George Kullis. The citizen at large is Peter

Stouffer of Rose Township.

Currently, Rose Township and Holly Township contribute the same amount, \$849,926, annually for coverage from NOCFAthrough their own millages. Rose Township has two NOCFA millages, 1.3096 and 0.7229 for a total of 2.0325 mills. They expire Dec. 31, 2021.

Holly township has a NOCFA millage of 4 mills for its property owners.

The board discussed whether the millage request should go on the August or November ballot. Consensus was that if the request failed, there would be time to put another request on the November ballot.

Scheib-Snider was in favor of 4 mills for six years and acknowledged that this would be the first increase in 12 years.

Following the vote, Scheib-Snider said they would vote on the language of the millage request at the February meeting for placement on the ballot.

and downtown," said Carmine Avantini, president of CIB Planning and Fenton's city planner.

The city's new master plan reaffirms officials' desires to maintain the long-term viability of the downtown area. It also addresses land use issues, housing issues, and it identifies certain intersections and roadways that are in need of redevelopment due to traffic volumes.

The entire plan can be viewed at cityoffenton.org.

Growth

The population of Fenton increased from 10,582 to 11,756 between 2000 and 2010. According to the 2020 Census, that number is now 12,050. The median age of the city is 36.

"The growth in Fenton has been well-planned and most of what we hear about the community is positive. Since I have been here such a long time, I am obviously of the opinion that growth has been handled properly and the city is doing great," Avantini said.

A growing population means more retail and traffic, especially with Fenton's location and proximity to U.S. 23 and I-75, which allow people to commute to Detroit, Southfield and other metropolitan areas.

"The primary pressure is increased traffic levels. This is normal for a successful, growing community and requires that drivers be more patient and courteous," Avantini said.

Land use

The city has 3,671 acres, and approximately 650 (17.7%) are vacant. More than 28% of the land in the municipality is single-family residential, the most common use, and other residential uses account for more than 20% of acres. Approximately 10% of land is commercial, 7% is industrial, nearly 9% is civic/institutional, parks and open space is 5.1% and 1.2% is office space.

"I consider the most significant goals to be ensuring that remaining vacant parcels are developed according to the Master Plan and maintaining the mixeduse character of Silver Lake Village," Avantini said. The plan aims to eliminate or minimize existing land use conflicts through sound planning and zoning.

The city also wants to prevent commercial intrusion into the residential areas along North Leroy, north of the Commercial Business District (CBD), by maintaining the commercial district boundaries identified in the North Leroy Street Subarea Plan. The plan lays out future zoning patterns.

Redevelopment opportunities along Owen Road

The master plan identifies ways to fix congestion and traffic flow near U.S. 23 by constructing more access driveways and promoting good driveway spacing. The city has a subarea plan for land near U.S. 23/Owen Road.

"The U.S. 23/Owen Road area has seen a considerable amount of growth and new development over the past 20 years. Much of this has been the redevelopment of existing sites. Spillover market demand from Silver Lake Village, Walmart, and the Shoppes of Fenton (planned unit development (PUD) has led to the upgrade of existing sites and buildings such as Speedway, BP/Tim Hortons, Taco Bell, Arby's and KFC," according to the plan.

The city plans to identify necessary infrastructure improvements, determine the appropriate combination of land uses and provide a strategy for the safe flow of traffic. The four quadrants include the four corners of U.S. 23/Owen Road.

"This interchange is the primary gateway into the city of Fenton and it has been the desire of the Planning Commission to see this study area improved. Over time, we have accomplished much of that with the Shoppes of Fenton development, the rebuild of McDonald's/mini-marts, and the soon to be redeveloped Sunoco station. A look back at this area some 20 years ago indicates just how far we have come along with our redevelopment efforts," Avantini said.

Another issue identified in the plan is how pedestrians and students lack crosswalks over the U.S. 23 bridge and sidewalks in front of Sunoco, the Mega Coney Island site and the Fenton Area Public Schools property on Owen Road. **Downtown**

The plan lays out objectives for the six districts in downtown Fenton: the rail district, the river overlay district, the downtown district, the government/civic district, the Dibbleville district, and the North LeRoy District.

"Now that downtown has had significant public and private investment, the opportunity to capitalize on further redevelopment potential lies in the North Leroy Street corridor," according to the plan.

National Blood Crisis

The American Red Cross is experiencing the worst blood shortage in over a decade. The dangerously low blood supply levels have forced some hospitals to defer patients from major surgery, including organ transplants. Your donation is desperately needed.

What is causing the blood shortage crisis?

- 10% overall blood donation decline since March 2020.



Blood cannot be manufactured or stockpiled and can only be made available through the kindness of volunteer donors. Less than a one-day supply of critical blood types in recent weeks.

The Red Cross asks that you consider booking additional appointments further out due to the fact that while availability of drives may be impacted, the need for blood remains constant.

southbound entrance ramp to U.S. 23.

City planner Carmine Avantini said this property had been owned by the same people since the early 1990s, and the city was unable to get them to make improvements to the building or site. This owner has since passed away.

Owen Road Fenton LLC bought the 1.36-acre property in December 2020.

"They proposed redevelopment of the site with a plan very similar to what was shown in the Master Plan. They obtained special land use and site plan approval at the August 2021 Planning Commission meeting and then variance approval at the October 2021 Zoning Board of Appeals meeting," Avantini

The site is zoned general business

district. Avantini said building plans have not yet been submitted to the city, but he anticipates a spring 2022 construction start date.

The special land use application states there will be four pump islands and a drive-thru for fast food. The site will utilize the existing water main and sewage systems, and it will include improved stormwater drainage and storage systems.

"As the proposed use of the site is a reconstruction of a similar use, there will be little change to the proposed site functions ... There has also been an agreement that allows the use of the overflow parking lot to the adjacent property to the south that will help mitigate parking congestion," according to the application.

The recently approved Fenton master plan identified this site as an area in need

of redevelopment.

"Although a functioning business, this site is poorly maintained and underutilized. Part of the building is vacant, and redevelopment of the site could benefit both the property owner and the community," according to the plan.

It also identifies the land as a potential brownfield site, which is "a property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant," according to the Environmental Protection Agency.

The rear portion of the property, which city officials originally thought might be utilized for expansion, contains a steep slope that prohibits full use.

"This rear portion is part of the 3401 Owen Road site to the west, but it is still a large parcel nonetheless and could be used for shared parking at some point in the future," according to the plan.

Master plan recommendations for this area include:

- Encourage full redevelopment of the site and incorporate usable portions of the undeveloped land to the rear. This would allow the station to potentially double the number of pump islands and incorporate a fast food tenant.
- Restrict the number of driveways to Owen Road. Provide cross-access to the adjacent 3401 Owen Road site and use directional driveways if needed.
- Maintain a positive image from the U.S. 23 highway. All sides of the new building should present an attractive facade and use landscaping to enhance the site design, according to the plan.

fair weather as we have. The rainy fall set us back a bit but the permitting has really been the main delay," said Scott Nelson, vice president of Quick-Sav Food Stores/ Beacon & Bridge Markets.

A couple contractors are on site every week. They're doing work on the exterior of the convenience store, which is now on the north end of the property. Before redevelopment, it was 2,240 square feet. After, it will be 2,592 square feet.

PM Environmental also is on site working on the remediation system that will extract contaminated groundwater from an underground gasoline leak. The fuel contractor is finalizing the piping from the tanks to the dispensers on the gas station side, which is now located on the southern portion of the property. There will be eight pumps.

Waiting on state approval for permits is one of the biggest, and longest, obstacles.

In October 2021, Kevin Berry, owner of Berry Custom Homes and contractor for the project, told Linden City Council that they were waiting on permits from the state for underground plumbing and electrical work.

Nelson said they're still waiting for the state inspector to issue permits for me-

chanical, electrical and plumbing work.

"Since the pandemic, commercial approvals have been very delayed. We have had recent discussions and it sounds like we are within a week or two of getting the permits," Nelson said. "This is the major hold up. We have been waiting since just before October for the permits to be issued from the state. We are getting close, the pandemic just has things taking a little more time than normal. We have been doing as much as possible on the exterior waiting for the interior permits."

Once they secure the permits, they can finalize the plumbing on the interior of the building, install a vapor barrier, and do additional work inside.

In the fall of 2021, their goal was to open by December 2021, However, due to the setbacks with state permitting, they're now hoping to open in late March.



1945 - 2022




