■ Residents give input on city infrastructure, housing, community and more

Linden — The Linden public survey results are in. They show residents want to preserve the historic aesthetic of Linden while improving the infrastructure and making downtown more vibrant.

More than 624 people filled out the survey from November 2021 to January 2022. During the Monday, May 2, Linden Planning Commission meeting, City Planner Adam Young said this was more responses than they expected, which shows residents are interested in this process.

Give your input on the Thompson Road Corridor

■ Public asked to give opinions on Thompson Road traffic, land use, roundabouts and more

Fenton Township is seeking input from the public on the Thompson Road Corridor.

On the homepage of fenton-township.org, users can find links to different questionnaires relating to the Thompson Road Corridor. In early April, the Fenton Township Board of Trustees approved a construction contract with Genesee County to construct a water main and an elevated water tank along the Thompson Road Corridor.

This is phase one of the township's plans to bring municipal water to Thompson Road and farther south. Officials expect more

Voters approve Holly schools' bond renewal

■ Provides \$97 million for district-wide improvements including new middle school

On Tuesday, May 3, voters in the Holly Area Schools district approved a bond proposal that will provide \$97 million for district-wide improve-

ments, with no tax rate increase to property owners. This bond proposal was developed and prioritized as Phase 2 of the Master Plan for district facilities. Buildings, sites, and educational programs were assessed to determine and prioritize a list of facility needs throughout the district.

According to the Oakland County Clerk's Office, there was a 13.53% voter turnout for this election.

Fenton to flush water mains

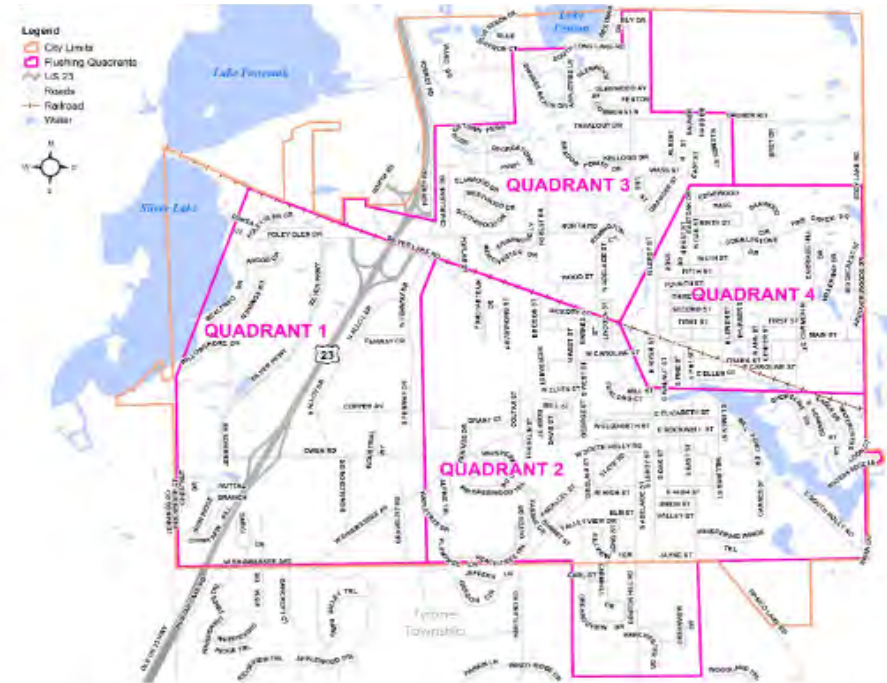
■ May 23-27 and
May 31-June 3

The city of Fenton Water Department has selected dates for its spring water main flushing program. The city flushes two quadrants of the city in the spring and two in the fall.

The water department will perform the flushing May 23-27 in Quadrant 2. Quadrant 4 will see flushing May 31-June 3. Flushing will be performed overnight from 10 p.m. to 4 a.m. to minimize the impact of low water pressure.

Flushing water mains removes minerals and sediment that naturally accumulate in the pipes of the water distribution system. Fire hydrants are used for the flushing process, allowing simultaneous inspection of the hydrants to ensure readiness in case of use for firefighting.

Once flushing is completed, water may appear rust-colored because iron and other mineral deposits in the water mains are stirred by the high velocity water flow associated with the flushing process. There is no health hazard associated with discolored water, but customers can usually eliminate discolored water by running the cold water tap on all house-

hold faucets. City officials recommend waiting a day after any discolored water is flushed from your pipes before doing laundry.

If you are experiencing discolored water after at least five minutes of cold

water flushing at all faucets in your home, contact the city of Fenton Water Department at (810) 629-6347 for assistance.

Health department issues warning

■ Phone scam targeting residents of Genesee County

The Genesee County Health Department (GCHD) is alerting the community of a phone scam targeting residents of Genesee County.

A Genesee County resident received a phone call from someone impersonating an employee of the GCHD regarding a health department funded grant for which this resident qualified. The scammer then went on to ask the resident for their bank information in order to apply for this grant. Luckily, after asking for the scammer's name and badge number, the resident hung up and decided to call the health department to report this call. The health department confirmed that the unknown caller was not an employee and it was a scam.

Genesee County residents should be advised that the GCHD would never call and ask for your bank account information.

"If you receive a call and are unsure if it is a scam, ask the caller for their name, a return phone number and avoid

sharing any personal information over the phone," said Dr. Pamela Hackert, medical health officer for Genesee County. "Report suspicious behavior to the authorities."

Concerned residents can report scam calls by calling the non-emergency phone number at the local police or sheriff's office.

Avoid becoming a victim of phone scams or identity theft by:

- Making a list of contact information for family members, close friends, health providers or anyone who may call regularly. This will help you know if the call is legitimate.
- Letting a call go to voicemail if you do not recognize a phone number; Scammers rarely leave messages.
- Hanging up if a stranger asks for personal or financial information. If you do answer the phone, it's OK to hang up.
- Not sharing any personal information such as your social security number to anyone over the telephone.

City launches new website

■ Will be continually updated and built upon; user friendly for residents

The city of Fenton launched its new website, cityoffenton.org, this past week.

The creation of the new website for the city has been happening for a few years. Talks began in the fall of 2019 and Fenton City Council approved the costs, which include the building of the website (\$19,830) and the networking system and maintenance (\$4,500) totaling \$24,330 in February 2020. That cost was bundled for the first year.

Michael Hart, assistant city manager and executive director of the Downtown Development Authority (DDA) said the city then approved a five-year agreement for maintenance of the website and an automatic rebuild/refresh of the website in the fourth year.

Although the project and costs were approved, the pandemic caused delays. City leaders look at this launch as just the beginning for the new site.

At the top of the homepage, there are big and bold tabs for "Government," "Services," "Residents," "Business" and "How do I," that take the user to everything they are looking for regarding the city.

Below that are tabs you can click on that will take you to everything you need to know regarding "Pay my bills," "Building permits," "Parks reservations," "Refuse/recycling," "Real estate records," and "Register to vote."

Keep scrolling down and you will see links to news and updates, and events and meetings.

Chris Clonts,

the communications coordinator for the city of Fenton, said opening the government link on the home of this new website is comparable to a one-stop library. Users will find agendas for city council, commissions and authorities here. They also will find agenda packets and meeting minutes.

Clonts said from the administrator's perspective, the website allows them to add pages and packets much more quickly than before. What used to take close to a day to load, now takes just minutes. "We'll get some time back," he said.

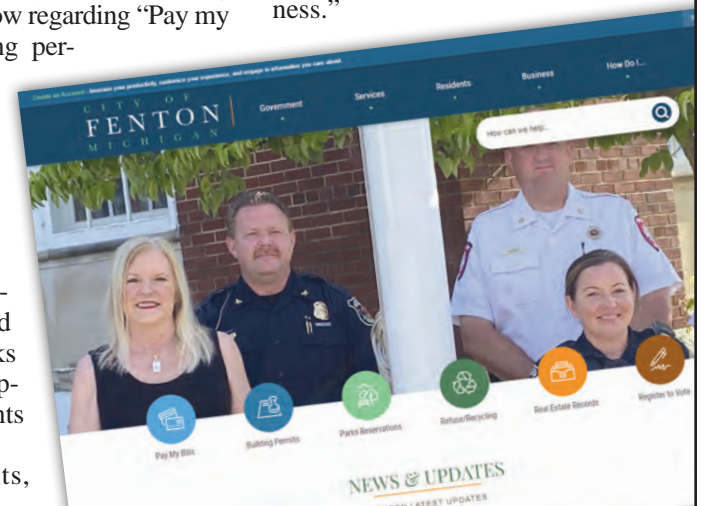
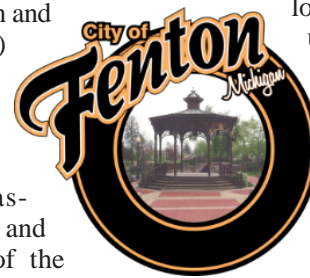
The new site also allows residents to report concerns and the city expects to be able to track those concerns and the reporting system.

Residents can create their own account on the website and request specific notifications for things such as meetings, events and more. Clonts said the city also has plans to post a newsletter.

The various city departments will have the capability of adding and updating its own page within the site.

Clonts said a time saver for many residents will be forms that can be filled out online. He said for those who prefer to fill out hard copies of forms, the city will continue to provide that option.

Clonts said, "This new website is as vibrant as the community of Fenton is, vibrant and open for business."

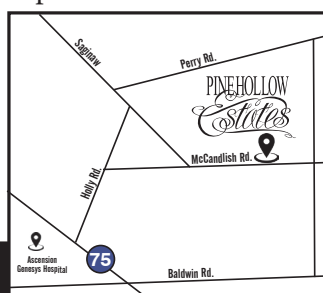

development.

Currently, development activities are not allowed on the Thompson Road Corridor. On Tuesday, Feb. 15, the Fenton Township Board of Trustees unanimously approved a resolution to enact a moratorium for development in the area due to increased interest in the land.

This gives township planners time to develop a subarea plan to address health, safety and welfare concerns before allowing new projects and developments. They are seeking public input.

On the corridor questionnaire page, the first link is the proposed future land use map. It asks the public for their opinion on the township's plan for the land in this area for the next 15-20 years. Do you approve of the current zoning? What density should be allowed? What do you want to see in the Highway Service District?

Answer the questionnaire and/or contact Zoning Administrator Michael Deem mdeem@fentontownship.org, by phone at 810-629-1537.

The second link is the roadway preference survey. This asks about traffic, if residents believe the Thompson Road bridge over U.S. 23 should be widened, if they should construct roundabouts on either side of the bridge and more.

The third link asks which type of buffer the public would prefer to see along the Thompson Road Corridor.

The fourth link contains questions about the building placement along Thompson Road. Do you prefer commercial buildings? Should parking be allowed in the front or back of commercial properties and industrial properties? It also asks about residential buildings.

The fifth link is a survey about building materials. Do you prefer metal industrial buildings? Should bay doors be visible from the road? How favorable are brick buildings? Should there be attached residential condos along the corridor? Would you support building attached residential townhomes in this area?

The webpage contains supporting documents and information about current land use, zoning, the sewer map, wetlands and lakes map and more.

LOOKING BACK *at this week in* **HISTORY**

MAY 8

2010: On this day, 88-year-old actress Betty White, known for her former roles on “The Golden Girls” and “The Mary Tyler Moore Show,” becomes the oldest person to host the long-running, late-night TV sketch comedy show “Saturday Night Live” (SNL). White’s hosting gig came about, in part, after hundreds of thousands of her fans signed onto a Facebook campaign rallying for it. As SNL’s eldest host, White earned positive reviews, and the show, which featured musical guest Jay-Z, drew its highest ratings in 18 months. The octogenarian actress later won the seventh Emmy Award of her career for her SNL appearance.

MAY 9

1960: The Food and Drug Administration (FDA) approves the world’s first commercially produced birth-control pill—Enovid-10, made by the G.D. Searle Company of Chicago, Illinois. Development of “the pill,” as it became popularly known, was initially commissioned by birth-control pioneer Margaret Sanger and funded by heiress Katherine McCormick. Sanger, who opened the first birth-control clinic in the United States in 1916, hoped to encourage the development of a more practical and effective alternative to contraceptives that were in use at the time.

MAY 10

1970: On this day, 40 seconds into overtime of Game 4 of the Stanley Cup final, Boston Bruins star Bobby Orr slips the winning goal past St. Louis Blues goaltender Glenn Hall. After scoring, Orr leaps into the air before landing flat and sliding into his teammates’ embrace. The famous celebration is immortalized by Boston Record-American photographer Ray Lussier, whose image of the soaring Orr is one of the most famous sports photographs of all time. In Boston sports lore, Orr’s game-winner, which made the Bruins NHL champions, is known as “The Goal.”

MAY 11

1934: A massive storm sends millions of tons of topsoil flying from

across the parched Great Plains region of the United States as far east as New York, Boston and Atlanta. At the time the Great Plains were settled in the mid-1800s, the land was covered by prairie grass, which held moisture in the earth and kept most of the soil from blowing away even during dry spells. By the early 20th century, however, farmers had plowed under much of the grass to create fields. The U.S. entry into World War I in 1917 caused a great need for wheat, and farms began to push their fields to the limit, plowing under more and more grassland with the newly invented tractor. The plowing continued after the war, when the introduction of even more powerful gasoline tractors sped up the process. During the 1920s, wheat production increased by 300 percent, causing a glut in the market by 1931.

MAY 12

1957: Race car driver A.J. Foyt scores his first professional victory, in a U.S. Automobile Club (USAC) midget car race in Kansas City, Missouri. A tough-as-nails Texan, Anthony Joseph Foyt Jr. raced midget cars — smaller vehicles designed to be driven in races of shorter distances — and stock cars before moving up to bigger things in 1958, when he entered his first Indianapolis 500 race. Foyt won his first Indy 500 crown in 1961, when rival Eddie Sachs was forced to make a tire change in the final laps, giving Foyt the chance to overtake him and win with a then-record average speed of 139.13 mph.

MAY 13

1846: The U.S. Congress overwhelmingly votes in favor of President James K. Polk’s request to declare war on Mexico in a dispute over Texas. Under the threat of war, the U.S. had refrained from annexing Texas after the latter won independence from Mexico in 1836. But in 1844, President John Tyler restarted negotiations with the Republic of Texas, culminating with a Treaty of Annexation. The treaty was defeated by a wide margin in the Senate because it would upset the slave state/free state balance between North and South and risked war with Mexico, which had broken off relations with the United States. But shortly before leaving office and with the support of President-elect Polk, Tyler managed to get the joint resolution passed on March 1, 1845. Texas was admitted to the Union on December 29.

MAY 14

1998: The legendary singer, actor and show-business icon Frank Sinatra dies of a heart attack in Los Angeles, at the age of 82. Sinatra emerged from an Italian-American family in Hoboken, New Jersey, to become the first modern superstar of popular music, with an entertainment

career that spanned more than five decades. In the first incarnation of his singing career, he was a master of the romantic ballads popular during World War II. After his appeal began to wane in the late 1940s, Sinatra reinvented himself as a suave swinger with a rougher, world-weary singing style, and began a spectacular comeback in the 1950s.

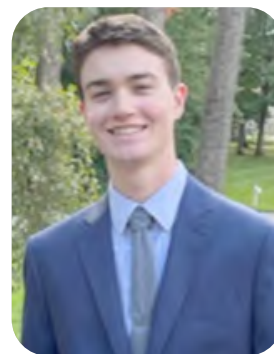

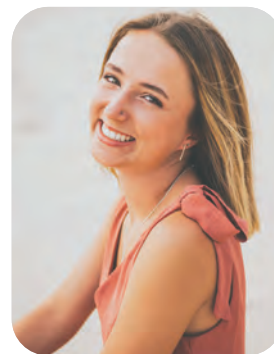

Fenton Township man arrested for domestic violence

■ Slapped face of girlfriend with tuna fish sub — she's allergic to tuna fish

A 59-year-old Fenton Township man was arrested May 4 for domestic violence.

Genesee County Sheriff's deputies responded to a home in Fenton Township at 6:13 p.m., Wednesday, May 4, for a domestic disturbance in progress. Dispatch advised deputies that the trouble half of the couple had left in a black pickup truck in an unknown direction.

Upon arrival, deputies observed redness on the left side of the 51-year-old female complainant's face. She told deputies that she and her boyfriend had two sub sand-

wiches delivered to their residence, a tuna and a steak and cheese.

The woman reported that she is allergic to tuna fish and noticed her boyfriend eating the steak and cheese sandwich. She became upset and confronted her boyfriend about the sandwich. She said he then walked into the living room and slapped her in the face with the 12-inch tuna fish sub.

While deputies were on scene, the black pickup truck pulled into the driveway and the man exited the vehicle. The boyfriend confirmed what was reported by his girlfriend.

Det. Sgt. Scott Pritchard said the man was placed under arrest. Deputies transported him to the Genesee County Jail where he was lodged for domestic violence.

City of Fenton, Water Main Flushing, May 23 through May 27, 2022 and May 31 through June 3, 2022

Fenton, MI: The City of Fenton Water Department will perform water main flushing in Quadrant 2 beginning May 23rd through May 27th. Quadrant 4 will begin on May 31st and continue through June 3rd. Water main flushing will be performed from 10:00PM through 4:00AM to minimize low water pressure conditions.

Flushing water mains removes minerals and sediment that naturally accumulate in the water distribution system. Fire hydrants are used for the flushing process, allowing Water Department personnel to operate fire hydrants to ensure proper function for fire protection.

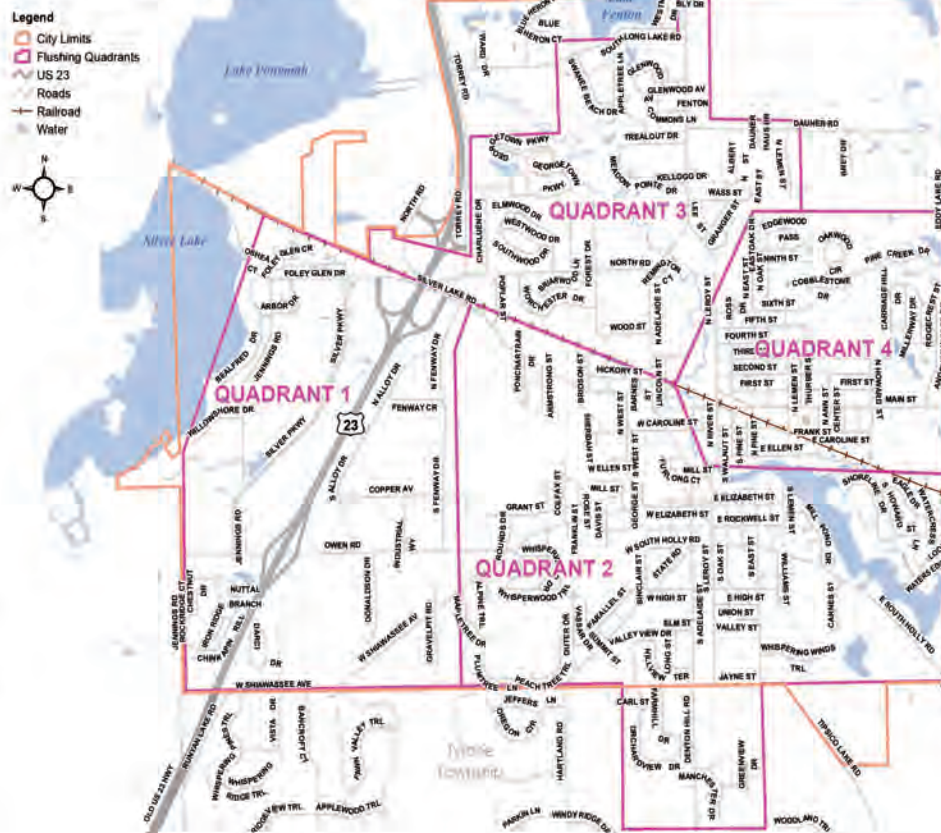
Once flushing is completed in your area, water may appear rust colored because iron and other mineral deposits in the water mains are stirred by high velocity water flow associated with the flushing process. There is no health hazard associated with discolored water and the water customer may need to run the cold water tap at all faucet locations in the home to eliminate discolored water. We recommend waiting a day after any discolored water is flushed from your pipes before doing laundry.

If you are experiencing discolored water after at least five minutes of cold water flushing at all faucets in your home, please contact the City of Fenton Water Department at 810-629-6347 for assistance.

Michigan's tastiest treasure hunt?

■ Hint: it's morels

They're found in every county in our state, but you still might be tempted to go full cloak-and-dagger or blindfold your friends before heading out to your favorite spot — it's that time of year, the annual Michigan treasure hunt that is morel month.

Morel mushrooms are a beloved forest treat that emerge in springtime, usually when warm weather arrives following a good rain. Look for their pitted, bumpy profiles near hilly areas with hardwood trees and around burn scars where a wildfire or prescribed burn has happened.

Before you head into the forest to search for a patch, make sure you know how to properly identify morels for safety; there are wild mushrooms in Michigan that can make you seriously ill. All wild mushrooms should be cleaned and fully cooked before enjoying.

Learn the basics about morel mushrooms from the DNR online at Michigan.gov/MiMorels. You'll find a map of last year's prescribed burn and wildfire areas on public lands to point you in the direction of locations where morels could grow. Find more advanced mushroom information from Midwest American Mycological Information (MAMI) at midwestmycology.org.

Be aware that morels and other foraged finds on state-managed lands are for personal use only and not for resale.

Want to sell morels or other foraged mushrooms? Michigan's food code requires certification to lawfully sell wild mushrooms. Get certified through a partner program offered by MAMI.

Approximately 39% were in the age range of 30-49 years old, 25% were 50 to 64 years old, 23% were 65 and older and 11% were 18 to 29 year olds. Nearly 92% of respondents said they are citizens of Linden or work in Linden.

They identified that the top 10 most positive aspects were the small-town atmosphere (74%), safe neighborhoods and community (65%), friendly people or atmosphere (44%), historic character of community (44%), no limited congestion (31%), quality of the school district (30%), proximity to family or friends (29%), community spirit or civic mindedness (28%), access to non-motorized transportation (27%) and recreation options (23%).

The top 10 least favorable aspects of the city were lack of dining options (60%), lack of shopping, retail and service options (41%), lack of entertainment options (37%), downtown district is not vibrant enough (35%), other (18%), congestion (17%), lack of youth activities (16%), housing costs (12%), lack of recreation options (12%) and loss of small-town atmosphere (12%).

When asked about one thing they would change, common responses were adding more retail, dining and entertainment options, maintaining the small-town character, adding more businesses, having a more vibrant downtown, improving roads, increasing parking downtown, adding youth facilities/activities, Mill building improvements and more.

A majority of respondents said there should be more large and small single family detached homes developed in the city over the next five to 20 years. The age group 65 and older also expressed a desire for more independent senior housing.

“Single-family detached homes, whether large or small, is the clear preference for the type of housing that should be developed in Linden in the future. Beyond single family, a fair number of residents saw the need for attached homes and senior independent living,” according to the report.

In the land use strategy prioritization section, most respondents said preserving natural features, enhancing and directing new development to downtown, improving the motorized transportation network and improving and enhancing community services and infrastructure

were their top priorities.

The survey asked participants to choose three sites or locations in Linden that should be targeted for redevelopment. Common responses were downtown, the Millpond area, the north end business district, the Department of Public Works building, the site in front of Eagle’s Wooden Park and more.

Under economic development, respondents identified challenges to jobs and economic growth to be the following: keeping young, skilled workers; competition from nearby business districts; availability of jobs; high costs; and inadequate transportation infrastructure. Residents support expanding the growth of existing businesses and supporting new businesses.

The city held a focus group in April with 15 community stakeholders representing different elements in the city. The group identified that pedestrian circulation and connectivity provided by sidewalks and trails was one of Linden’s valued features in neighborhoods, along with the small town feel and that it feels safe. However, neighborhoods need road improvements and enhanced code improvement to improve aesthetics.

The group also identified a need for housing for younger families and more affordable housing.

Suggestions for improving the business district include better marketing, establishing a business recruitment packet, funding opportunities, more financial assistance for businesses and more.

Working on getting more young people involved was one of the topics discussed by the focus group, along with developing more things for kids to do in the city. They also identified issues with city services, such as water pressure issues, challenges in finding staff and volunteers, and a need for a community center in Linden.

The Linden, Argentine Township, Fenton and Fenton Township (LAFF) Pathway was recognized as a “highly utilized” asset.

“With this information and one additional public meeting that we’re looking to get scheduled soon, that will be the bulk of the public engagement phase of our master plan update and we’ll be ready to start looking at recommendations moving forward,” Young said.

Of the 190,361 registered voters in Oakland County, 25,754 ballots were cast. These are unofficial results.

- Replacement of worn playground structures and septic systems, new fire protection upgrades and more safety improvements

According to Roper, Holly Area Schools continues to demonstrate fiscal accountability and responsibility in its use of tax dollars. Over the past 15 years, the district has saved taxpayers nearly \$6 million in interest costs by refinancing outstanding bond debt. The district has also improved its Standard & Poor's credit rating from an "A-" to an "A."

"The trust of our community to make wise use of their tax dollars is the cornerstone of our continued success and ability to serve the unique needs of all Bronchos," Roper said. "We will continue to demonstrate fiscal accountability and responsibility as these projects get underway."

The estimated millage that will be levied for the bonds in 2022, under current law, is 3.27 mills (\$3.27 on each \$1,000 of taxable valuation), for a -0- mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is 30 years.

The estimated simple average annual millage anticipated to be required

to retire this bond debt is 3.52 mills (\$3.52 on each \$1,000 of taxable valuation).

Pursuant to state law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.

NOTICE "TO ALL OWNERS, AGENTS OR OCCUPANTS OF LAND IN THE TOWNSHIP OF HOLLY:

Notice is hereby given that after May 25 of this year the provisions of Holly Townships Code of Ordinances, Chapter 10, Article VI, Noxious Weed Ordinance will be enforced.

No owner of any parcel of land within the township or the occupant or agent of such owner shall permit on such parcel of land or upon any sidewalk abutting the same, or upon that portion of any street or alley adjacent to the same between the property line and the curb or traveled portion of such street or alley, any growth of weeds, grass or other rank vegetation to a greater height than six inches on the average, or any accumulation of dead weeds, grass or brush. No such owner or agent shall permit on such land poison ivy, ragweed or any other poisonous, noxious or unhealthful growths.

If after May 1st an owner, agent or occupant has failed to cut or cause such noxious weeds to be destroyed it shall be the duty of the commissioner to abate the nuisance, either utilizing township employees or private contractors which may enter upon such land and destroy by cutting, with or without mechanical equipment, any such weeds and all expenses incurred in such destruction shall be paid by the owner of such land. The township shall have a lien upon land for such expense, to be enforced in the manner prescribed by the general laws of the state providing for the enforcement of tax liens.

(d) Means of abatement.

If an owner, agent or occupant has failed to cut or cause such noxious weeds to be destroyed after receiving notice as hereinbefore provided in subsection 6(b), it shall be the duty of the commissioner to abate the nuisance, either utilizing township employees or private contractors which may enter upon such land and destroy by cutting, with or without mechanical equipment, any such weeds and all expenses incurred in such destruction shall be paid by the owner of such land. The township shall have a lien upon land for such expense, to be enforced in the manner prescribed by the general laws of the state providing for the enforcement of tax liens.

(e) Exclusions.

This Article does not apply to weeds in unimproved lands, designated open space, open fields or fields devoted to growing small crops such as wheat, oats, barley, or rye. In the case of an easement or public property such as a forest preserve, and all other land as to which definite ownership is not known to the commissioner and cannot be established the county board of commissioners shall cause the destruction of noxious weeds in accordance with Public Act 359 of 1941.

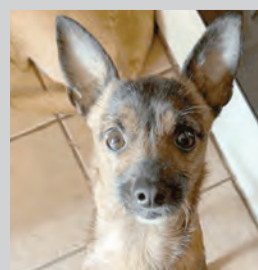

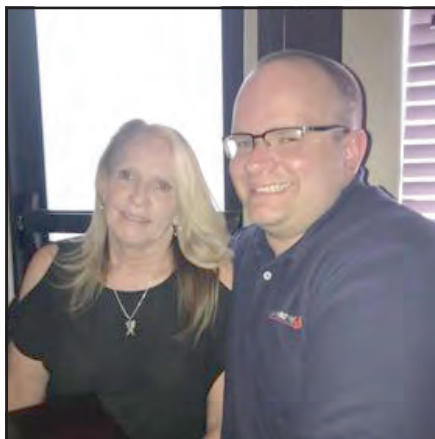
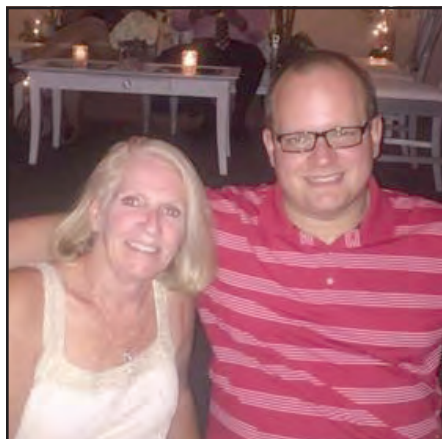

MICHIGAN VOTES

LEGISLATIVE ACTIVITY

MichiganVotes.org is a free, non-partisan website created by the Mackinac Center for Public Policy to provide concise, non-partisan, plain-English descriptions of every bill and vote in the Michigan House and Senate. This report was released Friday, April 8.

The legislature remains in recess for a spring break. Rather than votes, this report describes some proposals legislators have offered related to abortion laws.

The issue is in the news due to speculation that an upcoming U.S. Supreme Court ruling may revise the 1973 Roe v. Wade decision in a way that allows for state bans on abortions up to the 15th week of pregnancy. This could make enforceable a 1931 Michigan law making it a felony to perform an abortion. The 1973 Roe outcome made that law unenforceable, but it was never repealed.

General, police and regulators to enforce it. Republican majorities in both the House and Senate brought the non-binding measures to the floor and passed them on non-roll call voice votes in 2021.

Senate Bill 760 and House Bill 4737: Ban abortions because fetus disabled or not preferred sex or race

Introduced by Sen. Lana Theis (R) and Rep. Julie Calley (R), respectively, to make it a crime subject to two years in prison and a \$50,000 fine to knowingly perform or induce an abortion on a woman who wants it because a test indicates the unborn child has a disability, or is not the sex or race the mother would prefer. Referred to committee, no further action at this time.

Senate Bill 939 and House Bill 5444: Require fetal heartbeat test before abortion

Introduced by Sen. Kim LaSata (R) and Rep. Steve Carra (R), respectively, to prohibit a physician from performing an abortion without first determining whether there is a detectable fetal heartbeat, except in medical emergencies, with violations punishable by up to 15 years in prison. Referred to committee, no further action at this time.

House Bill 5475: Prescribe lessons for public school sex ed classes

Introduced by Sen. Rep. Rachel Hood (D), to require Michigan public school sex education courses to "affirmatively recognize that individuals have different sexual orientations;" "be inclusive of same-sex relationships;" "teach pupils about gender, gender expression, and gender identity, and explore the harm of negative gender stereotypes;" include "an objective discussion...of abortion" and much more. Referred to committee, no further action at this time.

House Bill 5558: Ban fetal tissue research from abortions

To prohibit knowingly performing research using organs, tissues, or cells taken from a dead embryo, fetus, or neonate obtained abortion. This and related bills would repeal an exception that allows this if the mother gives consent. This vote ran along party lines.

Podcast uses faith to help first responders

■ EMS worker of 18 years describes trauma of being first responder

The report on the body is in. It's a 33-year-old male with obvious signs of death. He was beaten. Lacerations were found on his back and a crown of thorns was forced onto his head, scalp and face. He was scourged and bloody, and it's likely he's septic. There's fluid in his lungs. Holes in his hands and feet. His shoulders are dislocated.

His arms are 6 inches longer compared to before the crucifixion.

"Upon review of the scene and the remains of the body of Jesus of Nazareth, I have concluded that the manner of the death of Jesus is murder while the cause of death is cardiac rupture," said Jim Parkin, director/chaplain and cohost of The Lighthouse Experiment podcast. He was narrating as if he was the medical examiner working on the report after finding the body of Jesus.

He and cohost Ashley Chandler, members of the Fenton Freedom Center Church, created the podcast in 2017 to help himself and others deal with the trauma of working in EMS. Parkin has been a first responder for 22 years, 18 of which on the EMS side.

They record weekly episodes with guests that work in EMS or have been touched by the profession. More than 130 episodes can be accessed on Soundcloud, Apple Podcasts and more. This Easter episode, called "Medical Examination of the Crucifixion," was recorded during Holy Week.

They use the podcast to show the ways religion and EMS work can intersect and how faith can help first responders. Considering the idea of looking at a medical report of Jesus' dead body is

striking, but drives home a point. EMS workers and other first responders often see troubling scenarios, horrible wounds and dead bodies.

"It's all here to help first responders deal with the big traumas and the micro traumas of the job," Parkin said. "The intent is to put out encouraging content. Sometimes it's more Bible based than other times. We have added a Monday night house church gather at my house."

Micro traumas are defined as "small, subtle psychic hurts that build up to undermine a person's sense of self-worth, skewing his or her character and com-

promising his or her relatedness to others" by the American Psychological Association. They pile up throughout the years and take a toll on someone's mental health.

"Think of combat veterans and what they deal with on deployment. But then they come off of deployment and there is some down time. For us, there is never really down time. So you have to find ways to off load some of those traumas," he said. "I realized that we all need help and or ways to off load trauma, just with my own experiences, as well as hearing about the first responder suicides across the country."

First responders, including law enforcement officers, firefighters, emergency medical services (EMS) clinicians, and public safety telecommunicators may be at elevated risk for suicide due to the stressful conditions of their occupations, according to the Centers for Disease Control and Prevention.

The rate of suicide for EMS workers and paramedics is 1.39 times higher compared to the general public.

One episode talks about dealing with post traumatic stress with guest Pastor Danny Sanchez, who wrote "Post Traumatic Quest." Other episodes deal with compassion fatigue, empathy and apathy and more. Parkin and Chandler incorporate elements of faith, which he said has been beneficial to his career.

"For me, faith is what keeps my head above water. Especially during that first part of COVID," he said. "With trauma specifically, faith keeps me grounded in the fact that this world isn't heaven. I know that God is with me in this stuff."

The response to the podcast has been good. The Fenton Freedom Center was "completely supportive" from the beginning, Parkin said. So far, they have 136 episodes and they've recently begun videotaping them as well. They record on Tuesday evenings using Zoom.

His message to EMS workers and first responders is that "we're out here."

"We aren't really the shining star of the first responder community. We aren't the police or the fire department guys, it's not as glamorous. But we're out here doing the thing," Parkin said.
