# Village council will not amend election date

■ Police/fire operations millage will remain on November ballot; August results will be invalid

## **By Sharon Stone**

During a special meeting of Holly Village Council on Wednesday, July 27, the council voted unanimously not to amend the election date for the police/ fire public safety operations special assessment ballot item.

On Feb. 8, the Holly Village Council authorized a police/fire public safety operations special assessment proposal of 3 mills for the November General Election ballot. However, the village was notified late last week that Oakland County Elections included this proposal on the ballots for the Aug. 2 Primary Election.

Village Manager Jerry Walker told council that last Thursday a resident brought the ballot item to the village's attention when they saw it on their absentee voter ballot (AVB). He said

that Clerk Deborah Bigger spoke with Oakland County Elections and learned that the ballot item placed on the August ballot was an error at the county level.

Walker told council that village staff recommended to allow the election date be amended to Aug. 2.

# Firefighters recognized for performance

■Credited with quick and effective response for heart attack patient

The Ascension Heart Institute recognized two employees of the village of Holly Fire Department for their quick and effective response for a patient experiencing a heart attack this past spring.

Firefighter/paramedic Kayti Hardman, and firefighter/EMT Will LaFoy, both with Advanced Life Support (ALS) training, responded to a 911 call in the village in May. The caller said a man in his 40s was unresponsive, possibly having a seizure.

Hardman said when she and LaFoy arrived, the patient was not doing well. They immediately set up their cardiac monitor and determined the patient was having a heart attack. Trained in field activation, they alerted the Ascension Genesys in Grand Blanc Township so that the hospital would be ready for the patient.

The Ascension Heart Institute wanted to recognize Hardman and LaFoy for the positive outcome of their patient. "He went home to his family," Hardman said.

Hardman said in 2017, the fire department switched over from a paid


on-call department where the first responders would get alerted at home and then respond to the emergency to a full ALS fire department that is staffed 24/7.

"I'm happy that we've grown," Hardman said. She has been with the department for 10 years and LaFoy has been with the department for three years.

"I live in the village and it's so important to me that we have 24/7 ALS care," she said adding that their patient's outcome could have been different had their response been delayed by being a paid on-call first responder.

Hardman credits other members of the fire department and members of the Holly Police Department who responded to help, as well. "There was a lot of good team work," she said.

LaFoy said, "It went well. I'm glad he made it home and we had a positive outcome."

# Council debates using eminent domain for pathway

# ■Engineers need three more easements from affected property owners

**Linden** — The Linden City Council debated eminent domain, also called condemnation, during the Monday, July 25 meeting in regards to The State Bank Trail, which is planned to be constructed along the south side of Silver Lake Road in 2023.

Municipalities have been asked to pass a resolution of necessity for the non-motorized pathway. It includes language acknowledging that Southern Lakes Parks and Recreation has the power to seize property for the project if necessary in the event that good faith offers are not accepted.

The State Bank Trail, a 2-mile, 10-foot-wide pathway, is expected to be built along the south side of Silver Lake Road, connecting Linden sidewalks at Triangle Park to Fenton City sidewalks.

Currently, SLPR needs easements

from three more properties.

Linden City Manager Ellen Glass said there was a potential for an agreement on one of these properties in the coming weeks. All of these properties are in Fenton Township.

The resolution recognizes SLPR's authority to use a Michigan statute within Chapter 213 of state law that covers eminent domain, also called condemnation. Eminent domain is the process for when the government takes private property for public use and gives property owners fair compensation.

Councilor Aaron Wiens said he doesn't personally support the idea of using eminent domain to obtain these easements.

"I don't personally support the idea of having condemnation as a possible tool for people's property for the pathway. I support the pathway but I don't think that it meets that standard personally. But I also see that that doesn't actually apply to us as the city of Linden right now," he said.

He asked if this resolution would set a precedent or obligation that could affect potential future trails in Linden. Attorney Michael Gildner said he doesn't believe it does and that it "carries as much precedential effect as you wish to give it."

"Is our opinion on it even relevant because it doesn't apply to us? But we're being asked to support it whole hog and not piecemeal," Wiens said. He believed the reason for the resolution was for the municipalities to be a united group in applying for grants.

Wiens said he supports the pathway, but he doesn't believe it warrants theoretically seizing someone's property.

Glass said that Ed Koledo, executive director of SLPR, has been "very great" about communicating with the city of Linden. "They're not seeing where they're going to have to evoke this process at all. That's what communicated to me," she said.

Councilor/Mayor Pro-Tem Brenda Simons, who's on the SLPR board, said that is consistent with what they've been hearing.

Glass said the resolution states that the city recognizes that SLPR has the ability to use eminent domain. SLPR will still have this ability even if Linden doesn't pass it.

Councilor Heather MacDermaid said she agrees with Wiens. She said this might not be an issue at all if SLPR isn't planning on using eminent domain. She had an issue with language in the resolution that states that Linden would agree that eminent domain would be "necessary."

A section of the resolution states: "the city of Linden, Fenton Township, the city of Fenton, and Southern Lakes Parks and Recreation Commission all agree that: (1) acquiring the easements over the properties referenced in Exhibit B is necessary for the completion of The Project, which is critical infrastructure for the Local Units; (2) Southern Lakes Parks and Recreation Commission shall seek to acquire the Easements by condemnation, if neces-



# Beacon & Bridge open in Linden

# ■Company planning a grand reopening closer to Labor Day

**Linden** — Friday, July 1 was a memorable day for Linden residents and Beacon & Bridge Market.

It was the soft opening for the newly redeveloped, two-story convenience store and gas station that reopened after approximately 13 months. Drivers now have another location to purchase gasoline.

The convenience store, which used to be a one-story 2,240-square-foot structure, is now 2,592 square feet. It was moved from the south side to the north side of the property. There are eight gas pumps instead of four, and the pumps are now located on the southern portion.

Eric Patterson, merchandising and marketing manager for Beacon & Bridge, said they're still waiting on materials to finish the canopy, but other than that, the gas pumps are running and the convenience store is open. He expects the materials to arrive the week of Aug. 8.

"It is challenging as a convenience store company because when you're

down for that long, it's hard to get customers back," he said, adding that customer habits shifted when the store closed.

They're working on ways to get customers back, including lower gas prices.

"We came out of the gate pretty aggressive with gas prices to incentivize customers to come back to us," Patterson said. "It was a 'thank you' for being loyal to Beacon & Bridge."

Initially, they had a few bugs and an issue with the filtration system, but operations are running smoothly now.

They opened the convenience store with approximately 85 to 90% of product lines they plan to carry. They scaled back at first due to the small size of the store, and they expect to bring in more products such as live bait and newspapers. Patterson said they also plan to carry more Michigan-made items.

"It's pretty exciting," he said.

The top floor of the building is the manager's office and storage.

"It's great to witness the process from start to finish and see what it was before the remodel, then see it empty, then the final project coming to life," said Patterson, who's worked at Beacon & Bridge for four years. "It's always fun to watch and it's fun to be a part of it and see all the hard work that everyone puts in. We're super appreciative of the people of Linden. Everyone's been really patient."

He sent a big "thank you" to the Linden community for coming back to the gas station and store. They're planning to have a grand reopening closer to Labor Day where they will have giveaways and activities.

which was intensified by the COVID-19 pandemic. The World Health Organization found that the pandemic triggered a 25% increase in the global prevalence of anxiety and depression.

GHS, which is Genesee County's public mental health provider, has helped county residents for more than 50 years with crisis help. In 2021, county voters approved a .94-mill mental health millage, which brings in approximately \$9.4 million each year, which helps the GHS provide mental health services.

Information about the GHS is provided by Lisa Bruder, manager of crisis services, and Carrie Chanter, MA, MCHES, director of prevention, health and wellness at the GHS.

"First and foremost our world, nation and community has experienced levels of ongoing stress that has impacted all of our abilities to manage stress and maintain wellness. When we consider our own community, we know that the Flint Water Crisis, COVID-19, along with high levels of community violence have a lasting and traumatic impact on people and their stress levels of overall emotional wellbeing," according to the GHS.

In 2020, the GHS received 2,834 calls requesting service. In 2021, that number was 3,342 and so far in 2022, they've received 2,312 calls for help. More people utilize their afterhours crisis center, and these numbers are also rising as more people seek help and resources. The GHS afterhours crisis center received 7,851 calls in 2020, 10,000 in 2021, and 7,695 so far in 2022.

"Schools, employers and much more are recognizing the impact that stress can have on people and in turn recognizing the benefits of discussing and supporting mental health more and more. Through these discussions, we lessen the weight of stigma and open opportunities for people to feel heard and understand the impact that stress can have on our body and mind," according to the GHS.

GHS assists people with a variety of needs, including intensive crisis stabilization services, referrals, walkin services and more. Everyone falls somewhere on a spectrum of wellness each day.

"Our daily stressors, our ecology,

our history or resiliency factors and so much more play a role in how we feel and behave every day. Being connected to mental health services is not about coming in to get help with a problem, it is about identifying how your mental health or where you are on that spectrum of wellness can and will impact your ability to live and enjoy your life. If your mental health is getting in the way of your life for whatever reason, we can support you through that need," according to the GHS.

#### SUICIDE

Mental health experts also are reporting a rise in suicide. Suicide is the 10th leading cause of death in Michigan. In Genesee County, 55 residents per year die from suicide. It's the second leading cause of death for youth and young adults aged 10–24 years in Michigan.

"While suicide rates went down in 2020, we are still waiting on 2021/2022 data. The outcome of the COVID-19 pandemic is impossible to predict, but many experts warn to expect an increase in suicide rates. We have already seen an increase in crisis call centers around the nation," according to the GHS. "Youth and young adult suicide rates have been steadily increasing in both Michigan and the United States since 2007."

While suicide affects people of all ages, backgrounds, and racial groups, certain populations are at higher risk for dying by suicide.

"In addition to the youth segment seeing an alarming increase, veterans, middle-aged men, isolated elderly, LG-BTQ youth, youth of color, American Indians and Alaskan Natives continue to be a priority," according to the GHS.

The National Suicide Prevention Lifeline recently became active in July. Anyone can call 988 24/7, 365 days a year to talk to trained counselors that provide free, confidential emotional support for people in distress.

The previous number to the National Suicide Prevention Lifeline (1-800-273-TALK) still works. GHS also offers a free suicide prevention online course (LivingWorks Start) to all Genesee County residents at genhs.org/LivingWorks.

GHS works with local law enforcement agencies to train officers in skills related to mental health and crisis intervention. They offer a 40-hour certification course that is complete

with education on common signs and symptoms of mental health concerns, psychological trauma, working with youth, de-escalation and much more.

"Officers certified in CIT will be priority dispatched when available to 911 calls that include a mental health component. Additionally, we have two masters level social workers who corespond with officers to assist in calls and make direct linkage to our behavioral health urgent care as needed," according to the GHS.

# LOCAL POLICE DEPARTMENTS PROVIDE INPUT

Linden Police Chief Scott Sutter said they haven't had any recent suicides, but they have seen an uptick in mental health calls.

"I believe we've seen an increase in it since COVID has occurred especially," he said. The department utilizes GHS resources when they encounter someone who needs help, which Sutter said helps officers better respond to mental health calls.

"They have great services over there. Our prisons and the justice system are filled with people that have had mental health crises. I think it behooves everyone including law enforcement to address those types of needs so that we can get people plugged into the right places. I think people that have crises such as these are searching. They want help," he said, adding that people experiencing mental health issues sometimes turn to substance abuse. "Expanding services for mental health care — it's a winwin for our community. If we can help people in those situations, it's going to make our community better."

The Fenton Police Department reported an increase in mental health calls in recent years, as well as a decrease in suicides. Acting Police Chief Jeff Cross said there were two suicides in 2019 and 2020, and there was one in 2021. They've had zero calls for suicides in 2022 so far. They received 10 calls for mental health in 2019, 18 in 2020, 24 in 2021 and 13 so far in 2022. Mental health calls can also come in as medical calls, welfare checks or suspicious calls.

Holly Police Chief Jerry Narsh said they haven't seen an increase in suicides.

"Good news is, I can't remember the last one we had. We have always had mental health depression calls. There was a slight uptick during the 2020/2021 pandemic season but even these have tapered off this year, so for us we are seeing less," he said.

sary, in the event the good faith offers are not accepted."

MacDermaid suggested tabling the resolution and coming back to it if necessary.

Councilor Brad Dick recognized that SLPR does have the right to use eminent domain. "I just don't feel that it's our point to give them blessings to take properties," he said, adding that there would be more consideration if these properties were in Linden.

Mayor Danielle Cusson said it is necessary to have all of the easements for the affected properties. She believes this resolution is consistent with the support the city has given for the project.

"We're not getting any additional authority or creating any additional authority," she said, adding that the resolution also recognizes that financial help Linden has contributed to the project.

"If we don't vote in favor of this... I guess I look at it as we're not fully supportive of the path, and we'll get what we want, but we don't want to have to stick our neck out," she said.

Wiens said, "But I'm only supportive of the path if it doesn't require seizing anyone's property."

Gildner said he views this resolution as expressing solidarity with the other municipalities in support of this project, and that SLPR still has the authority of eminent domain.

Included in the meeting packet are offers from SLPR to affected property owners. The amount offered depends on the size of the easement needed for the project. The highest amount offered was approximately \$6,400. These offers expired Jan. 15, 2022.

Swanson also recognized Dep. Justin Hall. He too was infected with the airborne fentanyl while working with the inmates and required medical attention at the hospital.

Swanson said after a long shift, Bradley was preparing to leave to go home, but instead was rushed to Hurley Medical Center where he was hospitalized for two days with fentanyl poisoning.

Swanson said an incoming inmate, Adam Lee Hill, 34, of Flint, allegedly had hidden a bag of pure fentanyl in his anal cavity. He reportedly retrieved the bag and took a dose of the fentanyl and then dropped the bag. Another inmate picked up the bag, was exposed to the fentanyl and needed to be saved by the deputies equipped with Narcan.

During this incident, Bradley was exposed to the deadly fentanyl, which became airborne.

The video showed Bradley struggling to stand and breathe in an area with no other people.

Narrating the video at the press conference, Bradley said, "I blacked out. I needed to find someone. I wouldn't be found for a while here. My body was going limp and my lungs cramped up. It was hard to get a breath."

As Bradley reached a more

visible area, a deputy saw him struggling and issued a Code Blue. Bradley started blacking out but was able to instruct the deputies that he needed to be washed off and he needed oxygen. The deputies used as many as five doses of Narcan to revive Bradley.

While the overdosing inmate was

being transferred to Hurley, Bradley too was rushed to Hurley. Several more doses of Narcan were used as well as a Narcan drip while he was hospitalized.

> Swanson thanked Bradley for his dedication to his profession of serving and protecting. The sheriff added that fentanyl, a synthetic opioid, is so much more dangerous than other drugs and is what is killing people.

The sheriff said since Jan. 1, Genesee County has reported 517 Narcan saves.

During this same time, the drug has killed 137 people.

"Fentanyl is the worst drug taking our people in modern day," Swanson said. He said that it's so dangerous because it's not regulated and the level of strength can vary. It's a very fine powder that can quickly be absorbed by someone's mouth, nose or eyes.

Swanson and Bradley both thanked the quick responses of the deputies, the paramedics and the staff at Hurley.

Bradley said from this experience with fentanyl, he knows he must be more cautious when responding to overdose situations.

Swanson encourages anyone to obtain Narcan and to learn how to use it in the event of accidental exposure or for overdoses of loved ones. He said Narcan is available free at the jail and at other places. He said there is no reason to pay for Narcan and if there is a charge, to go somewhere else and obtain the lifesaving nasal spray free of charge.

Hill, who is charged with bringing contraband into the jail, is facing five felonies. A \$50,000 cash bond was ordered and a probable cause conference has been scheduled for Aug. 4 at 8:30 a.m.


# Michigan football kicks off summer tour in Flint

### AUG. 2

1990: At about 2 a.m. local time, Iraqi forces invade Kuwait, Iraq's tiny, oil-rich neighbor. Kuwait's defense forces were rapidly overwhelmed, and those that were not destroyed retreated to Saudi Arabia. The emir of Kuwait, his family, and other government leaders fled to Saudi Arabia, and within hours Kuwait City had been captured and the Iragis had established a provincial government. By annexing Kuwait, Iraq gained control of 20 percent of the world's oil reserves and, for the first time, a substantial coastline on the Persian Gulf. The same day, the United Nations Security Council unanimously denounced the invasion and demanded Iraq's immediate withdrawal from Kuwait. On August 6, the Security Council imposed a worldwide ban on trade with Iraq.

## AUG. 3

**1958**: The U.S. nuclear submarine Nautilus accomplishes the first undersea voyage to the geographic North Pole. The world's first nuclear submarine, the Nautilus dived at

Point Barrow, Alaska, and traveled nearly 1,000 miles under the Arctic ice cap to reach the top of the world. It then steamed on to Iceland, pioneering a new and shorter route from the Pacific to the Atlantic and Europe. The submarine traveled at a depth of about 500 feet, and the ice cap above varied in thickness from 10 to 50 feet, with the midnight sun of the Arctic shining in varying degrees through the blue ice. At 11:15 p.m. EDT, Commander Anderson announced to his crew: "For the world, our country, and the Navy — the North Pole."

The Fenton Community eGift Card Program encourages people to shop and support their favorite local retailers, restaurants, services and entertainment within the city of Fenton DDA district to keep local dollars in the community. These eGift Cards are only available in a digital format, and accessed from an electronic device. Or, optionally, they can be printed on a piece of paper by the recipient.

To purchase a Fenton Community eGift Card, which is a pre-paid MasterCard, go to FentonGiftCard.com, select the value (prepaid amounts are available in \$25, \$50, \$75, or \$100), choose the recipient (yourself, family, friends, team member, etc.), and send via email or text message.

Volume discounts are available for one time or ongoing purchases of \$1,000 or more paid in advance by check or ACH. Visit FentonGiftCard.com for more details on this program.

The recipient can use the prepaid city of Fenton DDA MasterCard to make purchases at participating Fenton community merchants by presenting the card number to the service employee at the time of payment, in-person or over the phone, which is entered into the point of sale (POS) system as a credit card to access as payment. The card can also be used for online purchases (select businesses only).



Ryan Delaney told council that he was in favor of the fire/police assessment, but allowing an error at the county level to be accepted would have subverted the will of Holly Village Council. "We voted unanimously in February for the November election so that we could take the time and effort to educate and inform the residents," he said. "Stick with what we promised the voters."

During public comment time, resident Sherlyn Everly suggested that the Aug. 2 vote on this police/fire assessment not be counted and let it run in November as approved by council or not on any ballot.

"Use this screw-up as an opportunity to pull it off the table," she said. "Go back to the the drawing board and ask the residents."

Resident John Lauve suggested that they not count the August election results and that would solve the problem. "Tell the machine to skip that square," he said.

Resident Jim Clark said that if council amends the election date and allows the vote on Aug. 2, it would legitimize the error made at the county level.

On Thursday, Walker confirmed that the Aug. 2, ballot proposal question has been invalidated and no votes for this issue will be counted.

"Because we had previously requested by council resolution dated Feb. 8, 2022 for the question to on the November General Election ballot, that is what will happen.

"I spoke with Oakland County Clerk Lisa Brown today (Thursday, July 28) who acknowledged and apologized for the mistake, but there is no remedy except to invalidate the August results for this issue.

"The Council, administration, police and fire chiefs are all happy with the decision to continue on with council's original intent of having the question on the November ballot."

Walker added that there is no question that this has and will cause confusion with the voters.

"It may even foster some incorrect feelings that the village had a part in doing this, but that couldn't be further from the truth. We always wanted the issue to be decided in November because that is a larger voter turnout and that would provide us more time to educate the community as to why the special assessment is needed."

# Fenton's Baur finding his need for speed on the race track

Charlie Baur is just like any other 16-year-old high school kid living in Fenton.

But on Saturday nights during the racing season, he has one special need — a need for speed.

Despite his young age, Baur has been racing at vehicles at various levels since 2019.

This summer, the Powers Catholic student has been as busy as ever, competing not only in Kart races, but also making a transition to sprint cars, and he's having the time of his life.

"I'm having a lot of fun," Baur said on July 22 while showing off his #23 sprint car at a weekly car show in Fenton. "It's enough that I'm racing. It's a lot of fun, busy but not overbearing."

Baur has a pretty nice racing resume for someone who should just be getting his driver's license. While driving quarter midgets in 2019 and 2020, he earned seven feature wins and nine top-three finishes. He recorded three heat wins.

In 2020 while competing on dirt oval Karts, he recorded eight top-three finishes and won six heat races. As a member of the Michigan Midget Racing Association series in Waterford, he finished second in the 2020 Heavy Honda Points Cham-

pionship. A year earlier in the same organization, he earned a first and a third two different events.

Last season, Baur did a lot of Kart racing at Arthur Speedway in Reese. He had a strong season, finishing second in the Blue Plate Predator Points Championship race and fifth in the Blue Plate Clone Points Championship race.

This summer it has been a mixture of Kart events and Baur's new passion — sprint cars. Baur is competing in mustseeracing.com competition in the Midwest Lights Series Championship racing season. The sprint race

be listing our No. 5 to No. 3 teams today) has never finished in the top 16 ever before.

Well, that's enough of the preview. Let's get to today's installment. Only one more remains after this one.

No. 5 - Fenton boys soccer: The Tigers are a hit-or-miss squad when it comes to the top 16 poll. As mentioned earlier, Fenton has made just four other trips into our listing, but when they do, sometimes, it's at a high status. They were No. 14 in our first one way back in 2008-09, but didn't return until 2016-17 when they finished No. 4. Since then, they've become reasonably frequent visitors here, making four of six, taking our Top 16 championship in our 2019-20 poll. They return this season at No. 5.

The Tigers won their first seven games which included a 2-1 victory against Detroit Country Day, earning them a spot in the state's D2 top 10 poll for the rest of the season. After a 1-1 tie against Grand Blanc, the Tigers went on to win seven more straight games

before tying Goodrich 0-0 in a Flint Metro League contest. The Tigers won the league crown outright with an unbeaten 10-0-1 league record.

After that, the postseason tourney began. The Tigers avenged their tie against Goodrich, earning a 2-1 victory. They followed it up with a 3-2 win against Ortonville-Brandon, capturing the district crown at Brandon's own filed.

Regionals began with a pretty convincing 4-1 victory against Chelsea,

but the season came to a conclusion in the regional championship match, which ended up being a 2-1 loss. Fenton ended the season with a 17-2-2 mark, with both losses being tight 2-1 verdicts.

It also was a team for healing for the squad as ex-teammate Jimmy Myers had lost his life after injuries he suffered from an accident.

**No. 4 - Linden girls track and field:** Welcome to the Top 16 girls! This is the first time they have ever made it into our top 16 poll. And what a debut — making their first entry right at No. 4.

The Eagles were our No. 1 squad during the spring, and one of seven spring teams to make the poll this season making the spring season our most dominant sports session of the 2021-22 school year. And the interesting thing is usually at the season's start the sport staff can sense this type of year may be possible. While we knew they'd be a solid team we can't say we honestly expected a top 16 team, much less the No. 4 squad. So how did the Eagles get here?

Well, they Eagles opened some eyes with a pretty nice 81-52 victory against Flushing, setting up a dual with the Fenton Tigers. Fenton defeated the Eagles 80-57, pretty much establishing what most probably thought was the case — the Tigers were still the elite team in the Flint Metro League Stripes Division.

But, apparently that bothered the Eagles because they kept on winning during the remainder of the Metro dual season, finishing 4-1, one loss behind the Fenton Tigers. Then came the Flint Metro League meet, and the Eagles showed their wings. They captured the Metro League Meet Stripes Divi-

sion title with 159 points, just 14 more than the Fenton Tigers, forcing the two area rivals to share the overall crown. It was the Eagles first outright or shared league crown since 2003.

But that's not what got the Eagles to No. 4 here. It was the postseason. Linden put together a strong regional meet, edging out two Metro foes to win a D2 regional team championship. Linden won with 79 points while Goodrich took second with 76 points and Corunna was third with 73 points. That regional championship earned the Eagles a spot in the unofficial team state championship meet hosted by MITCA. At it, the Eagles finished ninth overall.

Finally, came the MHSAA's D2 state meet, and while there the Eagles defended their D2 state championship in the 400 relay, earning the title once again. As a team, the squad scored 12 points, tying for 22nd in the state.

No. 3 - Linden boys cross country: The Eagles found themselves battling the Fenton Tigers for league supremacy last fall, and finished a step behind them in the opening meet by a sixthman tiebreaker. Both squads finished atop the standings with 52 points, but the Tigers won the tiebreaker for first based on their sixth runner finishing in a higher place than Linden's.

Still, that showed the Eagles they had the talent to compete, and in the second league race, Linden defeated Fenton by seven points, netting just 41 team points. Now, with the two area foes tied in first entering the final league event, the Eagles blew out the Tigers by 22 points, earning the outright league championship.

Then came the postseason. The Eagles qualified for the D2 state meet (as they seemingly do every season) when they finished second to a strong Pinckey squad, despite just scoring 42 team points themselves. Then at the D2 state meet, the Eagles had another strong showing, finishing seventh in the state with 259 points.

The Linden boys cross country team can easily be argued as our most successful squad since the start of the polls. They've been in all but three of our top 16s and have been our champion a whopping three times. They also have finished in the runner-up spot twice and third once. That ranks the Eagles as the team that has not only the most first-place finishes, it ranks them as the squad with the most top-three efforts (six).



# '68 Tigers drop Indians out of AL race after dominant four-game series

When the Cleveland Indians came to Tiger Stadium for a four-game series with the first place 1968 Tigers, any hopes for the Indians to make one last plunge for first place had to happen in the next four contests.

The third-place Indians were 8 1/2 games behind after Aug. 5th action, while the Orioles trailed the Tigers by just 5 1/2. If nothing else, the Indians seemed like as good a candidate to give the Tigers' pennant bus a flat tire, possibly helping the Orioles' quest to contend.


The four-game series started with a twinbill on Aug. 6 in front of 48,413 mostly Detroit fans. The first game was the longest one of the season — a 2-1 17-inning victory for the Tigers.

John Hiller was getting a spot start against the Indians' Luis Tiant, who was having an outstanding season as well. Cleveland broke the tie in the third on Jose Cardenal's RBI-single, plating Tommy Harper, who also singled. The Tigers didn't tie it until the bottom of the ninth against Tiant when Don Wert hit a one-out home run, his 11th of the season. The game remained tied at 1-all until Detroit's 17th. Willie Horton began it with a lead-off single, and Bill Freehan was hit by a pitch. Don Wert hit into a fielder's choice play, getting Horton out at third, but Dick Tracewski followed with an RBI-single, plating Freehan from second base. The game that took 4:28 to play was a Tigers' victory.

"It came at the right time," Tracewski said about his first hit in a week. "It was a high fastball. Just like the pitch he threw me before the hit, and I swung right through it."

Hiller actually set a Major League Baseball record early in the contest when he struck out the first six men he faced in the opening two innings.

The second game was also a 5-2 Tigers' win, but couldn't be finished that night due to curfew rules. Detroit scored four runs in the sixth with Wert hitting an RBI-single and Al Kaline hitting a two-run double. A fourth run scored on a wild pitch. The ninth inning wasn't played until a day later, and ended pret-

ty uneventful.

The Tigers kept rolling, crushing the Indians 6-1 in Wednesday's third game of the series. Dave Campbell, a minor league call-up who didn't last long with the squad, hit a two-run home run eighth inning. Also hitting a four-bagger in the eighth was Horton, who now had 27 home runs on the season. Earl Wilson tossed six innings of one-run ball for the win while Daryl Patterson pitched three innings of shutout ball for the save.

The Tigers' domination of the Indians was complete during Thursday's final contest, as Denny McLain tossed a six-hitter and Bill Freehan hit a pair of two-run home runs in a 13-1 Tigers' win.

After the game there was some other big news. It was announced that Detroit's nine-month newspaper strike was finally over. That meant the Tigers were finally going to get some coverage from the Detroit publications.

"When we have player meetings we sit around and interview one another," Detroit manager Mayo Smith said. "That's so when the writers come back, we won't be out of practice."



season includes seven dates at three race tracks. Loraine Raceway Park in Ohio hosts five of the events while one is held at Sandusky Speedway and another was held at Kalamazoo Speedway.

"The season has been going pretty good so far," Baur said. "We've had two or three races since Kalamazoo (held on Memorial Day weekened) and we've done well. I've learned so much, and we have been working on the car more and more. The more we work on it, the more I'm learning about it. At first, there were changes we didn't know about, and now that we've made the changes, we are getting two-tenths or half-a-second faster now, so as the season progresses, we are definitely getting faster."

In the 2022 Midwest Lights Series Championship points race, Baur currently is in seventh place. His season started with a ninth-place finish at the first race at Lorain Raceway, but he has steadily progressed since then.

At Kalamazoo Speedway he fin-

ished sixth in the feature held during Memorial Day weekend and followed that up by taking fifth at Lorain on June 17. On July 9, the series returned to Lorain and Baur placed eighth. His qualifying time of 14.011 seconds on the 3/8ths-mile track was the fifth best in the field. His next race is Aug. 6, at

Lorain, once again.

The fifth-place finish ranked as Baur's best in the sprint car.

"We had a strong car that day," Baur said. "We were learning and were getting used to the car. Because we'd raced at Kalamazoo and Lorain before, we already had a game plan on what we wanted to do. We started 10th and through the laps we constantly working on passing people."

As a rookie driver, Baur has had to start in the back of the field until he earned some experience. That will change now that he's competed.

"Lifting my rookie status forced me to start at the back of the pack and I'd have to drive up through the field," Baur said. "I couldn't start fourth or fifth and drive up (to the front of the field). I'd have to start (in the last

row) and have to drive to get to fifth."

Baur is racing against drivers double and triple his age in the sprint car division. It's earning him some notoriety.

"We did an autograph session and a lot of the drivers are 40 and 50 years old," Baur said. "People were coming to me and asking how old I was. I'd tell them 16. ... They were like, 'no way can you drive this car when you are 16.""

Baur thinks his age helps him during the raceday. Saturdays can be long. He says they'll leave to drive to the track by 8 a.m. and they won't finish the day at the track until about 1 a.m. Sunday.

"It definitely helps with stamina," Baur said. "I notice a lot of drivers fall off later in the race. Around 20 to 25 laps they start to fall off more. They are getting tired and sweating. Me being younger and more fit helps me last longer and perform better."

Baur still competes in Kart races, and has won two of his races at Arthur Speedway in Reese this season, one in the Clone Master Class and the other in the Predator Lite Class. Last weekend, he placed second in the Clone Master and fourth in the Predator Class despite having to make an engine change.

"I'm kind of shifting (to sprints)," Baur said. "We've won in Karts and proved we are dominant on the track. Usually me or my buddy were in front, and it's always the same track. I like going to different tracks and seeing different things. That's part of the challenge — finding what is (a) good (setup) on that track versus the track we raced on before."







MichiganVotes.org is a free, non-partisan website created by the Mackinac Center for Public Policy to provide concise, non-partisan, plain-English descriptions of every bill and vote in the Michigan House and Senate. This report was released Friday, July 1.

The Michigan Legislature has adjourned until July 20 after passing scores of bills deep into the night of June 30/July 1. Roll call tallies for all those votes have not yet been published, so this report describes a few of the bills introduced in this 101st Michigan Legislature to grant selective income and business tax credits to certain individuals and businesses. Next week's report will contain key roll call votes from this week's sessions.

#### House Bill 6262: Give employers tax credits to subsidize workers' college loans

Introduced by Rep. Sarah Anthony (D), to give employers state business tax credits of up to \$1,800 that would cover half of the contributions the employer makes to repaying the college loans of up to 20 employees. The amount the credit exceeds the employer's tax liability would not be "refunded" (i.e. a cash subsidy) but could be "carrier forward" and used against up 10 years of future tax liability. The bill earmarks \$1.5 million for the credits, payable on a first-come-first serve basis, with half reserved for smaller employers. Referred to committee, no further action at this time.

### **House Bill 6238: Authorize income** tax credit for donating blood

Introduced by Rep. Rachel Hood (D), to authorize an income tax credit of \$25 for each time a taxpayer donates blood, up to \$100 per tax year. Referred to committee, no further action at this time.

### House Bill 6236: Give \$1,000 to electric car buyers

Introduced by Rep. Samantha Steckloff (D), to authorize giving a \$1,000 income tax credit to individu-

als who pay up to \$80,000 to buy a car powered solely by electric batteries. If the credit exceeds the taxpayer's annual tax bill, the unused portion could be "carried forward" and applied against up to five years of future income tax liability. Referred to committee, no further action at this

### House Bill 6237: Authorize income tax credit for buying solar cells

Introduced by Rep. Abraham Aiyash (D), to authorize an income tax credit for both businesses and individuals equal to 10% of the cost of a photovoltaic energy system. If the credit exceeds the taxpayer's annual income tax bill, the unused portion could be "carried forward" and applied against up to five years of future income tax liability. Referred to committee, no further action at this

# Senate Bill 697: Give selective income tax credits for certain farm

Introduced by Sen. Kim LaSata (R), to authorize individual income tax credits of up to \$32,000 for an owner who sells a farm or other "agricultural assets" to a "beginning farmer" as defined in the bill, and smaller credits for renting-out the property or assets, subject to approval by specified state officials. Reported from committee to the full Senate, further action pending.

#### Senate Bill 862 and 863: Give \$110 million annually in tax credits to some film producers

Introduced by Sen. Adam Hollier (D) and Sen. Wayne Schmidt (R), to authorize giving up to \$110 million annually in state income tax credits to certain film producers who do all or part of a production in Michigan. The amount that a credit exceeds a producer's tax liability could be carried forward and used to reduce taxes in future years. Provisions of the proposal are divided between Senate Bills 862 and 863, and House Bill 5724 and 5725. An earlier version of his program repealed in 2015 delivered more than \$400 million state taxpayer dollars to Hollywood producers and others. Referred to committee, no further action at this
