

Township adopts Thompson Road Corridor Plan

■ Plan outlines zoning classifications and potential future land uses

Creating a more walkable, commercial and retail-friendly and expansive Thompson Road Corridor is the plan.

The Fenton Township Board of

Trustees adopted the final draft of the 2022 Thompson Road Corridor Subarea Master Plan on Tuesday, Aug. 23.

“This has been a process that’s been ongoing for 20 years,” said Michael Deem, Fenton Township zoning administrator, referencing how long the township has discussed developing Thompson Road. The planning com-

mission adopted the plan on Thursday, Aug. 11 and they recommend the board of trustees do the same.

This plan, which officials and the planning commission have been working on for the last eight months, will be a guideline to help the township consider proposed developments in an area with expanding infrastructure, including mu-

nicipal water and a widened Thompson Road bridge.

The corridor encompasses Jennings Road, from Ray Road to Lahring Road, east along Thompson Road and past Fenton Road. It also includes land north of North Long Lake Road.

Linden passes resolution of necessity for pathway

■ Pathway expected to be built in spring of 2023

Linden — On Monday, Aug. 22, Linden City Council passed a “resolution of necessity” for the pathway that’s planned to be built along Silver Lake Road in spring of 2023.

This comes a month after the Monday, July 25 meeting when a few of the councilors indicated they were not supportive of using condemnation, also called eminent domain, to obtain the land necessary for the pathway. They took no action on the resolution at the time.

Linden business plans to expand

■ City creates commercial rehabilitation district

Linden — On Monday, Aug. 22, Linden City Council voted to approve establishing a commercial rehabilitation district in downtown Linden to make it possible for a business to apply for a tax exemption.

The district includes Linden Family Eye Care at 123 E. Broad Street, which is owned by Bryan and Gerianne Mulanix. Byran Mulanix is the community and economic development director in Linden.

The Commercial Rehabilitation Act of 2005 encourages the rehabilitation of commercial

Named 2022 Bush Award recipients



Children aren't props

This is not going to be a nice, happy column. I recently finished Jennette McCurdy's book, "I'm Glad My Mom Died," and so much of it is disturbing and concerning.

Jennette McCurdy played Sam on *iCarly*, a Nickelodeon show, from 2007 to 2012. As a millennial, I grew up watching these shows and she's close in age to me, so I feel a type of kinship with her.

McCurdy writes about how her mom forced her into acting at a young age, was emotional abusive and manipulative up until the day she died, how her mom regularly sexually assaulted her into her teen years, and how her mother gave her an eating disorder.

It's not a happy book. It's about trauma and lost childhood and dealing with immense amounts of fame when your brain isn't fully developed.

It's also about how Jennette turned down \$300,000 of hush money from Nickelodeon to not talk about her experiences with Dan Schneider (though she only calls him the creator, but everyone knows it's him because of his reputation and because he created "iCarly.") He was emotionally abusive, manipulative and caused irreparable harm to many young kids that worked on his shows.

This book, along with a few other recent news items, has made me ponder and lament how so many people are willing to exploit and abuse children, or turn a blind eye to it, if it means they get paid.

What's going to happen to these children in the future? Millions of people will forever have access to videos of their parents telling the world when they started their period, or when they started wearing bras, or talking about sensitive and private childhood moments.

Children deserve privacy. They cannot legally give consent. They are the most vulnerable population, and I have such little respect for people who treat them like money-making props.

ALDI approved

■ Final site plan approved for popular grocery store

Fenton — ALDI is coming to Fenton. On Thursday, Aug. 25, the Fenton Planning Commission approved the final site plan for ALDI grocery store which is proposed to be built between Target and the Fenton High School property.

Applicants are requesting to build a 20,664 square foot facility.

The area is 3.67 acres immediately east of the Shoppes of Fenton, which is the Target complex, and west of the Fenton High School stadium property. It is zoned general business/planned unit development. Fenton Area Public Schools currently owns the land. The proposed ALDI location will be split from the parent parcel.

The submitted site plan shows the access driveway to ALDI would be off the Target driveway, not Owen Road. Applicants submitted plans for

a 100-space parking lot and a retention basin. They are required to have a minimum of 91 spaces.

“They are making connections to existing sidewalks and making the site walkable,” said Justin Sprague, vice president of CIB Planning, Fenton’s planning consultant.

They meet the requirements under the zoning classifications. He said two signs are allowed on a corner lot. The dumpster enclosure and masonry wall will be built on the south side of the property, and they are also proposing a 29-foot light pole but were approved to go up to 30 feet.

Sprague recommended approval with certain conditions relating to building design, lighting parking, the buffer zone and a few other topics. The city traffic engineer reviewed the plan and told the commission there were no fatal flaws and they do not require a revised analysis.



Chris Grzenkovicz, representative for ALDI from the engineering and surveying company Desine Inc., spoke at the meeting and explained the facility design.

“This is really a more modern design,” he said, comparing it to the ALDI in Livonia and Chesterfield.

One commission member asked how much of the ALDI building will be visible if they’re standing at the neighboring football field. Grzenkovicz said they’re going to make the hill smaller and he estimated the building will be 8 to 14 feet above the eastern property.

A few commission members asked if they plan to construct a fire hydrant, which the Fenton fire chief requested. Grzenkovicz said he’ll work out a solution with the chief.

input and looked at previous Thompson Road Corridor Plans. Most respondents were supportive of bringing in municipal water, which Deem said will be a “dramatic change” and that the township needed a more detailed future land use plan.

The Thompson Road Water Project is a multi-community partnership between Fenton Township and Mundy Township. Phase one entails constructing a water main along Thompson Road and connecting to an existing Mundy Township line on Fenton Road. Construction is set to begin in 2022.

Phase II will bring water south along Jennings Road to Lahring Road, where it will continue east to Torrey Road, and loop back north to Thompson Road. Construction is set to begin in 2023, according to the plan.

They expect to see an increase in proposed developments due to the addition of municipal water.

“We needed to make sure that the development that we have coming in... is planned and consistent with the vision of the township,” Deem said. “One of the things that happens when you get utilities where utilities weren’t before is people wanting to continue to expand them. It is important that we have an up-to-date plan in place so that we’re able to maintain our rural character where it’s necessary.”

Deem said the future land use plan is the most important, and that there are only “slight” changes to zoning classifications compared to the master plan.

Currently, most of the land along Thompson Road, east of U.S. 23, is zoned mixed use, planned unit development, industrial and commercial. It houses a mix of businesses from retail, restaurants and factories.

Previously, before the township had plans for municipal water, the mixed use classifications and guidelines were flexible to let developers present their plans and make their case in front of the township, Deem said.

One of the most significant changes with this new plan is the creation of the Town Center District.

“It would incorporate commercial, it could incorporate residential, civic uses, public spaces, high density residential, but the key to this is that it is a planned project. The intent is not just to allow a strip mall here, a strip mall there,” he said. Deem compared it to Hill Road, where there are hotels and healthcare facilities in specific areas off of U.S. 23. “It’s a mixed use planned development that has a thought in mind behind it.”

The Highway Service District is a mix of auto, industrial and commercial. The township wishes to continue this and add buffer and design requirements.

“This biggest change to this is not actually Thompson and U.S. 23. It would be Fenton and Thompson Road. The plan currently is a little bit of low density residential, mobile home park... but now what we’re showing is high density residential and then another commercial node at the intersection of Fenton and Thompson Road,” Deem said. They identified more areas for commercial use in this section of the township.

The plan also recommends widening Thompson Road to support future devel-

opment.

“We need to improve Thompson Road west of the interchange and bring it up to AASHTO (American Association of State Highway and Transportation Officials) standards, make it a four season road, have the appropriate number of lanes,” Deem said. “We need to promote roundabouts.”

He said the Thompson and Fenton roads intersection could become a roundabout to keep traffic moving. Widening the Thompson Road bridge, a project that

already has a dedicated \$10 million from the state, is also expected to alleviate traffic flow.

“Even Genesee County admits it’s an obsolete bridge. It’s functional. It works. But the level of service shows that it’s failing,” Deem said. “Without changes to the intersection there, you can’t see new development.”

Constructing a 10-foot wide path on the south side of Thompson Road and a 5-foot path along the north side has been in the Thompson Road Corridor plan for approximately 15 years. Having safe paths to walk to school was one of the main concerns for respondents.

Starting in September, the planning commission will look at zoning ordinance amendments.

After a discussion, the board unanimously approved the plan.

Trustee Mark Goupil, who’s said previously that he wishes to maintain the rural feel of the township, said they don’t need a Hill Road in Fenton Township. He has concerns about developments not stop-

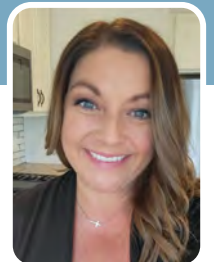

The Michigan House and Senate did not meet this week, so this report describes some bills and votes related to private and public sector unions and unionization. The legislature remains in recess until Aug. 17.

Senate Bill 922: Let teachers union bargain against privatization

Introduced by Sen. Sean McCann (D), to repeal a ban on public schools bargaining with employee unions over outsourcing non-instructional services to private companies, and over many other management issues including layoff policies, school calendars, and more. Union bargainers instead would be permitted to seek contract provisions that ban outsourcing. Referred to committee, no further action at this time.

House Bill 6099: Impose union "prevailing wage" mandate on private and public "renewable energy projects"

Introduced by Rep. Rachel Hood (D), to impose a "prevailing wage" mandate that would prohibit a person from awarding a contract to the lowest bidder for a "renewable energy project" unless the contractor pays wages based on pay scales that local union officials represent as prevalent in a particular area. Referred to committee, no further action at this time.

Senate Bill 1094: Repeal ban on schools giving pay or benefit increases if union contract expired

Introduced by Sen. Marshall Bullock (D), to repeal a 2011 law that prohibited school districts from giving seniority-based automatic pay hikes if their union contract has expired and no replacement has been negotiated. The bill would also repeal a ban on making a new contract's terms retroactive to the expiration date of the old one. Referred to committee, no further action at this time.

House Bill 6078: Mandate school boards record and post union collective bargaining sessions

Introduced by Rep. Brad Paquette (R), to mandate that public school boards make audio recordings of their collective bargaining sessions with the teachers union, and post them without edits on the district's homepage within two days. Referred to committee, no further action at this time.

Senate Bill 914: Impose binding arbitration mandate on all state agencies

Introduced by Sen. Betty Jean Alexander (D), to impose a "binding arbitration" mandate on every state agency, not just the state police. This would invest binding arbitration panels with the power to impose contract terms between state agencies and employees when unions claim a collective bargaining "impasse." This is tied to Senate Joint Resolution M, which would place the mandate in the state constitution if approved by voters. Referred to committee, no further action at this time.

Senate Bill 908: Prohibit employer policies on off-work conduct

Introduced by Sen. Marshall Bullock (D), to prohibit an employer from having a policy against employing an individual on the basis of legal conduct by the individual during nonworking hours. Referred to committee, no further action at this time.

Senate Bill 907: Restrict certain employer communications to workers

Introduced by Sen. Jeff Irwin (D), to make it unlawful for an employer to require an employee to attend an employer-sponsored meeting or other communication with the employer if the primary purpose is to discourage unionization. The bill also applies to communications about the employer's religious or political views. Referred to committee, no further action at this time.

Senate Bill 898: Define relocating unionized government facility as unfair

Introduced by Sen. Adam Hollier (D), to define as an "unfair labor practice" a government employer choosing to close, relocate or outsource operations at a facility within a year of its employees authorizing a union there. House Bill 5816 would apply the same restriction to private workplaces. Referred to committee, no further action at this time.

House Bill 5424: Ban using taxpayer dollar to pay school employee union expenses

Introduced by Rep. Pamela Hornberger (R), to make it unlawful for public schools to contribute toward the union or "education association" dues assumed by teachers, school superintendents, principals and administrators, building directors, school building "liaisons," "central office administrators and staff" and related positions. Referred to committee, no further action at this time.

Senate Bill 477: Let police union agent walk away from member's invalid discipline grievance

Introduced by Sen. Adam Hollier (D), to make exceptions to a law that requires a police union bargaining agent to represent a police officer who is aggrieved by a disciplinary action taken against him, where the union representative determines the grievance is without merit. Referred to committee, no further action at this time.

House Bill 4262: Ban union bargaining over school calendars

and schedules

Introduced by Rep. Pamela Hornberger (R), to add school calendars and schedules to the list of prohibited subjects of collective bargaining between school districts and public employee unions. Referred to committee, no further action at this time.

House Bill 4176: Require government employees to pay union dues as a condition of employment

Introduced by Rep. Terry Sabo (D), to prohibit the state or local governments from entering a union contract that does not require their employees to pay union dues and fees as a condition of employment. This would go against the 2018 ruling of the U.S. Supreme Court in Janus vs. AFSCME, which held that requiring government workers to pay union dues violates their First Amendment rights to freedom of speech and freedom of association. The bill is sponsored or cosponsored by 49 of 52 Michigan House Democrats. Referred to committee, no further action at this time.

Township repeals building moratorium

■ Township finishes subarea plan for Thompson Road Corridor

On Tuesday, Aug. 23, the Fenton Township Board of Trustees repealed the Thompson Road Corridor building moratorium.

The moratorium was originally enacted on Tuesday, Feb. 15 due to increased interest in the land and was set to expire in 180 days. The Fenton Township Planning Commission used the time to develop a subarea plan to address health, safety and welfare concerns before allowing new projects and developments.

The moratorium, which was extended in June, applied to rezoning applications, land divisions, subdivision approvals, special land use permits, building permits and site plan approvals. It did not apply to basic maintenance, interior construction work, repair or installation of utility facilities, demolition or repair of features that present a risk to public health and safety, and it did not apply to permits granted prior to the effective date of the temporary moratorium.

The planning commission adopted the 2022 Thompson Road Corridor Plan on Thursday, Aug. 11 and the township adopted it on Tuesday, Aug. 23.

With the plan adopted, the moratorium was no longer necessary.

property by abating the property taxes generated from new investment for a period up to 10 years, according to the Michigan Economic Development Corporation. Facilities that qualify include multi-family residential, commercial business enterprises or qualified retail food establishments.

Mulanix said this law helps bring development in areas that are underutilized or were affected by incidents such as fires. This location burned down during the 2007 fire.

The couple plans to expand the building, which is currently 1,100 square feet, west onto the neighboring parcel they own. They will expand the first floor business operations, add an examination room and more space for staff. The first floor is expected to be 3,200 square feet when done.

They plan to construct two 1,000 square-foot apartments on the second story. They refer to the apartments as the

Mill Yard Loft due to the history of the land. When construction is complete, the building will be approximately 5,200 square feet.

Mulanix said they'd like to bring a little more activity downtown.

City Attorney Michael Gildner said in order to qualify for the exemption, they have to show that the property was used for commercial purposes within the last 15 years. He believes they are eligible to be classified as a commercial rehabilitation district.

City Manager Ellen Glass believes the area fits the criteria.

The Mulanix's are requesting a six-year abatement on property taxes. The city has not yet voted on this. Mulanix said he really hopes the city approves the abatement.

Multiple councilors and residents spoke in support of creating the district. The city previously approved creating a commercial rehabilitation district and the tax abatement for the Dr. Wax building.

The 2-mile, 10-foot-wide non-motorized pathway, called The State Bank Trail, that will be built along the south side of Silver Lake Road, will connect Linden sidewalks at Triangle Park to Fenton City sidewalks. Southern Lakes Parks and Recreation is in the process of gathering easements from affected property owners.

Ed Koledo, executive director at Southern Lakes Parks & Recreation, was not present for the July 25 meeting. He sent a letter to the city and attended the Aug. 22 meeting. The letter states that Fenton Township and Fenton passed the resolution and that SLPR intends to “negotiate in good faith with each property owner who required an easement.” Originally, there were 18 property owners that required easements. That number is now three.

The resolution states that these mu-

nicipalities recognize that SLPR has the authority to use eminent domain.

“While voluntarily easement acquisition is preferred by municipalities when constructing public projects, it is not always possible, especially on a linear project of this type, that all easements will be acquired, even with compensation,” Koledo wrote in the letter.

Michigan does not permit eminent domain to be used for private use or benefit. The resolution states that the pathway is a “necessary” public infrastructure project and that completing the project is in the best interest of the public.

“Accordingly, even though it appears the easement hold-outs are in Fenton Township, it would be prudent and relevant for each municipal partner to make the finding of necessity that the trail-way is a proper public infrastructure that will not be for a private use, but a necessary public use. This allows the eminent domain power to be exercised,

if necessary, to complete this public project,” Koledo wrote.

A few of the councilors who had concerns told Koledo his letter cleared up some of their questions.

The resolution

The resolution states, “The State Bank Trail has been identified as a Tier 1: Short Term Priority in the Genesee County Regional Non-Motorized Long Range Transportation plan where Tier 1 pathways represent those which have strong public support and are the highest priority for development.”

The 2-mile pathway will be 10-feet wide and paved with a minimum of 2 feet of clearance on either side or a 14 feet wide reinforced boardwalk with all improvements meeting American Association of State Highway and Transportation Officials (AASHTO) and Americans with Disabilities Act (ADA) requirements. The city of Fenton accepts ownership of the trail and will be responsible for maintenance in

perpetuity.

A significant amount of funding has been secured.

- The Michigan Department of Transportation TAP funds: \$996,752
- The Michigan Department of Natural Resources, Michigan Natural Resources Trust Fund: \$300,000
- The Genesee County Metropolitan Planning Commission: \$441,509.
- The State Bank: \$500,000
- LAFF Pathways, Inc.: \$ 48,000.00
- Linden, Fenton, Fenton Township and SLPR have all committed \$15,000 each.

The resolution also states that these parties agree that, “acquiring the easements over the properties referenced in Exhibit B is necessary for the completion of The Project, which is critical infrastructure for the Local Units; (2) Southern Lakes Parks and Recreation Commission shall seek to acquire the Easements by condemnation, if necessary, in the event the good faith offers are not accepted.”

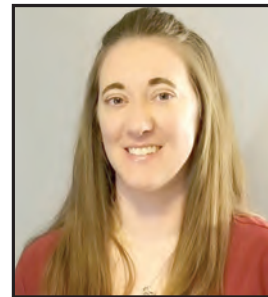

LOOKING BACK at this week in HISTORY

AUG. 28

1996: After four years of separation, Charles, Prince of Wales and heir to the British throne, and his wife, Princess Diana, formally divorce. On July 29, 1981, nearly one billion television viewers in 74 countries tuned in to witness the marriage of Prince Charles to Lady Diana Spencer, a young English schoolteacher. Married in a grand ceremony at St. Paul's Cathedral in the presence of 2,650 guests, the couple's romance was, for the moment, the envy of the world. Their first child, Prince William, was born in 1982, and their second, Prince Harry, in 1984. On Aug. 31, 1997, she was killed with her companion Dodi Fayed in a car accident in Paris.

AUG. 29

2005: Hurricane Katrina makes landfall near New Orleans, Louisiana, as a Category 3 hurricane. Despite being only the third most powerful storm of the 2005 hurricane season, Katrina was among the worst natural disasters in the history of the United States. In the wake of the storm, there were over 50 failures of the levees and flood walls around New Orleans and its suburbs. The levee and flood wall failures caused widespread flooding. In a 2006 federal report, the U.S. Army Corps of Engineers admitted that the flood-control complex surrounding New Orleans had been incomplete, insufficient and improperly maintained.

AUG. 30

1963: John F. Kennedy becomes the first U.S. president to have a direct phone line to the Kremlin in Moscow. The "hotline" was designed to facilitate communication between the president and Soviet premier. The establishment of the hotline to the Kremlin came in the wake of the October 1962 Cuban Missile Crisis, in which the U.S. and U.S.S.R had come dangerously close to all-out nuclear war. Kennedy's administration had discovered that the Soviets had planted missiles capable of launching nuclear warheads into the U.S. on the island of Cuba. The highly tense diplomatic exchange that followed was plagued by delays caused by slow and tedious communication systems.

AUG. 31

1888: Prostitute Mary Ann Nichols, the first known victim of London

serial killer "Jack the Ripper," is found murdered and mutilated in the city's Whitechapel district. London saw four more victims of the murderer during the next few months, but no suspect was ever found. That summer, a serial killer began targeting prostitutes. On Sept. 8, the killer claimed his second victim, Annie Chapman, and on Sept. 30, two more prostitutes, Liz Stride and Kate Eddowes, were murdered and carved up on the same night. In 1892, with no leads found and no more murders recorded, the Jack the Ripper file was closed.

SEPT. 1

1972: In what's billed as the "Match of the Century," American chess grandmaster Bobby Fischer defeats Russian Boris Spassky during the World Chess Championship in Reykjavik, Iceland. In the world's most publicized title match ever played, Fischer, a 29-year-old Brooklynite, became the first American to win the competition since its inception in 1866. The victory also

marked the first time a non-Russian had won the event in 24 years.

SEPT. 2

1945: Aboard the USS Missouri in Tokyo Bay, Japan formally surrenders to the Allies, bringing an end to World War II. By the summer of 1945, the defeat of Japan was a foregone conclusion. The Japanese navy and air force were destroyed. The Allied naval blockade of Japan and intensive bombing of Japanese cities had left the country and its economy devastated. At the end of June, the Americans captured Okinawa, a Japanese island from which the Allies could launch an invasion of the main Japanese home islands. U.S. General Douglas MacArthur was put in charge of the invasion, which was code-named "Operation Olympic" and set for November 1945.

SEPT. 3

2004: A three-day hostage crisis at a Russian school comes to a violent conclusion after a gun battle erupts

between the hostage-takers and Russian security forces. In the end, over 300 people died, many of them children, while hundreds more were injured. On the morning of Sept. 1, a group of Chechan terrorists surrounded students, teachers and parents on the playground of School No. 1 in Beslan as they held a celebration in honor of the first day of the school year. An estimated 1,200 adults and children, were herded into the school gym, which the hostage-takers rigged with a number of explosive devices. Negotiations broke down after two days and early on the afternoon of Sept. 3, an explosion went off in the gym—accidentally, according to some survivors. Some hostages died immediately, and more were killed or injured when the gym collapsed. Further chaos ensued as Russian police and soldiers opened fire on the school. Some hostages were moved to the cafeteria and forced to stand at the windows as human shields, where they were caught in the crossfire.

"Last year, obviously, they beat up on us pretty good," junior running back and lineback-

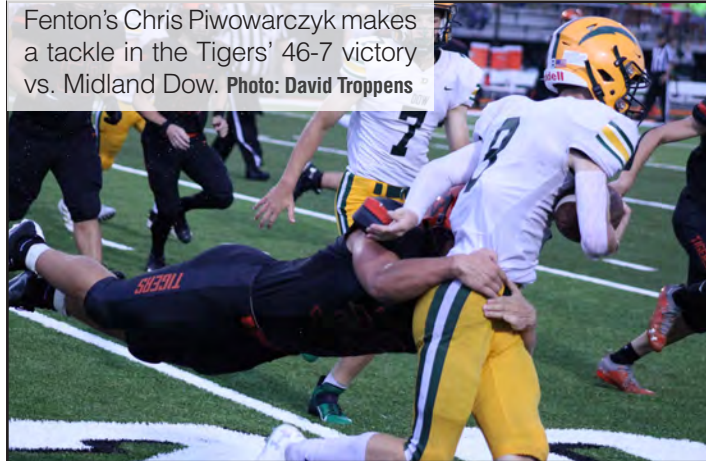
er Jake Nichols said. "We have practiced all summer and all off-season. We came ready to play, came out hot and played better."

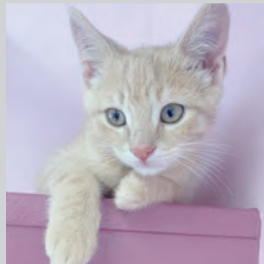

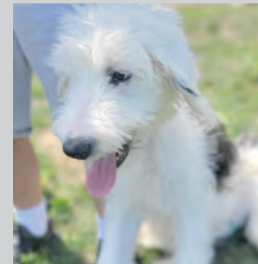

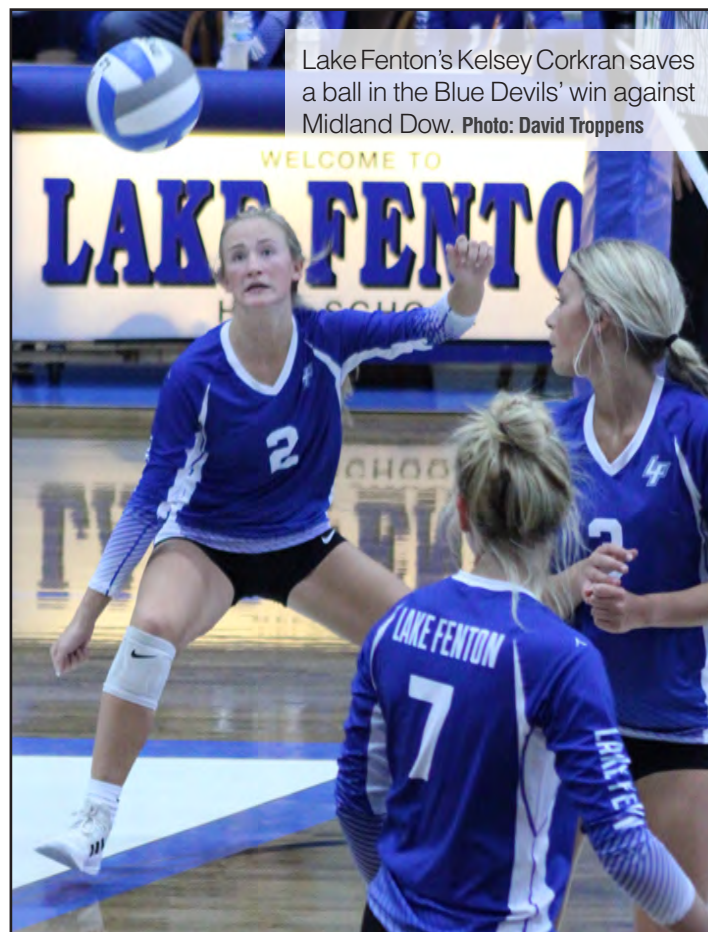
“A win is a win,” Lake Fenton varsity volleyball coach Brent Maynor said. “But the first three games we gave up big runs.
