Woman's body found on frozen Pine Lake

Sheriff says she drove from Tecumseh to clear her head, ended up in Fenton Township

On Wednesday, Dec. 28, the deputies with the Genesee County Sheriff's Office were dispatched to the 5000 block of Islandview Drive in Fenton Township after a homeowner called 911 at 9:58 a.m. to report a small purple SUV was blocking their driveway. There was no one in the vehicle, however, clothes and shoes were piled on the roof and a window was open.

Bare footprints could be seen near the vehicle and heading down to the home's dock on Pine Lake. Footprints could be seen on the lake's ice.





Record amount raised for local cancer patients

Impactful events and newsworthy happenings in 2022

■Below are only a few of the noteworthy events from last year

In the tri-county area, 2022 was a year of fires, infrastructure improvements, growing events and communities coming together to help others.

Two municipalities were impacted by devastating fires this year. On Tuesday, June 21 in Holly, a fire destroyed Battle Alley Arcade Antiques, heavily damaged Andy's Place and the Holly Hotel, and caused minor damage to other neighboring businesses.

A week later on Tuesday, June 28 in Fenton, a fire heavily damaged El Topo/The Relief & Resource Co. and destroyed a barn. Both communities fundraised for the business owners and affected employees. Most businesses have indicated they have plans to rebuild.

One positive event in Holly this year was the opening ceremony for the Vietnam Memorial Moving Wall, which was available for the public to see in Holly for a weekend in August.

A significant milestone in Fenton Township in 2022 was how much planning and preparing township officials have done for the Thompson Road Corridor and in bringing municipal water to sections of the township. The board of trustees adopted an updated Thompson Road Corridor Plan.

The board also approved plans to join the Genesee County water system and bring municipal water to Thompson Road and farther south to Linden. Work began this past fall.

In 2022, township officials approved plans for multiple housing projects along Lahring Road. Construction is currently ongoing for the 83-bed senior living facility, called Silver Lake Road. Assisted Living, on Silver Lake Road.

The township also will receive \$10 million from the state to widen the Thompson Road bridge over U.S. 23.

Fenton Township and Linden entered into service agreements with Medstar Inc. after reports of long wait times for ambulances. Linden City voted to join the Genesee County water system as

"2022 was a very eventful year for Fenton Township. Township officials and staff have devoted considerable resources to improving services for township residents.

"The biggest news for 2022 was the approval of contracts to connect to the Genesee County water system. By allocating a substantial portion of our own American Rescue Plan Act (ARPA) funds, along with \$6.5 million in ARPA funds from Genesee County, Fenton Township was finally able to move forward with bringing municipal water to our community. Phase I is already under construction and Phase 2 should follow close behind.

"Fenton Township also took a large step forward in our interactions with the public. A new website was launched March 1, providing easier access to information and multiple ways to contact the township regarding various issues and concerns. The township also entered the social media universe in 2022, establishing a presence on Facebook, Twitter and Instagram.

"The township continued to fund road improvements this year. Working with the Genesee County Road Commission, Fenton Township repaved four local roads in 2022, totaling just over 2 miles in length.

"The Fenton Township Planning Commission had a very busy 2022. They approved an updated Thompson Road Corridor Plan in August and began work on updating both the Master Plan and the 5-Year Parks & Recreation Plan, both of which will be

Will work with state and federal officials to rename lake deemed derogatory

In November 2022, Fenton Township Supervisor Vince Lorraine announced that residents living on Aanikegamaa Lake (formerly Squaw Lake) who wish to be part of a discussion at the local, state and federal level were to contact him at the Fenton Township office.

Lorraine's announcement came after the federal government changed the name of a lake in Fenton Township.

On Sept. 8, 2022, the Department of the Interior (DOI) announced the Board on Geographic Names (BGN) had voted on the final replacement

names for nearly 650 geographic features with the word "squaw."

According to the Ojibwe People's Dictionary, Aanikegamaa means "chain of lakes."

Lorraine is forwarding all of the Squaw Lake name issues to Fenton Township resident Mark Shantz as he was told by federal and state officials that it would be best if residents drove this. Shantz' home is on Aanikegamaa Lake. Shantz volunteered to head this issue.

He said he is currently awaiting new name ideas from residents. "Once we have names, we will ask residents to vote on which one they prefer. Once we complete that, the federal paperwork starts," Shantz said. He can be reached at (248) 396-1093.

Gone but never forgotten

Tri-county area remembers several who died, made the news

Each year, the Times obituary pages are filled with the names of loved ones who lost their lives, however, there are those whose deaths resulted in a news story. This year, there were 11 of those deaths. They are listed in order of the dates they died.

Don Merrill

Former Lt. Don Merrill of the Fenton Police Department died Dec. 28, 2021. His story did not make it into the 2021 Year in Review.



Merrill of Fenton joined the police department in 1979, after serving as a reserve patrolman. He was promoted to sergeant in 1993 and lieutenant in 2002. He served as interim police chief for eight months in 2003. When he retired, he received numerous letters of thanks and recognitions from the community and was awarded a Department Citation for Meritorious Service in 1989 for his actions in the arrest of two felons involved in a theft from a night deposit box.

Bill Miller

Former Gaines Fire Chief Bill Miller died Jan. 1, 2022 of natural causes. Miller helped build the Gaines Township Fire Department



from scratch in 1979. A February 2015 Swartz Creek View article announcing his retirement noted that he was the longest-serving continuous fire chief in Genesee County at that time. Miller was a descendant of the first settlers of the Swartz Creek area, originally called Miller's Settlement, for whom Miller Road is named.

Jerry Palmer

Gerald (Jerry) Palmer, 89, of Fenton, died Jan. 20, 2022. He was chief of the Fenton Fire Department from 1990-1997. He served with the



fire department from 1961 to 1997. He was a lifelong resident of Fenton and graduated from Fenton High School, where he lettered in four sports. He was inducted into the Fenton Sports Hall of Fame for Football.

Cathy Miller

Cathy Miller, 70, of Groveland Township, died Feb. 16, 2022. Herhusband Howard Miller was charged with her death. He died ap-



proximately a month later.

Ted Goupil

Ted Goupil, 87, of Fenton Township, died Feb. 22, 2022. He served on the Fenton Township Board of Trustees for nearly 20 years,



10 of them as clerk. One of his most significant accomplishments was working to build sewers around the township's many lakes. He was also retired after 10 years as principal at West Shore Elementary in the Lake Fenton schools. He and his wife, Pat, of 62 years, a retired Realtor, have been long time residents of Fenton Township.

Gilda Mizell

Gilda Mizell's body was discovered Jan. 21, 2022. She was a 64-year-old Gaines resident who was found dead in her vehicle in her driveway on Seymour Road in January. Her death went unnoticed for weeks, and no one took care of the animals on her property.

Ongoing court cases

■ Tri-county area sees wide range of crimes in 2022

By Sharon Stone

The Times covered several arrests and court cases in 2022. Crimes ranged from domestic assault, armed robbery, violating the state marriage act, threat of terrorism, attempting to disarm a police officer, interfering at abortion clinics, and involvement at the Jan. 6, 2021 protest in Washington, D.C.

Below are summaries and statuses of cases reported on in 2022.

Caleb Tierney and Cameron Zavler

A former Genesee County Jail guard, Cameron Zayler, 24, of Prudenville and formerly of Davison, was bound over to Genesee County Circuit Court on June 1, 2022 for two counts of firstdegree criminal sexual conduct (CSC) in Linden.



Zayler's friend and alleged accomplice, Caleb Tierney, 25, of Davison and formerly of Linden, has one charge of first-degree CSC in Linden. His case also was bound over May 31 to circuit court for trial. Tierney is a former Flint police officer. They both have a pretrial hearing Jan. 19.

Matthew Krol

Matthew Krol of Linden was arrested Tuesday, Feb. 22, 2022 by federal agents for his alleged involvement in the events at U.S.



Capitol in Washington, DC, on Jan. 6. 2021. Krol is charged with assaulting, resisting or impeding certain officers using a dangerous weapon or inflicting bodily injury; civil disorder; entering and remaining in a restricted building or grounds; disorderly and disruptive conduct in a restricted building or grounds; engaging in physical violence in a restricted building or grounds and the act of physical violence in the capital grounds or buildings. He pleaded not guilty during his arraignment May 16 and has remained in federal custody in Virginia since his arrest. A status conference is scheduled for Jan. 9, at 3 p.m.

Megan Imirowicz

On Oct. 1, 2021, Michigan State Police (MSP) Metro North troopers responded to an aggravated assault complaint in Groveland Town-



ship where a suspect, Megan Imirowicz, then 18, allegedly threw drain cleaner on her father causing significant injuries. Her father died from his injuries in March 2022 and her charge was elevated to homicide. Her trial in Oakland County Circuit Court is set to begin April 17.

Joshua Allgever

Joshua Robert Allgeyer, 39, of Holly, was arraigned in Oakland County 52-2 District Court on Tuesday, March 29, 2022. He was charged with two



counts of felonious assault, three counts of possession of a firearm in commission of a felony, one count each of carrying a concealed weapon, felon in possession of a firearm and felon in possession of ammunition. Motion to dismiss counts 3-6 were granted on Oct. 27. His trial is set to begin Jan. 23, in Oakland County Circuit Court.

Heather Idoni

A grand jury for the Middle District of Tennessee indicted Heather Idoni of Linden and 10 other individuals Oct. 3. 2022 on violations



of the Freedom of Access to Clinic Entrances (FACE) Act, which prohibits even temporary interference with reproductive health care services, which could include abortion, and conspiracy to obstruct access to a clinic providing reproductive health services, which could include abortion. A trial date of Jan. 10, has tentatively been scheduled.

Idoni is facing similar charges for allegedly obstructing a women's reproductive health clinic in Washington, D.C., on Oct. 22, 2020. A trial date of Aug. 9, has tentatively been scheduled.

John Gleason

John Gleason, 68, of Flushing, pleaded guilty to one count of violating the state marriage act, a 30day misdemeanor. He did this in a



Livingston County courtroom Tuesday, Oct. 25, 2022. He also agreed to step down from being the Genesee County clerk, effective Nov. 2, 2022.

Kimber Sattler, Christina Parker, **Dajour Jackson, Cody Sanders**

On Wednesday, Feb. 2, 2022, at approximately 2 a.m., three suspects entered a home located on Fish Lake Road in Holly Township. They confronted the homeowner at gunpoint. The victim was held at gunpoint by one suspect while the others stole a firearm from the home. The suspects were wearing ski masks and gloves and were armed with an AK style pistol. The suspects fled the scene in the victim's vehicle.

Kimber Sattler, 33, of Flint, was convicted Aug. 4, 2022 and sentenced Sept. 1, 2022 to two to 15 years in state prison for armed robbery. She was





originally charged with armed robbery, home invasion first-degree, unlawfully driving away of an automobile and larceny of a firearm.

Christina Parker 34, of Flint, was charged with unlawfully driving away of an automobile, larceny of a firearm and armed robbery. She was sentenced Aug. 4, 2022 to 18 months to 15 years in state prison for armed robbery. She also was sentenced in Genesee County to 17 months to 10 years for possession of a controlled substance.

Dajour Jackson, 32, of Flint, was sentenced Aug. 11, 2022 to 27 months to 15 years in state prison for armed robbery.

Cody Sanders, 31, was sentenced Sept. 8, 2022 to 27 months to 15 years in state prison for armed robbery.

Jeremy Coder and Kevin **Deisler**

Two men, Jeremy Coder and Kevin Deisler. who allegedly believed they were arranging to have sex in June 2022 with a 15-yearold girl learned they were making plans with law enforcement. The were arrested and lodged in the Oak-





land County Jail, each charged with multiple felonies that could land them in prison for up to life if convicted.

The men were caught in an undercover sting operation orchestrated by the Oakland County Sheriff's Office in partnership with the Genesee County Sheriff's Office. They were arraigned in 52-1 District Court on June 4, 2022. Coder has a pretrial in Oakland County Circuit Court on Jan. 18. Deisler's next court hearing is Feb. 6, in Oakland County Circuit Court.

Richard August Prausa, Fazlollah Farz Haritash, and John Erwin Dingens,

Three men, Richard August Prausa, 45, of Clarkston; Fazlollah Farz Haritash, 64, of Farmington Hills; and John Erwin Dingens, 61, of Corunna, who believed they were arranging to have

Robert Nelson Jr Robert Nelson Jr, 39, of Holly was arraigned Wednesday, Aug. 24, 2022 on three counts of false report or threat of terrorism. He was

Holly Police Chief Jerry Narsh reported that Nelson made a series of false 911 phone calls reporting bomb threats in an attempt to implicate someone else due to grievances. He waived his preliminary exam in district court and was bound over Dec. 2, 2022 to circuit court for trial. A pretrial is scheduled for Feb. 7.

Stanley Fournier

Stanley Fournier Jr., 38, of Fenton, was arraigned Sept. 17, 2022 on three felonies following a traffic stop in Fenton on Sept. 13, 2022. A consent search resulted in the recovery of a container containing a white substance, three bottles of a liquid, a plastic bag of illegal mushrooms, brass knuckles, two open bottles of intoxicants, miscellaneous prescription pills, a bag of cocaine, a

bag of meth, two scales an assortment of small plastic bags and an undisclosed amount of cash. He reportedly admitted possession of the cocaine, meth and mushrooms. On Dec. 13, 2022, he pleaded guilty to reduced charges. He was credited with days served and ordered to community service. A show cause hearing is scheduled for March 7.

Jared Salisbury

Jared Salisbury, 33, was arraigned Oct. 1, 2022, with one count of accosting a child for immoral purposes, a four-year felony. He was released



from the Oakland County Jail on a \$25,000 personal bond. As a condition of bond, Salisbury is to have no contact with minor children and is not to use a computer or the internet. A probable cause conference is scheduled for Feb. 7 in 50th District Court in Pontiac.


Douglas Walsh

Brian Pearson

On Friday, Oct. 28, 2022, Brian Pearson, 44, of Rochester, was charged with four counts of fourth-degree criminal sexual conduct involving a student at Holly Area Schools. Holly Police Chief Jerry Narsh said that in May 2022, Holly police investigators were notified by Holly Area Schools officials that they were investigating a complaint they received from a former female student against a male Holly High School teacher for inappropriate conduct that occurred while she was his student during a period starting in 2012 and ending in 2014. Pearson was bound over to Oakland County Circuit Court for trial Dec. 6, 2022. A pretrial hearing is set for Jan. 12.

Ryan Davis

Ryan Davis, 40, of Fenton, is charged with one count of false report or threat of terrorism and has been bound over to circuit court for



jury trial. He was arrested Sept. 15, 2022 and arraigned Sept. 16, 2022 in Genesee County 67th District Court. The charge is a 20-year felony. Davis obtained attention from police Sept. 14, 2022. Police had received calls that a man was seen walking on LeRoy Street carrying a shotgun, a chair and a sign shortly after 10 a.m. Acting Police Chief Jeff Cross said it is legal to open carry a shotgun (loaded or unloaded) in the state of Michigan. Once Davis arrived at the police station, he sat down out front in his chair. At this time, officers walked out to speak with him. Cross said officers had a conversation with Davis, who said he wanted to speak with the city manager. After police spoke with him, Davis took his firearm home and returned to speak with the city manager. Through their investigation, Fenton police learned that Davis had reportedly contacted multiple individuals with the city and he made statements that he was familiar with the shootings during a July 4 parade in Highland Park, Illinois and the elementary school in Uvalde, Texas. He remains lodged at the Genesee County Jail on \$250,000 cash bond. A pretrial is set for Jan. 6 at 10 a.m.

Mitchel Reis

Mitchel Reis of Metamora was arraigned Thursday, Sept. 22, 2022 in Genesee County 67th District Court following his arrest in Argentine Township on Sunday, Sept. 18, 2022. Reis is charged with attempting to disarm a police officer, a felony. A preliminary exam is set for Jan. 31 at 1 p.m.

Bobby Lee McMillan

Bobby Lee McMillan, 28, is facing sentencing on four counts of first-degree criminal sexual conduct (CSC) during a



felony and four counts of accosting children for immoral purposes. McMillan was arraigned on the charges Oct. 22, 2022. A felony plea was accepted for a reduced charge of third-degree CSC and accosting children for immoral purposes. His case was bound over to Genesee County Circuit Court on Nov. 22, 2022. A sentencing hearing is set for Jan. 6 at 9 a.m.

Joseph Mitchell

Joseph Mitchell, 38, of Burton, is lodged in the Genesee County Jail after bond was denied. His charges include two counts of first-



degree CSC during a felony, two counts of accosting children for immoral purposes, two counts of child sexually abusive activity and human trafficking of a minor for commercial sexual activity. Genesee County Sheriff Chris Swanson said a young victim was at Hurley Hospital in Flint. Child Protective Services were called to investigate and they in turn dispatched the county's Genesee Human Oppression Strike Team (G.H.O.S.T.) to investigate. The

Fenton Township expanded its Thompson Road water project.

The city made upgrades to the downtown area. Roger Sharp, CEO and founder of Sharp Funeral Homes, and Joe Kimble, Emeritus Professor at WMU–Cooley Law School., who paid to renovate the gazebo, also paid to fix the old water wheel, which is working again.

The Linden City Council is also different going into 2023. Former Councilor Aaron Wiens did not receive enough votes to keep his seat. Elizabeth Armstrong, the new councilor, was a write-in candidate and had her first meeting on Monday, Dec. 12.

The city had multiple successful and well-attended events this year. Zombies, Scarecrows and Monsters, one of the largest family friendly Halloween events in the area, continues to grow and grow every year.

Linden also approved plans to make Triangle Park a trailhead for The State Bank Trail, which is expected to be constructed alongside Silver Lake Road in 2023.

In August, voters approved a 5-mill millage to fund police and fire services in the city.

Construction was completed on the Beacon & Bridge gas station and the business is up and running.

In Argentine Township, work is ongoing to fix the dam. The Argentine Township Police Department is now host to a community food pantry, which was built and donated by Girl Scout Troop 75722. The Lobdell Lake Chili Cook Off remains one of the township's most popular events. Thousands attend the event in February.

The Argentine Township Board of Trustees changed in 2022. After six years on the board, Scott Conner stepped down from his trustee position. Trustee Tom Hallman, who previously served on the board from November, was appointed to the seat.

All of these municipalities, except for Fenton, are in the process of updating their master plans or sections of their master plans. Fenton adopted its new master plan in January 2022. Citizens can find these plans on the municipality websites.

son said deputies responded, drones were launched and the sheriff's dive team responded to start searching for the driver of the abandoned vehicle.

At approximately 1:30 p.m., a homeowner on Harp Drive, which is on the north end of Pine Lake, called 911 to report seeing an individual laying down on the ice.

Swanson said first responders made it out to where the individual was laying and determined that she was deceased, most likely from the elements. He said an autopsy would be done as well as toxicology testing.

The sheriff said the woman was identified as Lisa Marie Rothfuss, 44, of Tecumseh. Her family was notified of her death.

Swanson said Rothfuss had struggled with mental health issues. On Friday, Dec. 23, she told her family that she needed to clear her head. She borrowed a vehicle and started driving. He said her cell phone last

pinged Tuesday, Dec. 27 at 10:30 p.m. in Detroit.

The sheriff said there were no signs of foul play and there was no indication that she had any relatives, friends or interests in Fenton Township.

Swanson said Rothfuss posted Dec. 22 on her Facebook page that for her birthday this year she was asking for donations for 988 Suicide & Crisis Lifeline.

As a reminder, Swanson said mental health issues can strike anyone, anytime, anywhere. "It happens in our town too," he said.

and more, residents had much to talk about in 2022.

The fire that destroyed or damaged several businesses in downtown Holly in June stands out as one of the biggest stories of the year because it impacted so many people and businesses.

The following are some of the Times' biggest stories that the editorial department followed throughout the year.

FENTON

After 40 years of providing the finest chocolates and treats to Fenton, Carol Schuler, owner of Sweet Variations retired in January 2022. Her candy store used to be located where Bridal Loft is now located downtown. In 2016, she relocated her store to N. Fenton Road in Fenton Township behind Sagebrush Cantina.

Last winter, Fenton City Council indicated it would be investing \$30 million in infrastructure, which includes water, sewer, local streets, sidewalks. This would be done utilizing some federal and state funding.

Controversy began in October 2021 when Picasso Landscaping, owned by Brian Dennis, requested approval of a site plan and a special land use permit for property on Meadowridge Drive near Fenway Drive. Confusion over whether there would be concrete crushing resulted in talks being tabled. The Fenton Planning Commission eventually approved the site plan and special land use request for Picasso Landscaping during its March 24, 2021 meeting. Dennis filed a lawsuit against the city seeking monetary damages in excess of \$25,000 along with a reversal of the denial of a special land use permit for the concrete batch plant and to remove restrictions on his current operations. This court case is pending.

The Fenton Community Expo celebrated its 37th year in March 2022. It was held in person at Fenton High School.

In May 2022, Fenton City Council approved a \$4.1-million contract with Waldorf & Sons, Inc. for its 2022 Local Roads Program.

On June 3, 2022, after nearly 27 years with the Fenton Police Department, Police Chief Jason Slater retired. Lt. Jeff Cross has been serving as acting

chief since that time.

After a year of intricate work, Ronny Medawar, owner of Medawar Jewelers began the final steps of repairing the four-sided fire hall clock tower in June 2022. The clock had not worked in several years and the owners of the Fenton Fire Hall restaurant commissioned Medawar in July 2021 to make the repairs.

One week after the massive fire in downtown Holly, a fire broke out in downtown Fenton on June 28, 2022, causing damage to the El Topo restaurant and Relief & Resource Co. on Mill Street, as well as an adjacent barn. The barn was destroyed and the damaged restaurant was torn down in December.

In August 2022, the Fenton Downtown Development Authority announced the purchase of the former Deehl Chiropractic property on Pine Street at E. Caroline Street. Once the building is removed, the city plans to put in parking spaces as well as a storage garage and training space for the fire department.



This past summer and fall, Torrey Road, from North Road to the northern city limits was rebuilt for a total of \$1.3 million. Work also included a sidewalk from North Road to Georgetown Parkway.

In August 2022, the Fenton Planning Commission approved the final site plan for ALDI grocery store, which is proposed to be built between Target and the Fenton High School property.

After two years in an alternate format due to COVID, the St. John Applefest was held in person once again from Sept. 15-18, 2022. The event was deemed a success and the golf outing in memory of Ron Lockwood was sold out.

Also in September 2022, the Fenton Trolley, a free service of the Mass Transit Authority (MTA), started operating in Fenton.

In October 2022, Pat Lockwood, the city's mayor pro tem, received the Jim

On Oct. 24, 2022, Fenton City Council approved an estimated \$389,218 for the Veterans Memorial Park Project, which will be constructed at Fenton Freedom Park. The city expects the project to be completed in time for Veterans Day 2023.

A Fenton family with seven kids was able to spend Christmas 2022 in their newly renovated home. The project of Fenton Area Resources and Referral Network, Inc. (FARR) was nicknamed Miracle on Sixth Street. Community members, several local businesses and the Genesee County Sheriff's Office joined forces to make the family's home safe again.

HOLLY TOWNSHIP

On Jan. 19, 2022, Holly Township Treasurer Mark Freeman announced that he would be retiring after 13 years of service on Oct. 30, 2022. In December 2022, the Holly Township Board of Trustees held a special meeting and voted to appoint Jen Ryan of Holly as treasurer. Holly Township Supervisor George Kullis said Ryan's resume is stellar. She is on maternity leave and will begin her duties with the township Jan. 30.

It was announced in March 2022, that the 2020/2021 N. Holly Road resurfacing project, from north of Grange Hall Road north to the Genesee County border, a partnership of the Road Commission for Oakland County (RCOC), Holly Township and the village of Holly, was recognized by the American Public Works Association (APWA), Detroit Metro Branch. The APWA chapter named the road project

the 2021 Project of the Year in the \$1 million to \$5 million category.

A severe storm and weak EF-0 tornado on July 11, 2022 caused damage through the tri-county area. Strong winds damaged homes on the east side of Lake Fenton in Fenton Township. The storm traveled at a southeast direction. The Red Riding Hood Stables on N. Holly Road in Holly Township, owned by George and Chrissy Kutlenios, sustained heavy damage. This came after their other business, the Holly Hotel in downtown Holly was heavily damaged by fire on Tuesday, June 21.

During the November 2022 election, Holly Township residents approved a proposal to add two seats to the Holly Township Board of Trustees. The proposal passed by a vote of 2,916 to 2,207. The board of trustees will go from a five-seat board to a seven-seat board.

HOLLY VILLAGE



Holly Village was the site of two movies being filmed in January 2022. Christmas at the Holly Hotel and Cupid's Christmas were filmed in the downtown area and featured several local residents. The movie about the Holly Depot debuted in November 2022 and the movie, Christmas at the Holly Hotel debuted in December 2022.

On Feb. 8, 2022, Holly Village Council approved an ordinance amendment that would allow Holly Village to grant business licenses to qualified applicants to open recreational marijuana establishments. On June 28, 2022, Holly Village Council approved two marijuana retail licenses, one for The Brand Labs and one for Lume Cannabis Co. Village Manager Jerry Walker said he expects the businesses to open this winter.

At approximately 4 p.m. on Tuesday, June 21, 2022, a fire broke out at Battle Alley Arcade Antiques in downtown Holly. With strong winds and temperatures in the 90s, the fire quickly spread to nearby businesses. The fire raged for hours. The antique shop was destroyed and the Holly Hotel, the Holly Moose Lodge, Andy's Place, Creative Fashions of Holly, RHL Financial Group



and Ziggy's Ice Cream were damaged. The historic Holly Hotel sustained heavy damage and the owners have said they are committed to rebuilding. There have been fundraising efforts to help the other businesses and employees who lost their jobs due to the fire.

The Vietnam Moving Wall was installed at the Karl Richter Campus on Thursday, Aug. 4, 2022. Hundreds of people attended the opening ceremony. The memorial remained in Holly for several days.



During the November 2022 General Election, the voters in Holly Village approved a 15-year, 3-mill millage for fire and police services. Holly Village Council approved the millage proposal Feb. 8, 2022. In July 2022, Holly Village Council learned that the millage was accidentally placed on the August ballot at the county level. Village council then voted to keep the millage on the November 2022 ballot and invalidating any August election results.

During a special meeting on Nov. 7, 2022, Holly Village Council voted

4-1 to censure Councilmember Ryan Delaney for violating the village's code of ethics for council members. A candidate for village president, Delaney was elected president the next day, Tuesday, Nov. 8, 2022.

NORTH OAKLAND COUNTY FIRE AUTHORITY, ROSE TOWNSHIP, HOLLY TOWNSHIP

On March 9, 2022, during a Rose Township Board of Trustees meeting, Supervisor Dianne Scheib-Snider admitted that she was attempting to remove NOCFA fire chief, Jeremy Lintz.

On March15, 2022, the NOCFA Board of Directors citizen-at-large, Peter Stouffer submitted his resignation.

On April 14, 2022, Rose Township Treasurer Paul Gambka announced his resignation from the NOCFA Board.

On April 18, 2022, Scheib-Snider announced her resignation from the NOCFA Board.

On April 26, 2022, the Rose Township Board of Trustees voted to appoint Rose Township Trustee Glen Noble to the NOCFA Board. They also voted to appoint Gambka back to the NOCFA Board.

On June 6, 2022, the NOCFA Board appointed Brad Stilwell of Rose Township as the citizen-at-large for a two-year term.

On Dec. 15, 2022, Noble's seat became vacant when he submitted his resignation to the Rose Township Board of Trustees. Rose Township Clerk Debbie Miller was then appointed to the NOCFA Board to represent Rose Township.

In September 2022, the NOCFA Board approved a three-year contract for the full-time firefighters' union.

ROSE TOWNSHIP

By a vote of 1,076 to 656, the residents of Rose Township approved the Fire Protection and Emergency Medical Services Operating Millage during the Primary Election on Tuesday, Aug. 2, 2022.

Members of the Michigan Association of Municipal Clerks (MAMC) elected Rose Township Clerk Debbie Miller as the 2022 "Township Clerk of the Year." A veteran of four presidential election cycles (2008, 2012, 2016, 2020), Miller has



The Lake Fenton varsity wrestling team has won its second tournament of the young season.


The Blue Devils earned the second title at the Corunna Team Tournament, earning first place by beating Tecumseh 42-36 in the finals of the 10-team competition.

The Lake Fenton varsity boys basketball team lost both of its contests.

After losing a competitive 65-57 verdict against a very good and eventual champion Genesee Christian squad, the Blue Devils lost its second game against Chesaning by a 58-40 margin, Lake Fenton's worst offensive performance of the

The Blue Devils enter their holiday break with a three-game losing streak, falling to 3-3 overall.

"It felt like an out of body experience," Lake Fenton varsity boys basketball coach Ty Szczepanski said about the Chesaning loss. "Chesaning is much improved from the last two seasons. They are seniorheavy and they deserved to win. They played a great game, specially on defense. And then they iced the game in the fourth.

The Genesee Christian contest was a super entertaining game, one that stayed close until the fourth quarter. Both teams were shooting the ball well through three quarters. The Blue Devils shot the ball well, nailing 22-for-47 shots, but 21 turnovers kept the Blue Devils from extended scoring runs. The loss wasted an outstanding offensive effort by Brit Antonangeli, who scored 21 points, with 15 coming from behind the three-point arc. Ashton Hunter chipped in 11 points while Lessner had nine points.

"The turnovers are something we've been trying to clean up the last couple of games," Szczepanski said. "Last Friday against Corunna, I thought it was more us making mistakes shooting ourselves in the foot more. Today, I thought it was more of a credit to how good Genesee Christian's defense was."

Today, Sunday, Jan. 1 starts National Blood Donors Month.

On Dec. 31, 1969, President Richard Nixon signed a proclamation designating January as National Blood Donors Month (NDBM). The month long observance was meant to honor voluntary blood donors and to encourage more people to give blood at a time when more blood is needed.

As of Dec. 13, the blood drive total at Holly Calvary Church reached over 522 good donations (whole blood-449, Double Reds-65, Plasma-8) for the 12, once-amonth blood drives that are hosted by the Versiti Blood Center of Michigan. The area account representative for Versiti, Brad Warju said, "It's amazing. That's over 1,500 lives (in Michigan) will be impacted."

The Versiti blood drives in Holly are planned and carried out by a retired teacher, Ellen Pease, a volunteer for the

Holly Calvary Church of Holly. Working with Pease is a partnership of volunteers including local adults plus student volunteers from Holly, Linden, and Fenton high schools. The students are learning leadership skills and responsibility while serving their community.

"The students are hard workers and a joy to work with," Pease said. "The reason we've been doing blood drives at Holly Calvary Church since 2015 is to save the lives of patients who may have heart defects, blood diseases, cancer, transplants, leukemia, and trauma patients across lower and upper Michigan.

"Hospitals will only use donated blood for their patients' needs. There is no substitute for living, life-saving blood. A typical blood donor can donate every 56 days or two months."

The Versiti Blood Center of Michigan versiti.org/michigan (1-866-MIBLOOD) provides over 120,000 units of blood annually to local patients in over 85 Michigan hospitals and has a nationally recognized stem cell (marrow) program.

earned certification as a Master Municipal Clerk by the IIMC, and her MiPMC level II from the MAMC. She was elected in 2008, after years of service in the private sector as a Project Manager and earning her MBA.

On Dec. 15, 2022, Rose Township Trustee Glen Noble submitted his resignation letter to the Rose Township Board of Trustees. His resignation from Rose Township duties also removed him from his duties serving as a board member on the NOCFA Board of Directors. He had been appointed to the NOCFA Board during a special meeting on Tuesday, April 26, 2022. The township seeks to appoint a new board trustee.

The fence around Rose Center Cemetery on Milford Road was replaced for approximately \$31,000. Replacement was necessary after it was damaged by a vehicle driven by an intoxicated driver in February.

On June 27, 2022, the Oakland County Election Commission ap-

proved recall language regarding the recall of Rose Township Supervisor Dianne Scheib-Snider and Treasurer Paul Gambka. The recall language was submitted by Rose Township resident Don Speace. Enough valid signatures, however, were not obtained to place the recall on an election ballot.

TYRONE TOWNSHIP

improvements and the construction of a new middle school in the May 2022 election. In the November 2022 election, Lisa Oaks, Jennifer Young and Liz Cunningham were elected to the Holly Board of Education.

FENTON AREA PUBLIC SCHOOLS

On March 9, the Fenton Board of Education named Mike Bakker as the new principal of Fenton High School. Superintendent Adam Hartley stepped down June 30, 2022 and the school board named Heidi Ciesielski, the former teaching and learning executive director, to be superintendent, effective July 1, 2022. Mike Pearce, Ashley Prew and Renee Juhl were elected to the school board in the November 2022 election. Voters also approved a sinking fund millage renewal.

LAKE FENTON COMMUNITY SCHOOLS

During the Aug. 2, 2022, election, voters in the Lake Fenton Community Schools district approved the renewal

of the school district's sinking fund millage. Approval of this .9846 mill sinking fund millage for the next 10 years allows the school district to continue to levy the building and site sinking fund millage that expires with the 2022 tax levy.

In the November 2022 election, Michael Peraino and Shannon Elenbaas were elected to six-year terms.

two of the project, which is to replace the stop logs on the auxiliary spillway. Originally, they were hoping to begin this phase in September. They're hoping it will happen sometime this winter.

"The contractor isn't sure when we'll get the material. We're trying to get materials made and fabricated. It's very time consuming right now," Patsy said. "It's been like this since COVID but it's tough to get a finger on when things will arrive."

In November 2019, the right principal spillway on the Argentine Township dam failed, resulting in Lobdell and Bennett lakes losing approximately 11 inches of water over the course of about five days. During the following years and throughout the summer of 2021, Argentine Township residents put pressure on township, county and state officials to have the dam fixed. They regularly attended Lobdell-Bennett Lake Association meetings to express concerns about the infrastructure and the potential of the dam failing entirely, similar to what happened when

the Edenville Dam failed in 2020.

The GCRC and contractor E. T. Mackenzie began work in May 2022. Upgrades include replacing both the primary outflow spillway gates and installing new operating mechanisms. They will replace the logs, which are opened and closed depending on conditions, in the auxiliary spillway. Upstream work also includes replacing the trash grate, which keeps out branches and other items. Repairs cost approximately \$700,000, paid for by the GCRC.

They installed a cofferdam in the summer, which allows them to open and work on the gates. Their goal is to maintain the lake levels. If the water level rises to a level that can't be controlled by the auxiliary spillway, the water will go over the cofferdam.

"It's in a good spot, really. It's just a matter of getting the materials," Patsy said. "I appreciate the patience of the people down there. We're trying to keep the lake in use while we work on the dam. The dam is going to be just fine; it's just a matter of time."

Traffic along that section of Silver Lake Road will be reduced to one lane intermittently. They anticipate completing the project in 2023.
